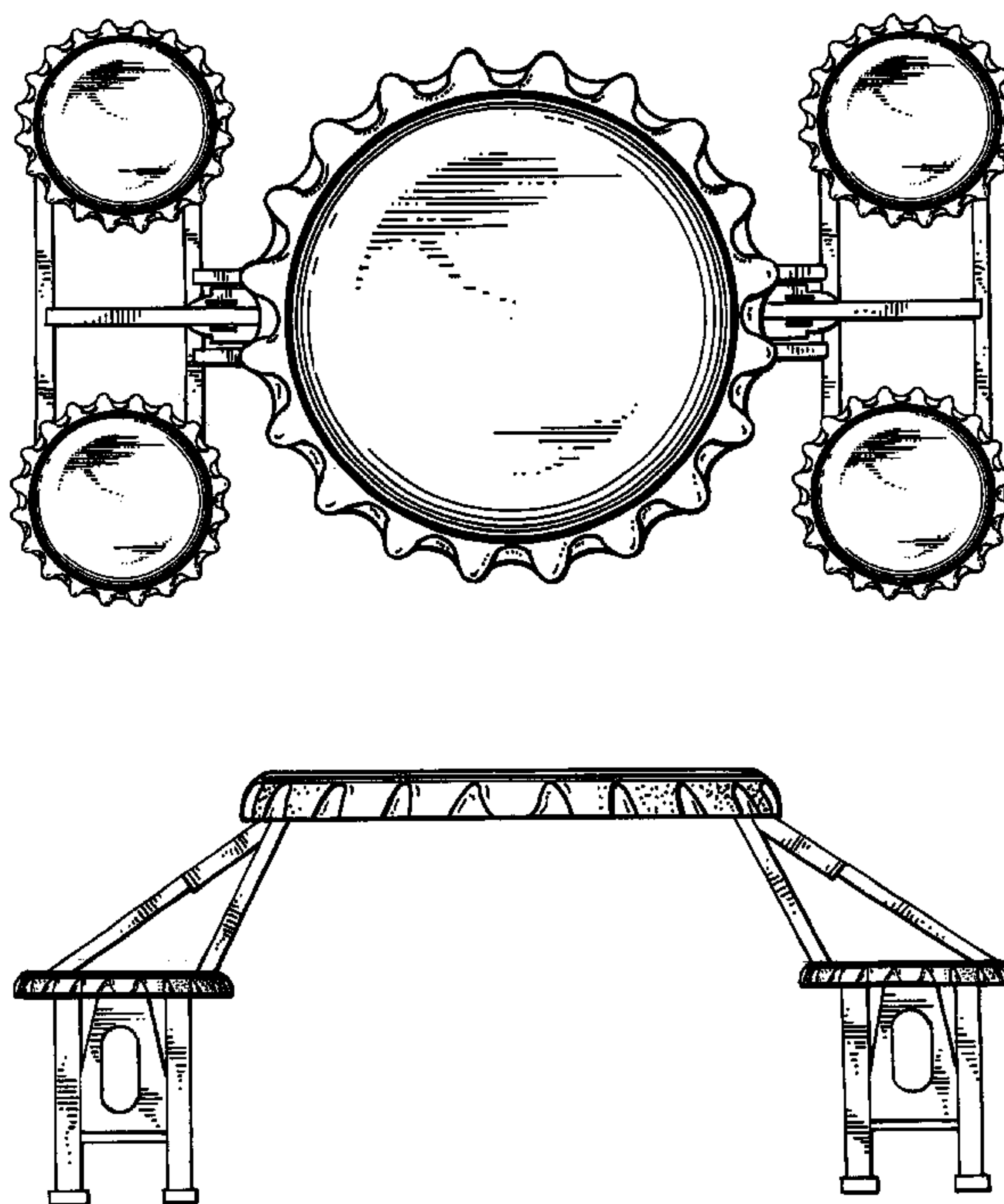

table top, as shown.

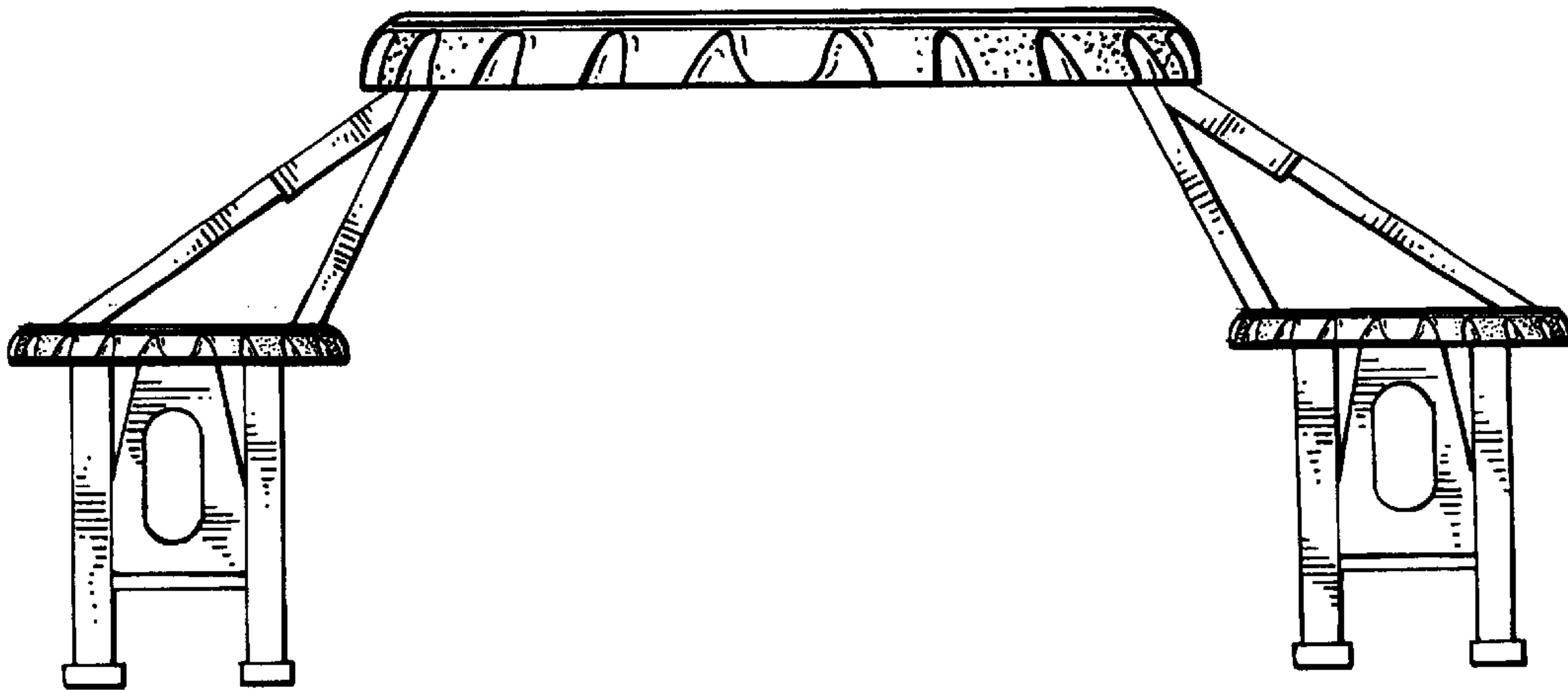
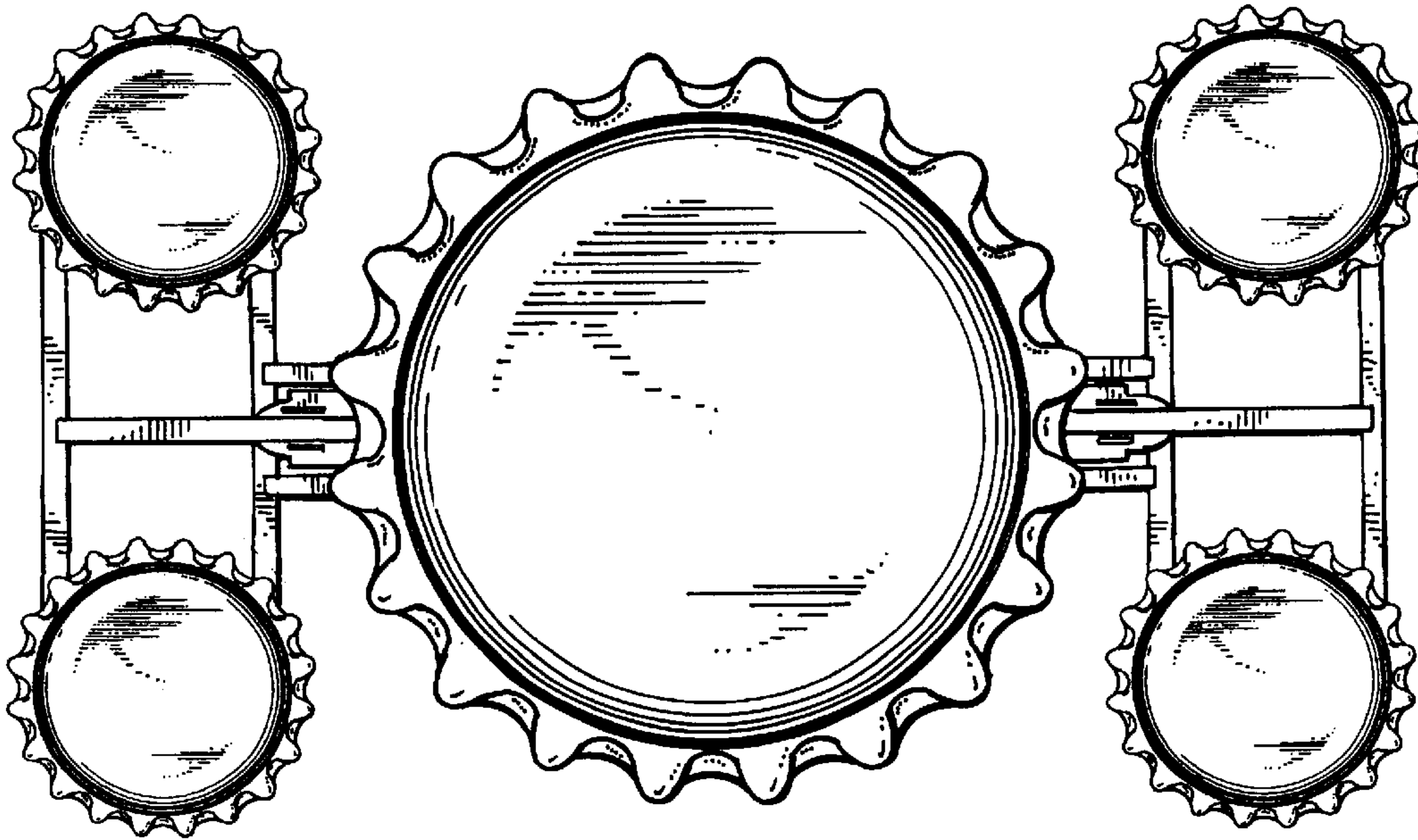
**DESCRIPTION**

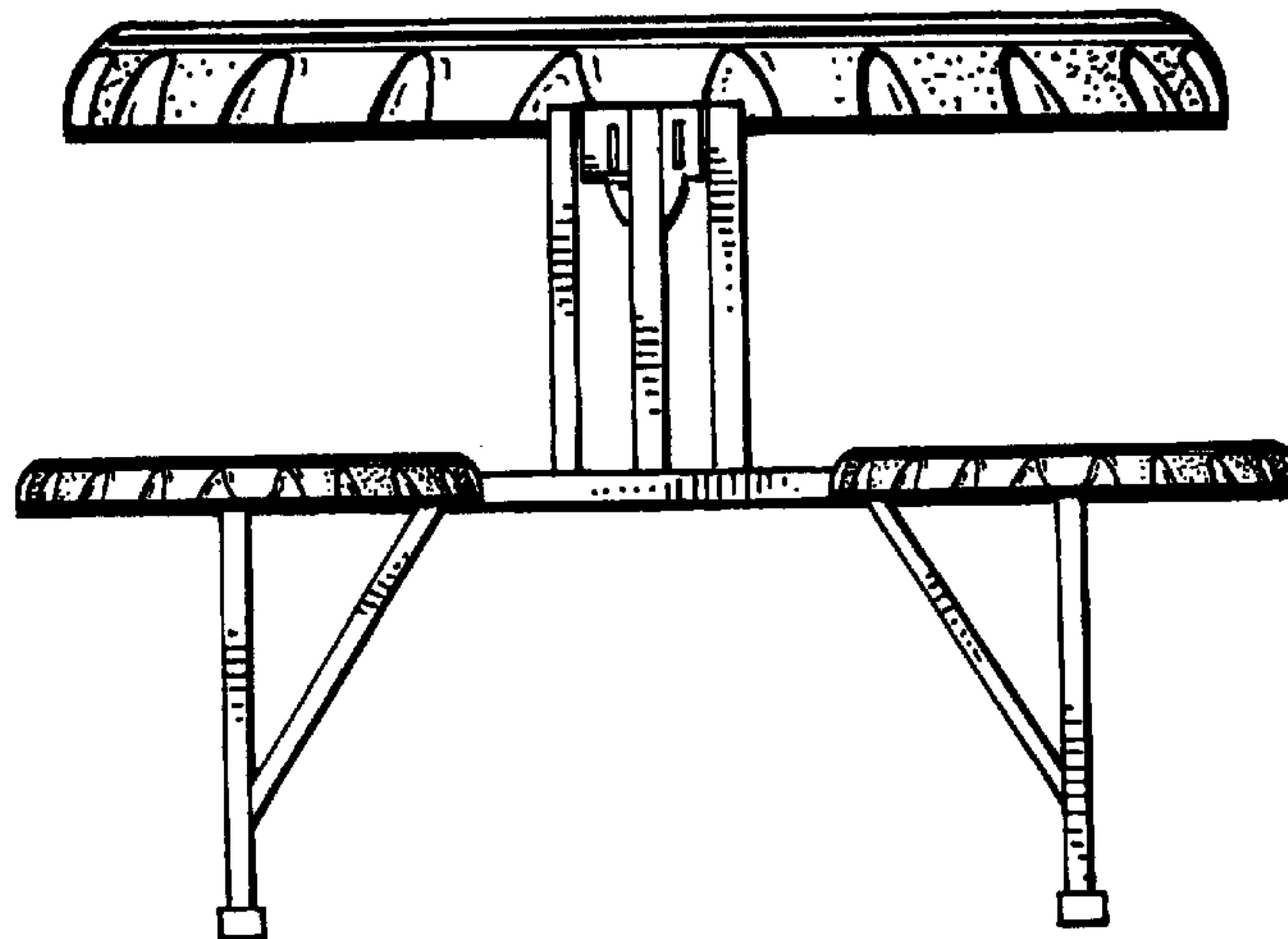
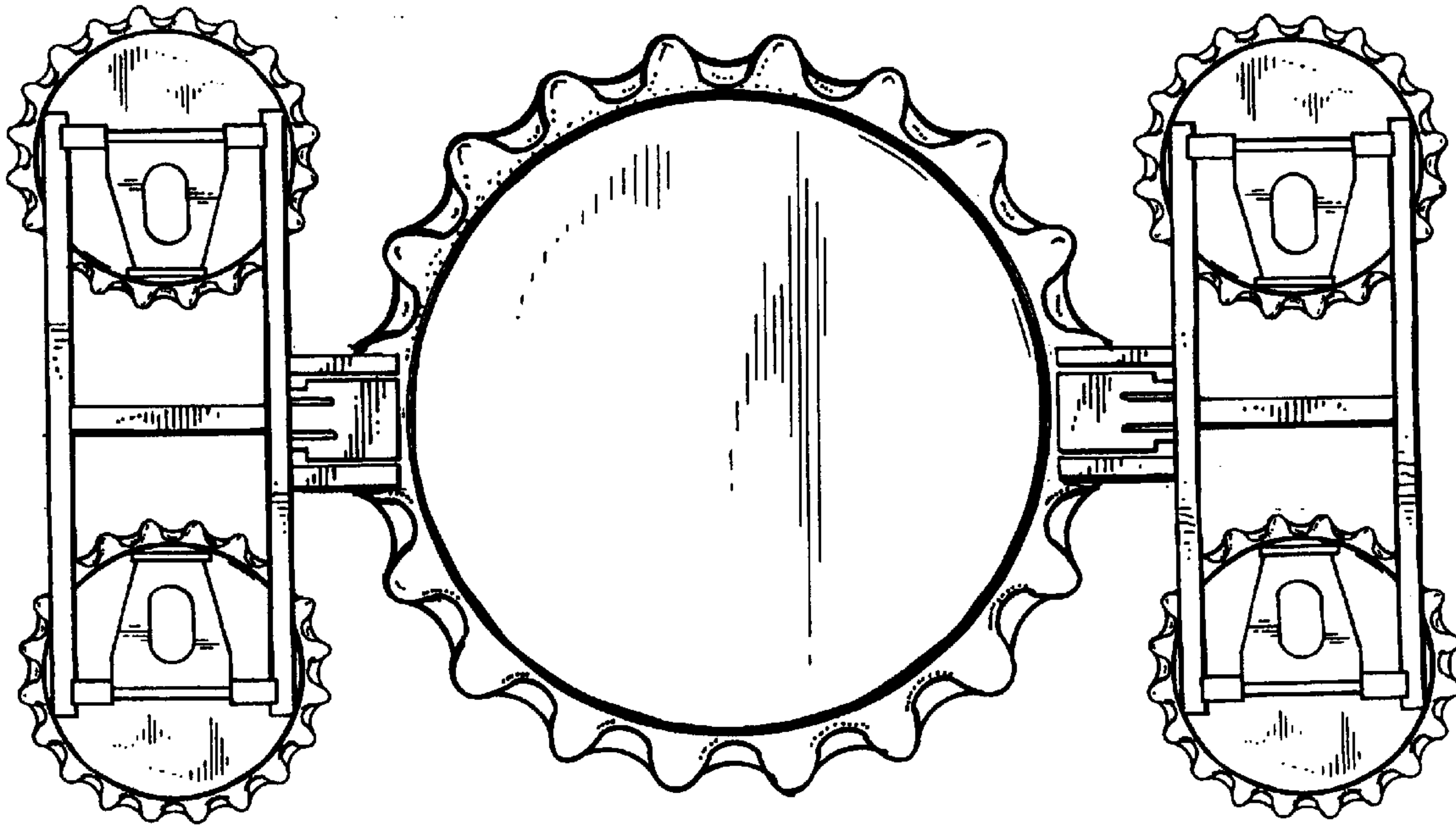
