FIG. 6 is a side view thereof;

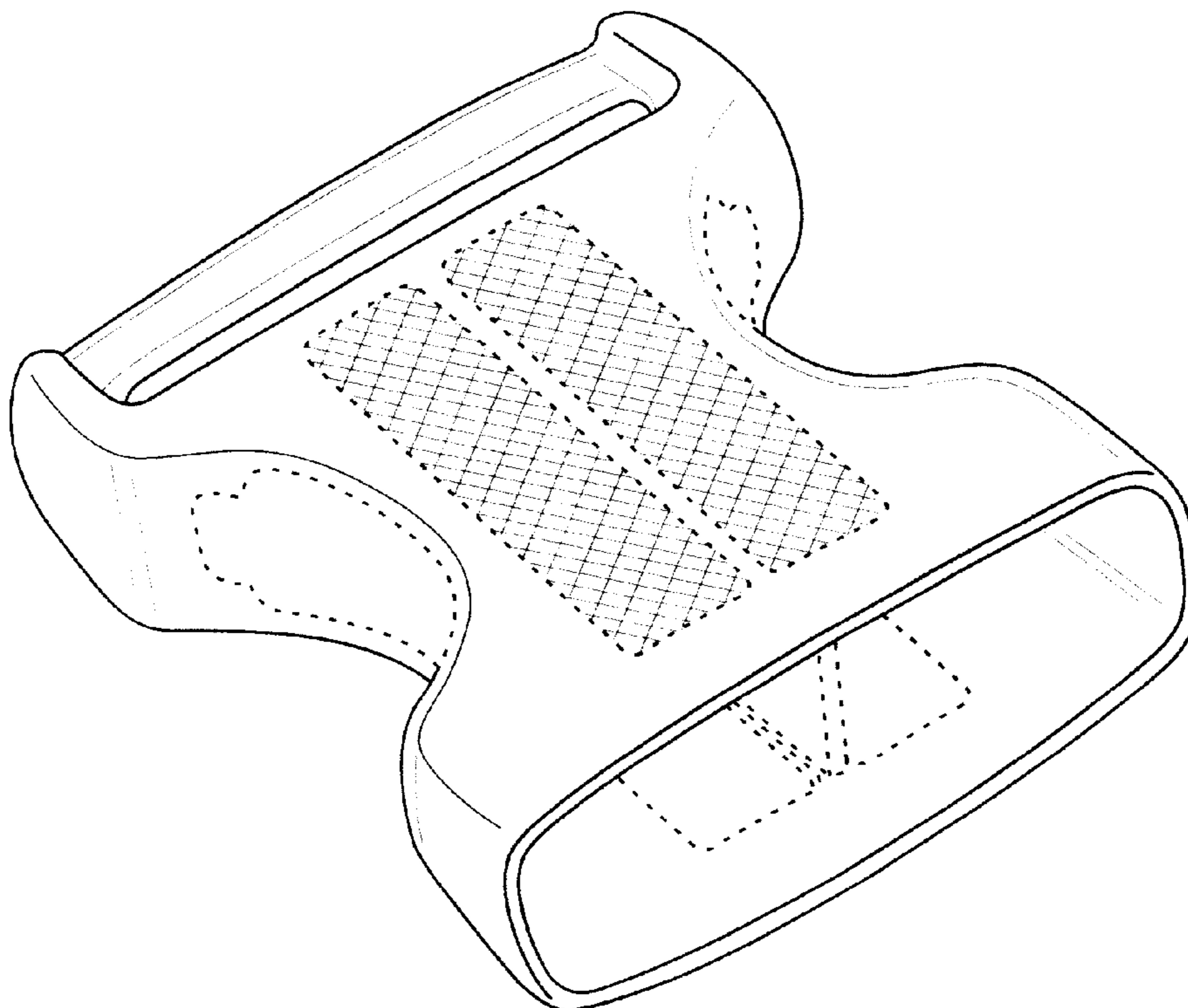
FIG. 7 is another side view thereof, opposite the side view of FIG. 6;

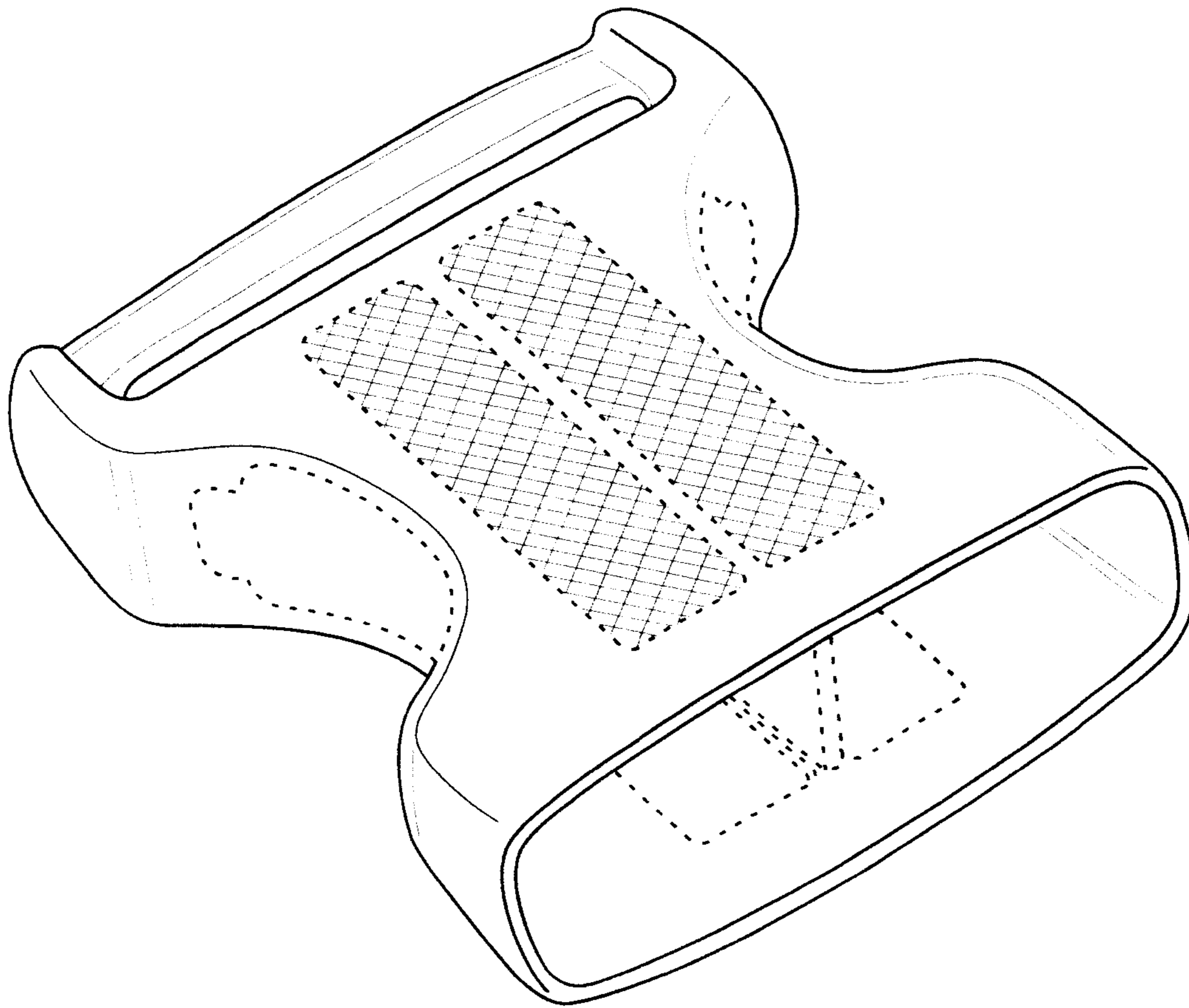
FIG. 8 is an end view thereof; and,

FIG. 9 is another end view thereof, opposite the end view of FIG. 8.

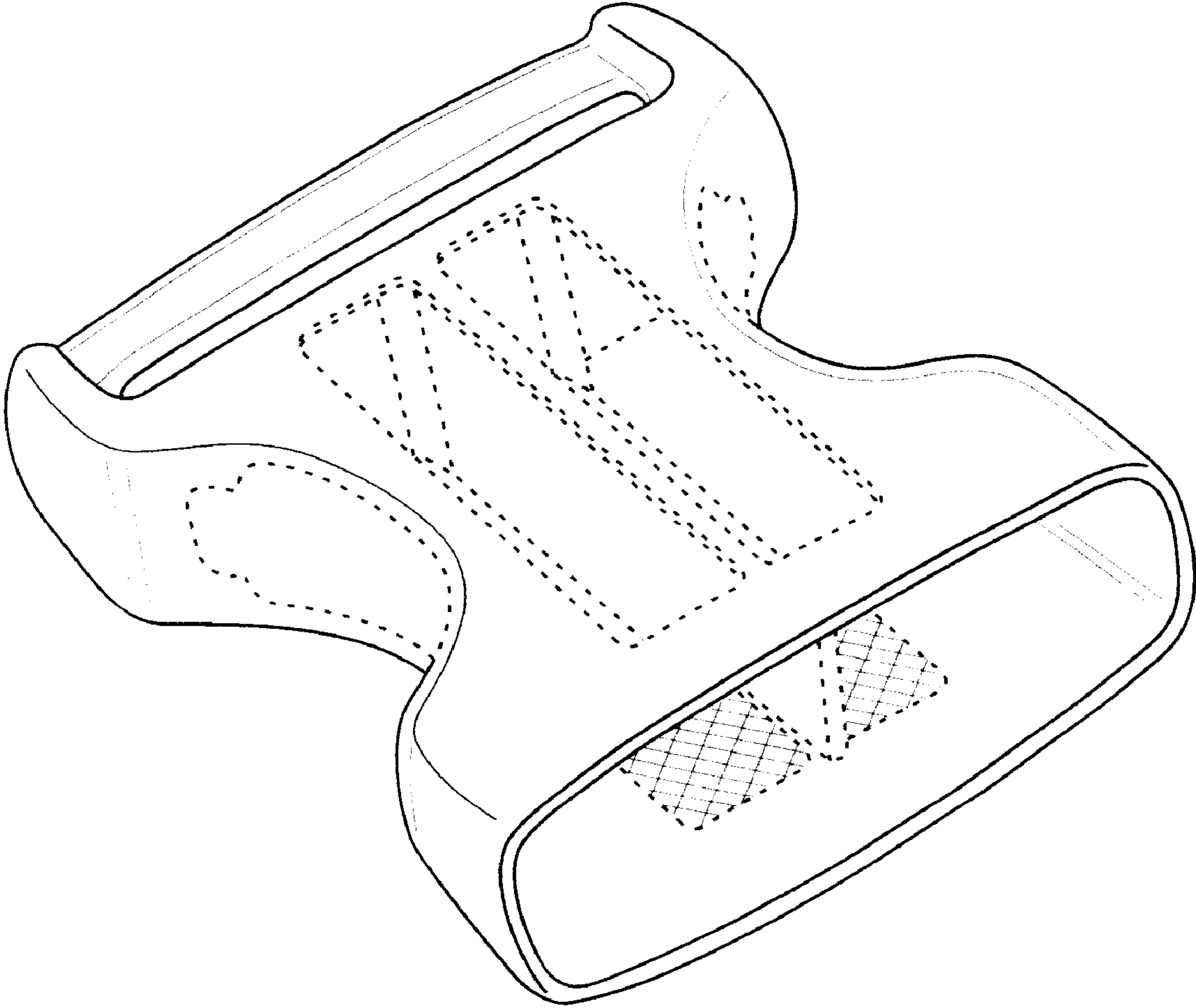

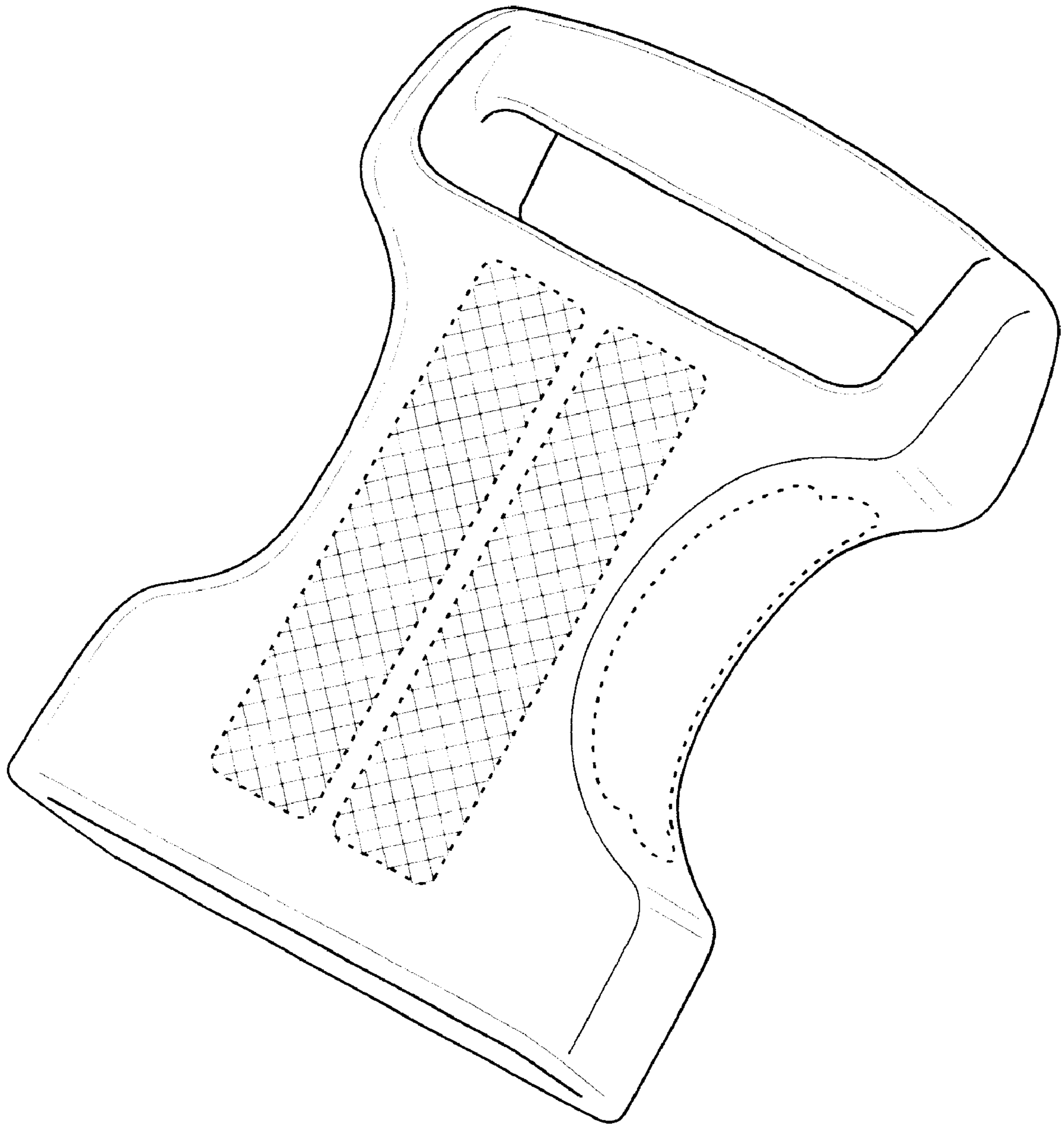




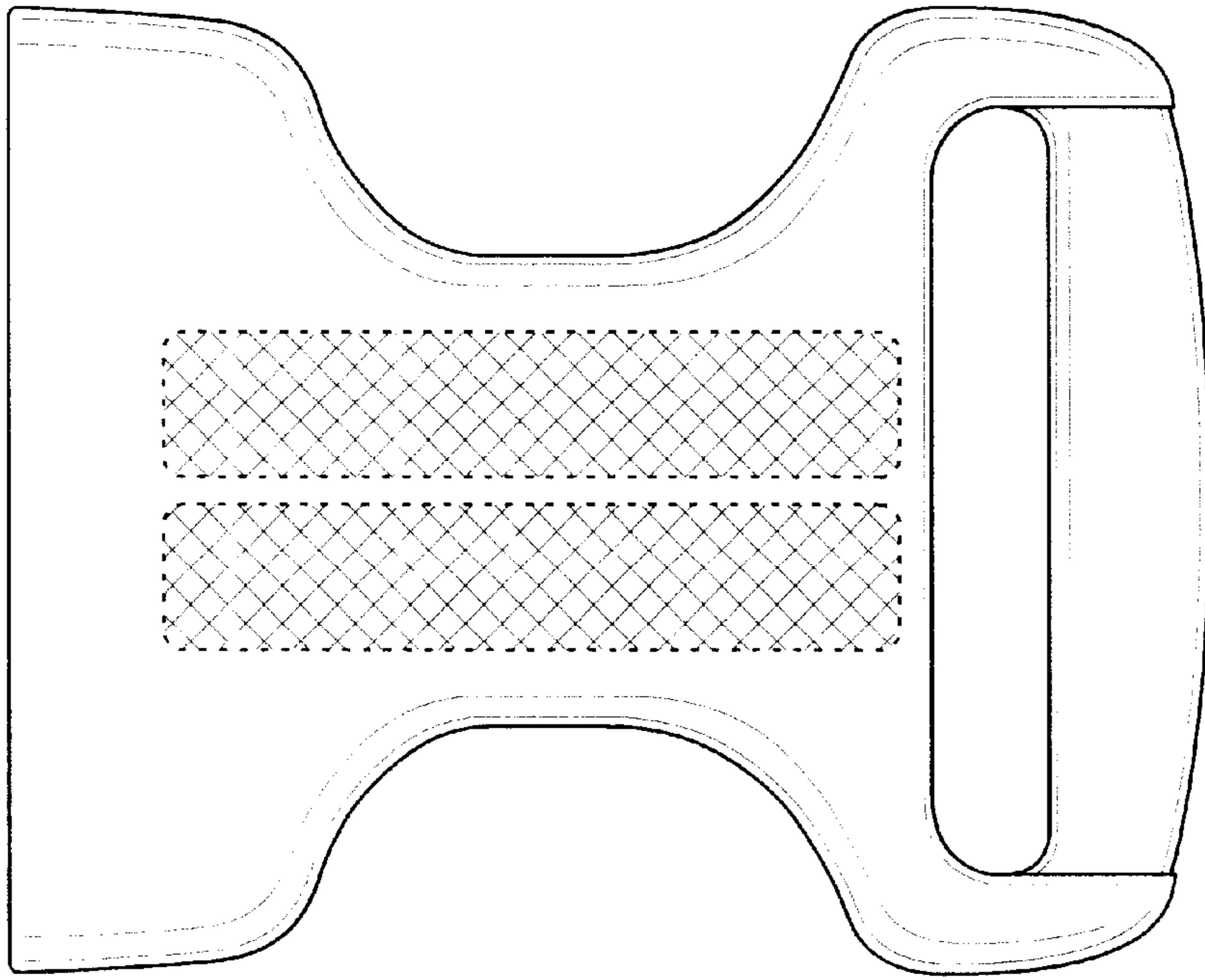

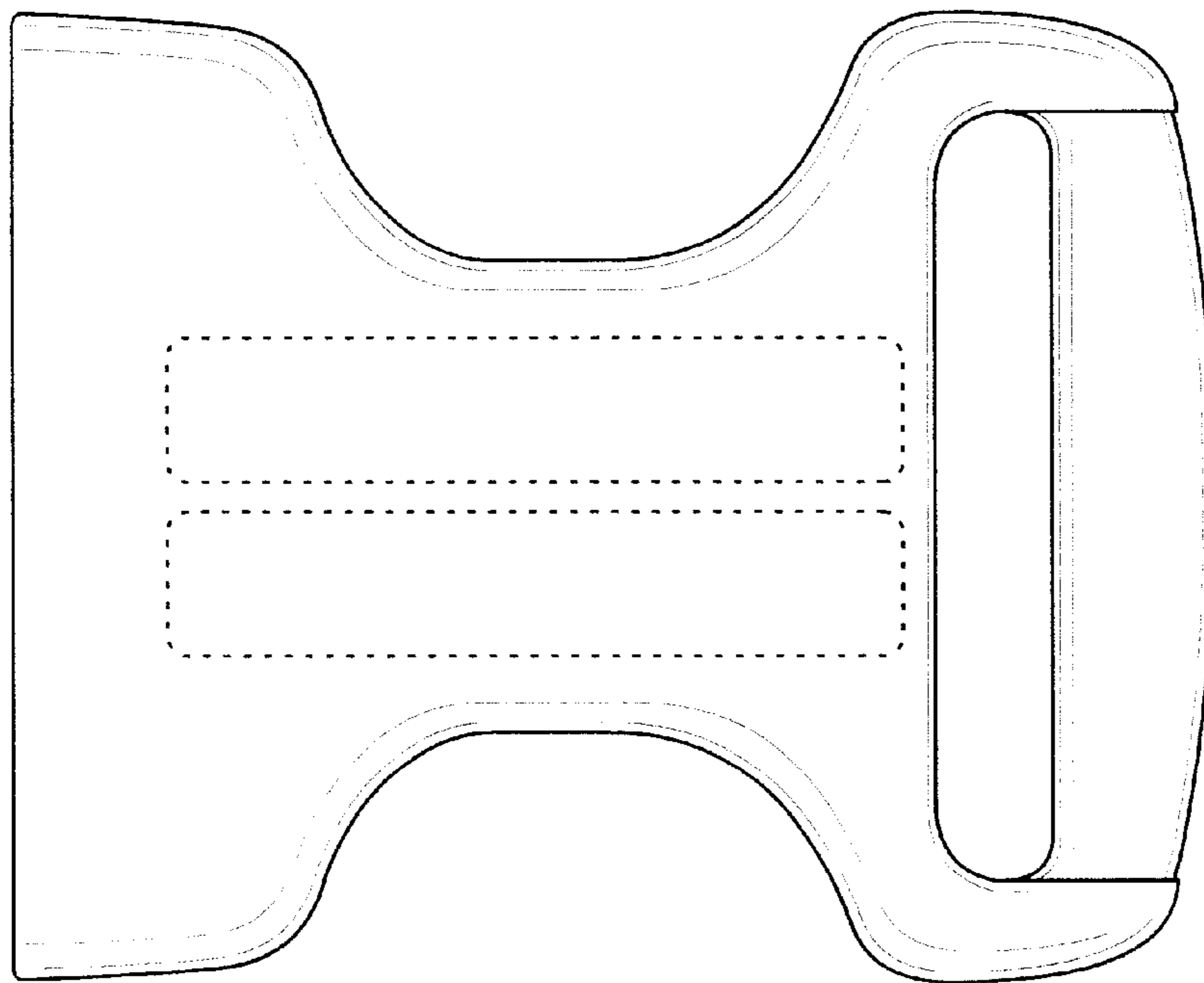

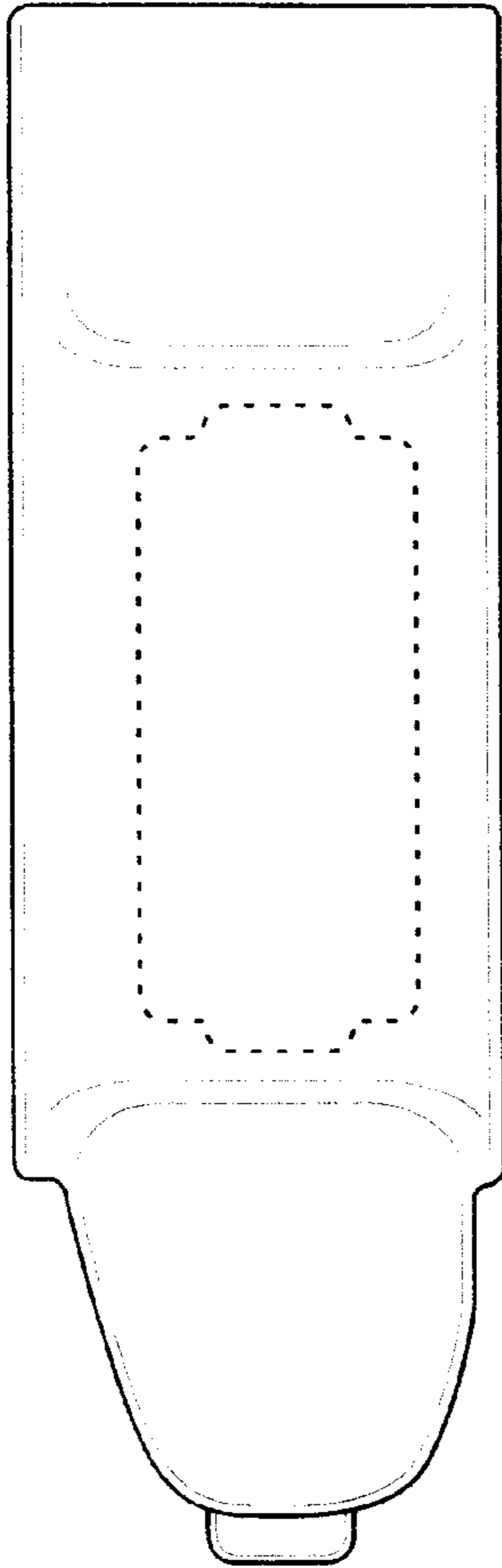

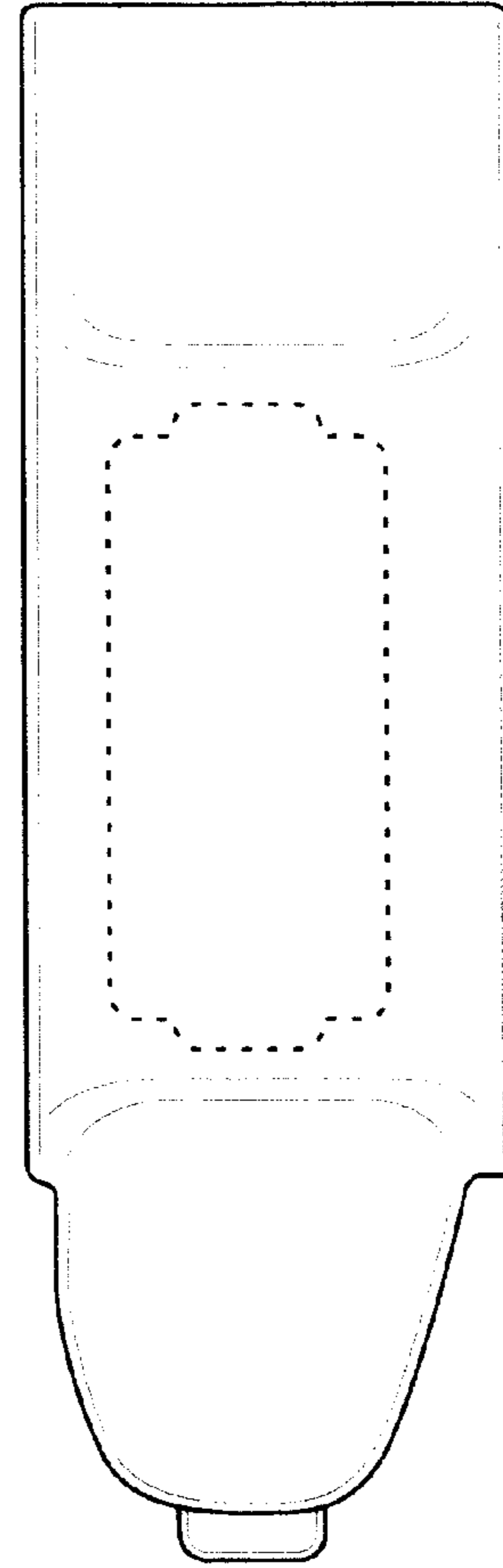

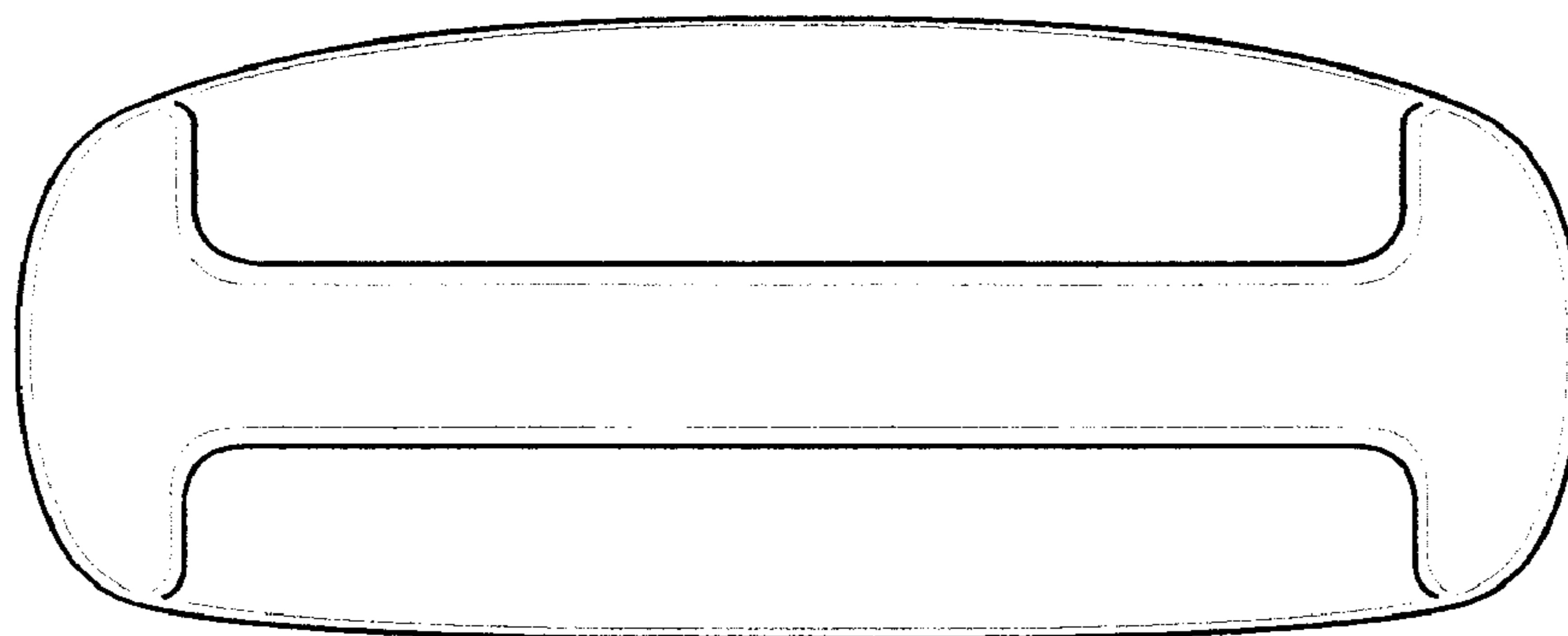

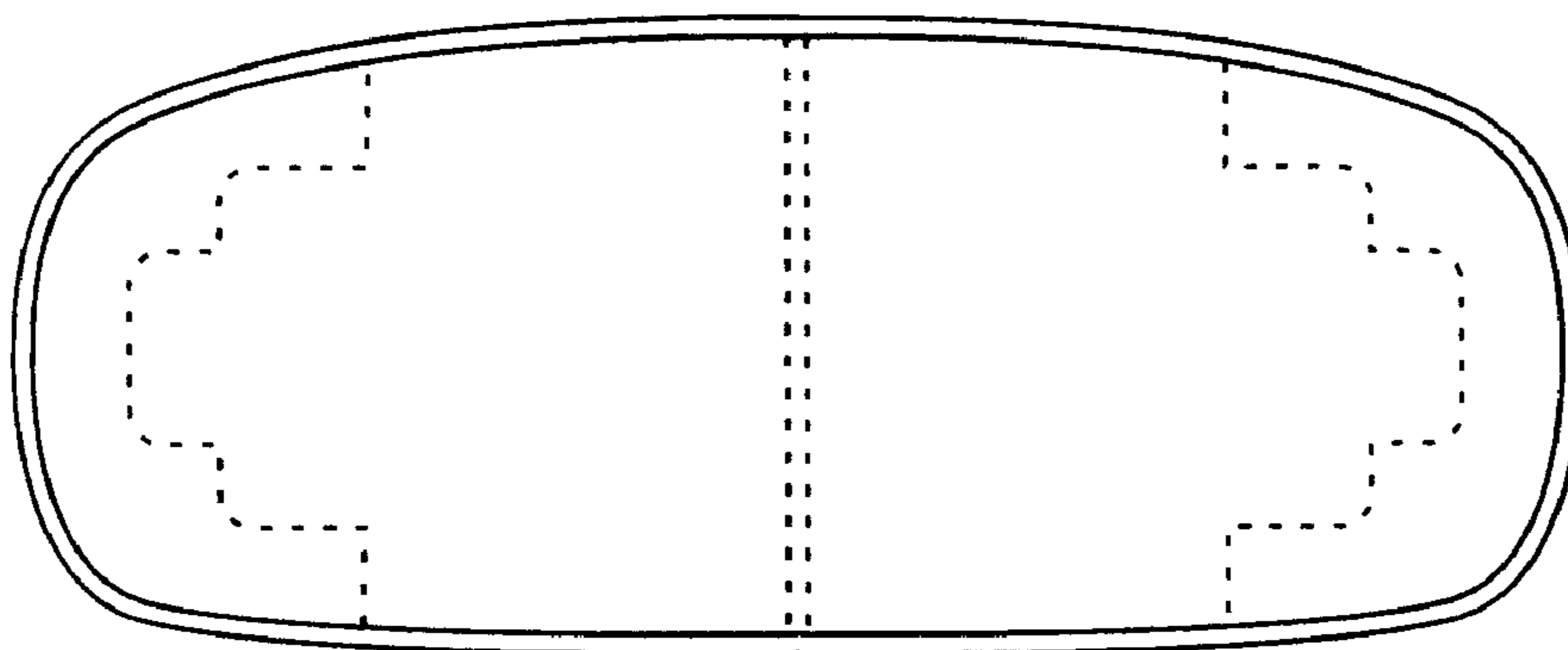
