(57) **CLAIM**

The ornamental design for a vehicle grill, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a vehicle grill showing the exemplary embodiment of my new design, with an exploded view of a mounting housing therefor shown in broken lines for illustrative purposes only so that it forms no part of the claimed design;

FIG. 2 is a right side view in elevation of the vehicle grill shown in FIG. 1 with an exploded view of the mounting housing shown in broken lines for illustrative purposes only so that it forms no part of the claimed design;

FIG. 3 is a front view in elevation of the vehicle grill shown in FIG. 1;

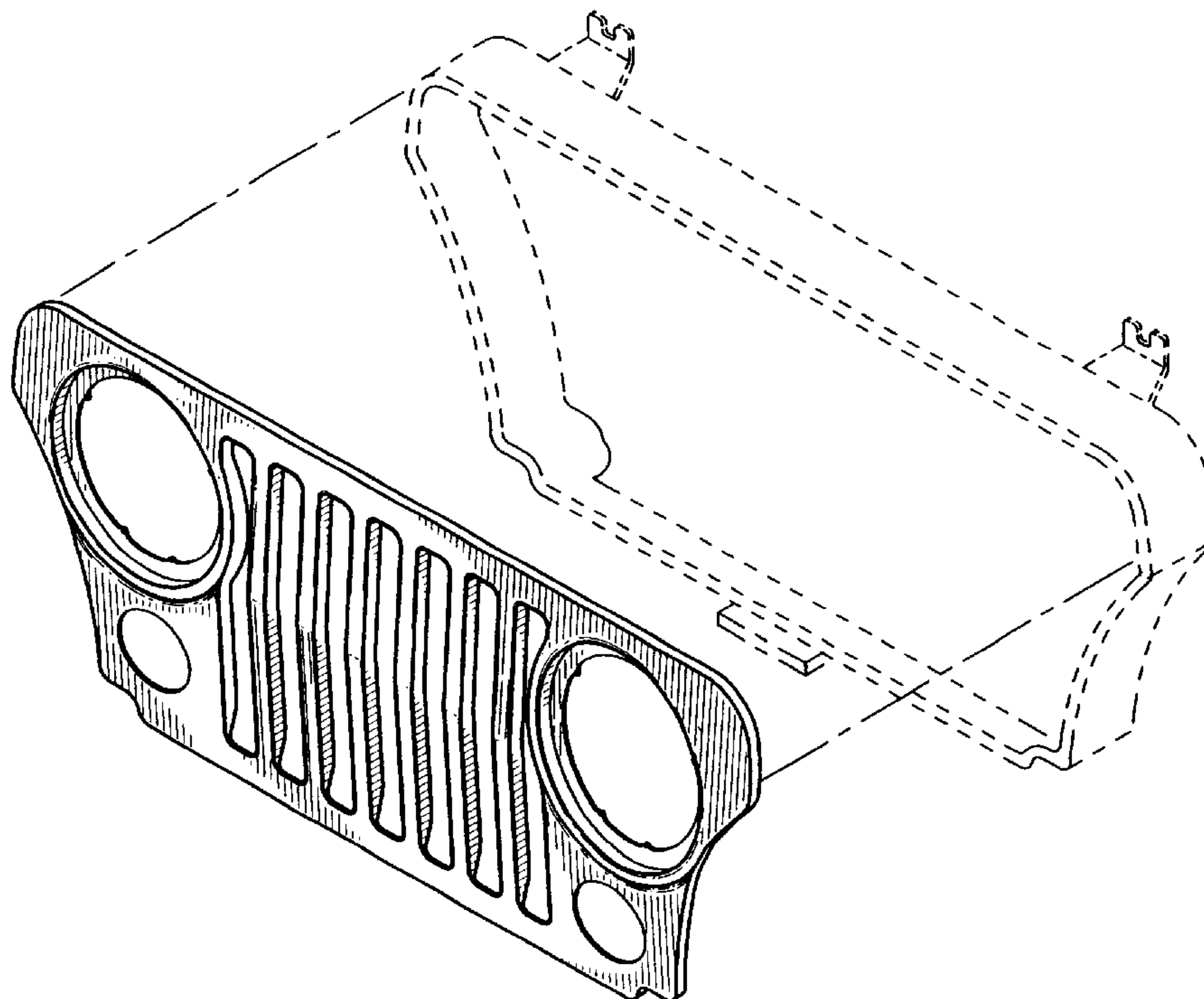
FIG. 4 is a rear view in elevation of the vehicle grill shown in FIG. 1;

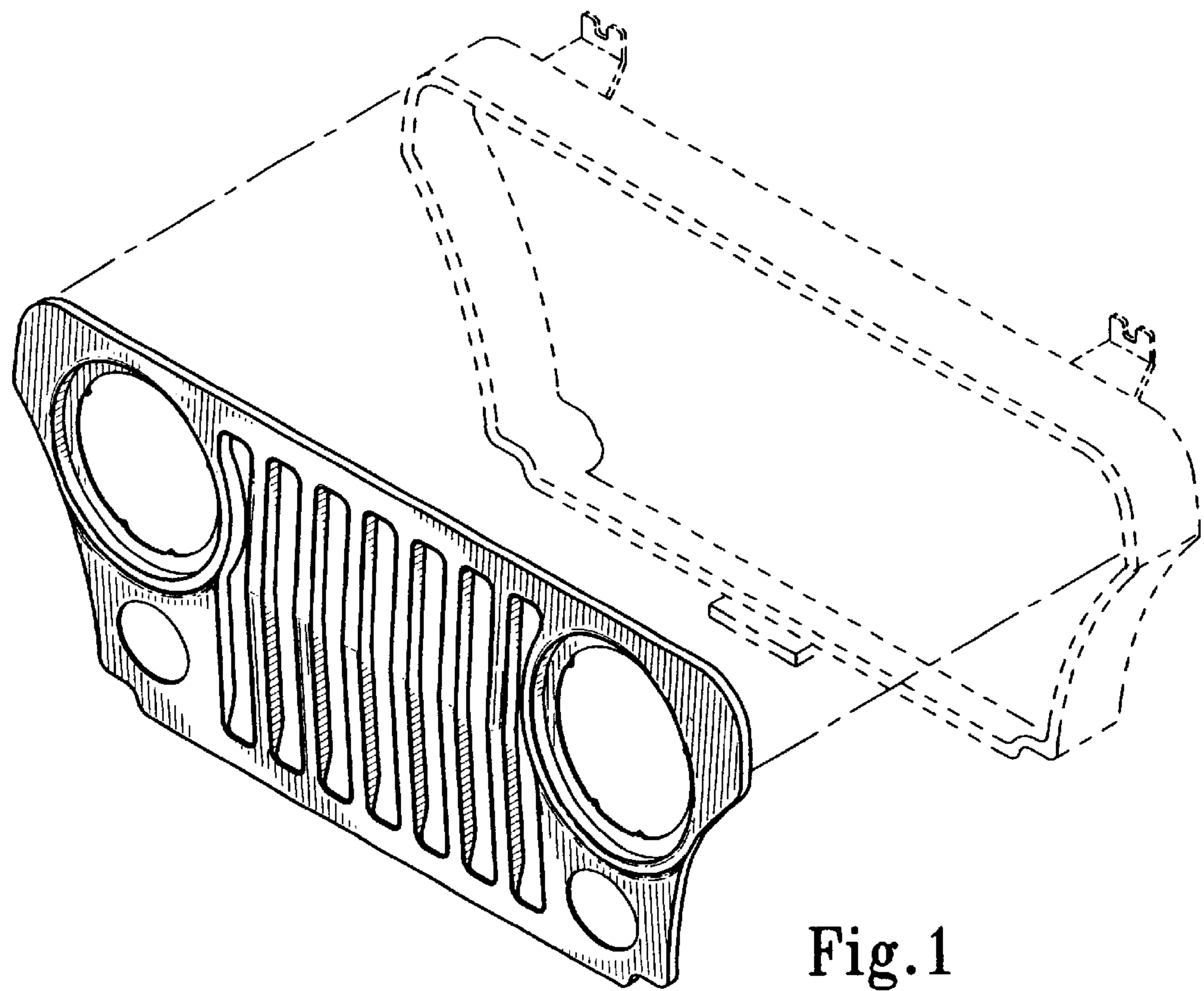

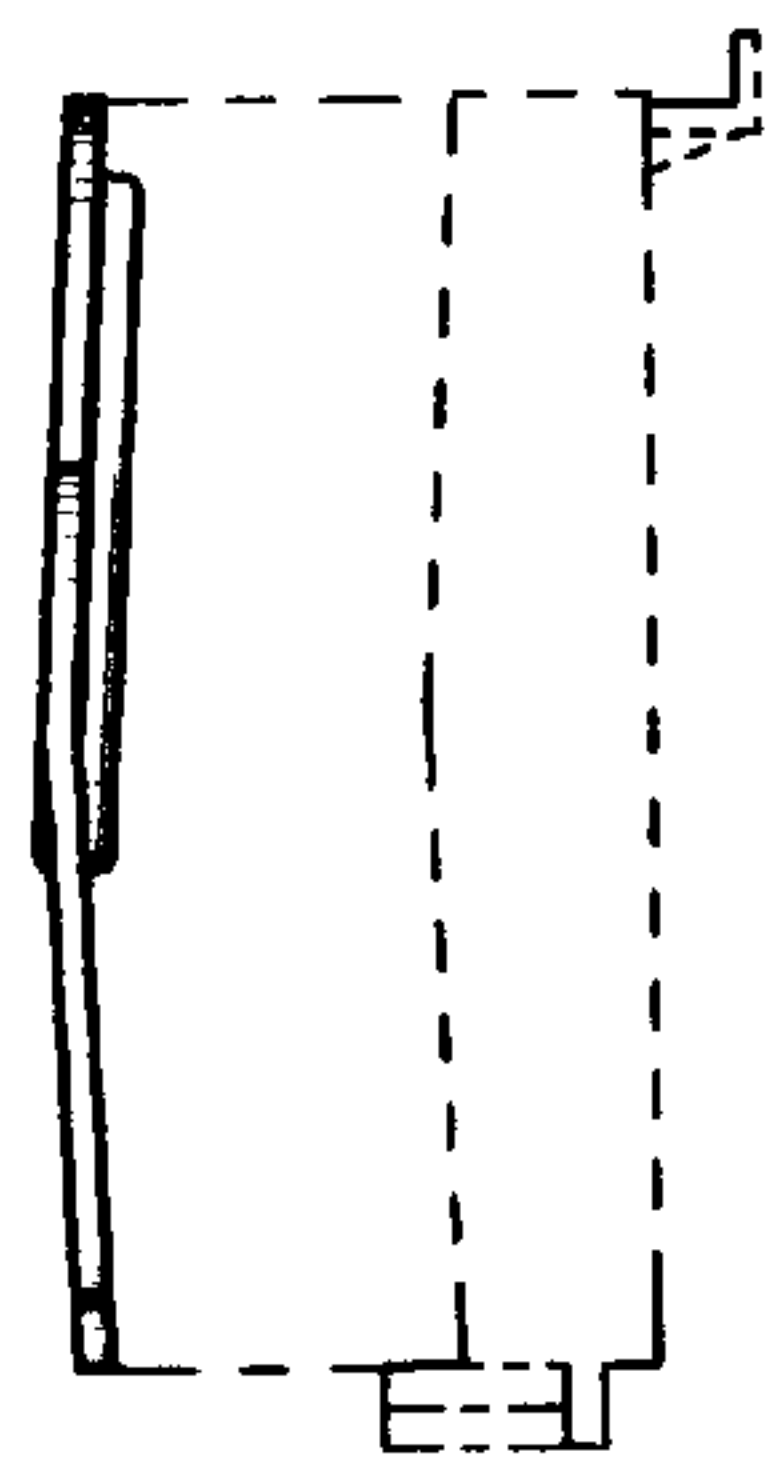

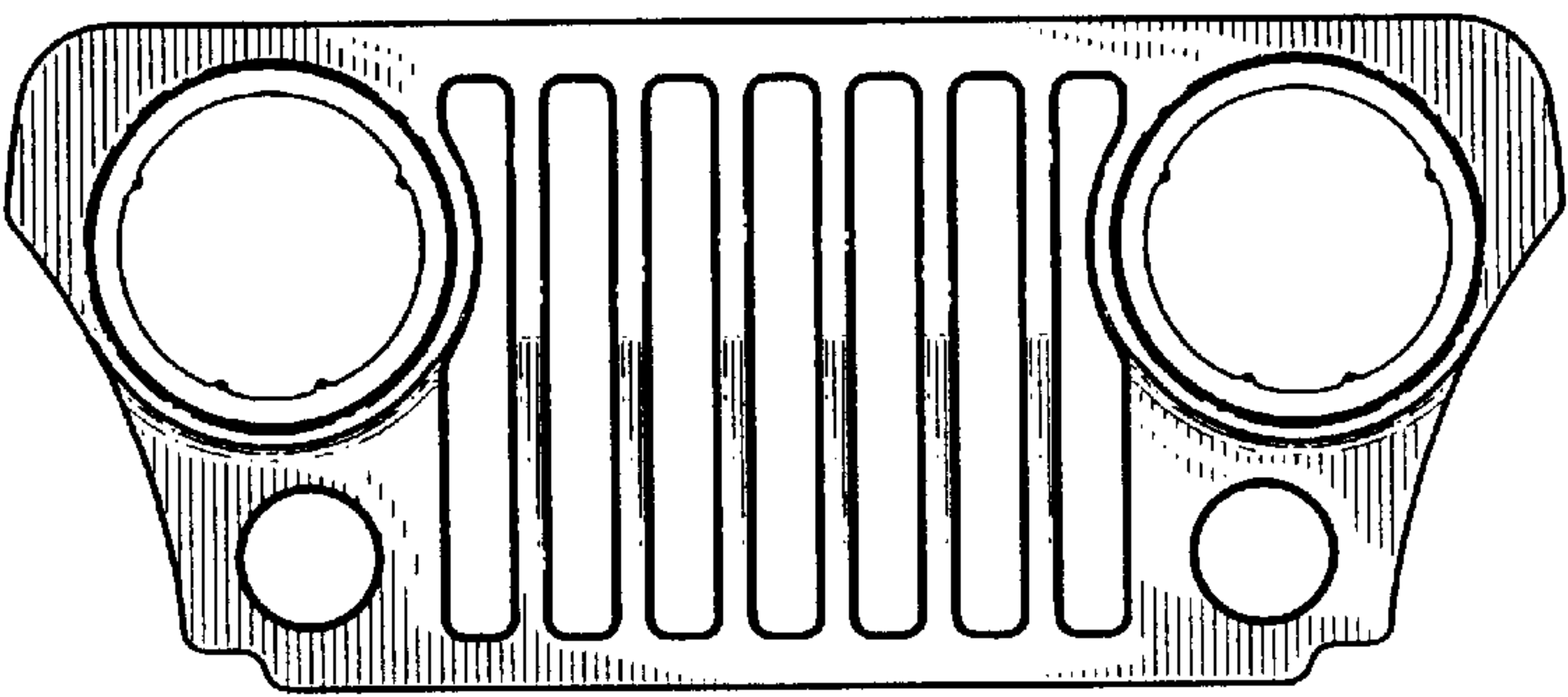

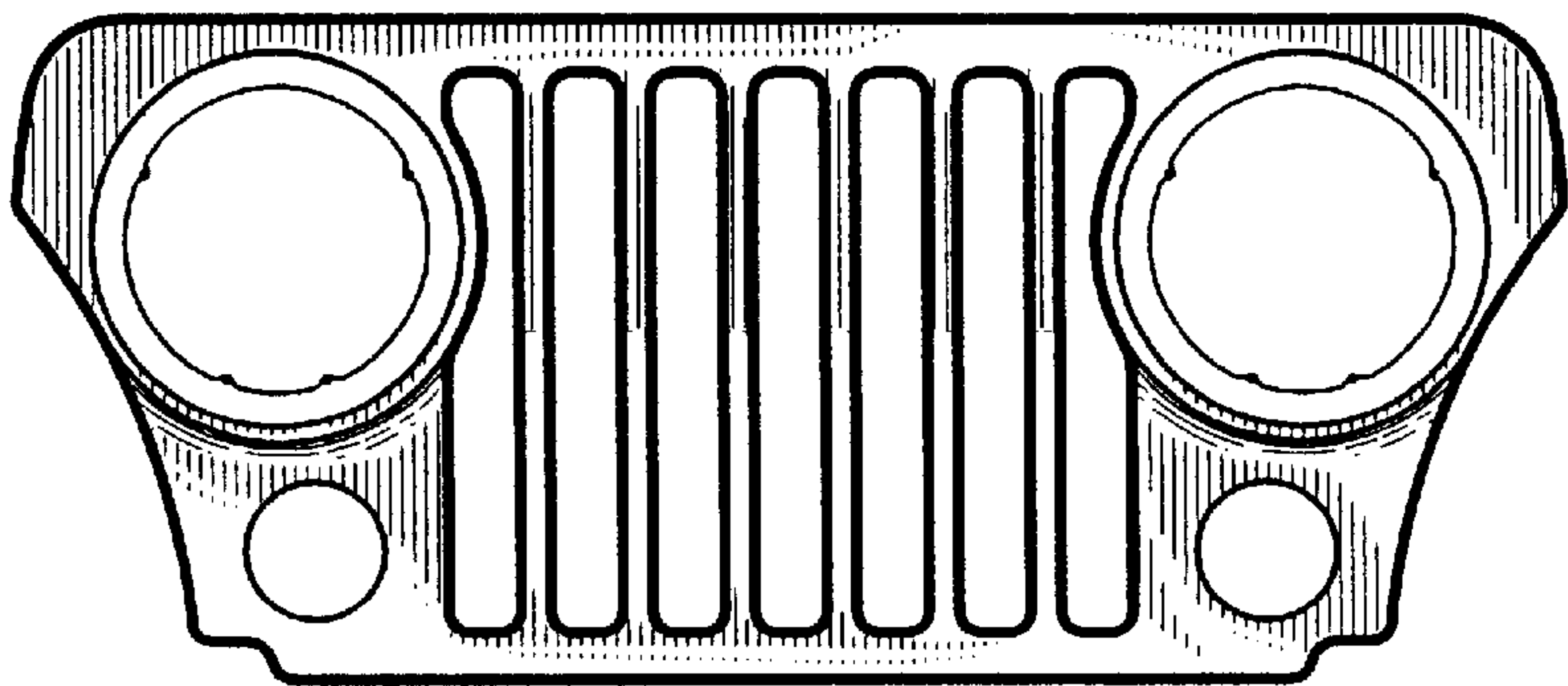

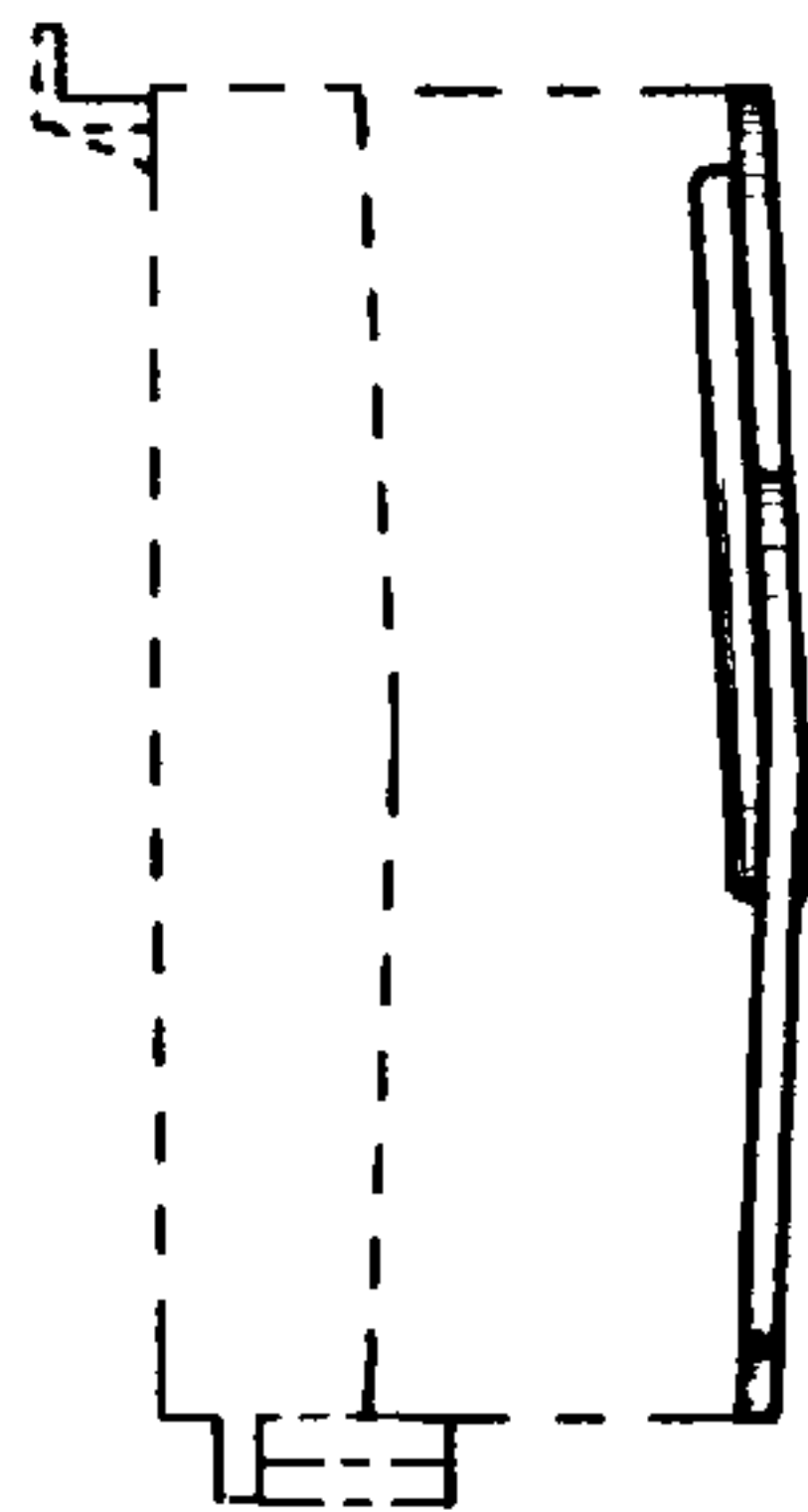

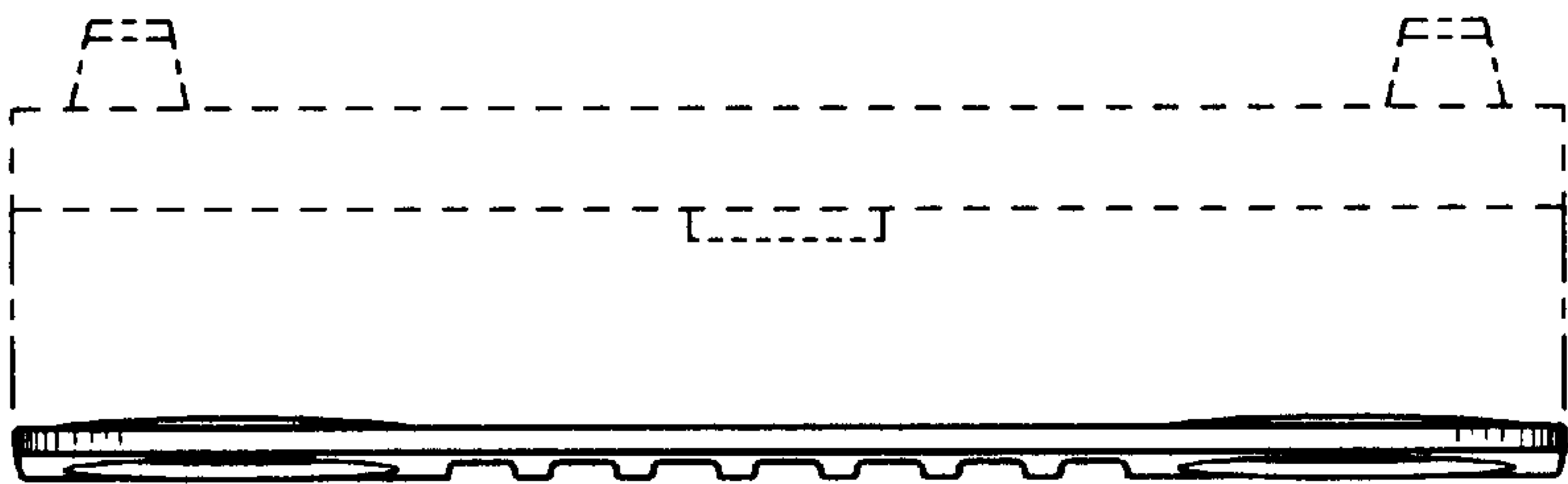

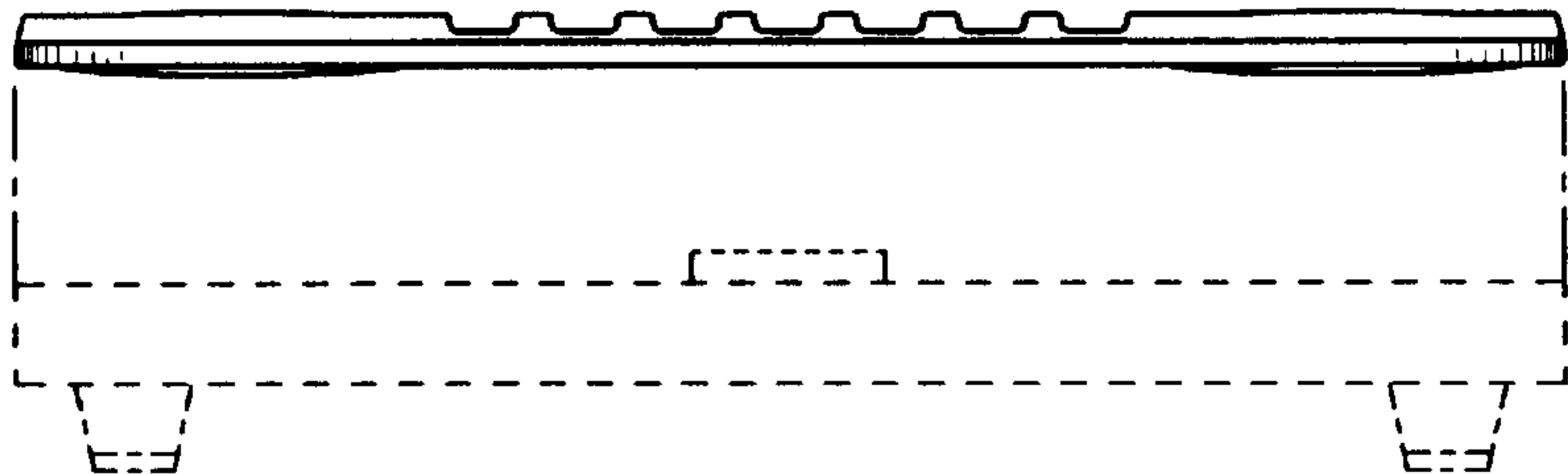
