I claim, the ornamental design for a cellular phone, as shown and described.

DESCRIPTION

FIG. 1 is a top and front perspective view of a cellular phone, showing our new design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a rear elevational view thereof;
FIG. 4 is a left side elevational view thereof;

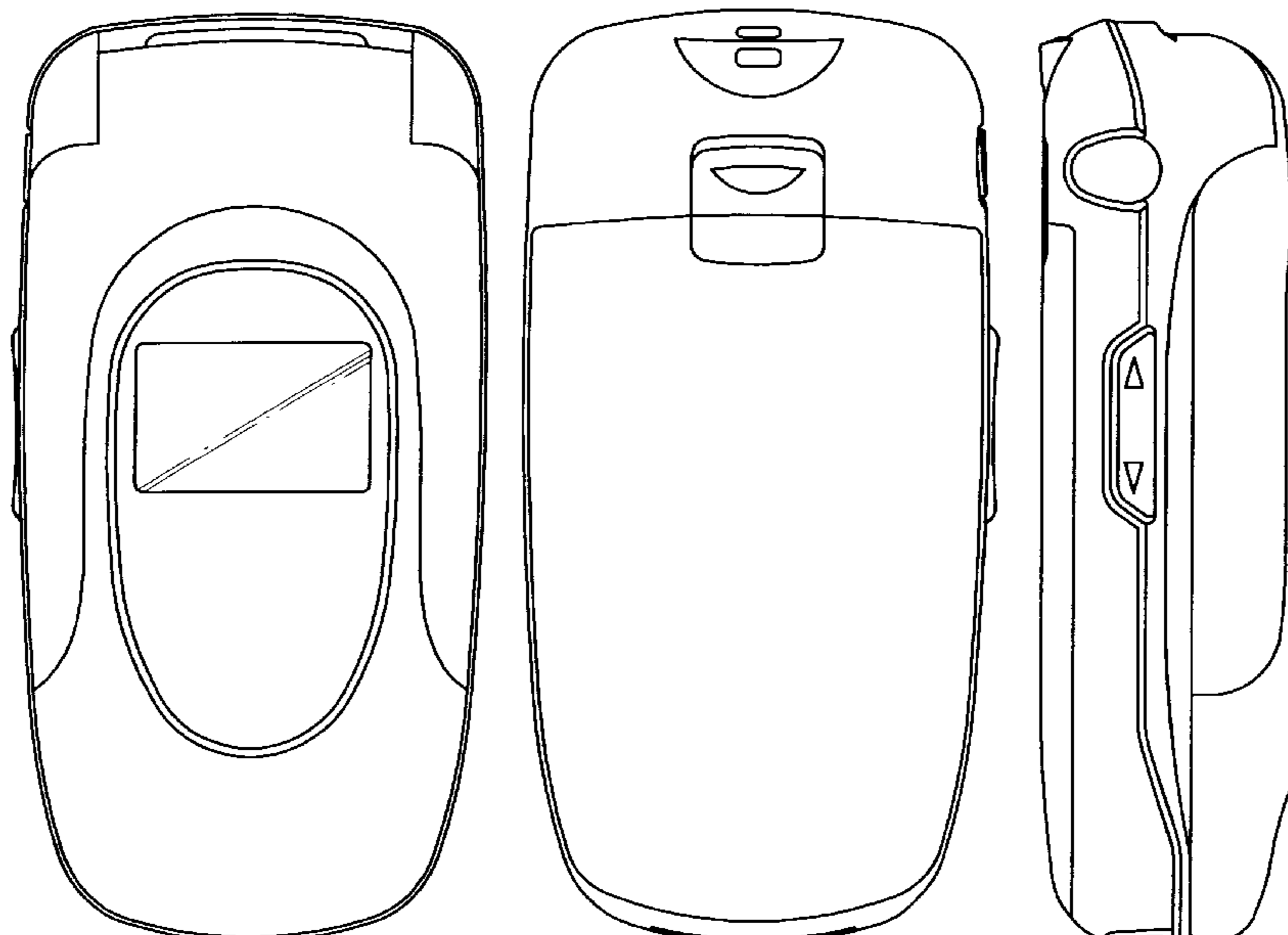

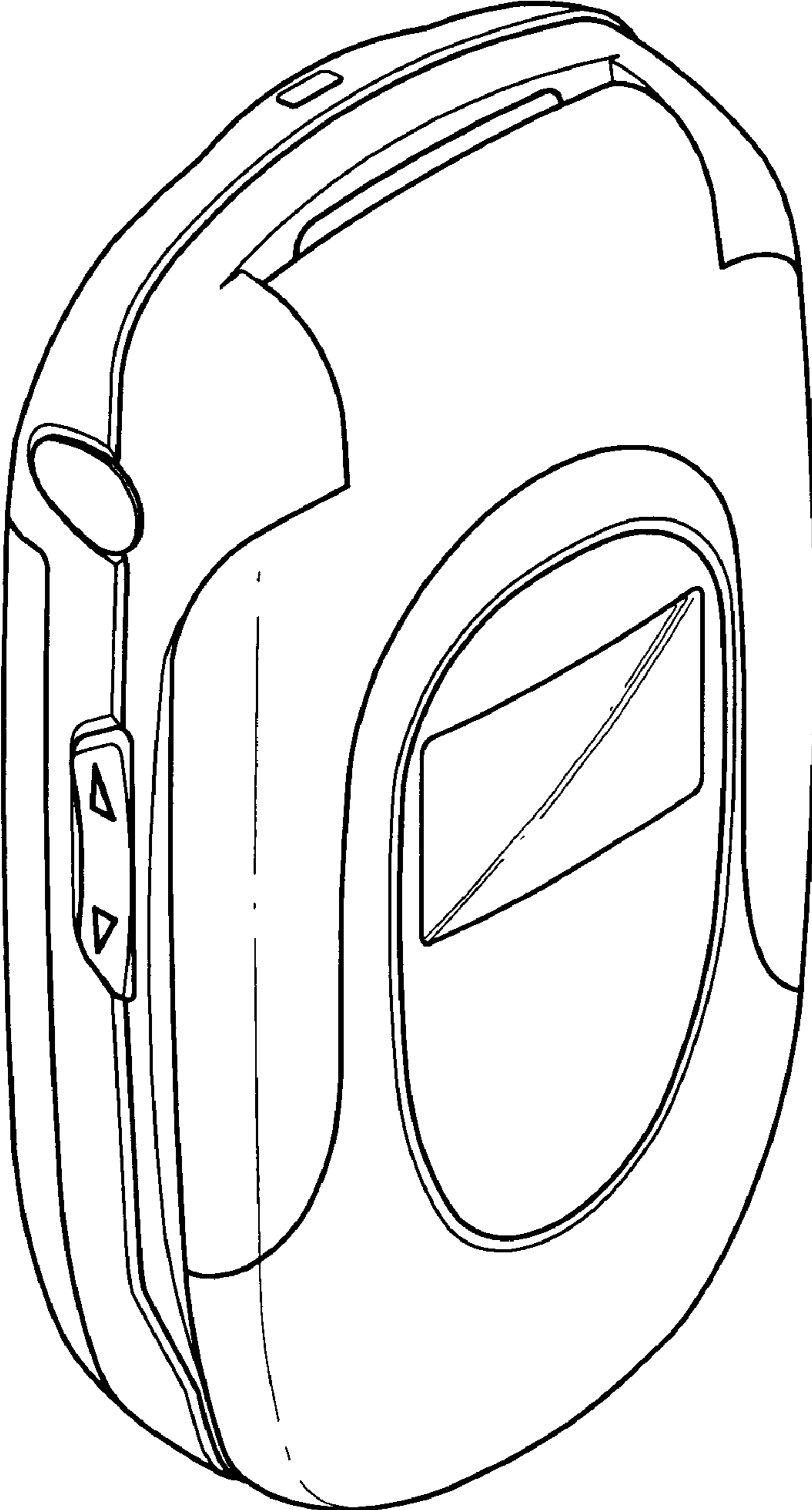

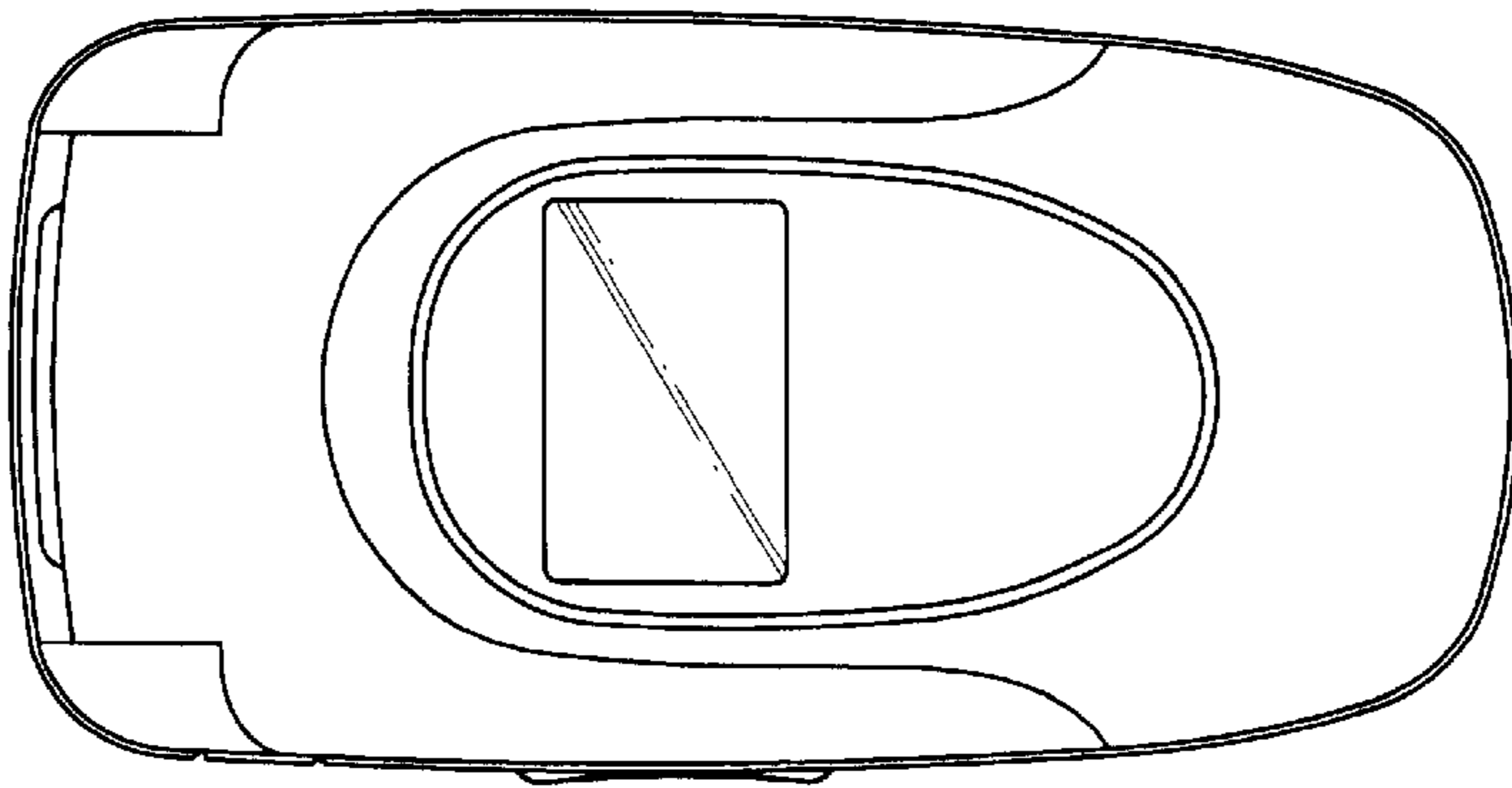

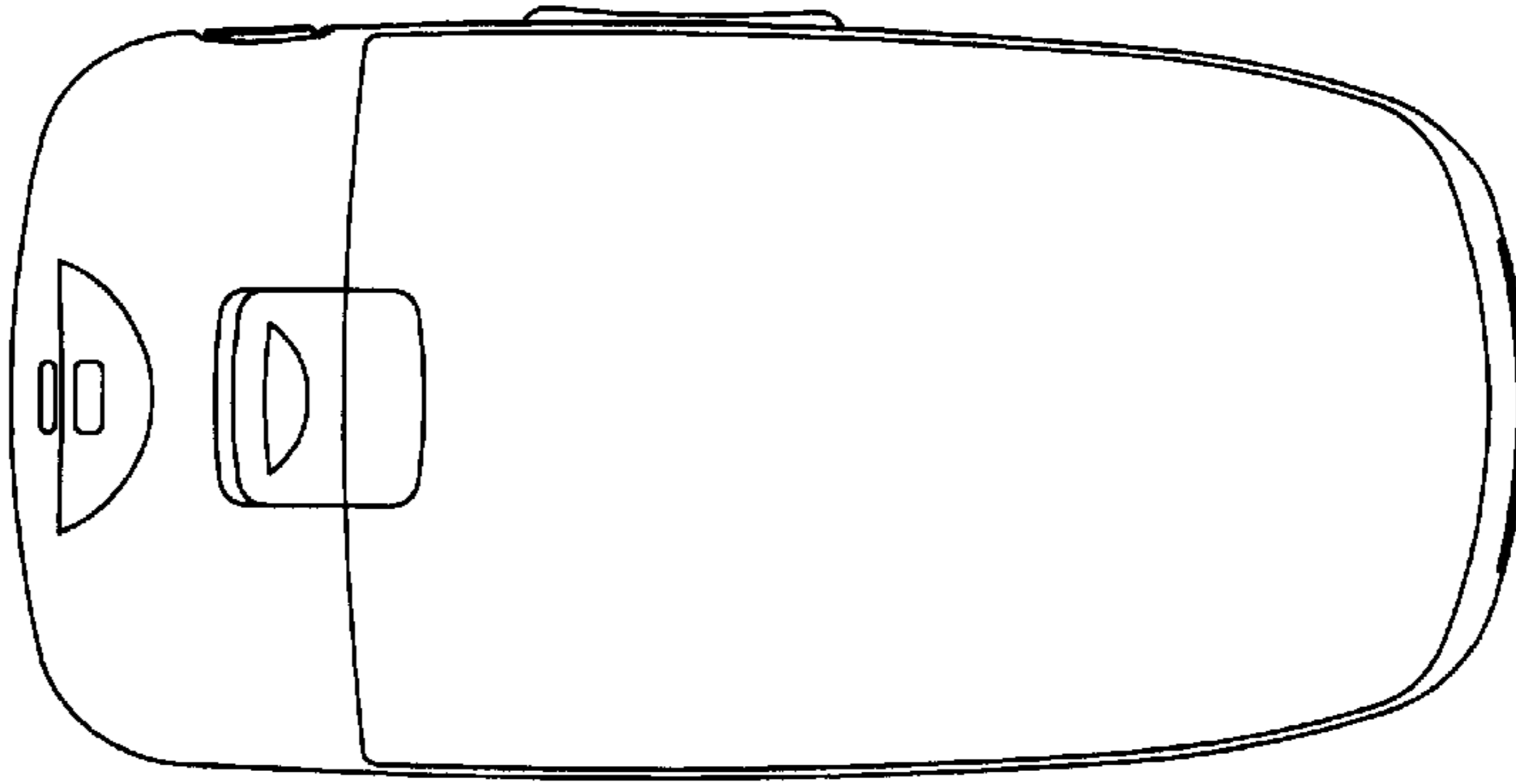

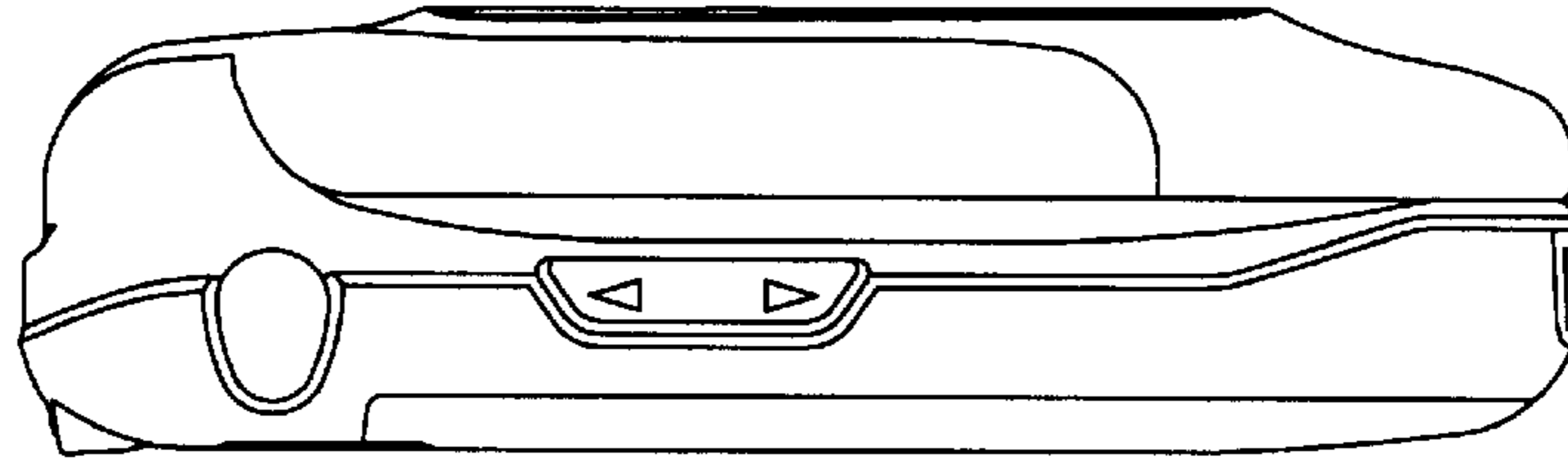

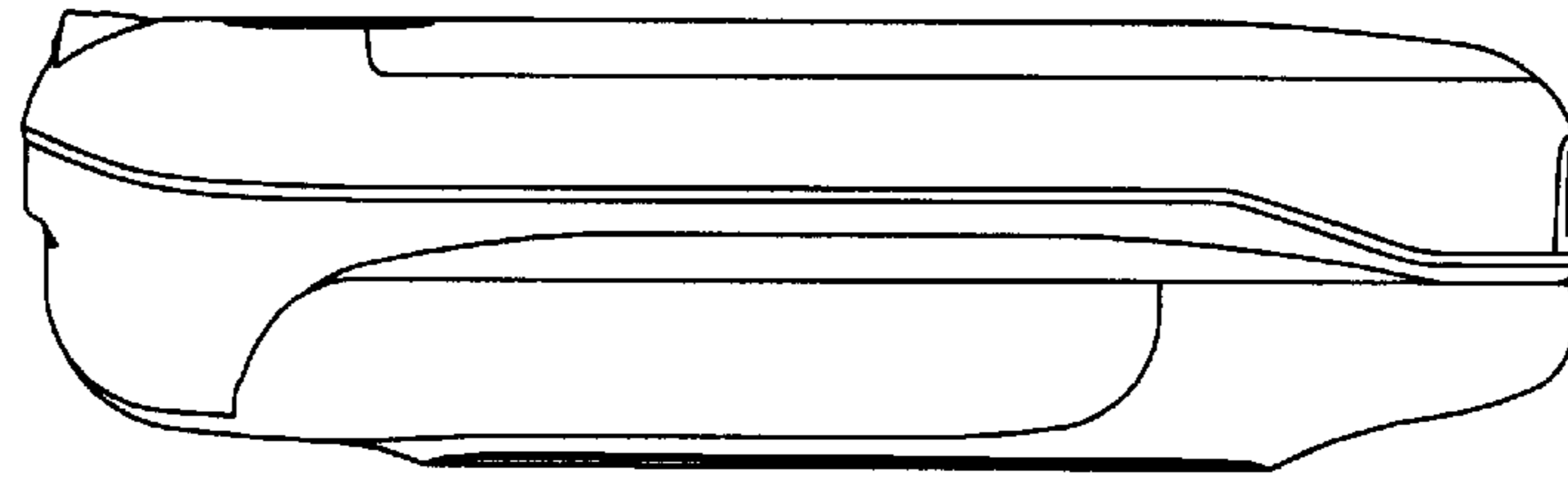

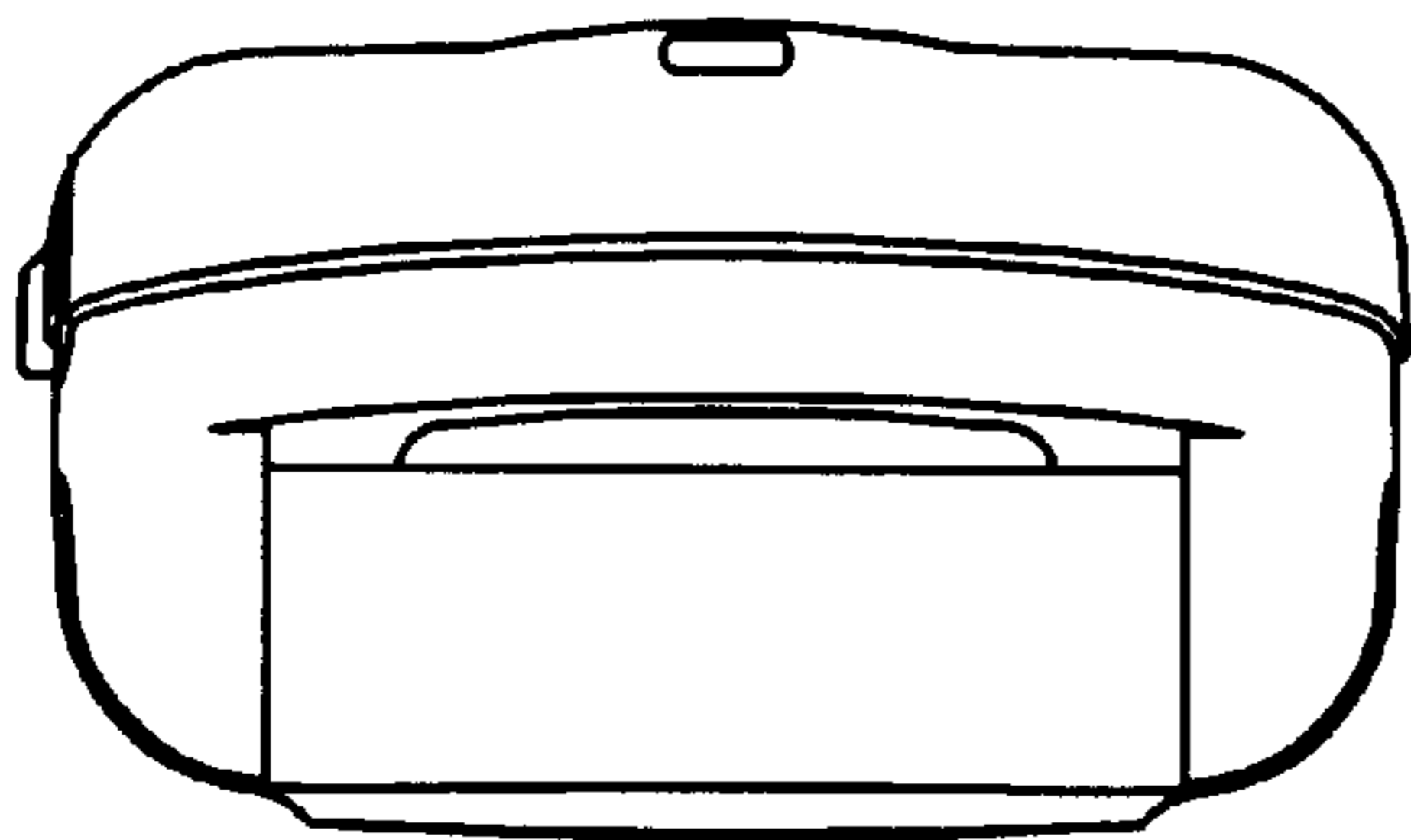
