(57) **CLAIM**

The ornamental design for a surface mount box, as shown and described.

DESCRIPTION

FIG. 1 is a front and top perspective view of a surface mount box showing our new design;

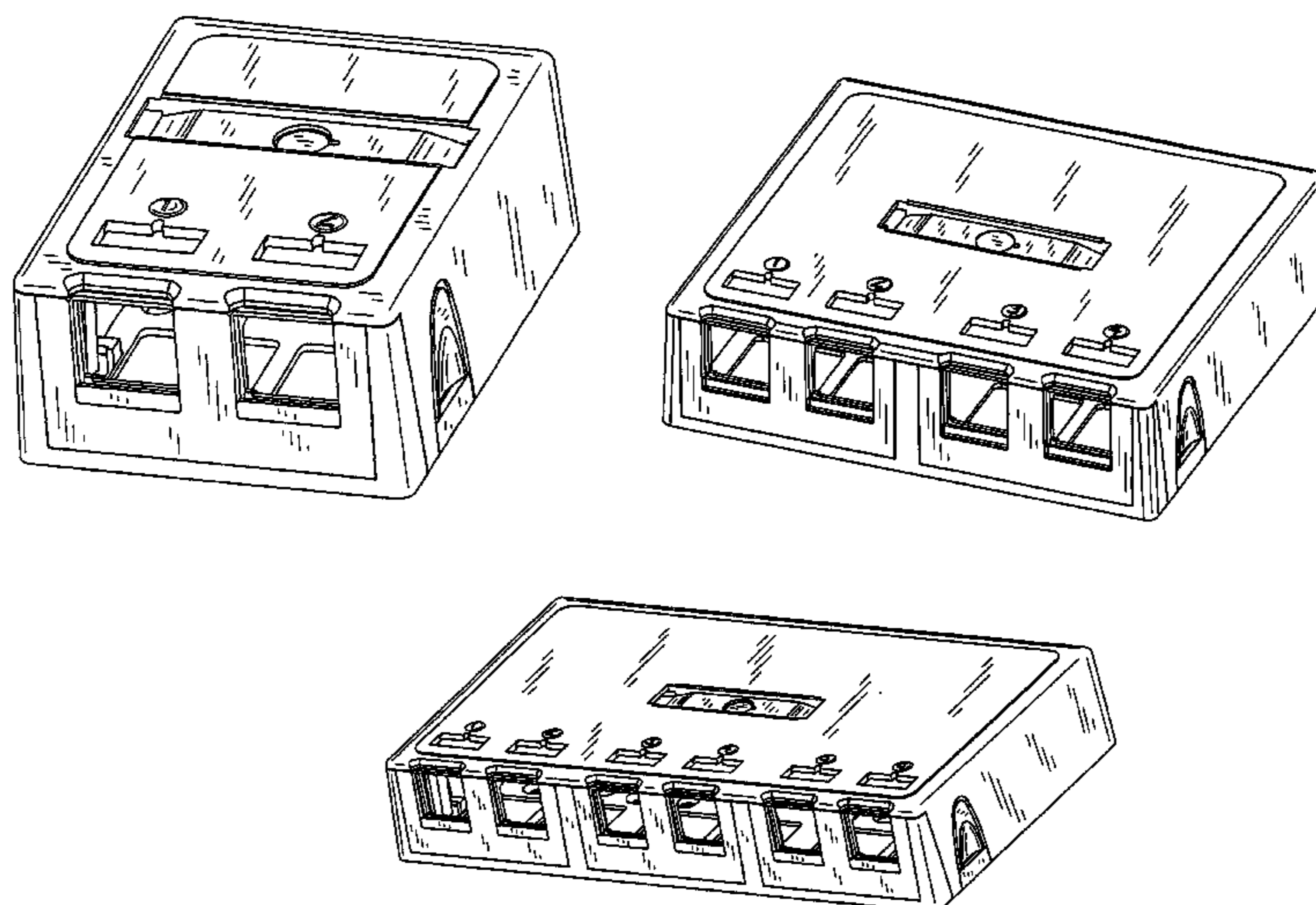

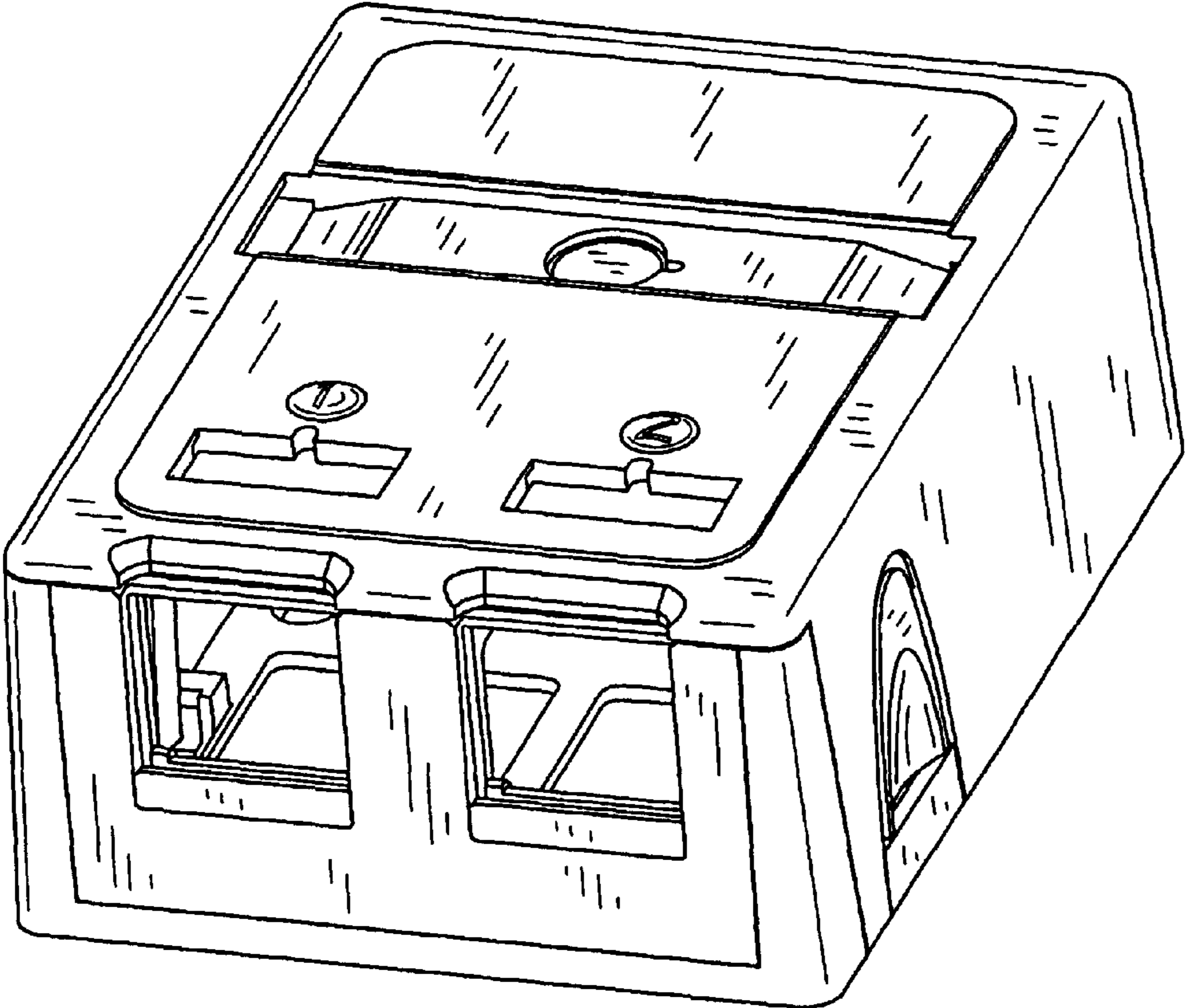

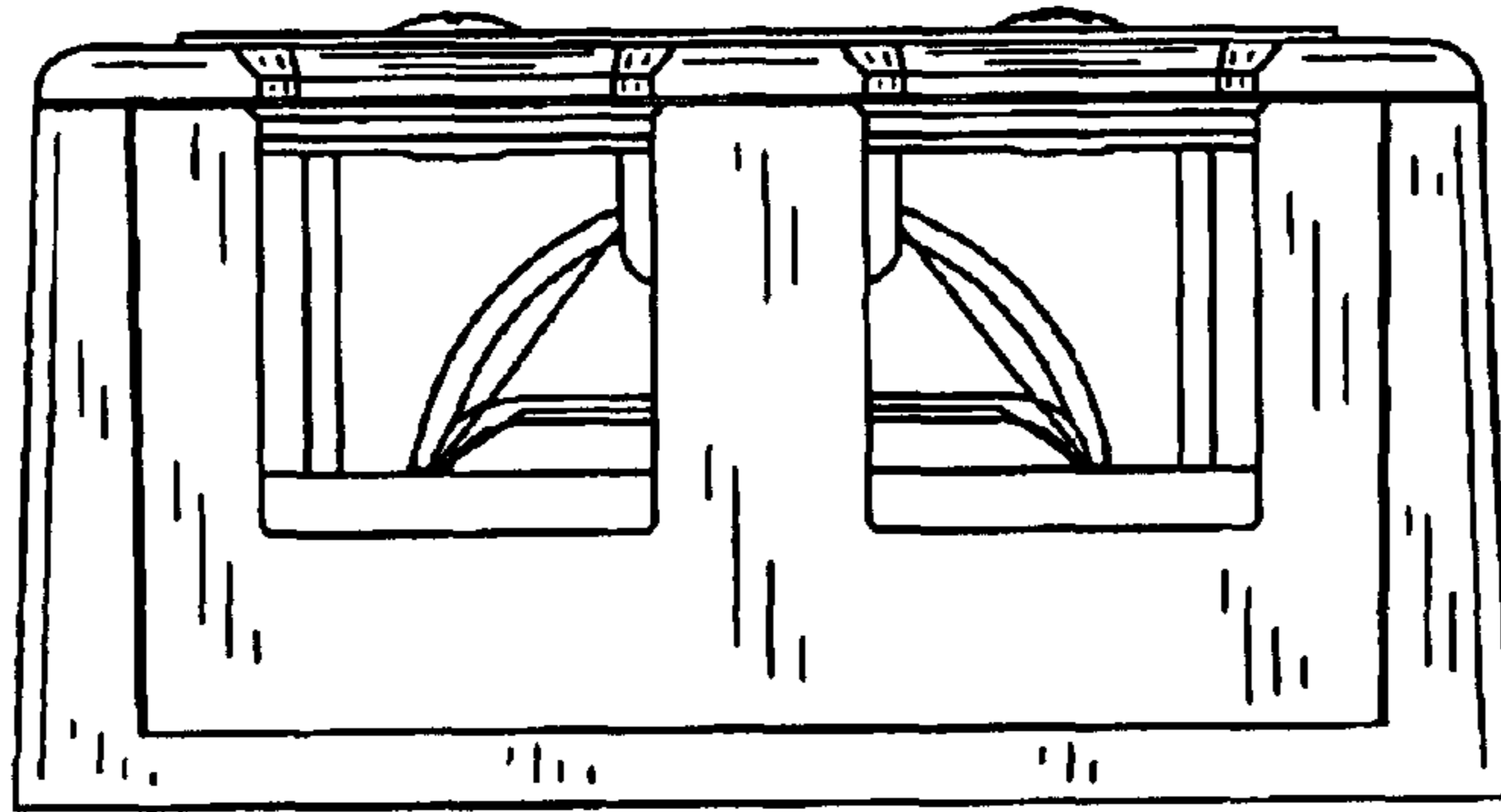

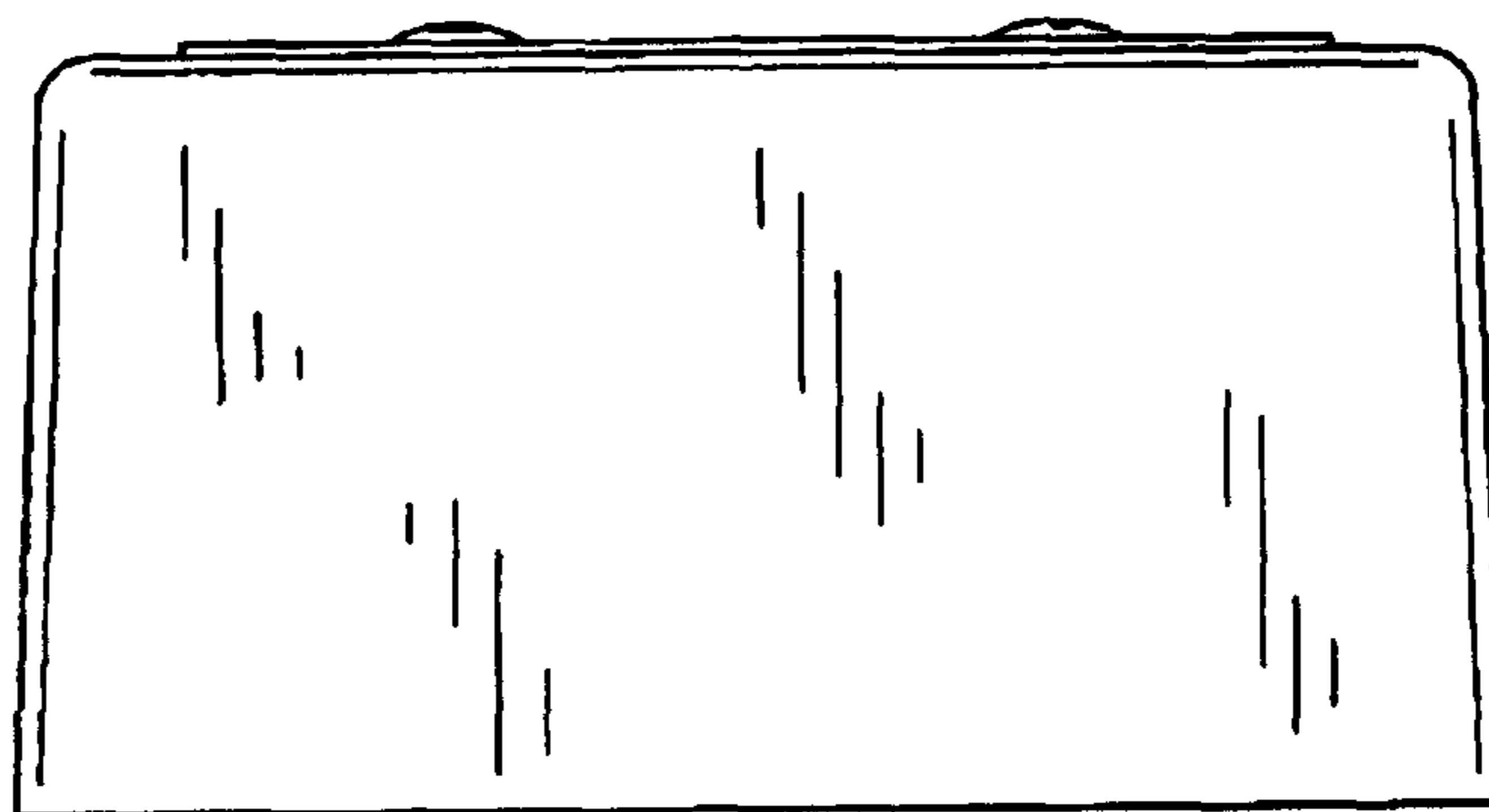

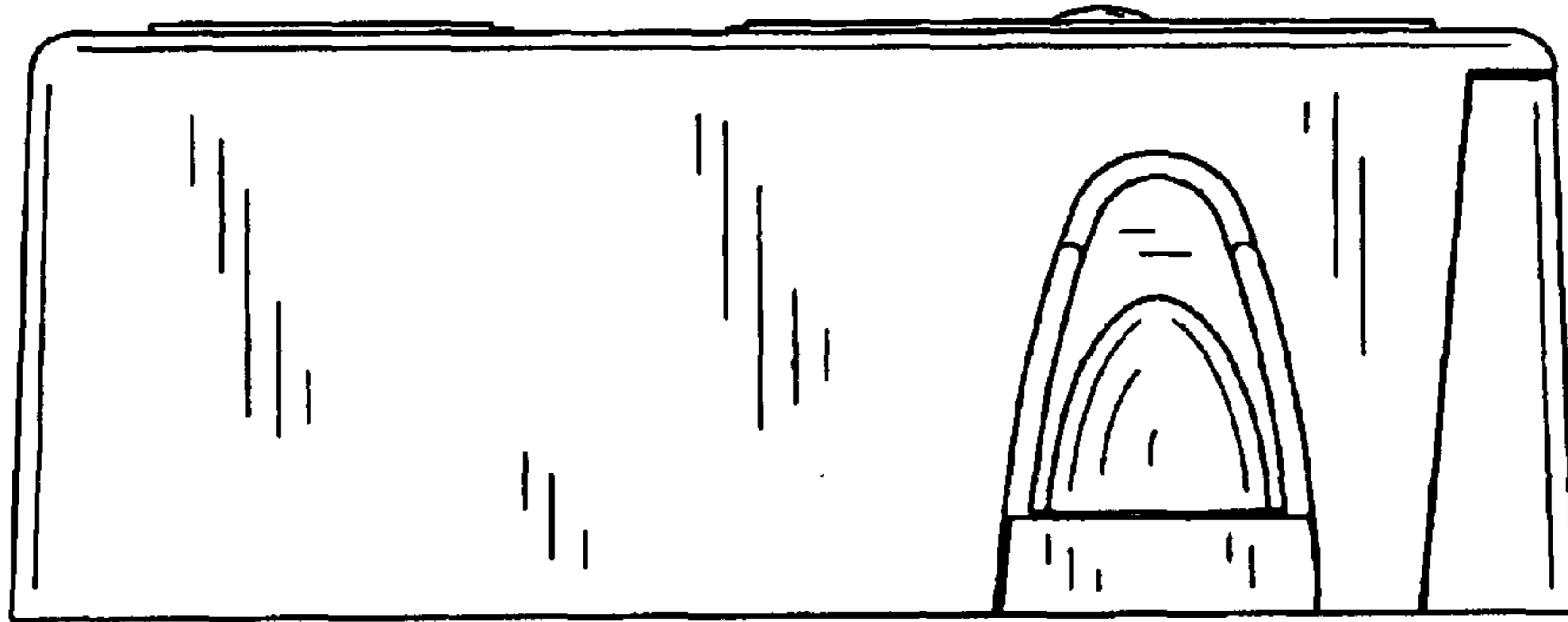

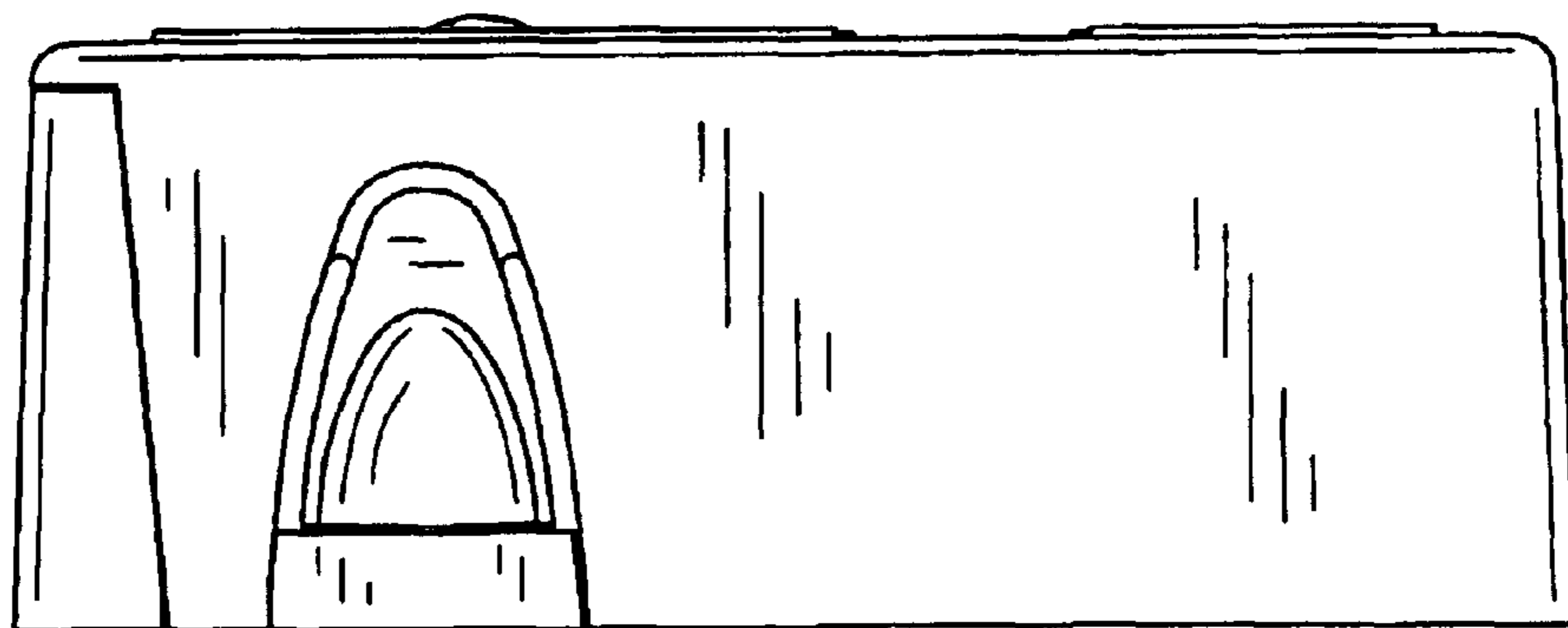

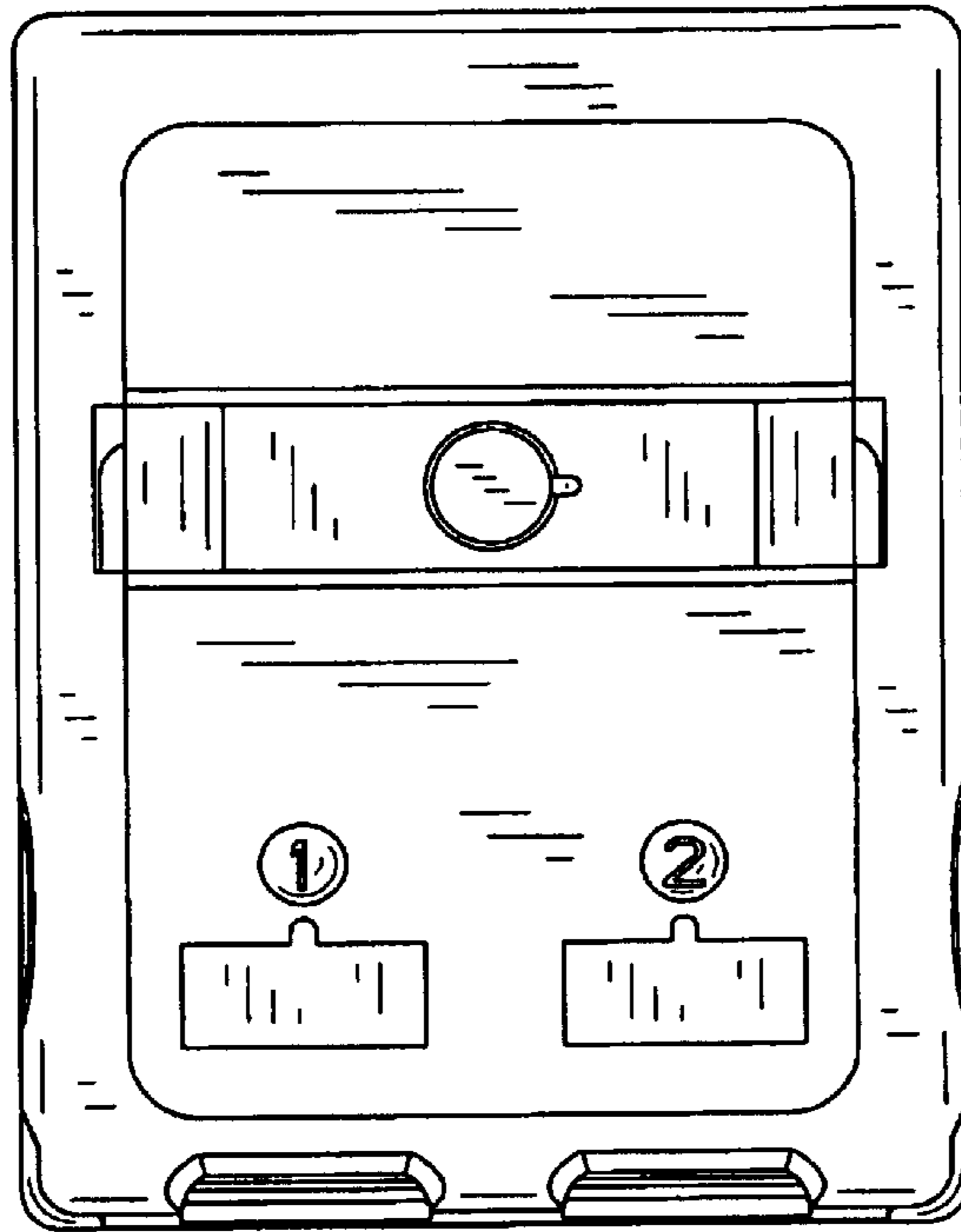

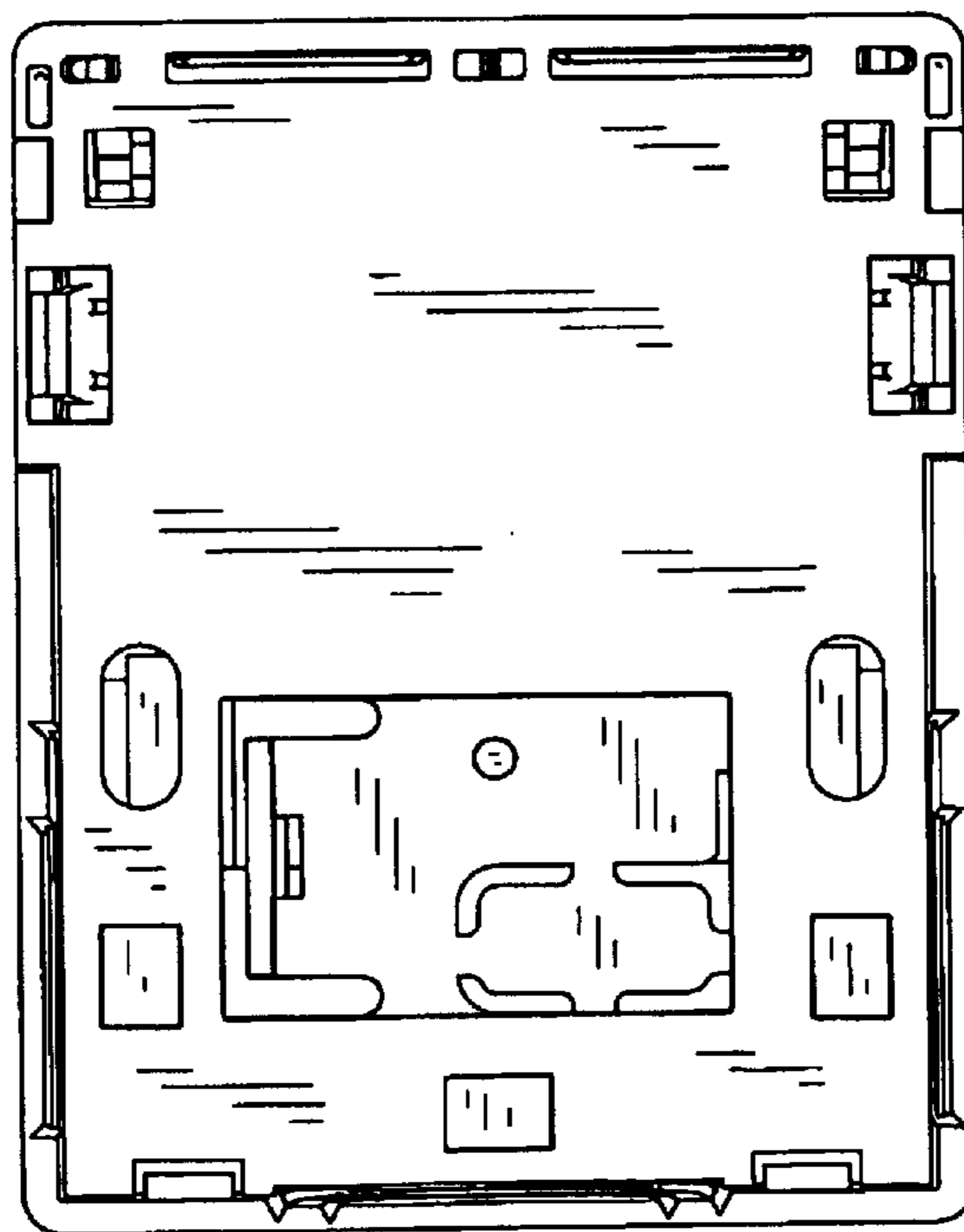

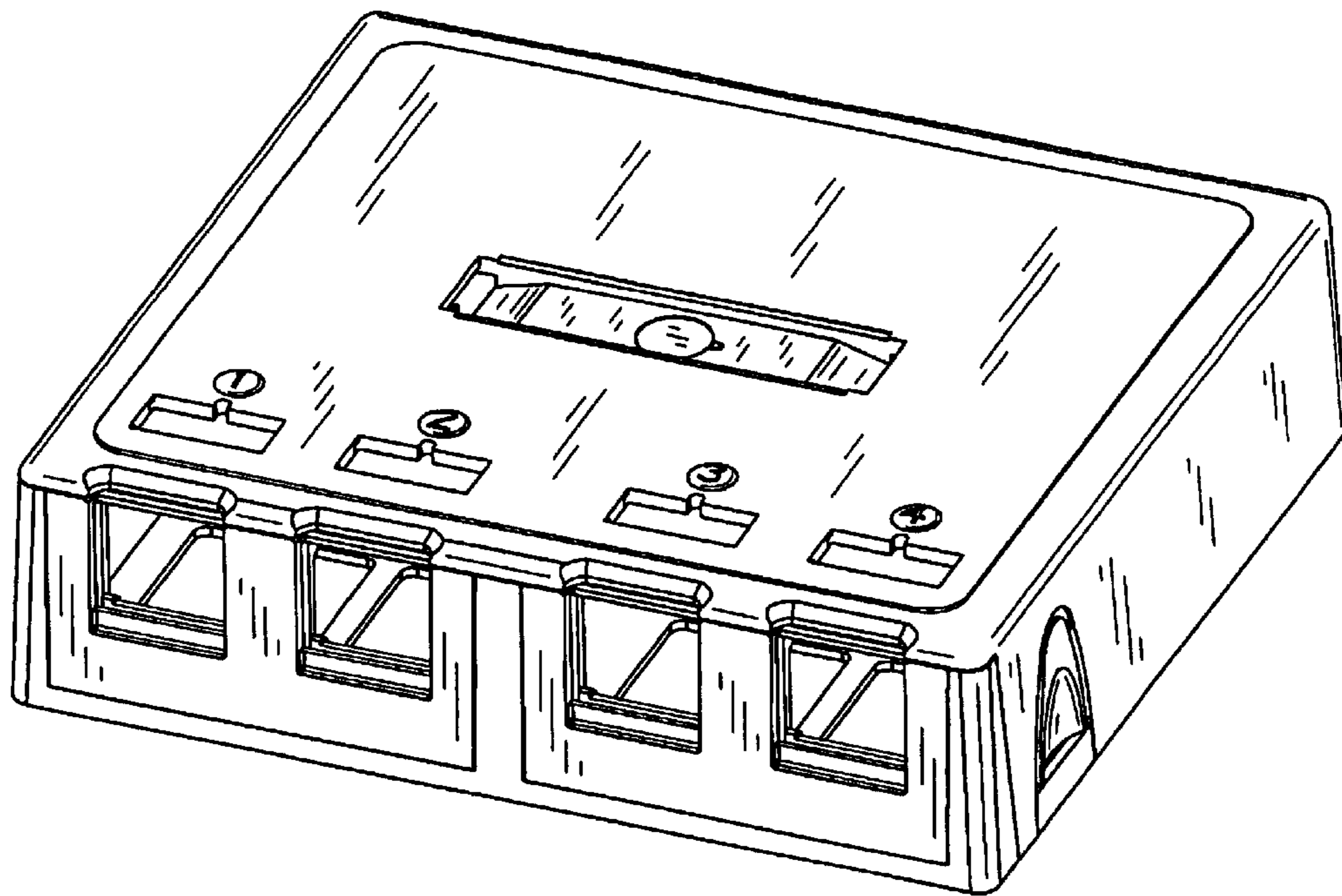

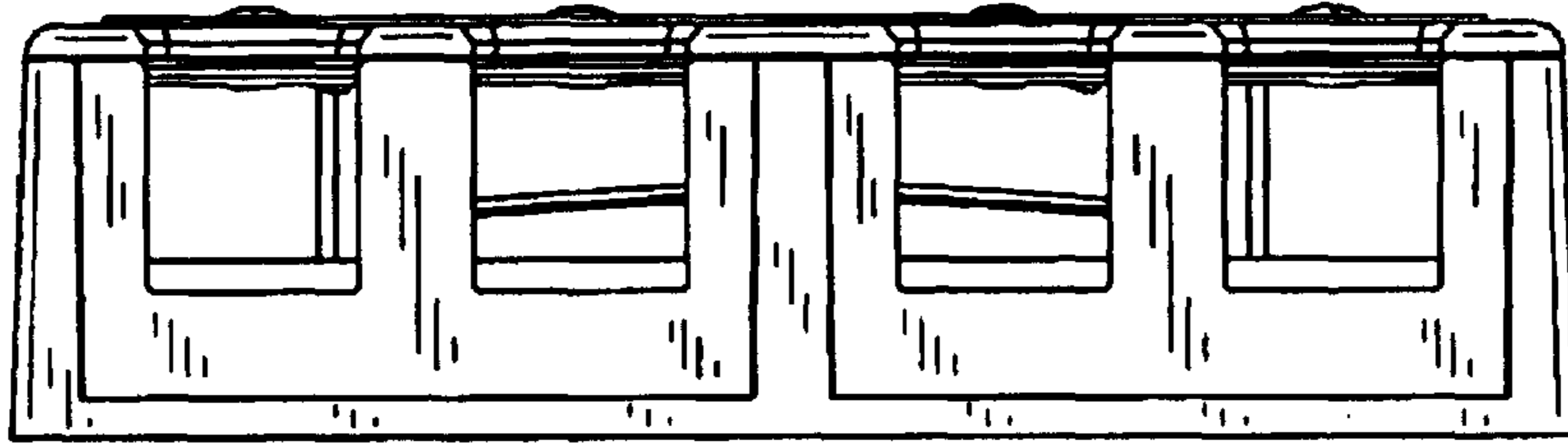

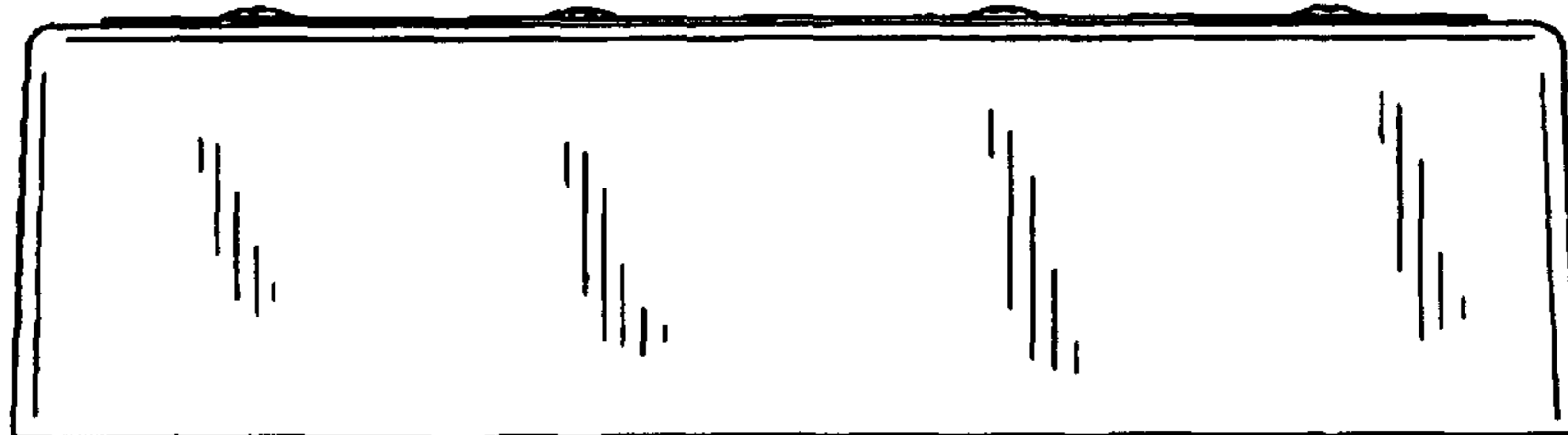

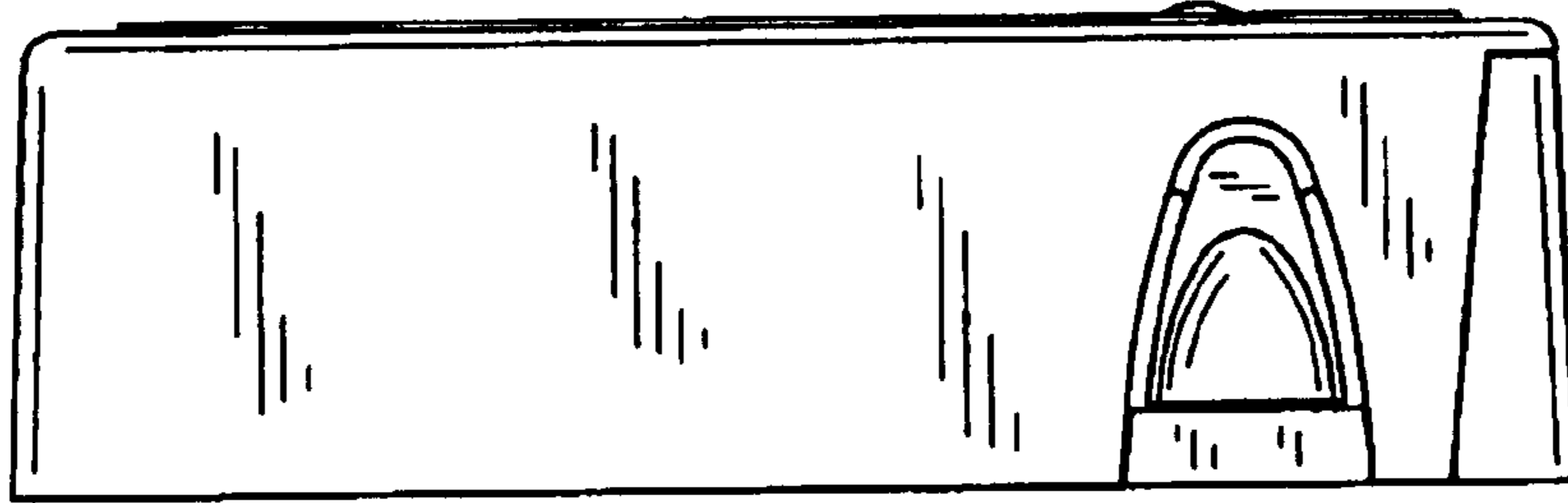

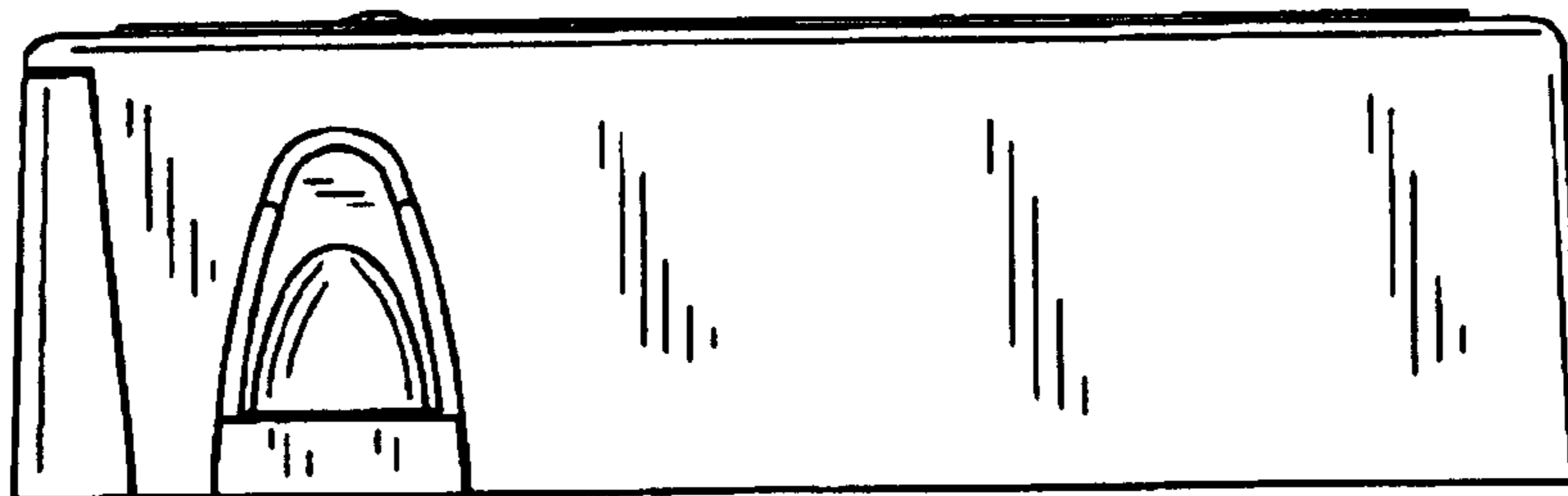

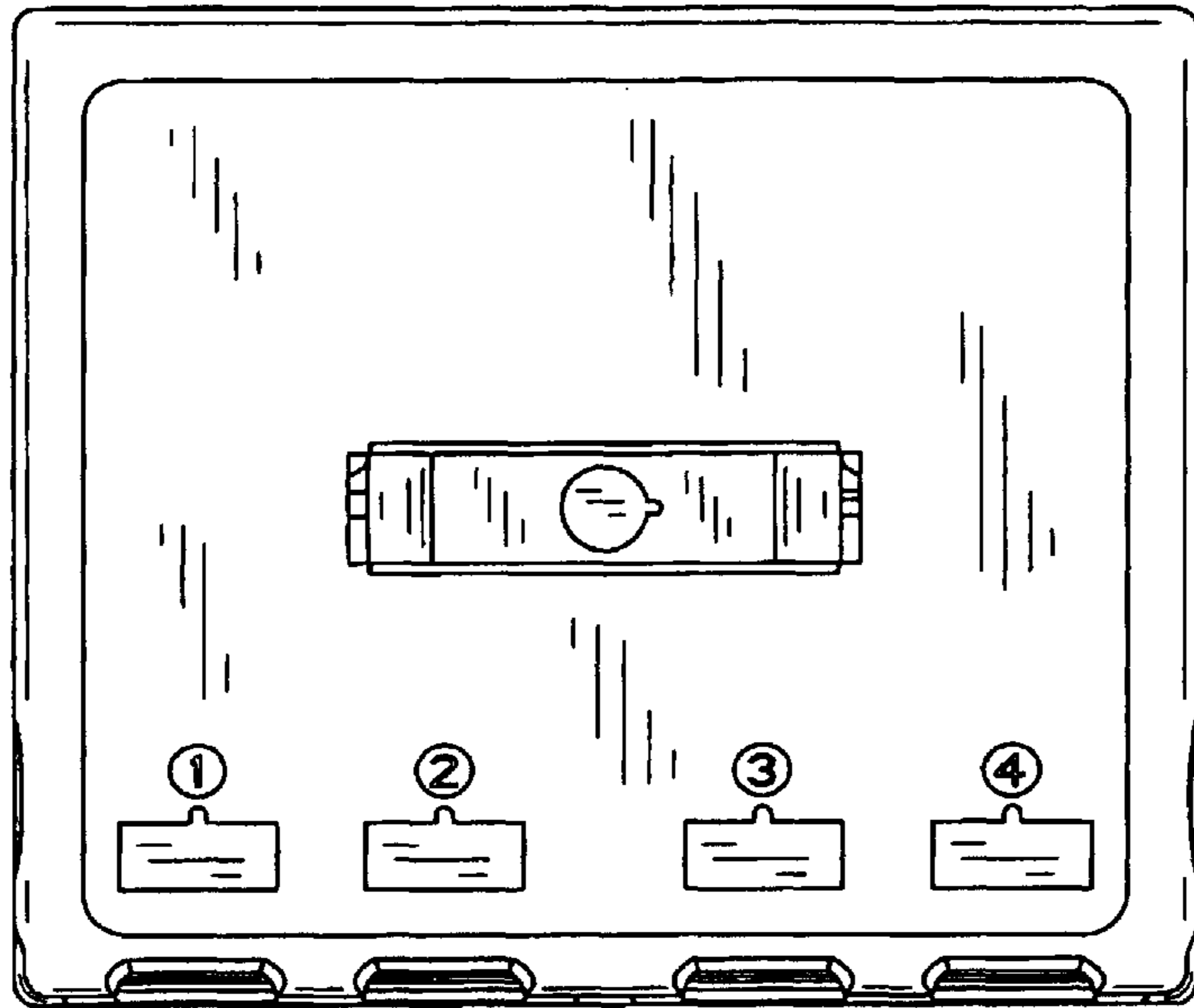

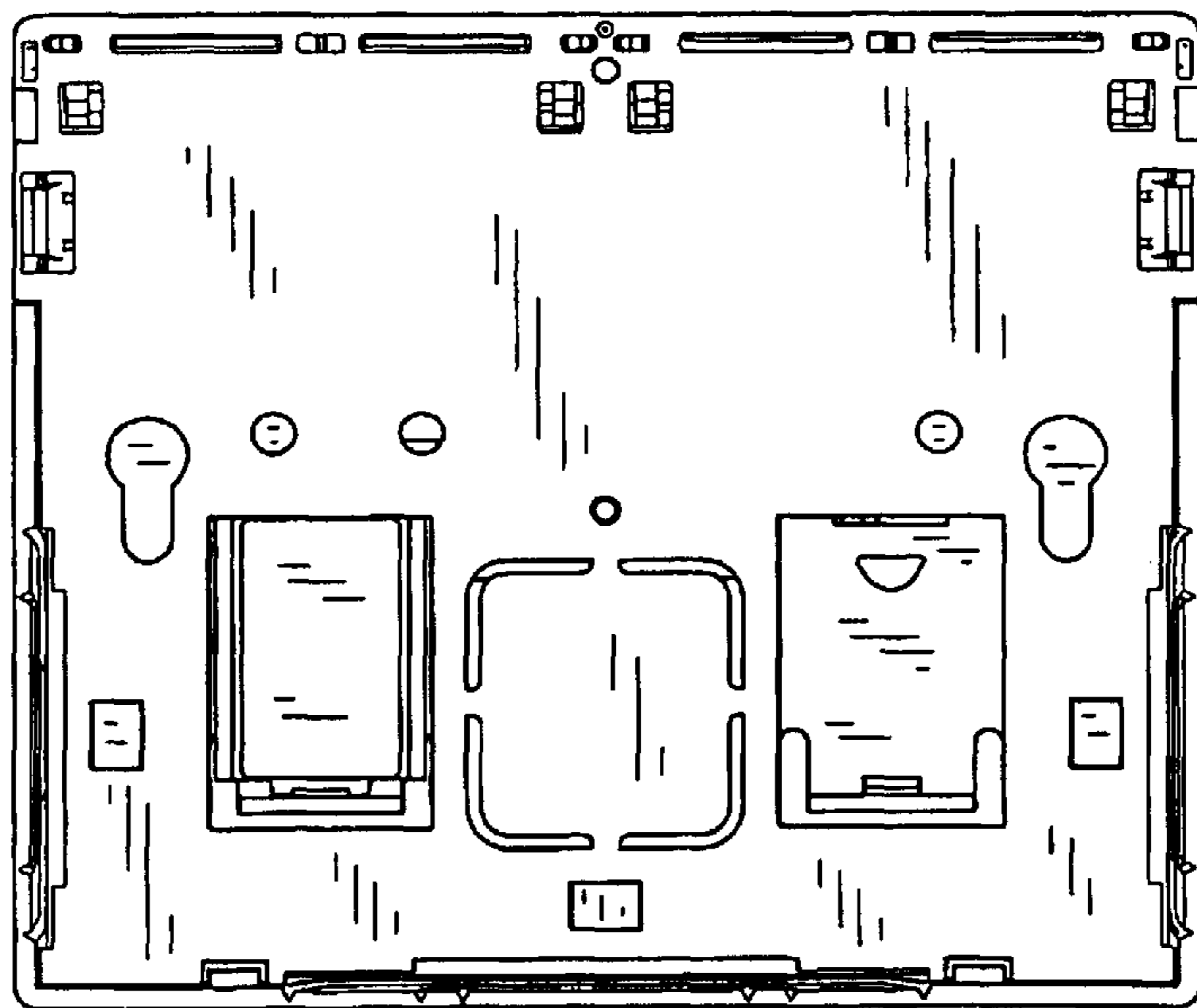

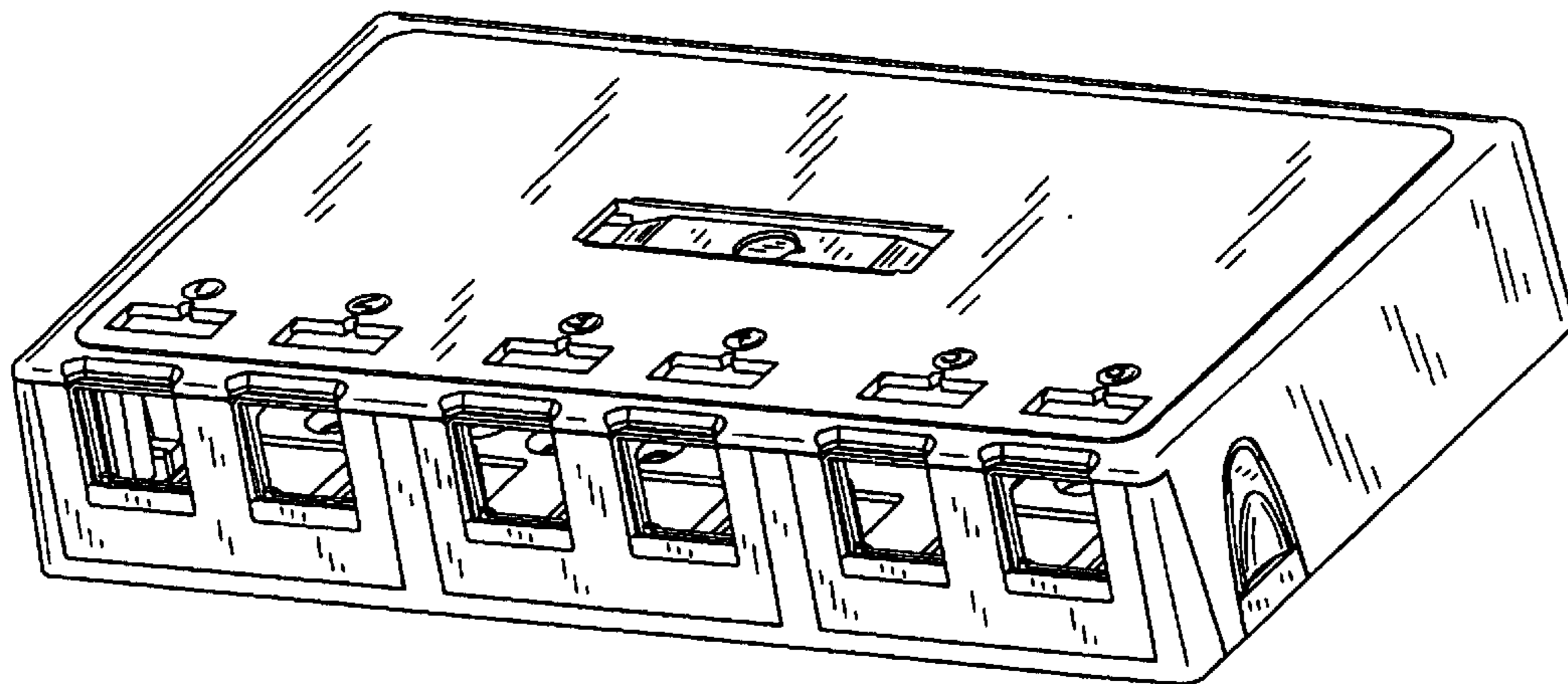

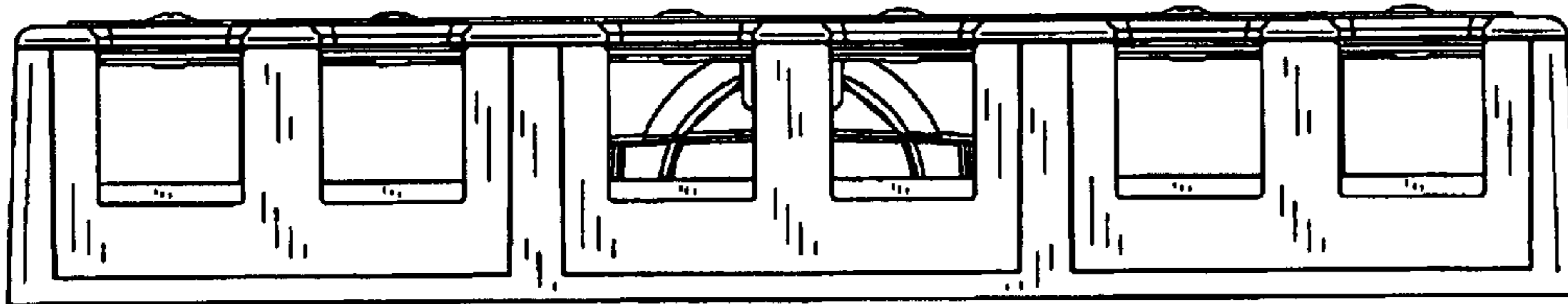

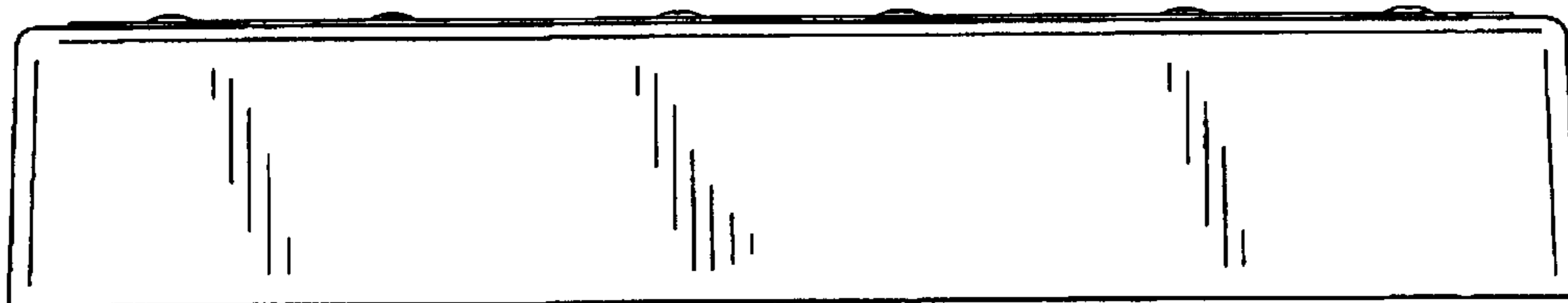

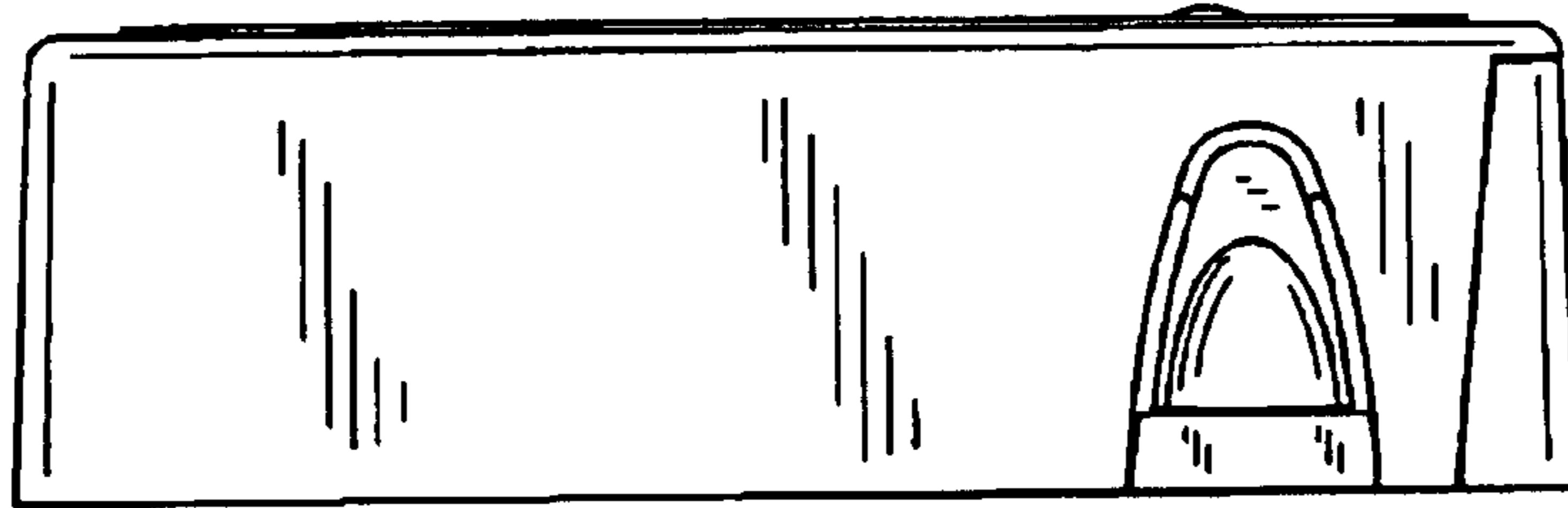

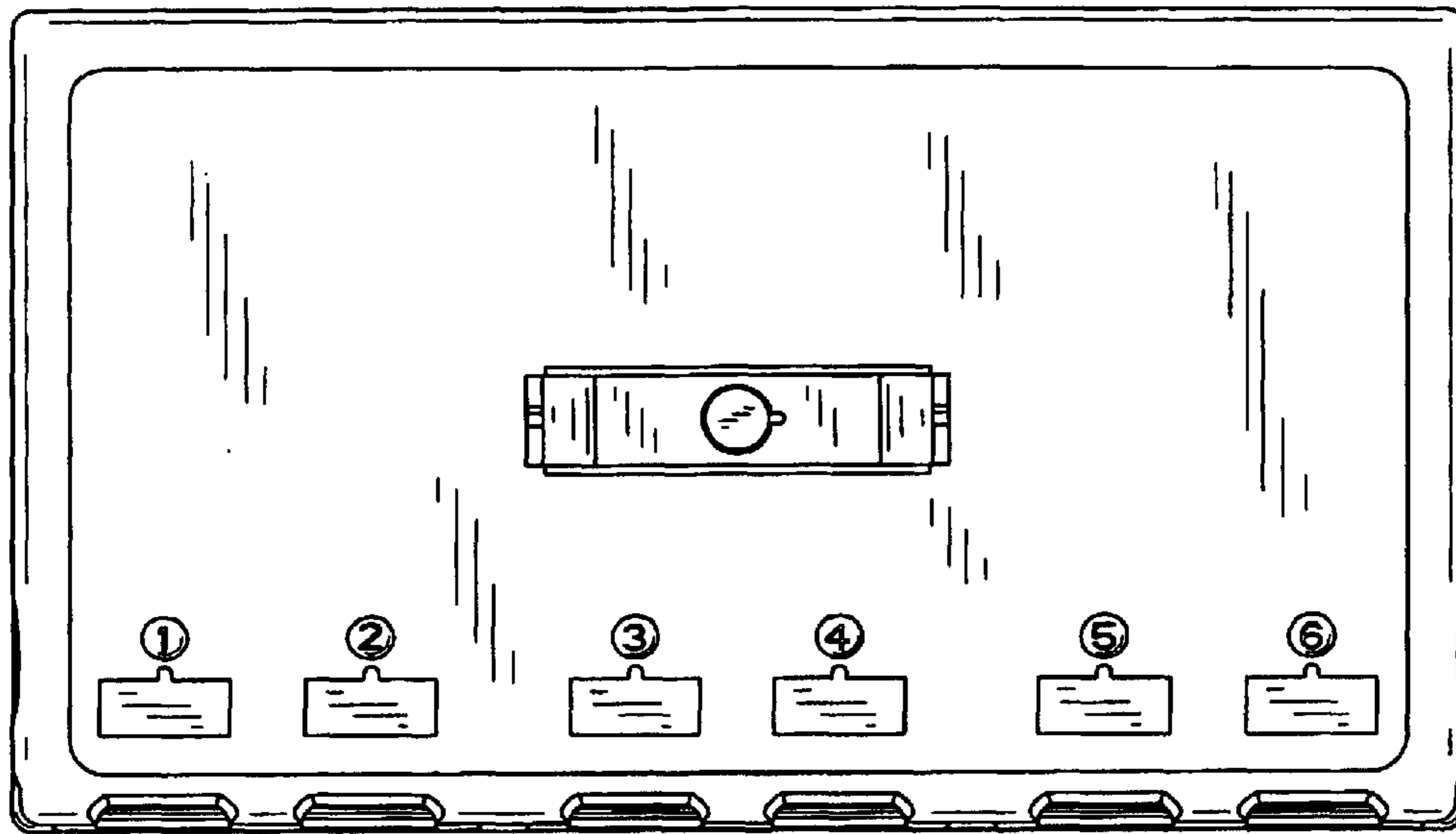
