(57) **CLAIM**

The ornamental design for a half jacket eyewear, as shown and described.

DESCRIPTION

FIG. 1 a side perspective view of my new half jacket eyewear design.

FIG. 2 is a top view of my new half jacket eyewear design.

FIG. 3 is a front view of my new half jacket eyewear design.

FIG. 4 is a bottom view of my new half jacket eyewear design.

FIG. 5 is a rear view of my new half jacket eyewear design.

FIG. 6 is a left side view of my new half jacket eyewear design, the right view being a mirror image thereof; and,

FIG. 7 is a left side perspective view of my new half jacket eyewear design with the inner removable frame shown separately from the main frame.













