**DESCRIPTION**

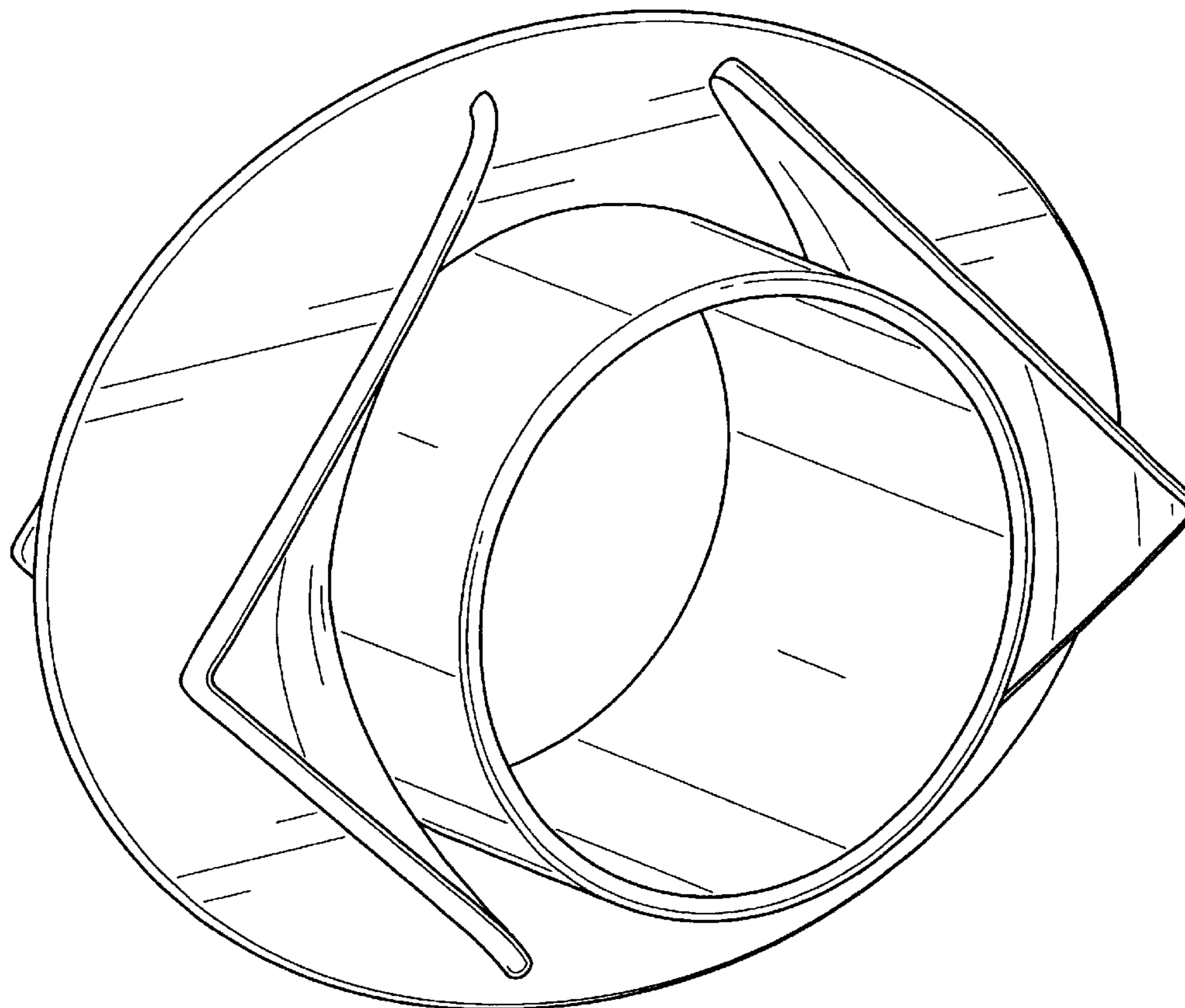
FIG. 1 is a perspective view of a swim exercise cuff showing my new design;

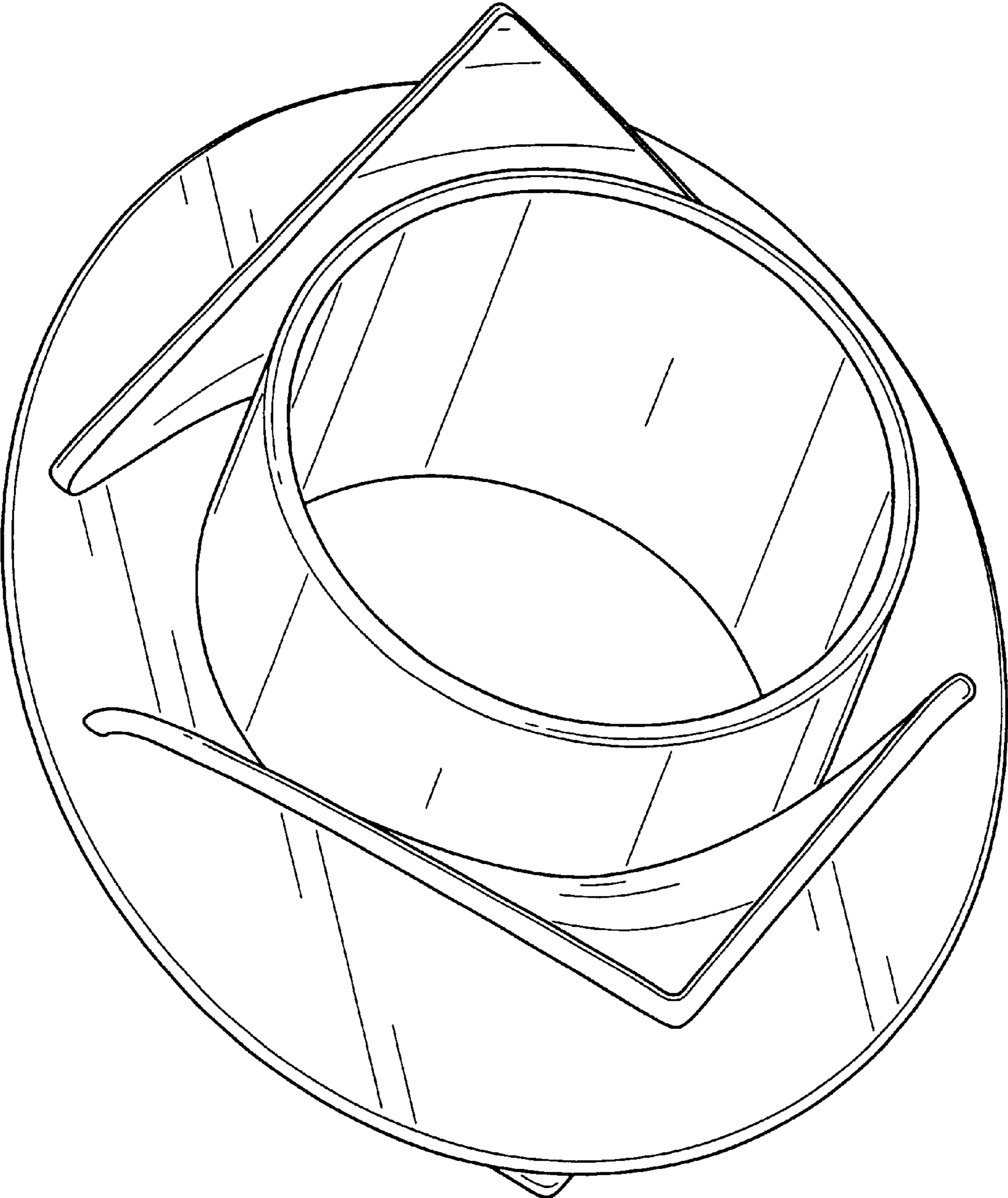

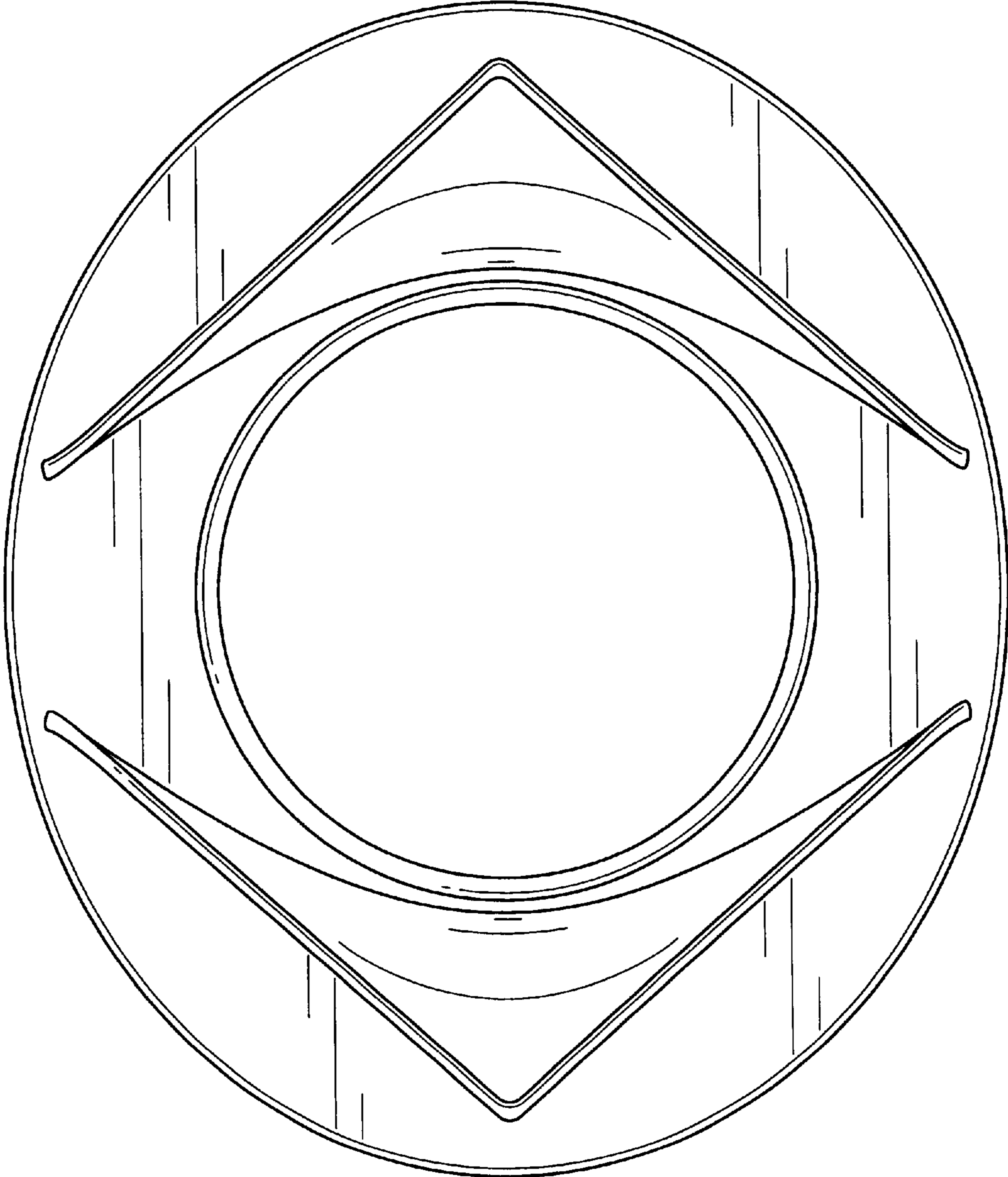

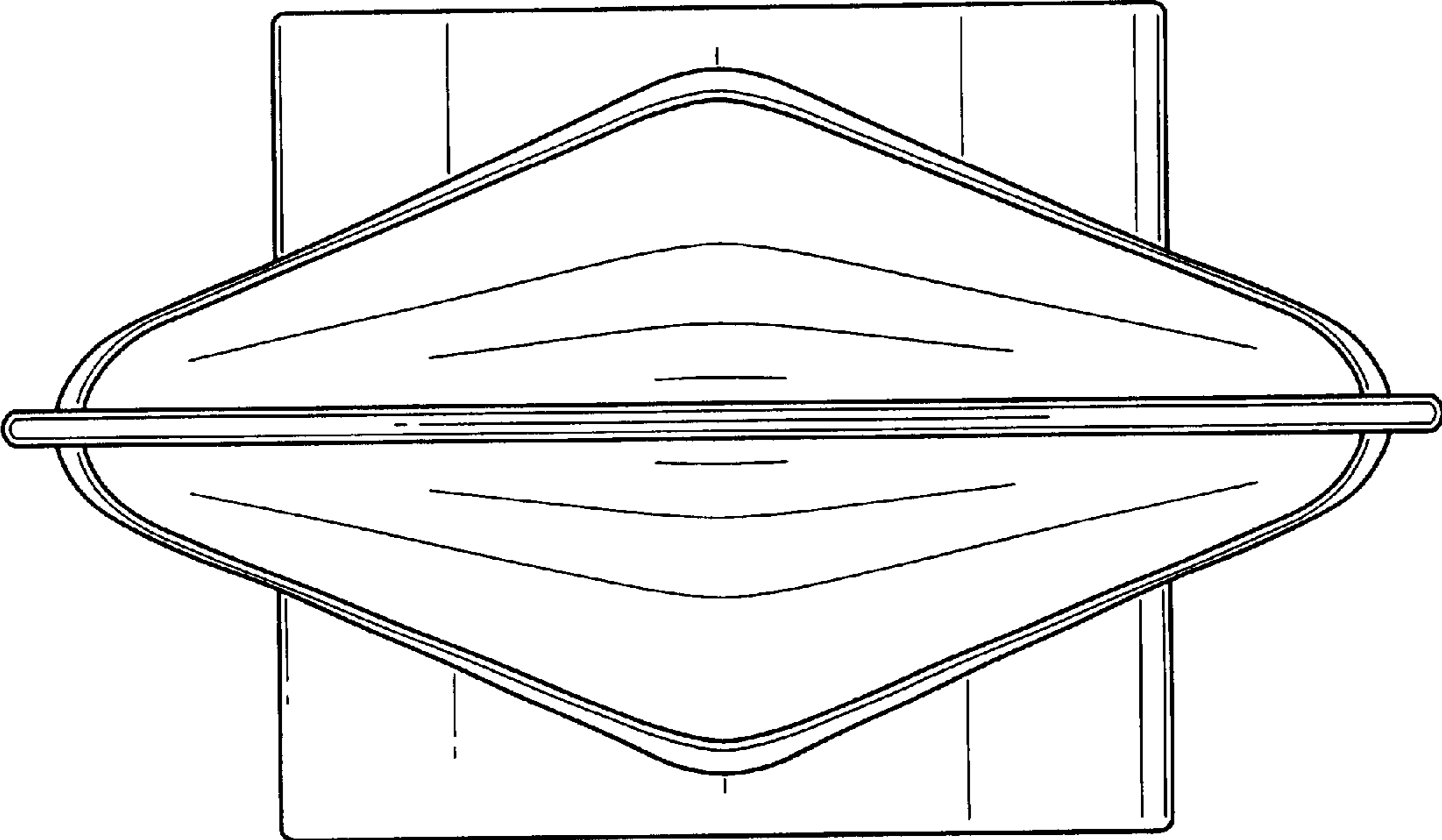

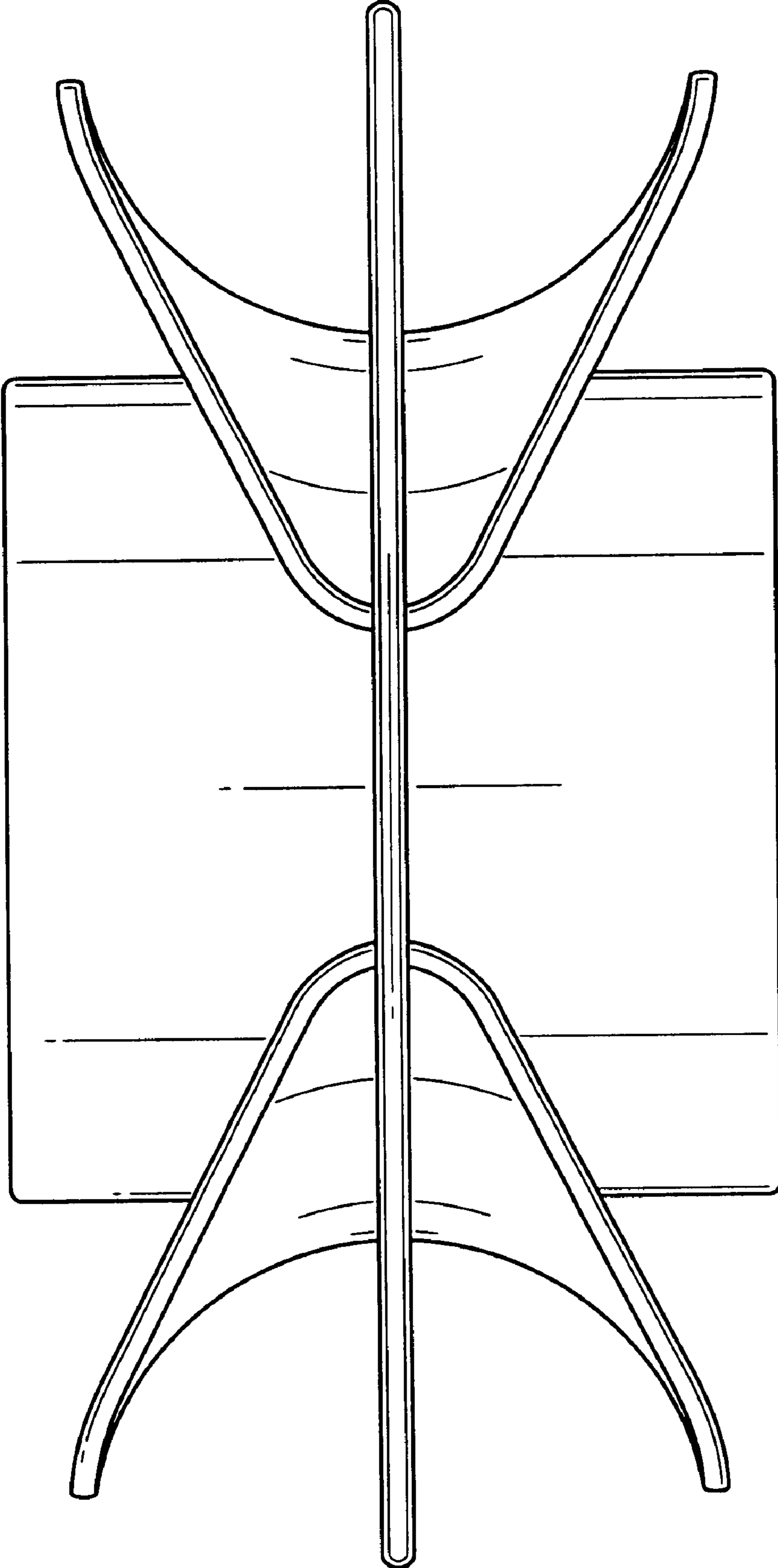
