The ornamental design for a golf club head, as shown.

DESCRIPTION

FIG. 18 is a second perspective view of the third embodiment of the golf club head shown in FIG. 17.

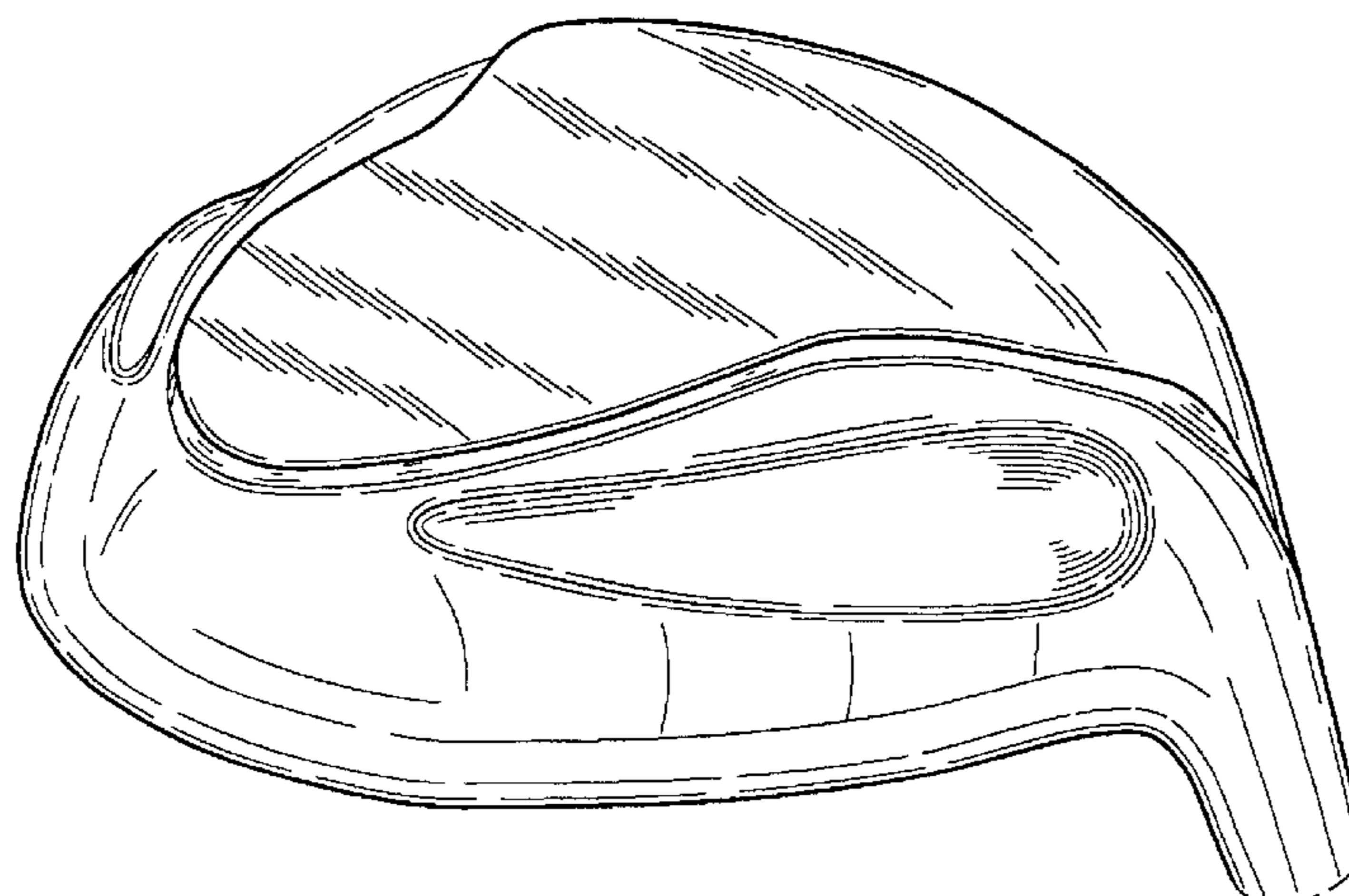


FIG. 19 is a front view of the third embodiment of the golf club head shown in FIG. 17.

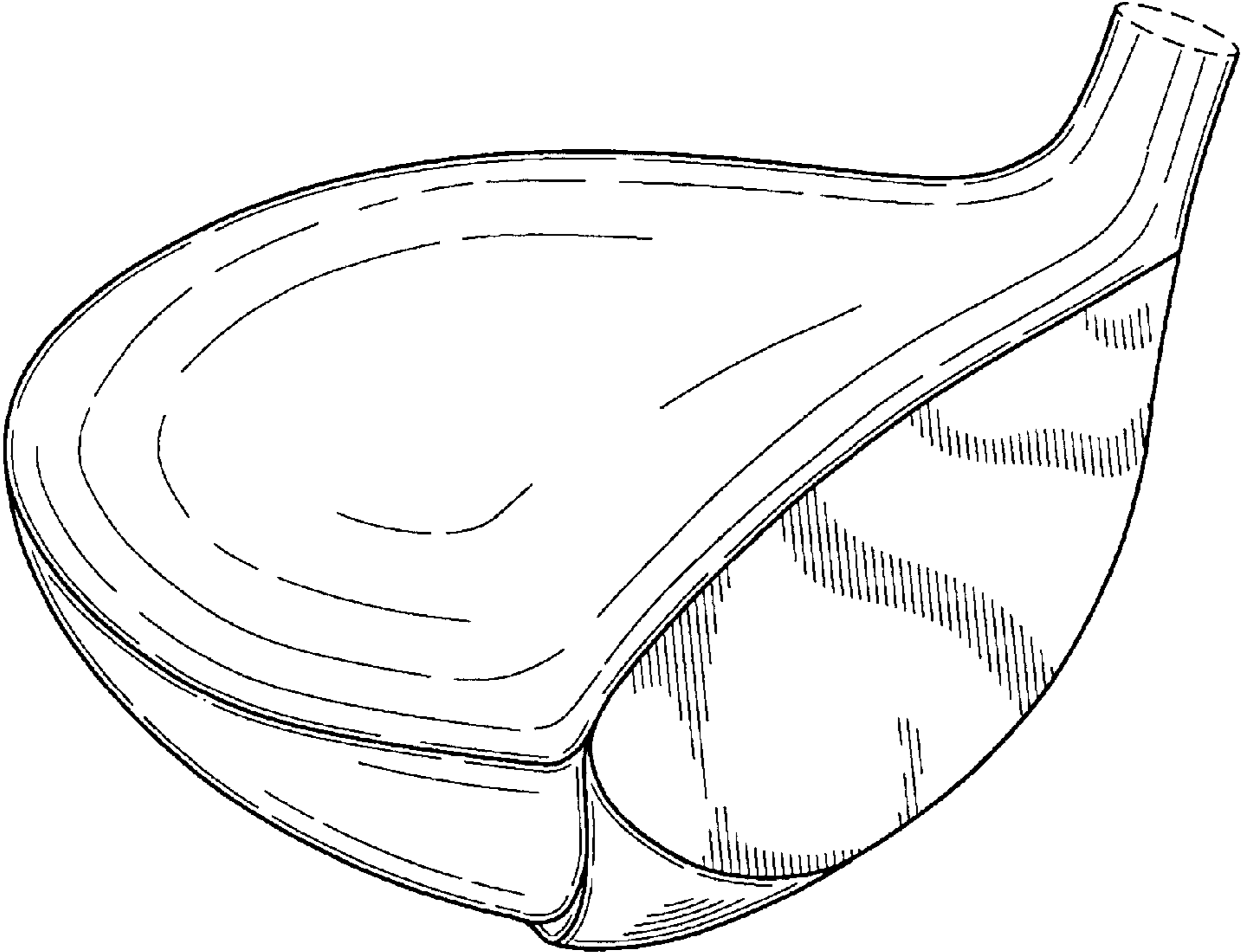

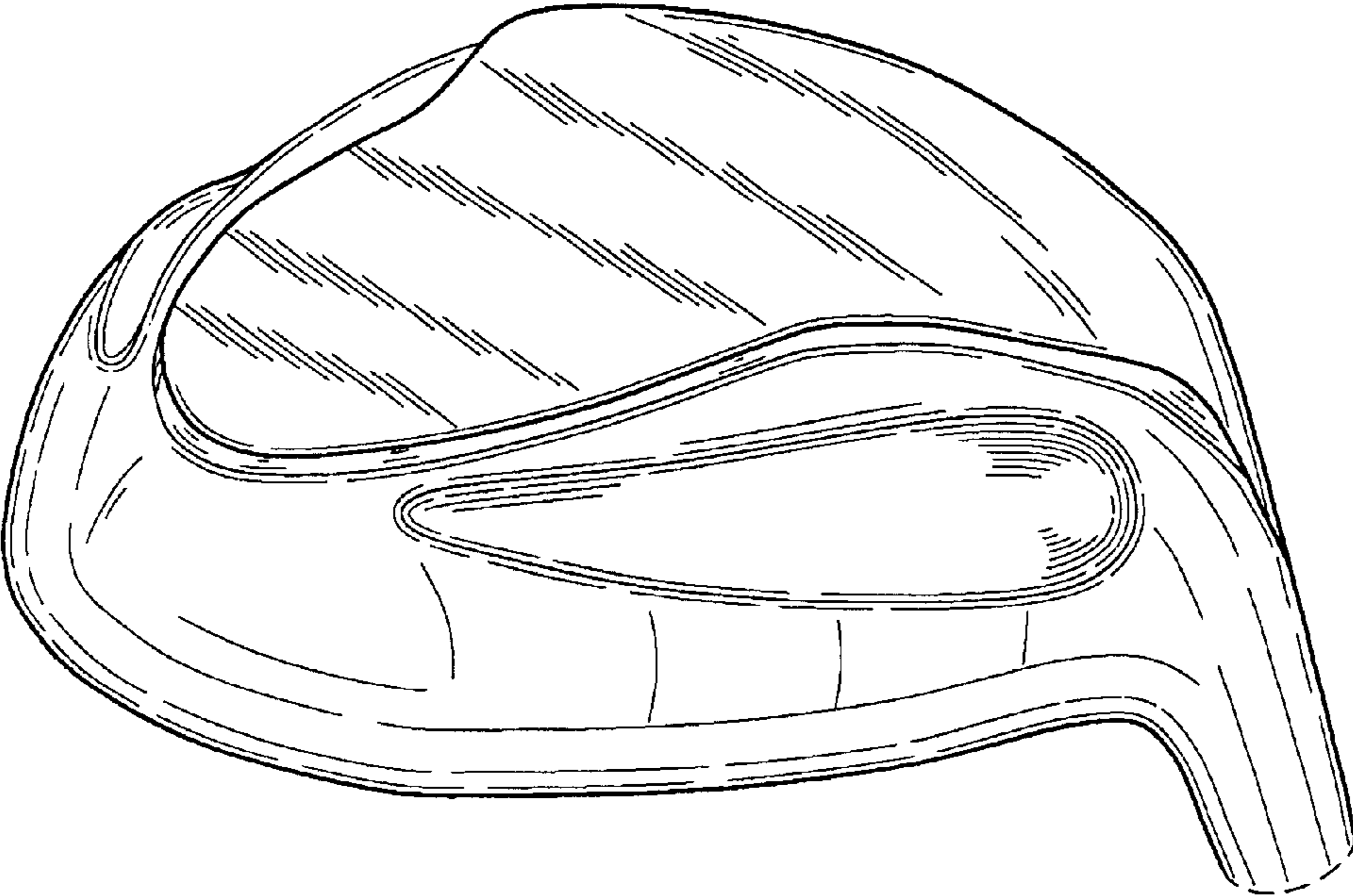

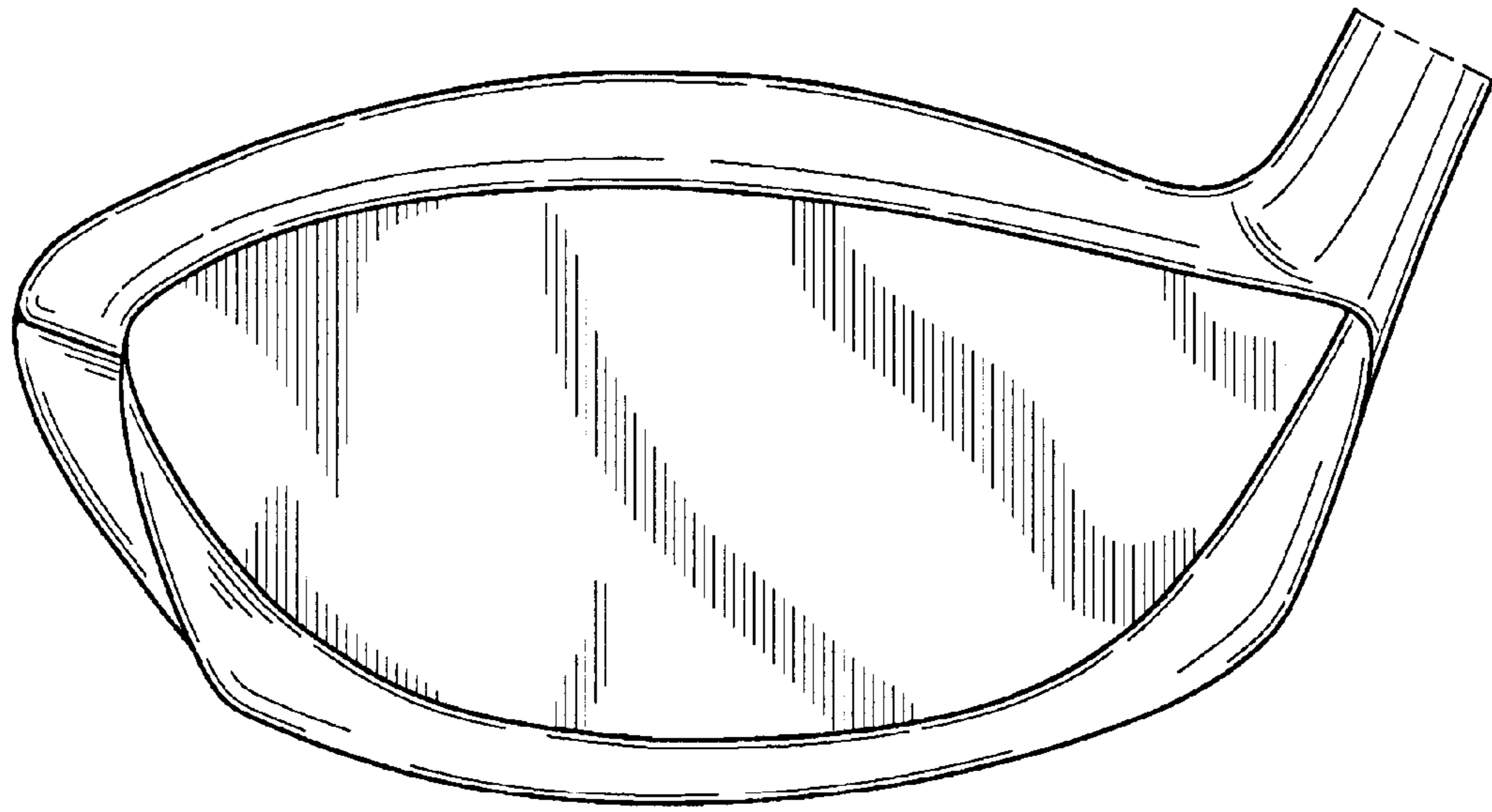

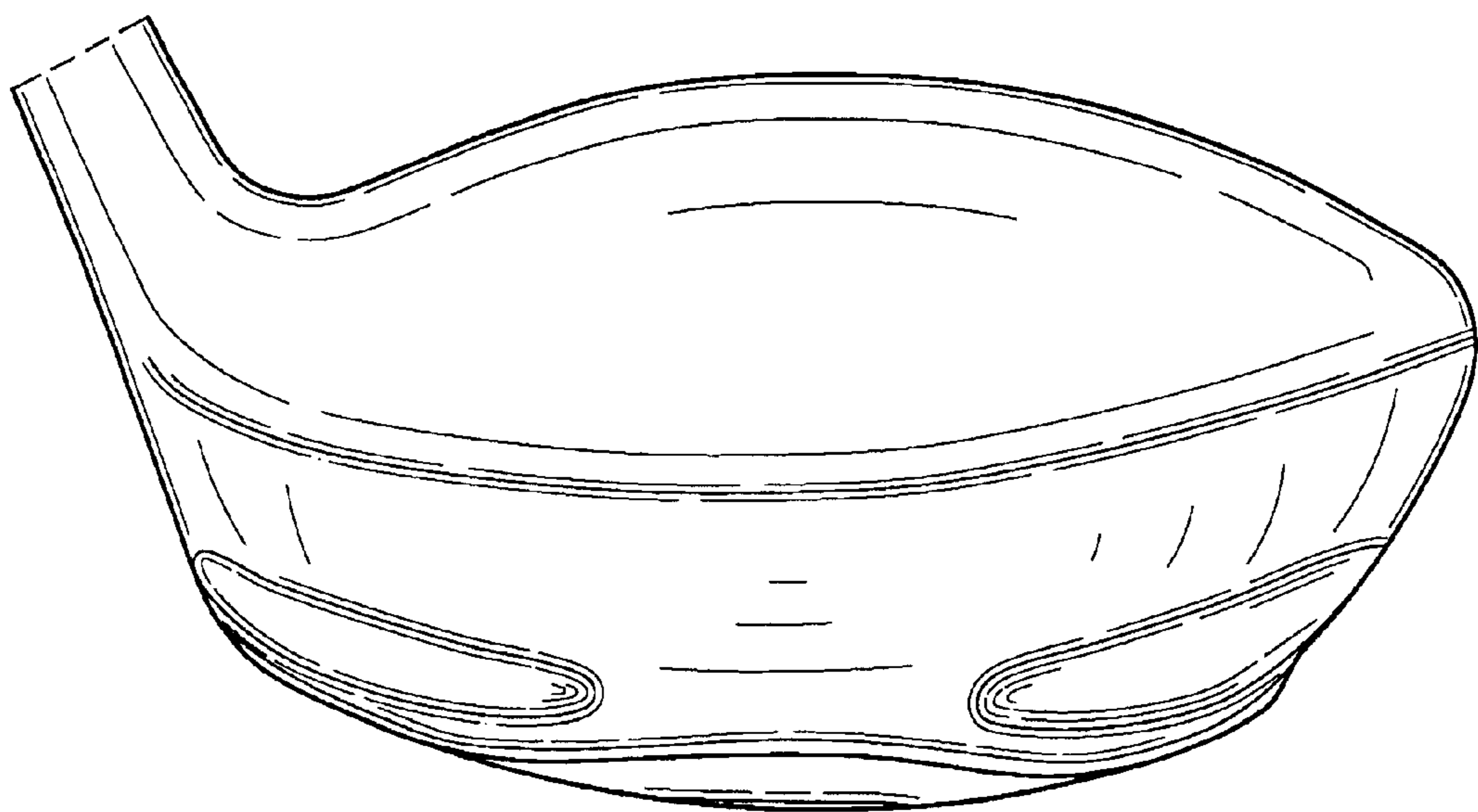

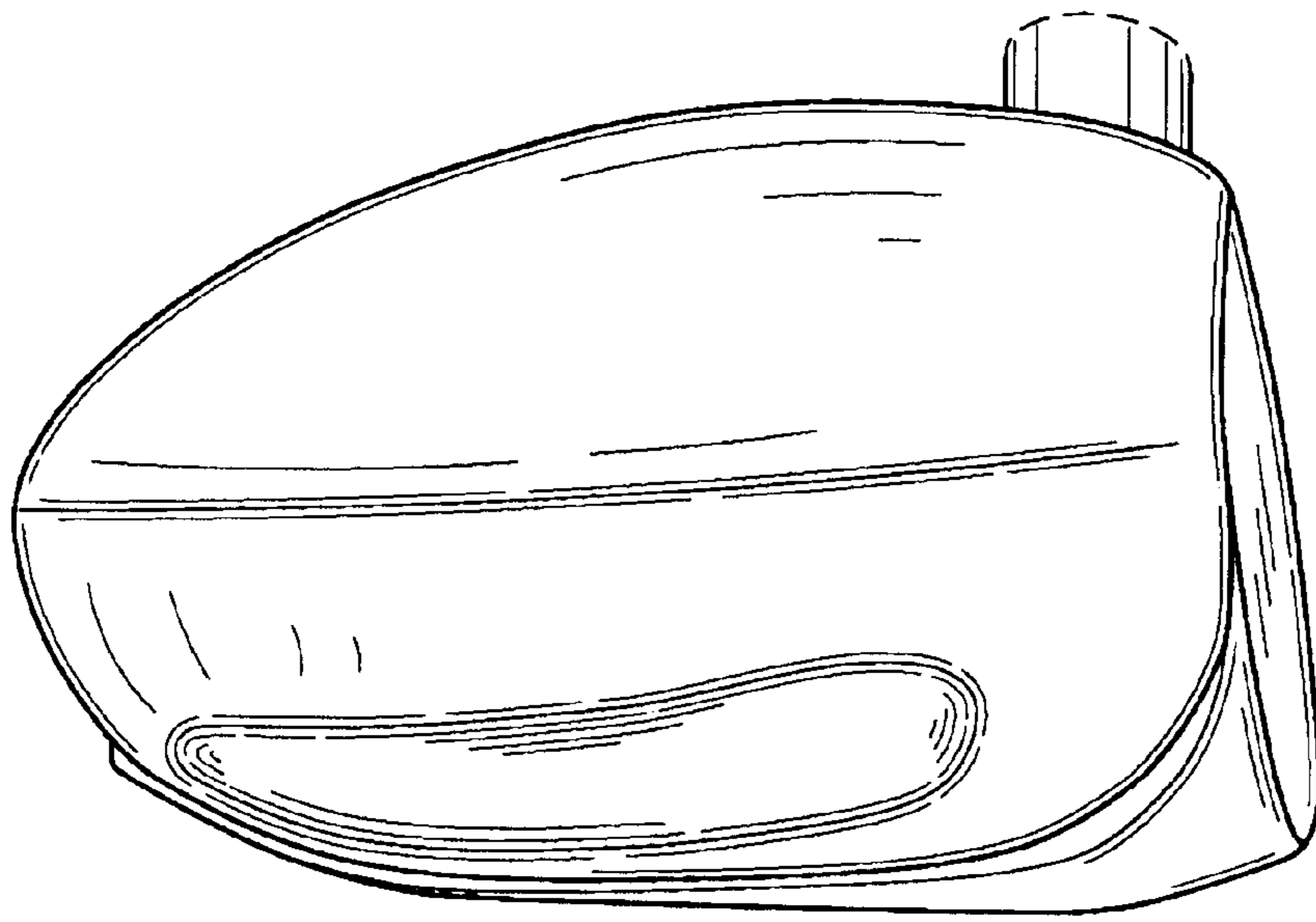

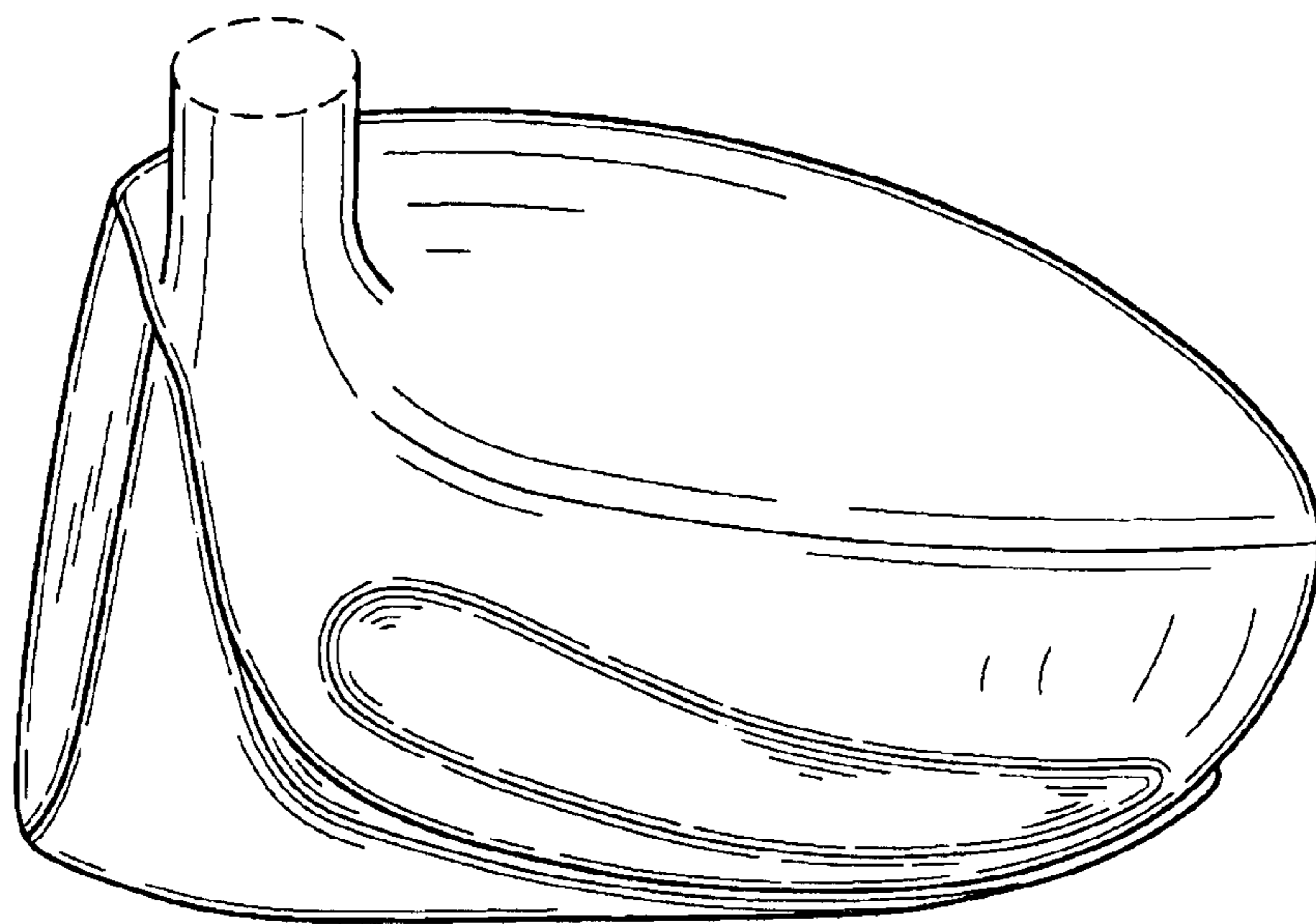

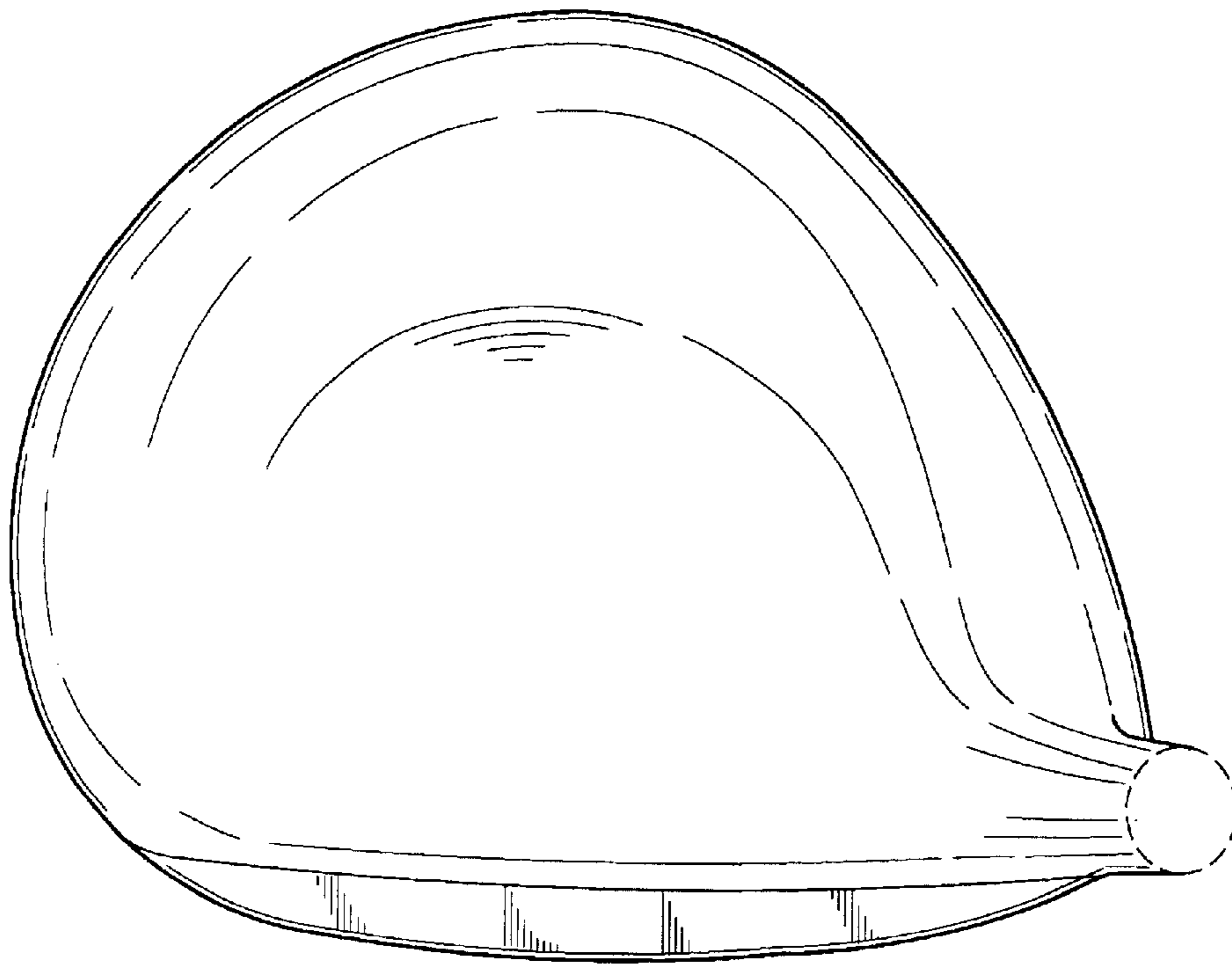

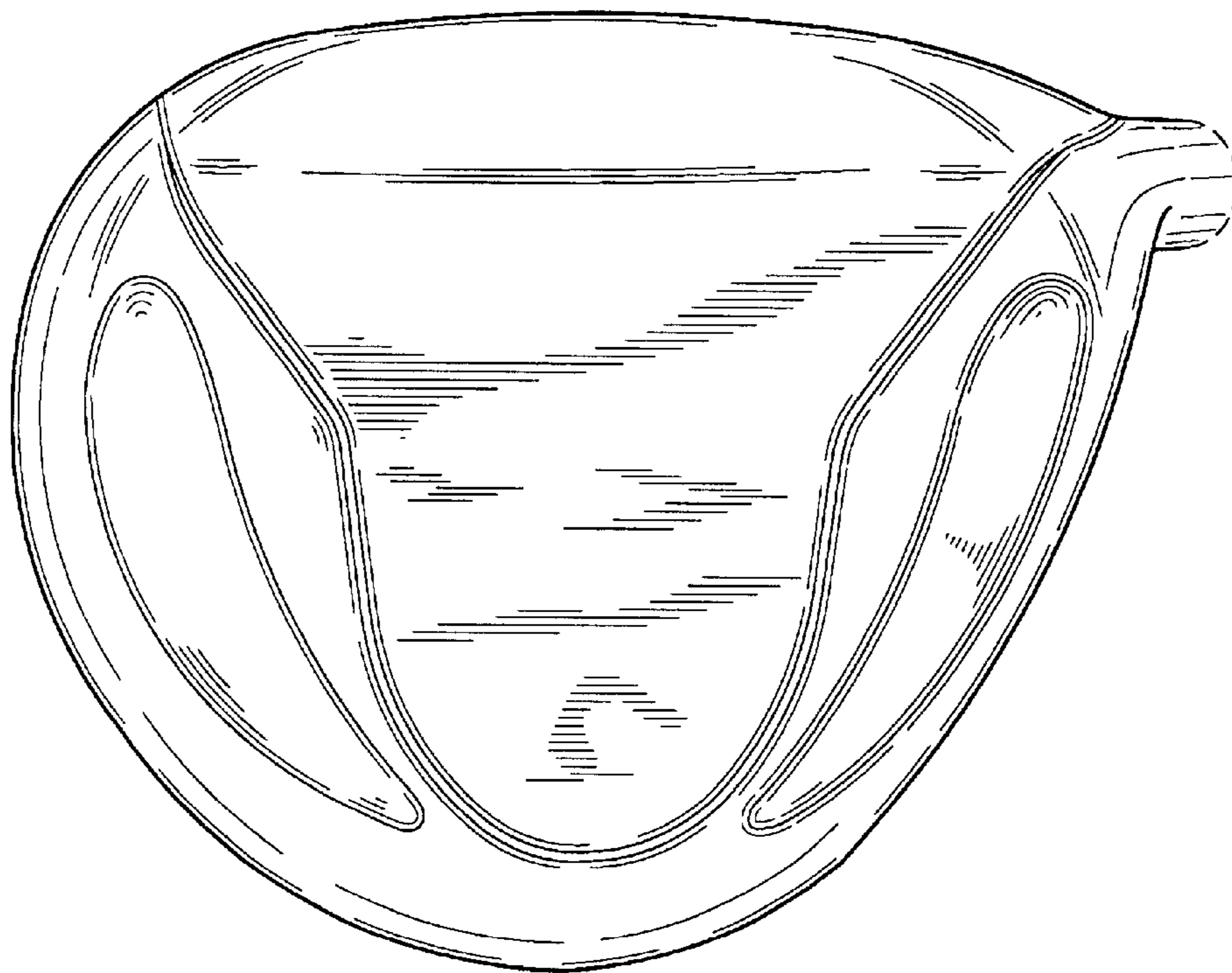

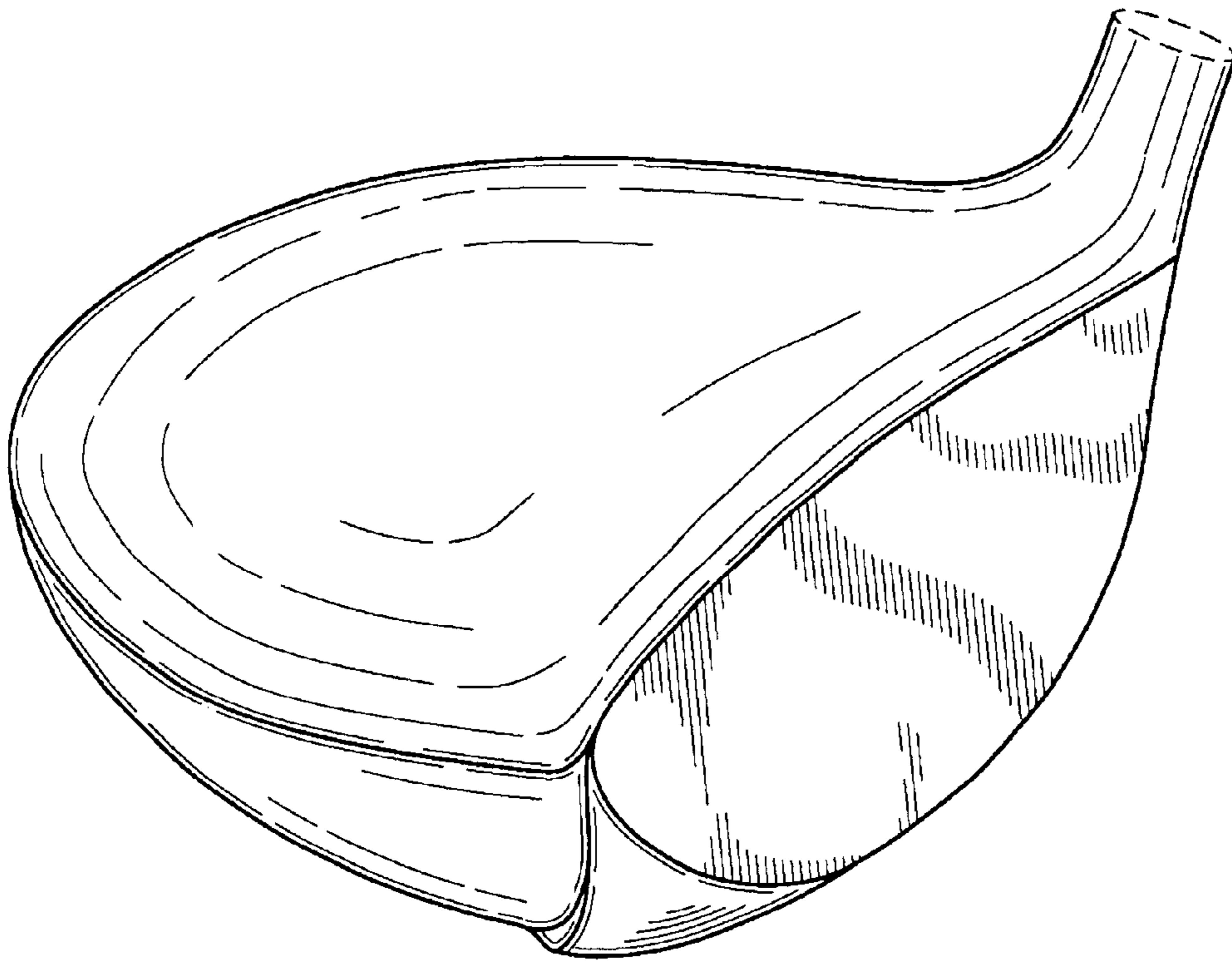

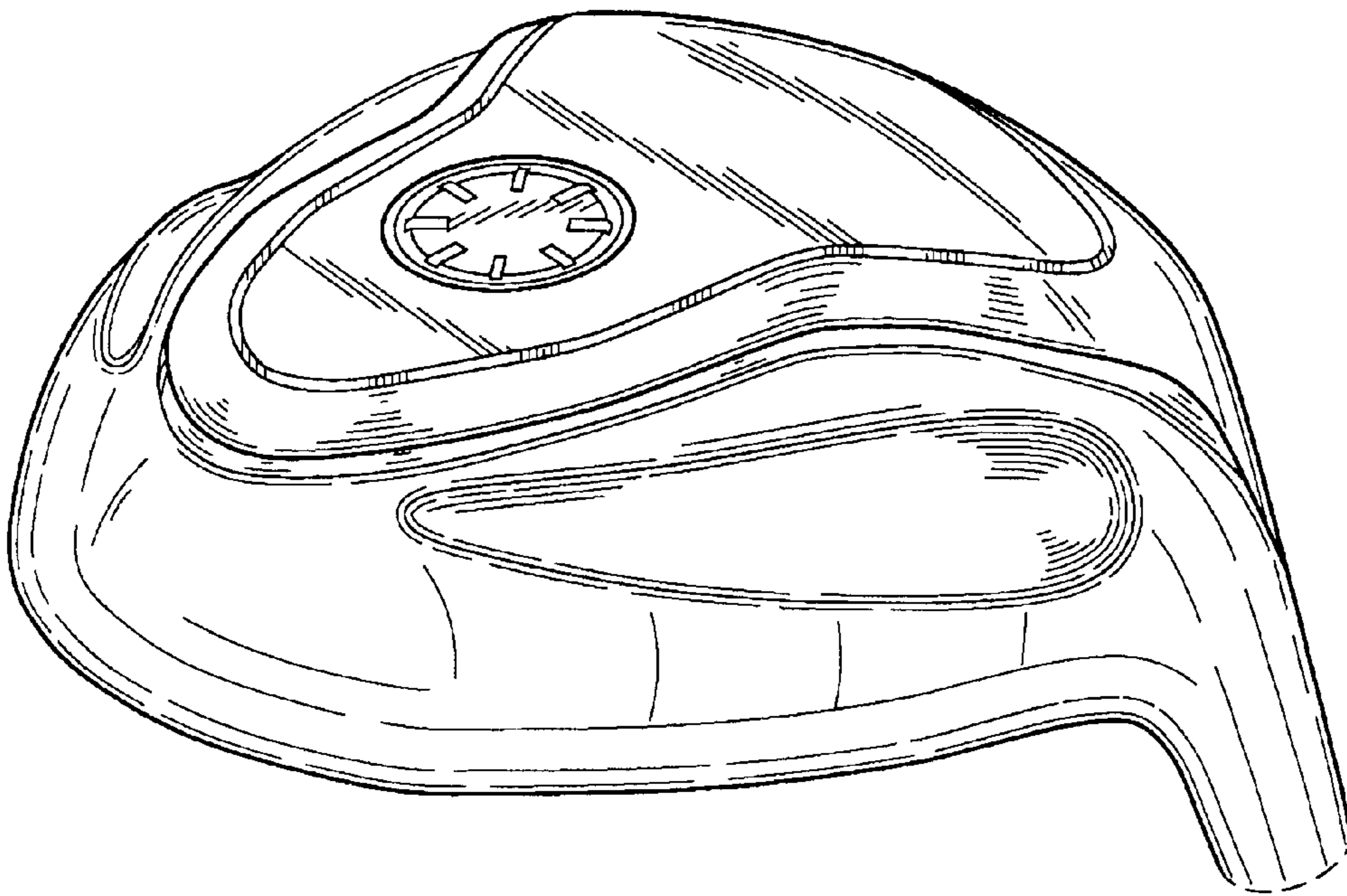

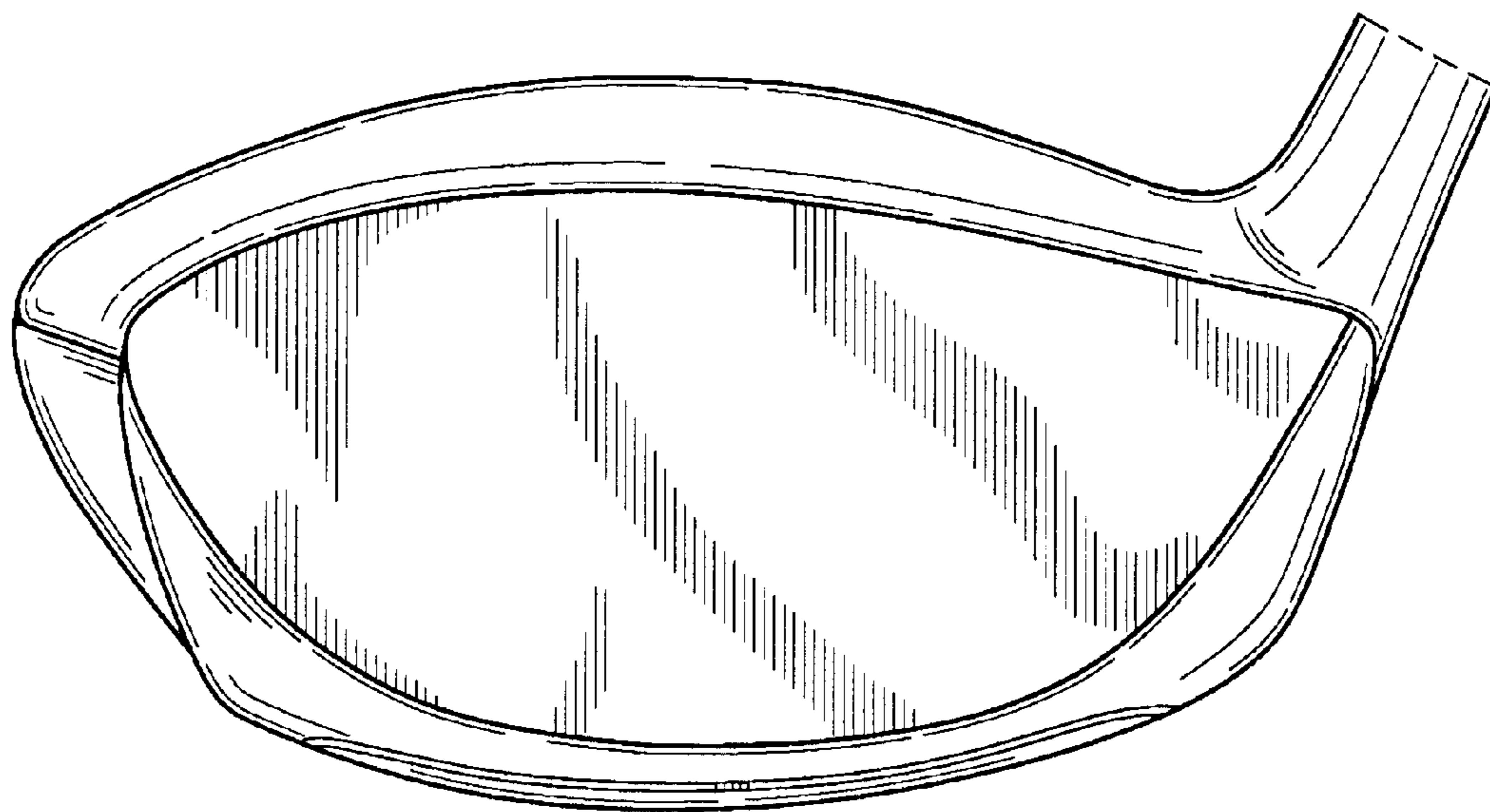

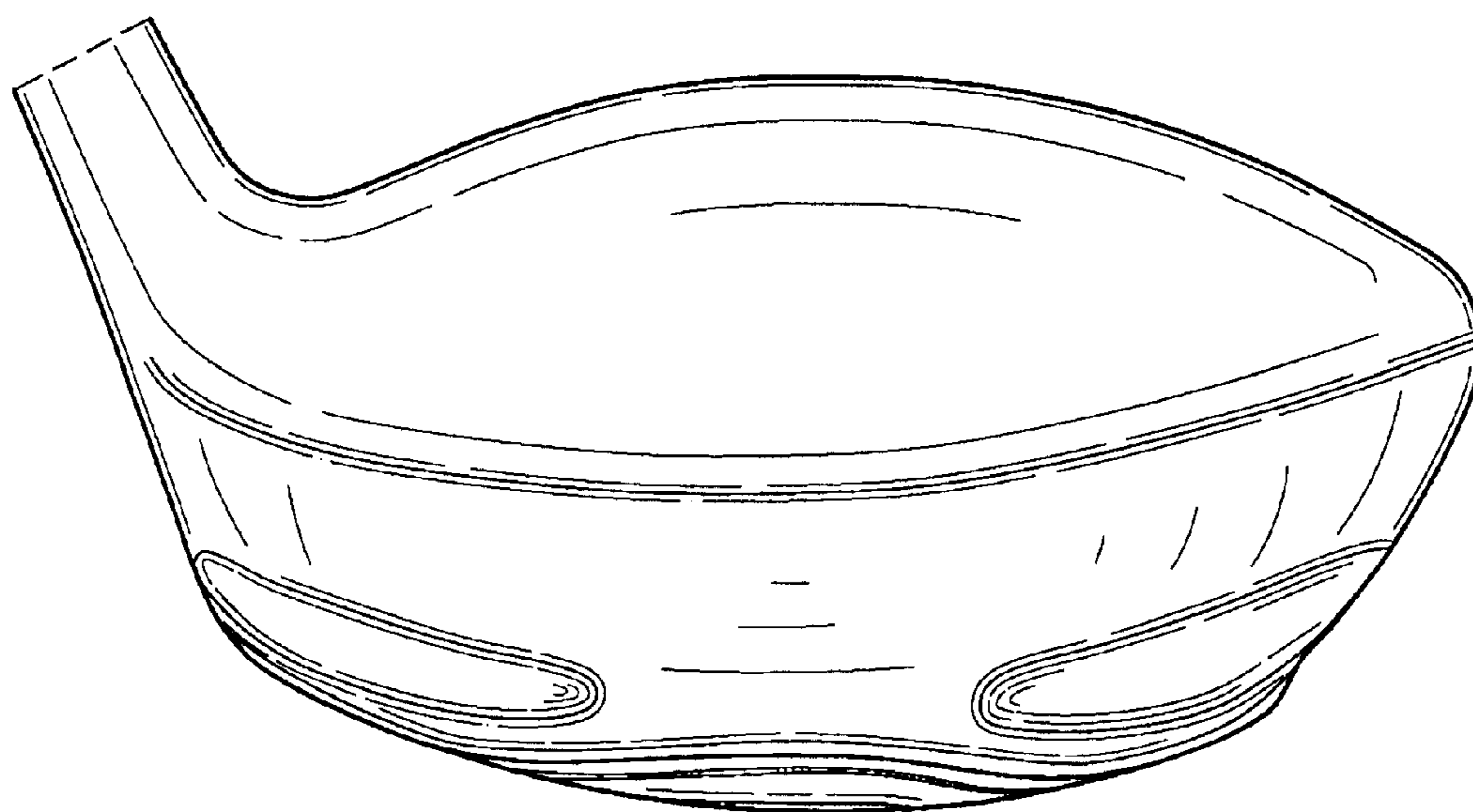

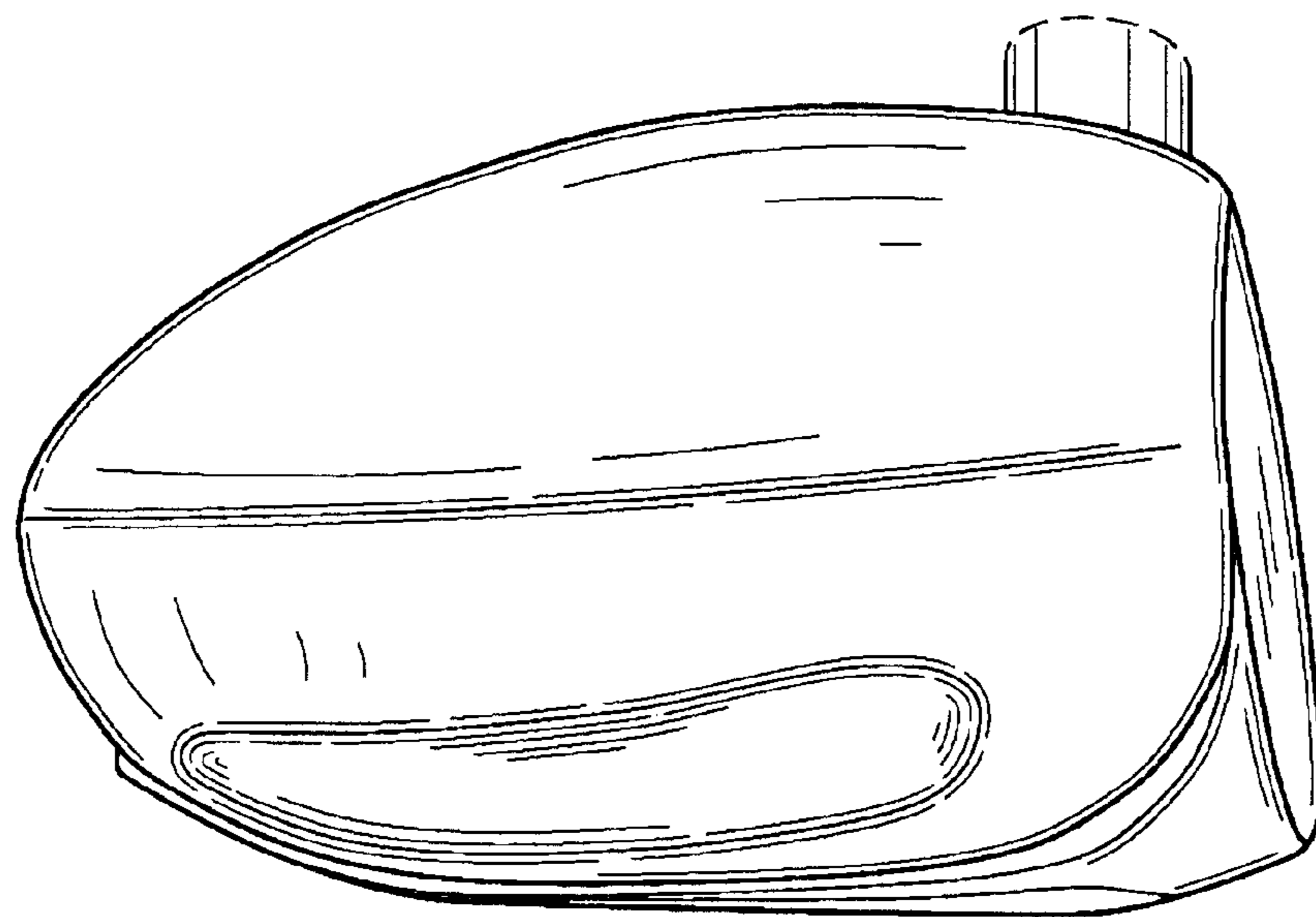

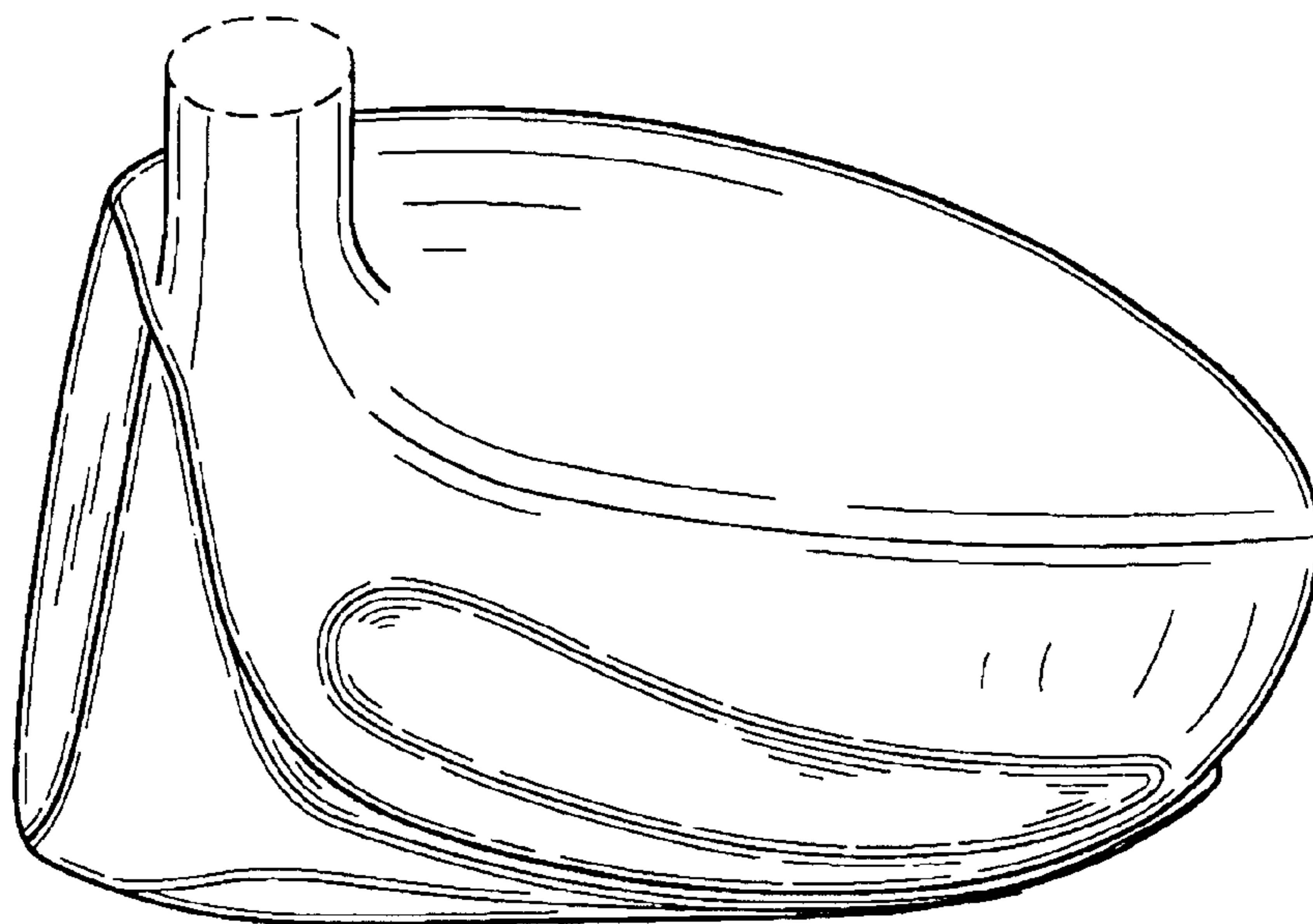

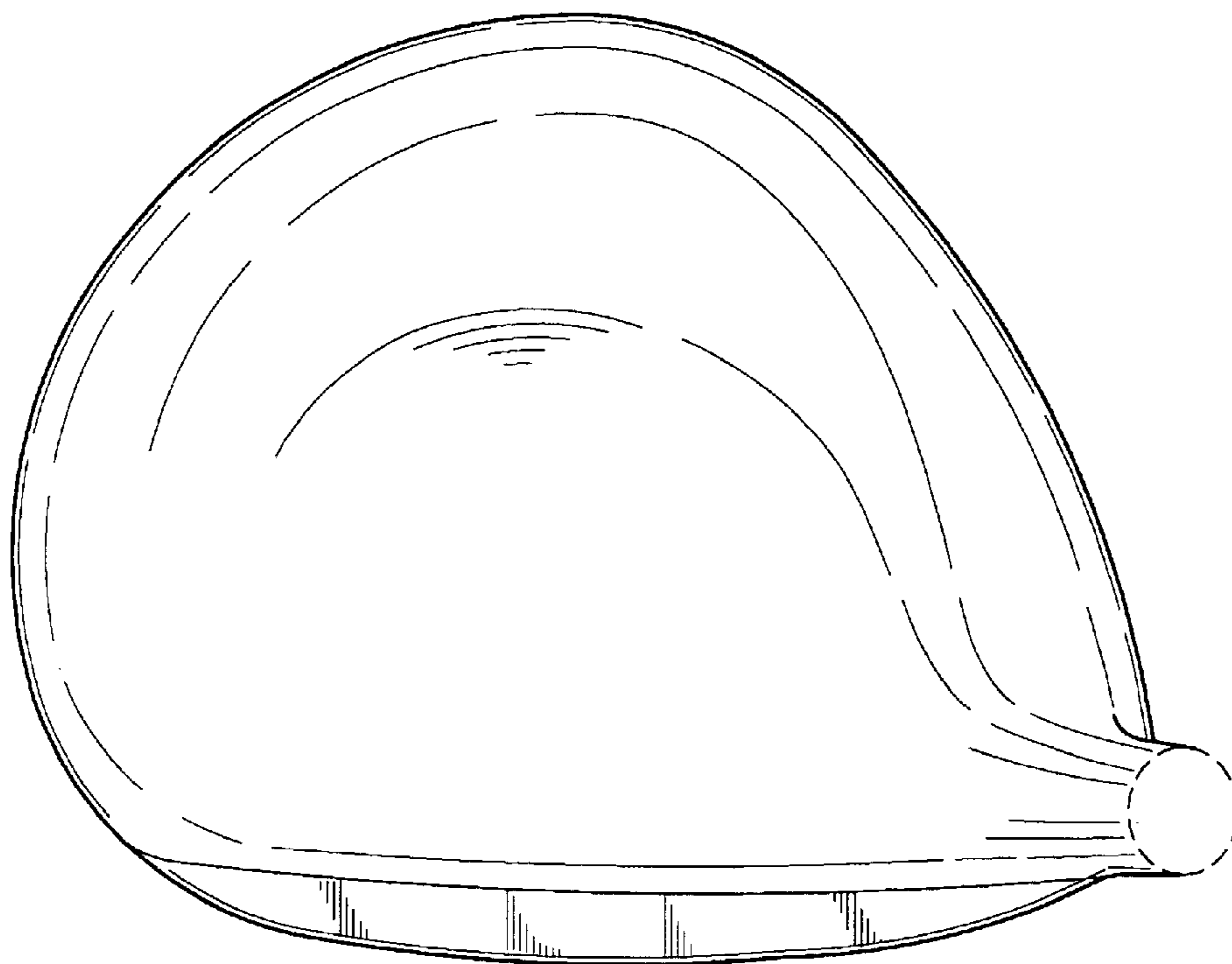

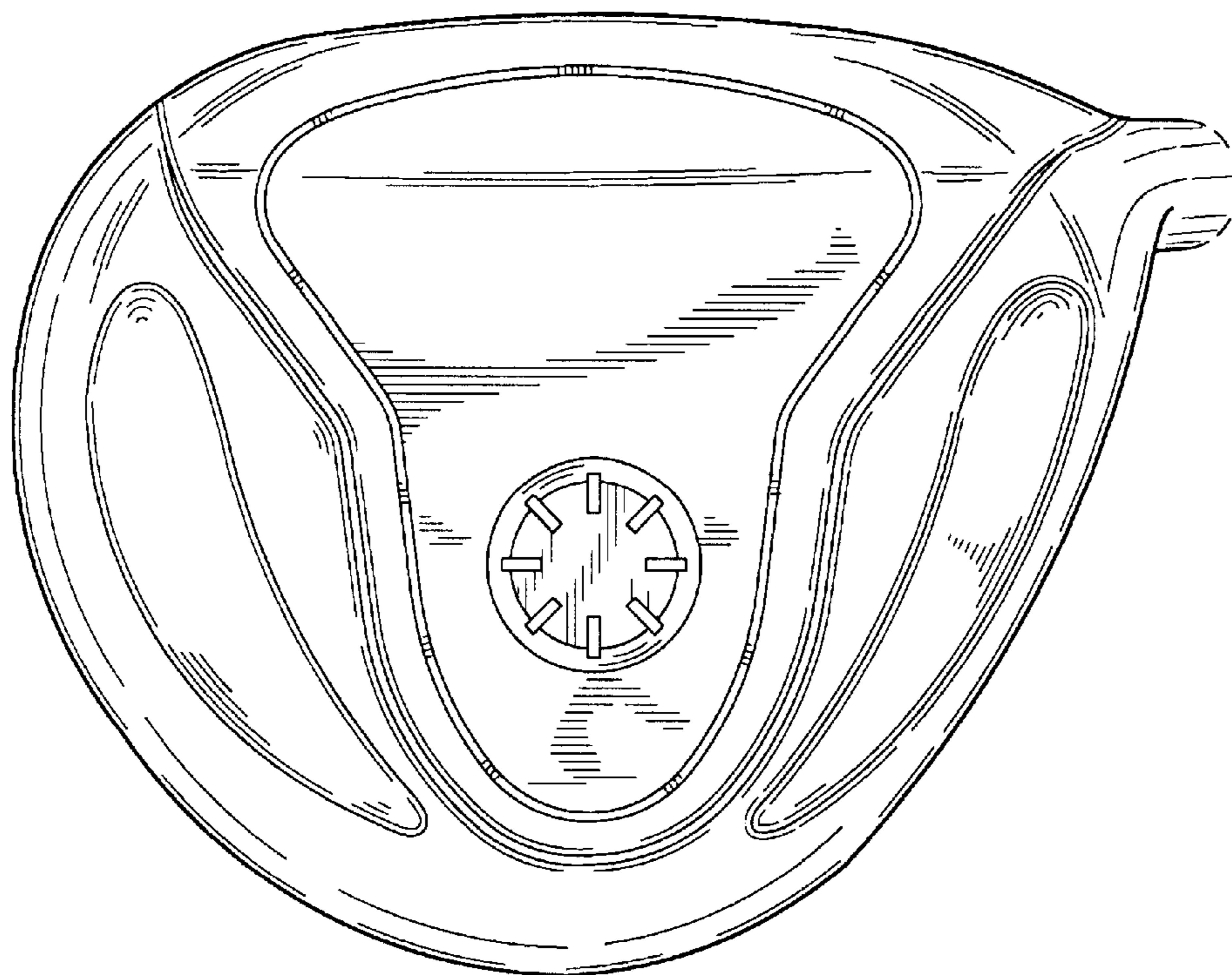

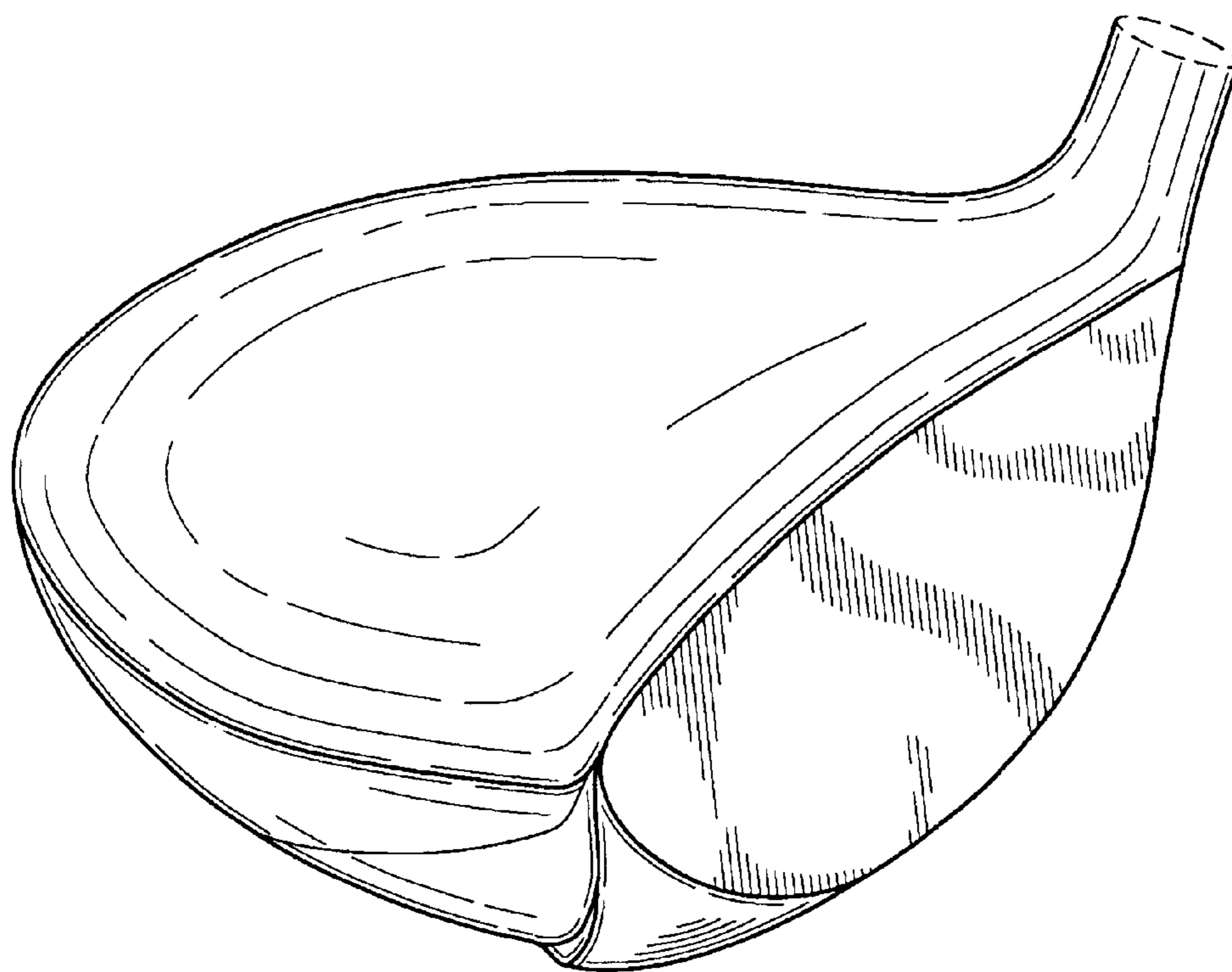

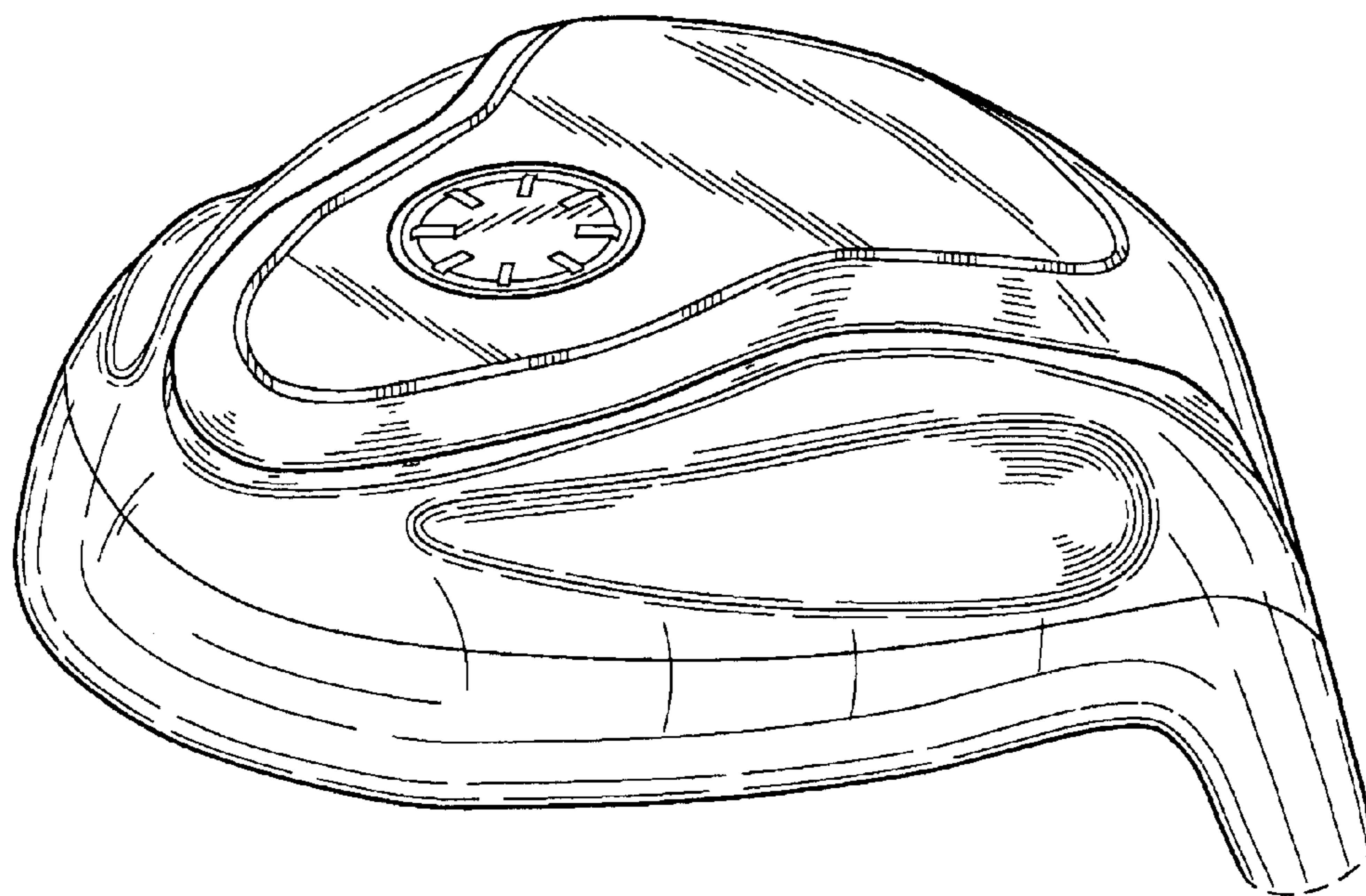

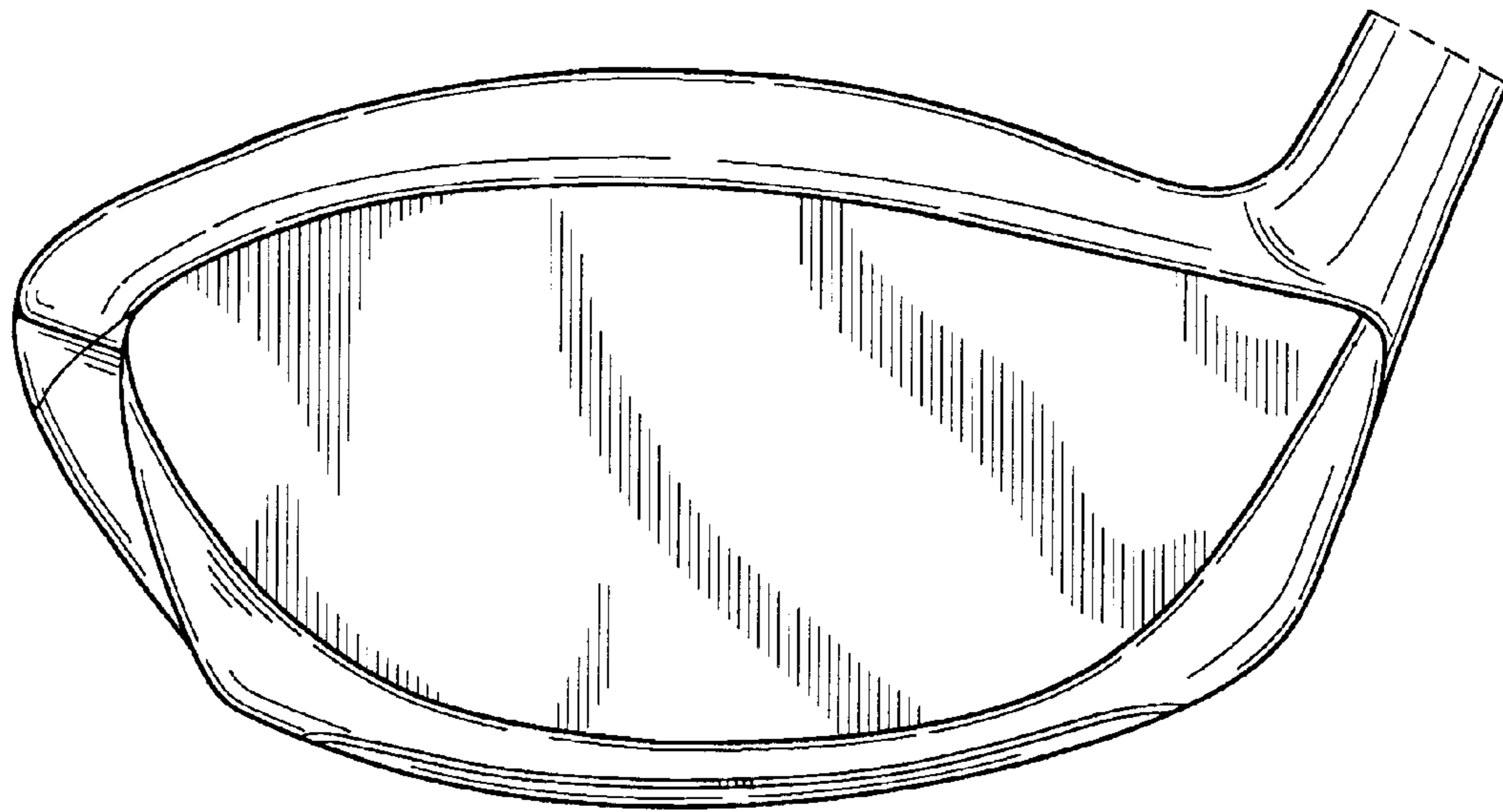

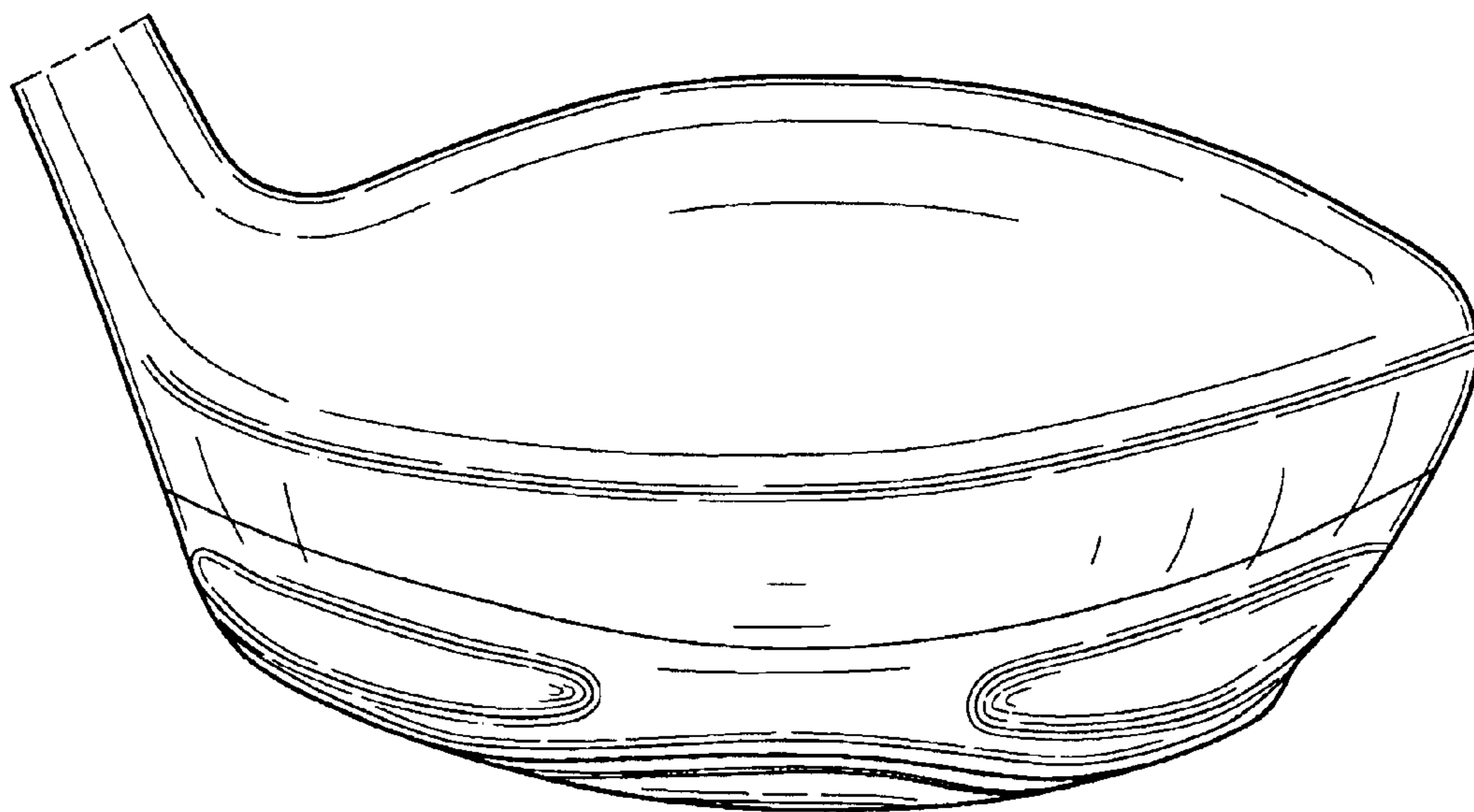

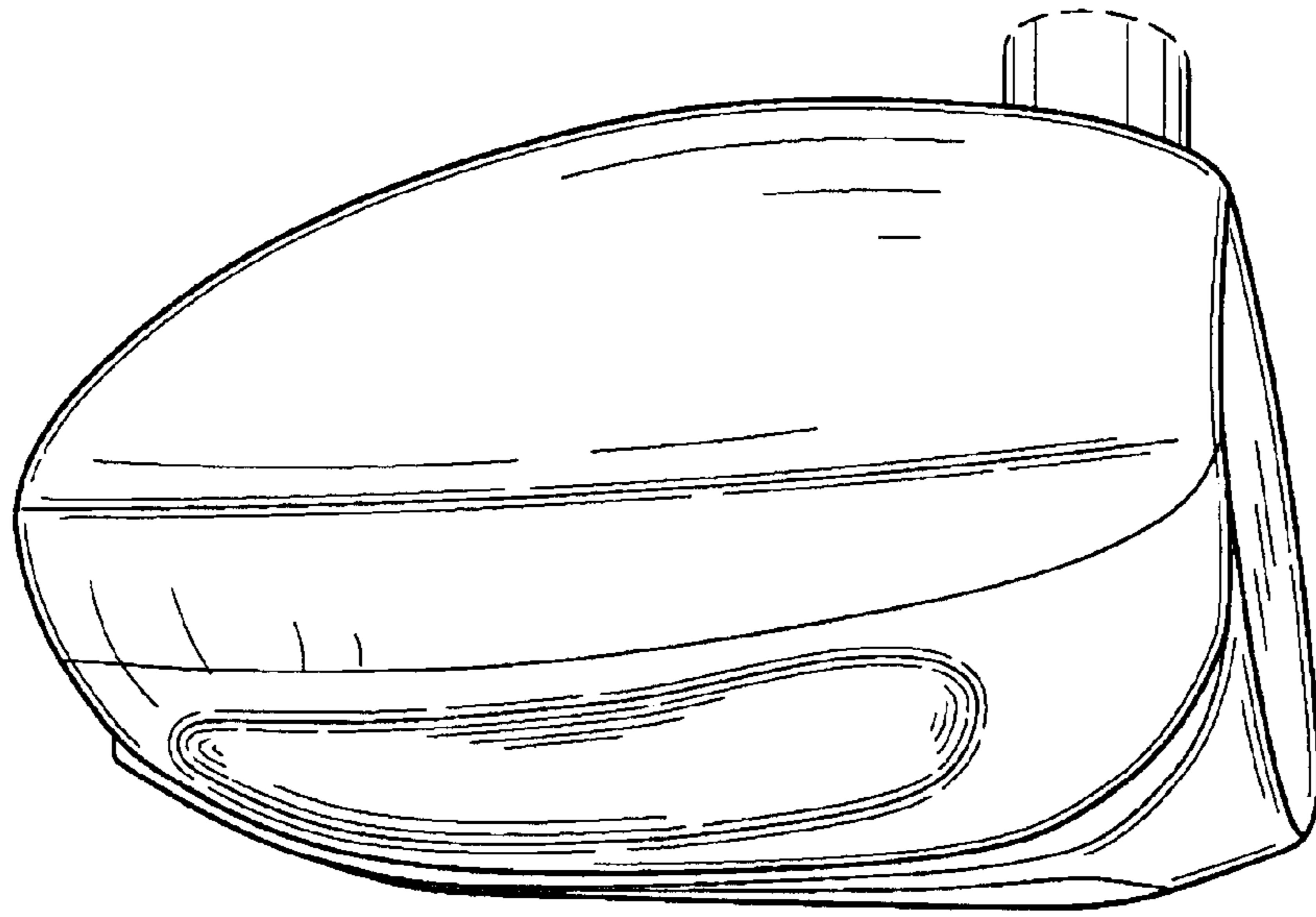

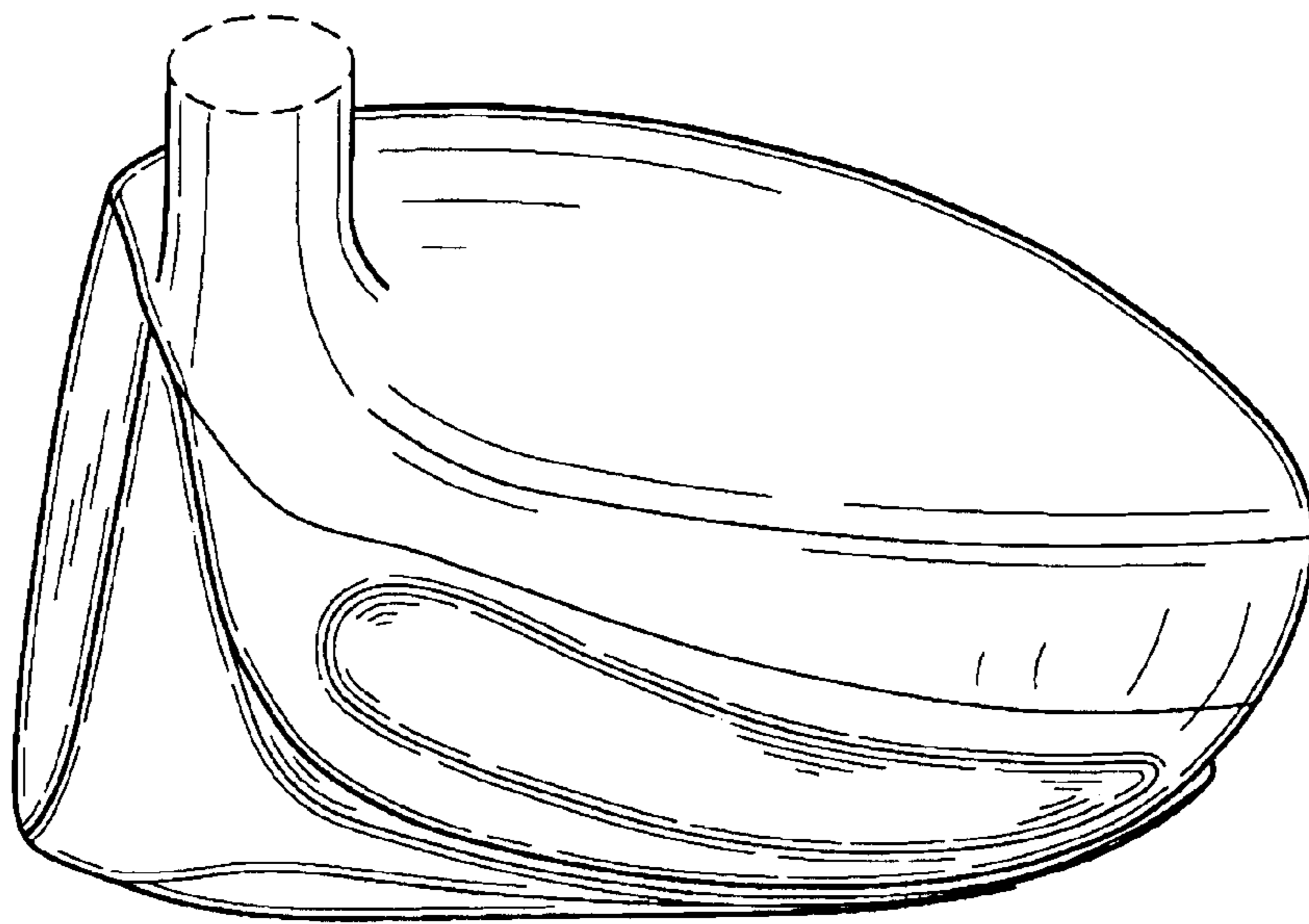

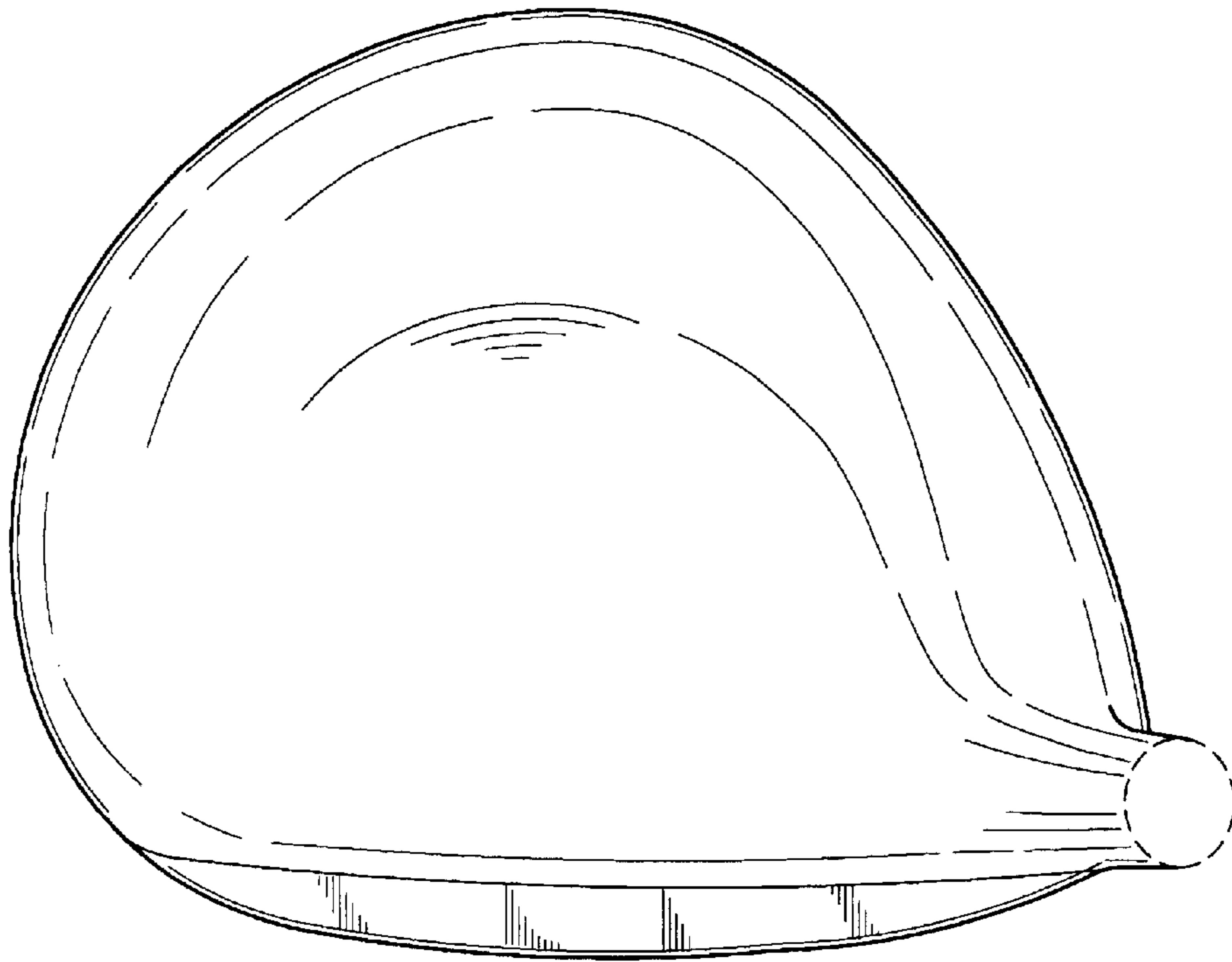

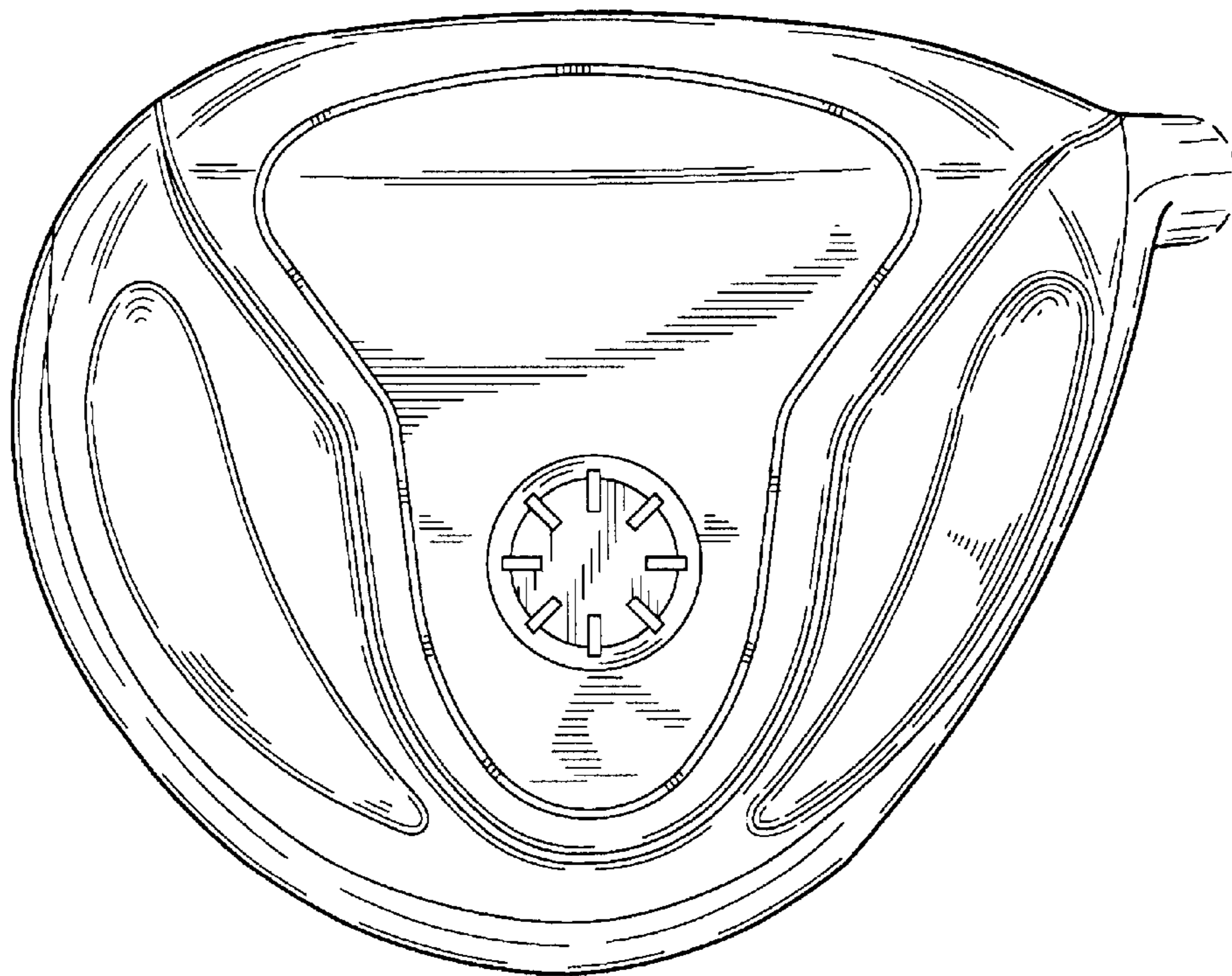

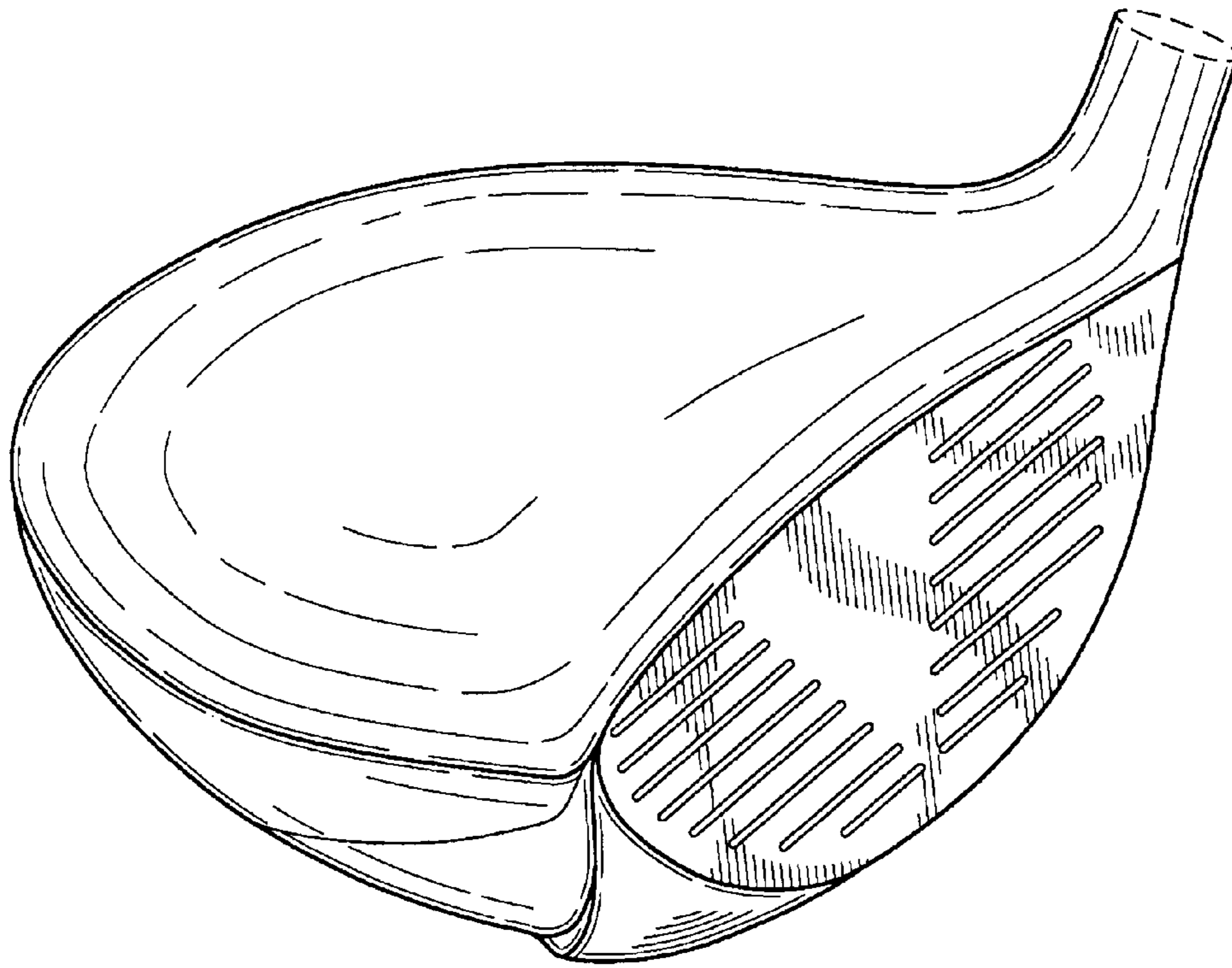

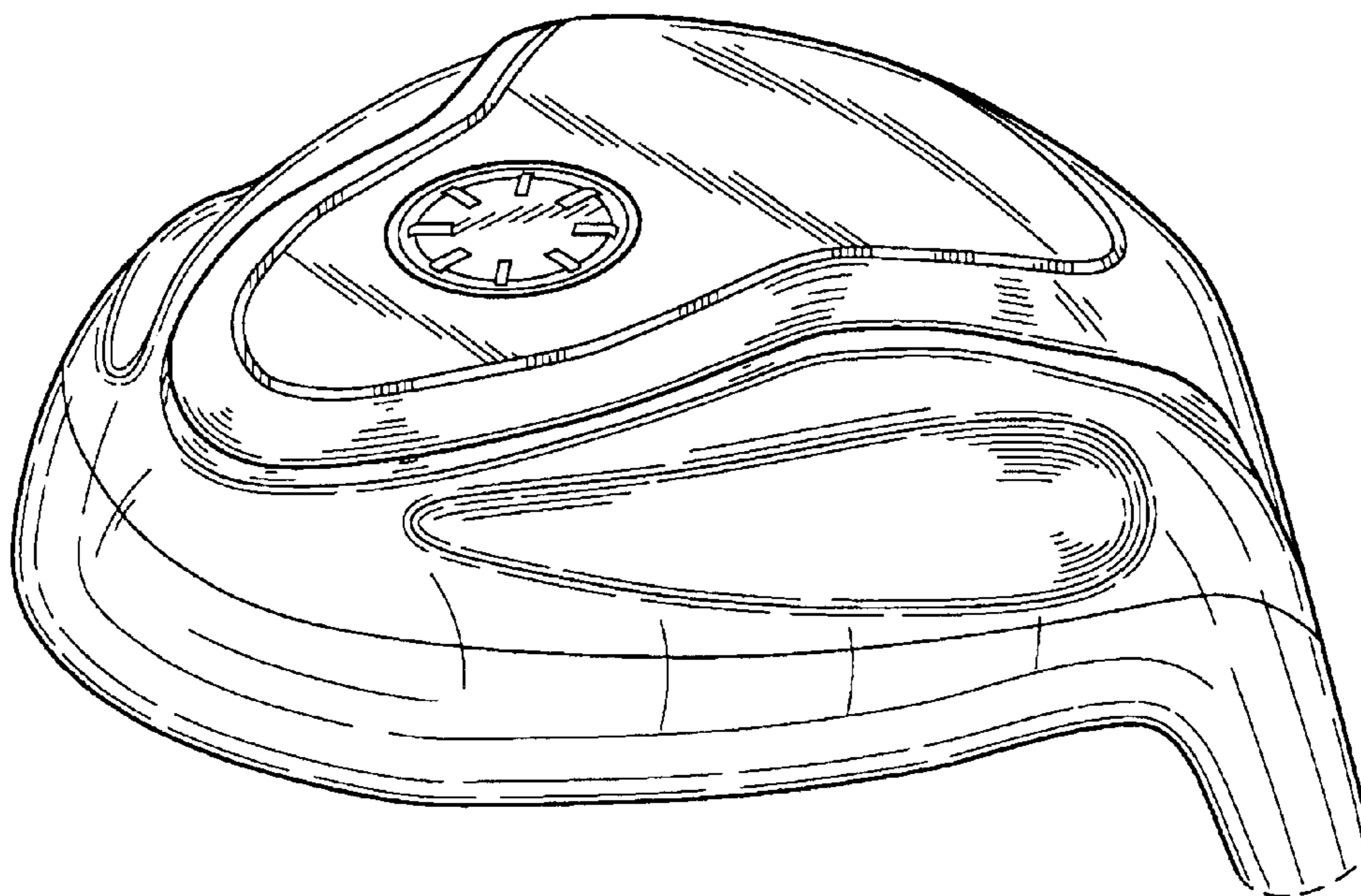

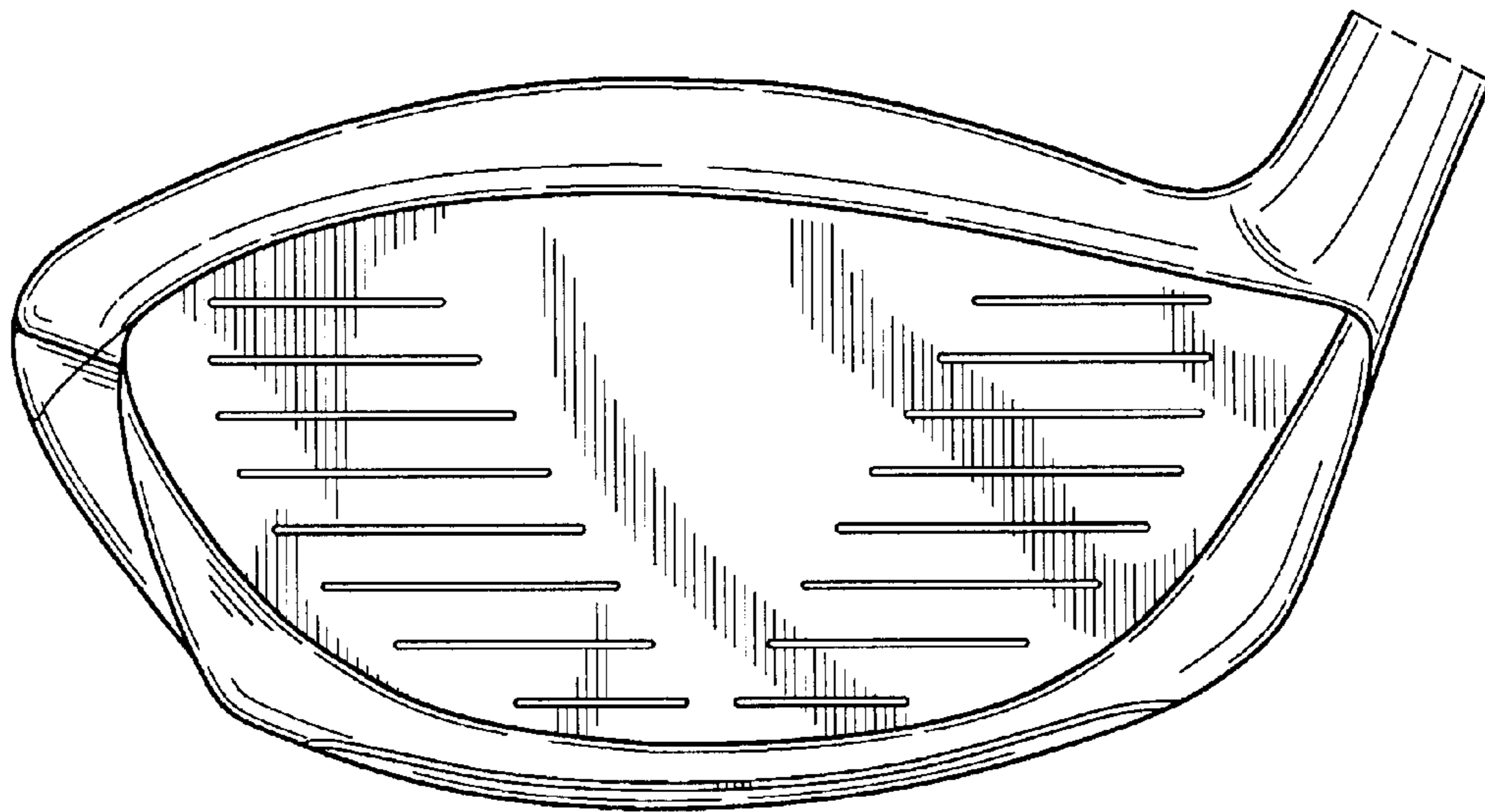

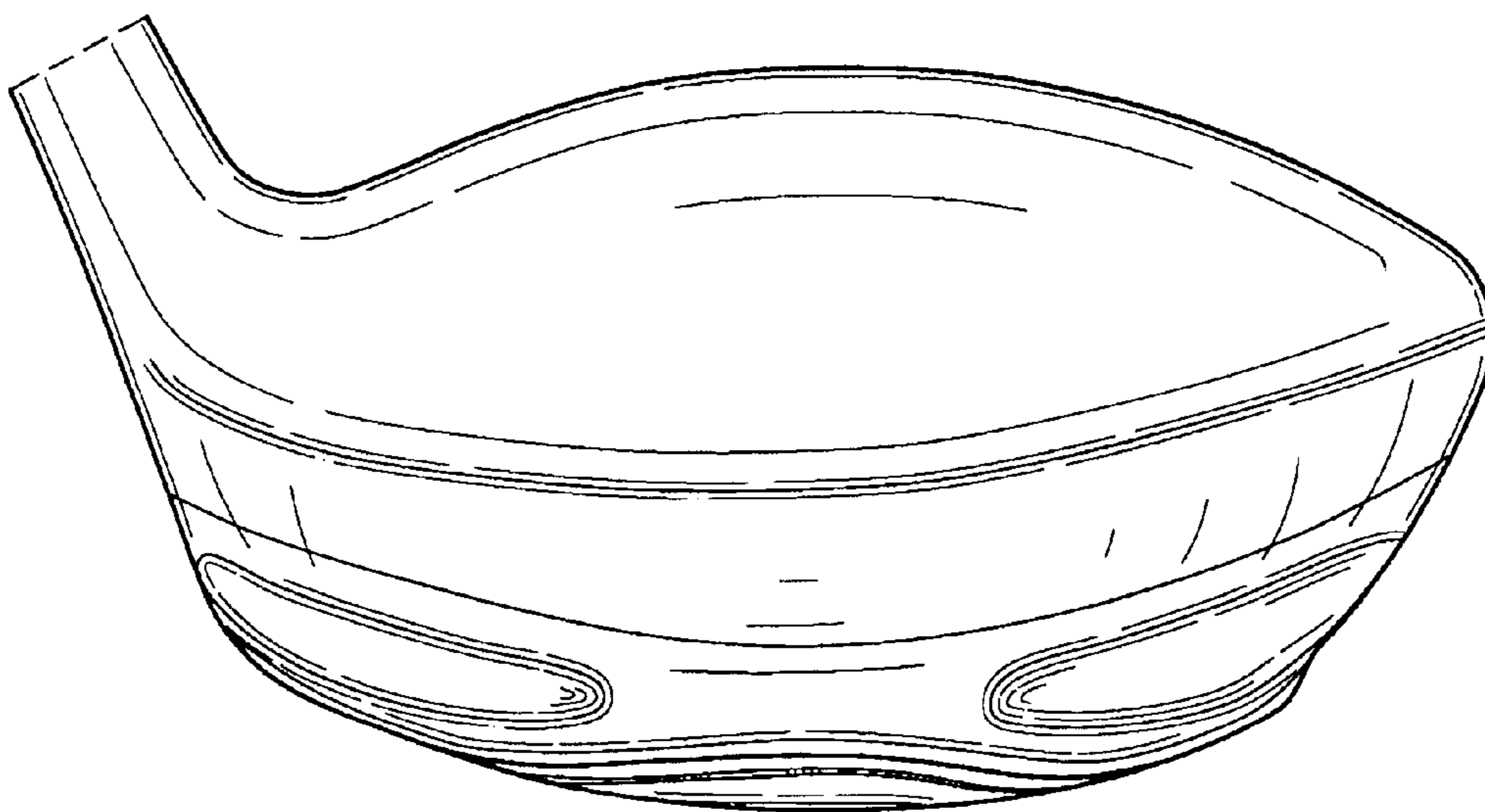

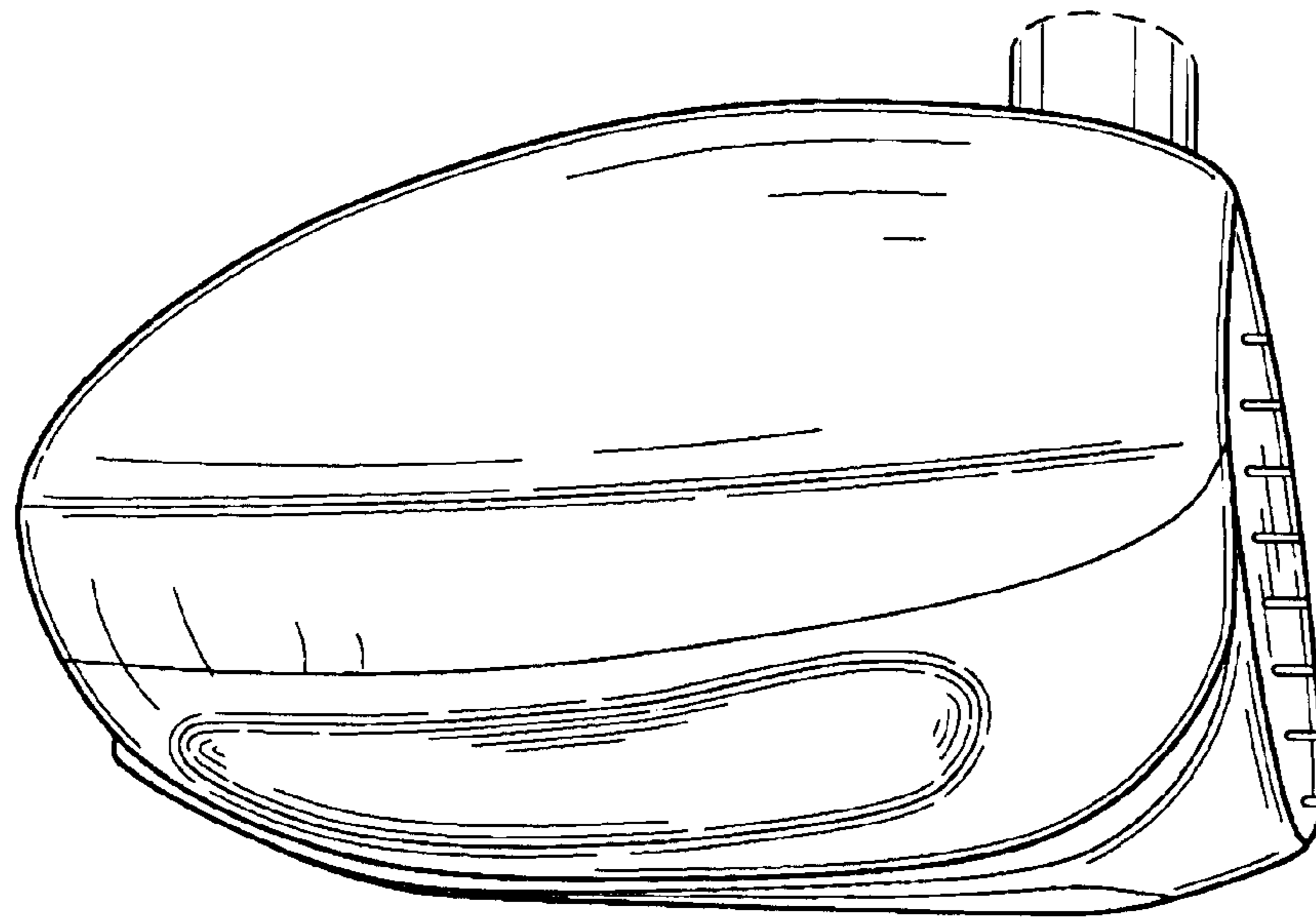

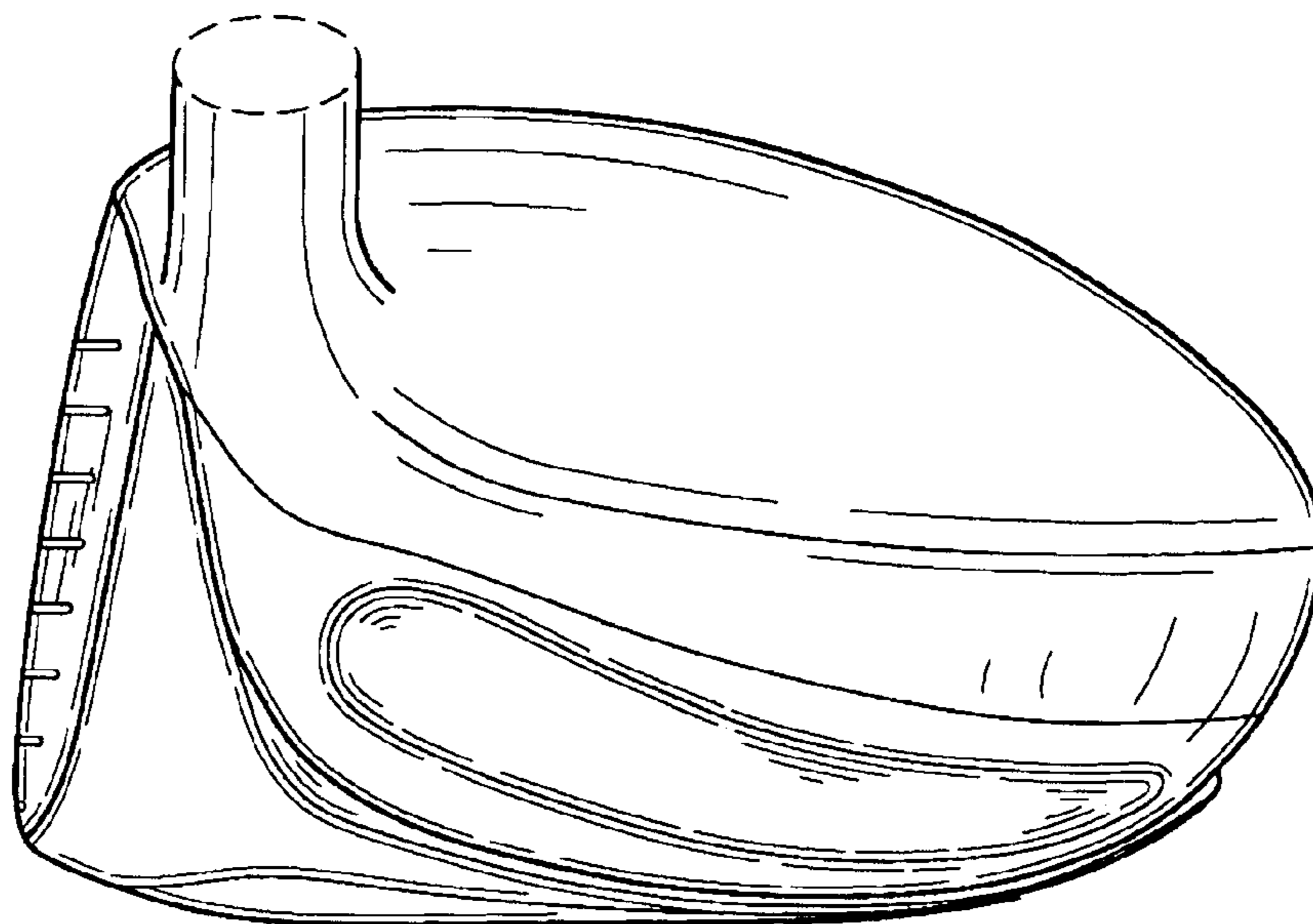

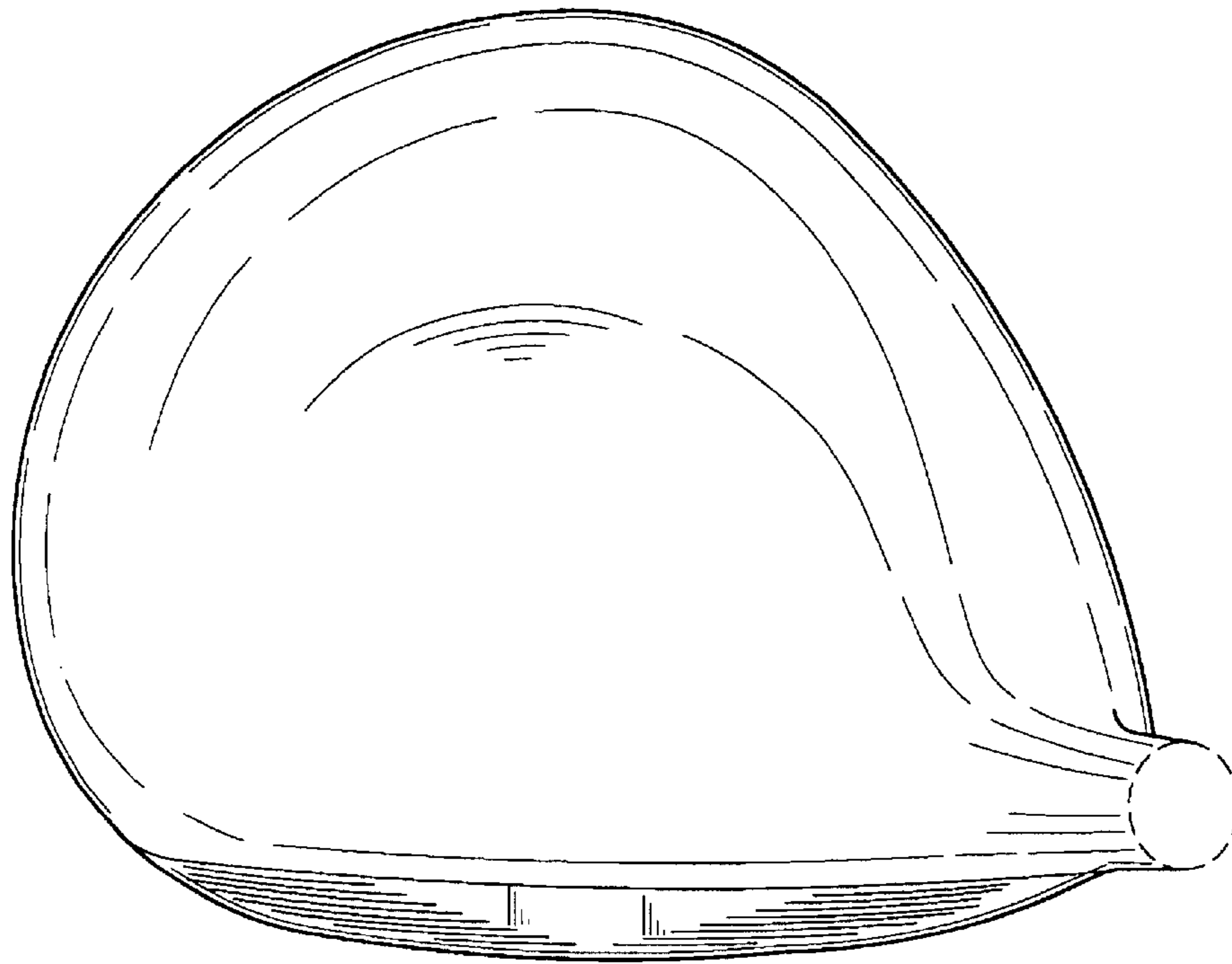

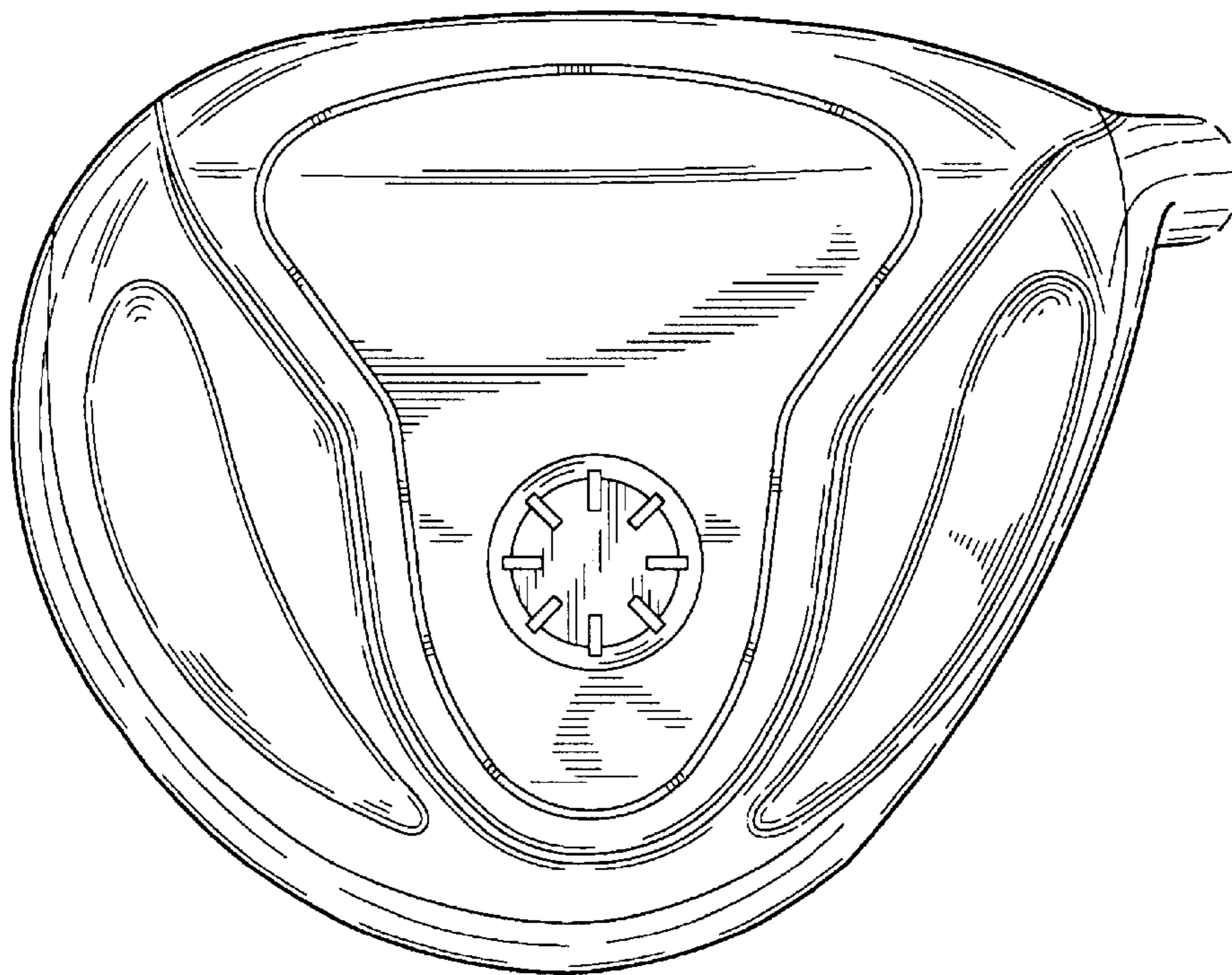
