(57) **CLAIM**

The ornamental design for a decorative radiator cover, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of the decorative radiator cover in accordance with the present invention;

FIG. 2 is a back view of the decorative radiator cover of FIG. 1;

FIG. 3 is a top view of the decorative radiator cover of FIG. 1;

FIG. 4 is a bottom view of the decorative radiator cover of FIG. 1;

FIG. 5 is a perspective view of the decorative radiator cover of FIG. 1;

FIG. 6 is a first side view of the decorative radiator cover of FIG. 1;

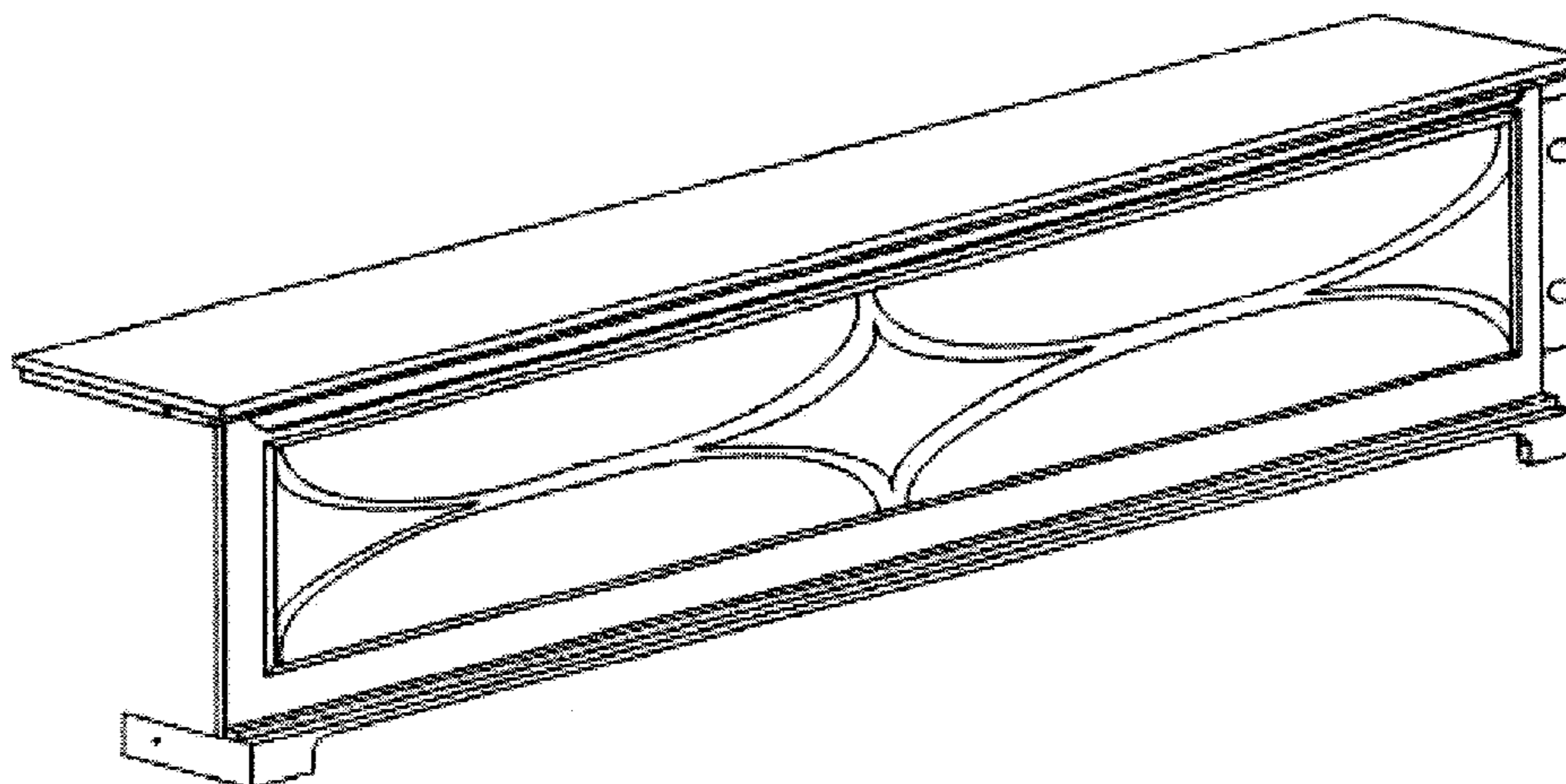
FIG. 7 is the other side view of the decorative radiator cover of FIG. 1;

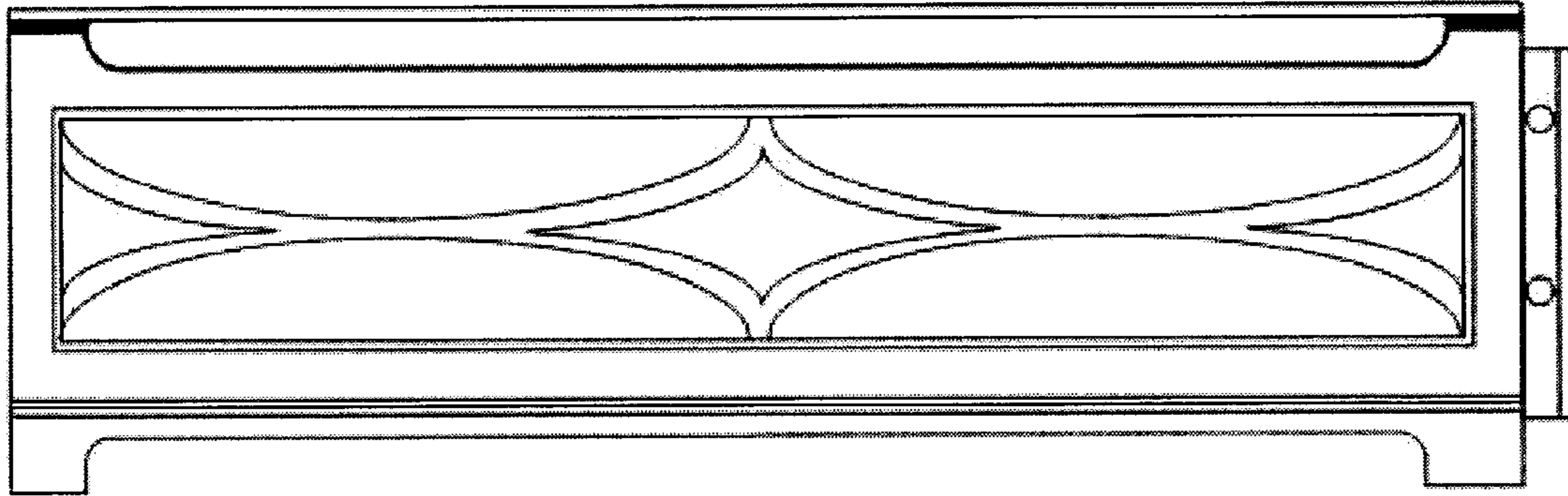

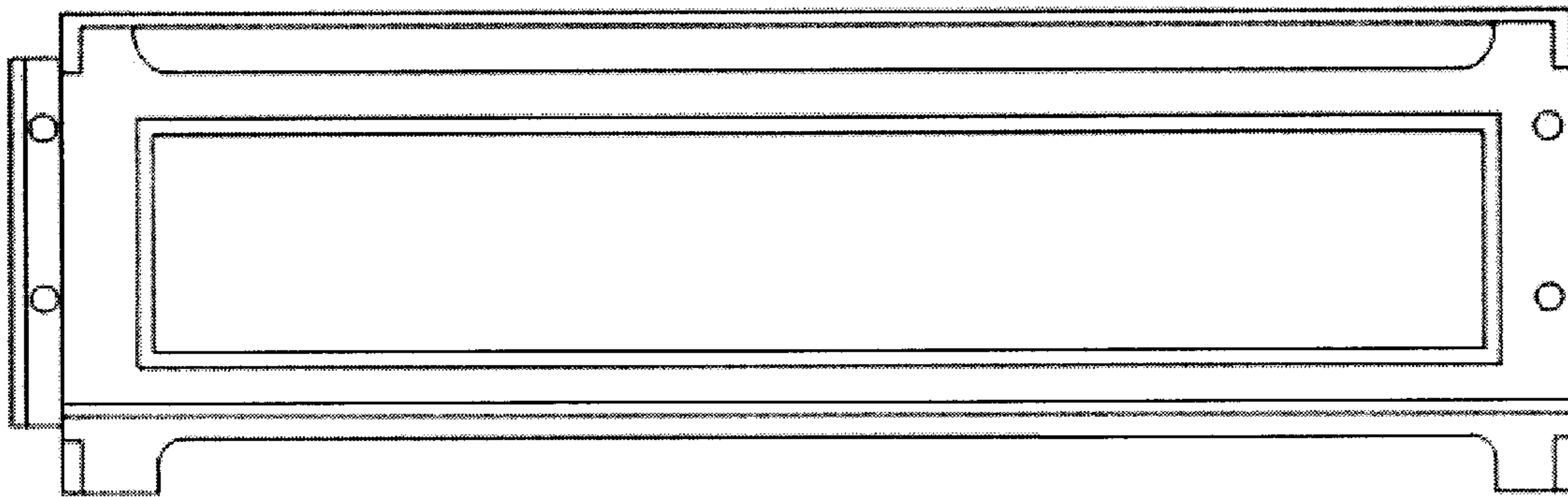

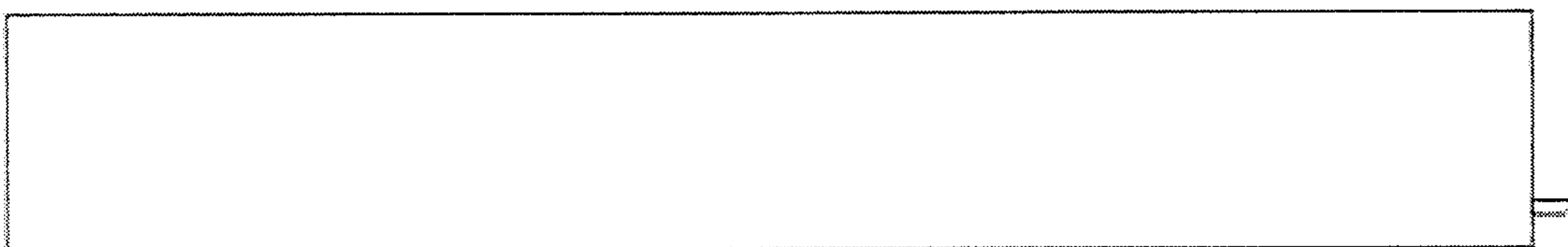

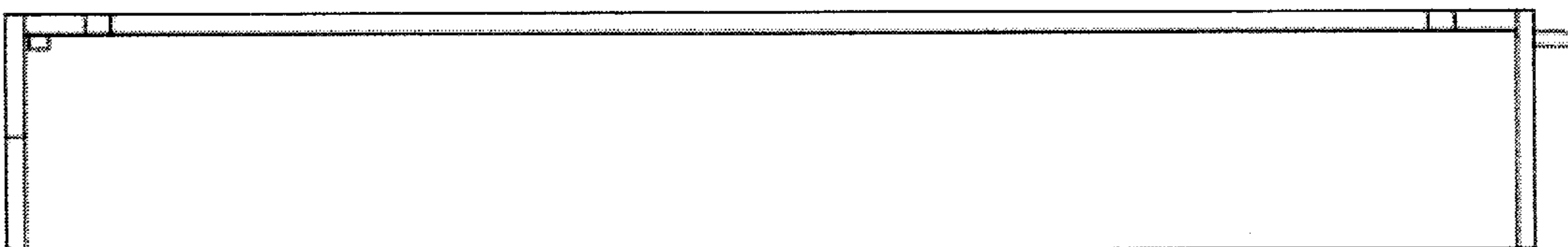

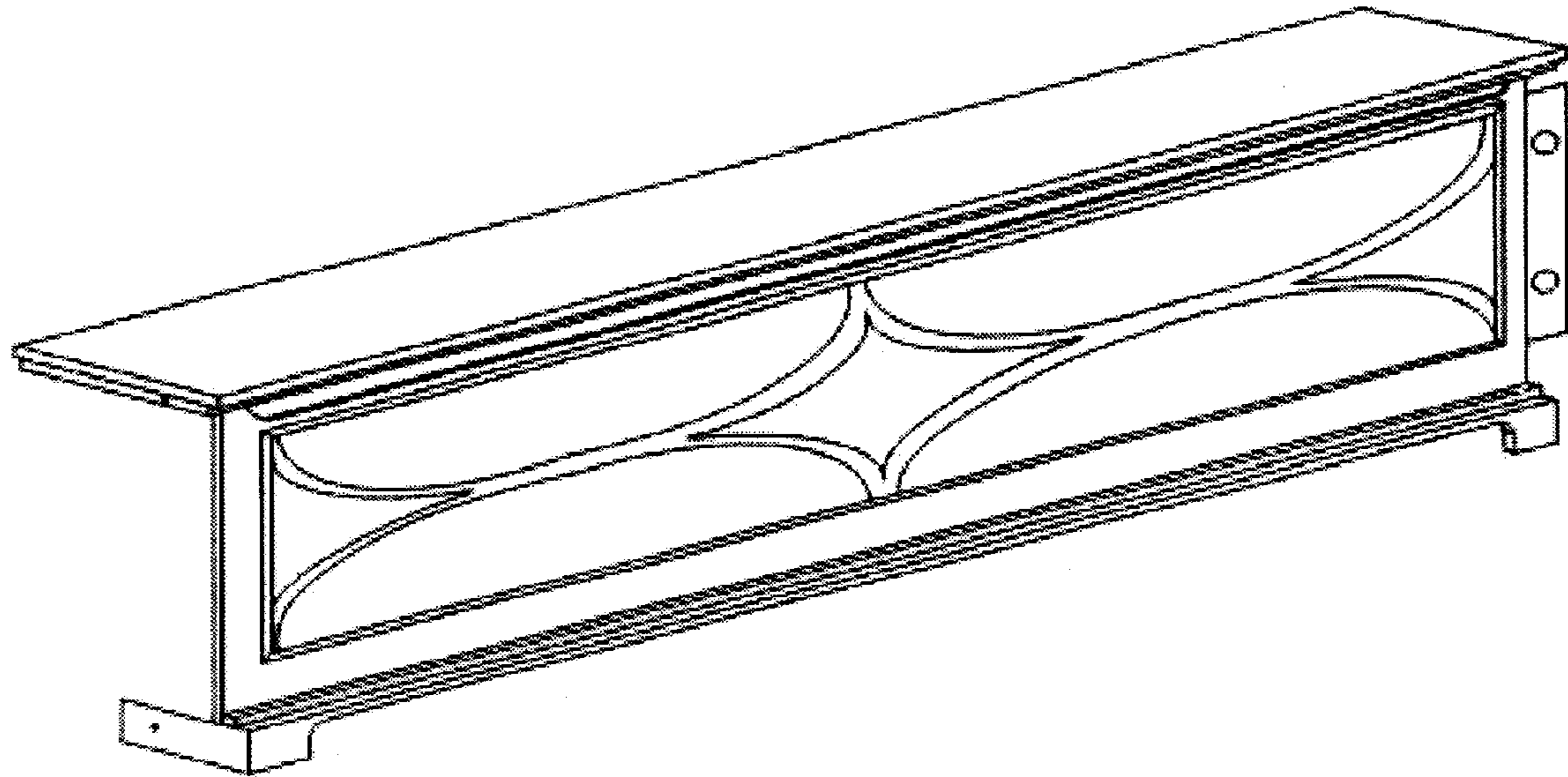

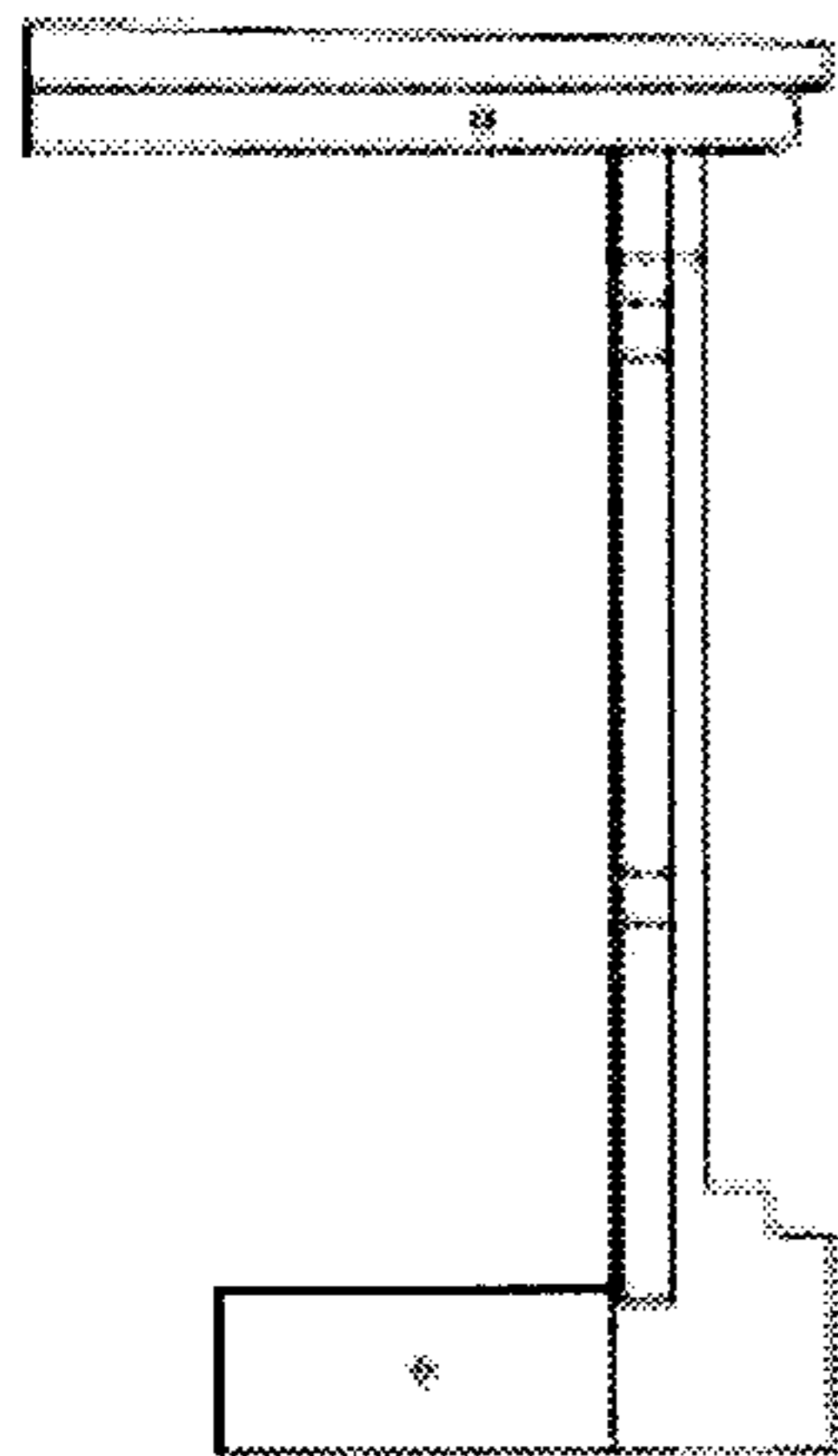

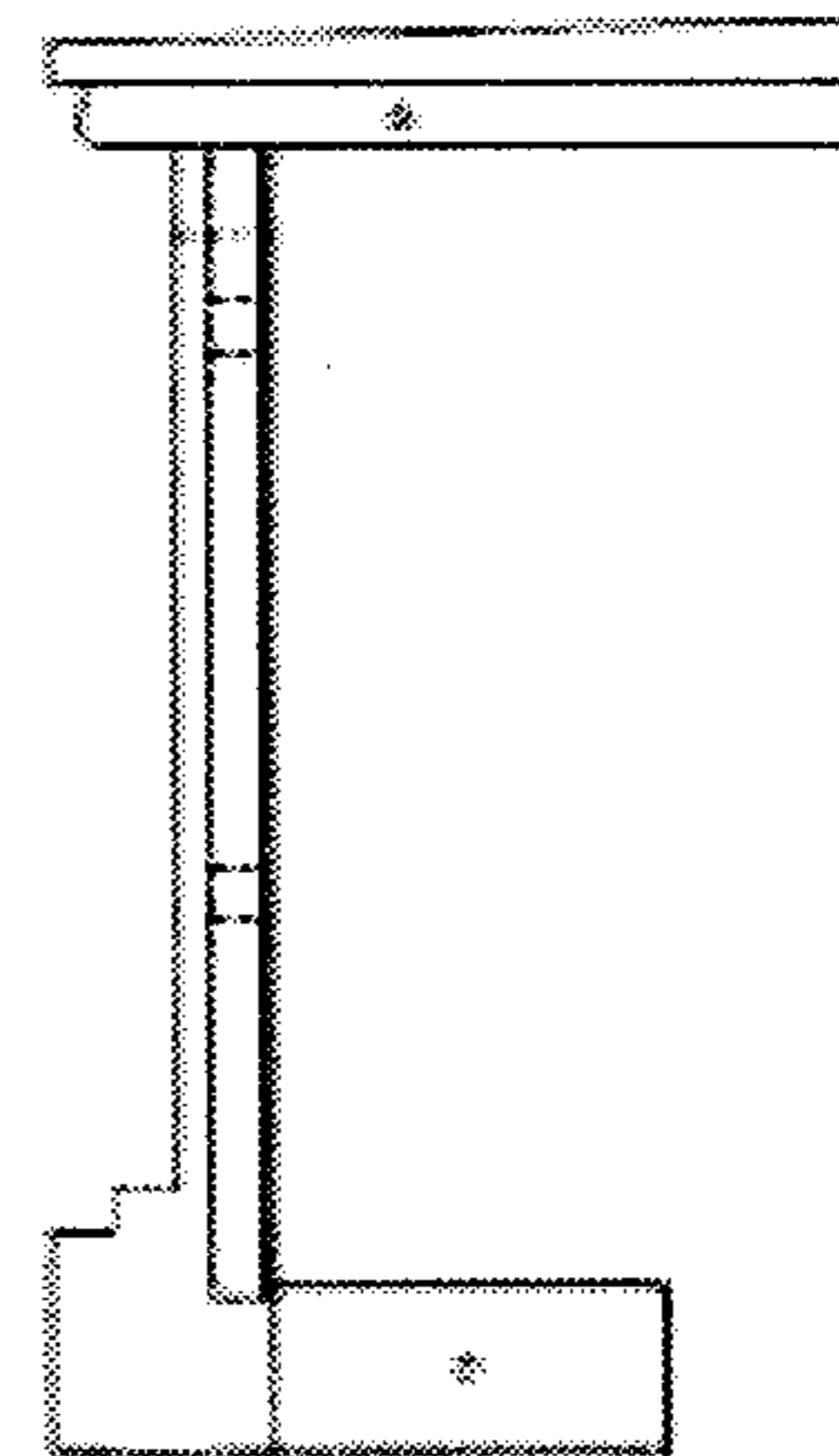

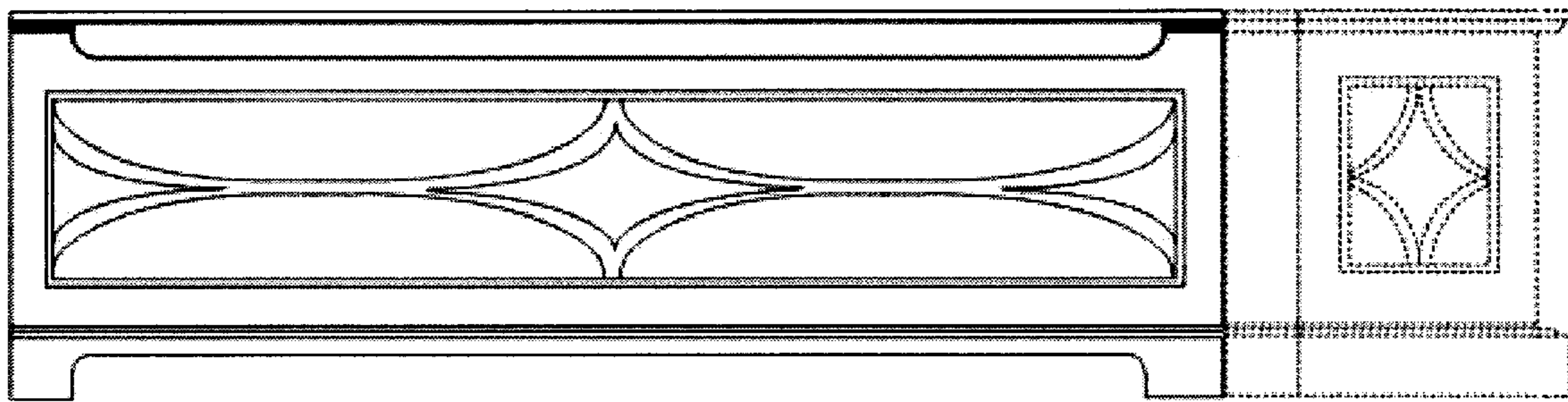

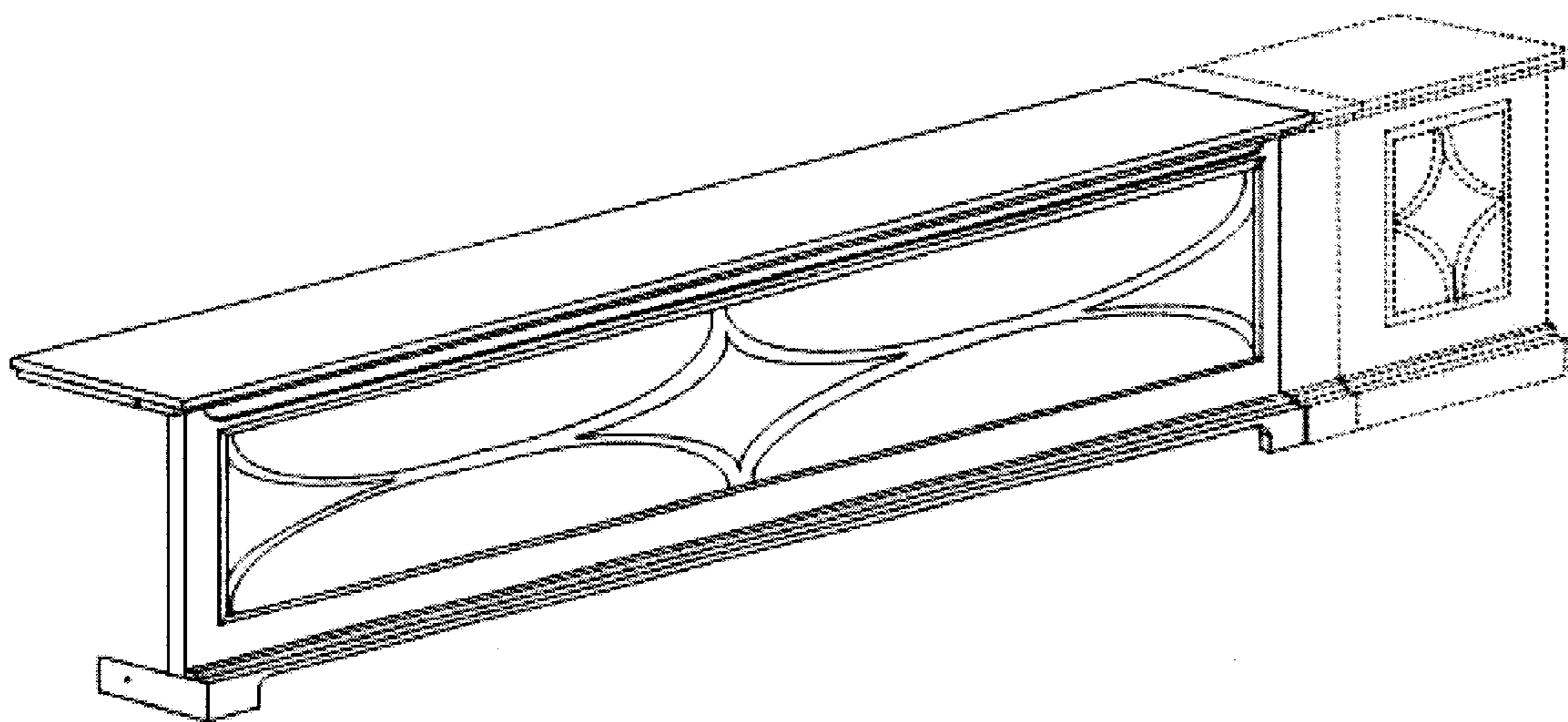
