(57) **CLAIM**

The ornamental design for a syme amputation boot for a locked ankle, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the syme amputation boot for a locked ankle with adjustable strap in an open position.

FIG. 2 is a front elevational view of the syme amputation boot for a locked ankle.

FIG. 3 is a rear elevational view thereof.

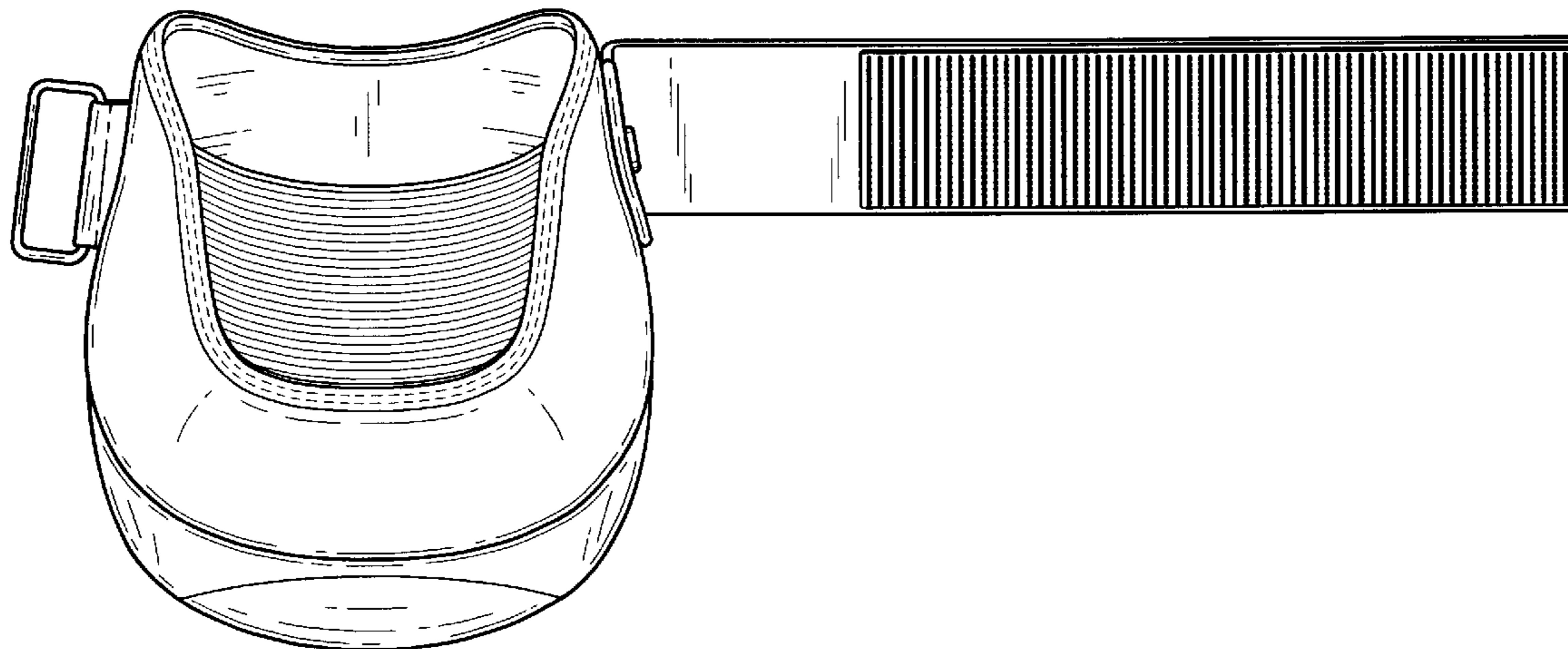
FIG. 4 is a left side elevational view thereof.

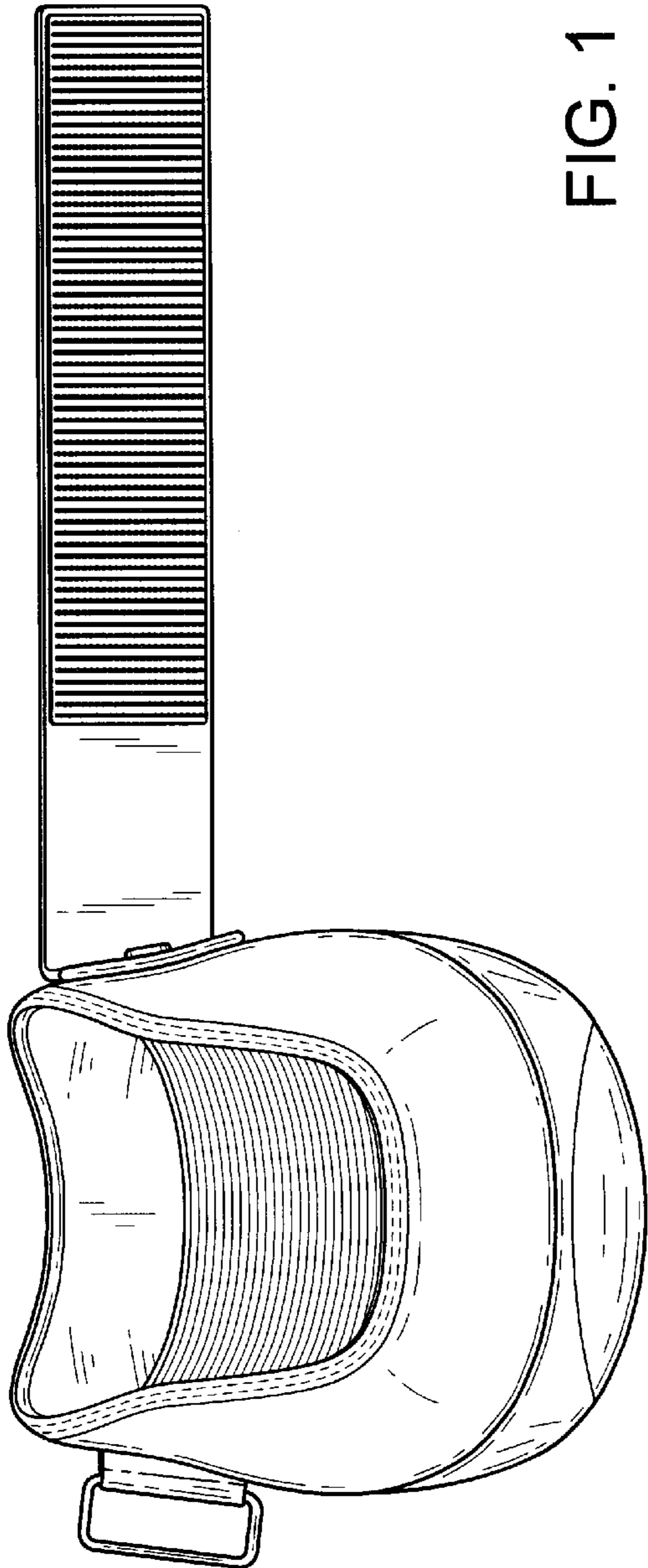

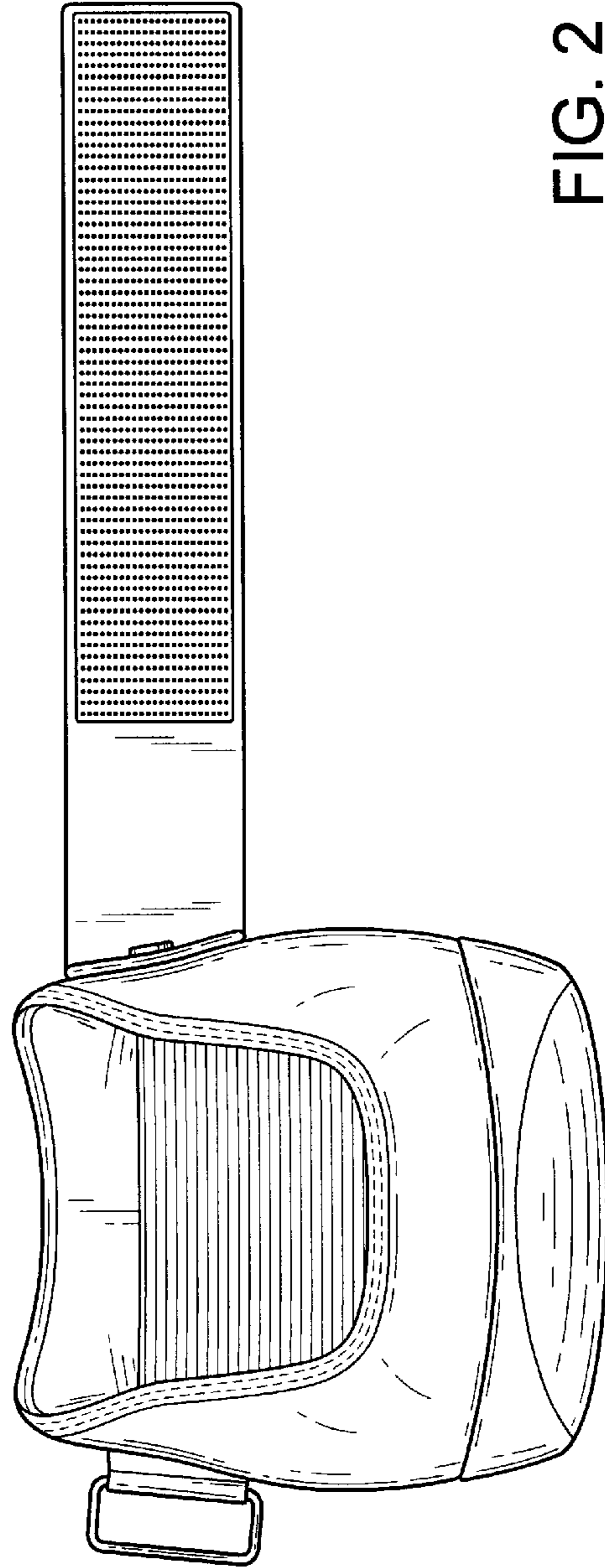

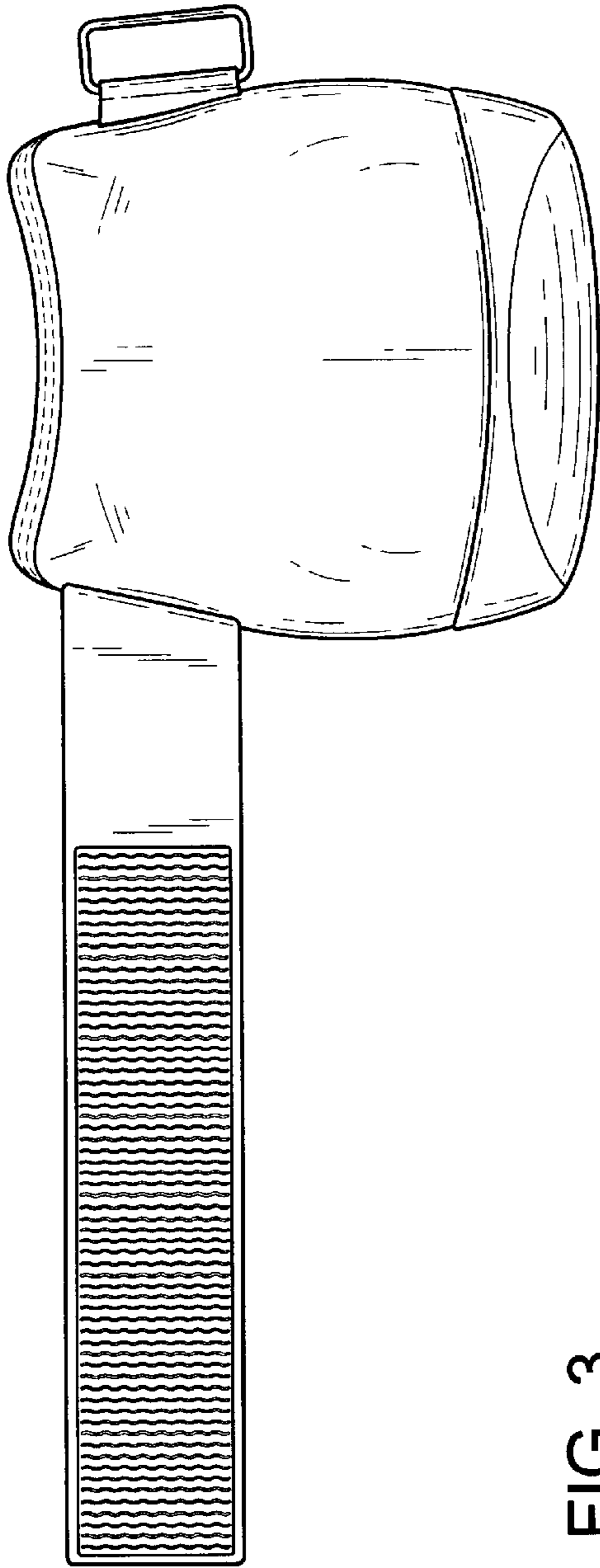

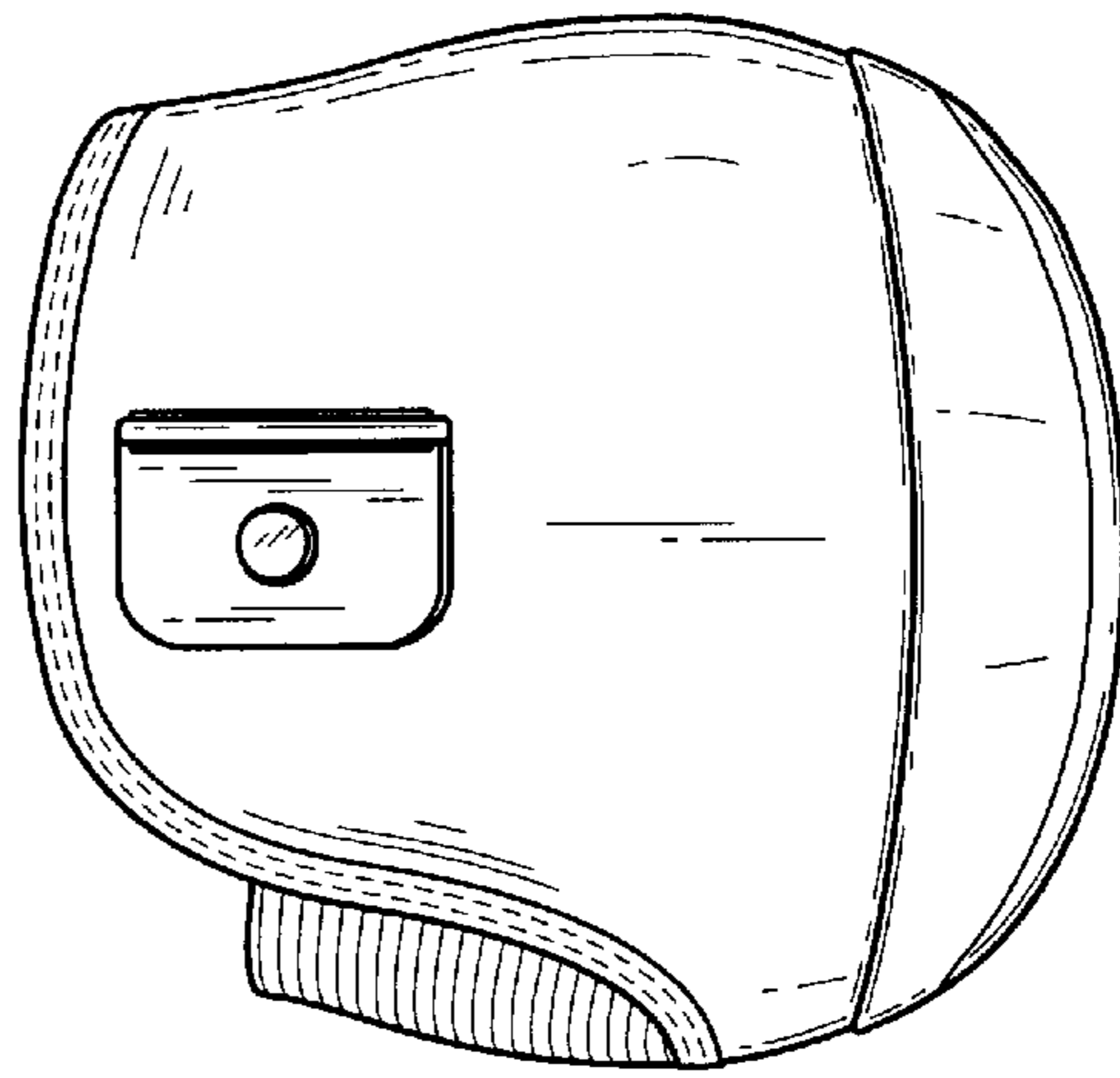

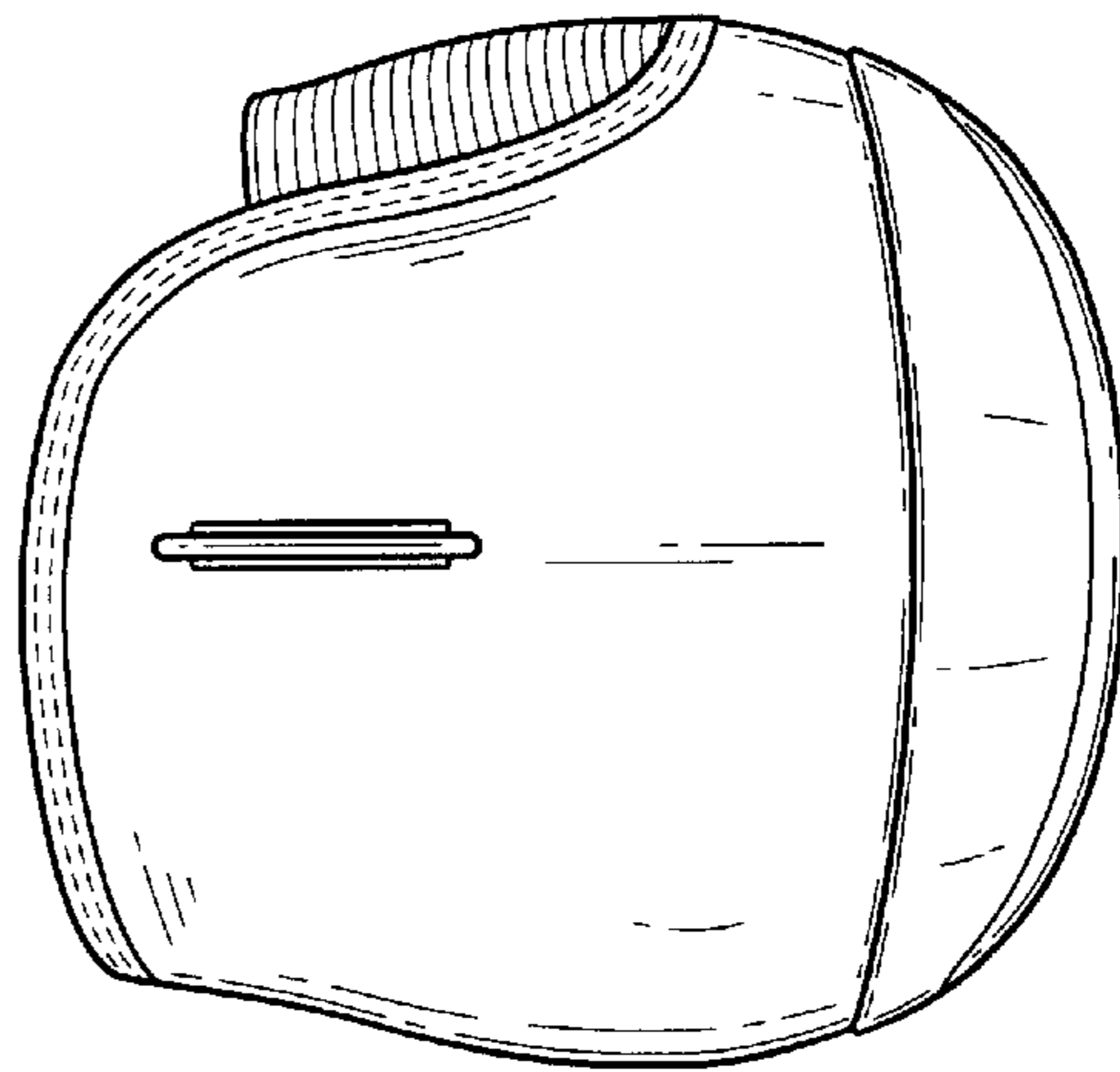

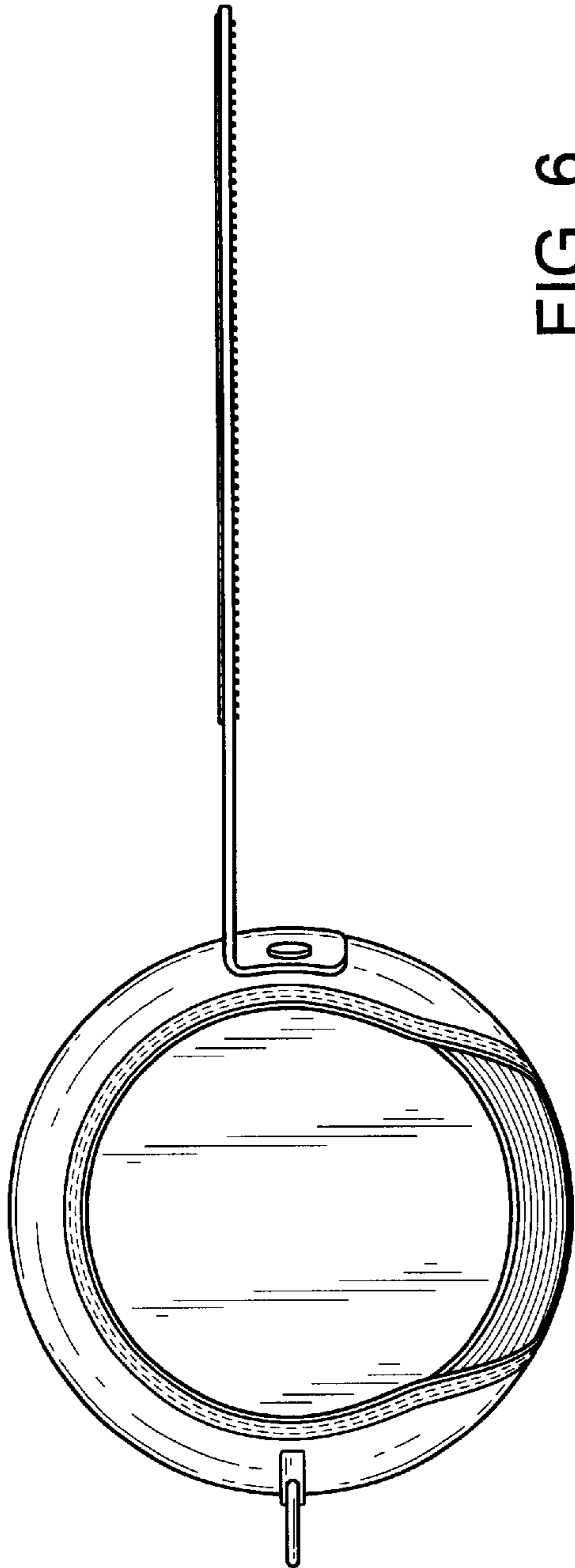

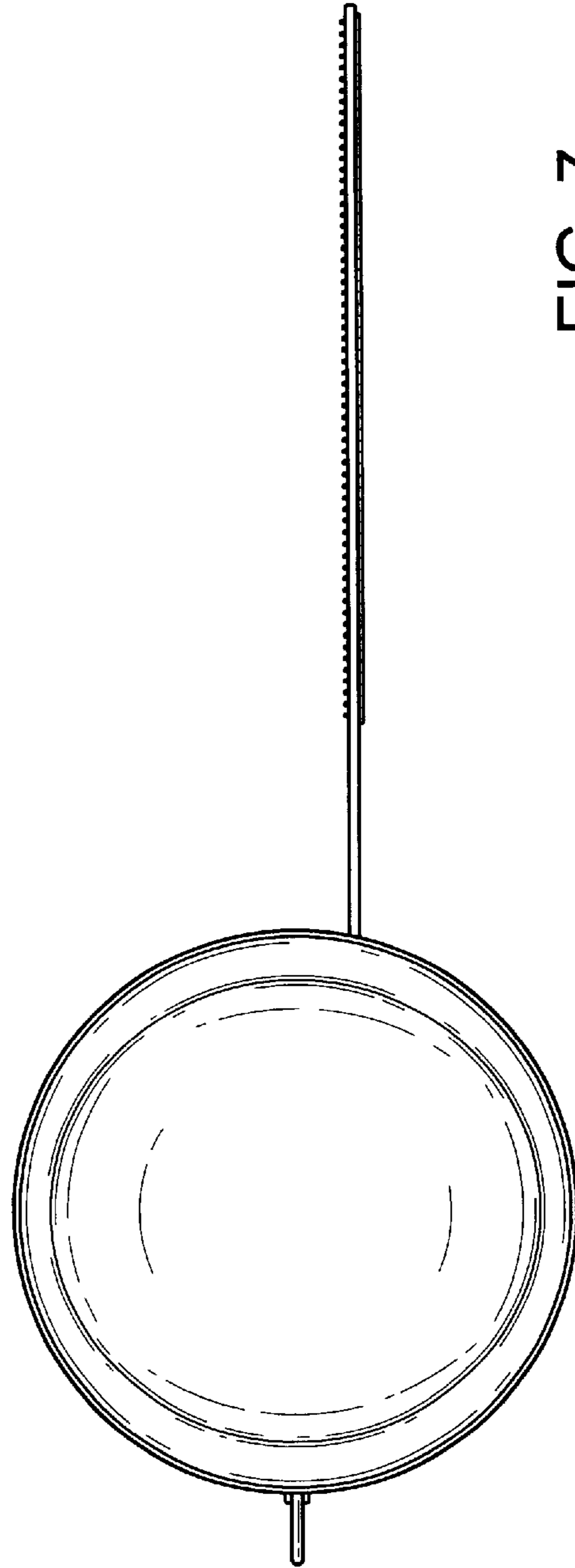
