DESCRIPTION

FIG. 1 is a front view of the shorts showing my new design. The broken line showing is for illustrative purposes only and forms no part of the claimed design;

FIG. 2 is a front elevational view of a second embodiment the shorts thereof;

FIG. 3 is a front elevational view of a third embodiment of the shorts thereof;

FIG. 4 is a front elevational view of a fourth embodiment of the shorts thereof;

FIG. 5 is a front elevational view of a fifth embodiment of the shorts thereof

FIG. 6 is a side elevational view of FIG. 1;

FIG. 7 is a side elevational view of FIGS. 3 and 4; and,

FIG. 8 is a side elevational view of FIGS. 2 and 5.

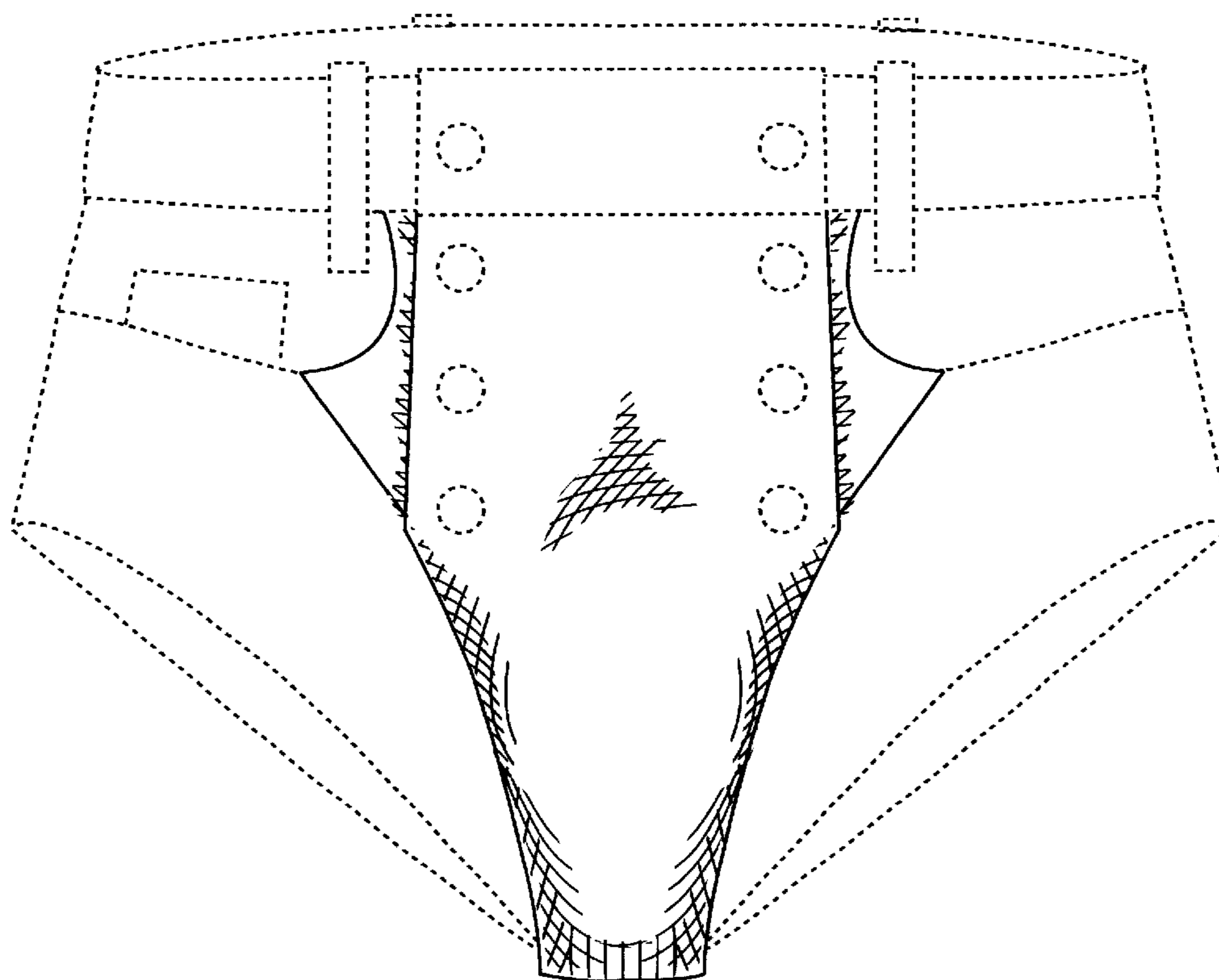

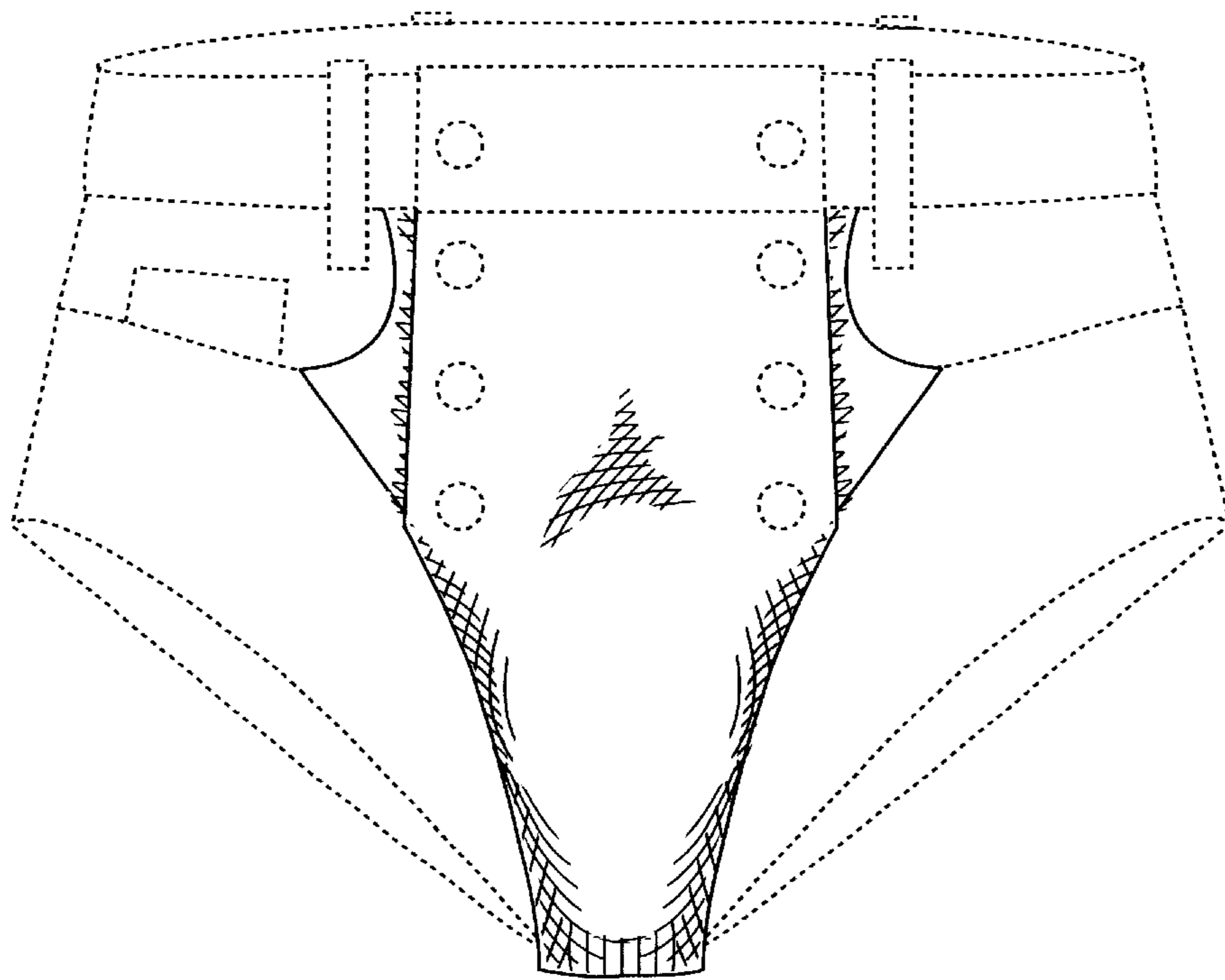

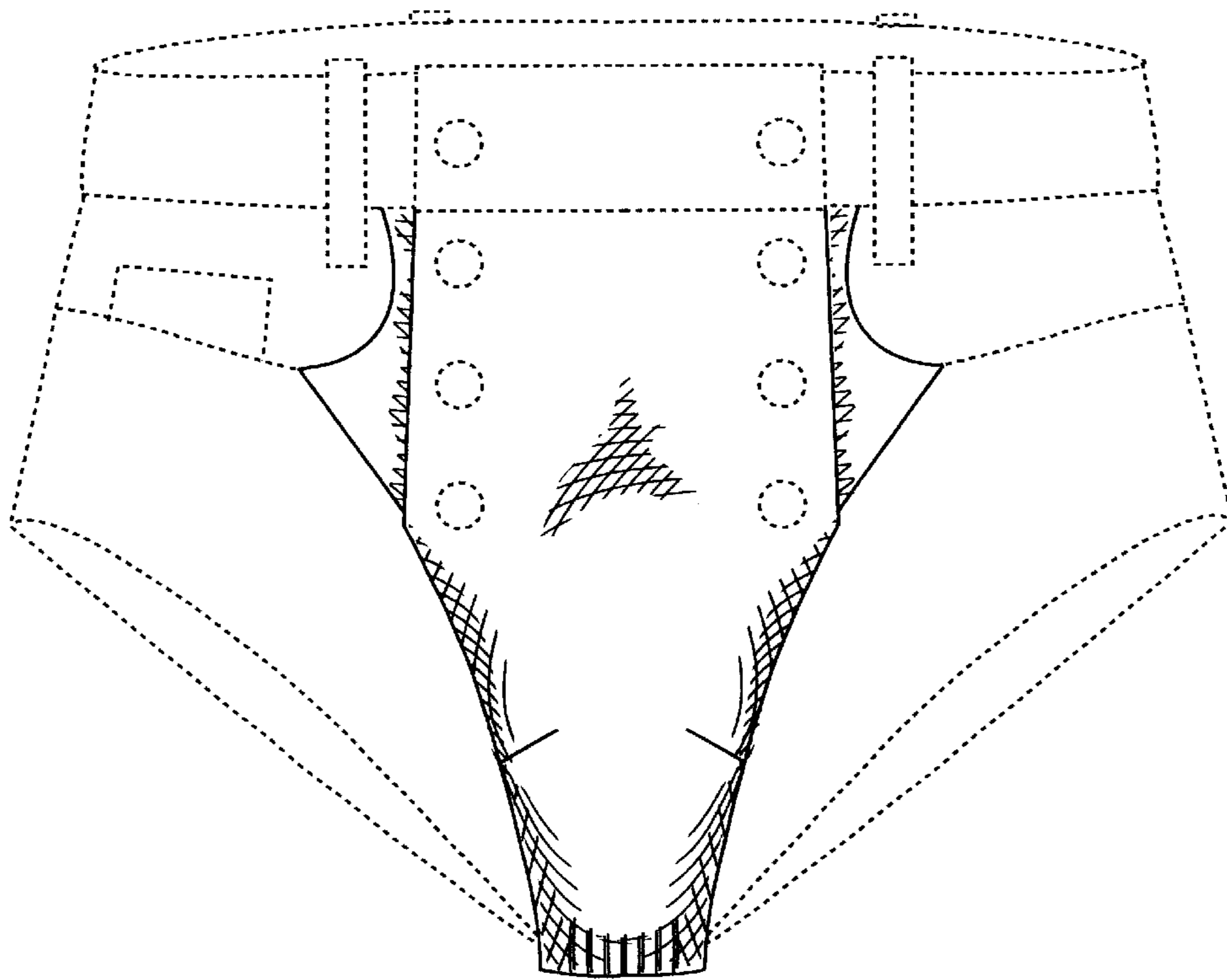

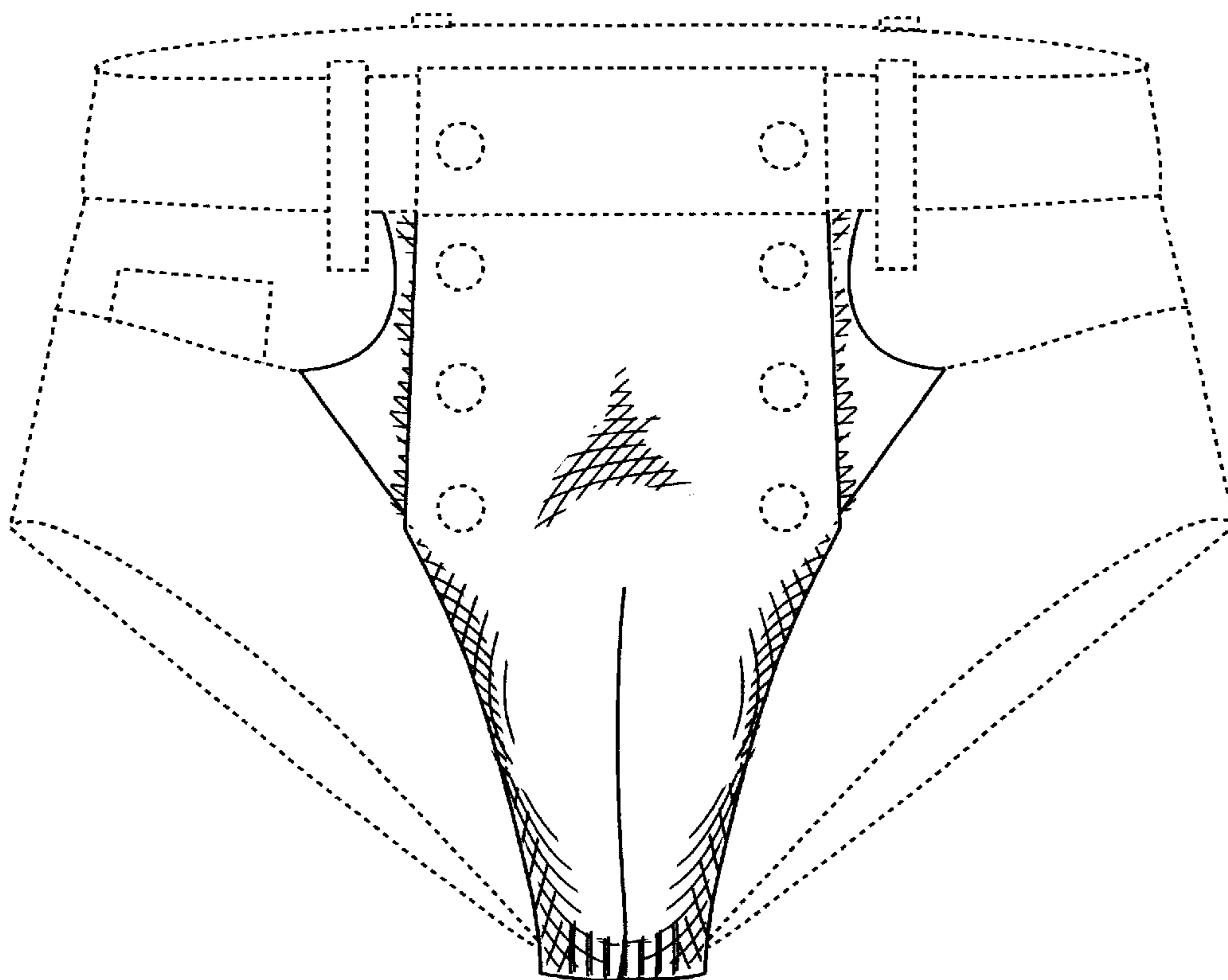

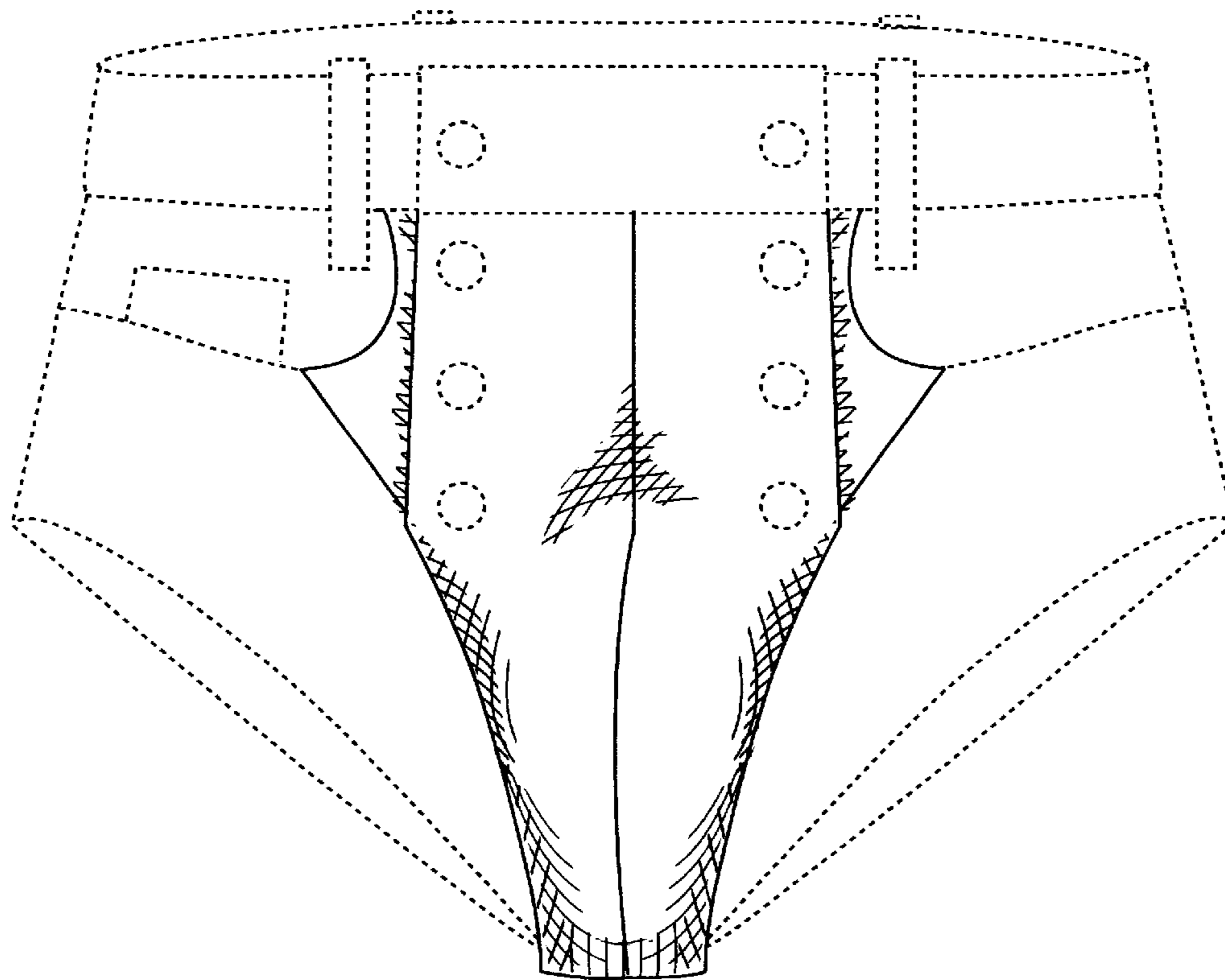

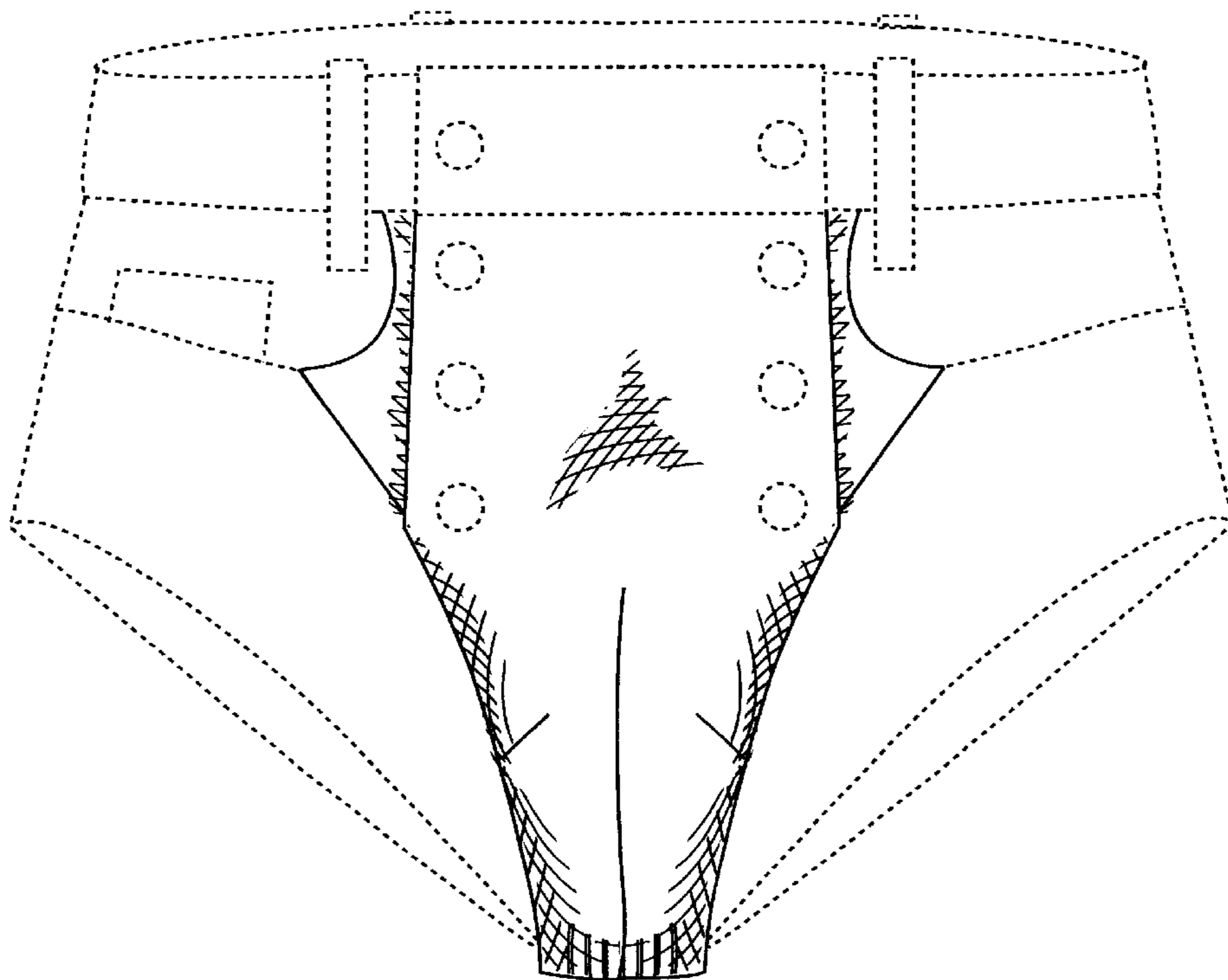

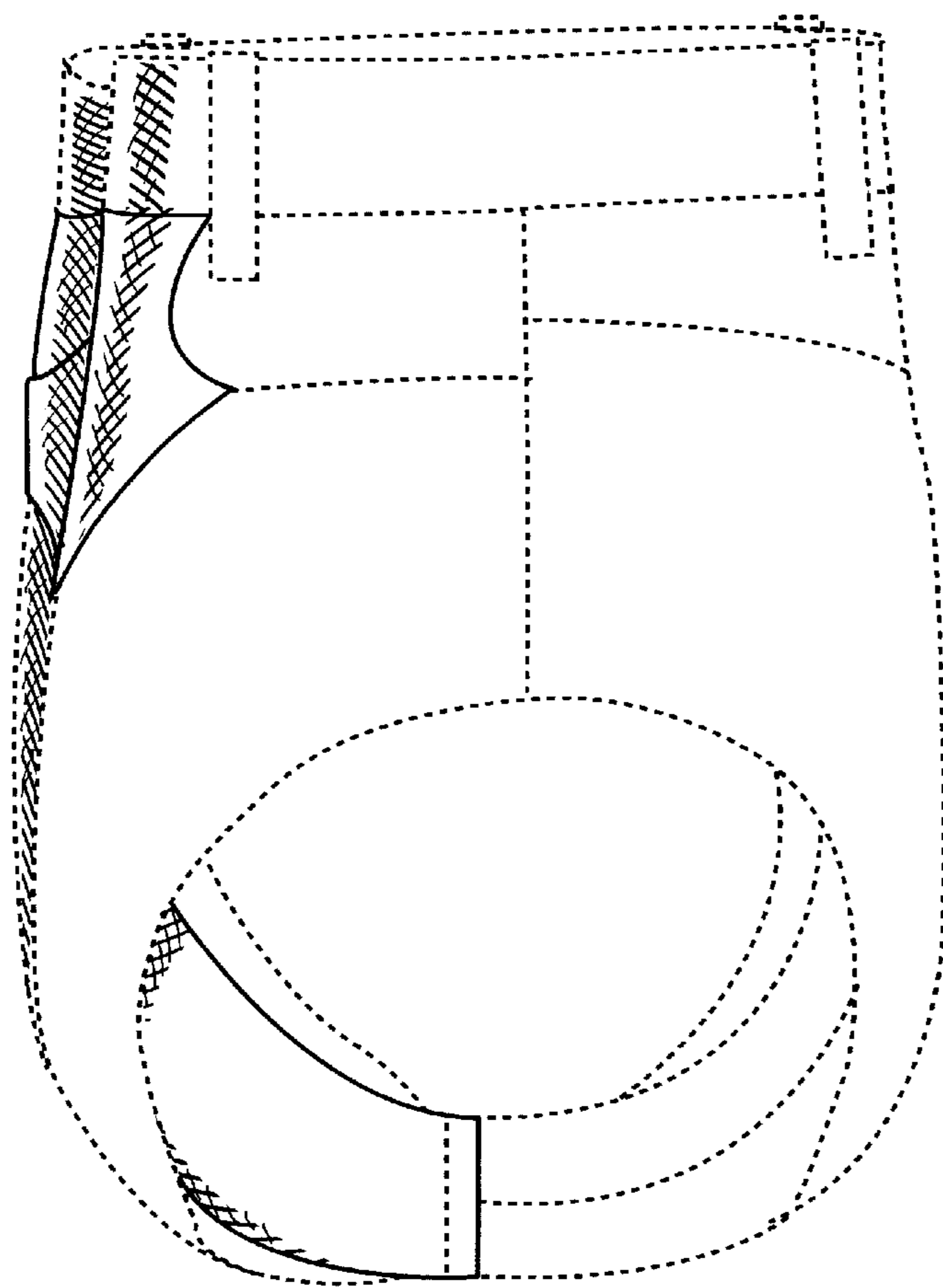

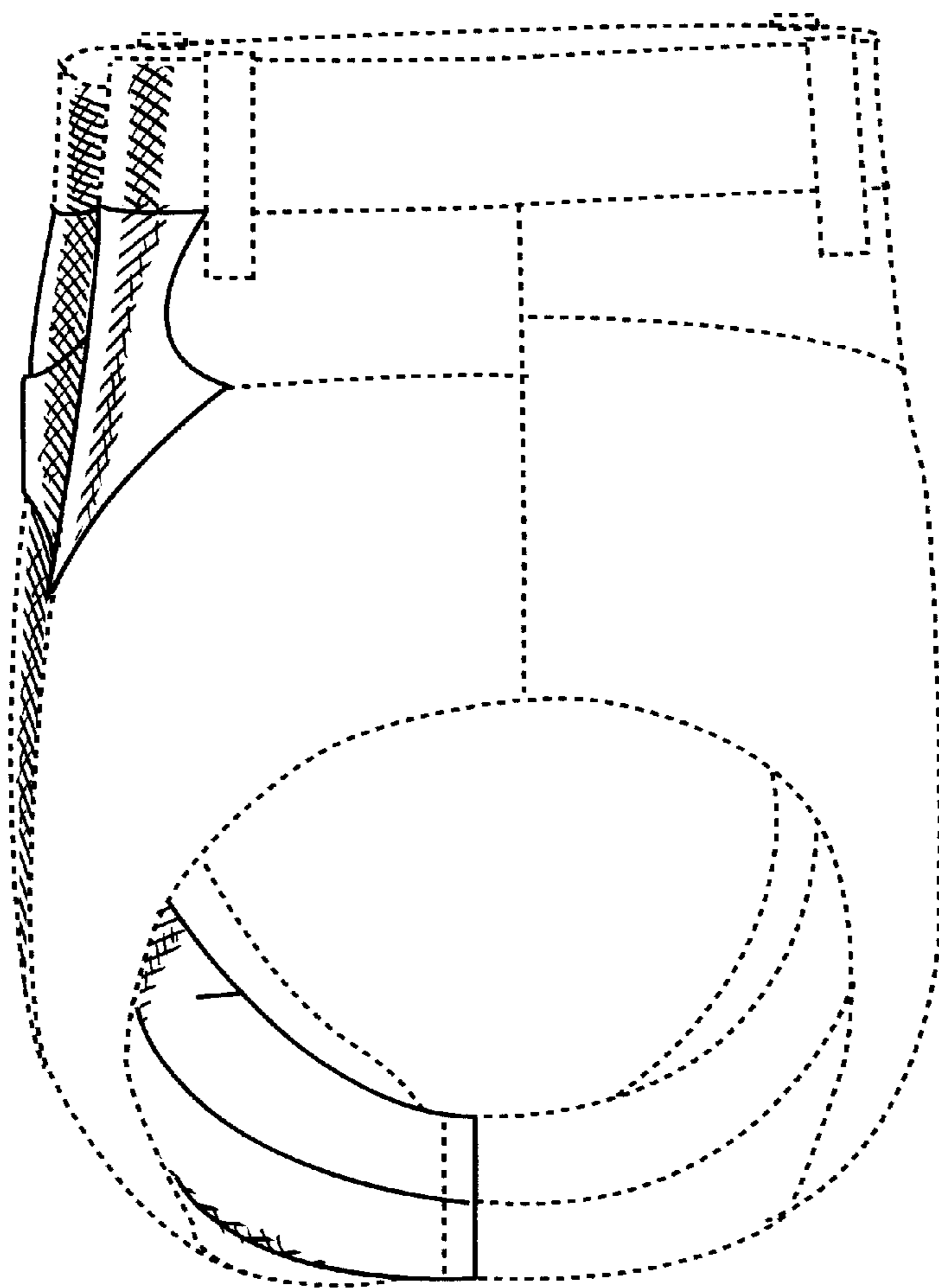
