FIG. 1 is a front perspective view of a boot showing my new design;

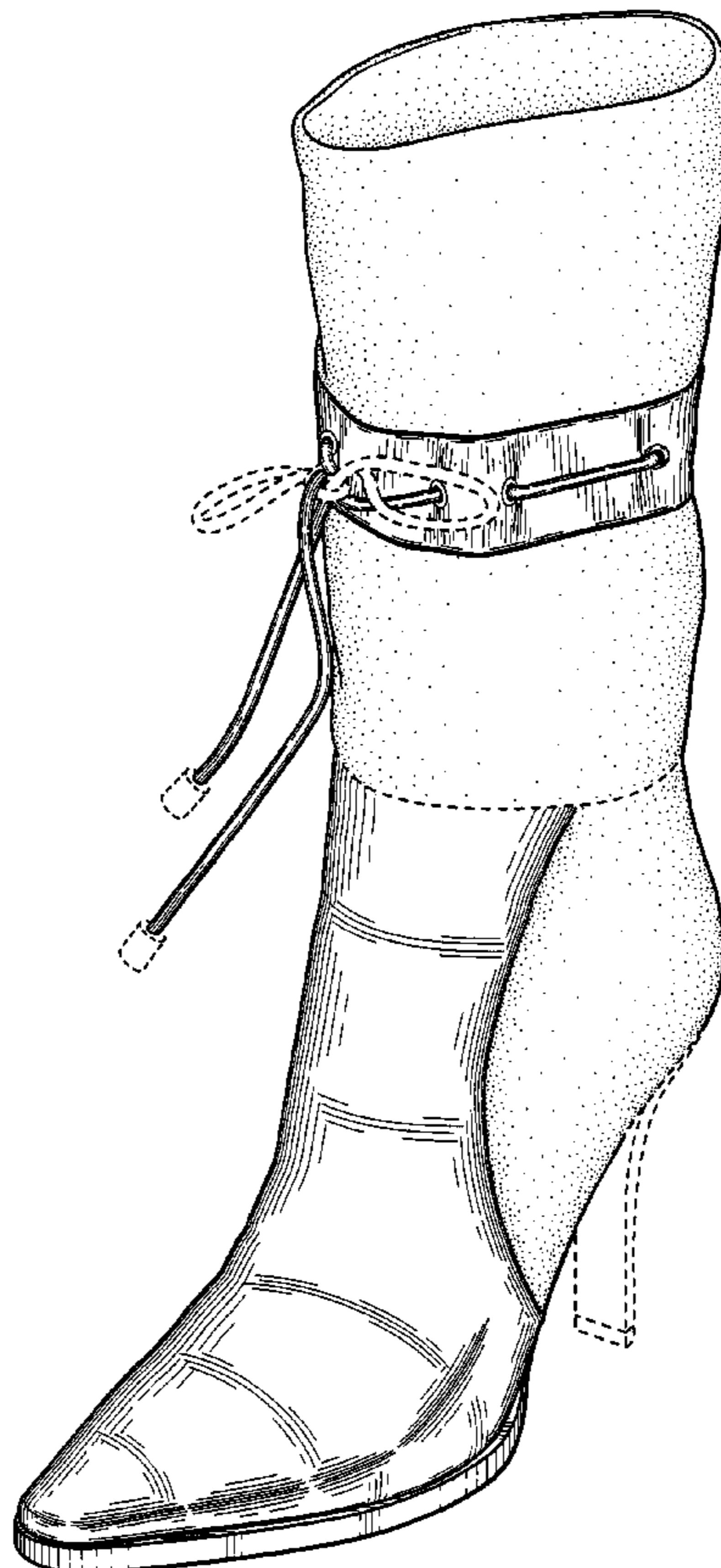
FIG. 2 is a right side view thereof;

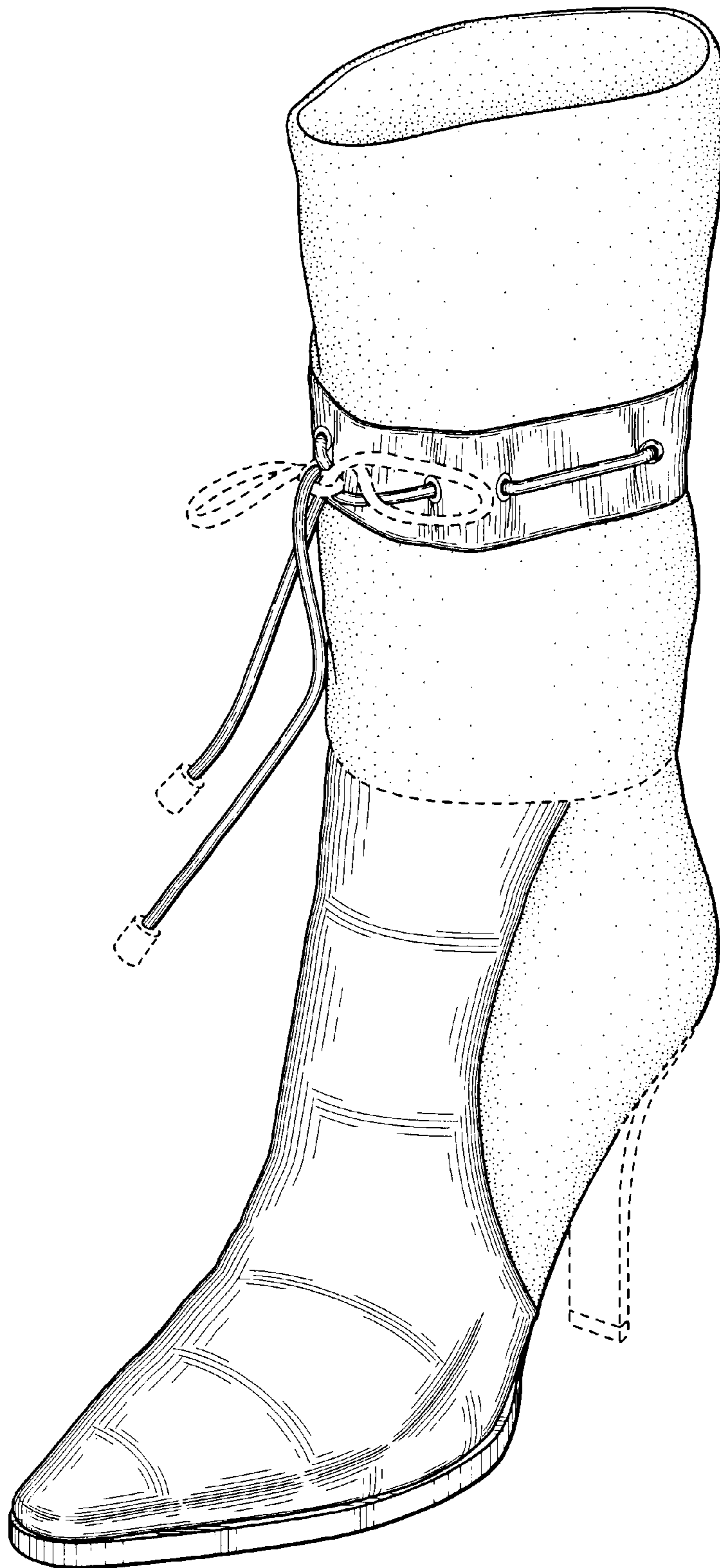

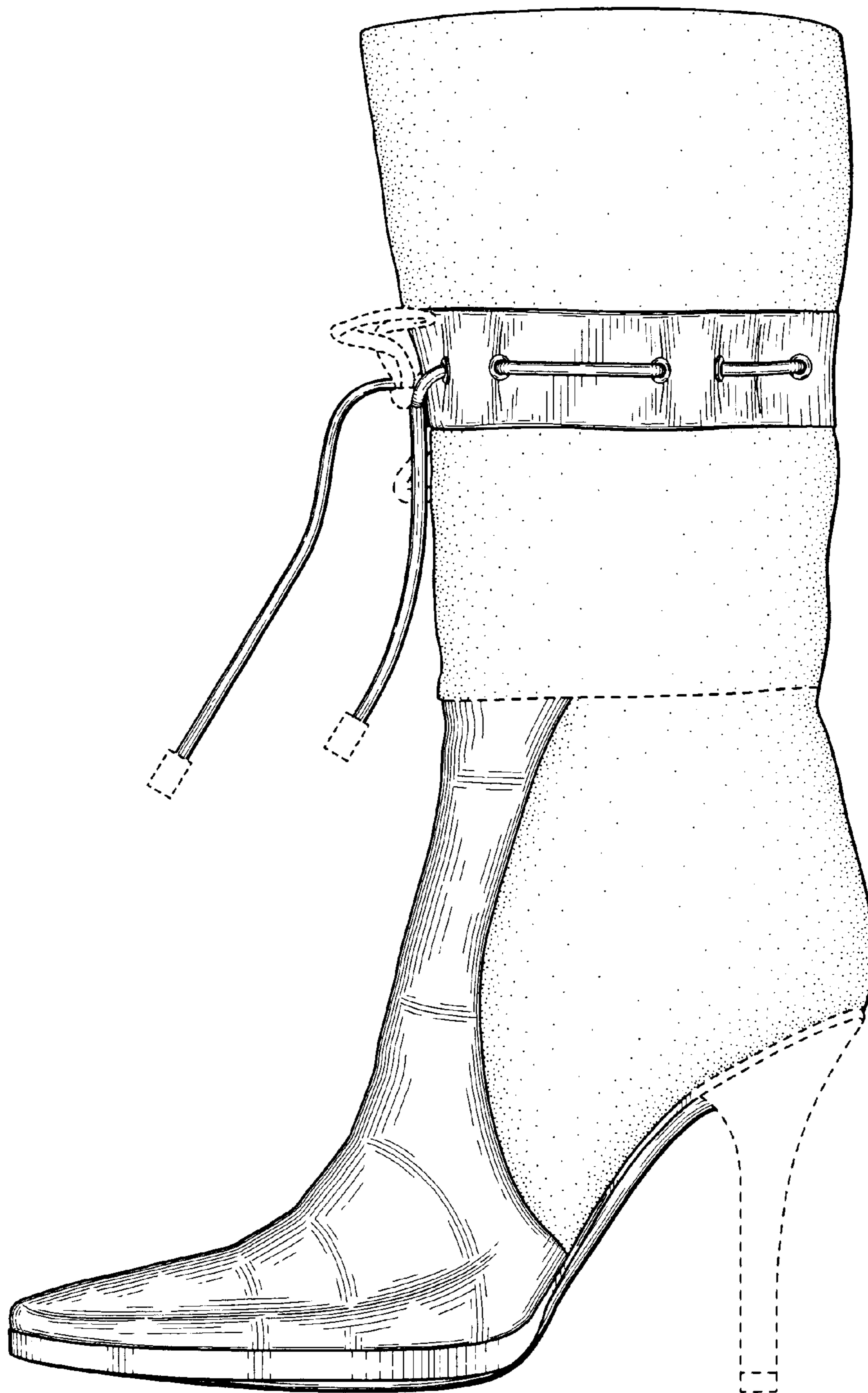

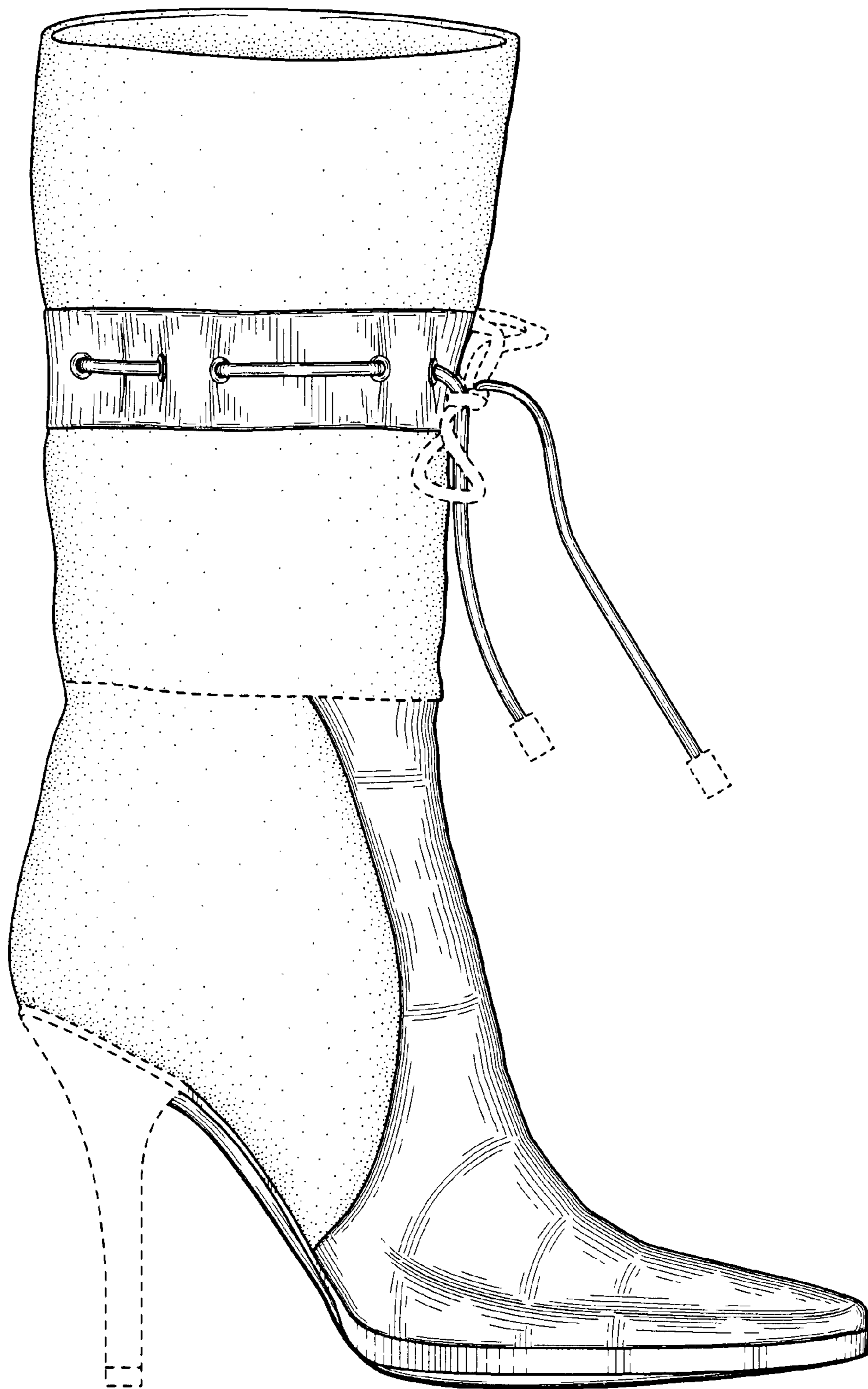

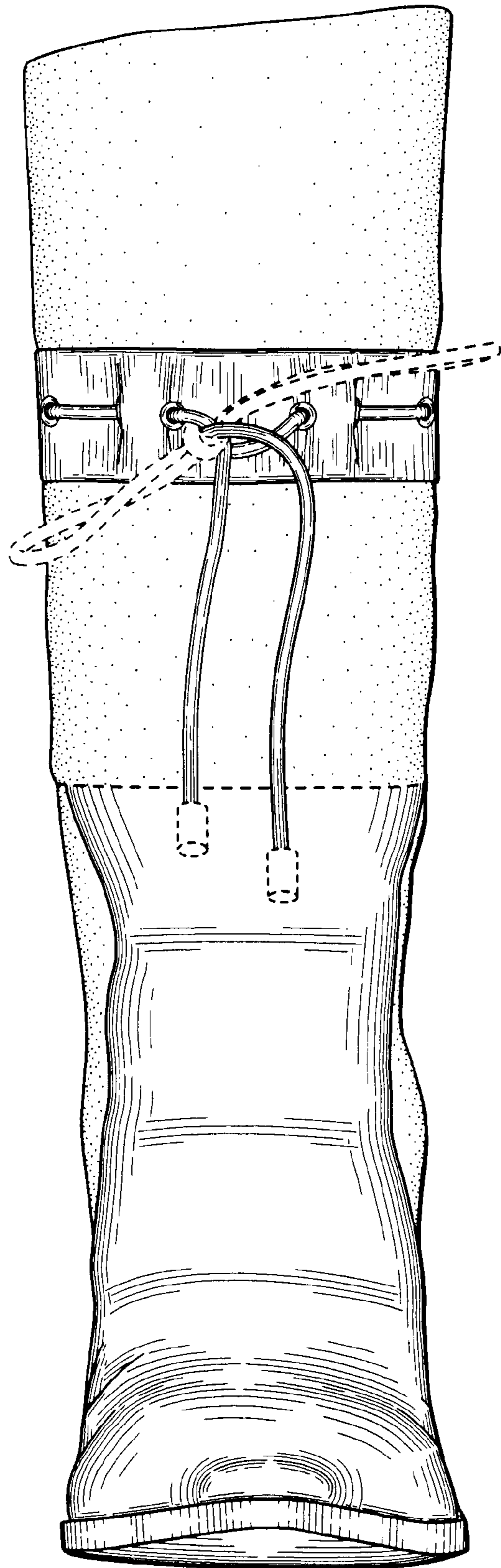
