**DESCRIPTION**

FIG. 1 is a front, top, left-side perspective view of a case showing my new design;

FIG. 2 is a top, front, left-side perspective view thereof with the cover open;

FIG. 3 is a right-side elevational view thereof;

FIG. 4 is a top view thereof;

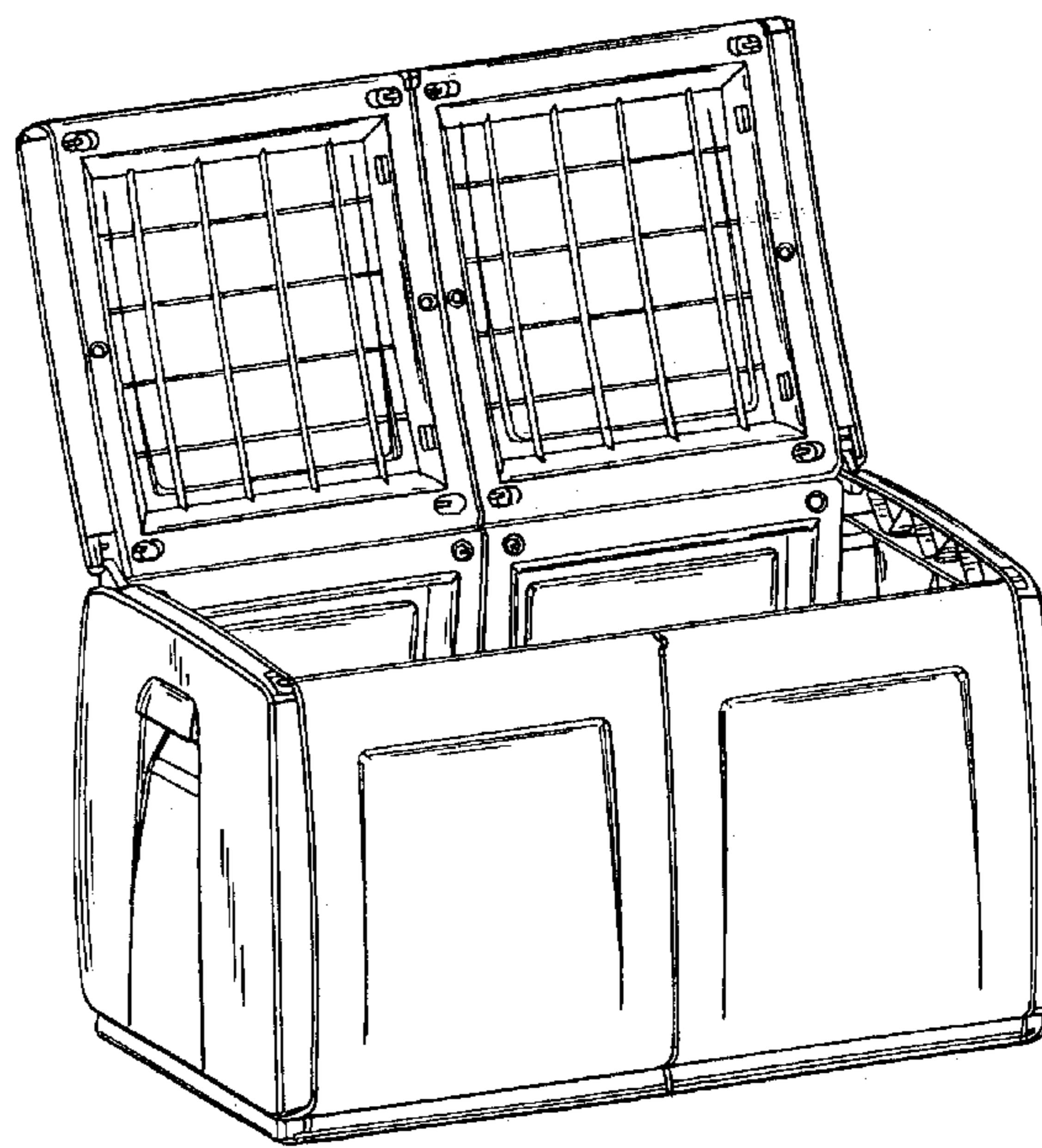
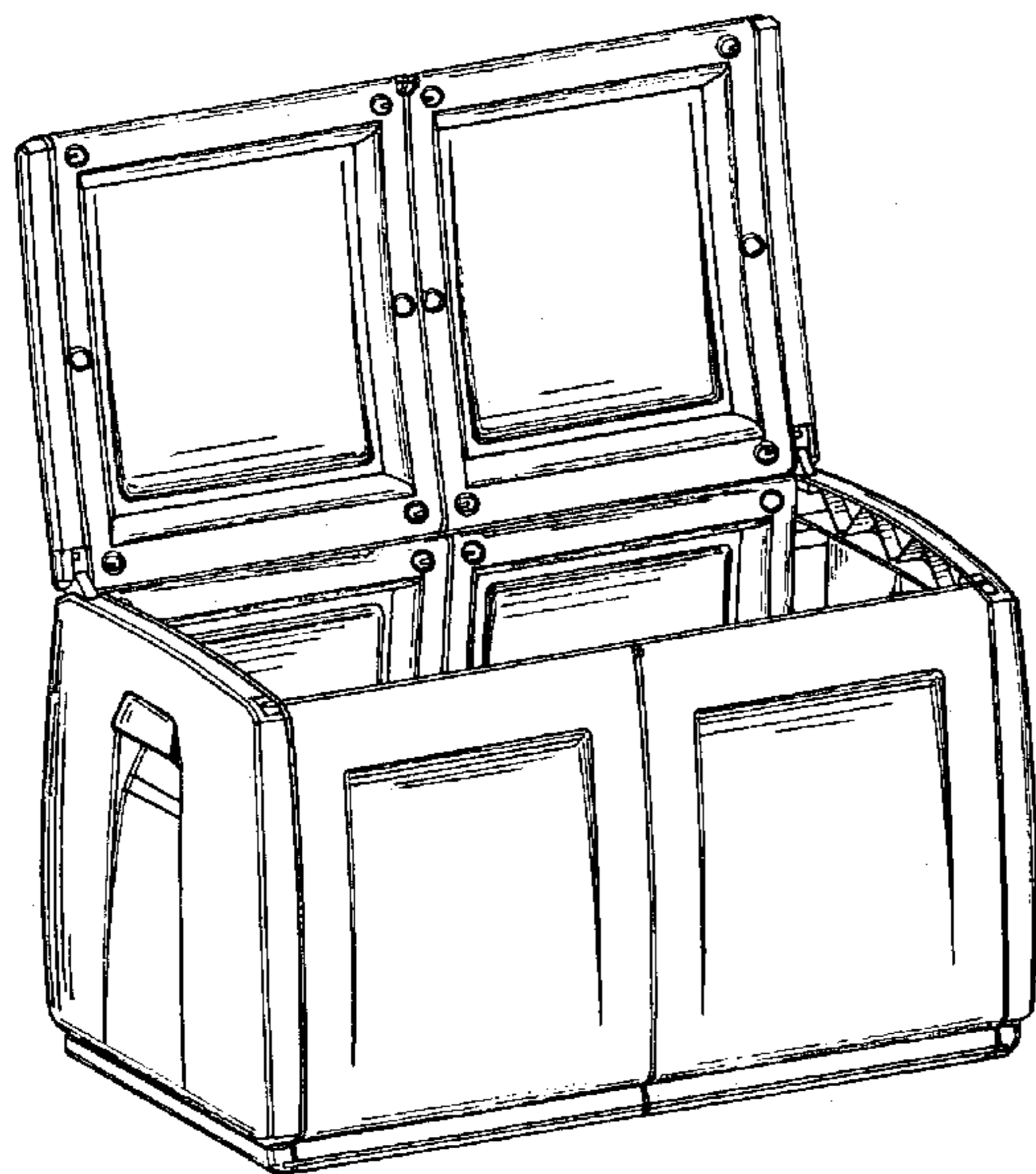
FIG. 5 is a rear view thereof;

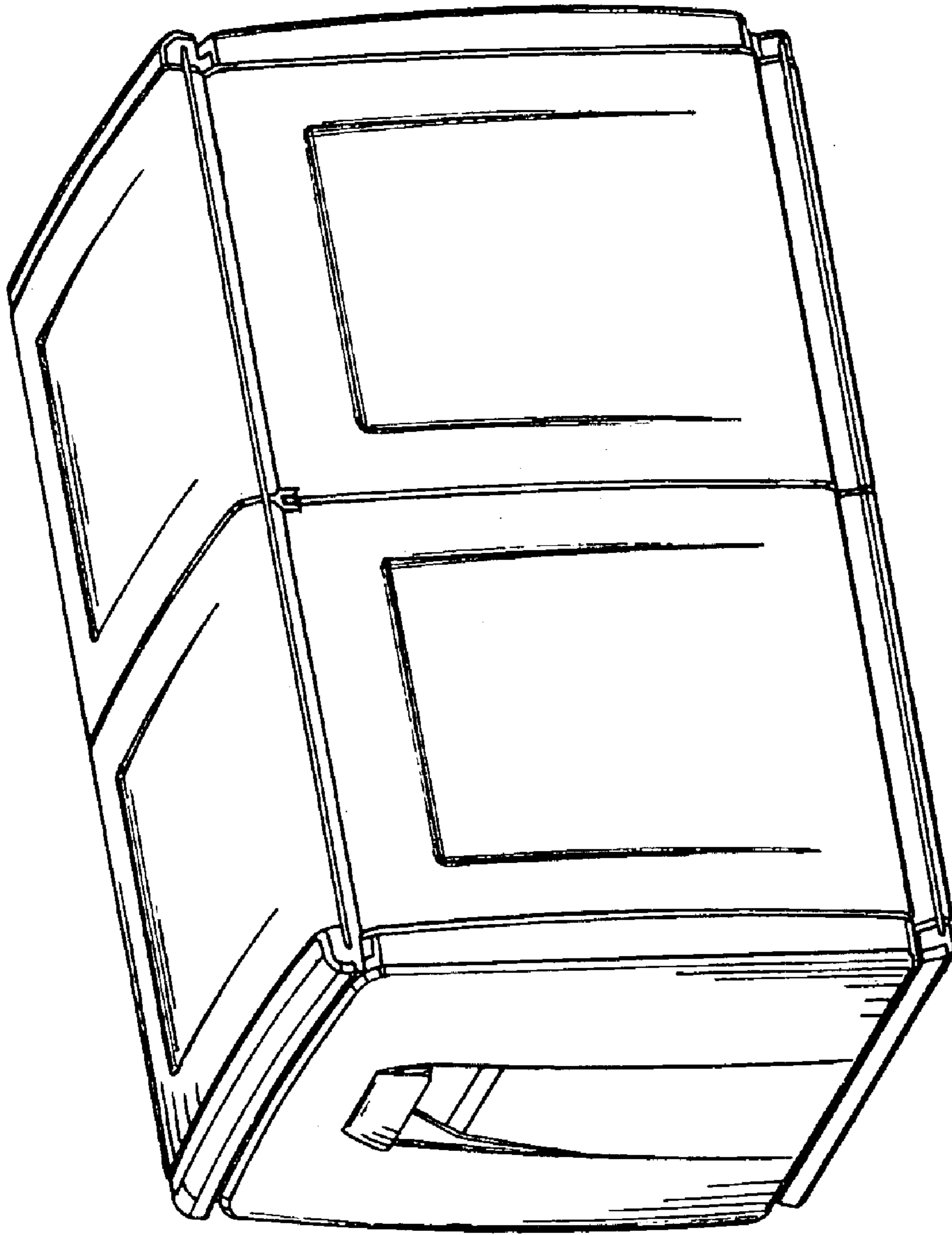

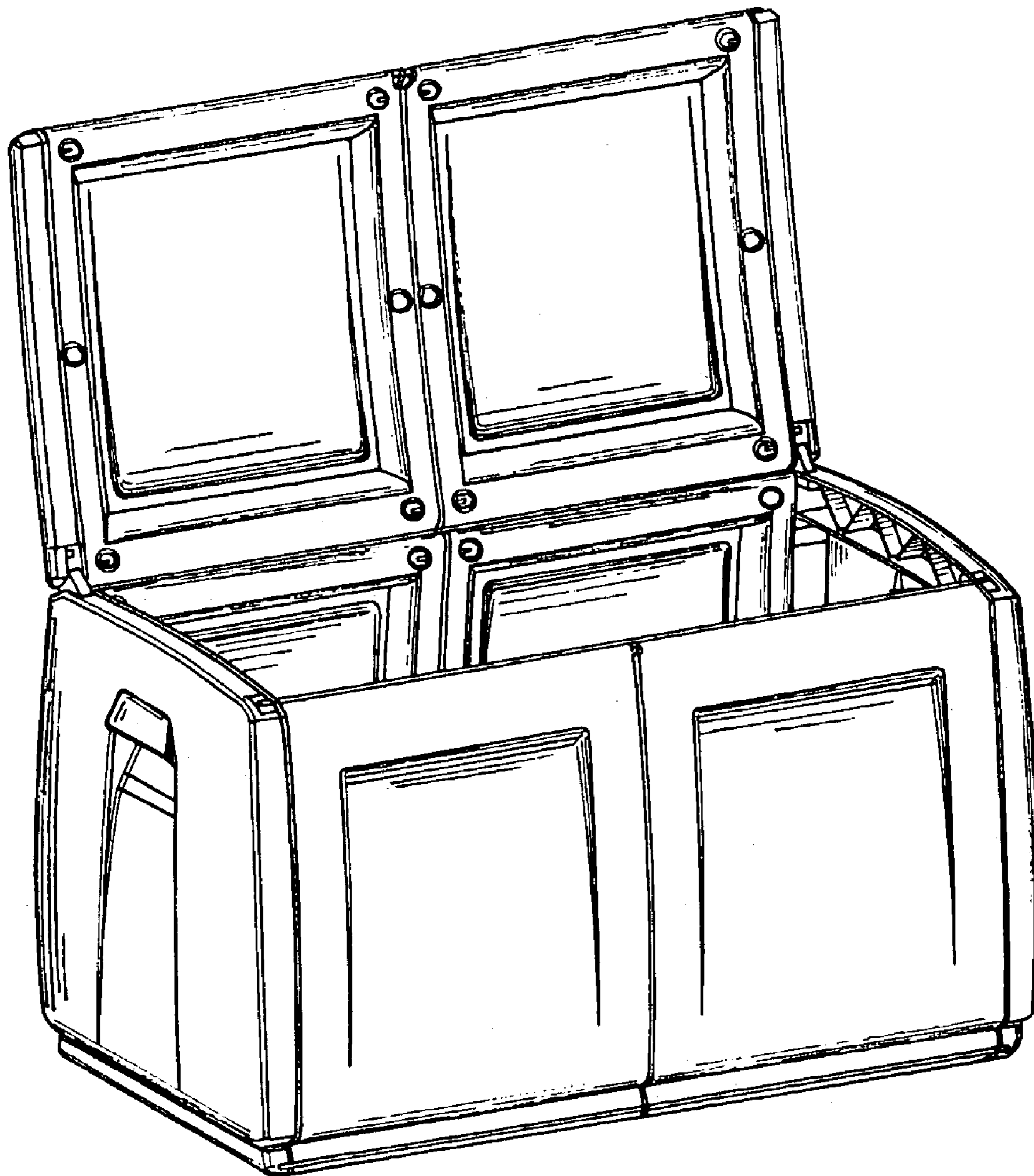

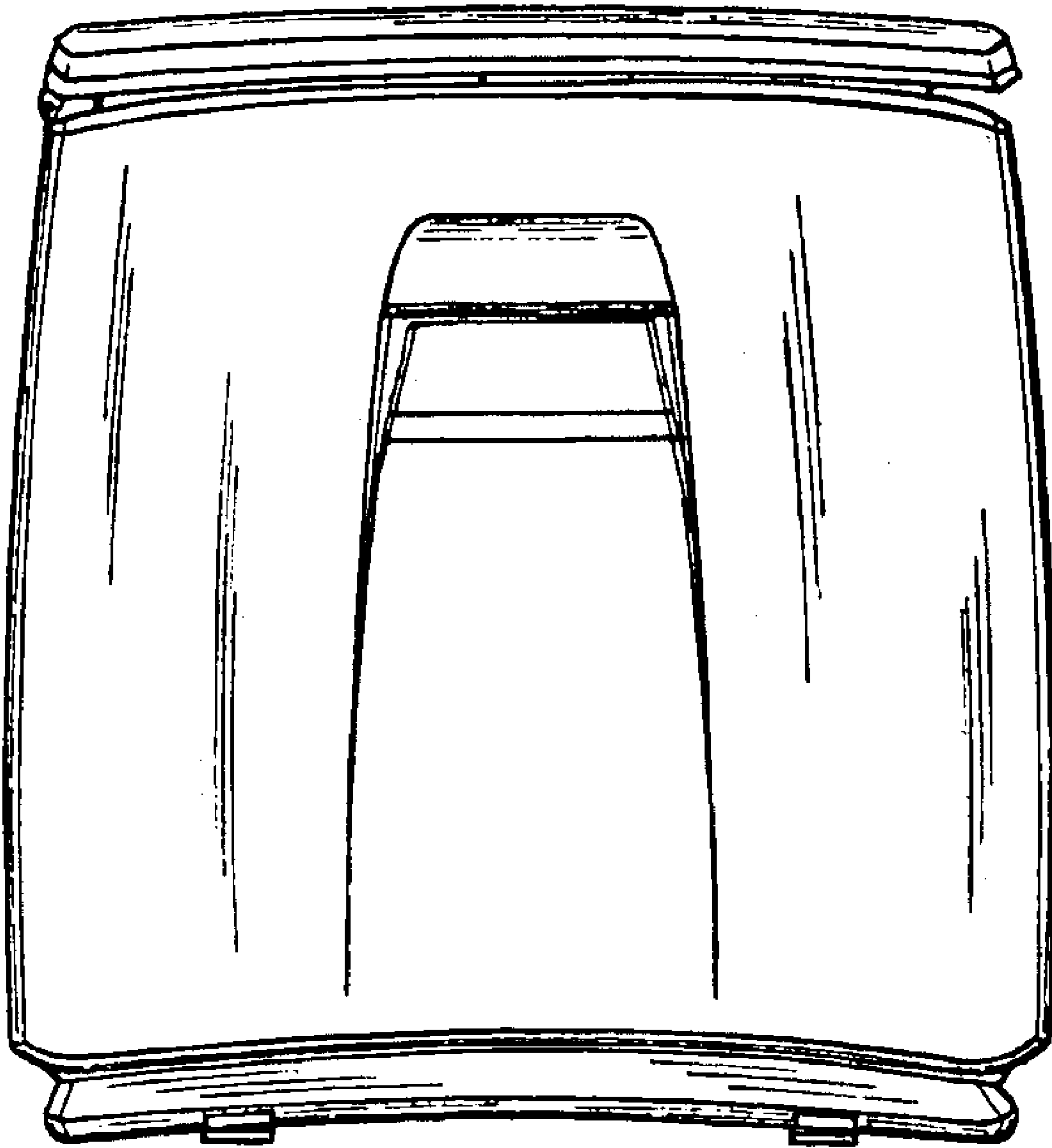

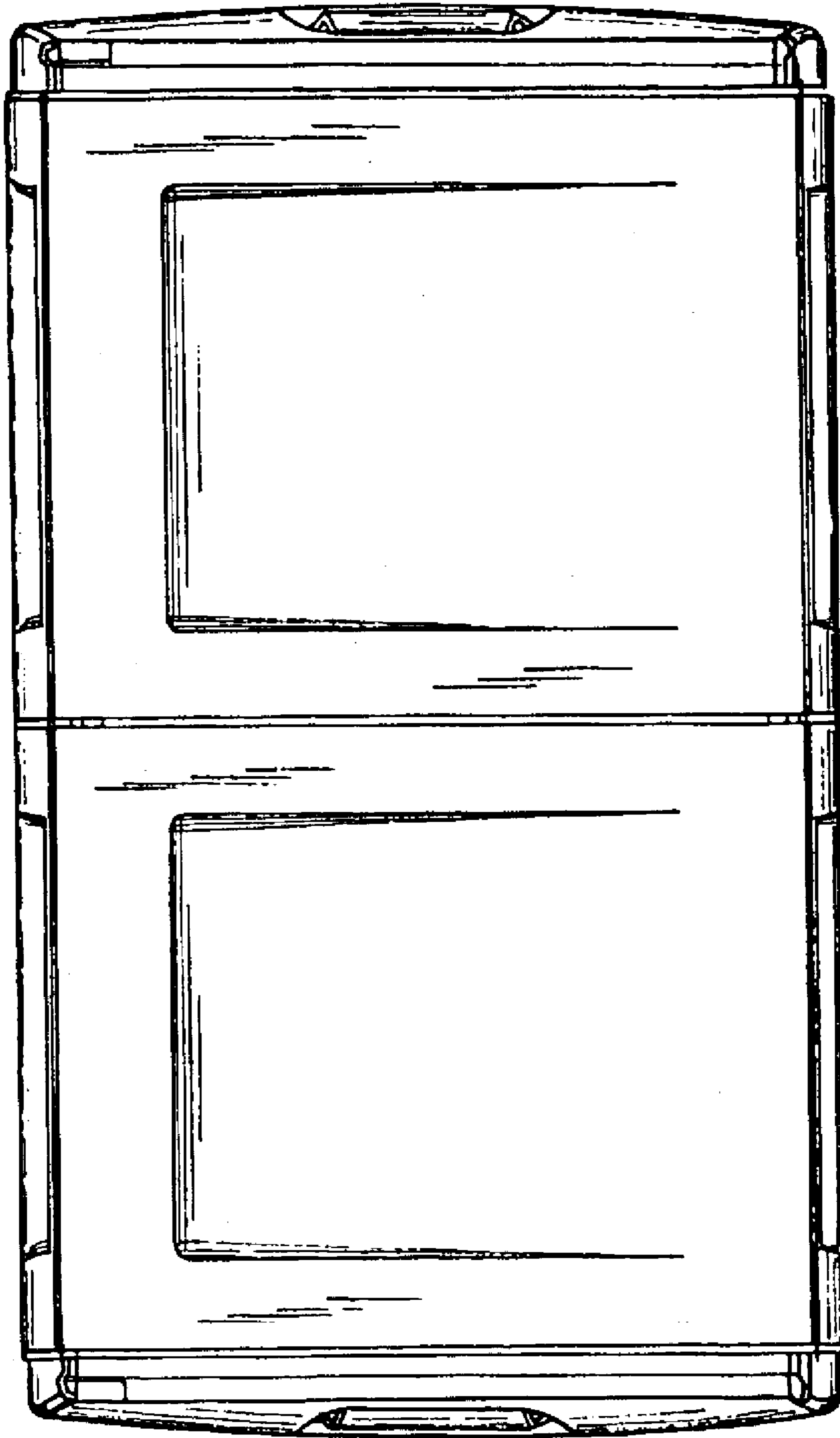

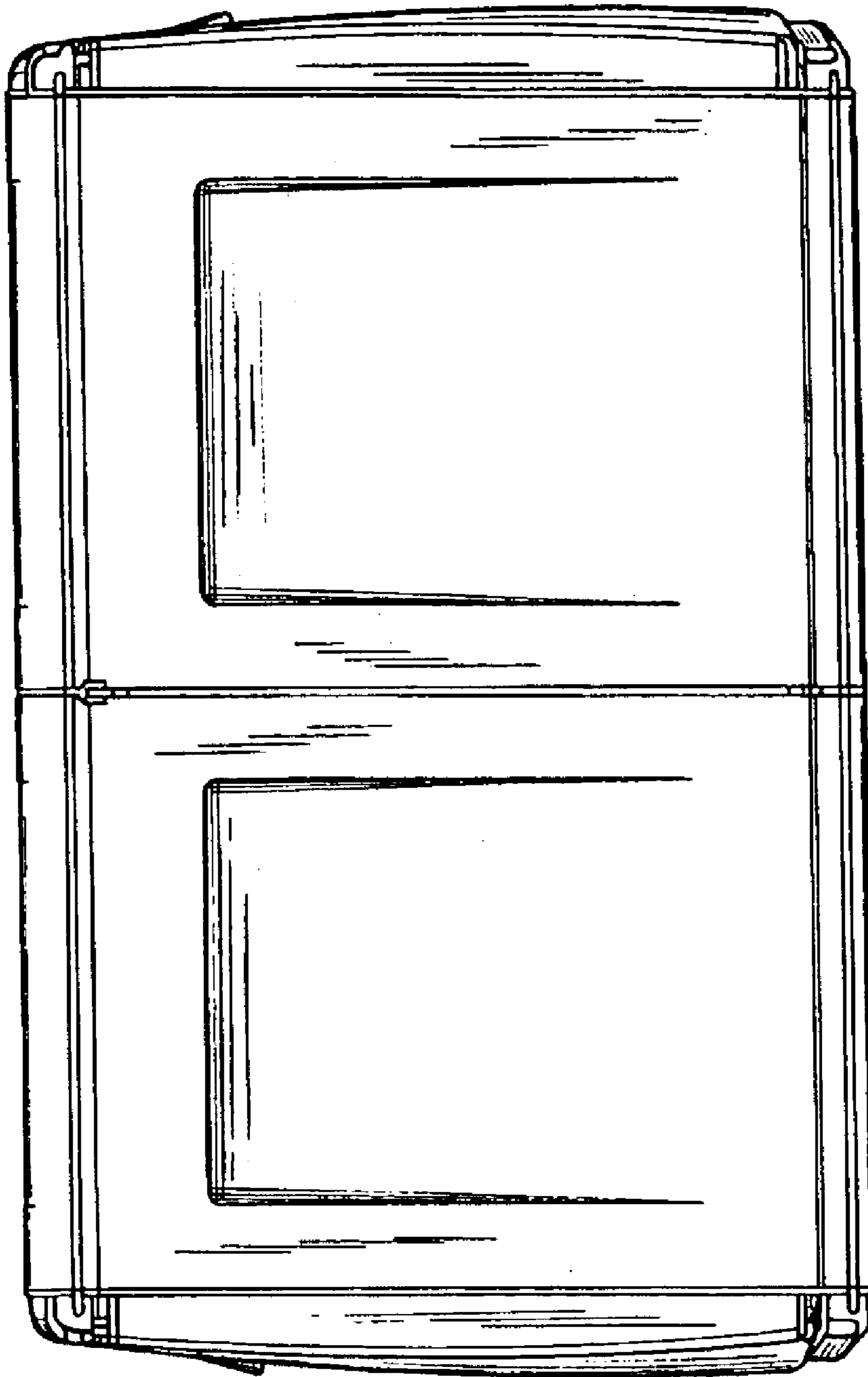

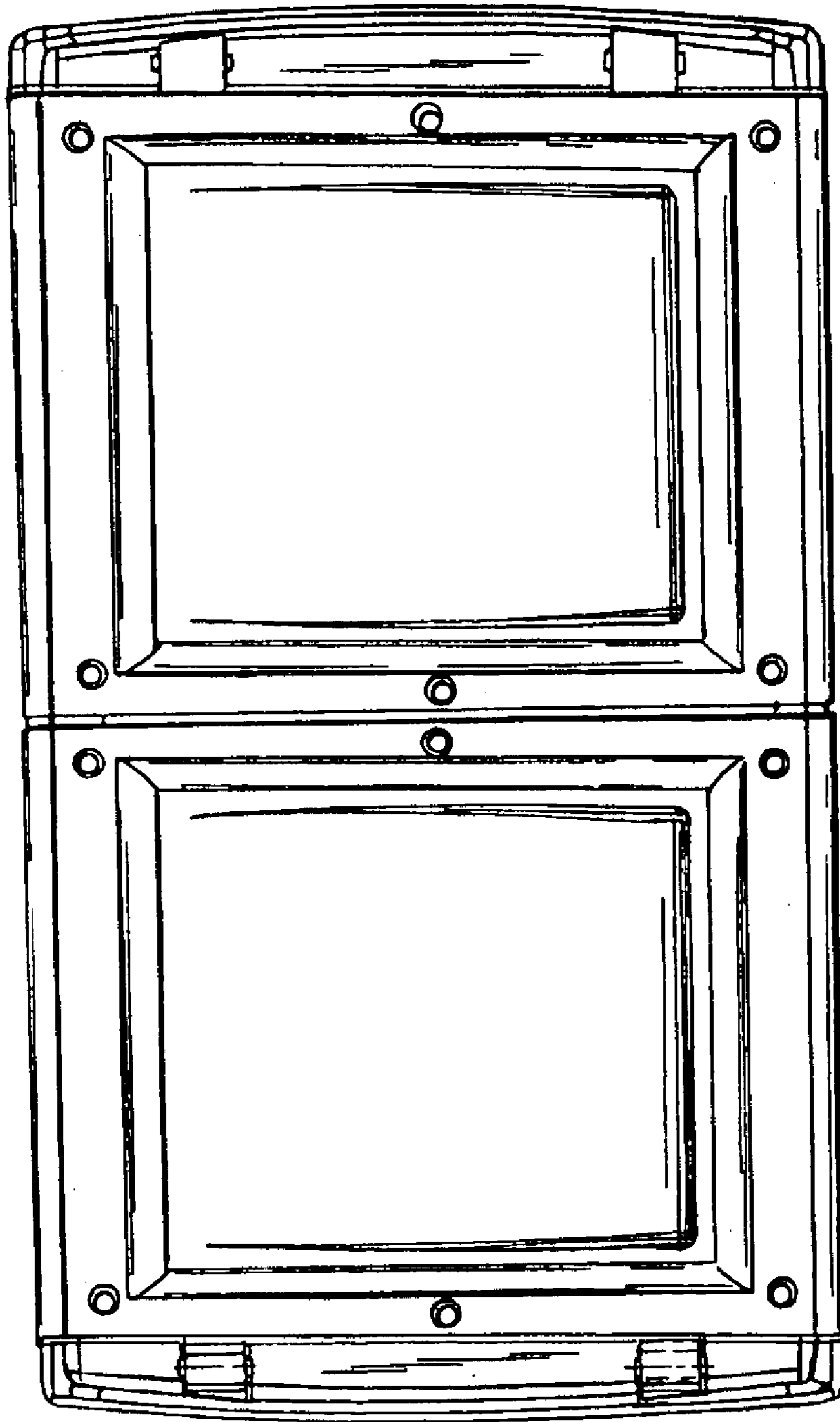

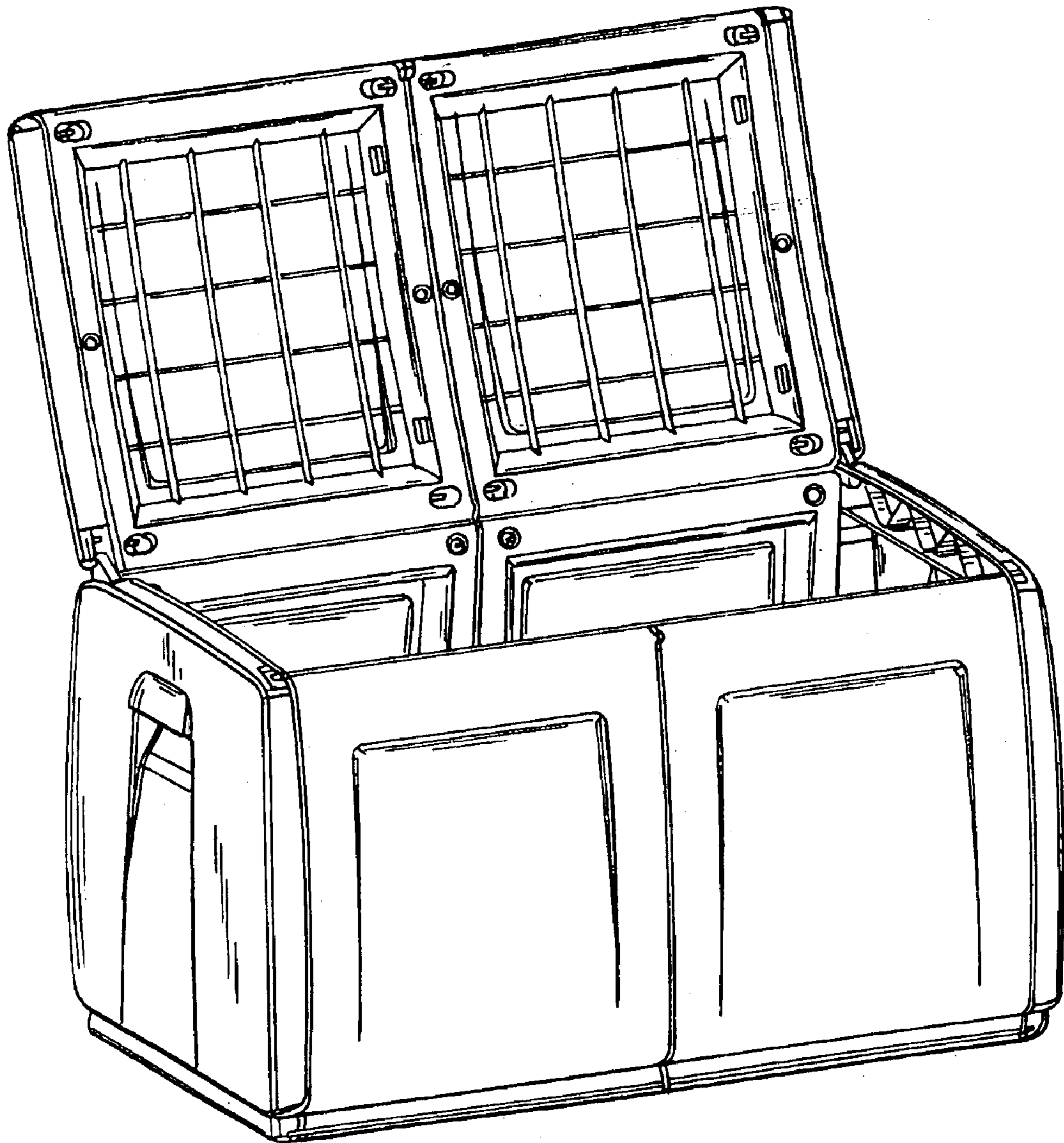

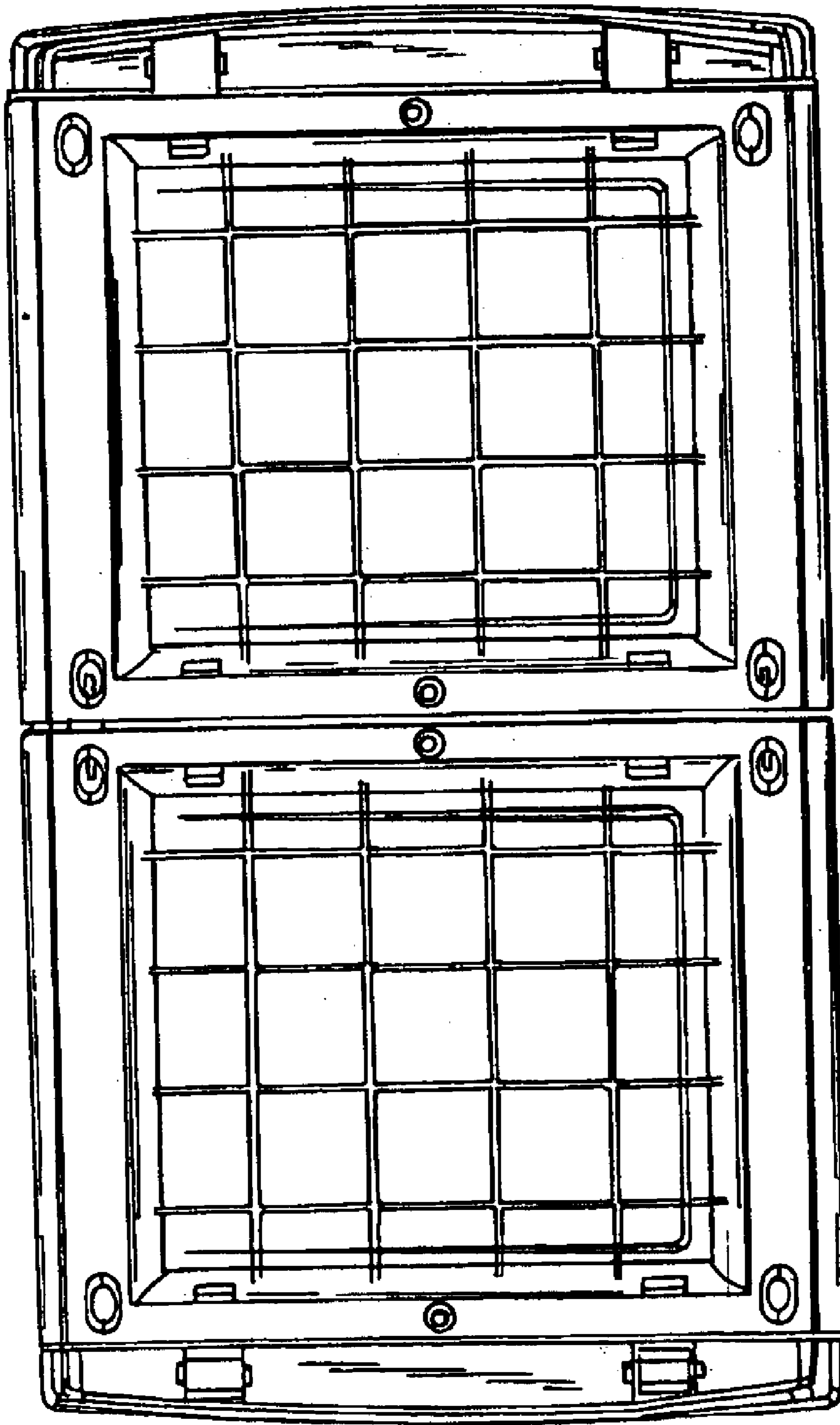
