DESCRIPTION

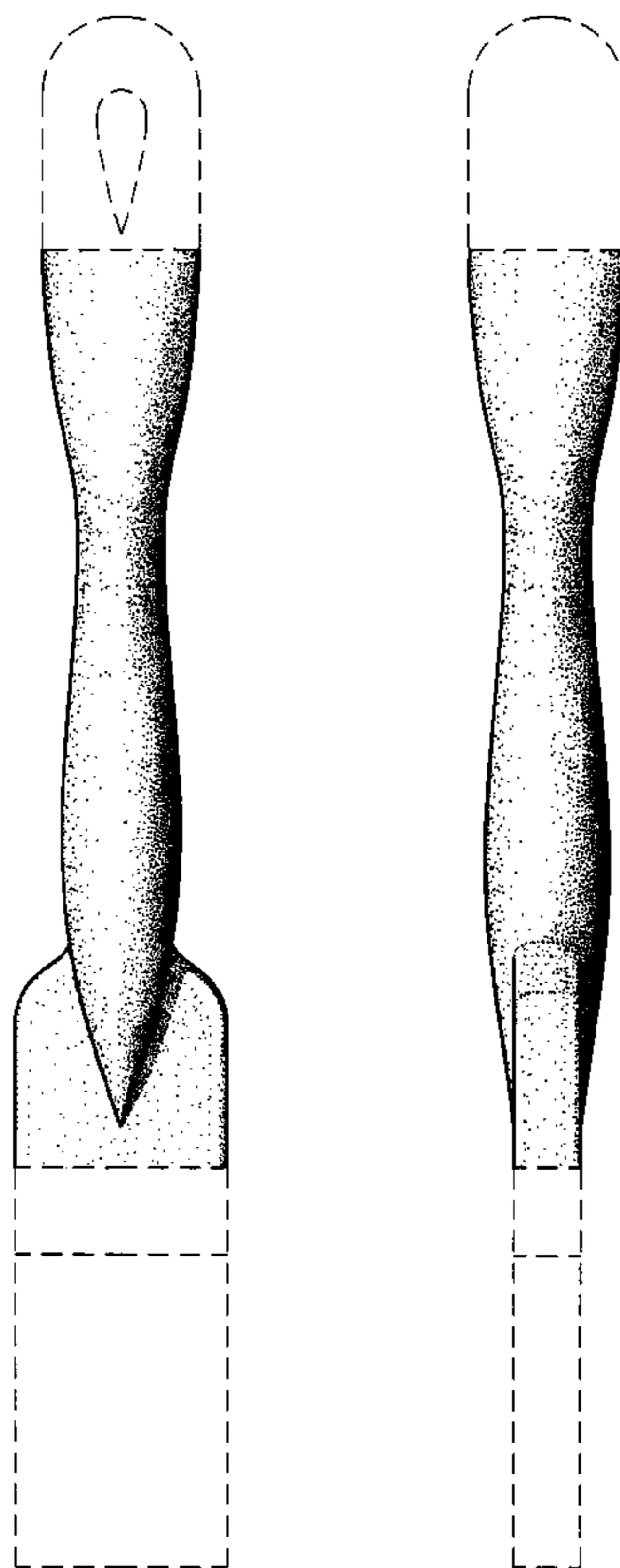
FIG. 1 is a perspective view of a paint brush, showing our new design;

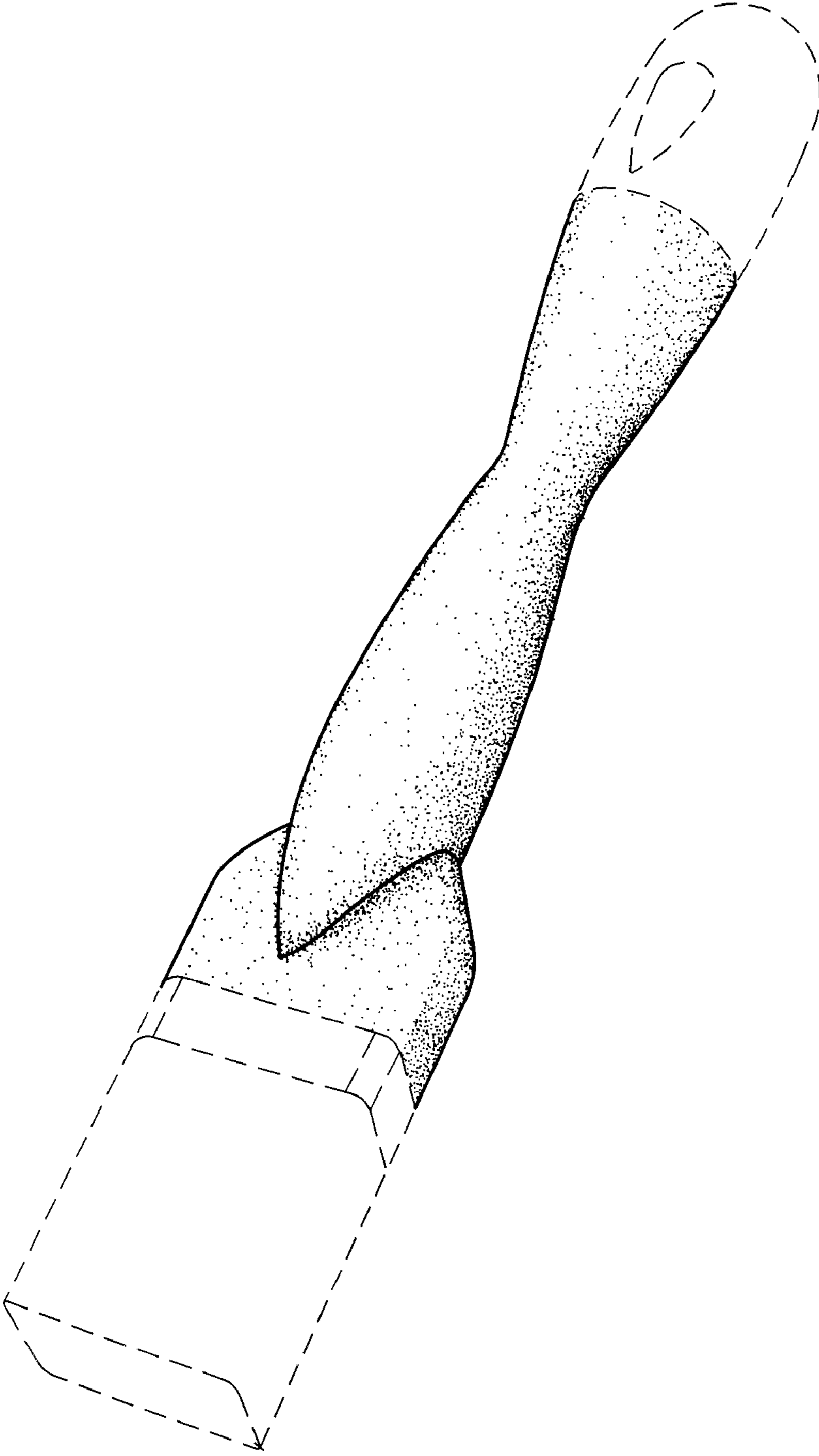

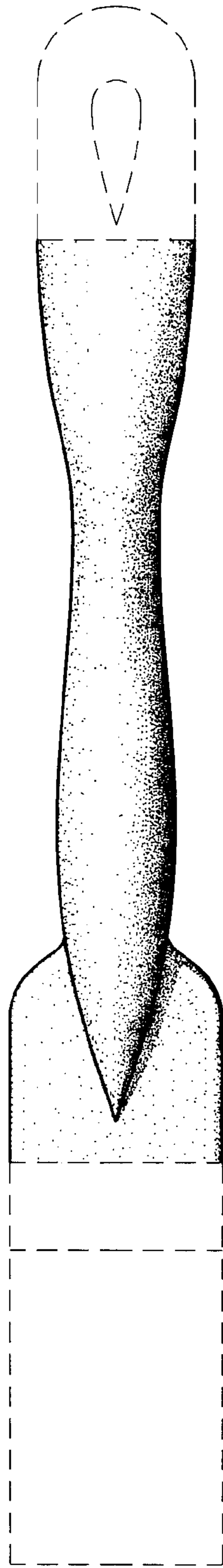

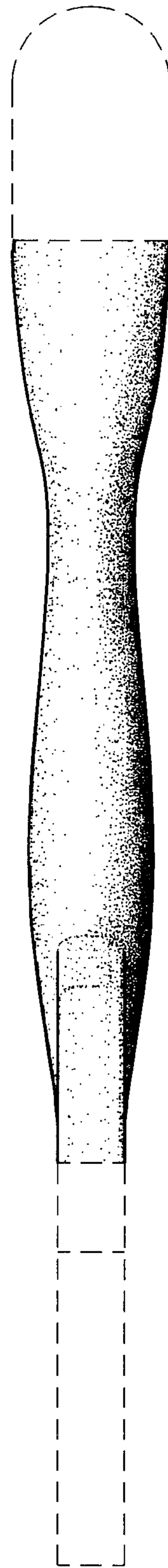
