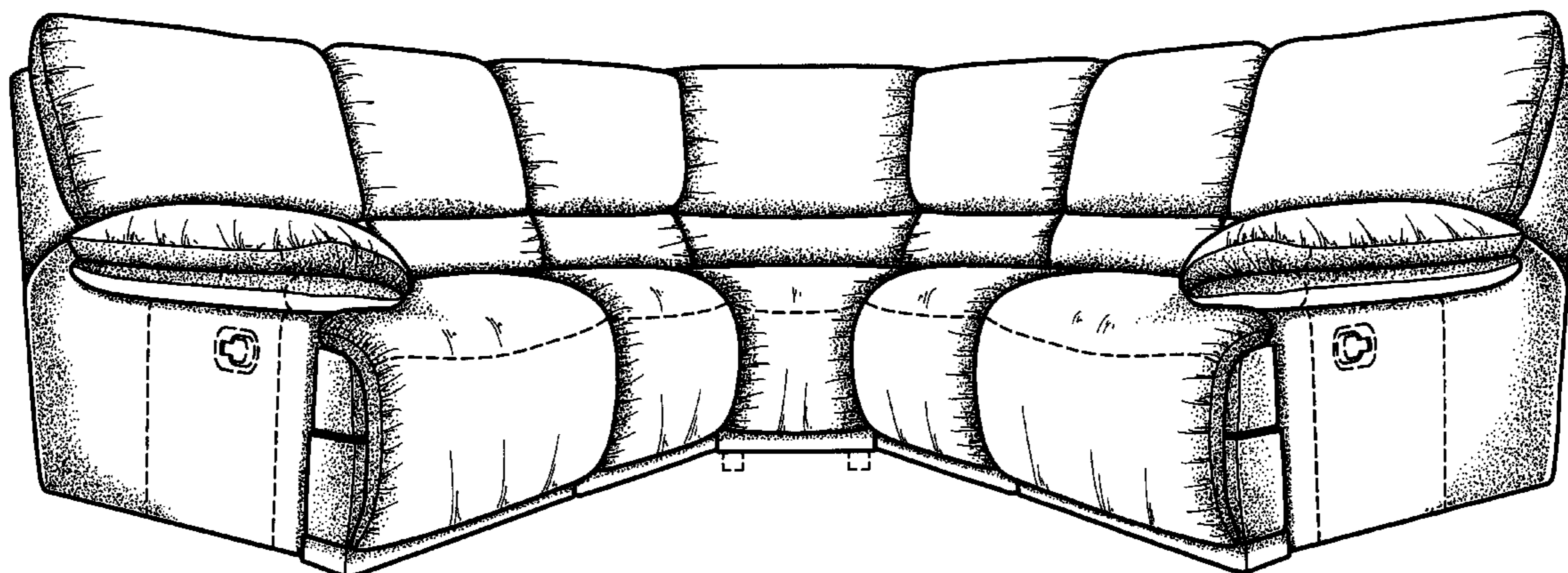
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front perspective view of an embodiment of my new sectional sofa design;
 FIG. 2 is a left, side elevation view thereof;
 FIG. 3 is a right, side elevation view thereof;
 FIG. 4 is a right, rear elevation view thereof; and,
 FIG. 5 is a left, rear elevation view thereof.

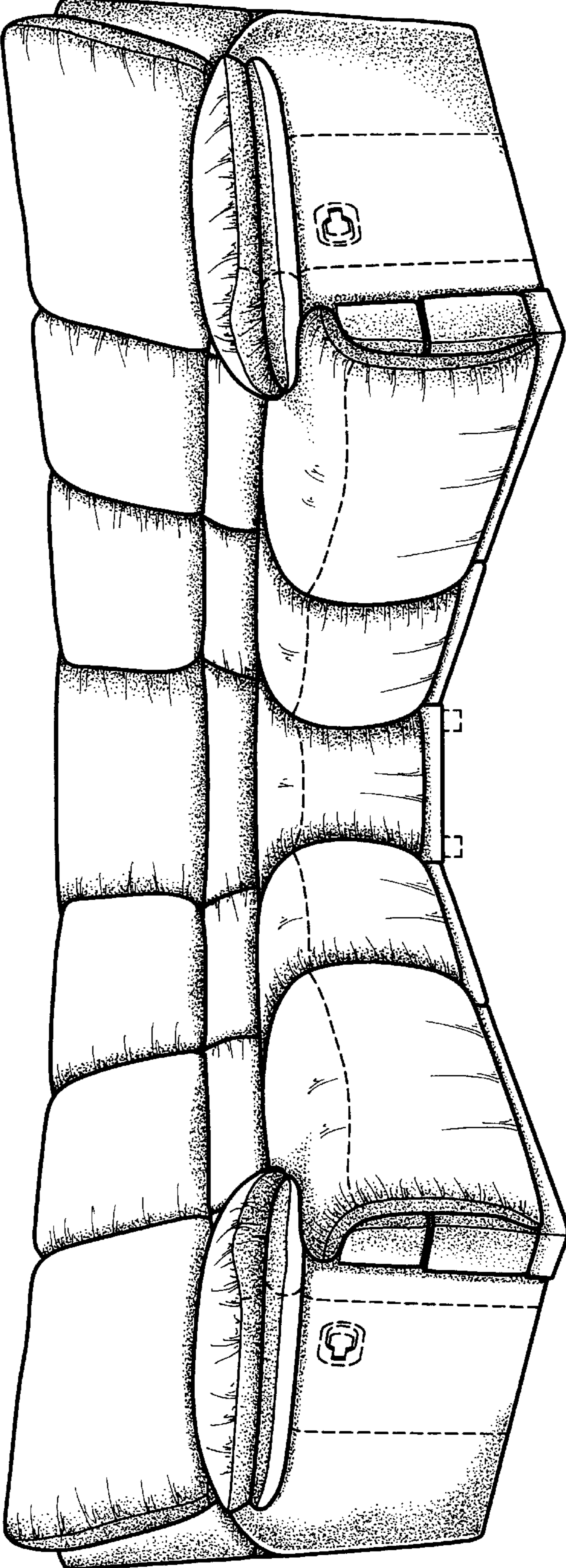

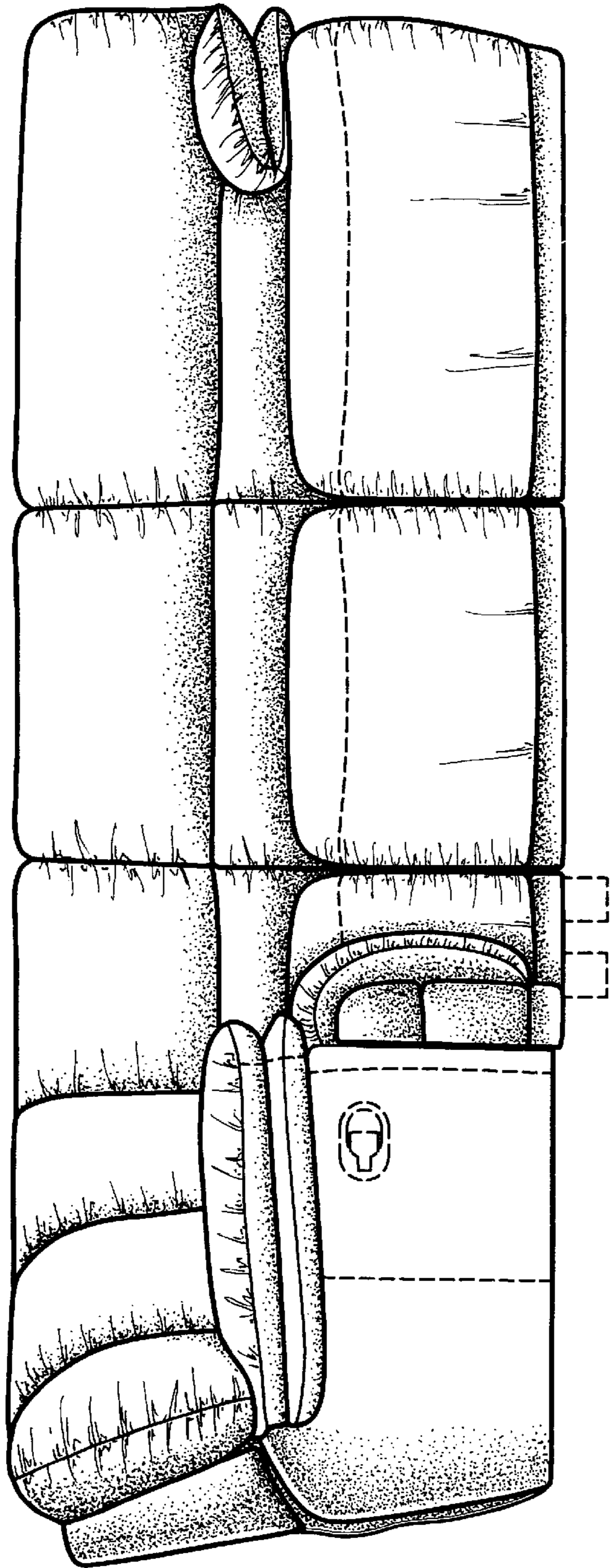

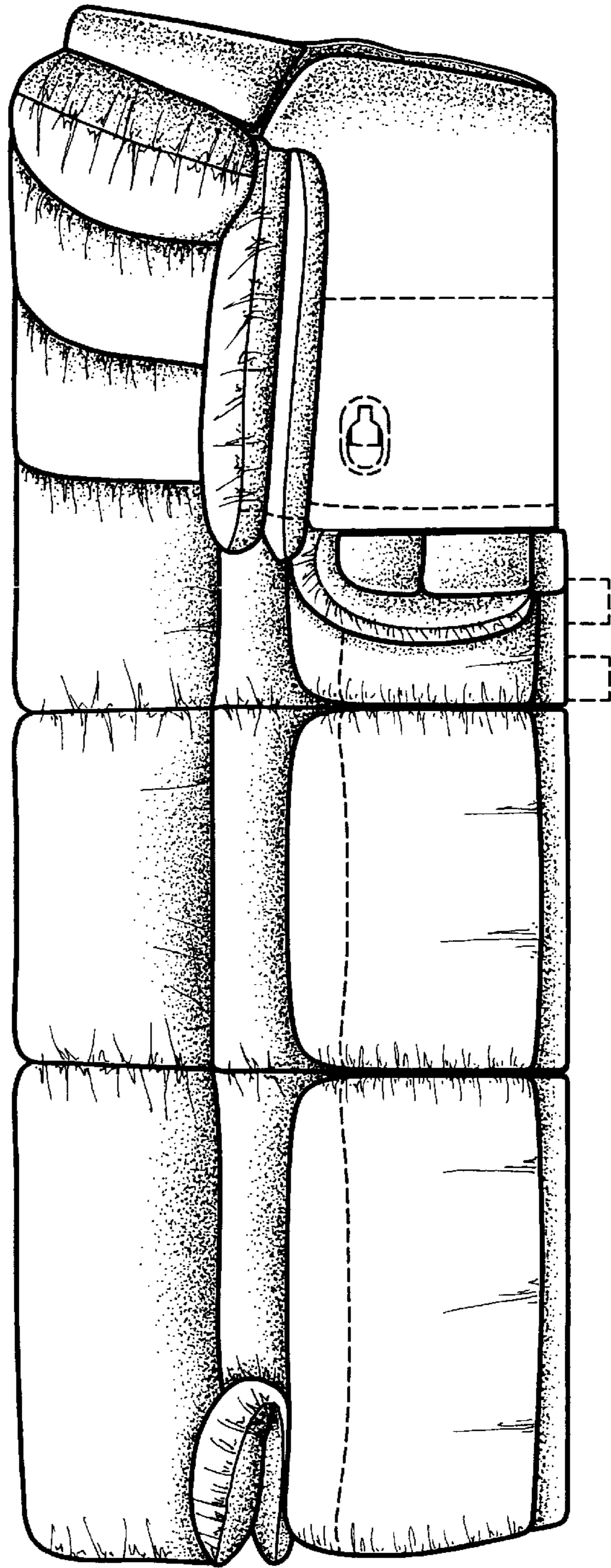

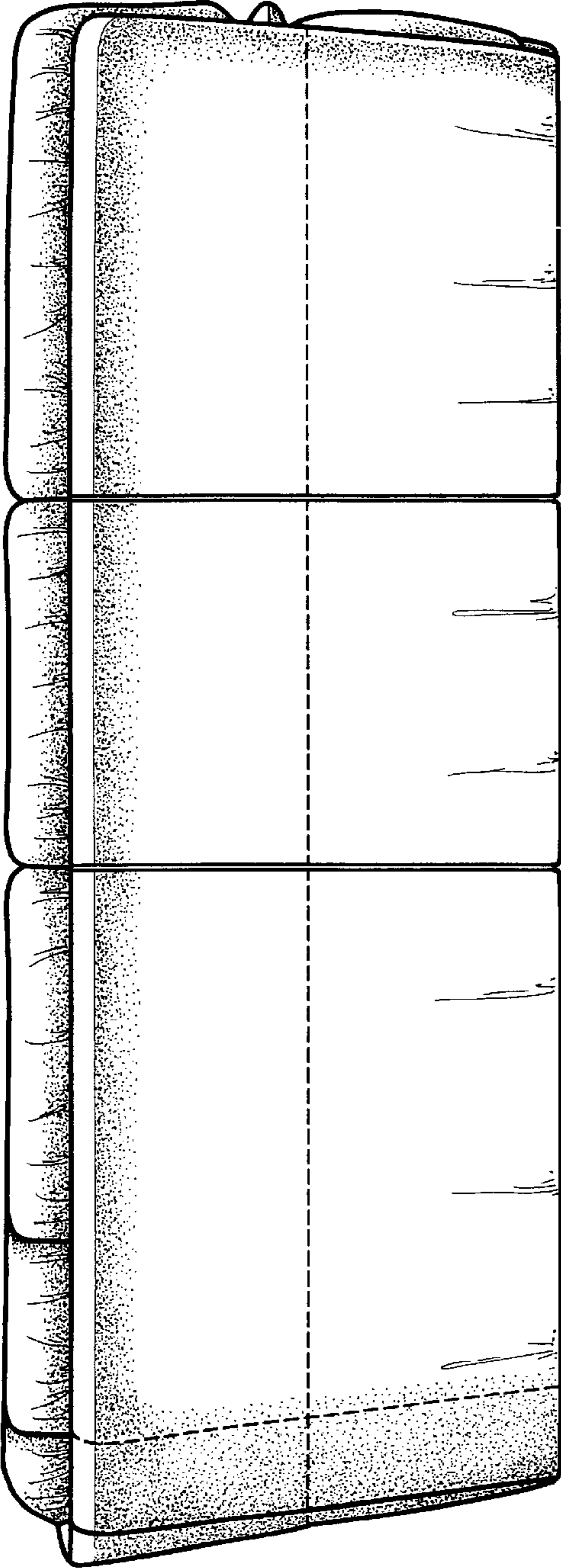

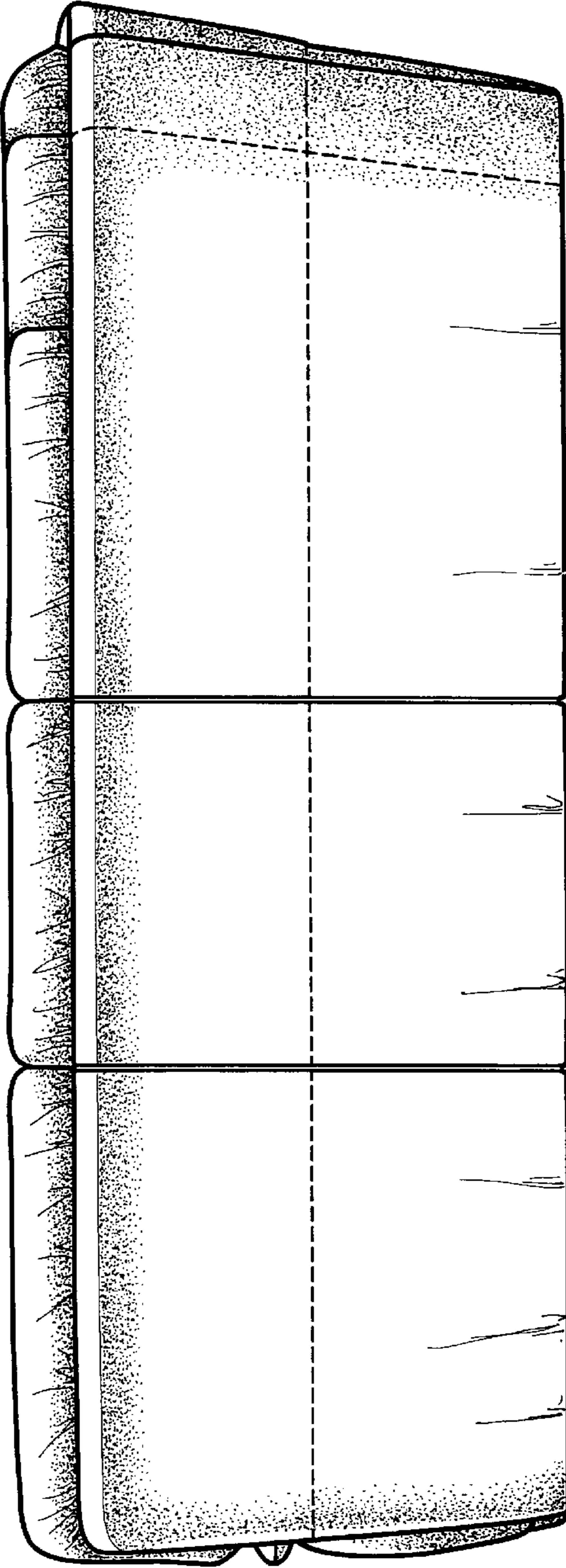
