(57) **CLAIM**

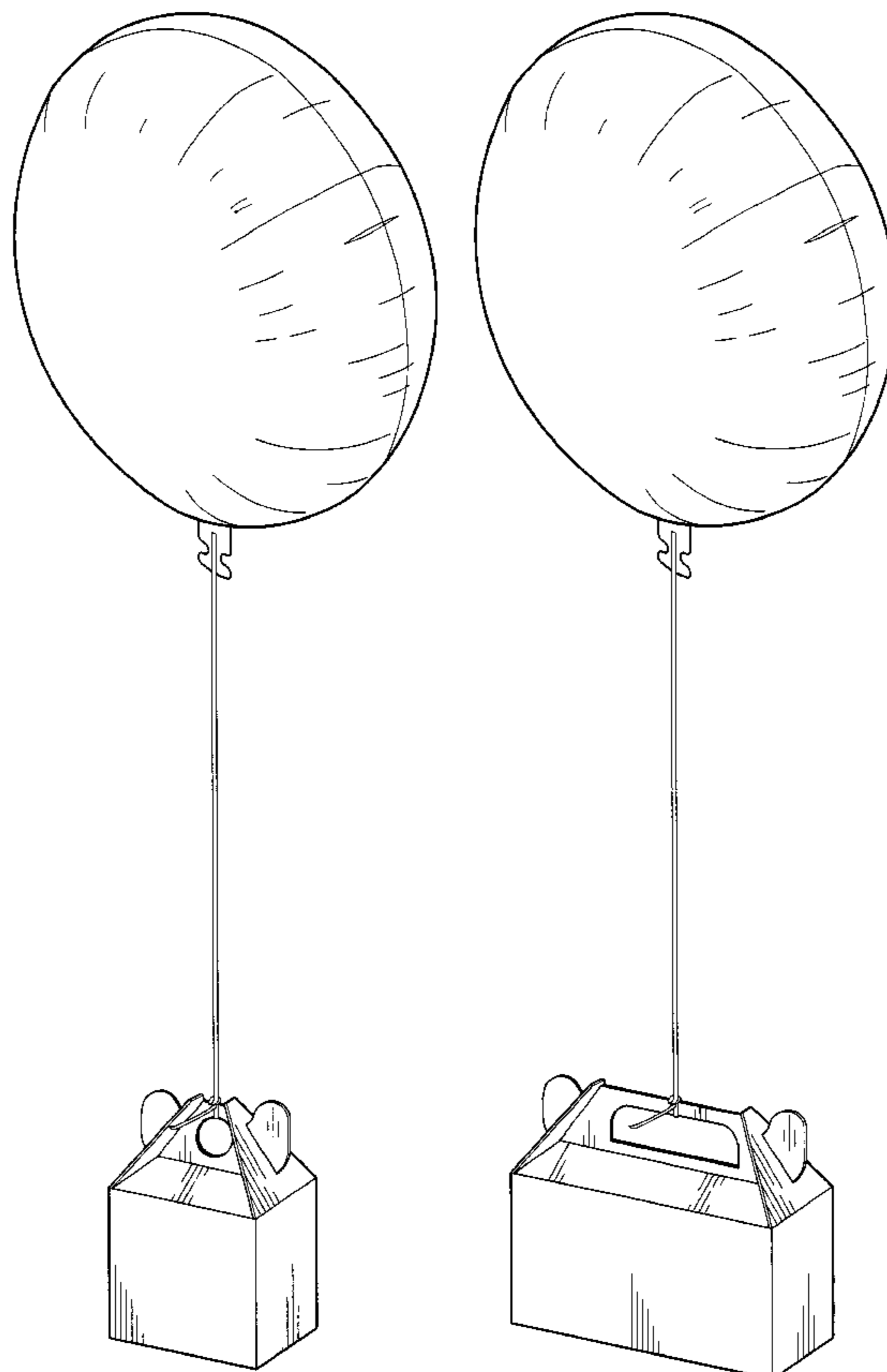
The ornamental design for an inflatable balloon with container ballast, as shown and described.

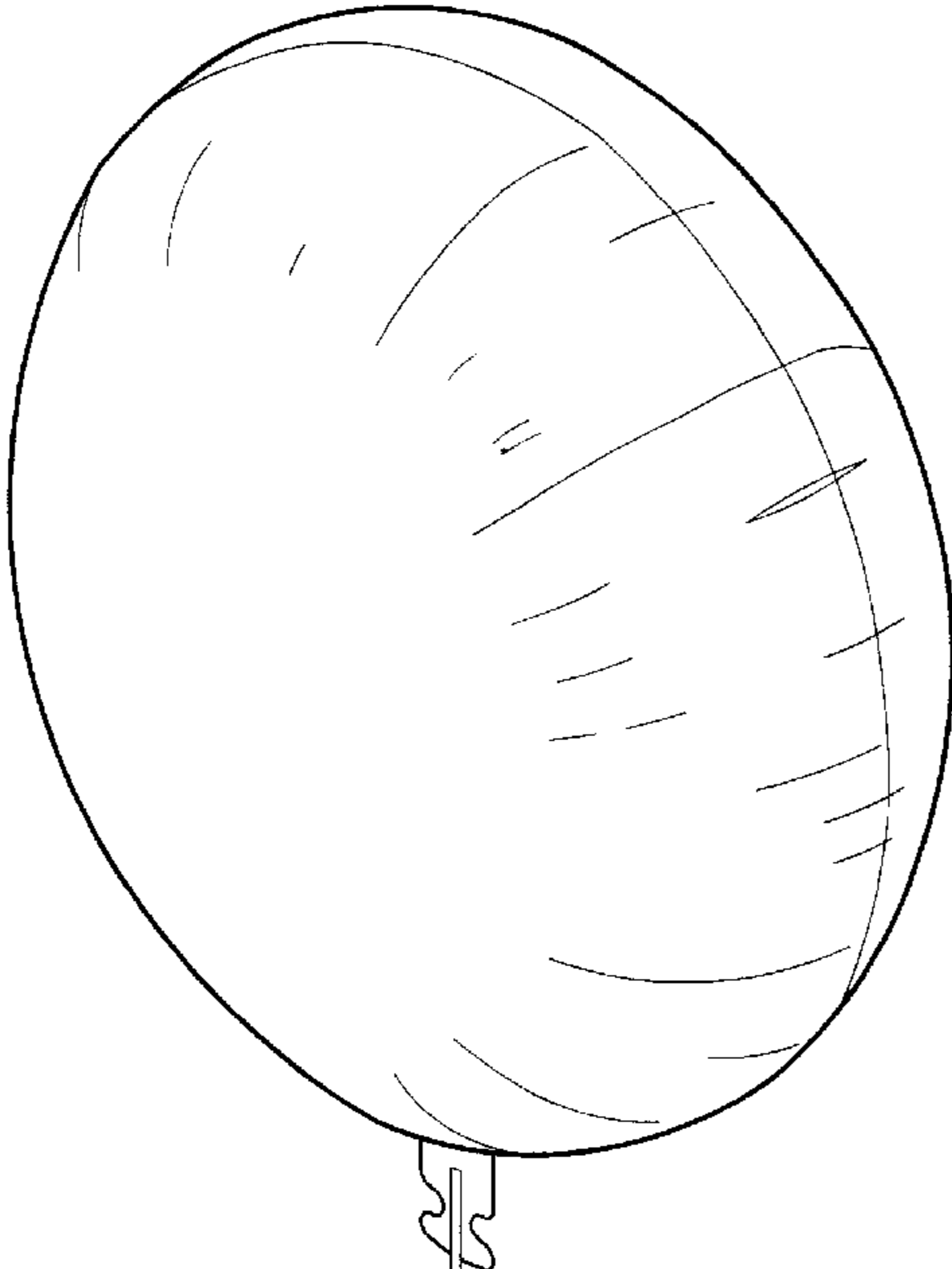

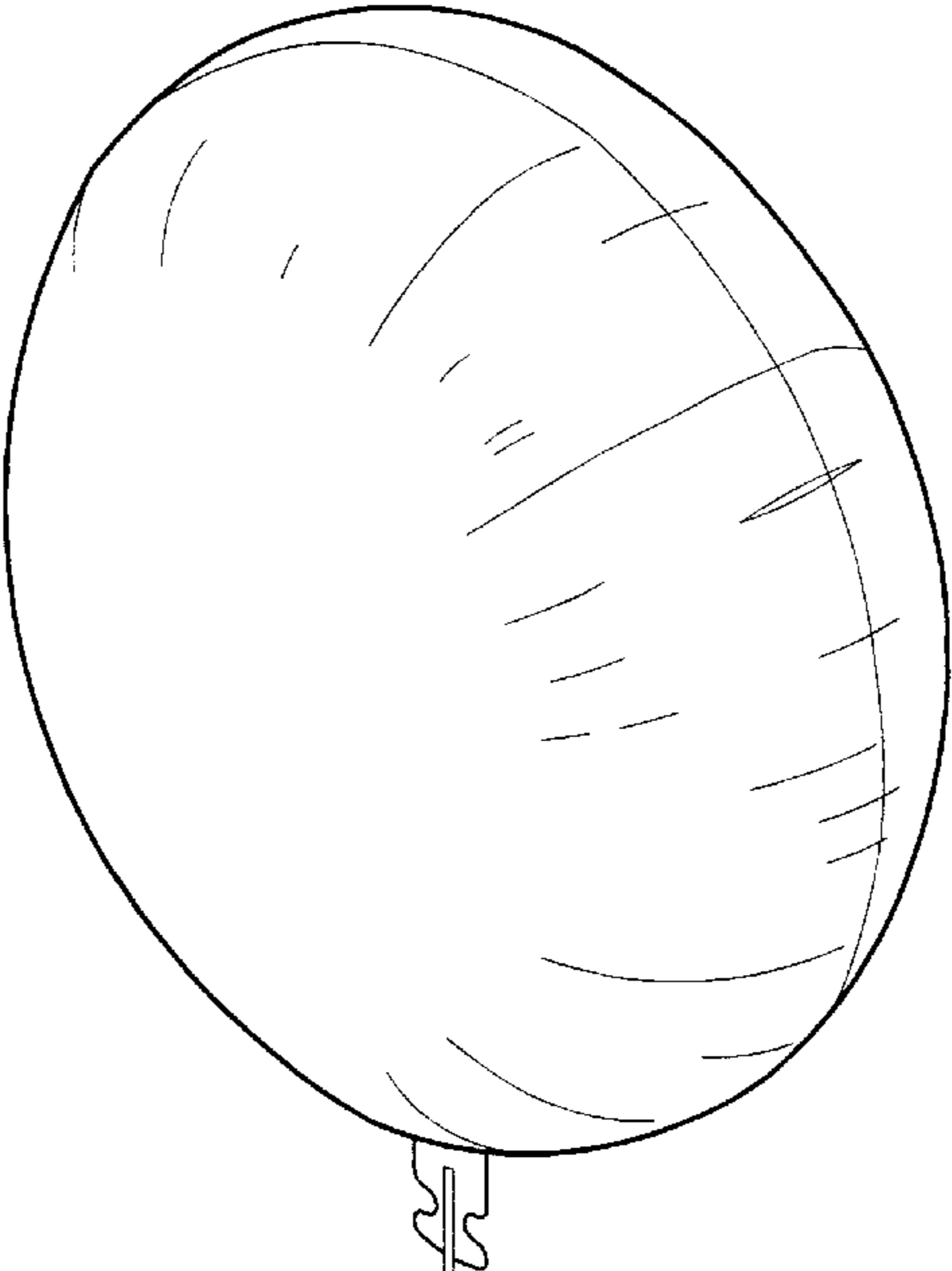
