(57) **CLAIM**

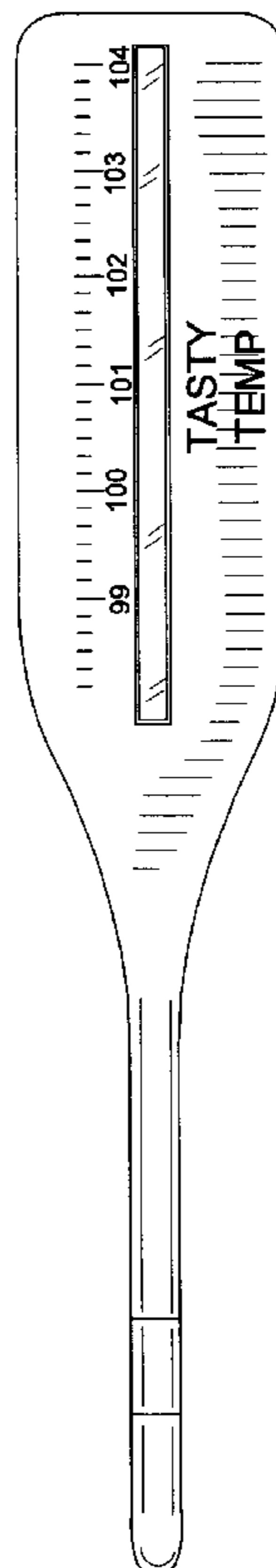
The ornamental design for a thermometer with flavored tip, as shown and described.

**DESCRIPTION**

FIG. 1 is a top plan view of a thermometer with flavored tip showing my new design;

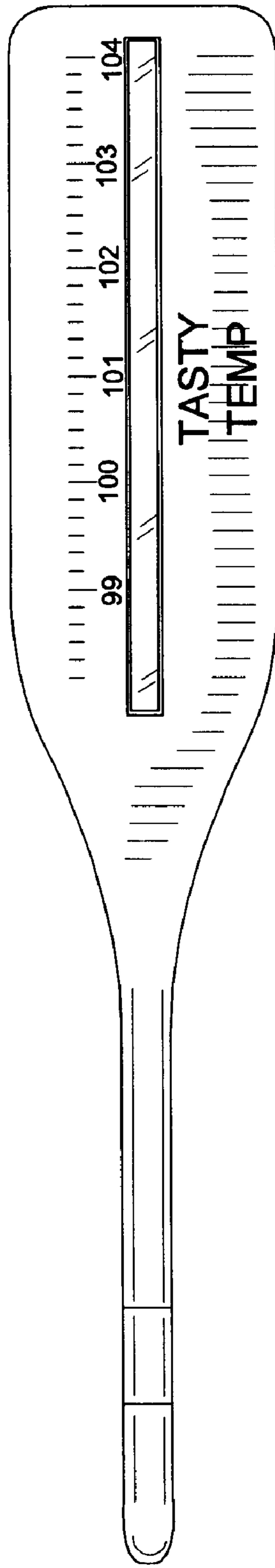

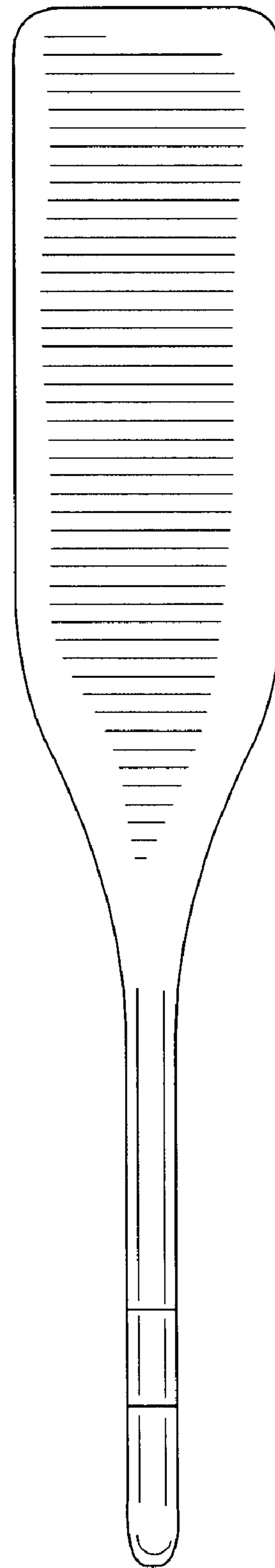

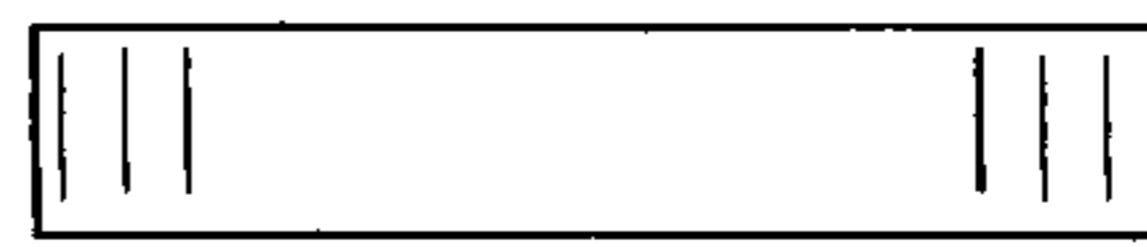
