FIG. 4 is a front view of the base of FIG. 1;

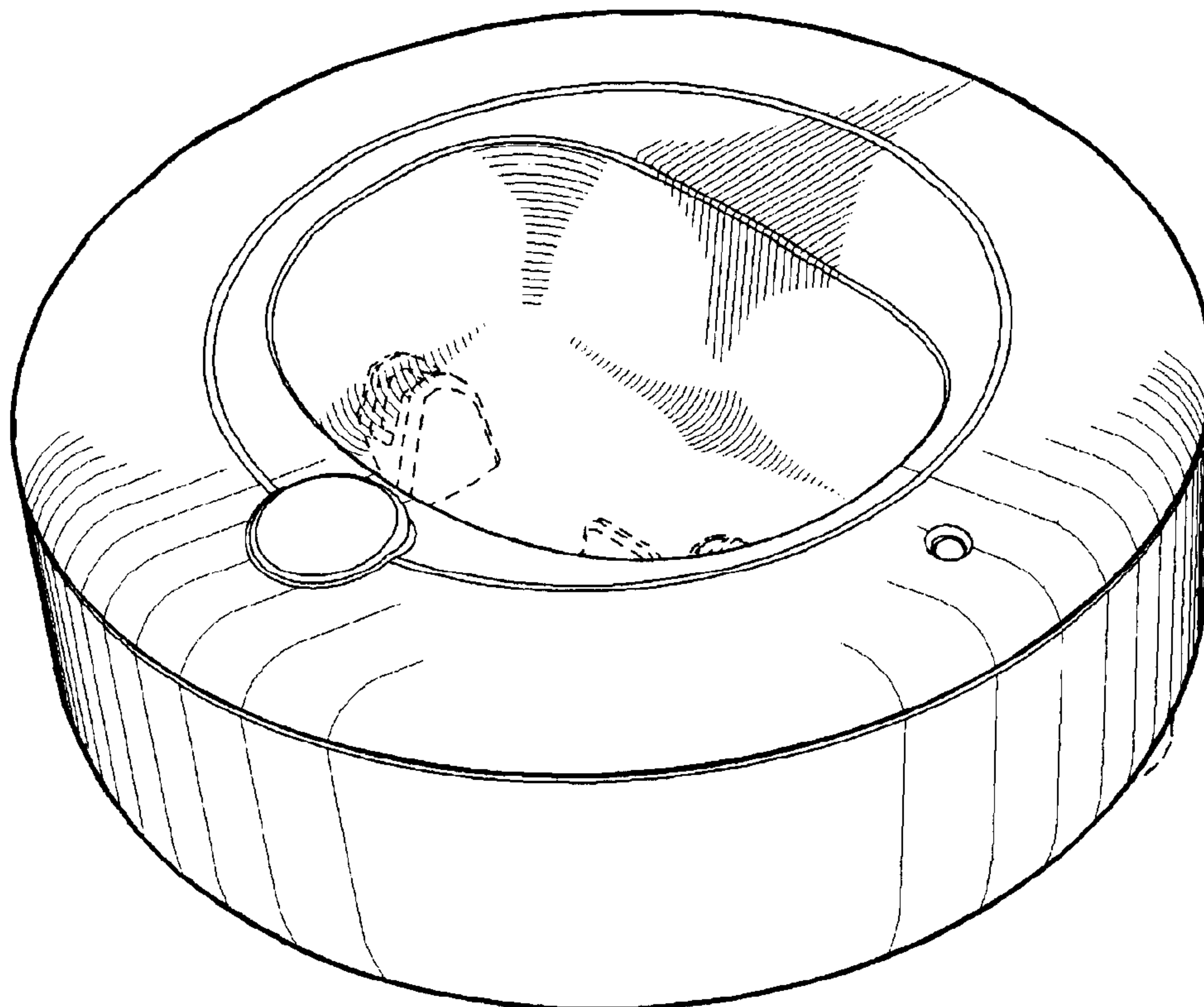
FIG. 5 is a back view of the base of FIG. 1;

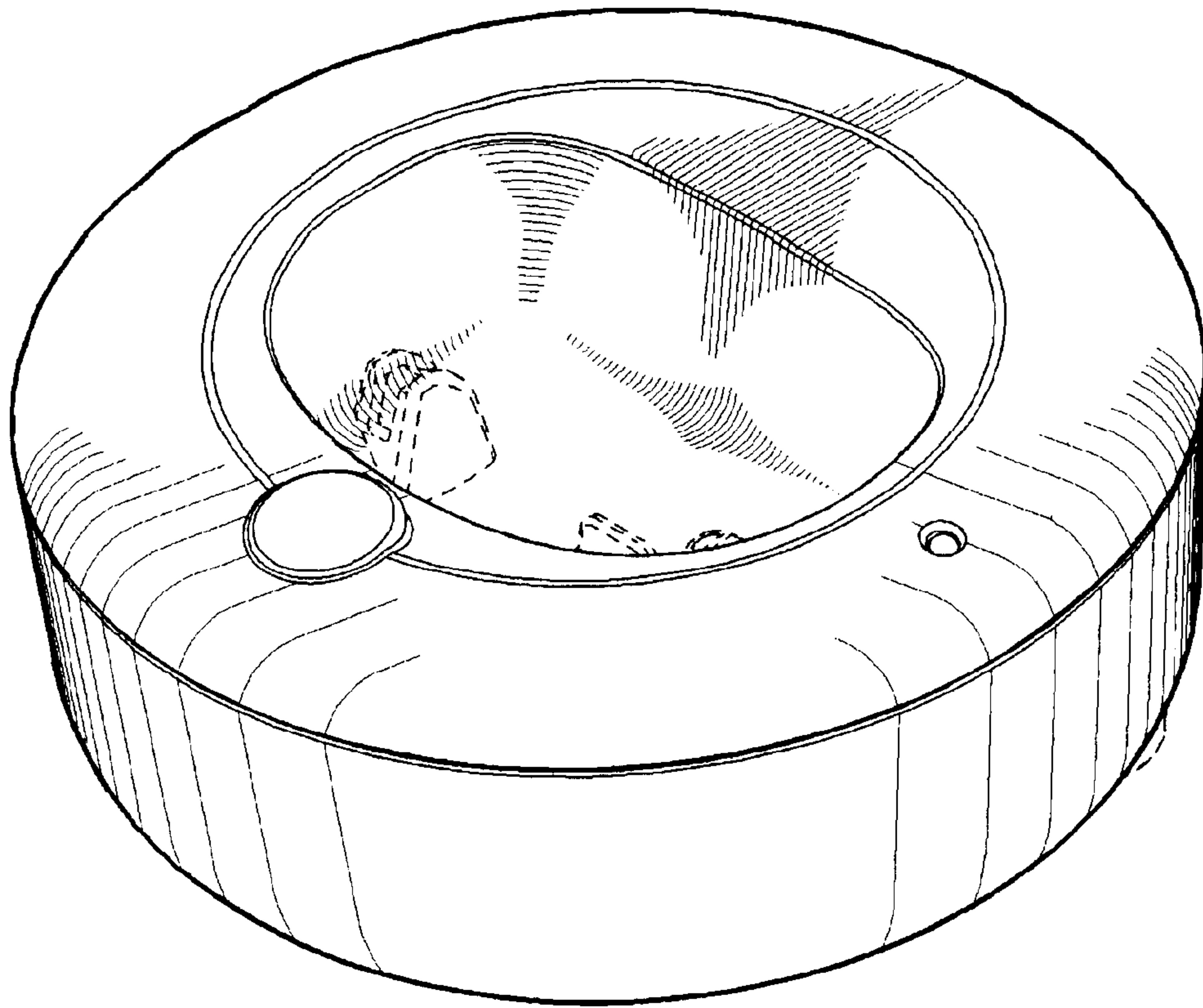
FIG. 6 is a side end view of the base of FIG. 1; and,

FIG. 7 is an opposite side end view of the base of FIG. 1.

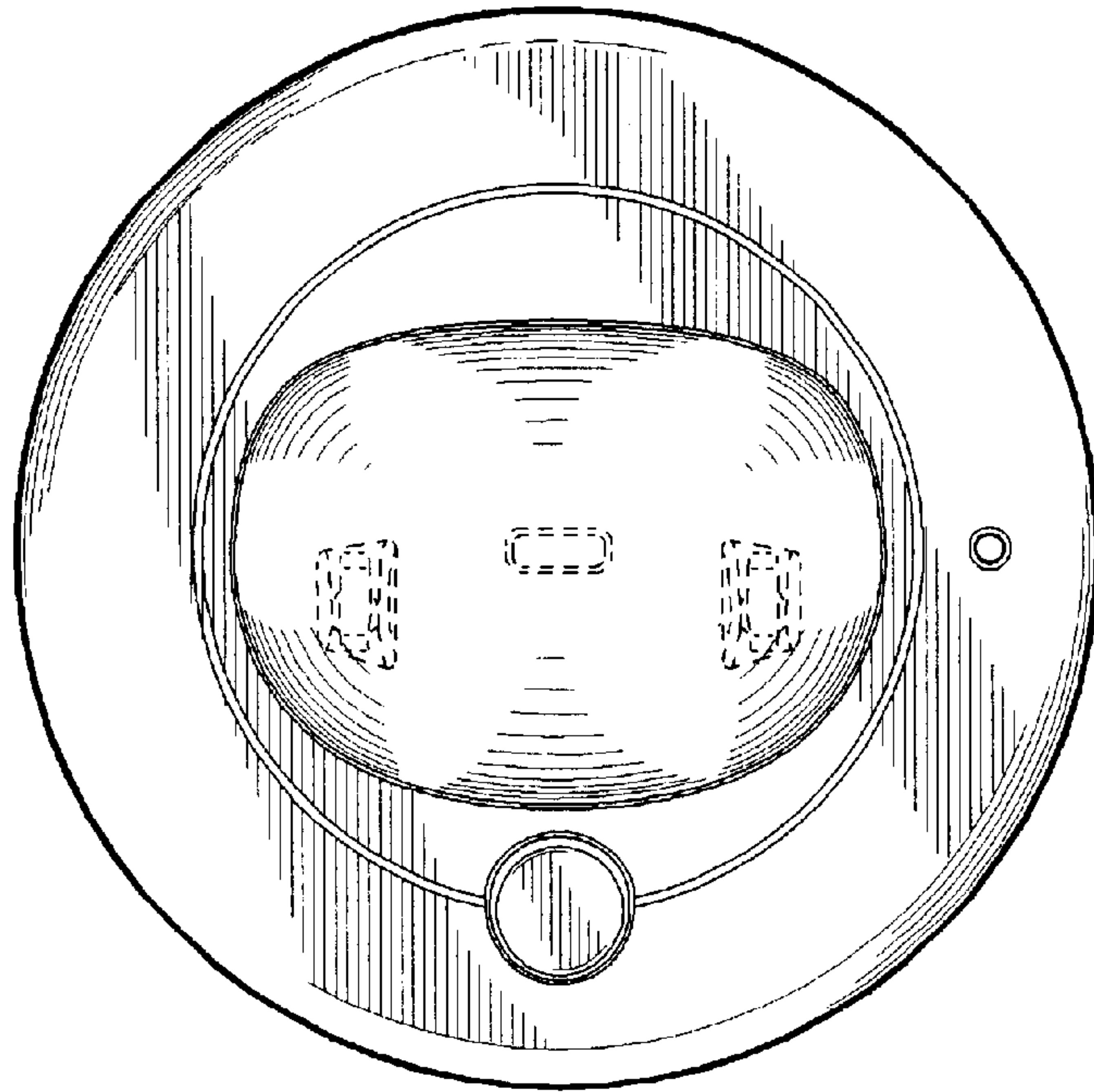

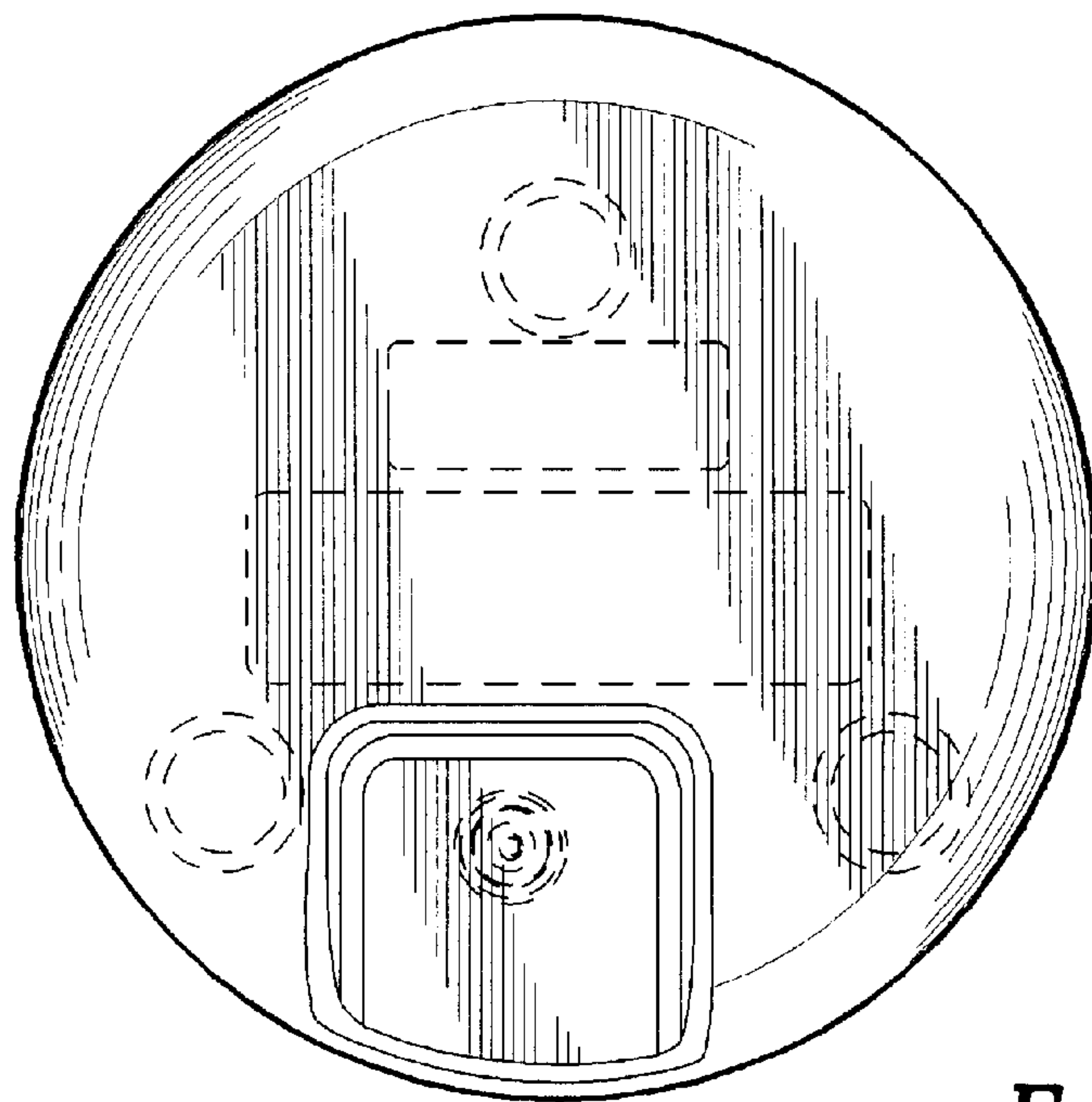




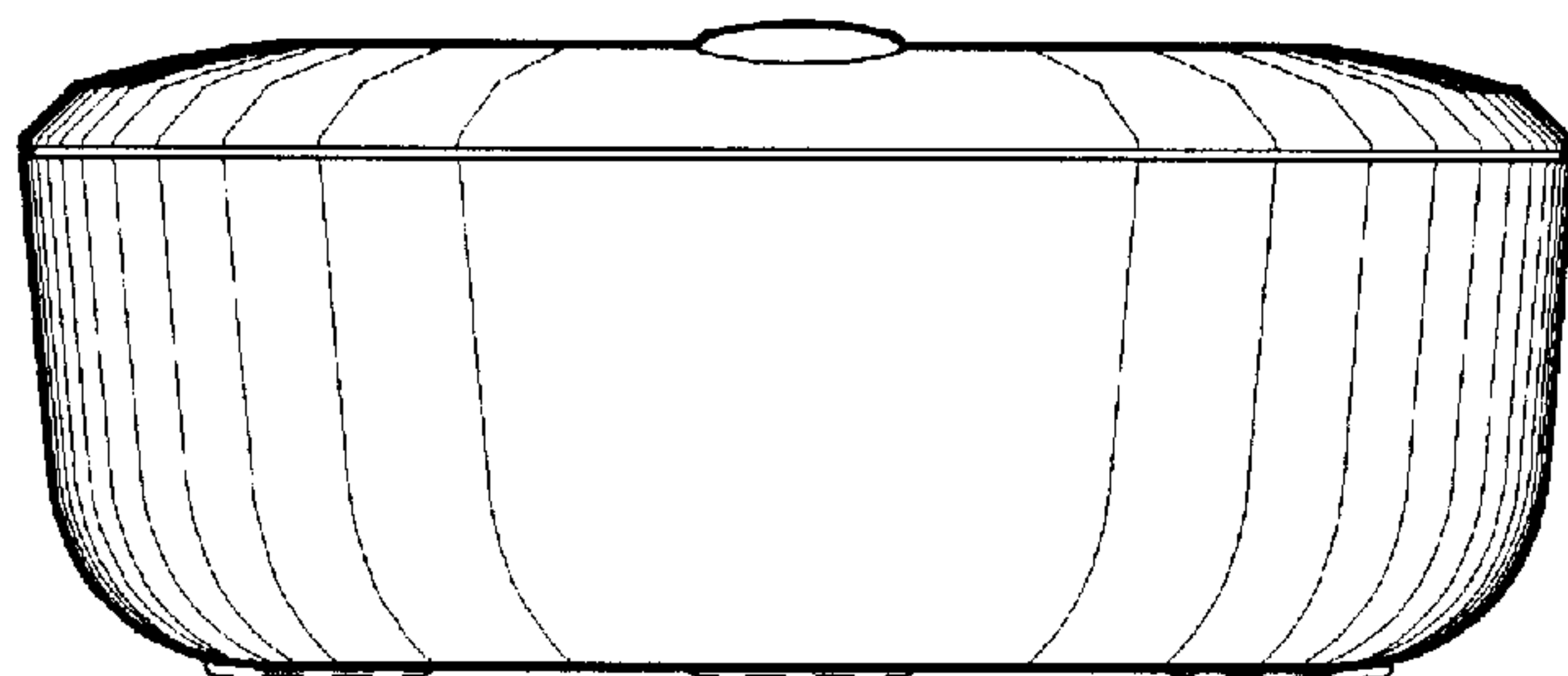

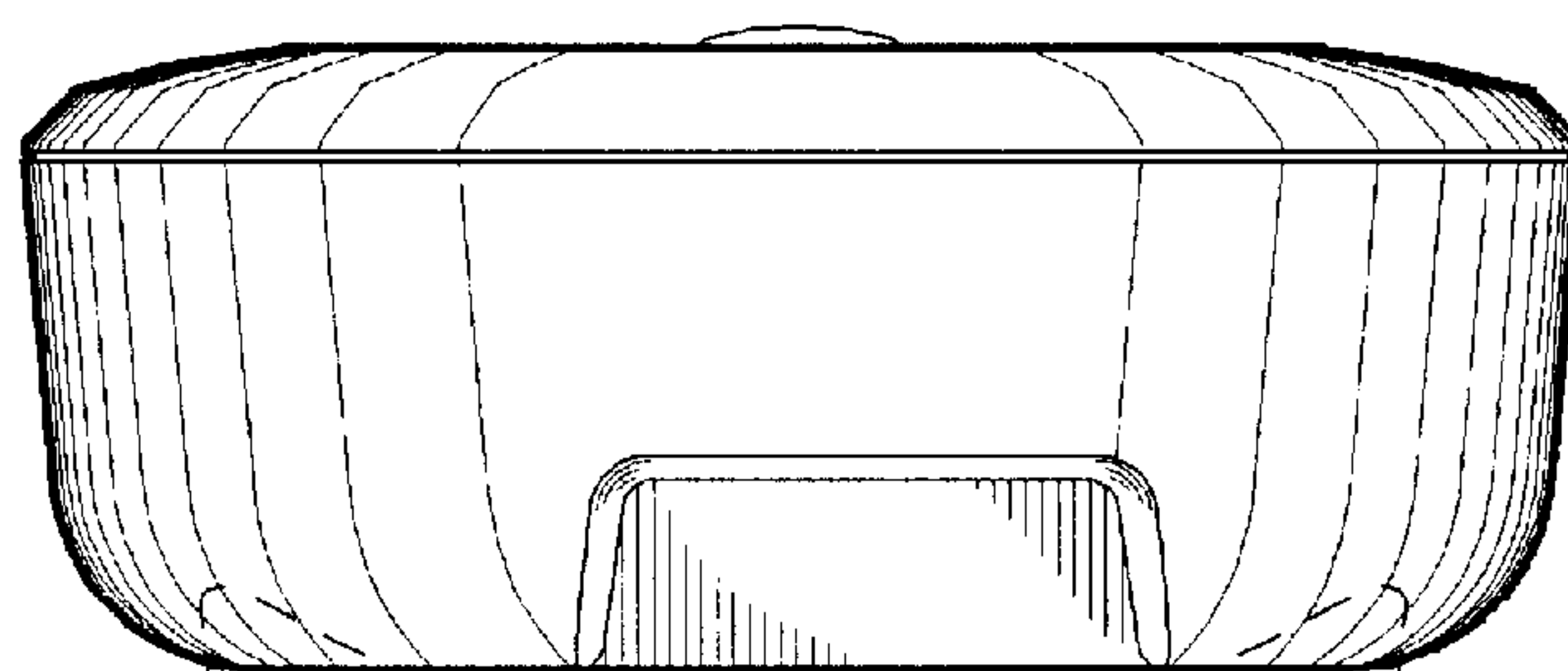

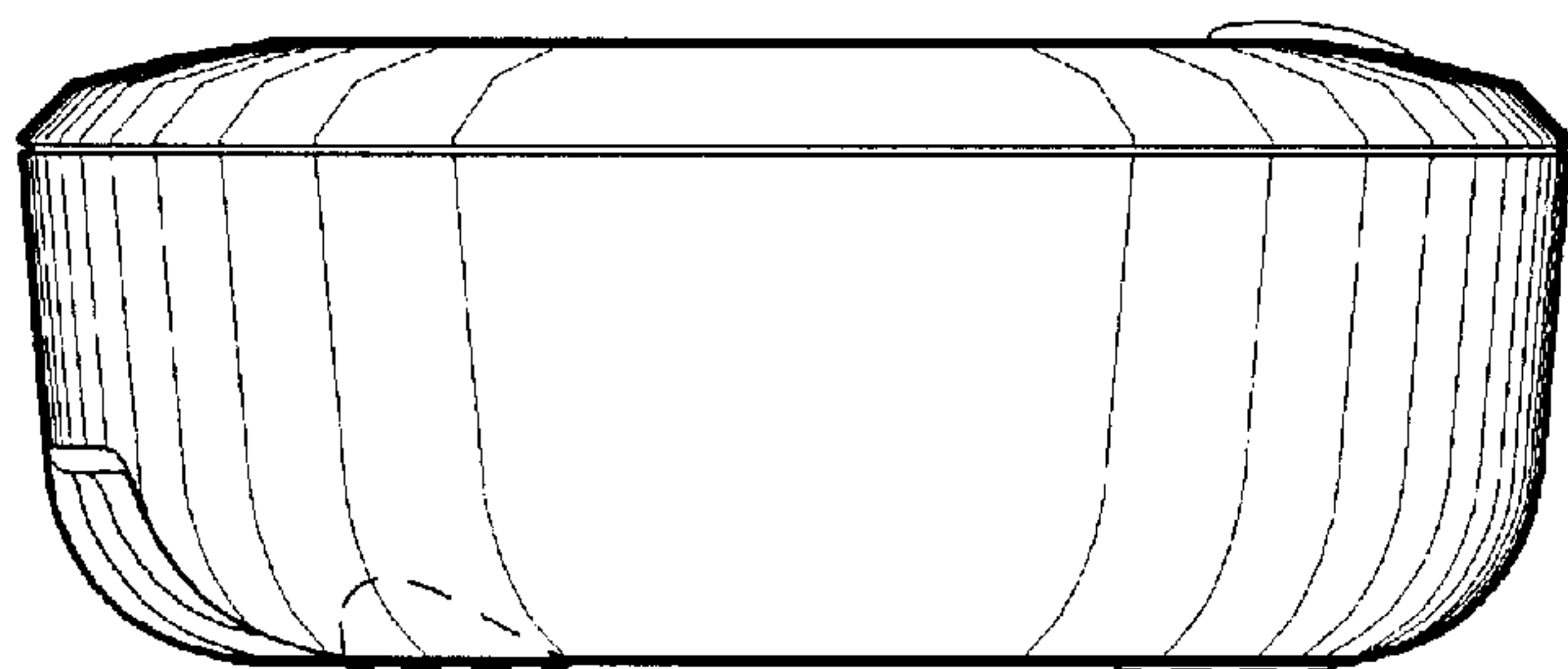

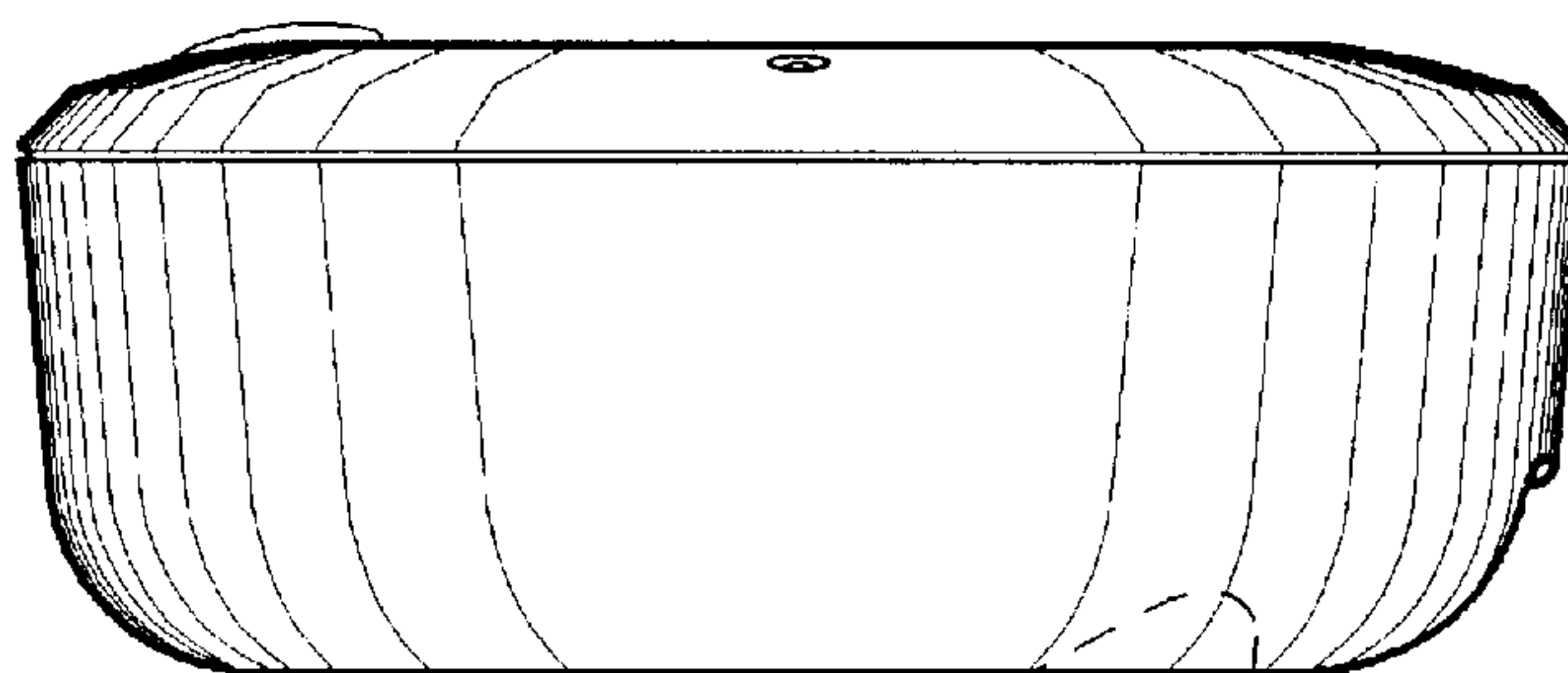
