**DESCRIPTION**

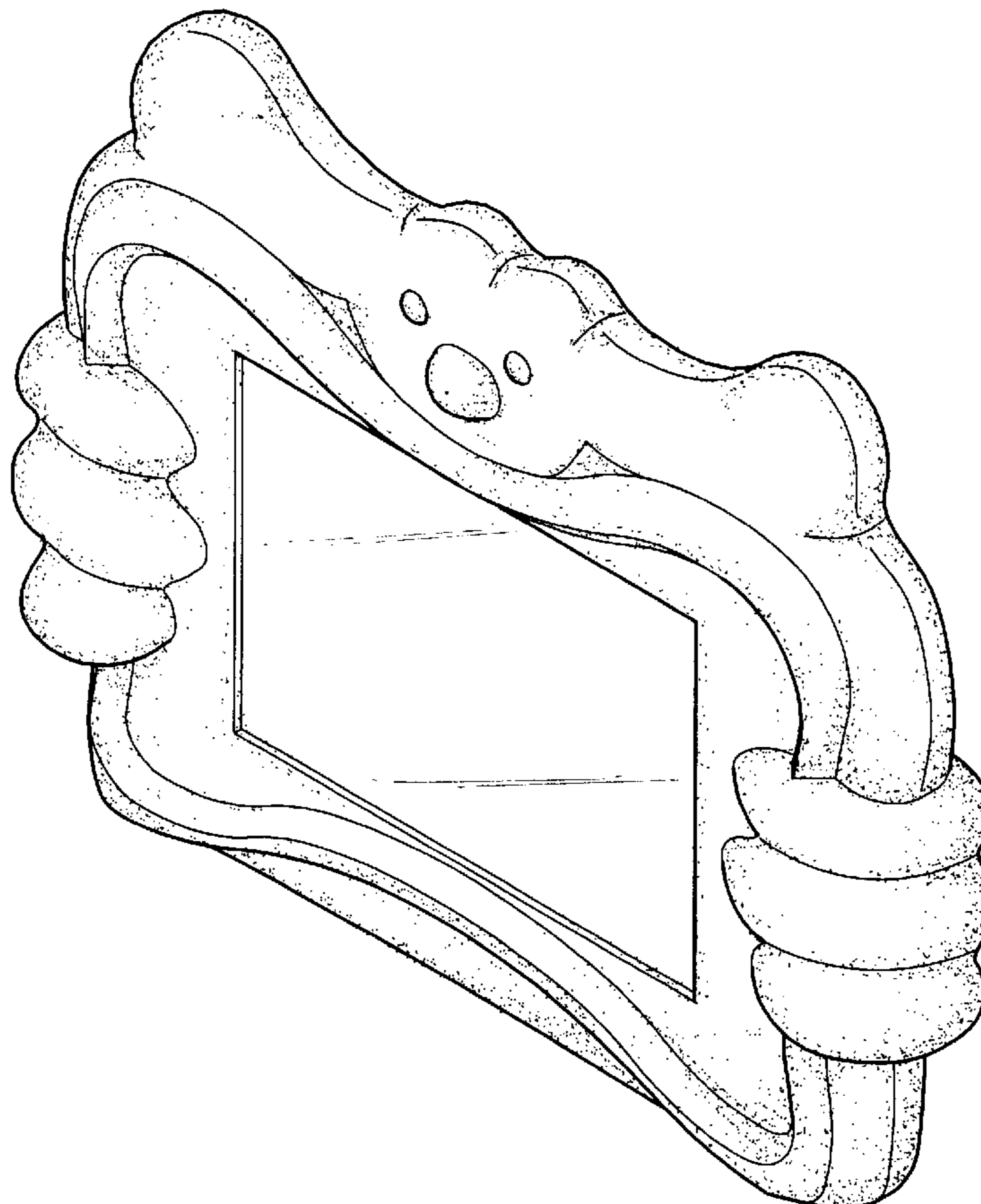
FIG. 1 is a perspective view of a television set showing my new design;

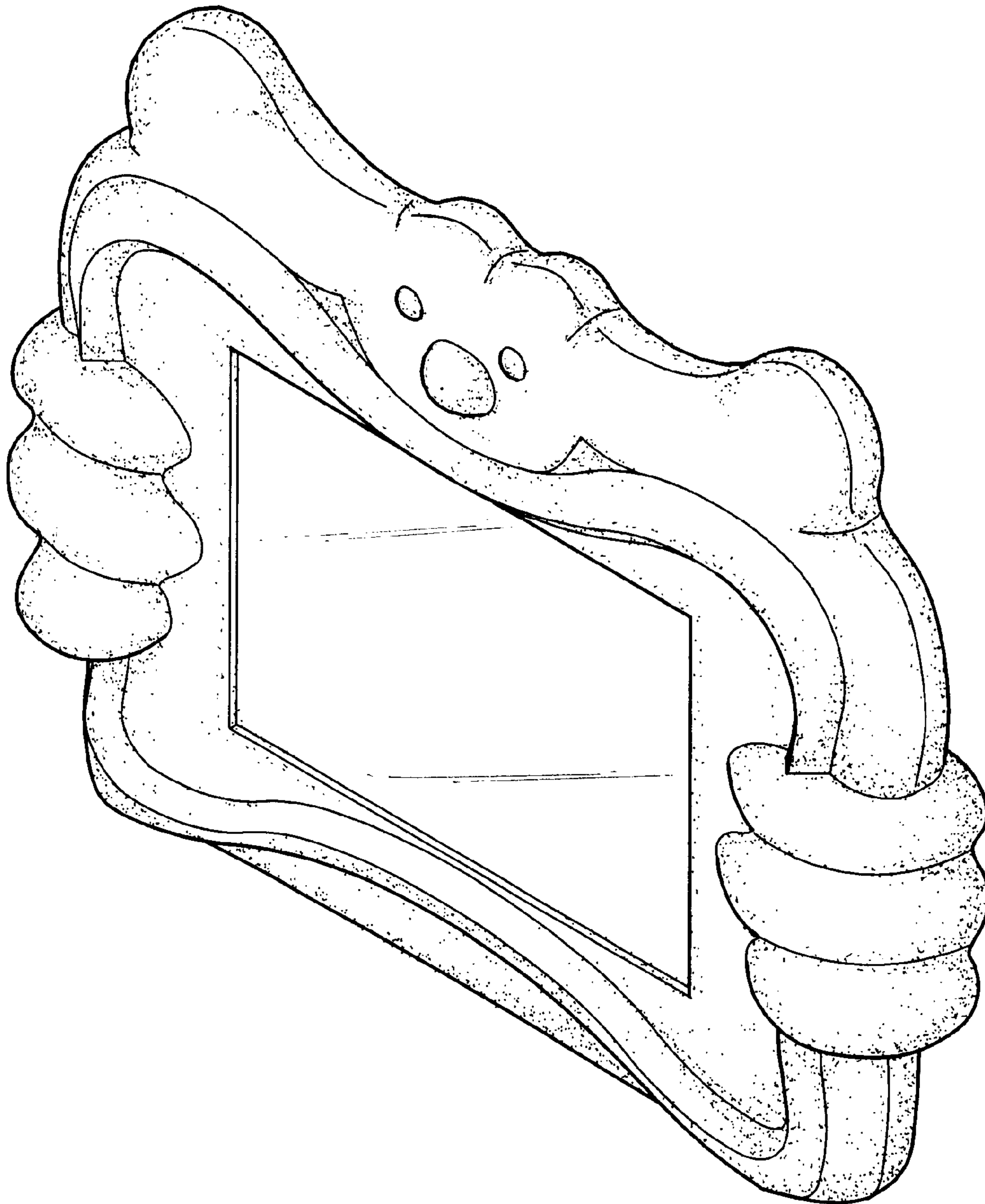

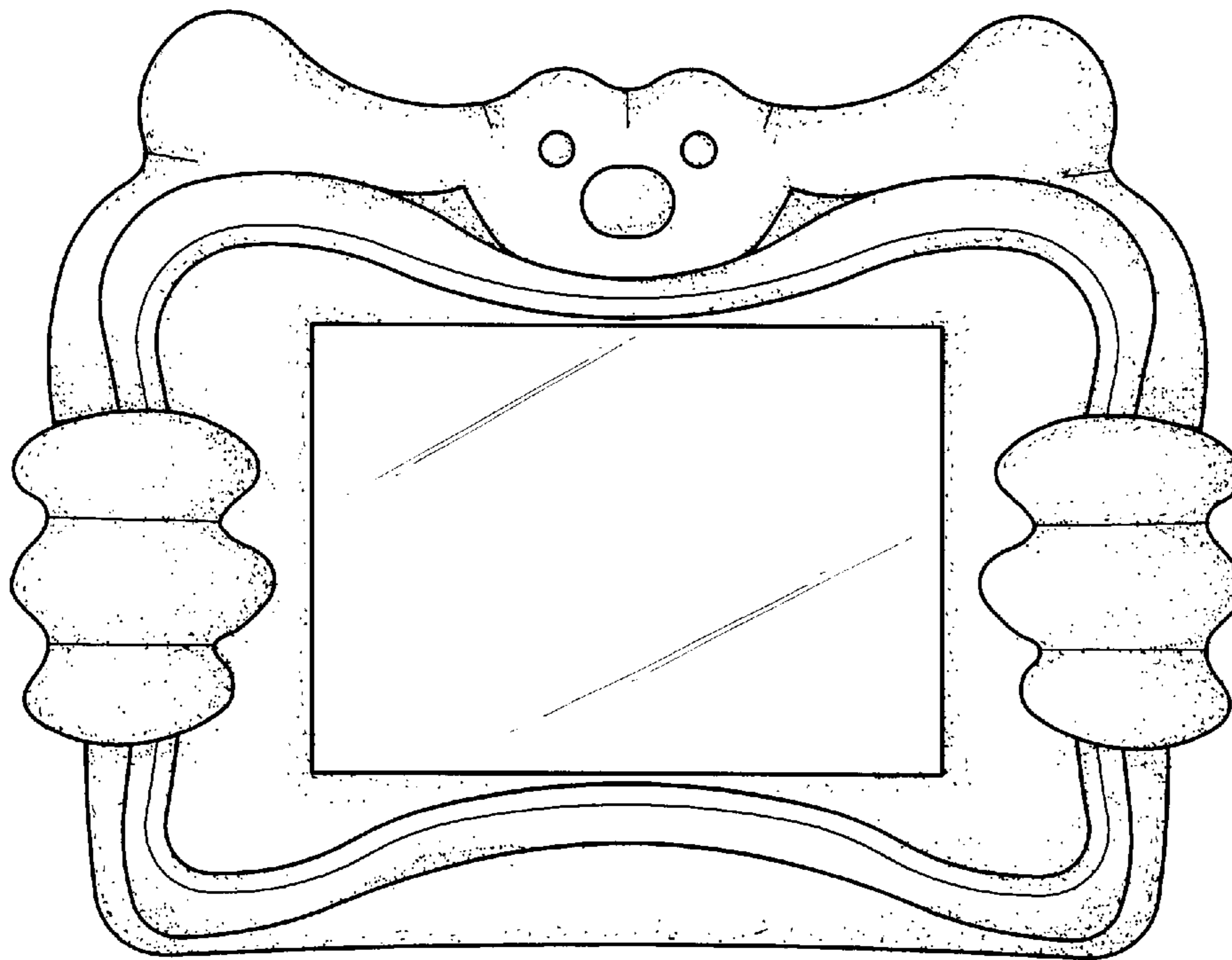

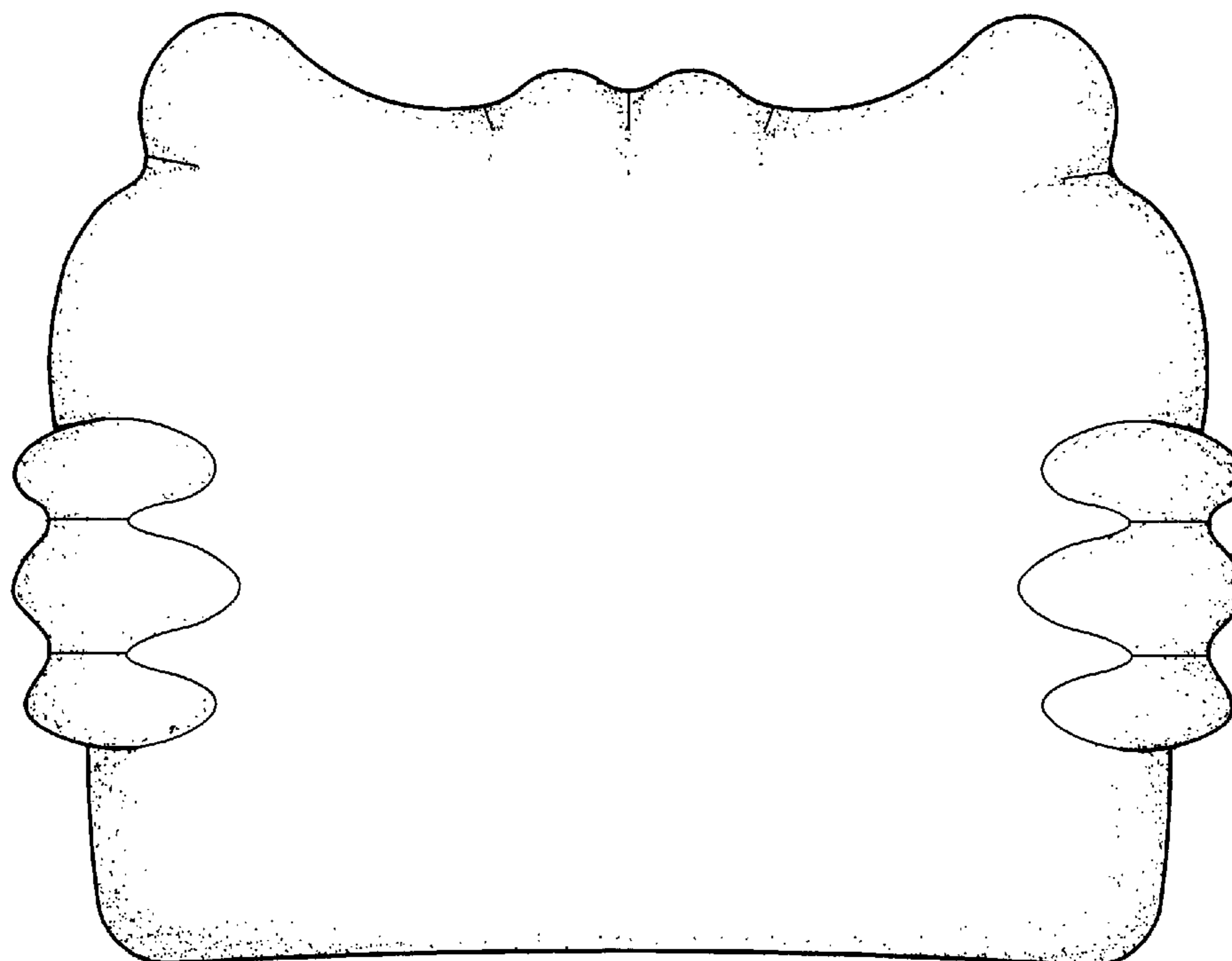

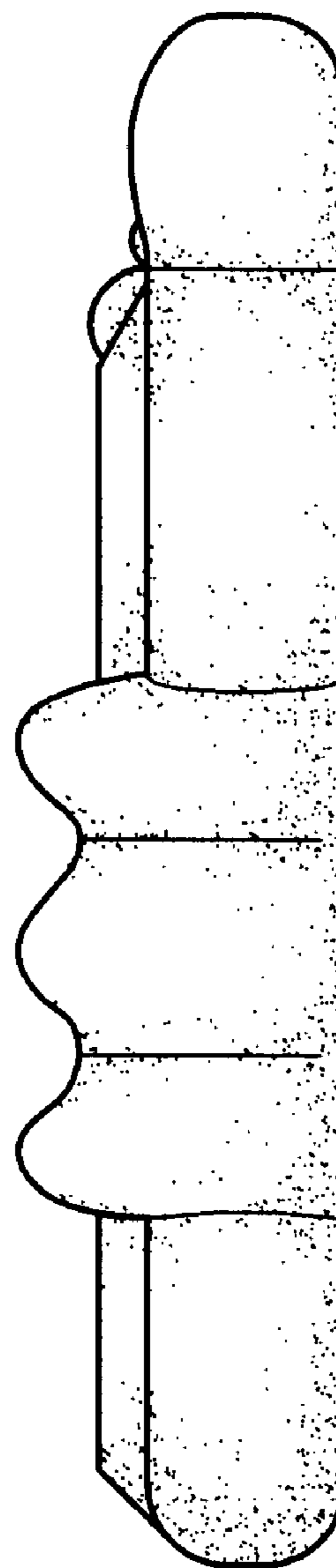

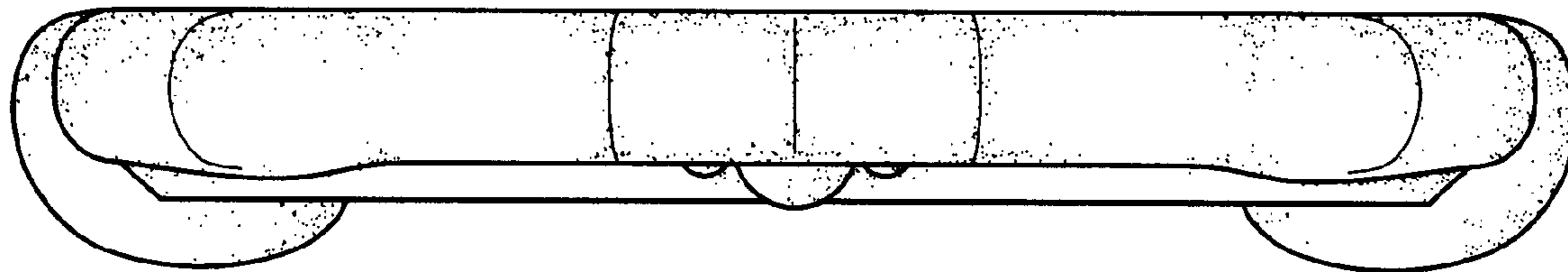

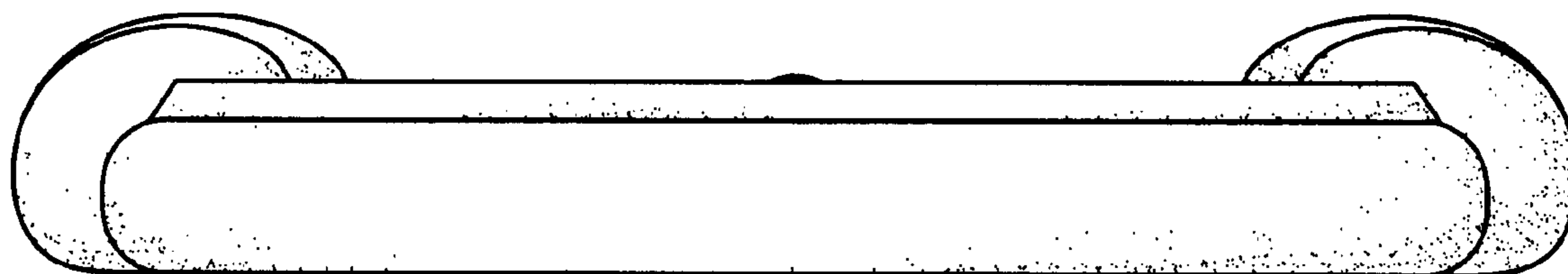
