(57) **CLAIM**

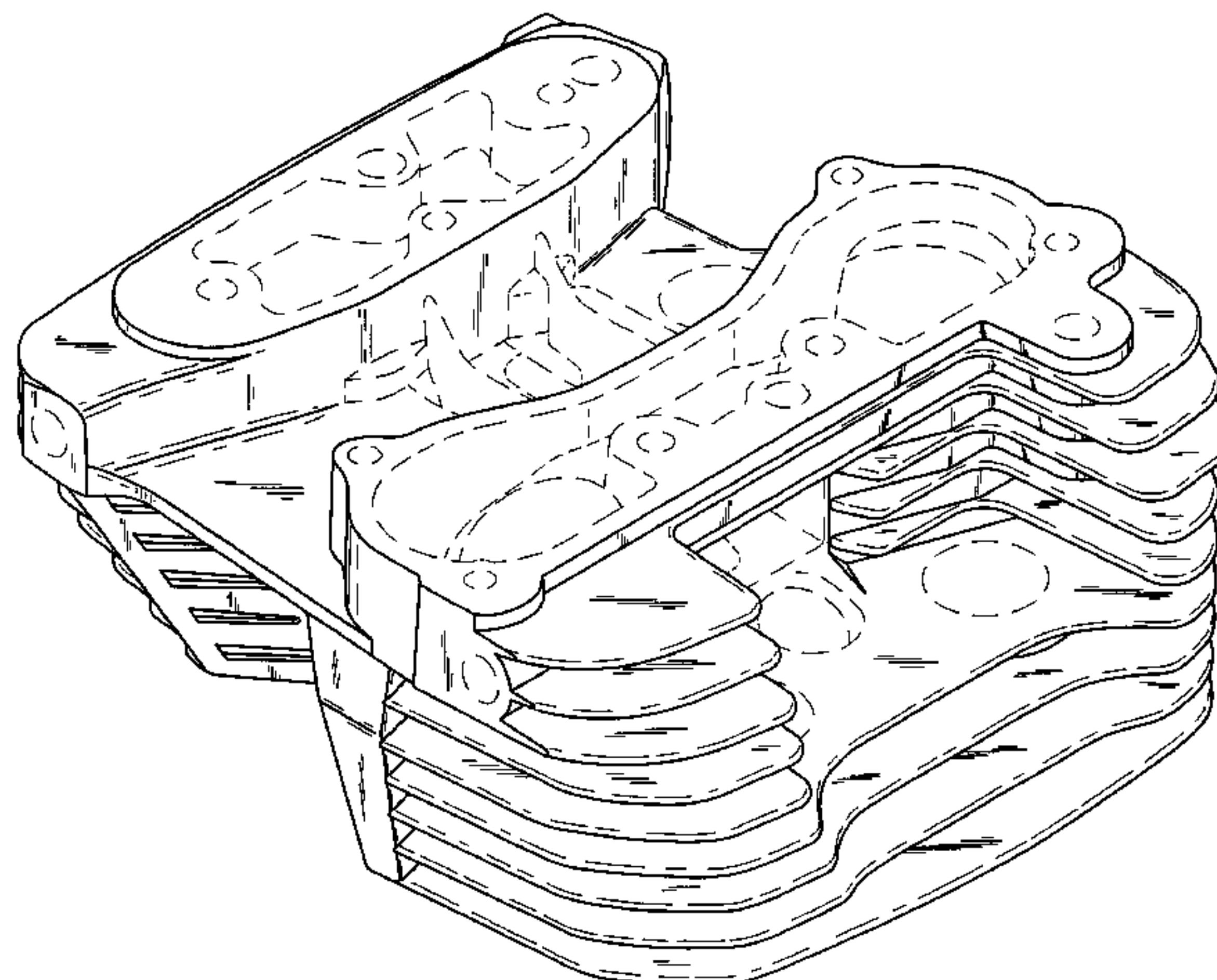
We claim the ornamental design for engine cylinder head, as

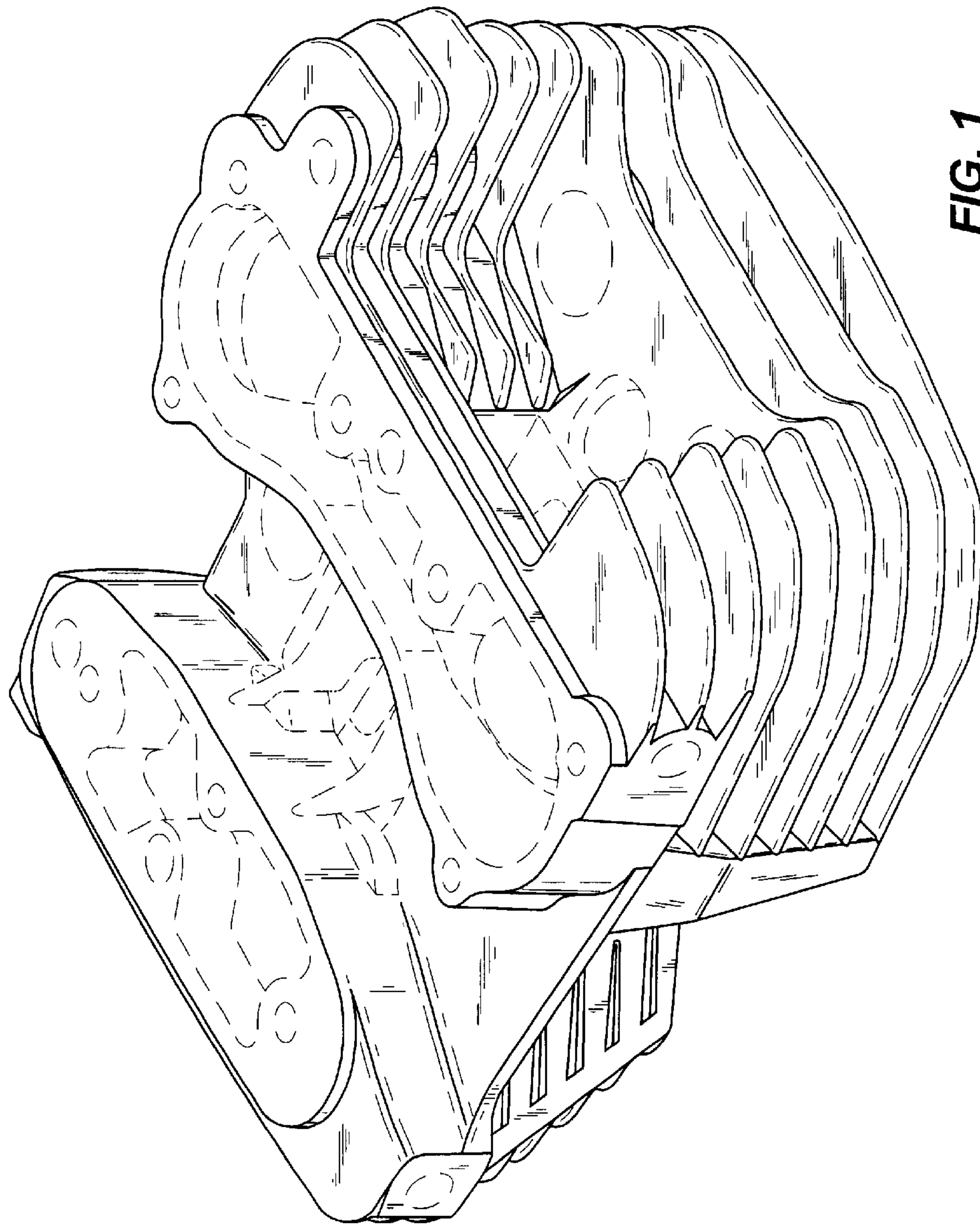

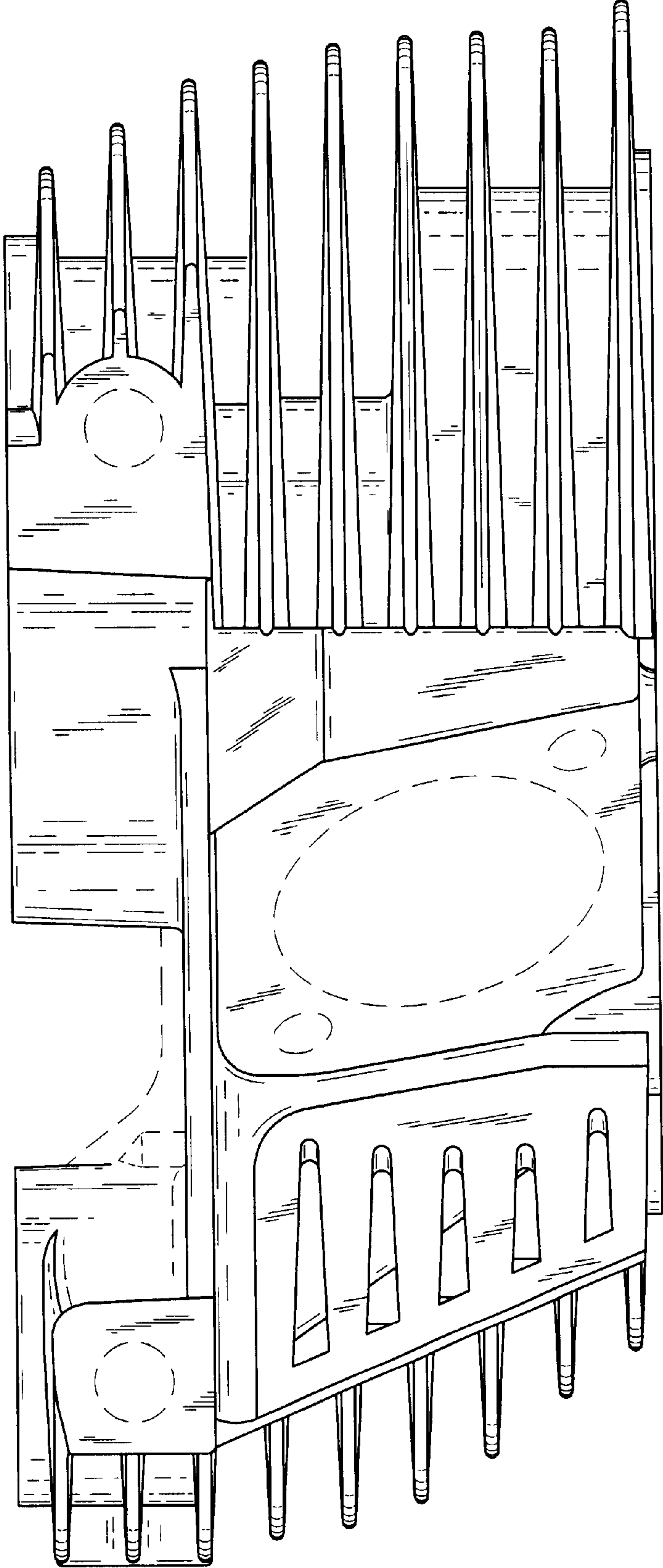

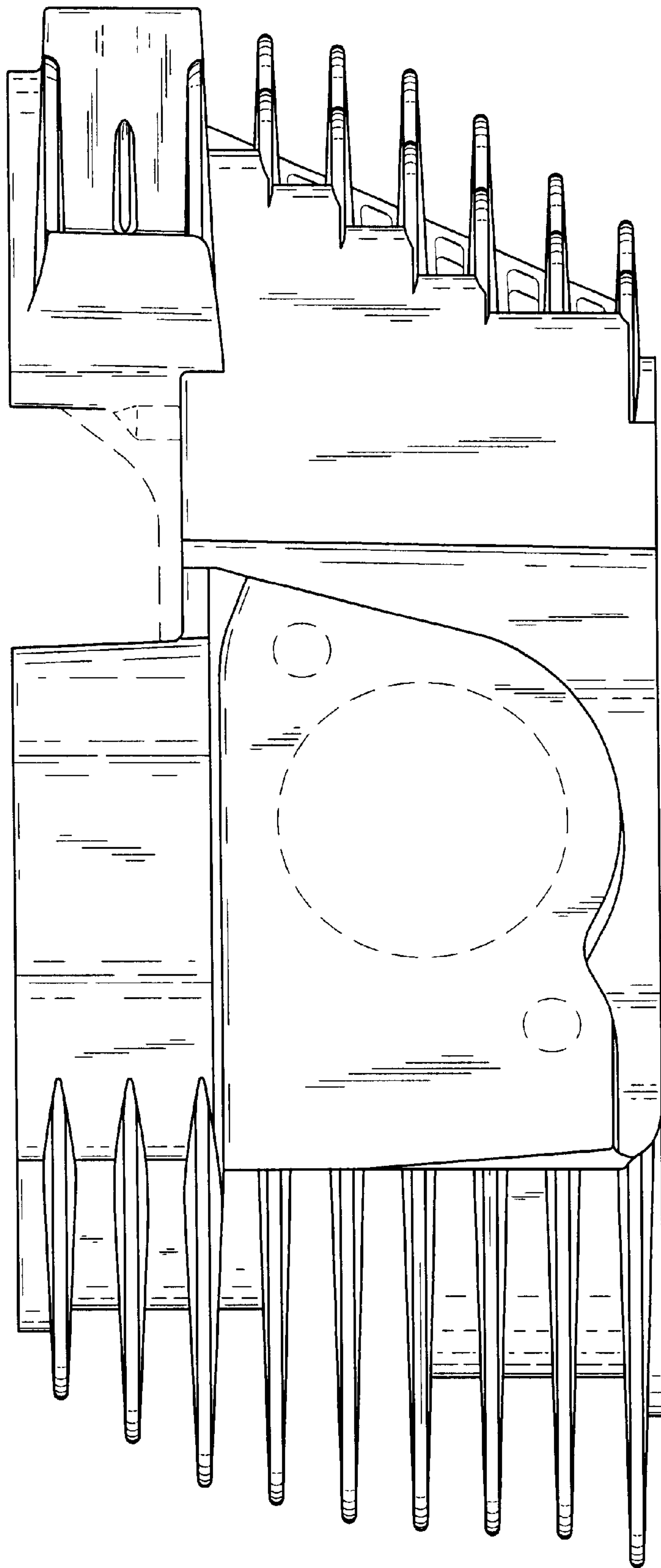

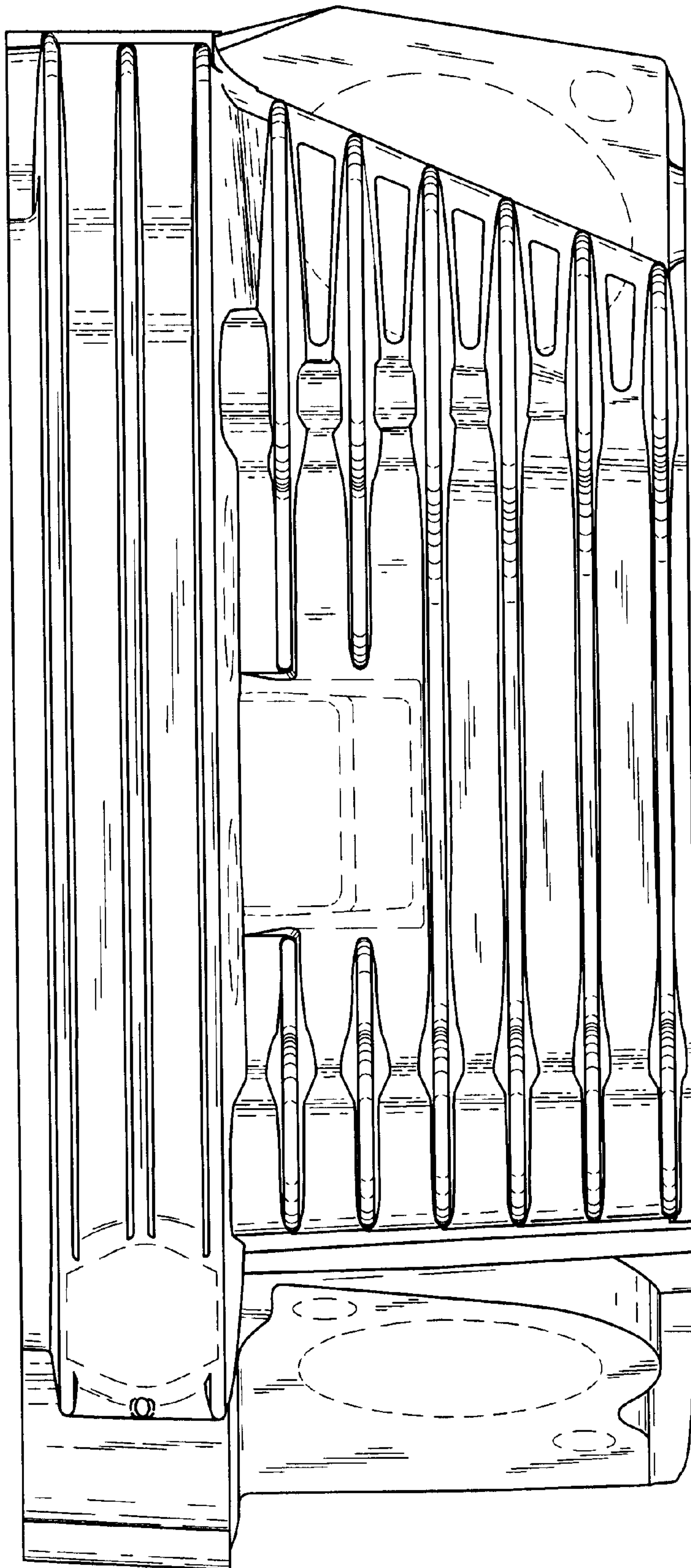

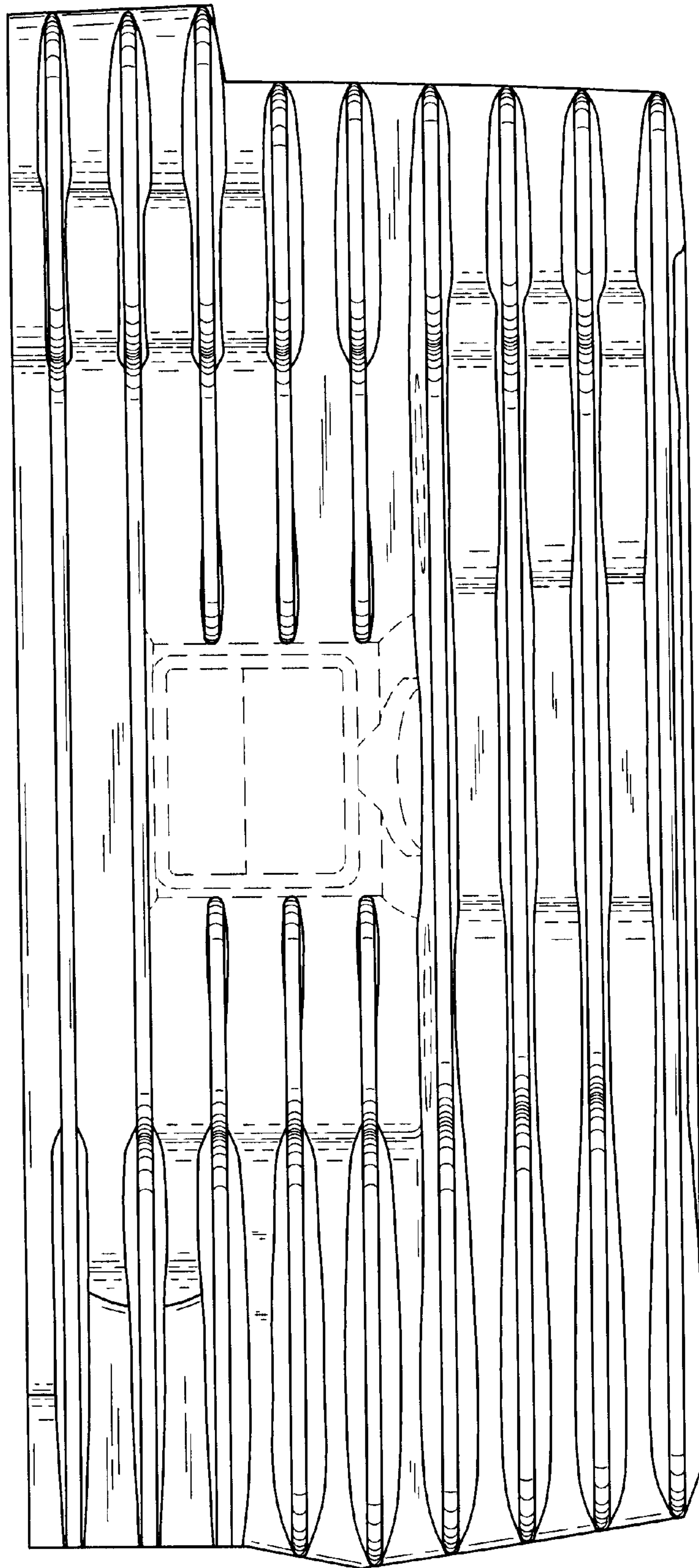

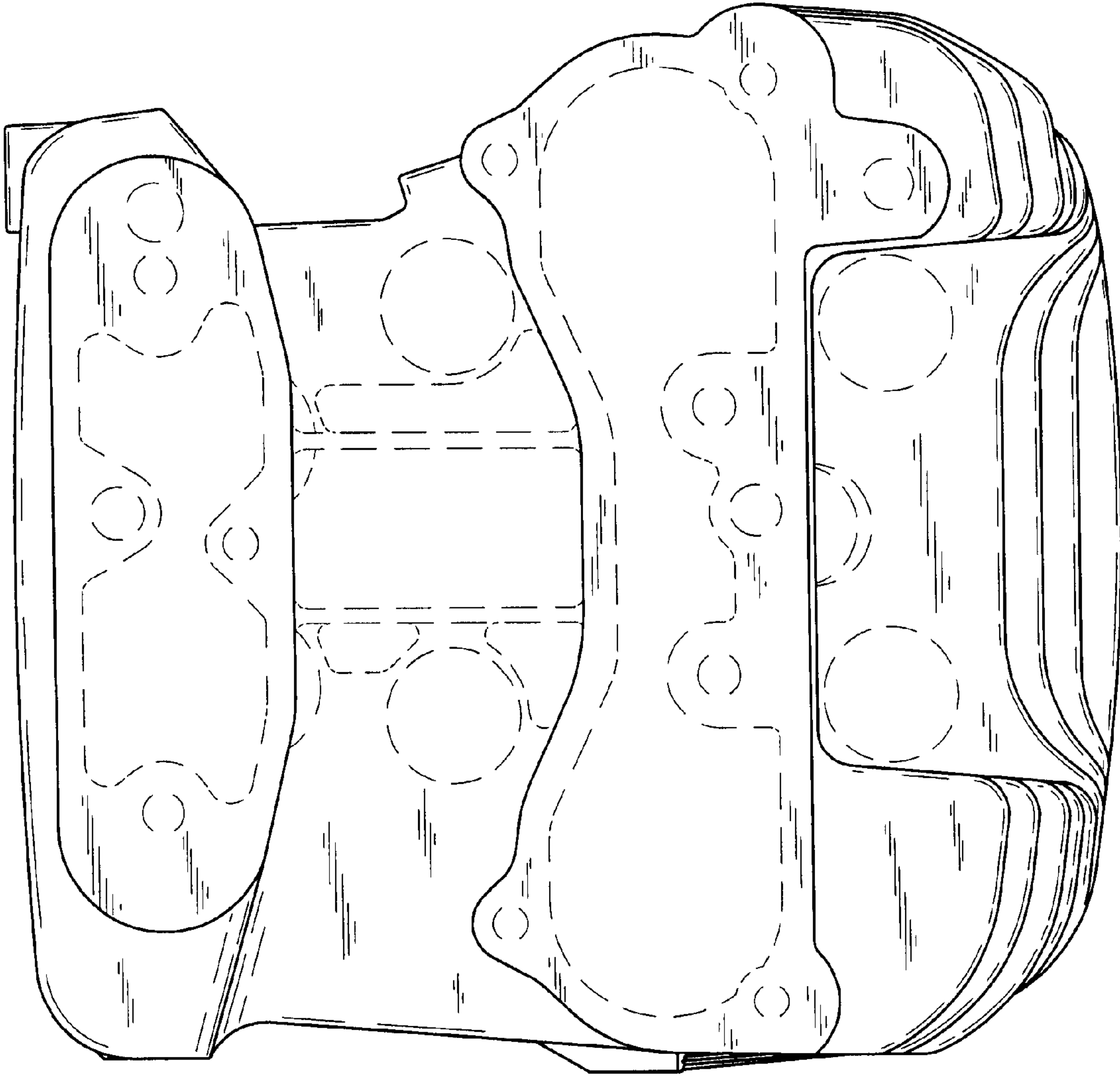

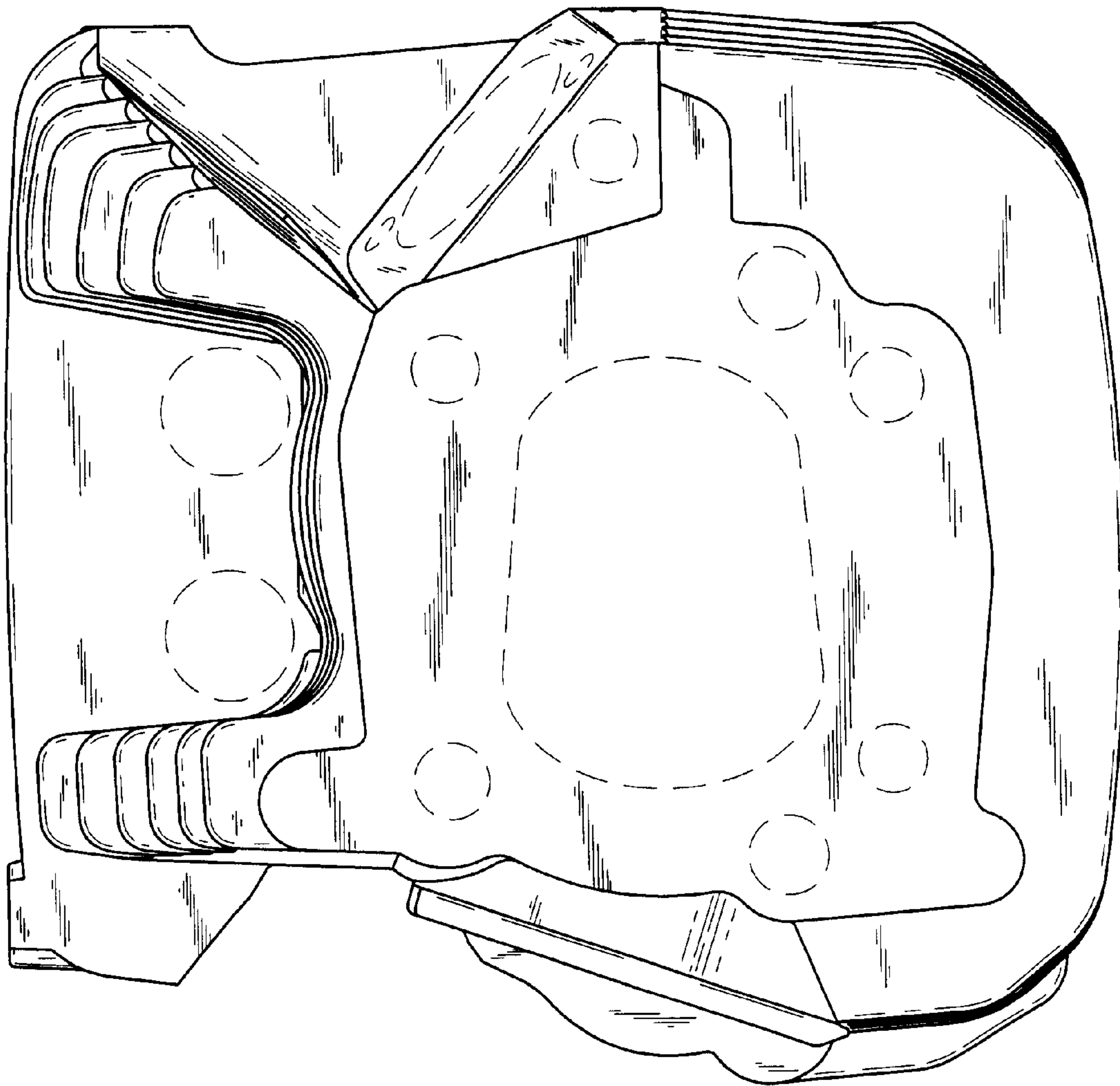
