(57) **CLAIM**

The ornamental design for a sleeve label for a plant container, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation drawing of the sleeve label for a plant container.

FIG. 2 is a back elevation drawing of the sleeve label for a plant container; and,

FIG. 3 is a bottom view of the sleeve label for a plant container.

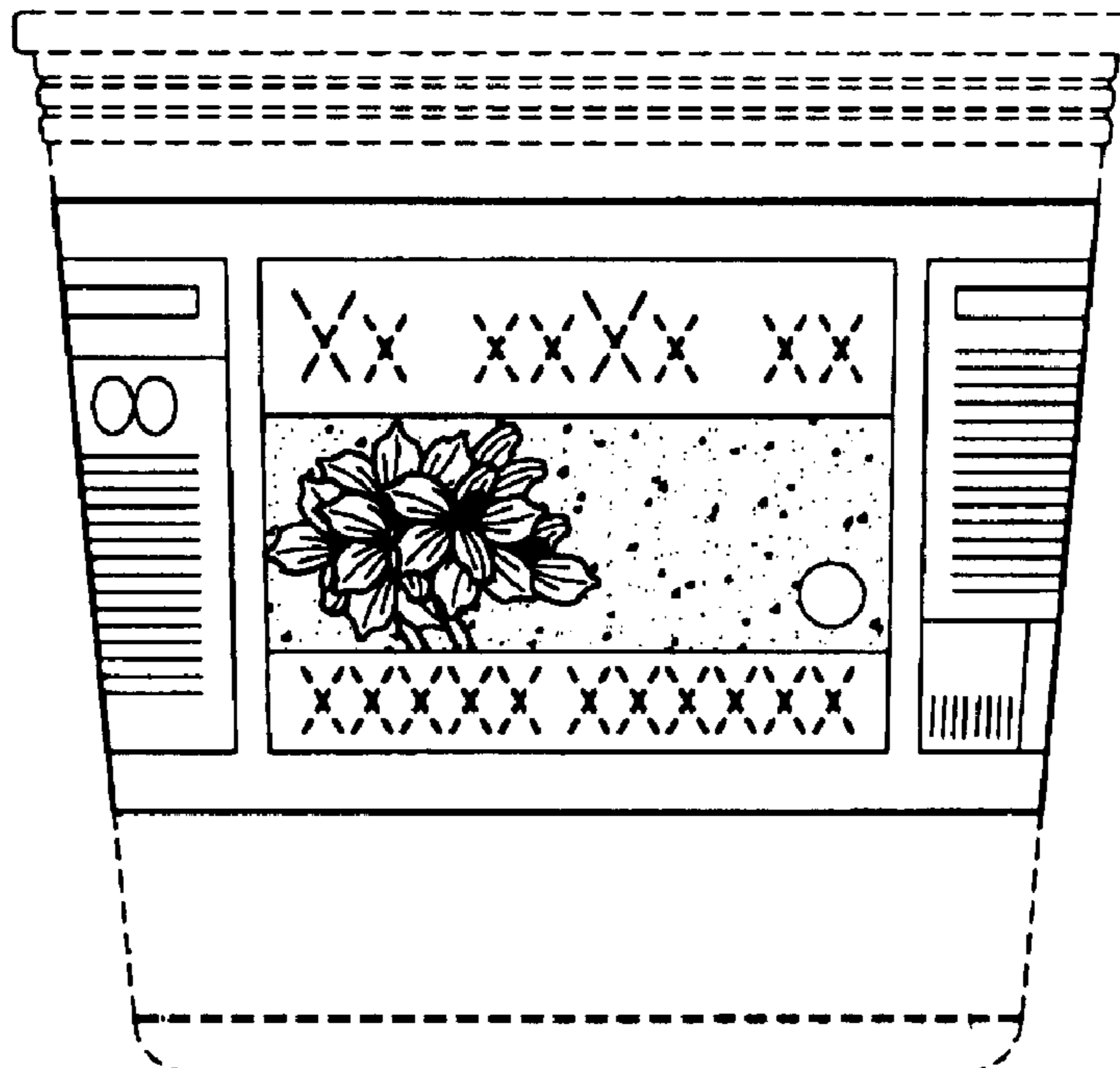

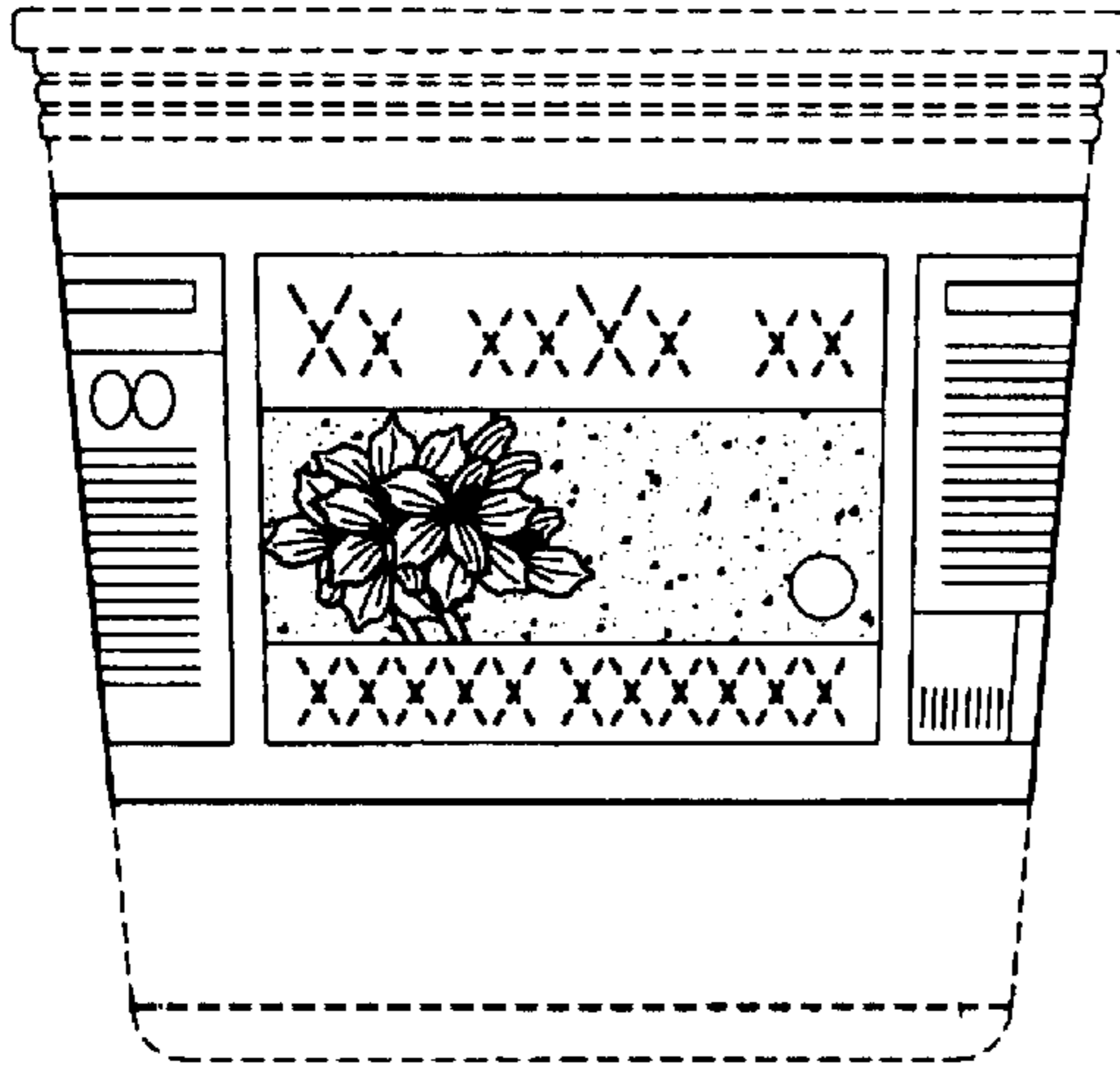

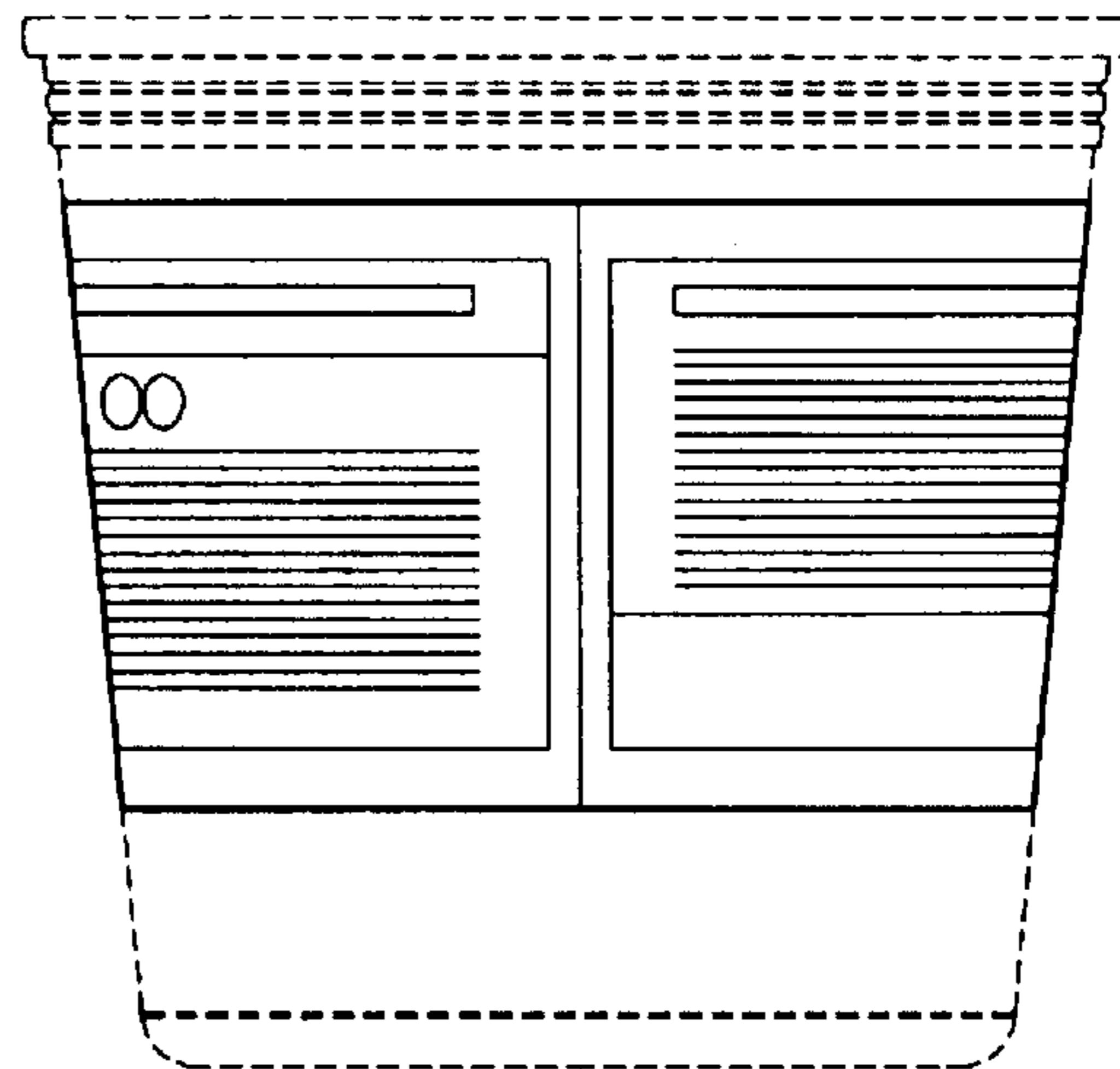
