(57) **CLAIM**

I claim the ornamental design for a perfume burner, as shown.

**DESCRIPTION**

FIG. 1 is a perspective view of a perfume burner comprising the present invention;

FIG. 2 is a front elevational view of the perfume burner shown in FIG. 1;

FIG. 3 is a rear elevational view of the perfume burner shown in FIG. 1 and FIG. 2;

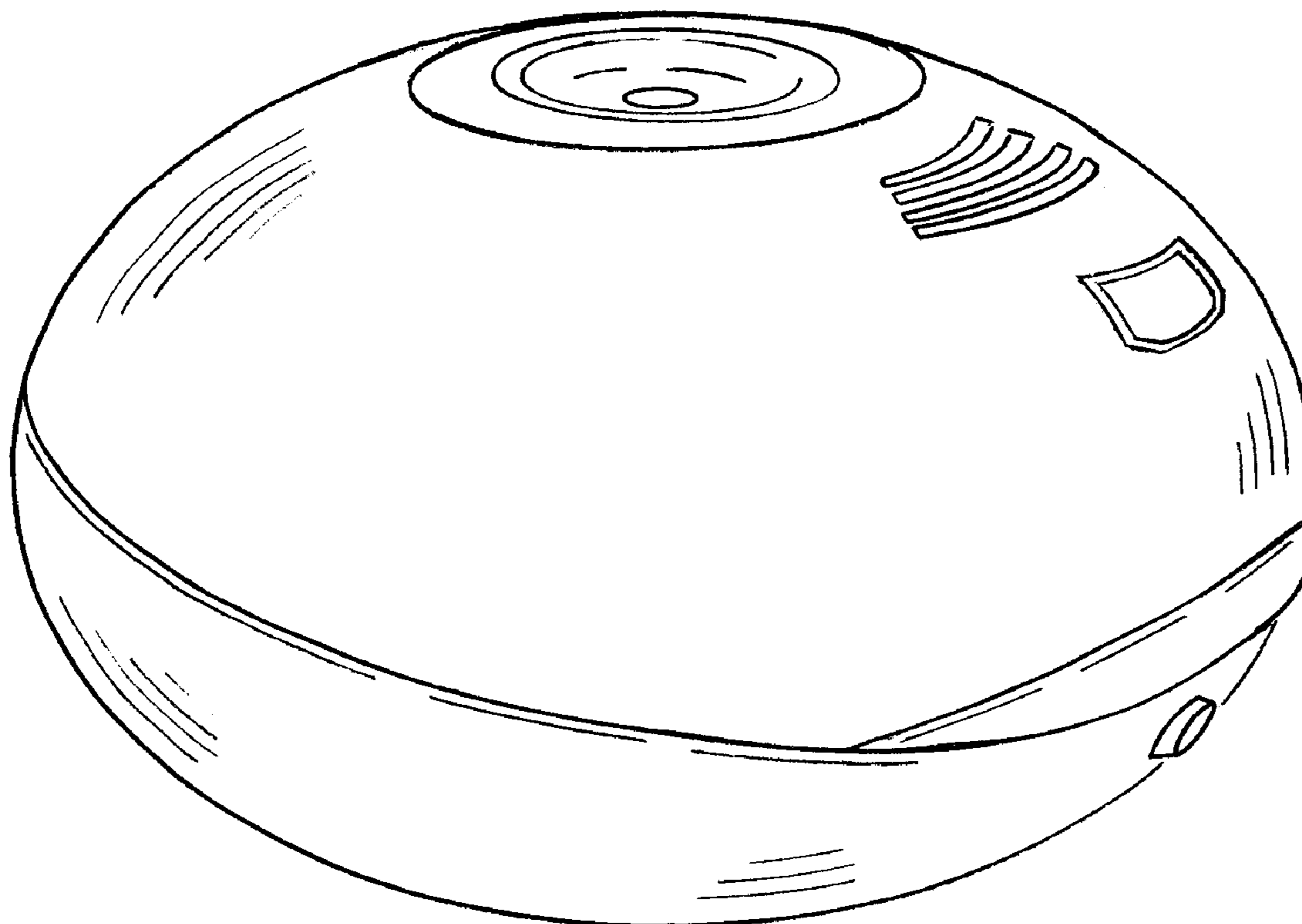
FIG. 4 is a side elevational view of the perfume burner shown in FIG. 1, FIG. 2, and FIG. 3;

FIG. 5 is another side elevational view of the perfume burner shown in FIG. 1, FIG. 2, FIG. 3, and FIG. 4;

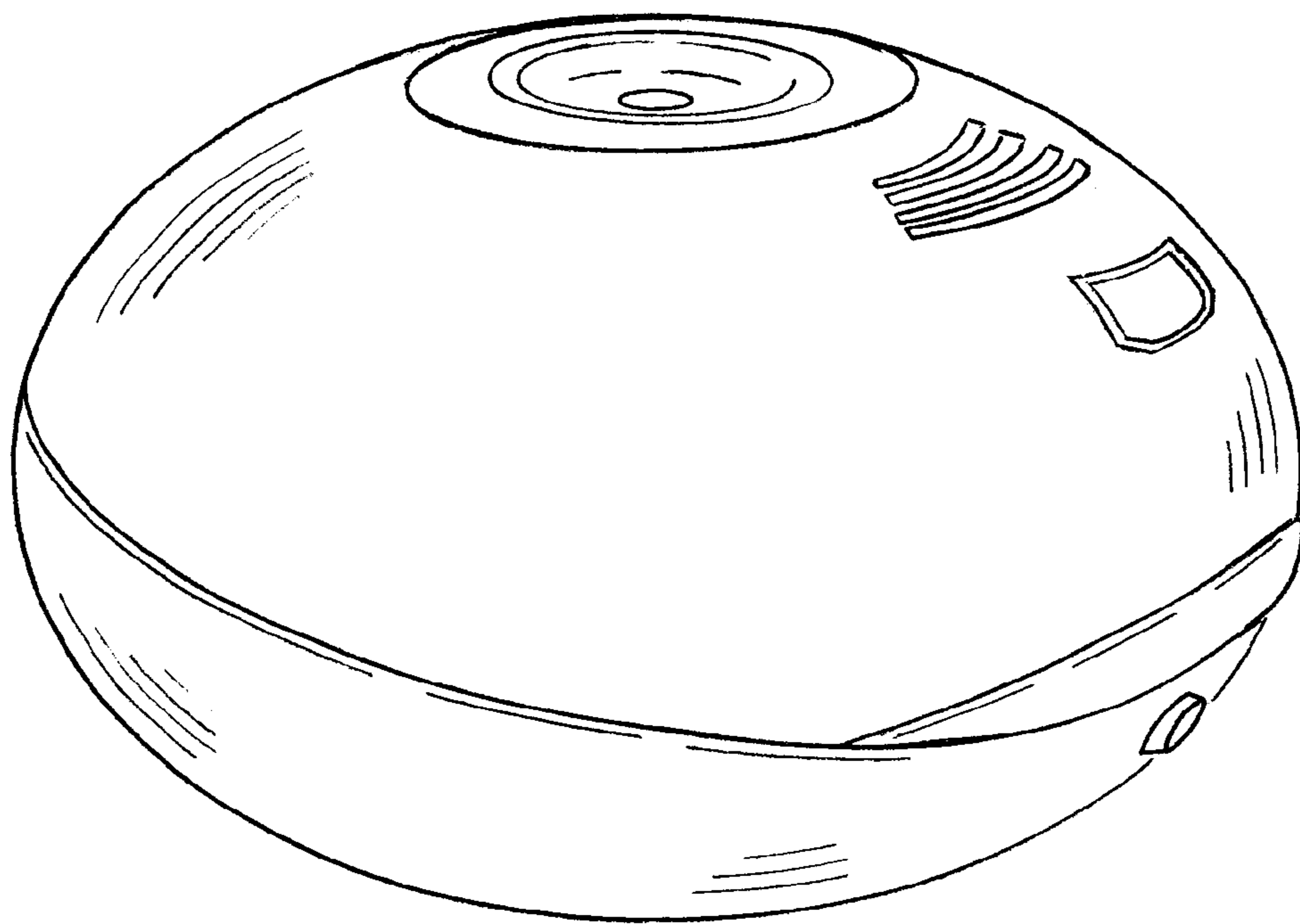

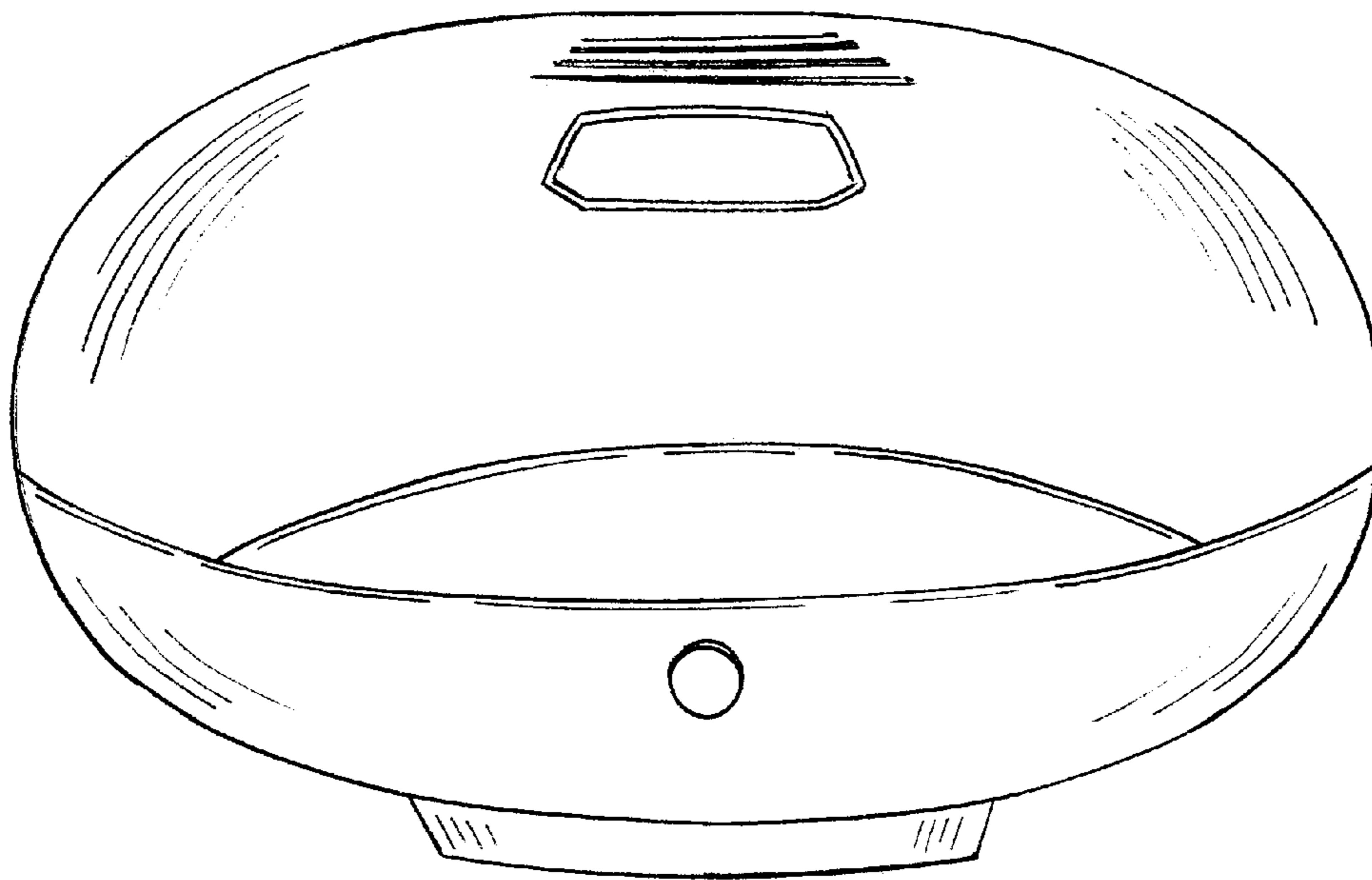

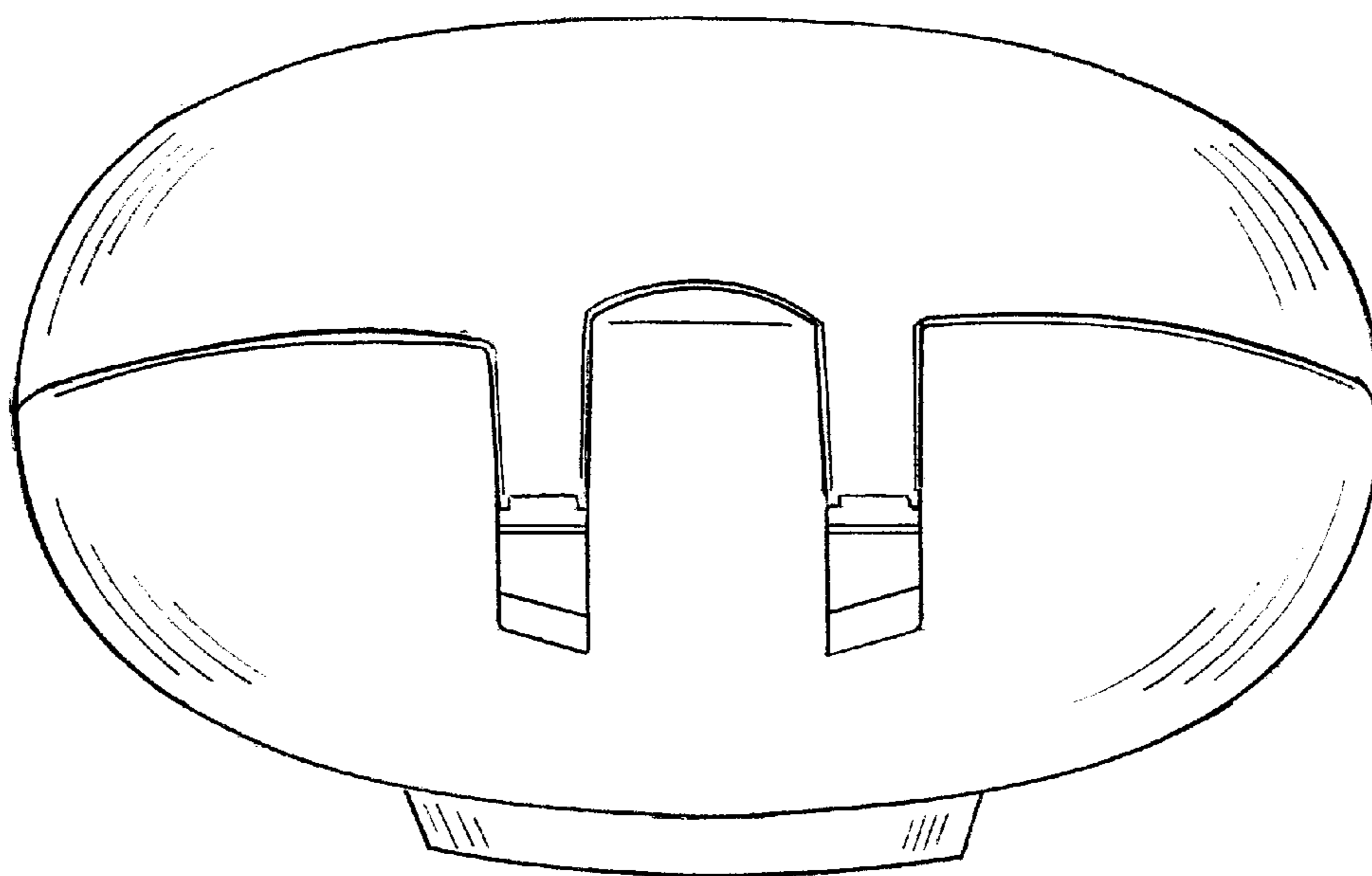

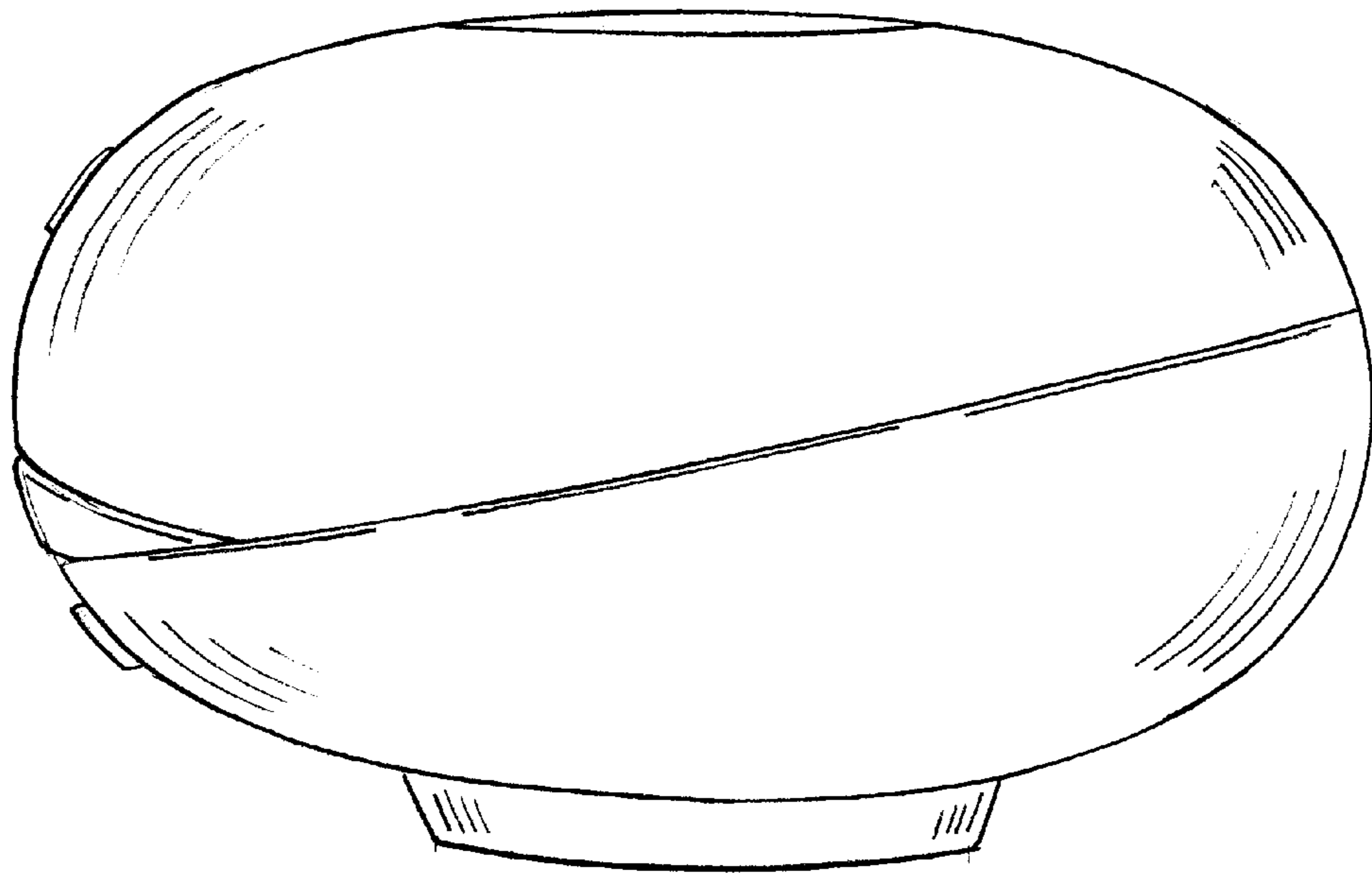

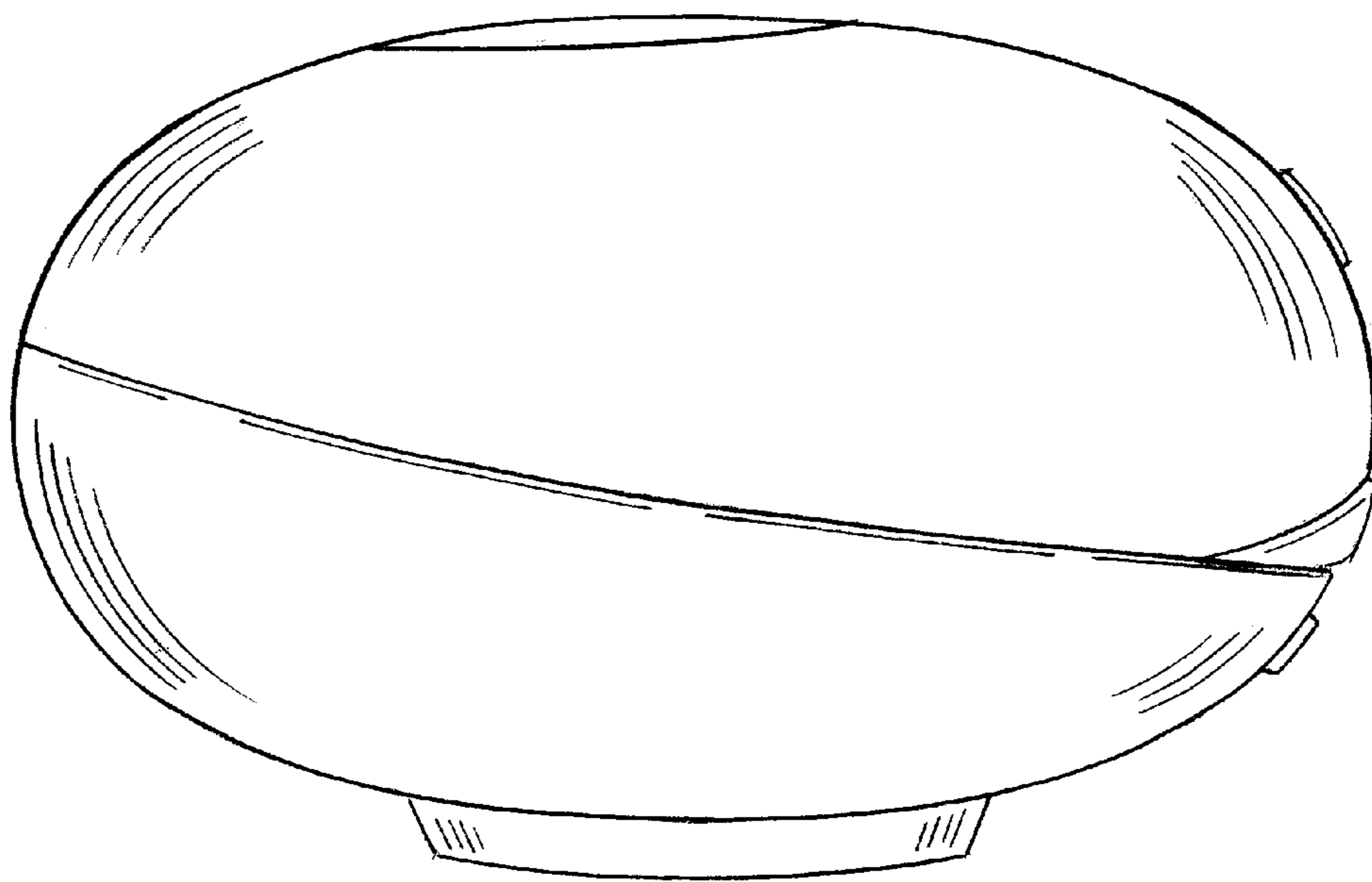

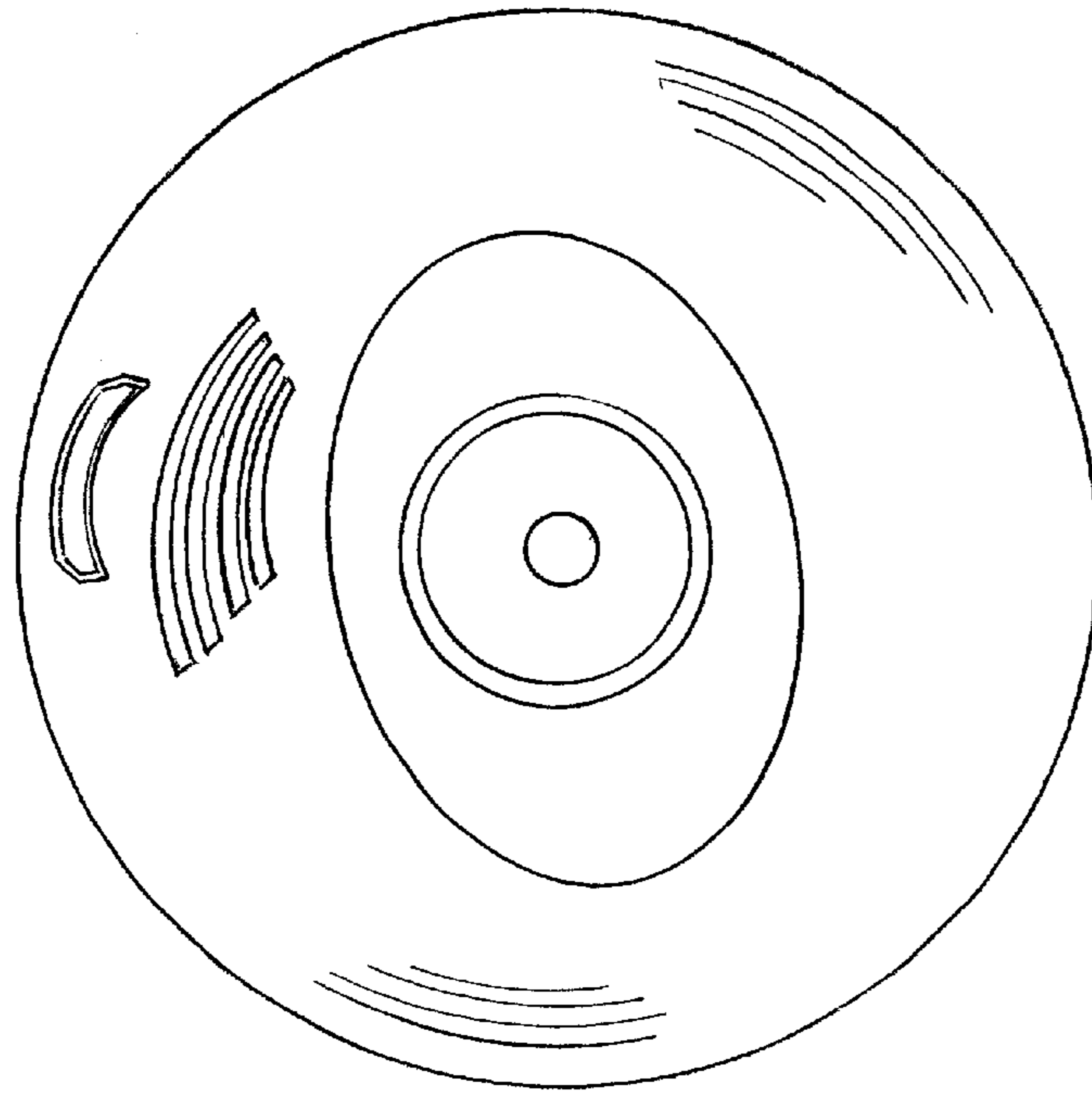

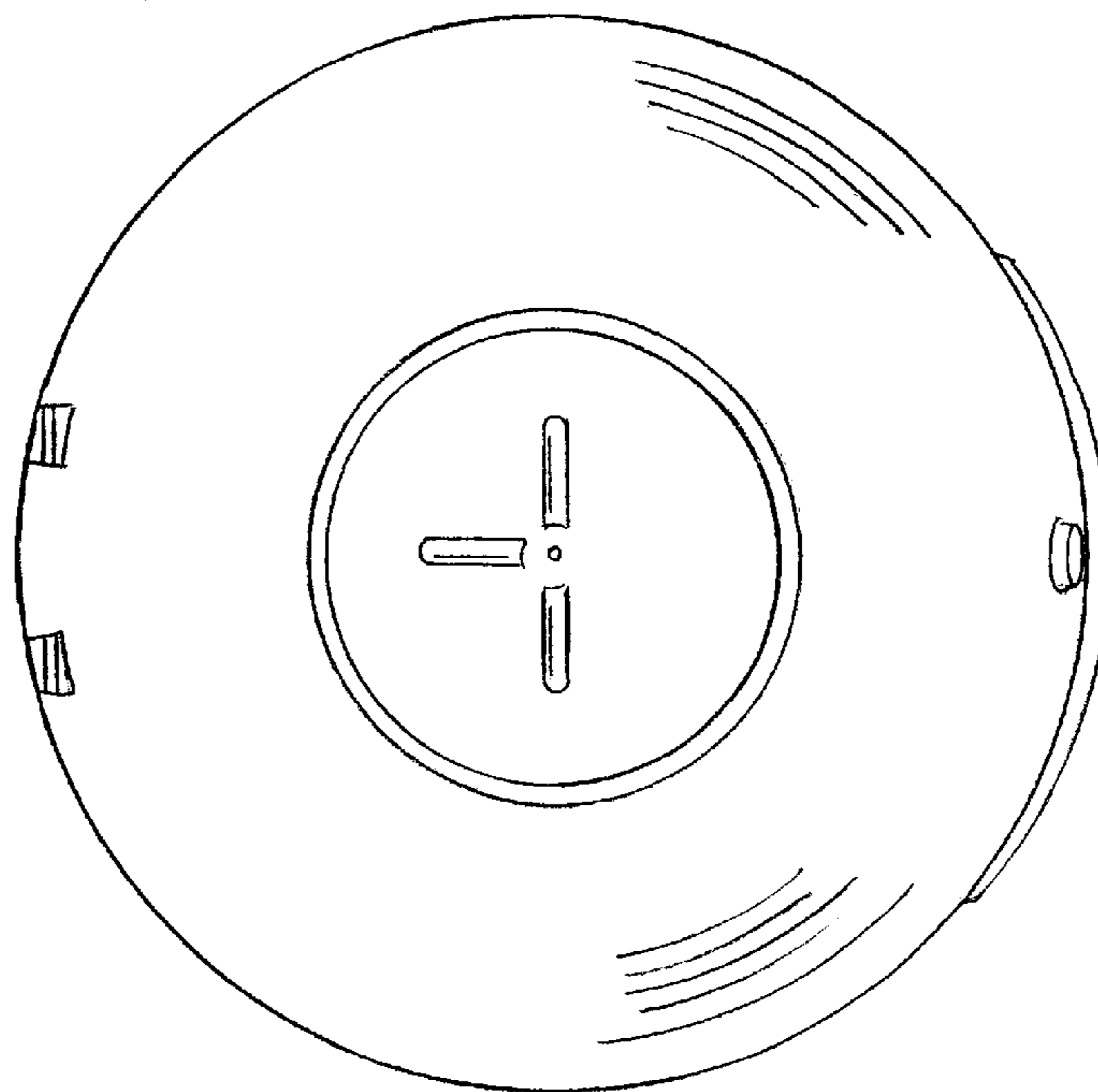
