DESCRIPTION

the spotlight cylinder showing a first embodiment of our
new design;

FIG. 11 is a left side view of the design shown in FIG. 8;

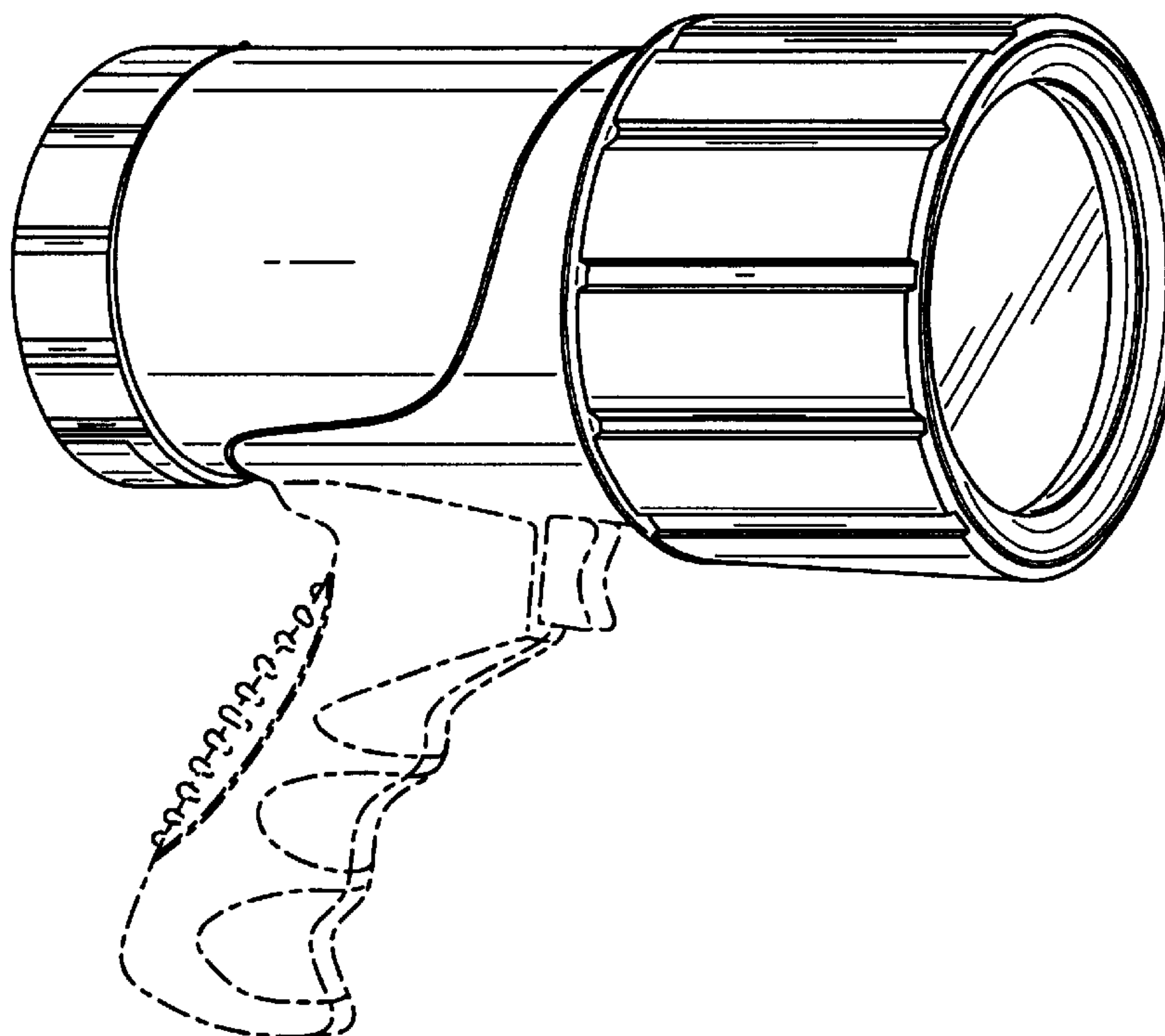
FIG. 12 is a right side view of the design shown in FIG. 8;

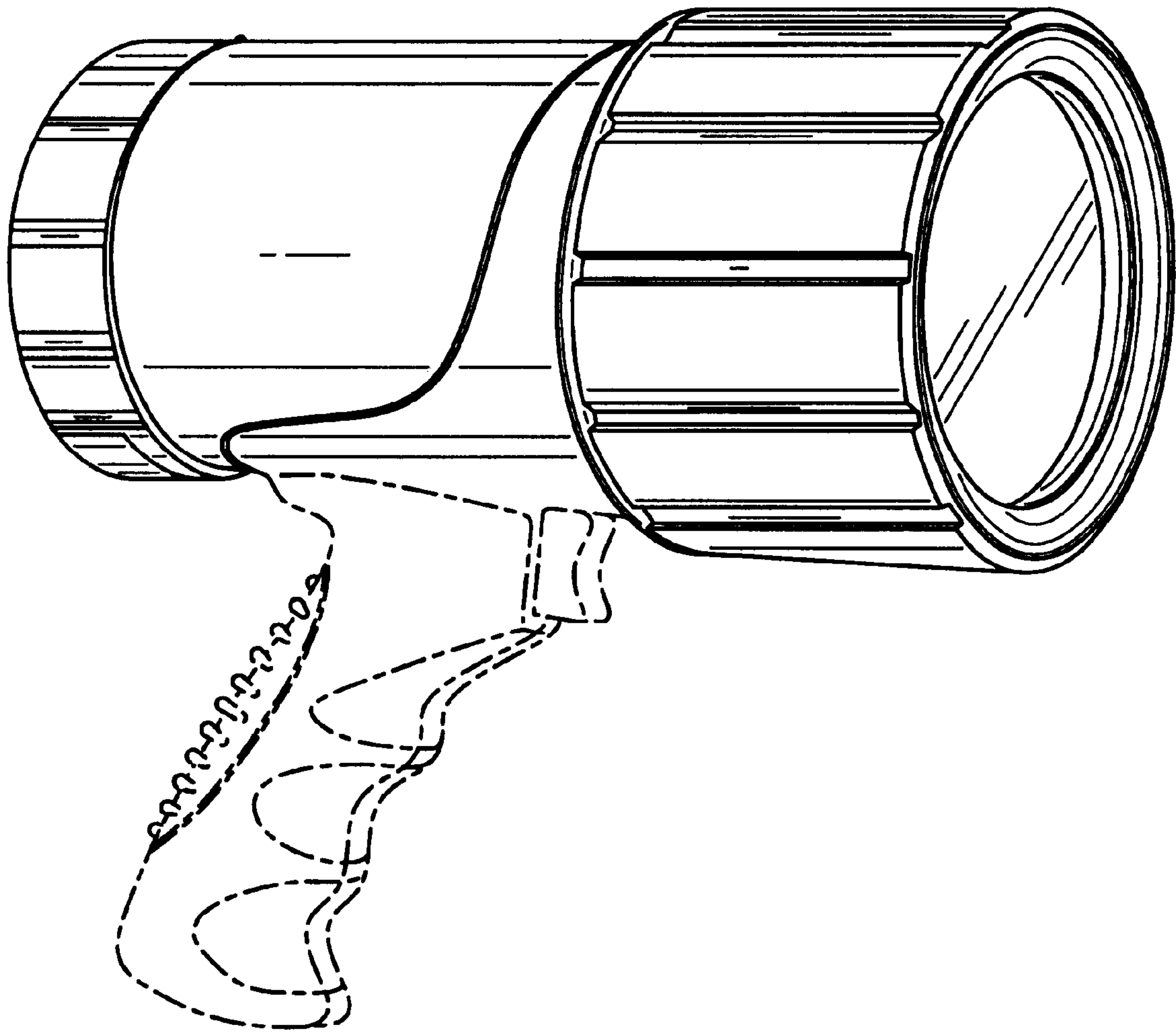

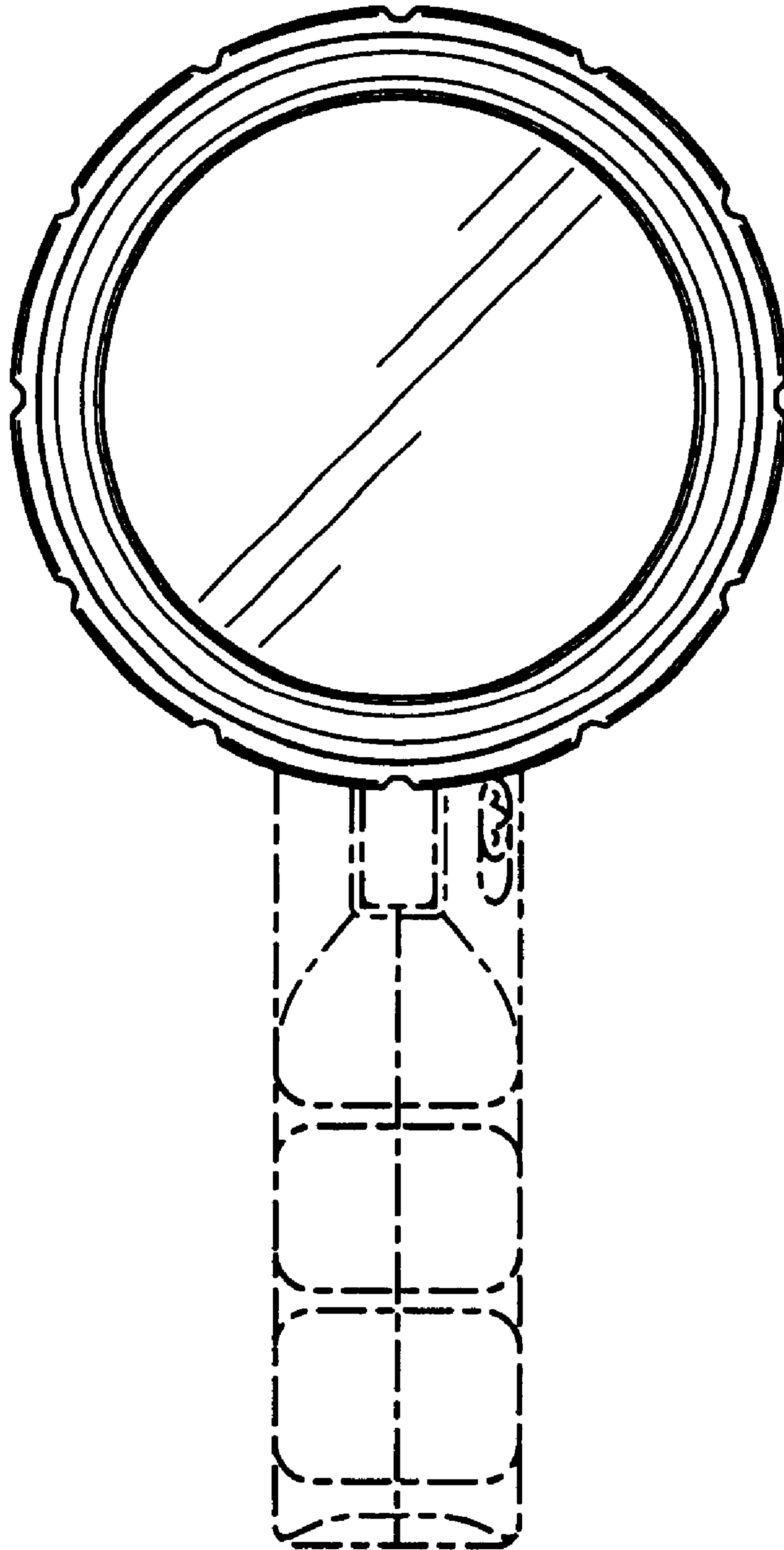

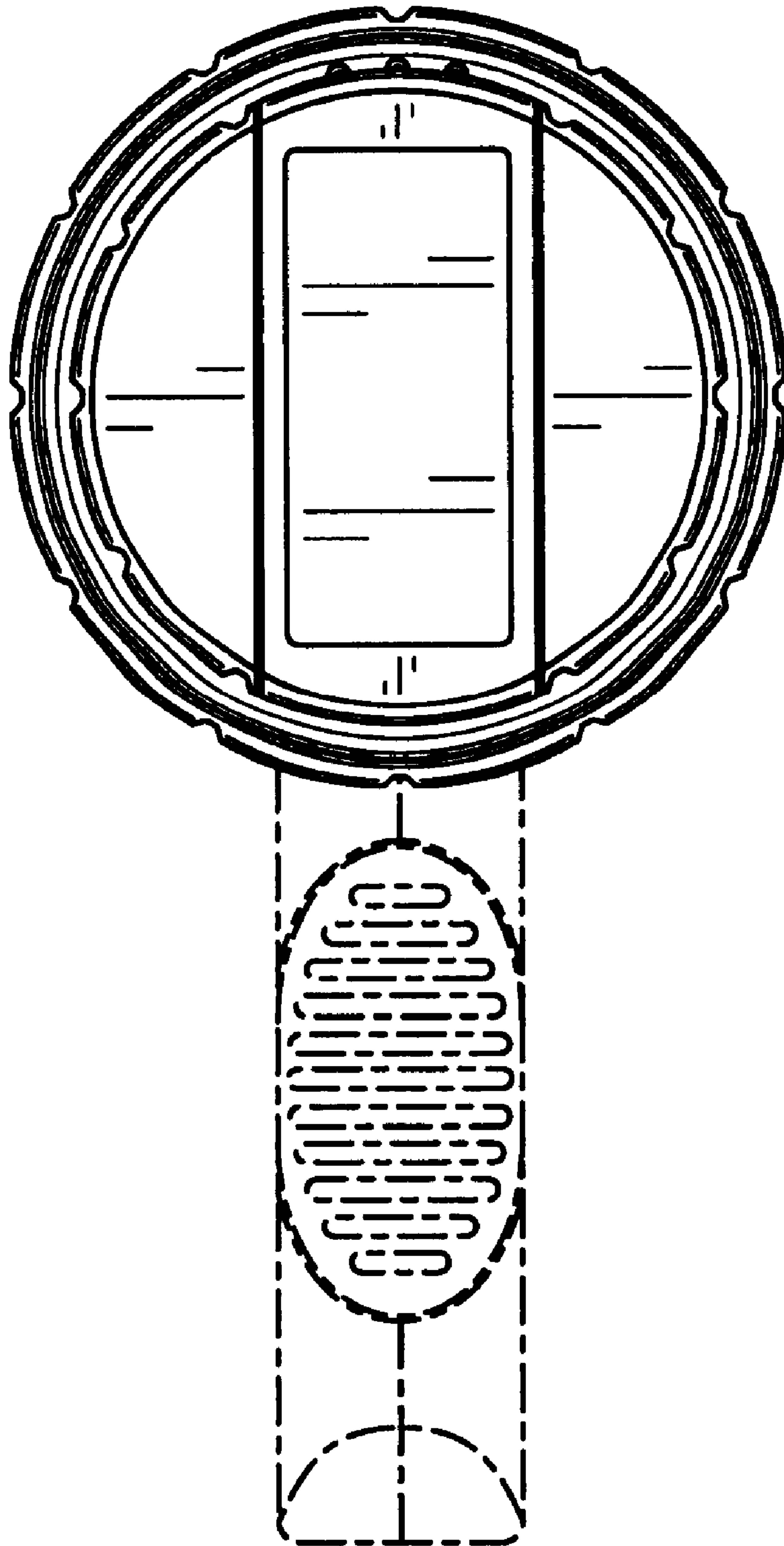

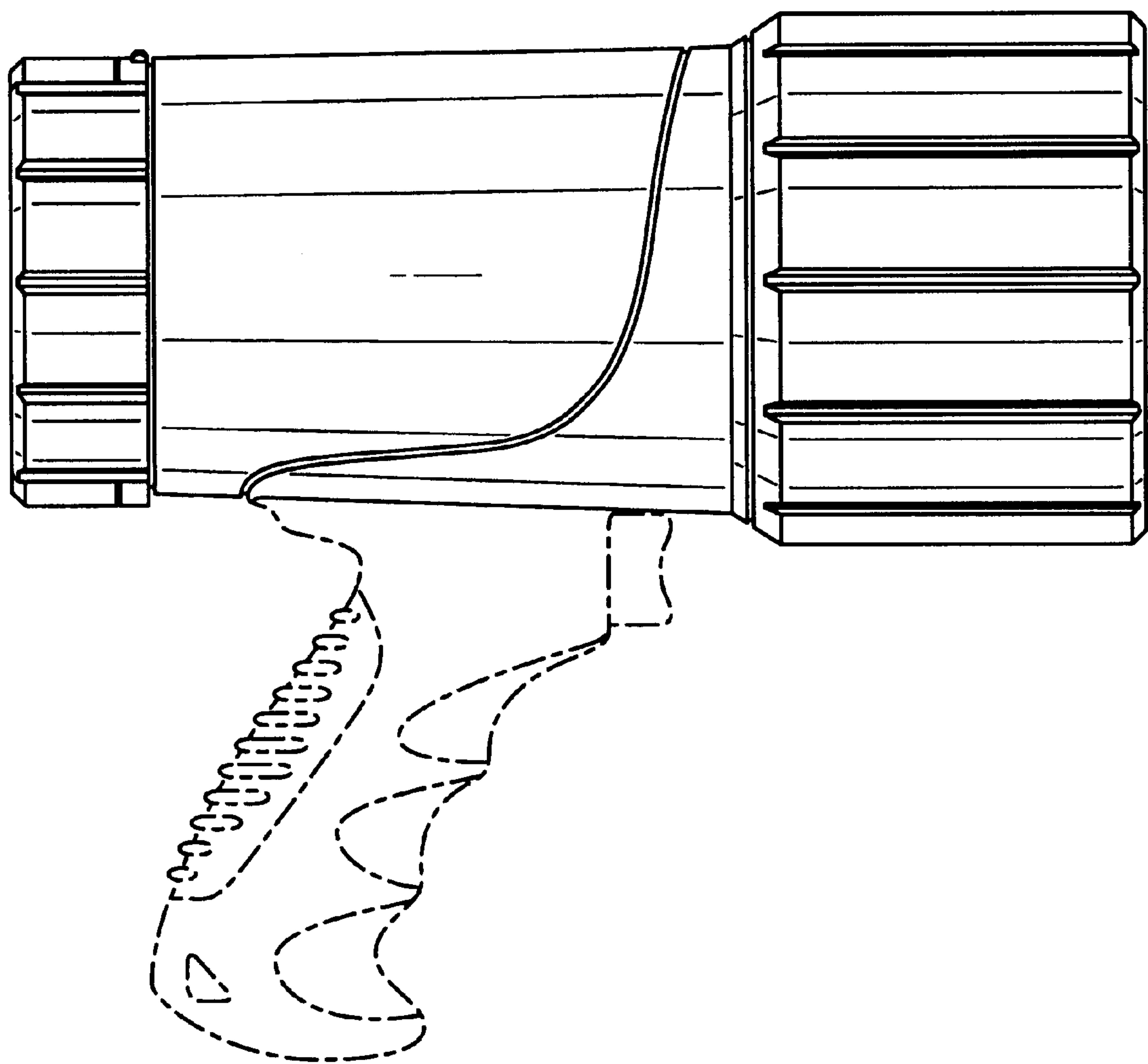

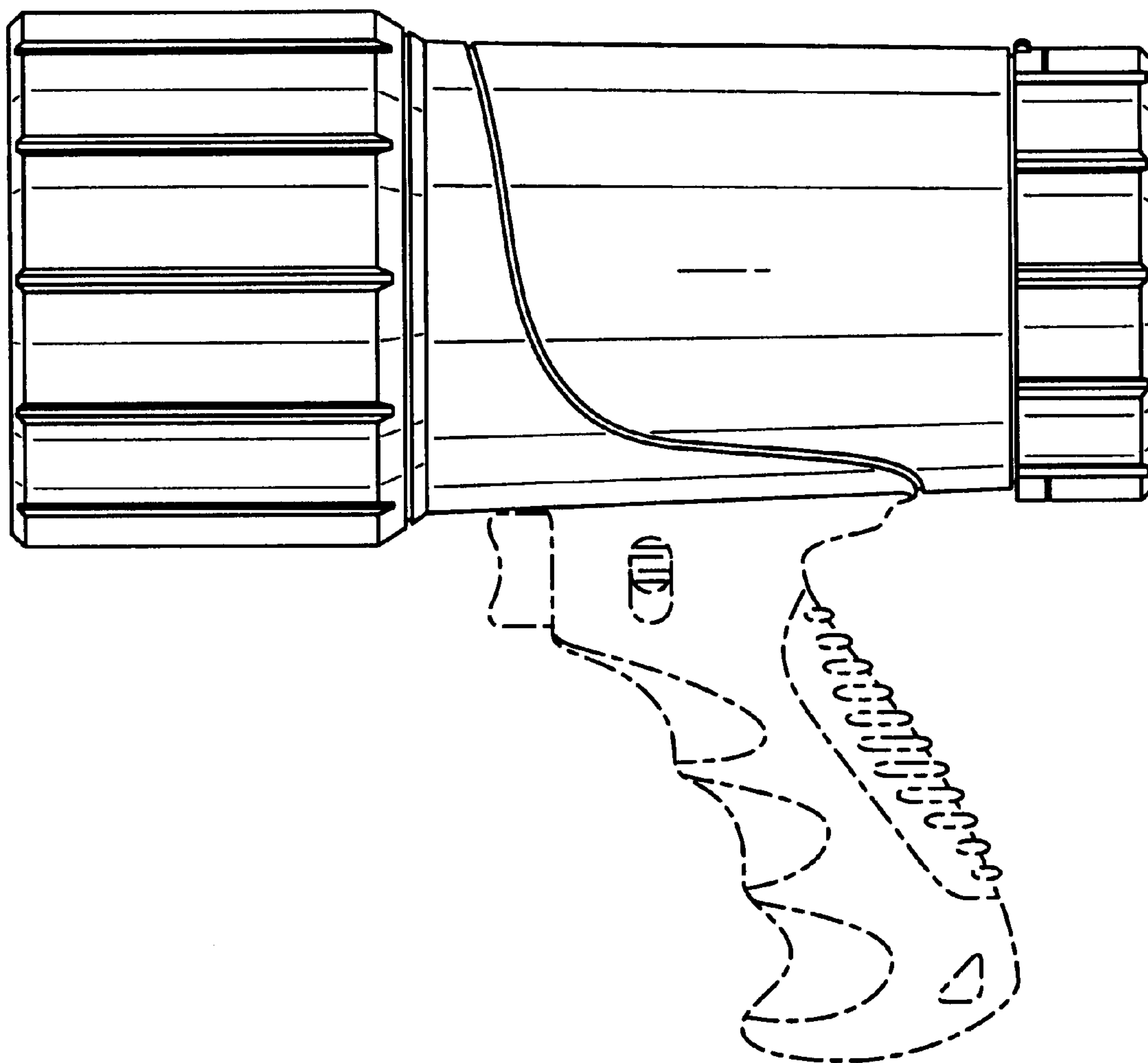

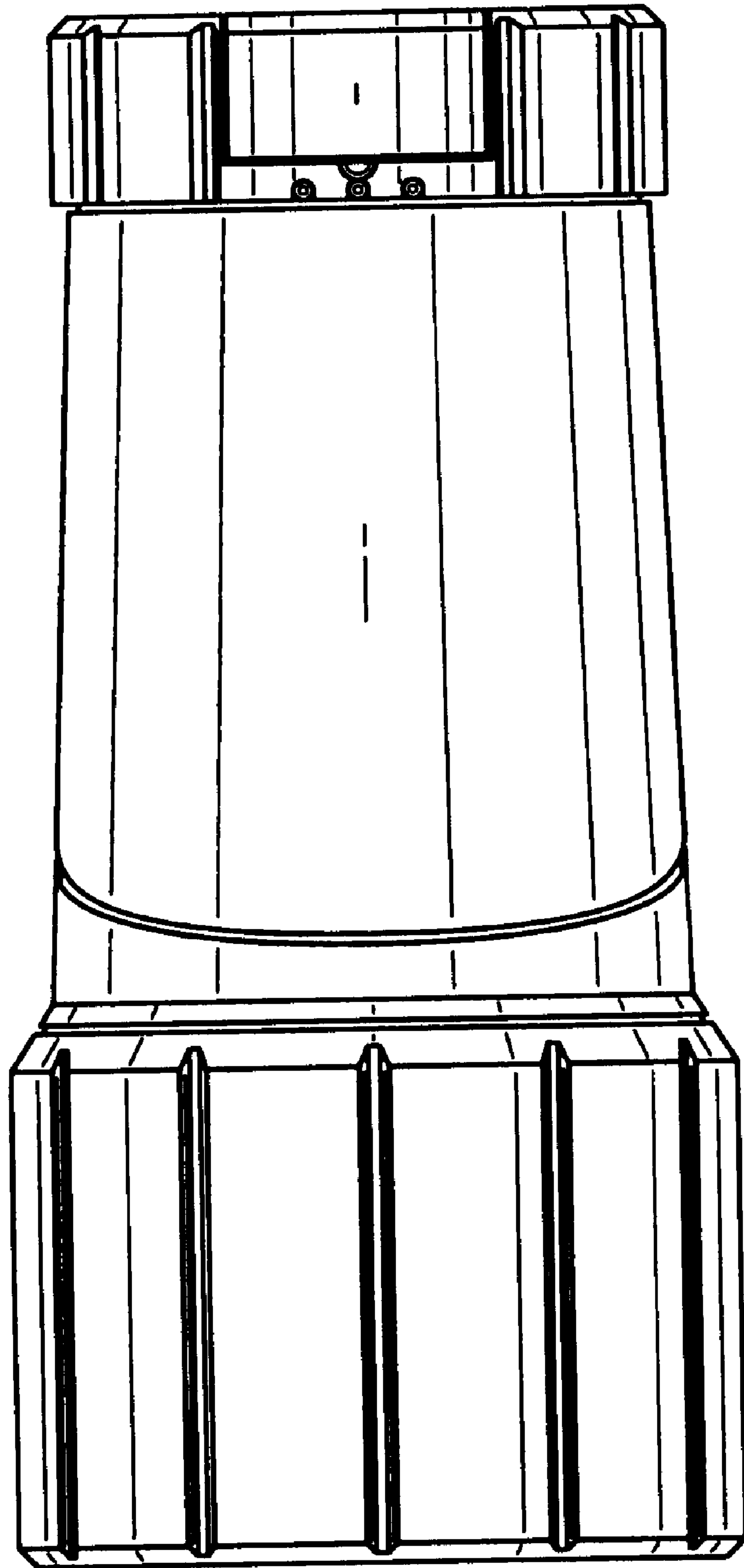

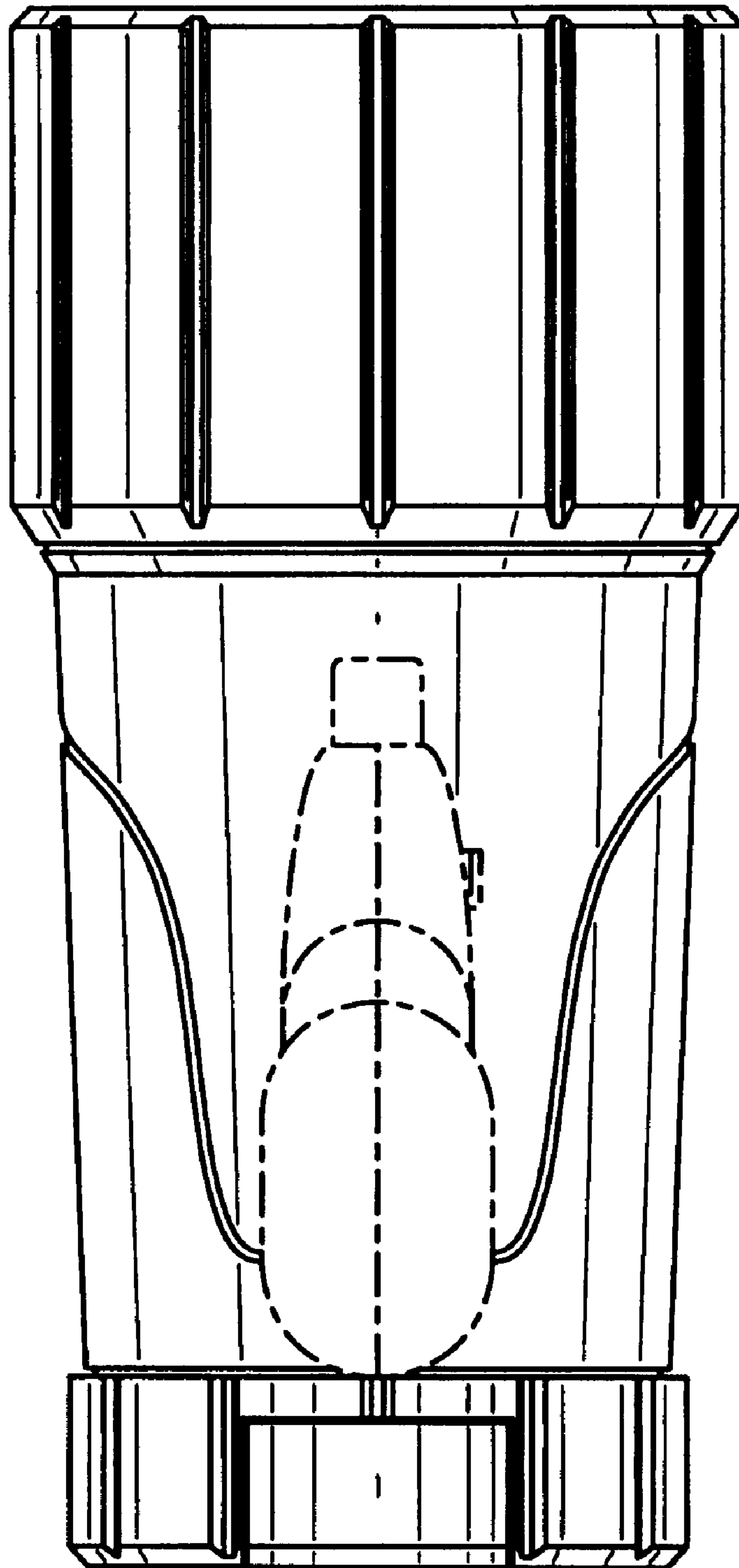

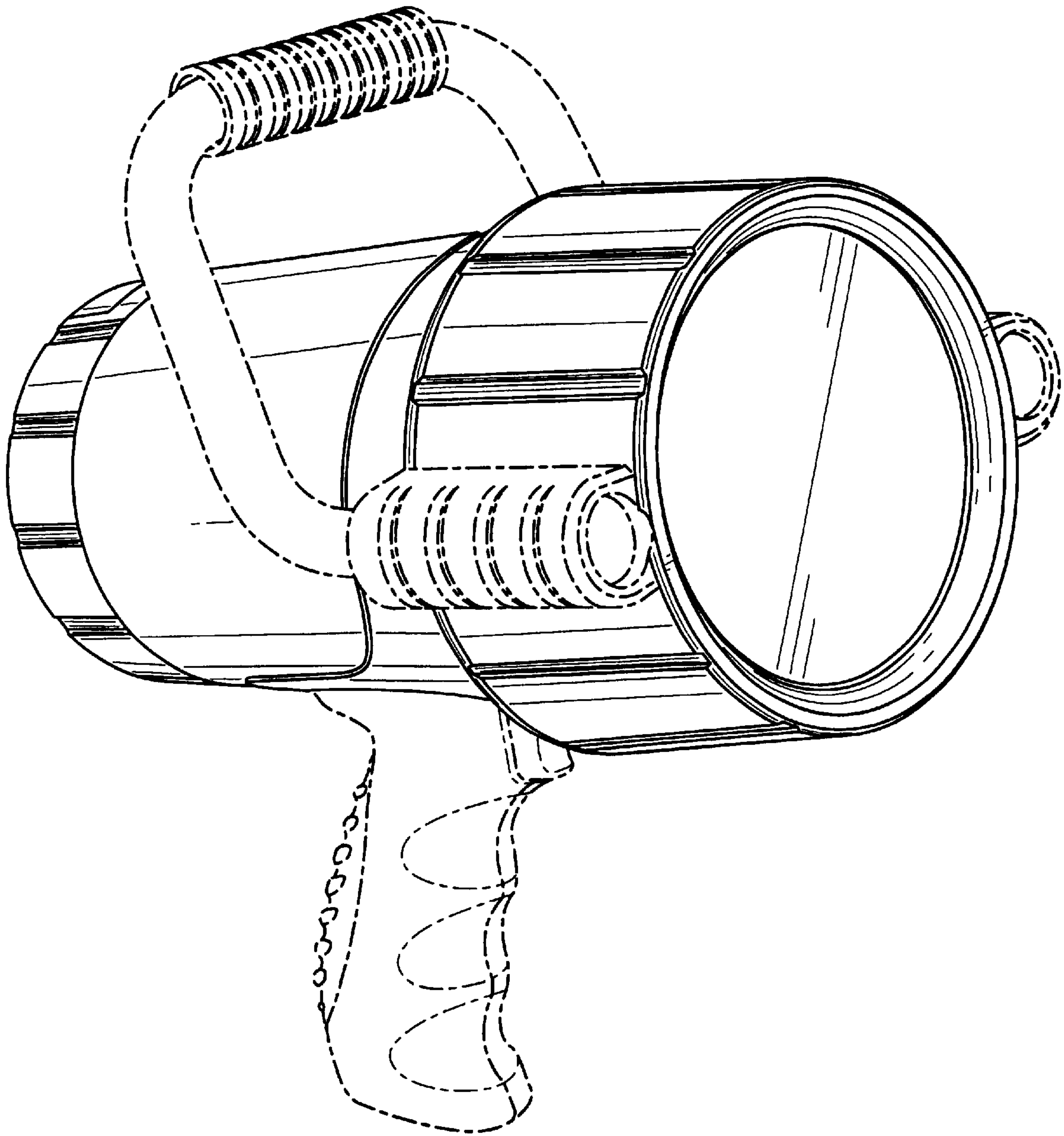

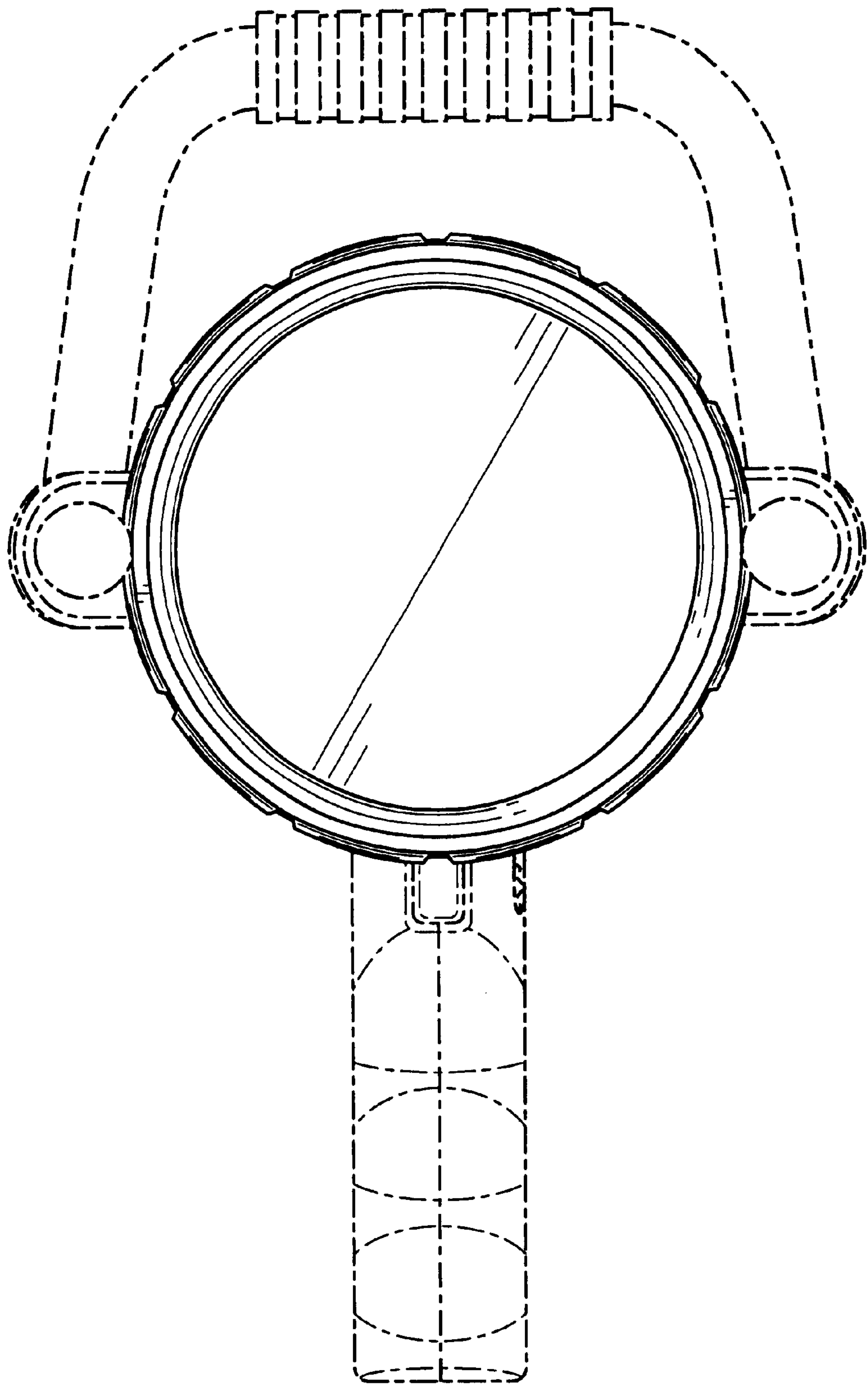

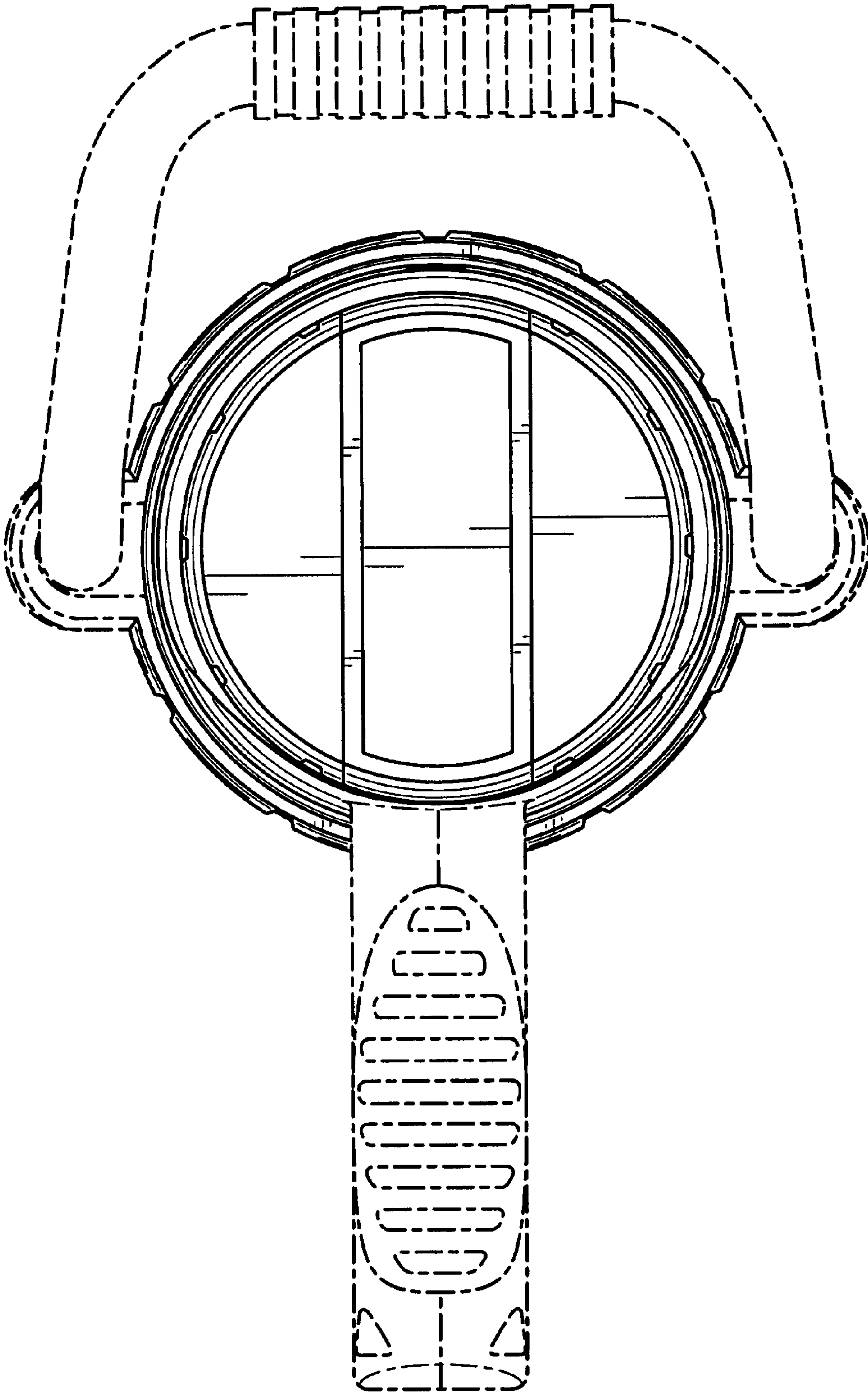

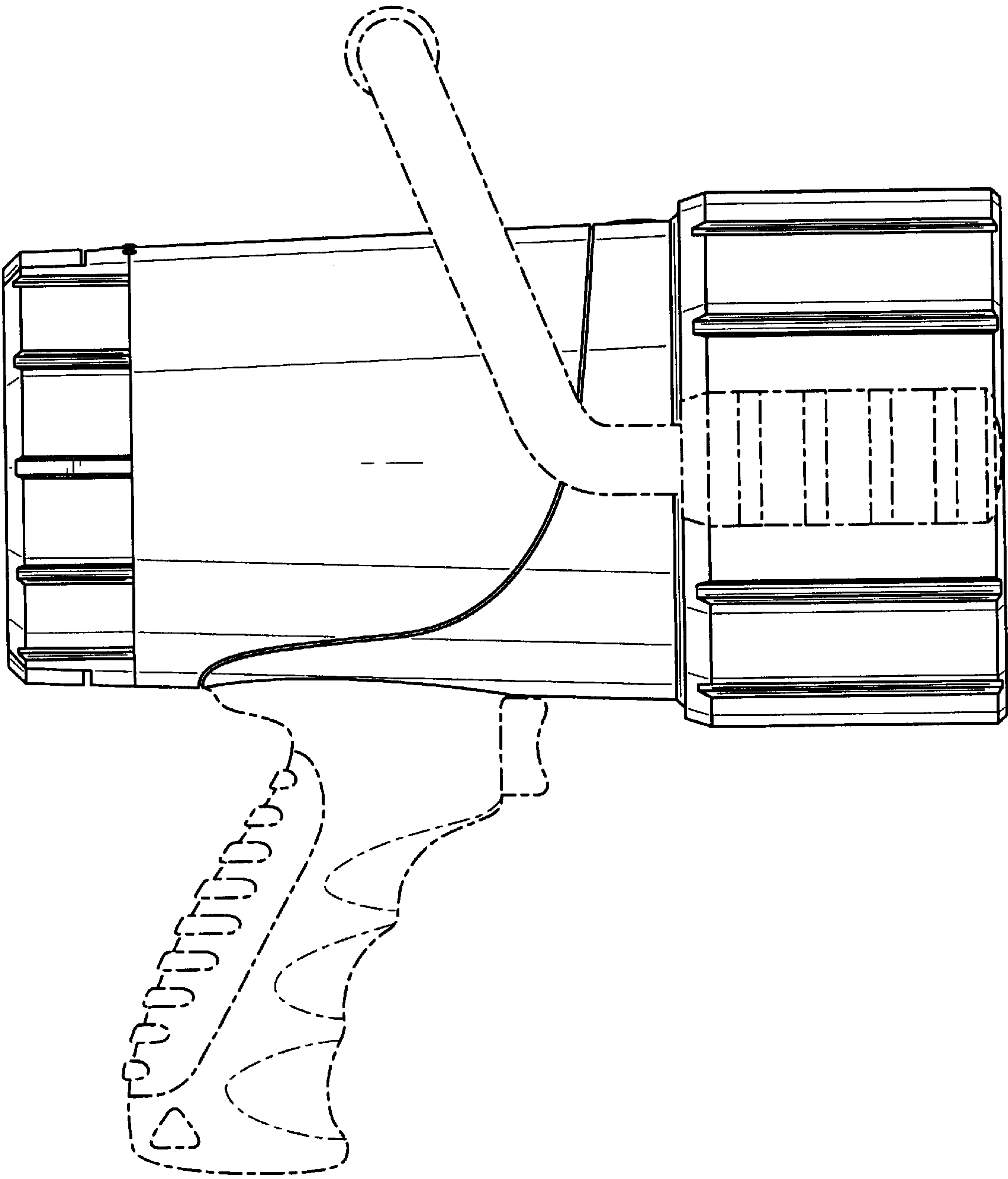

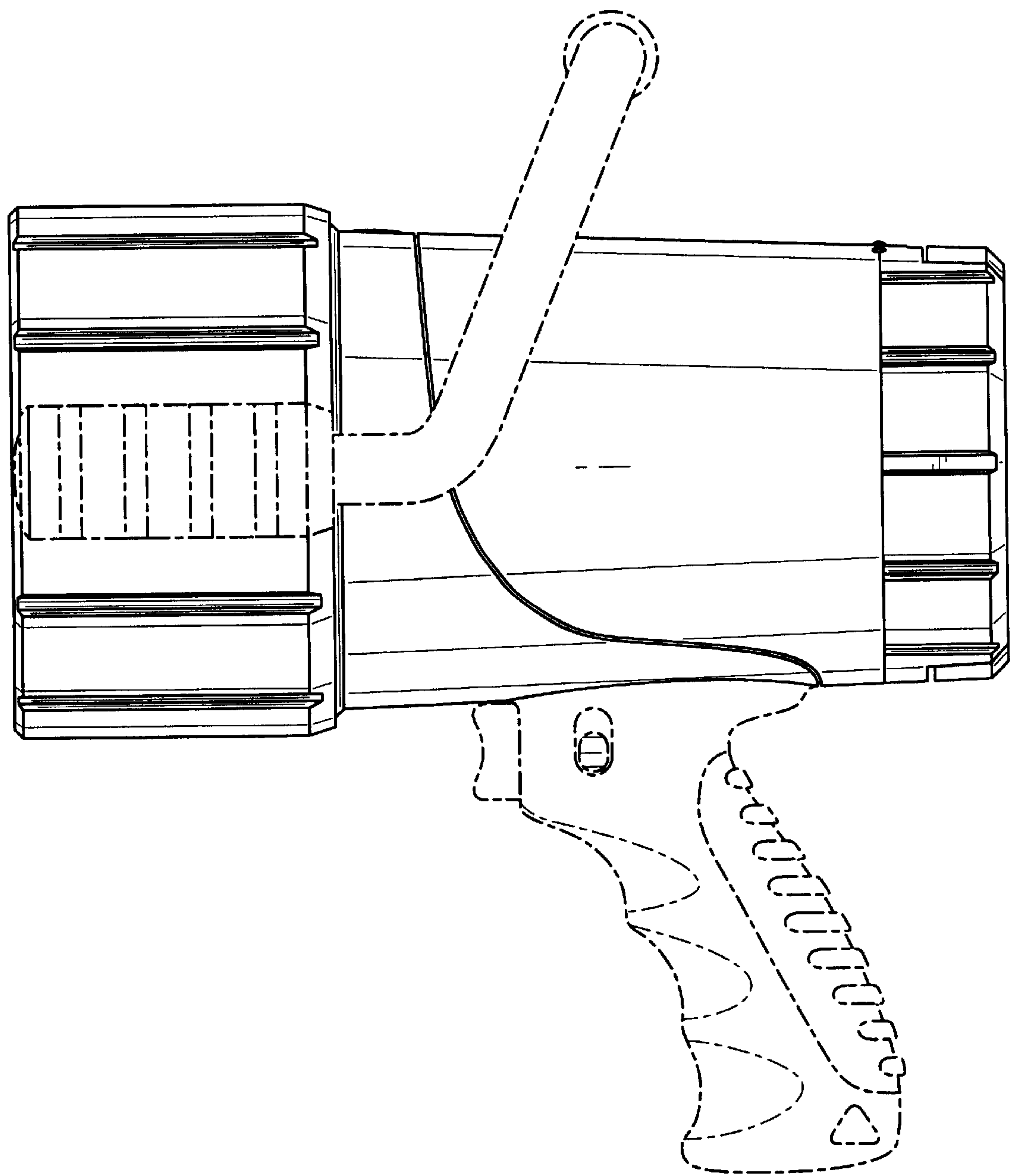

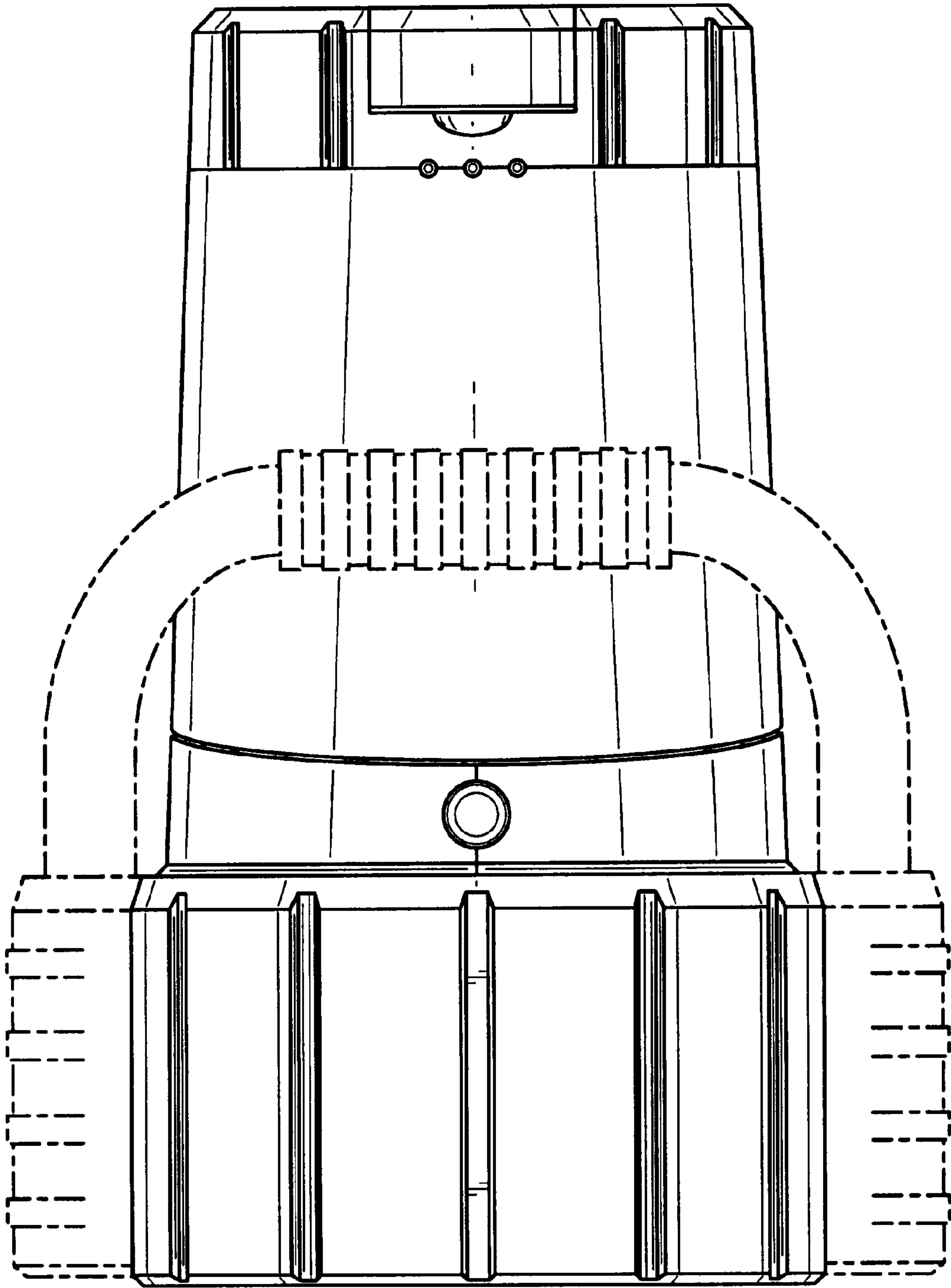

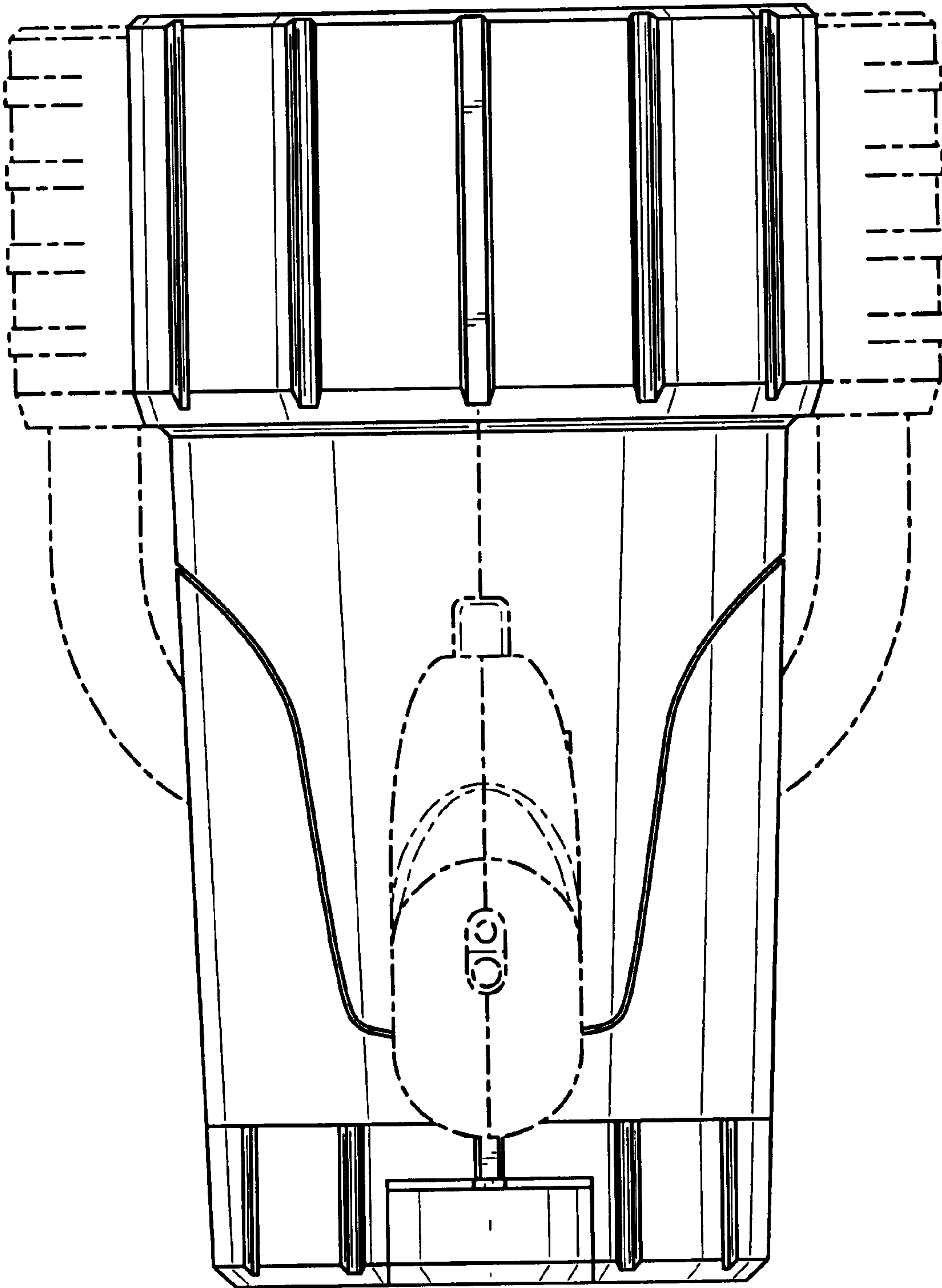
