DESCRIPTION

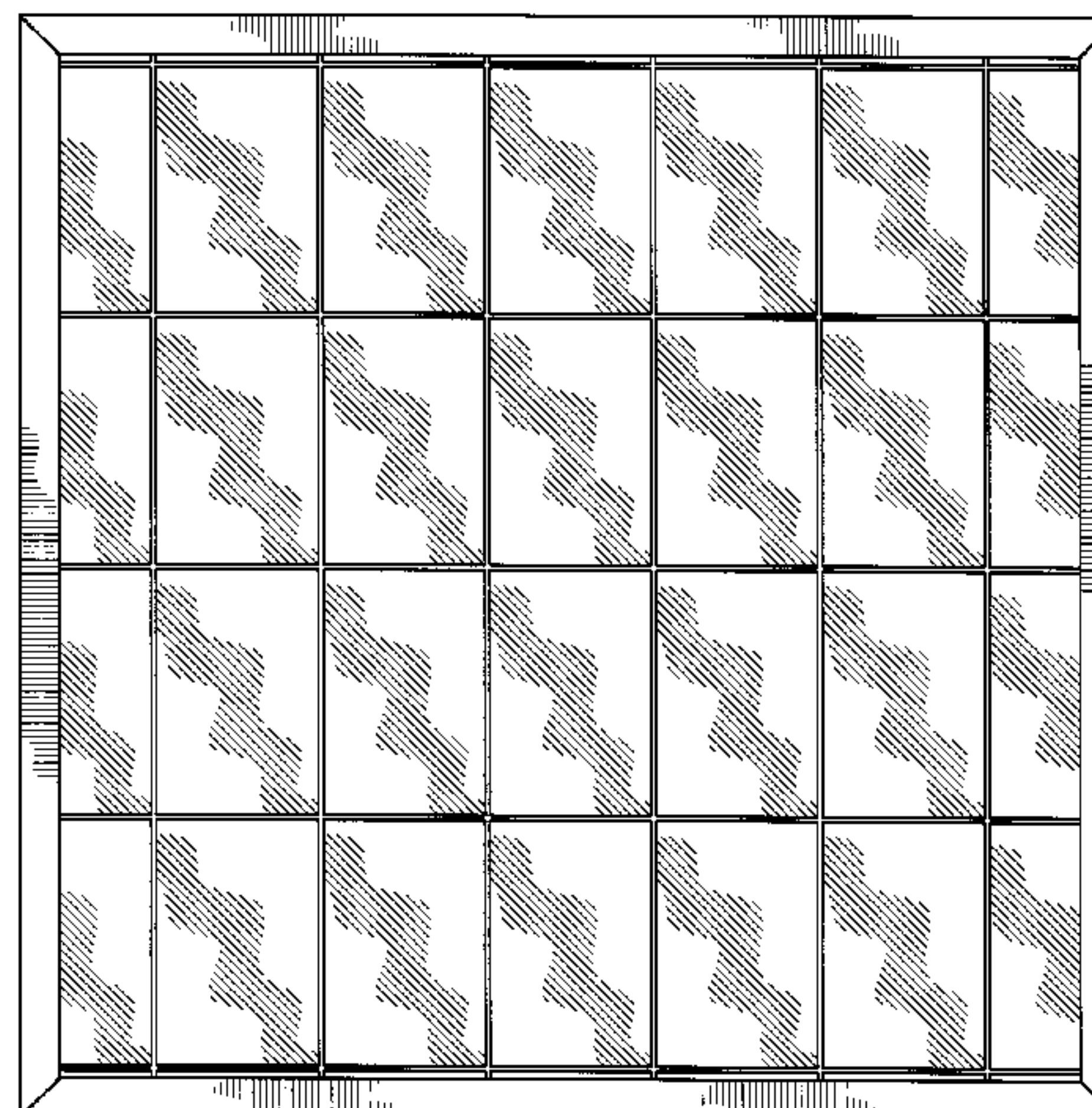
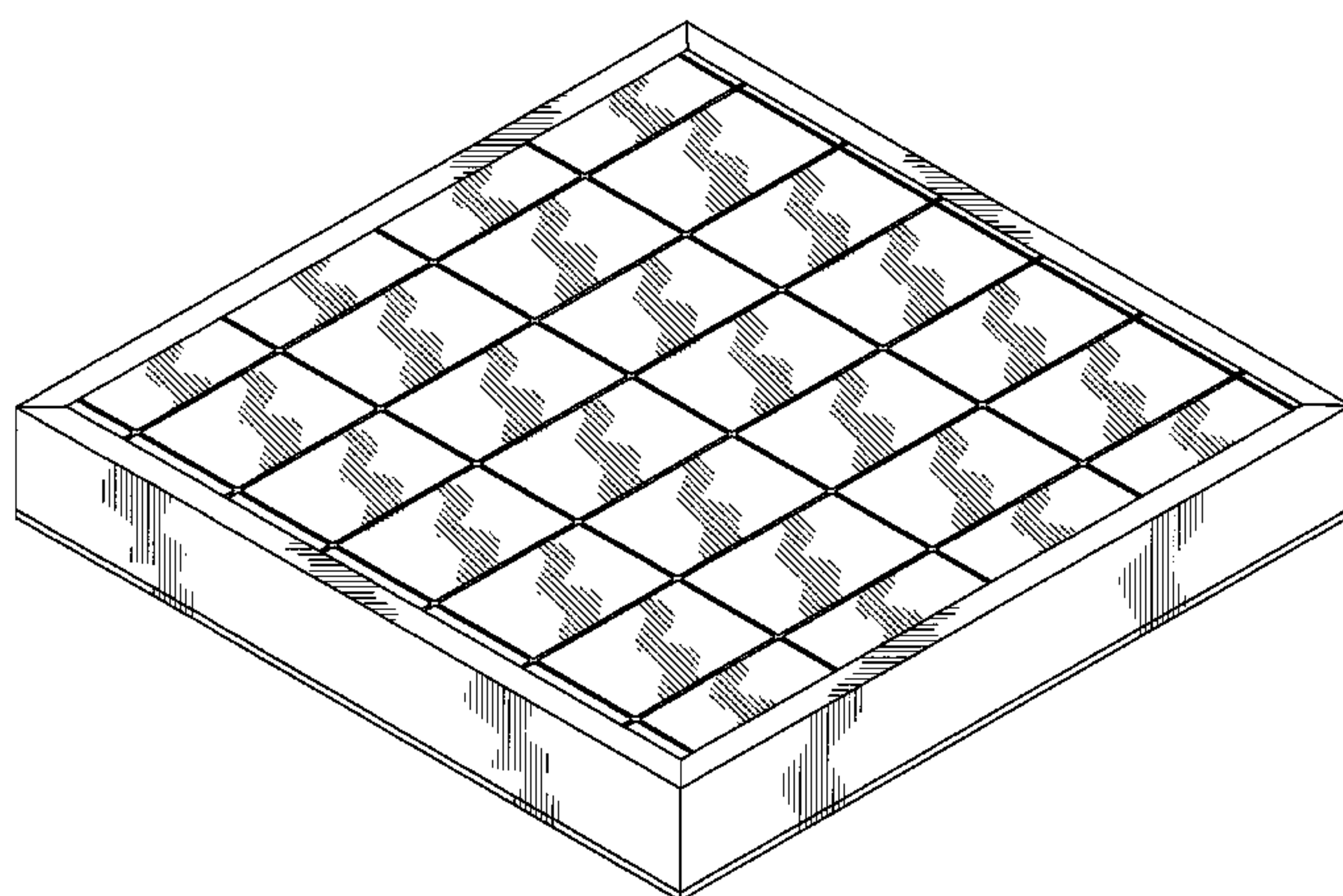
FIG. 1 is a perspective view of a light fixture incorporating a lens showing my new design;

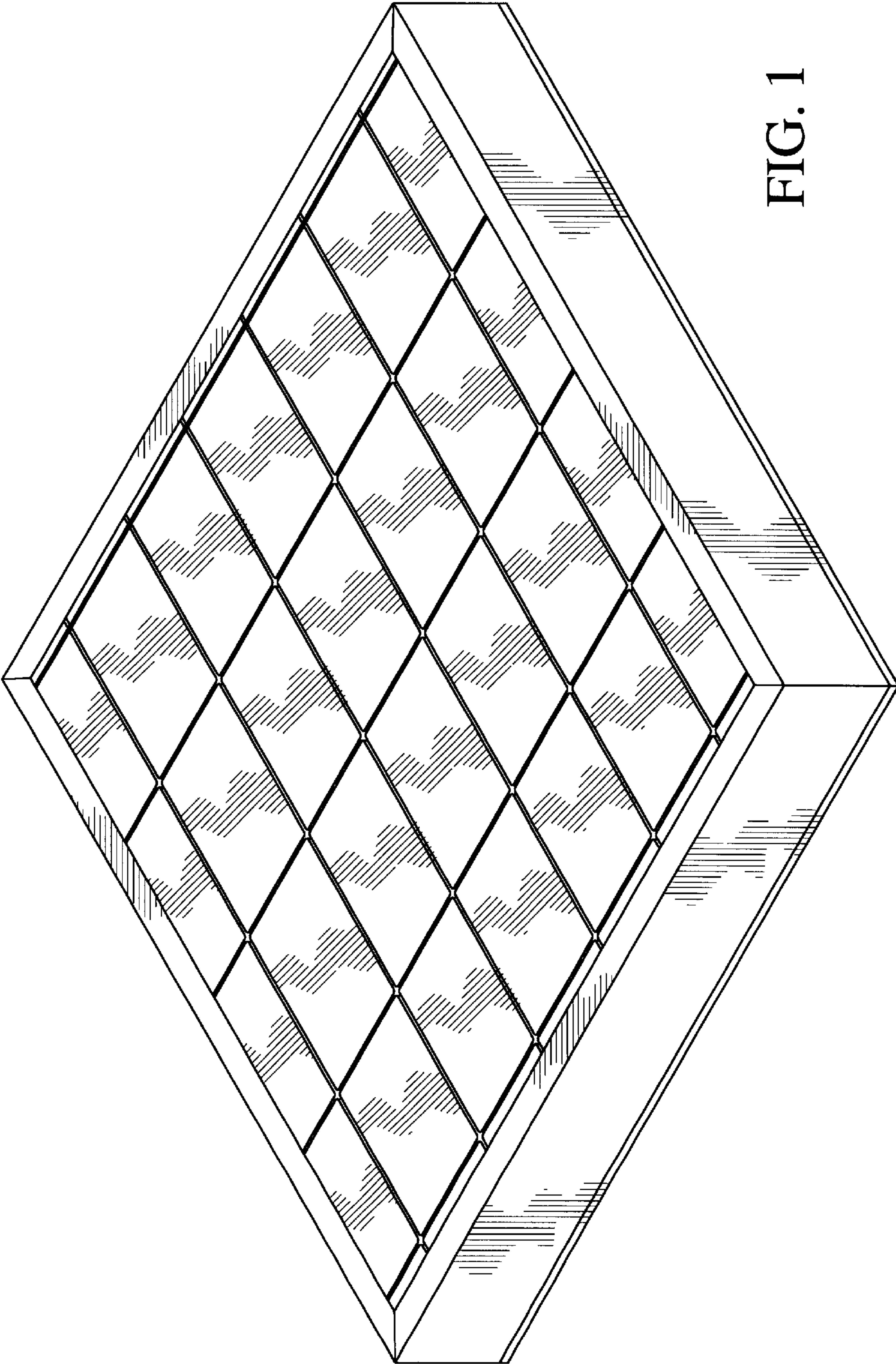

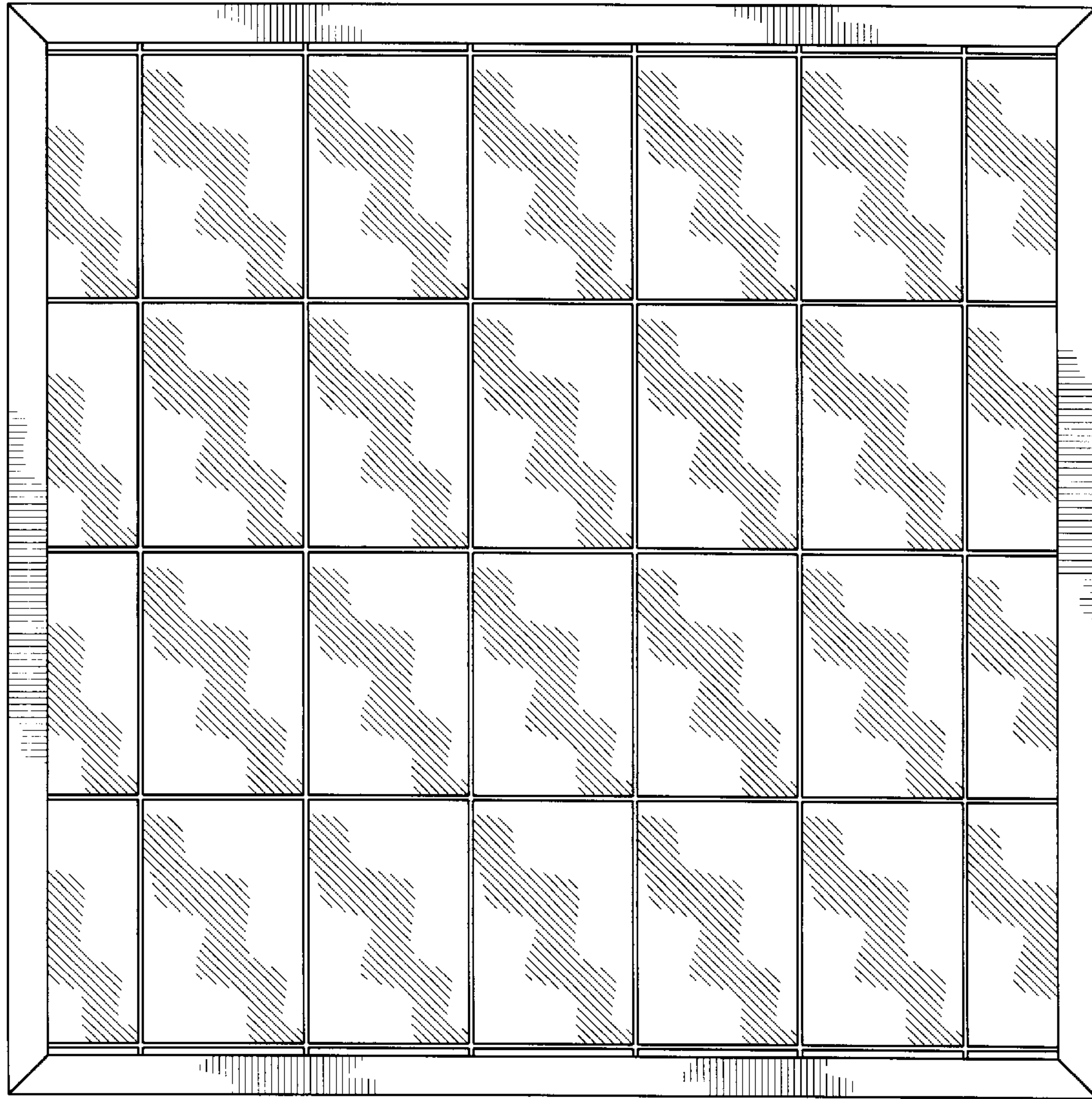

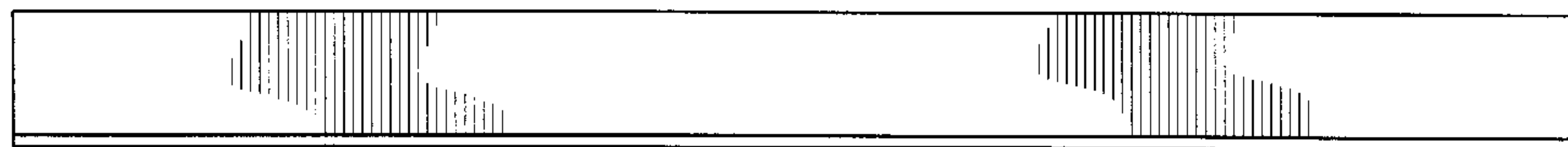
