The ornamental design for a fire extinguisher holder, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a fire extinguisher holder showing a new design with the rear elevational view being identical;

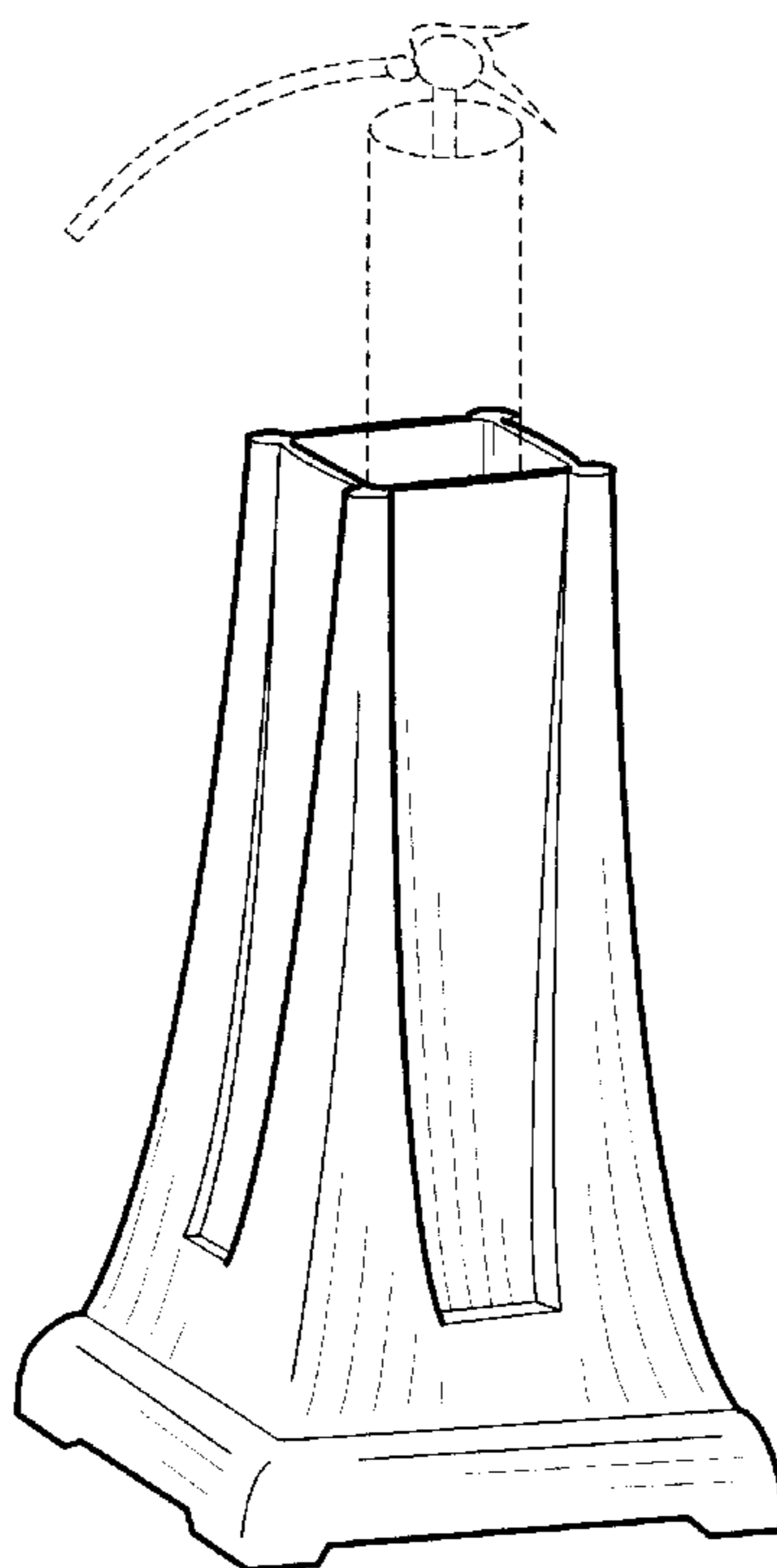
FIG. 2 is a top plan view thereof;

FIG. 3 is a first side elevational view thereof with the second side elevational view being identical;

FIG. 4 is a front and left side perspective view thereof; and, FIG. 5 is a top and front perspective view thereof.

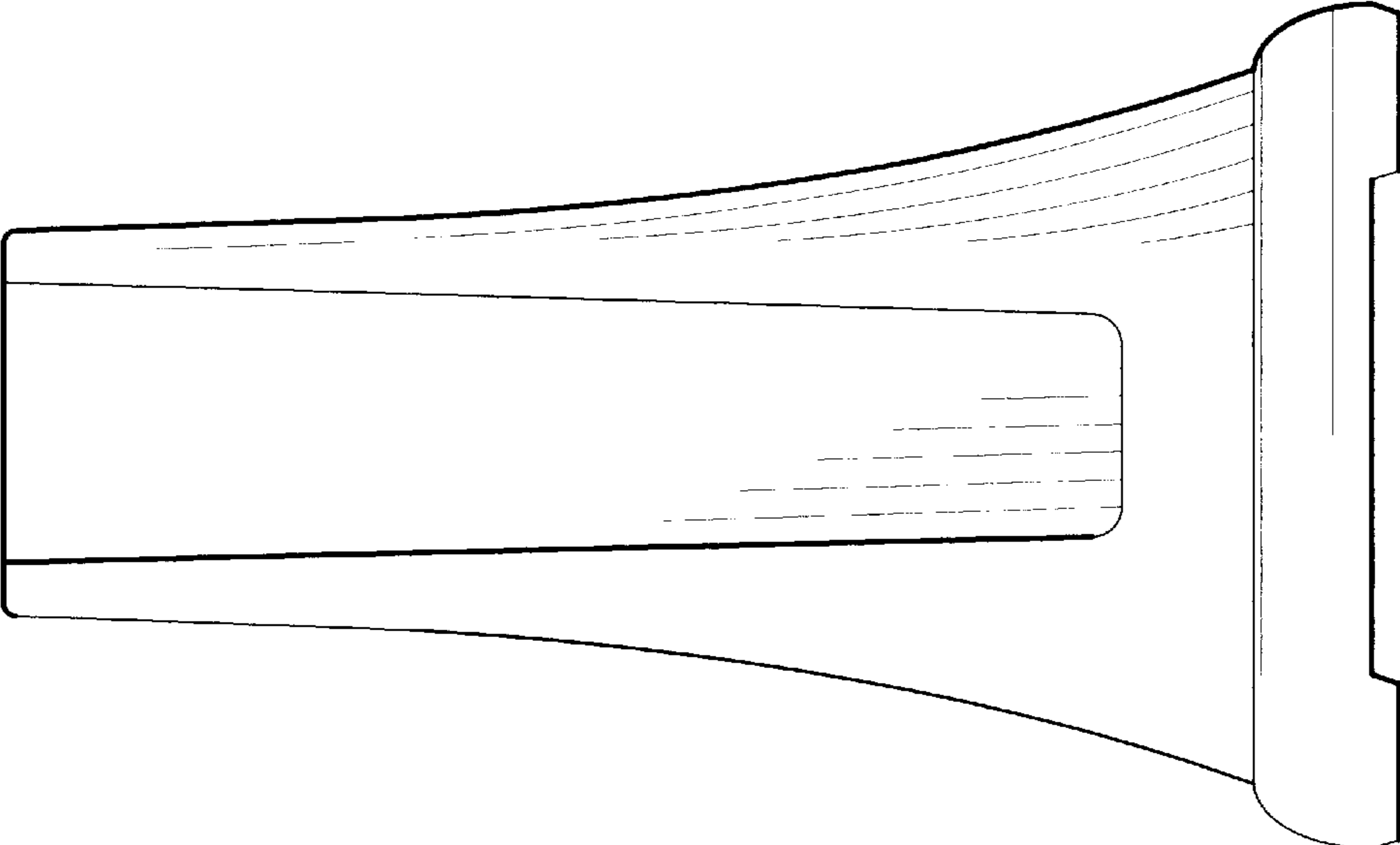

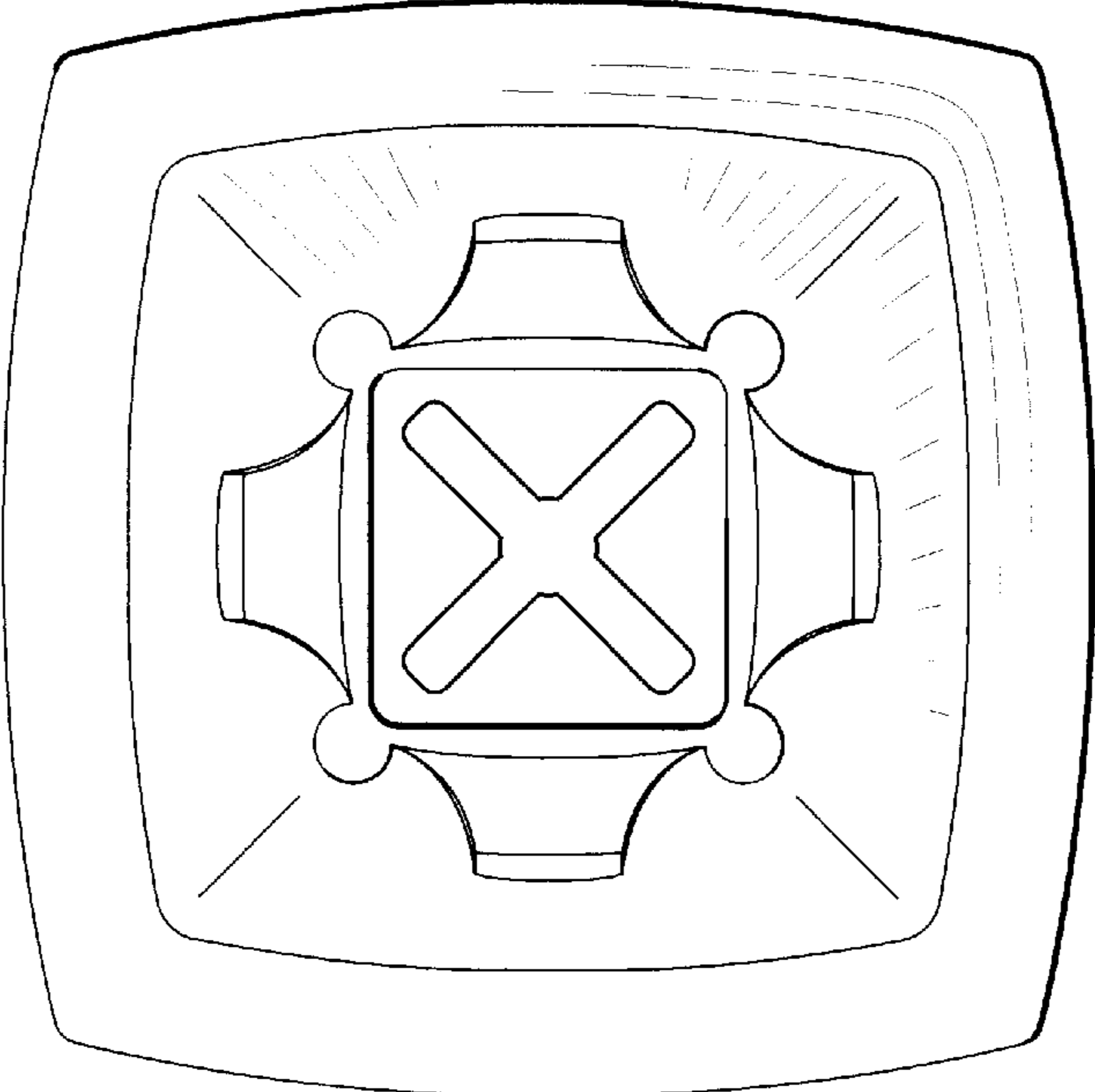

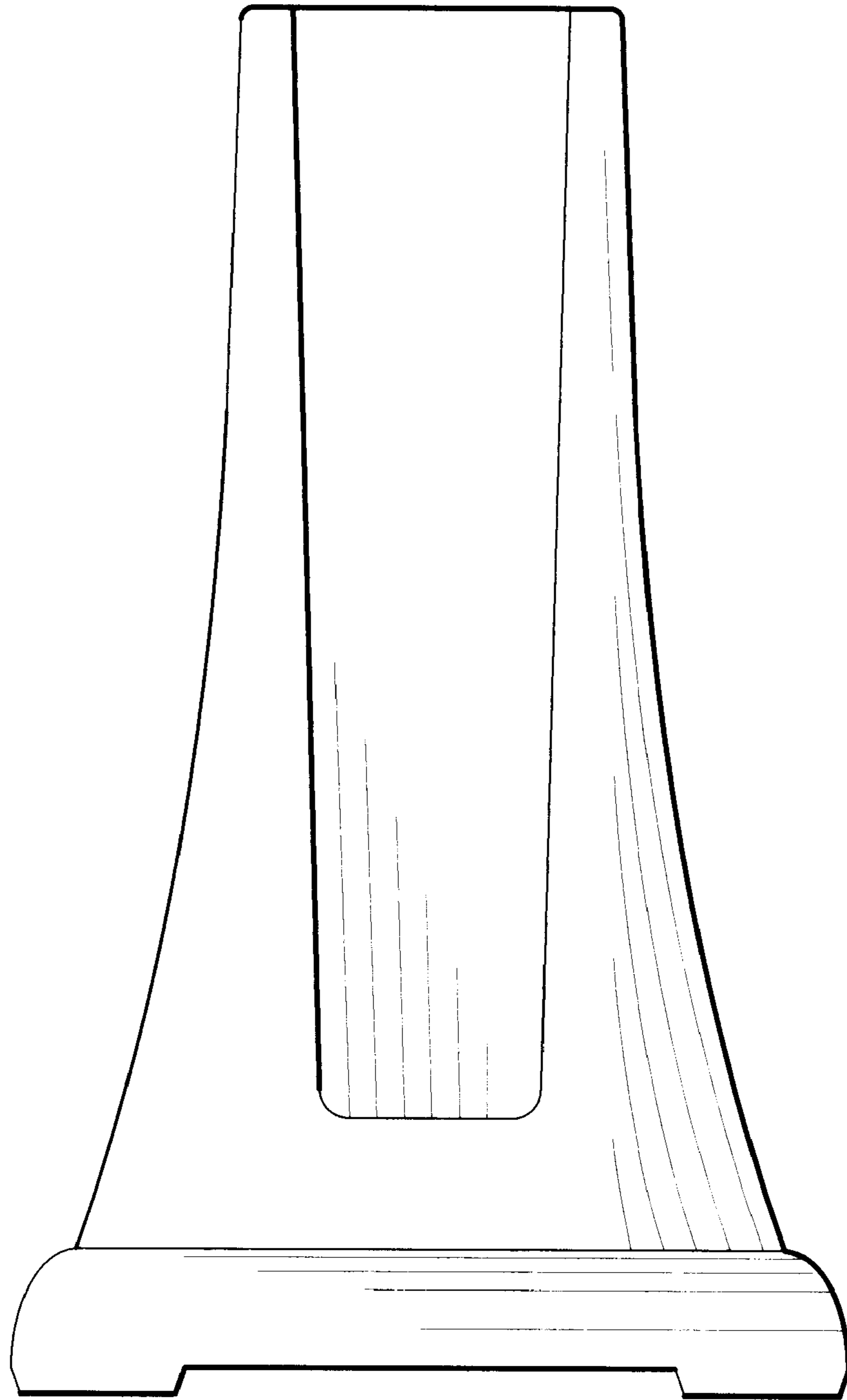

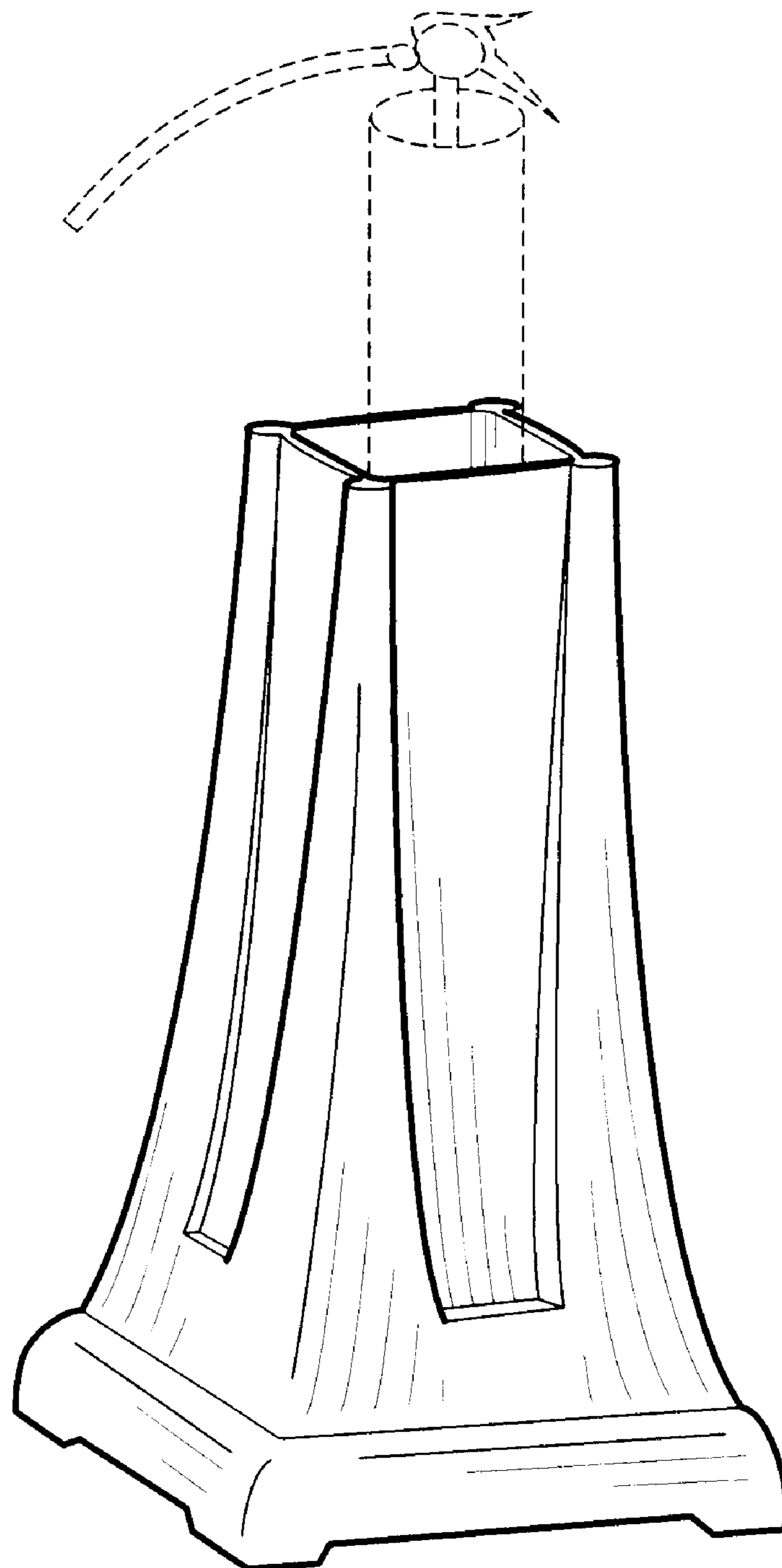

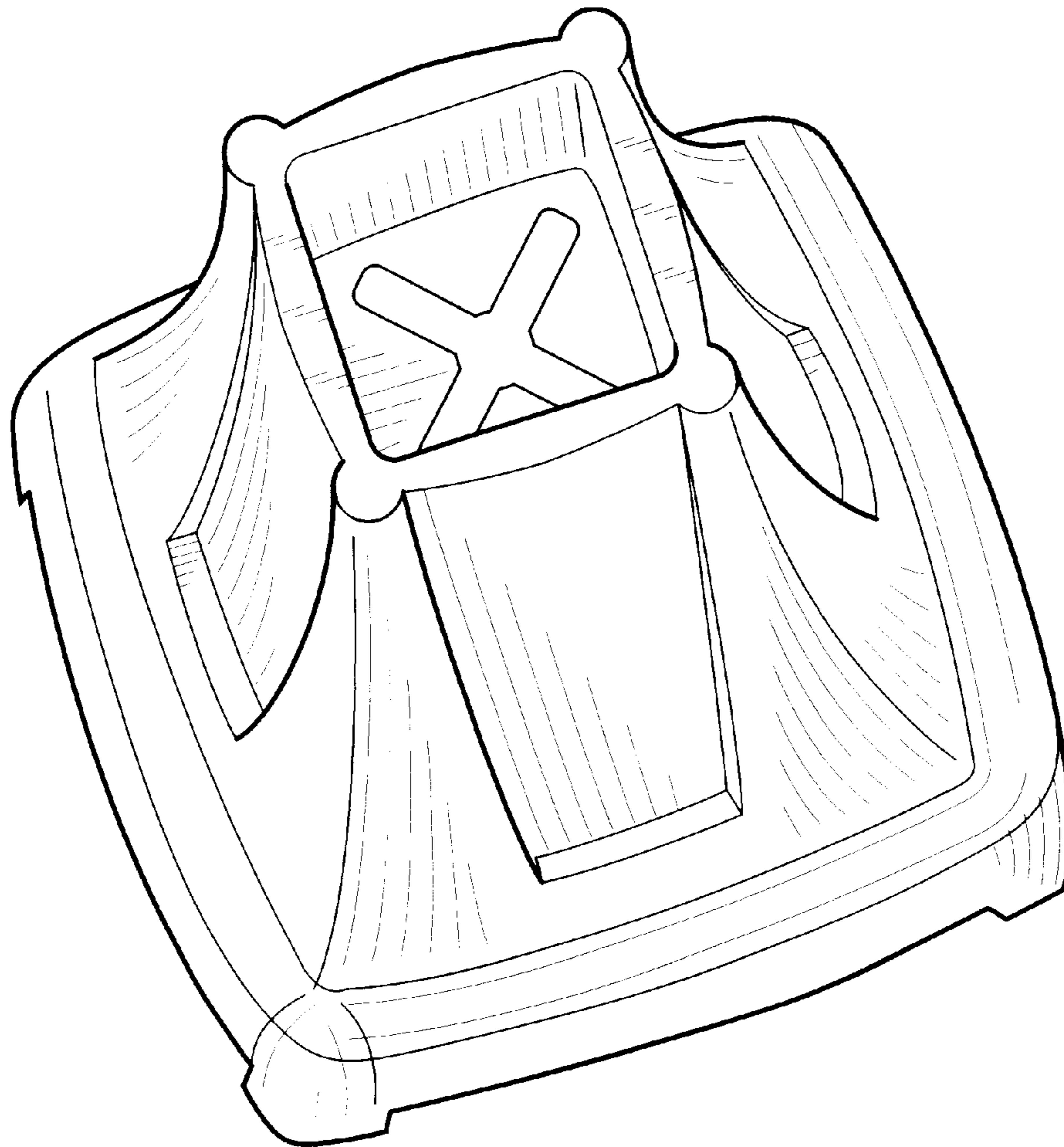
