(57) **CLAIM**

The ornamental design for a vehicle pet bed, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of a vehicle bed showing my new design;

FIG. 2 is a perspective view thereof in a different position;

FIG. 3 is a top plan view thereof, it being understood that the bottom plan view is a mirror image thereof;

FIG. 4 is a side edge view thereof, it being understood that the opposite side is a mirror image thereof;

FIG. 5 is a left end view thereof;

FIG. 6 is a right end view thereof;

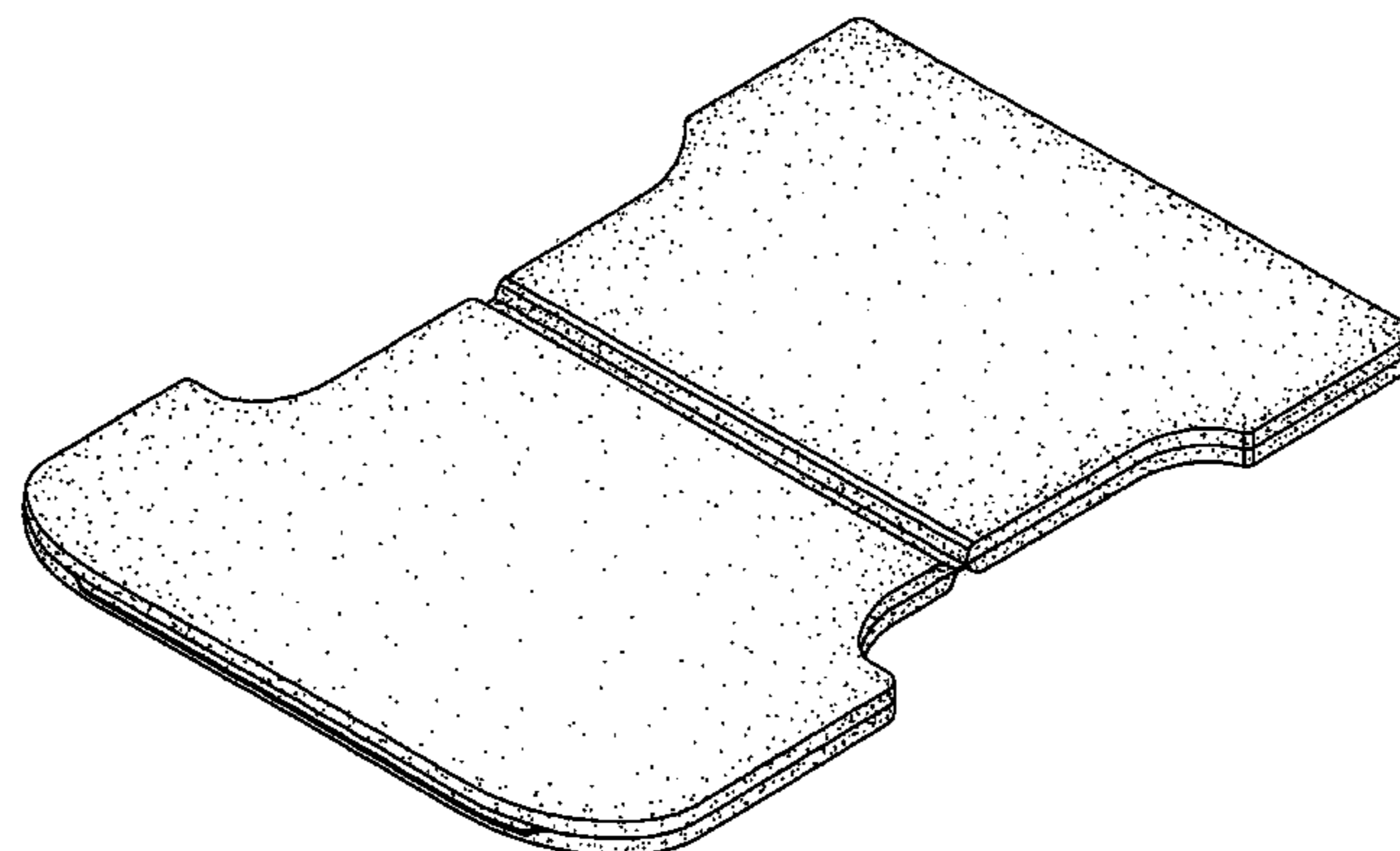
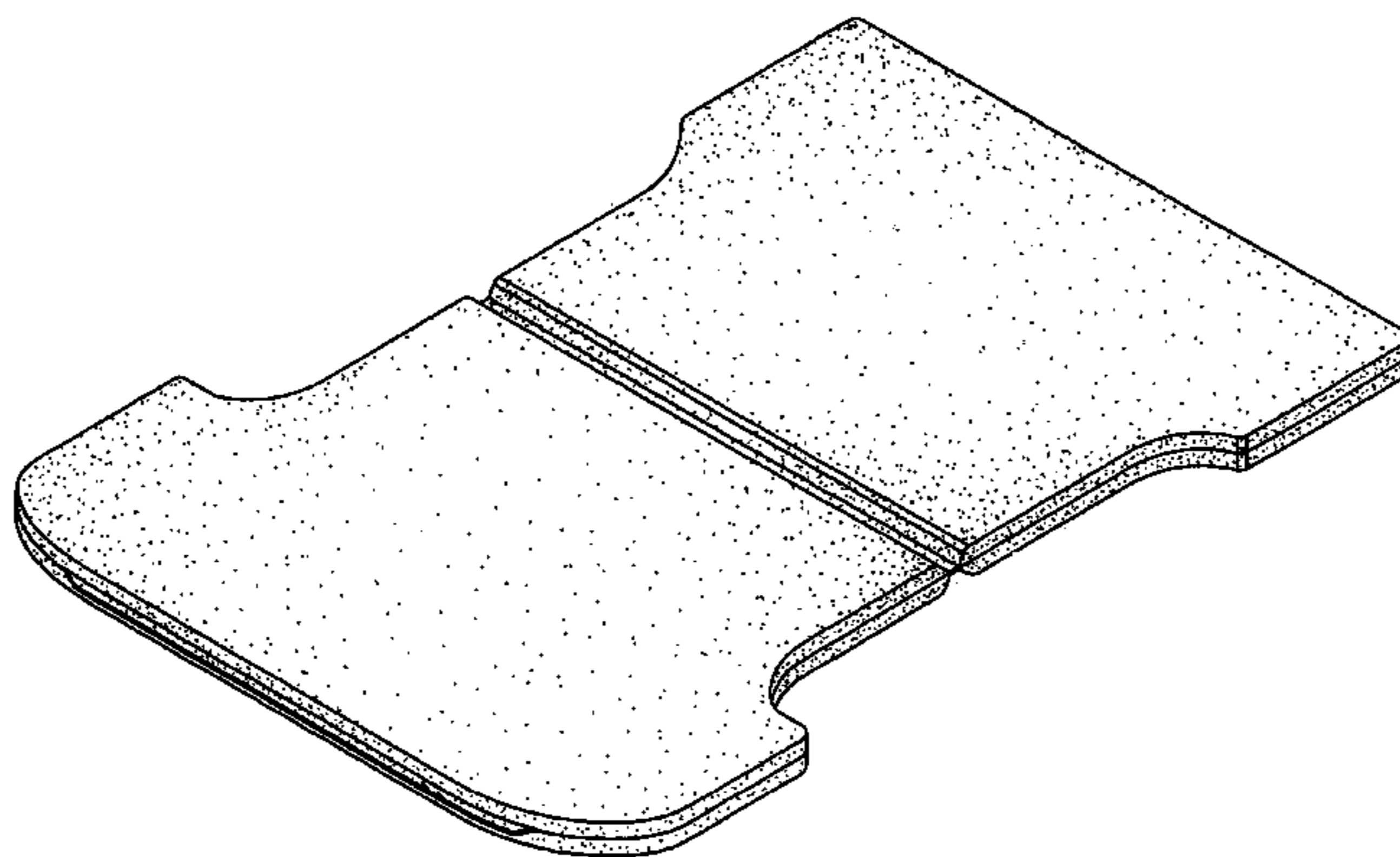
FIG. 7 is a perspective view thereof showing the bed cover in partially opened position;

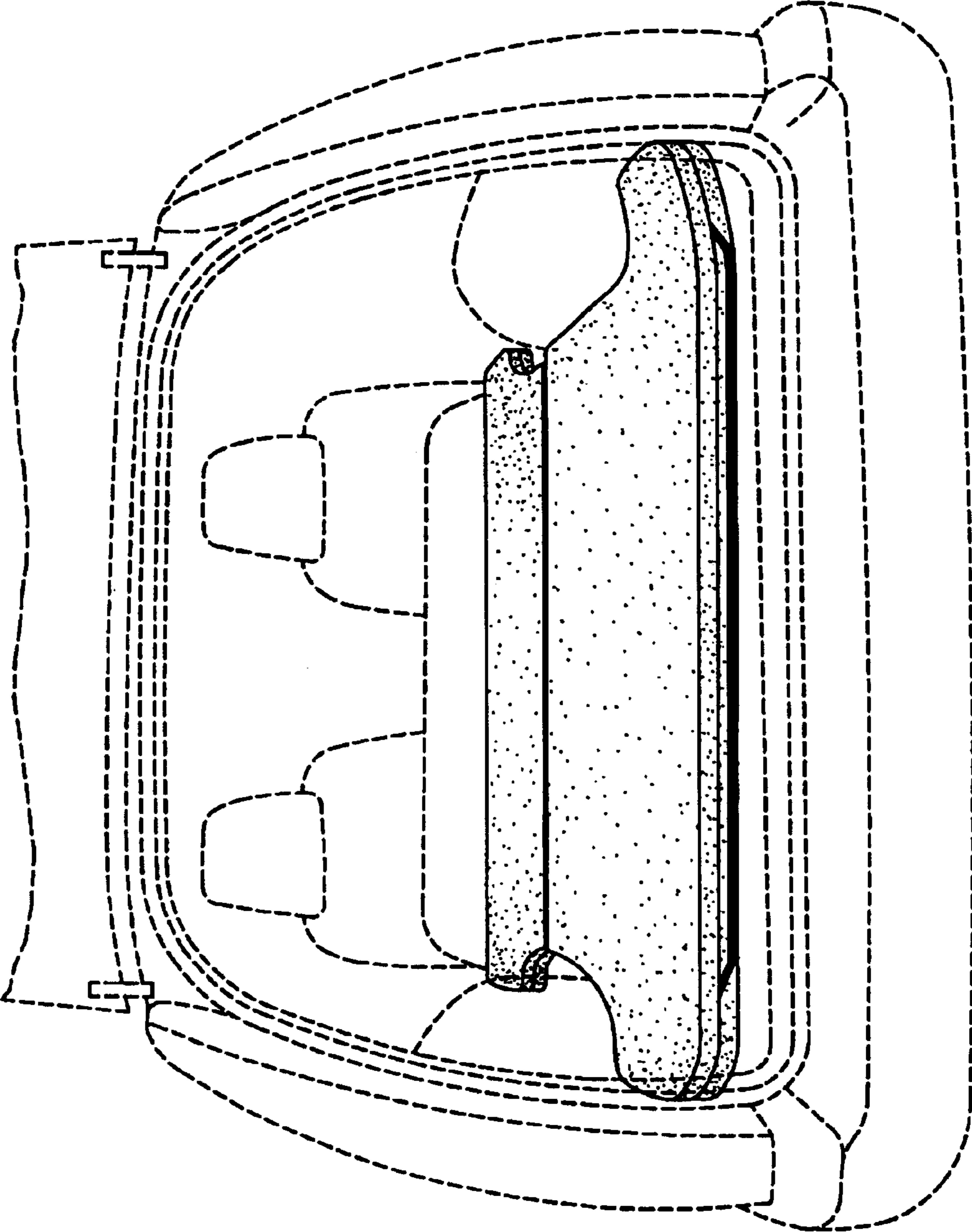

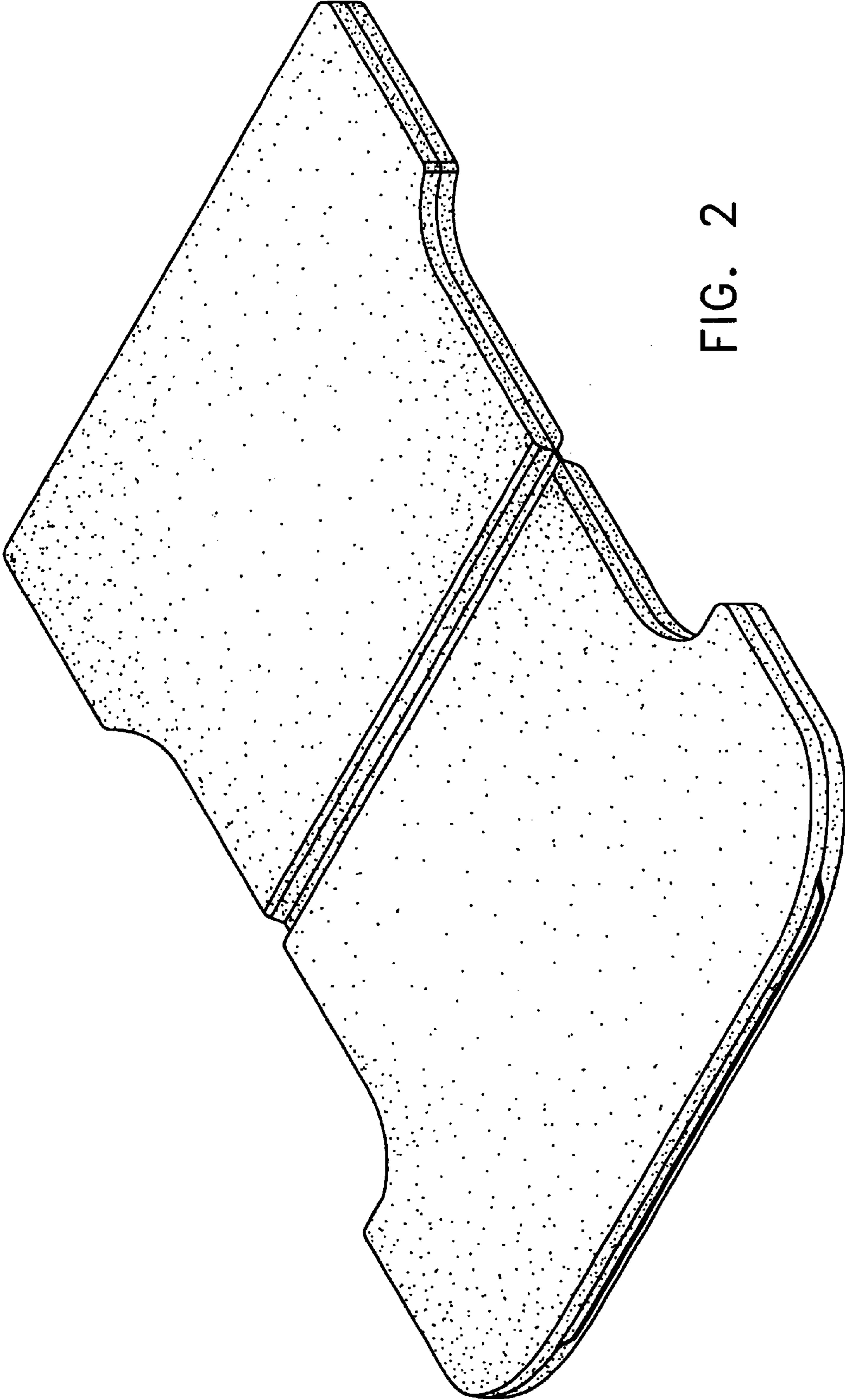

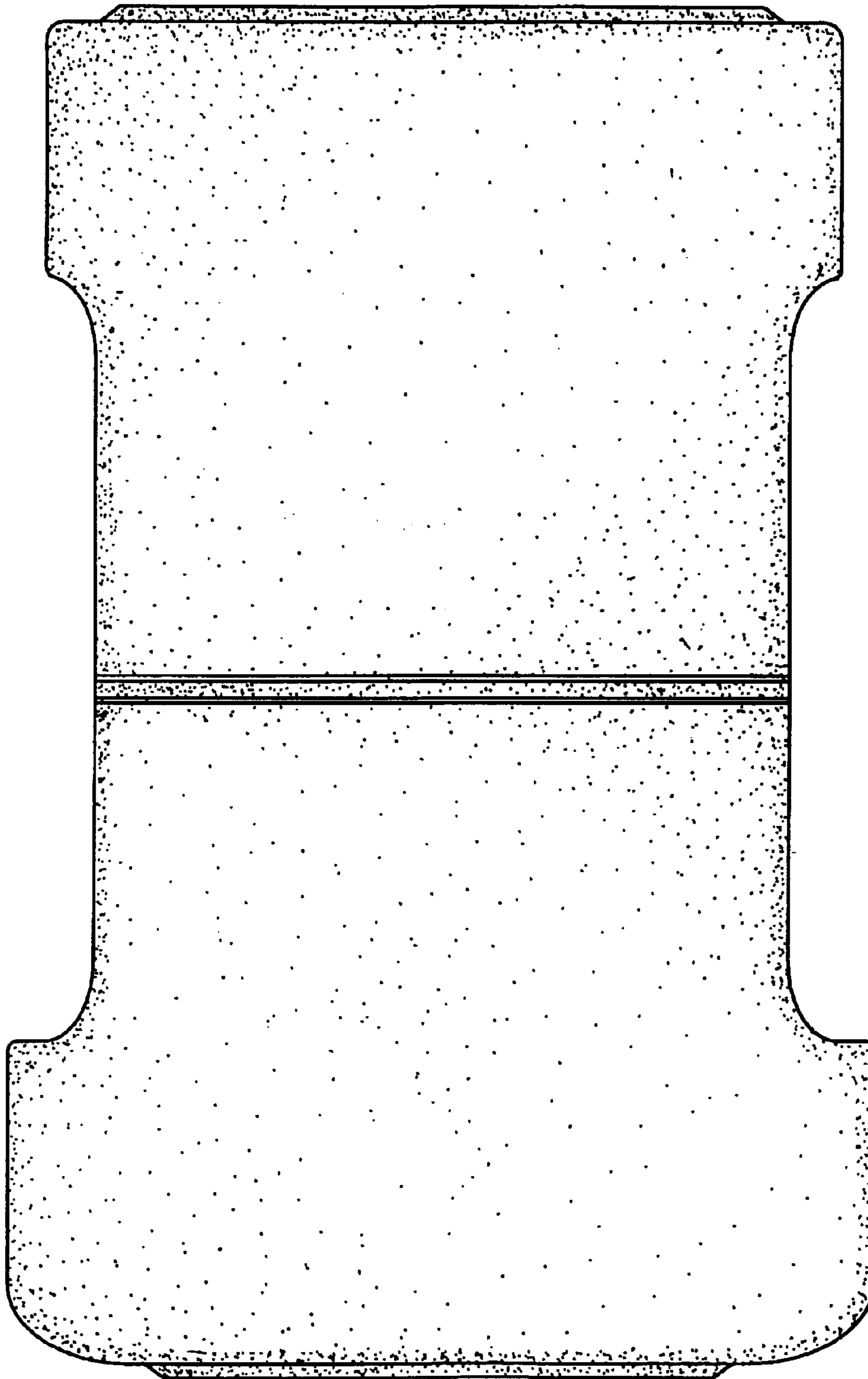

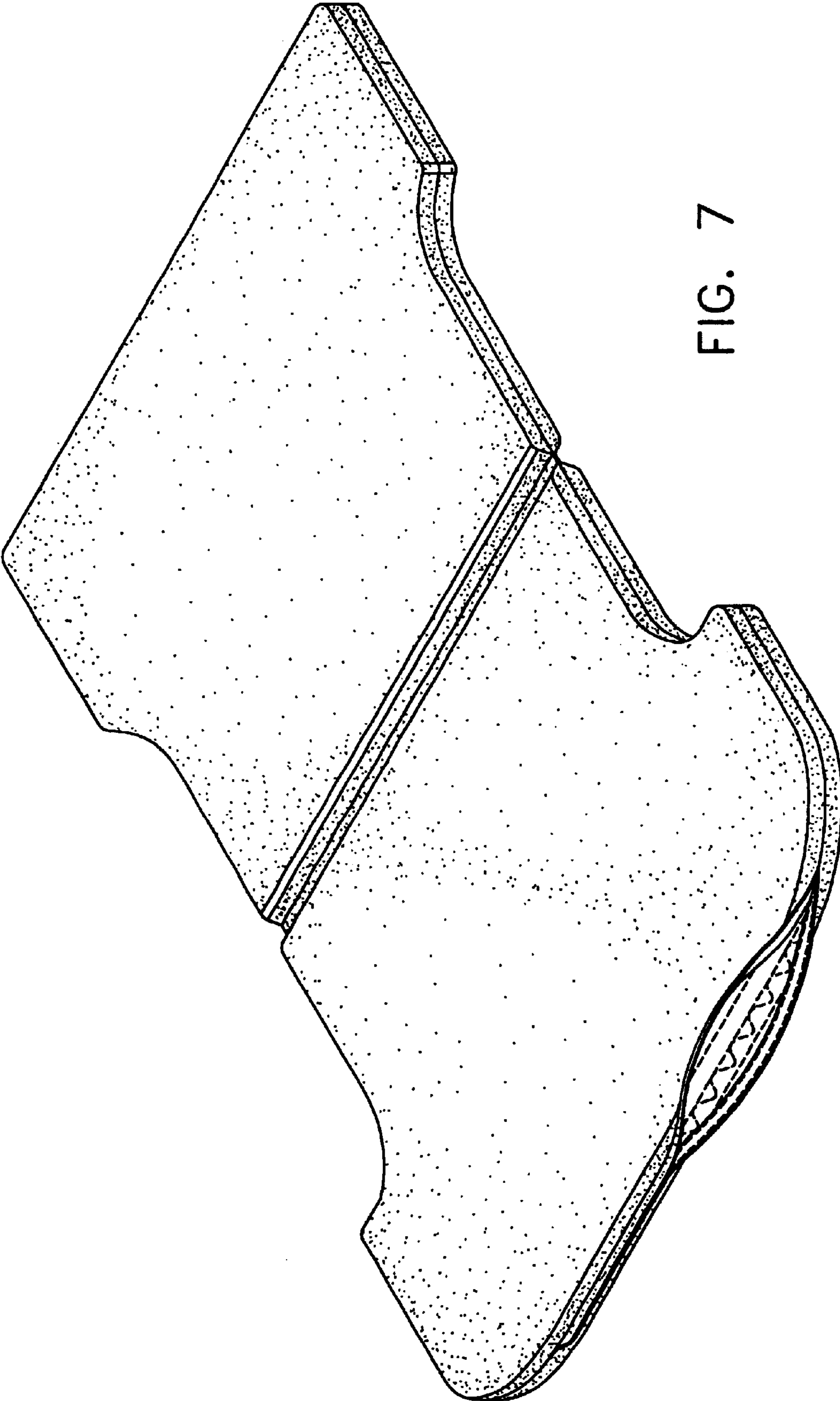

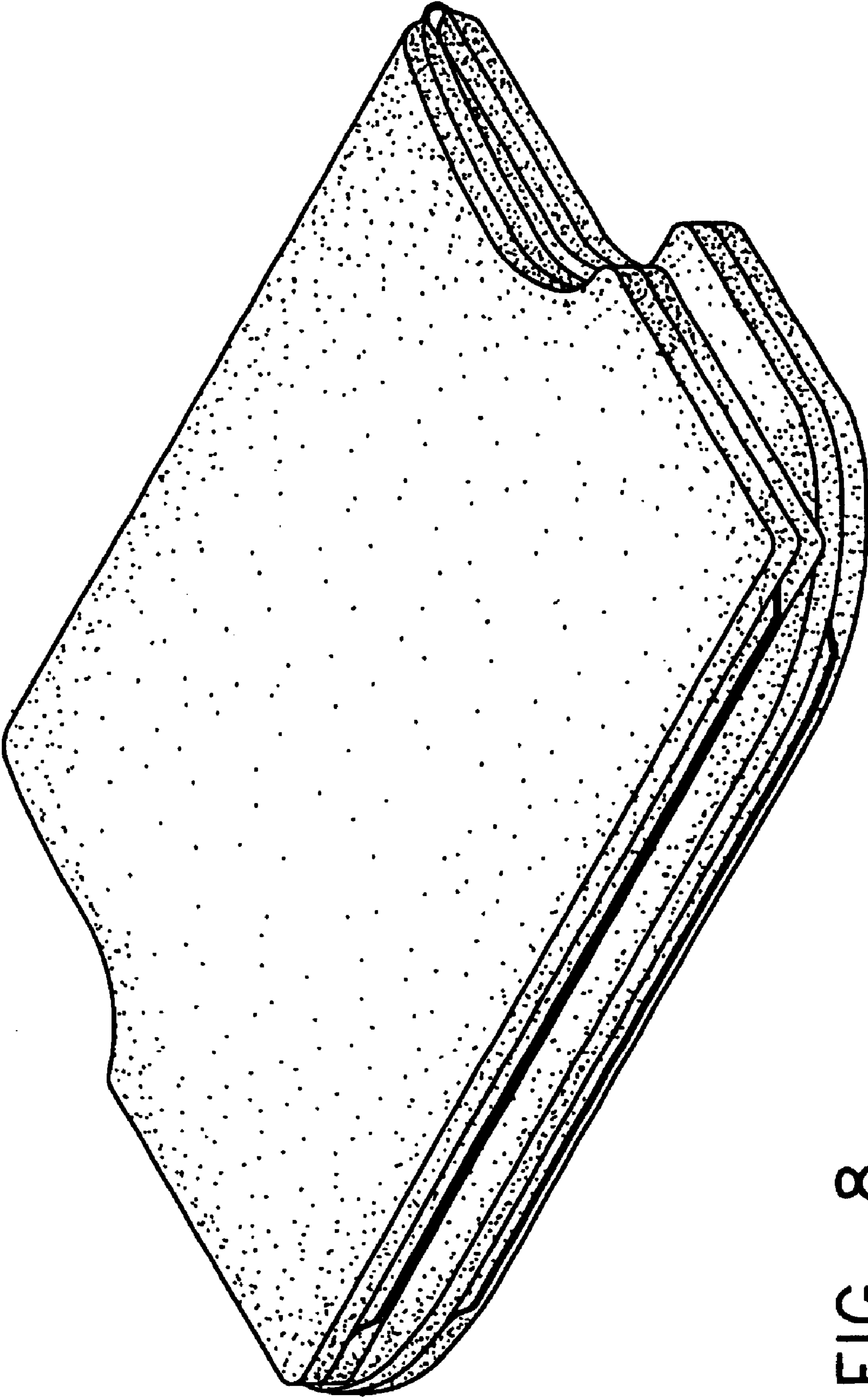

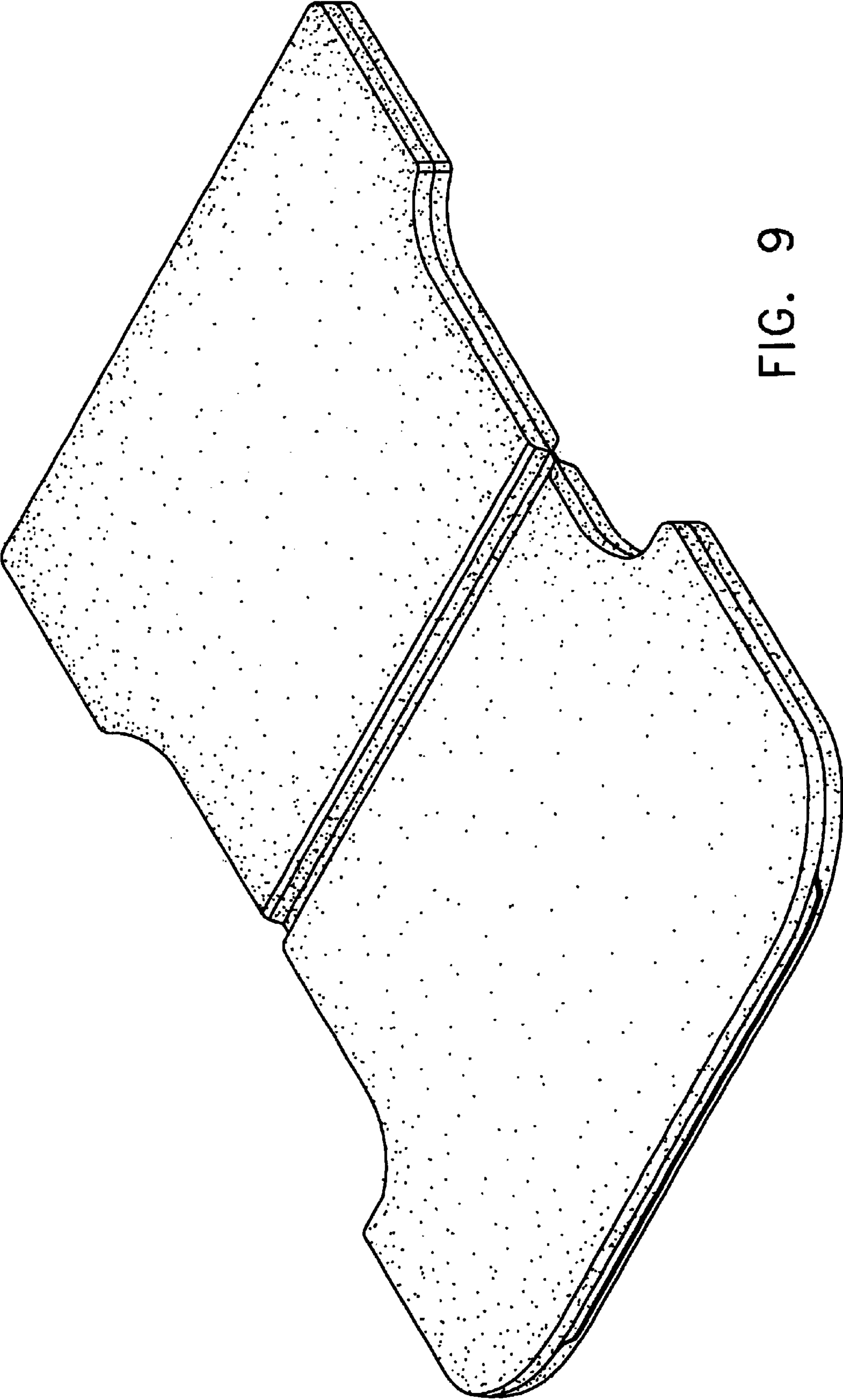
