The ornamental design for a mop head, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the mop head, embodying the new design;

FIG. 2 is a top view thereof;

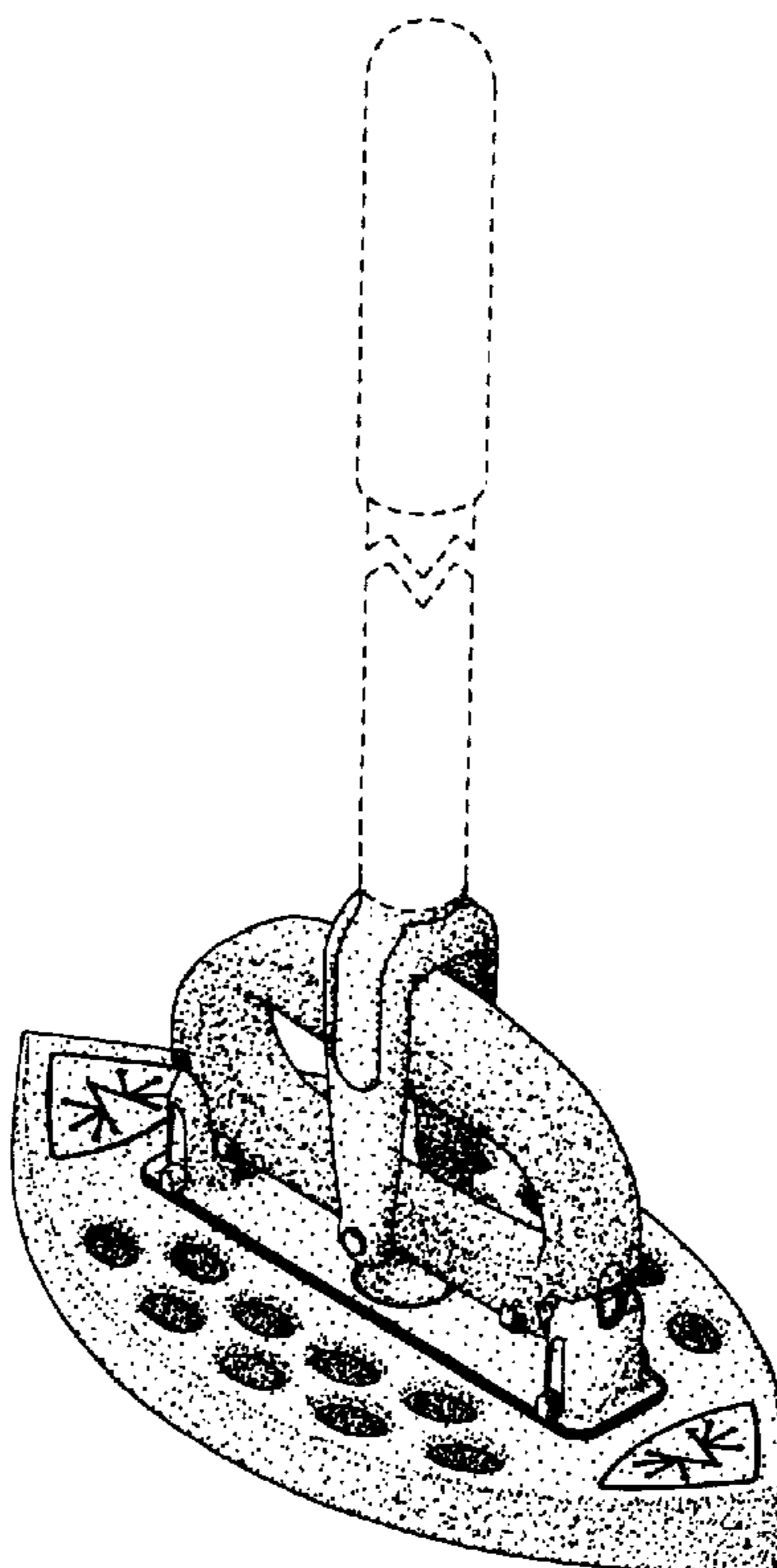
FIG. 3 is the bottom view thereof;

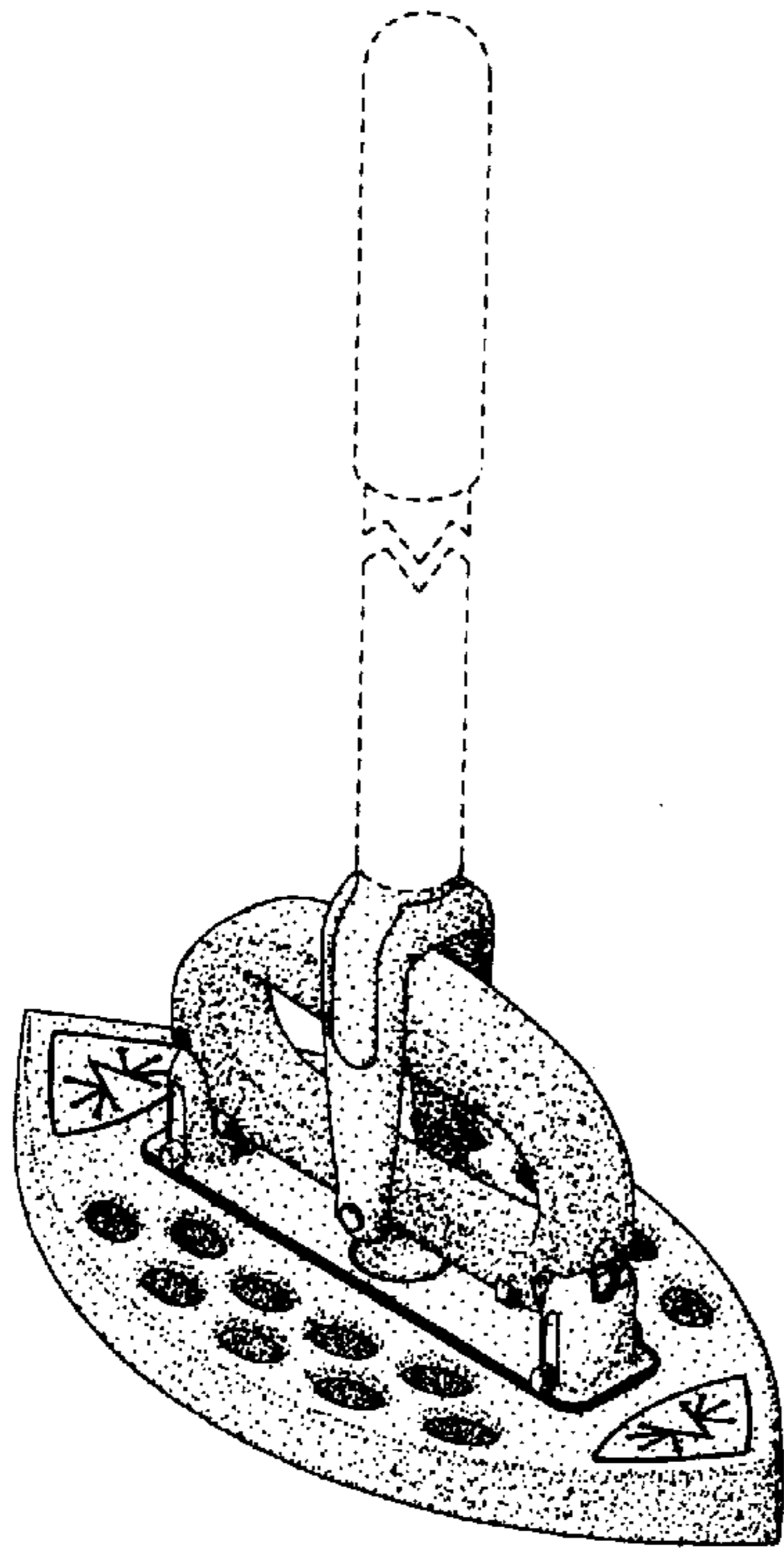

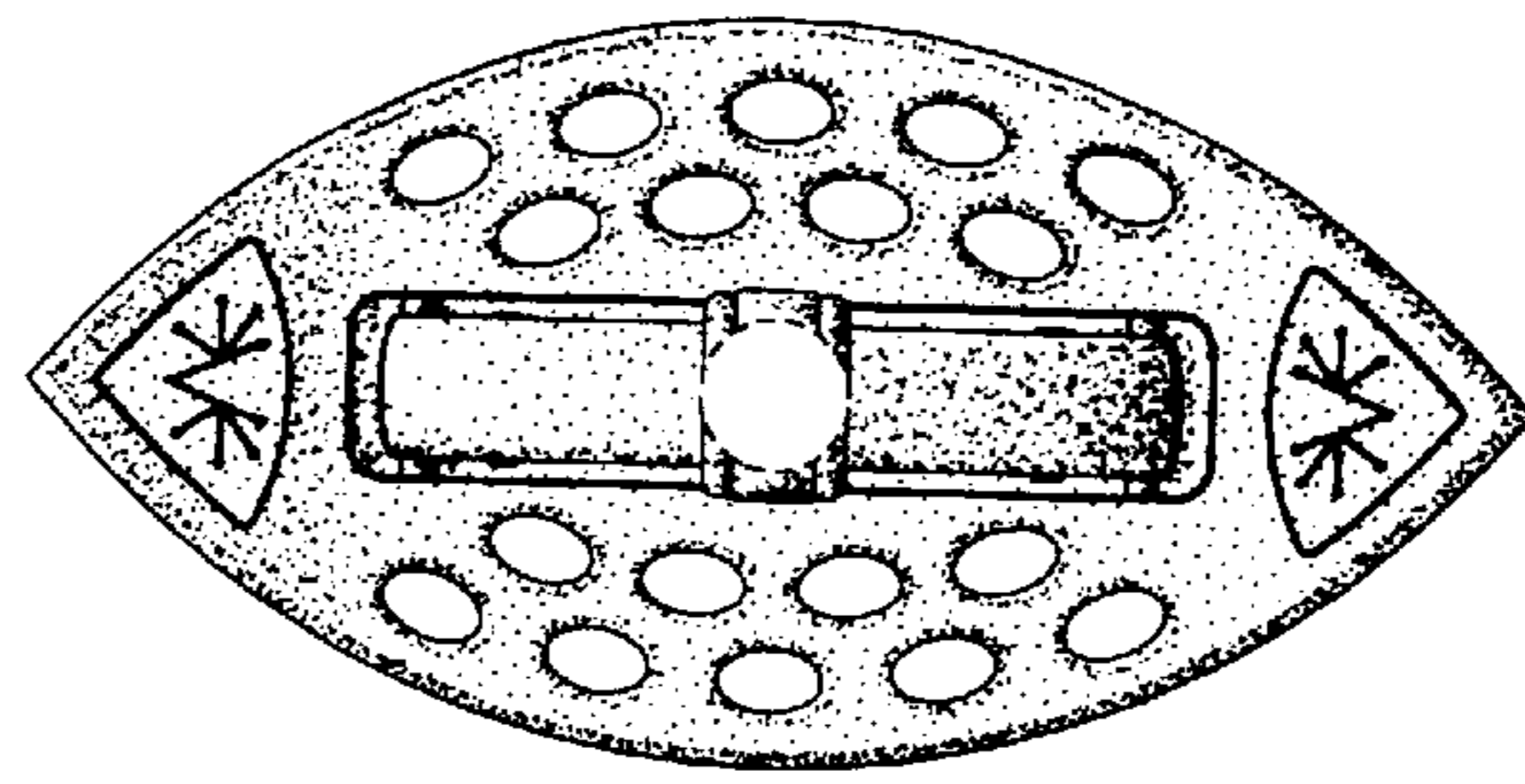

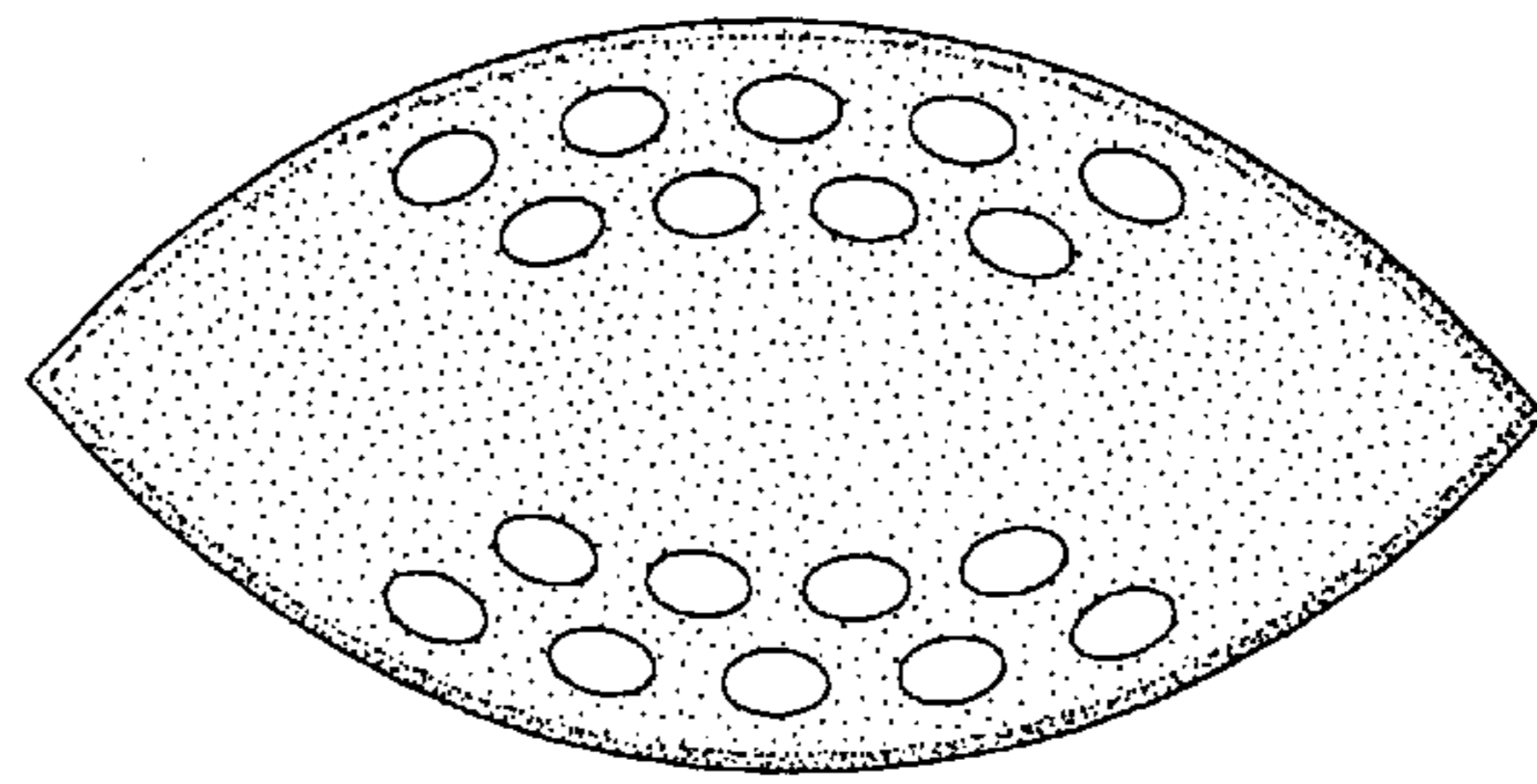

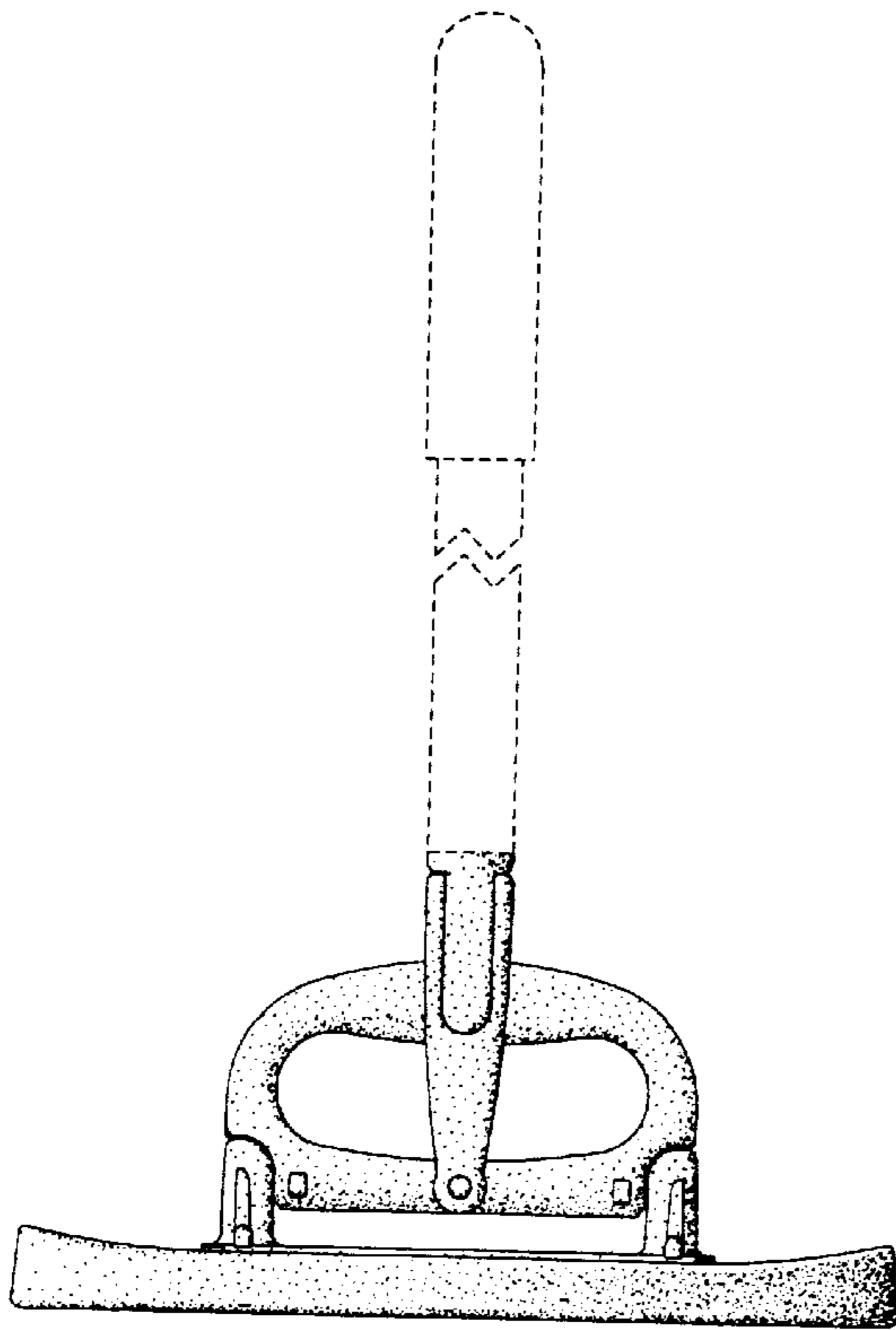

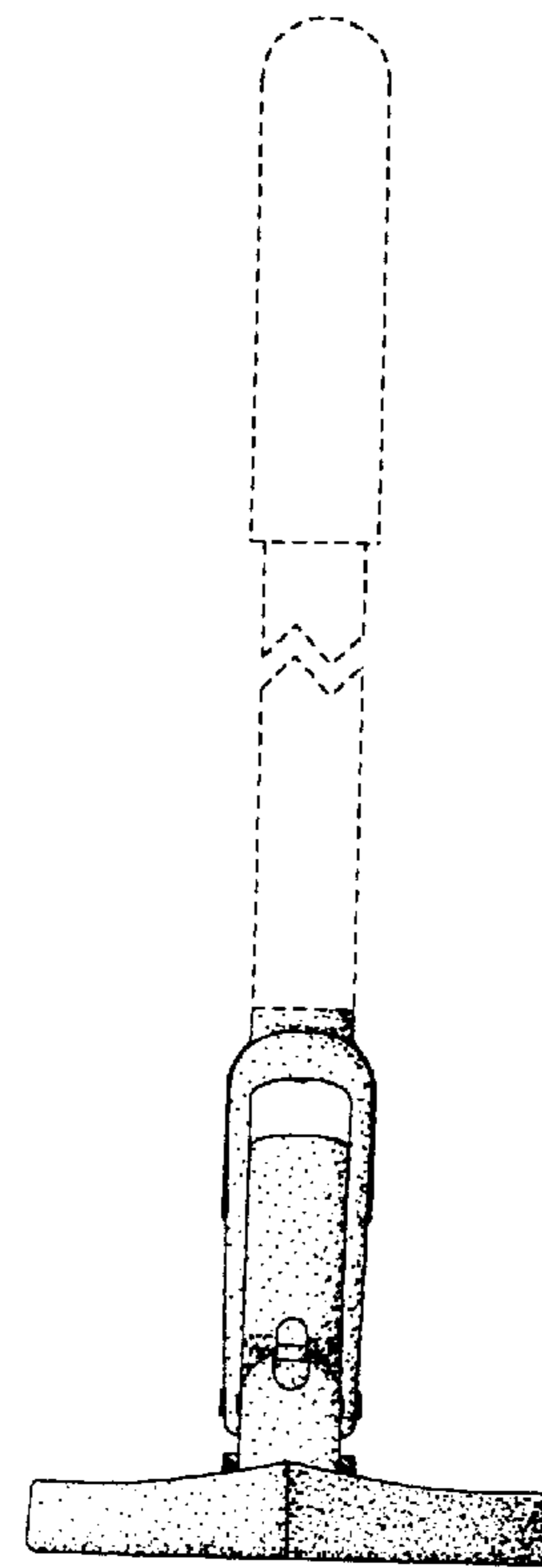
