(57) **CLAIM**

The ornamental design for a novelty hat and wig, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a novelty hat and wig showing my new design;
FIG. 2 is a left side elevational view of FIG. 1;
FIG. 3 is a right side elevational view of FIG. 1;
FIG. 4 is a back elevational view of FIG. 1;
FIG. 5 is a top plan view of FIG. 1;
FIG. 6 is a bottom plan view of FIG. 1; and,
FIG. 7 is another front view of FIG. 1.
The broken lines showing environment in the drawings are for illustrative purposes only and form no part of the claimed design. The crisscross pattern shown intermittently on the band and inside of the novelty hat and wig represents material and is understood to be distributed uniformly over the surfaces on which it is represented.

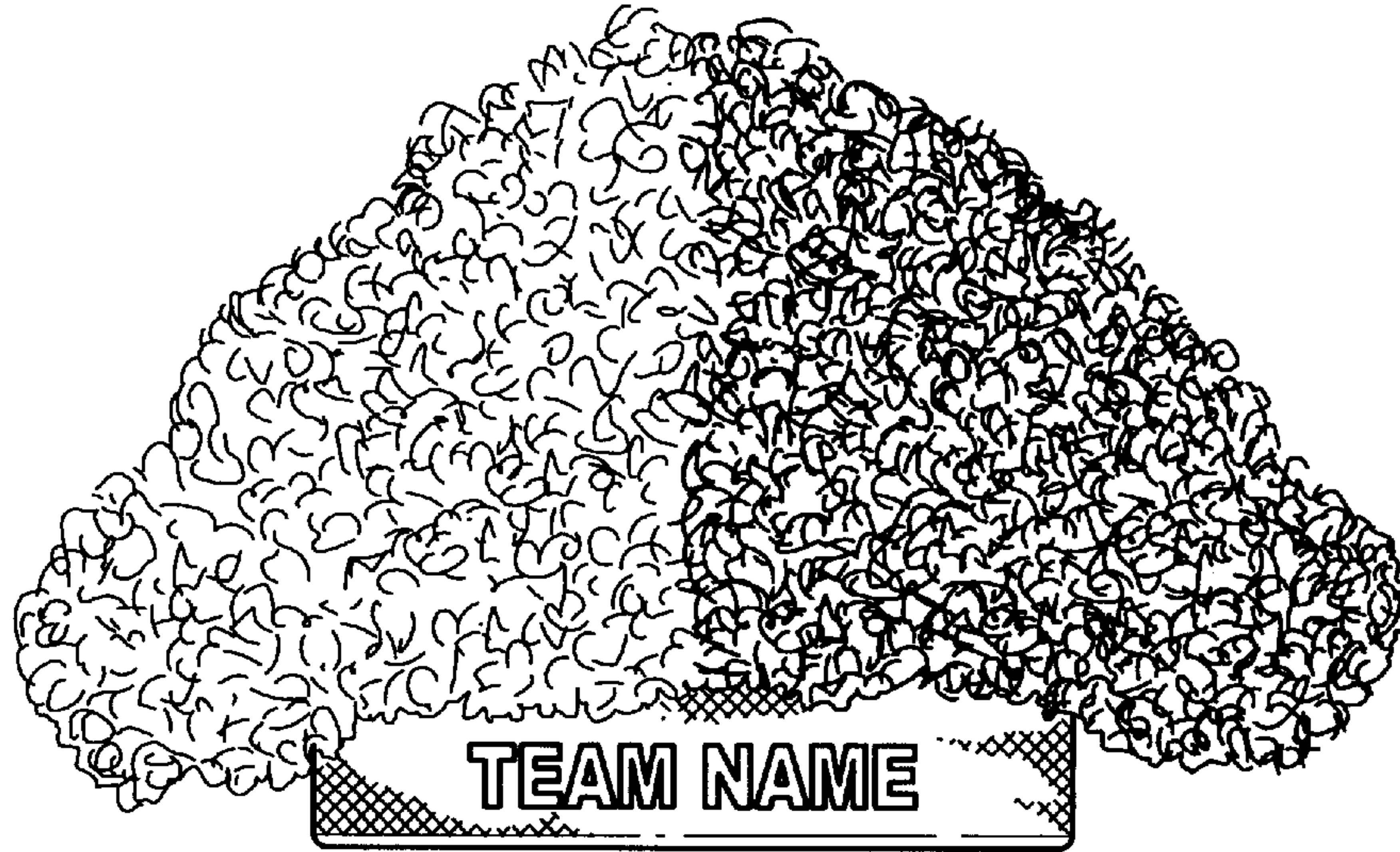

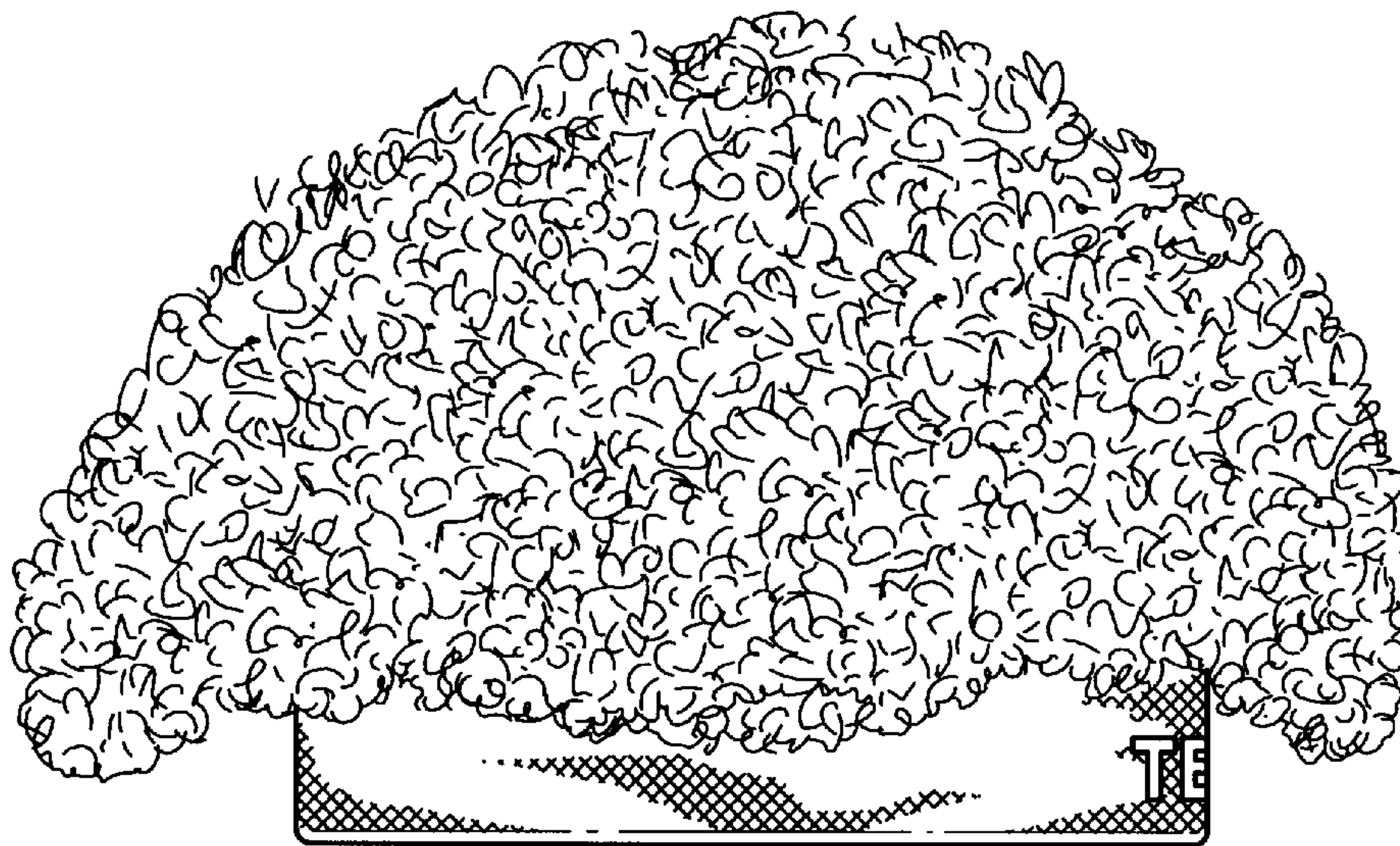

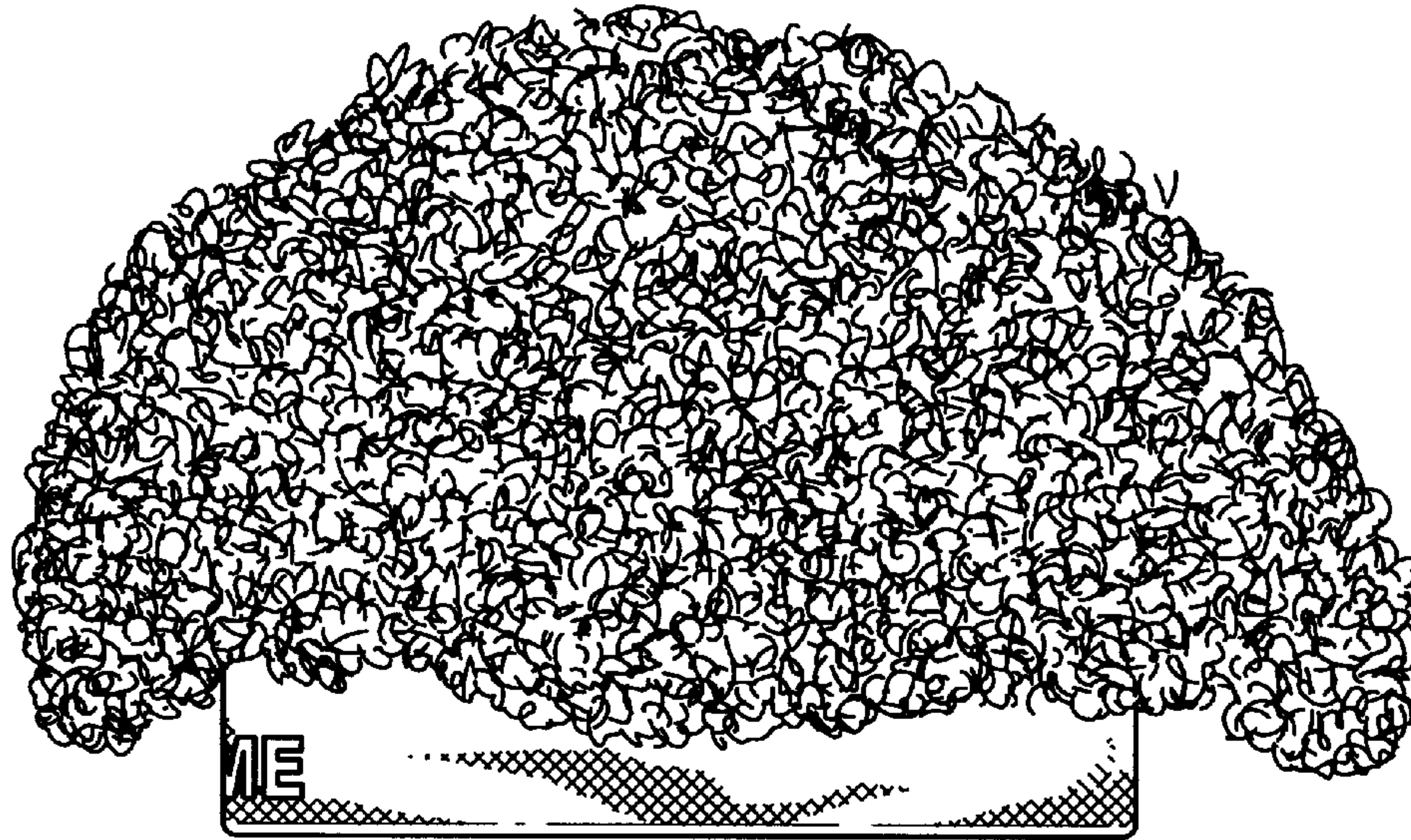

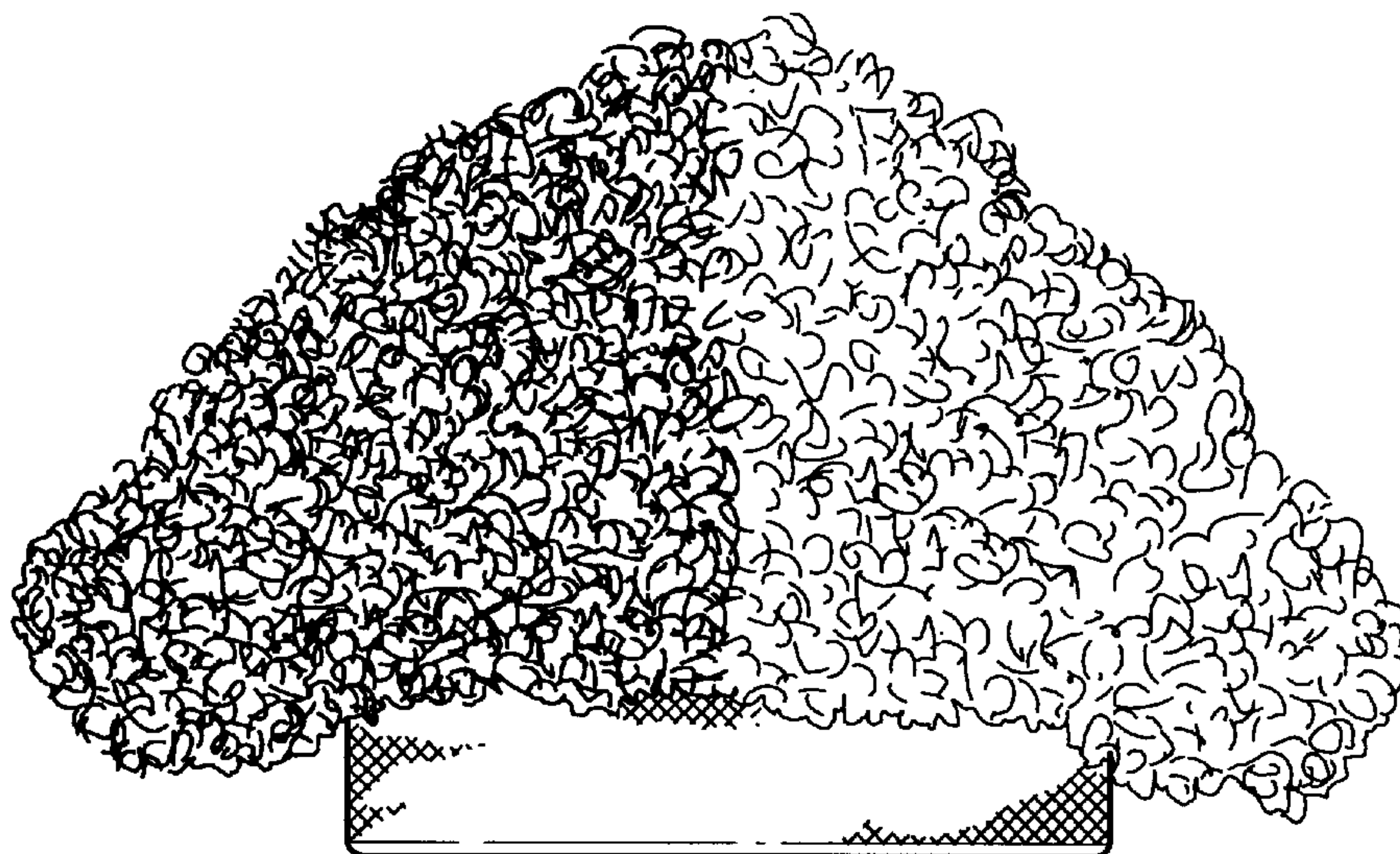

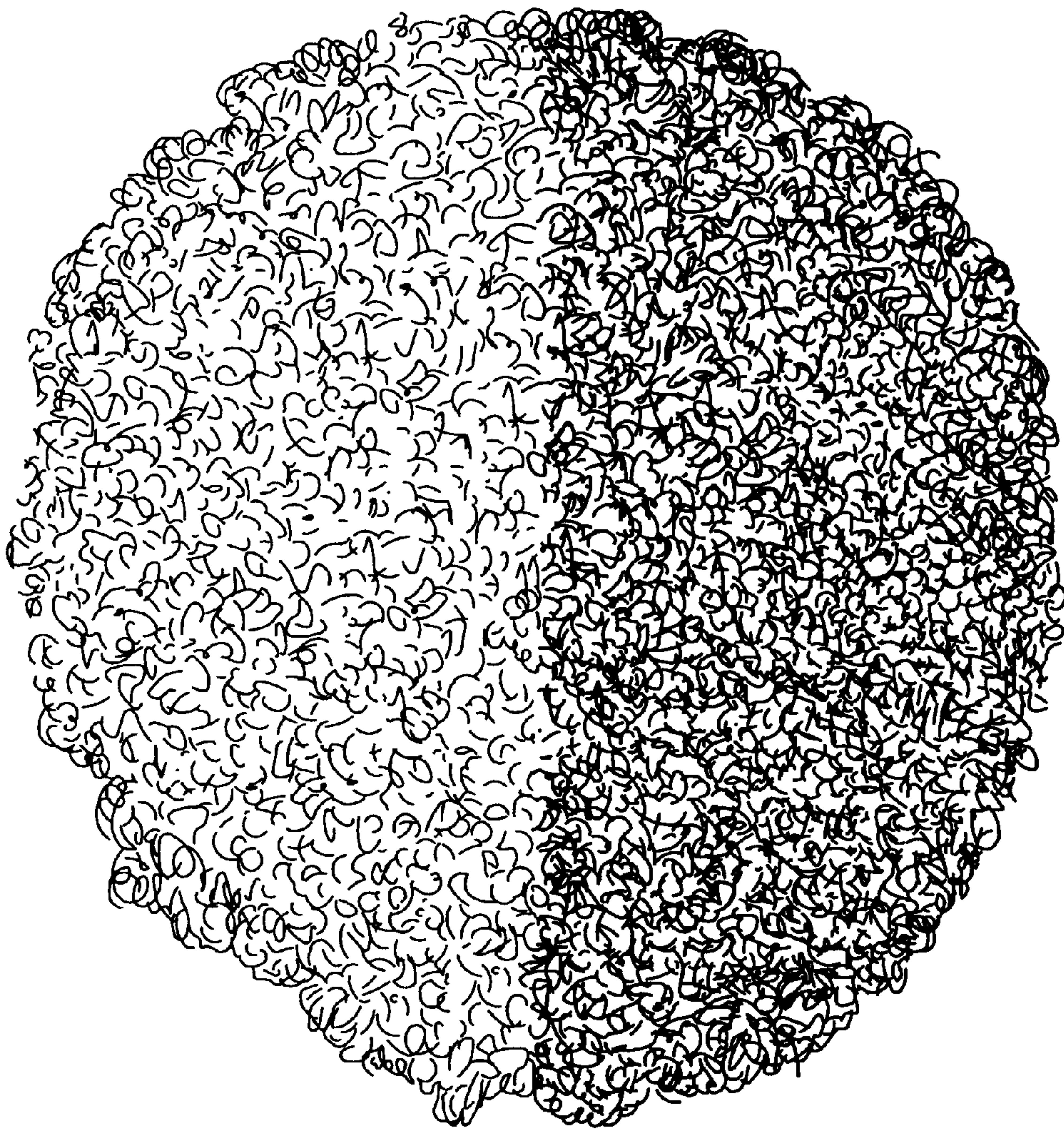

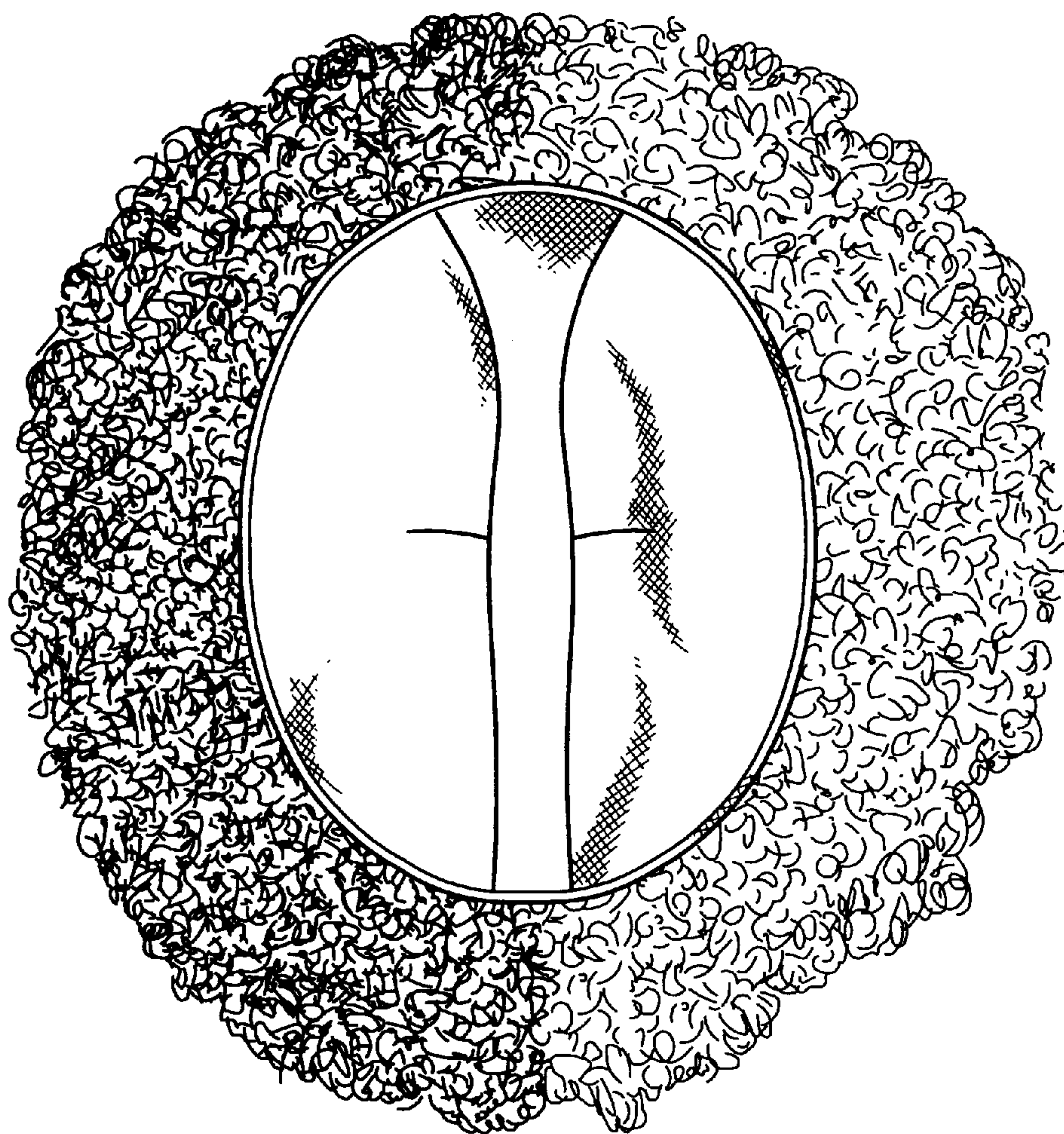
