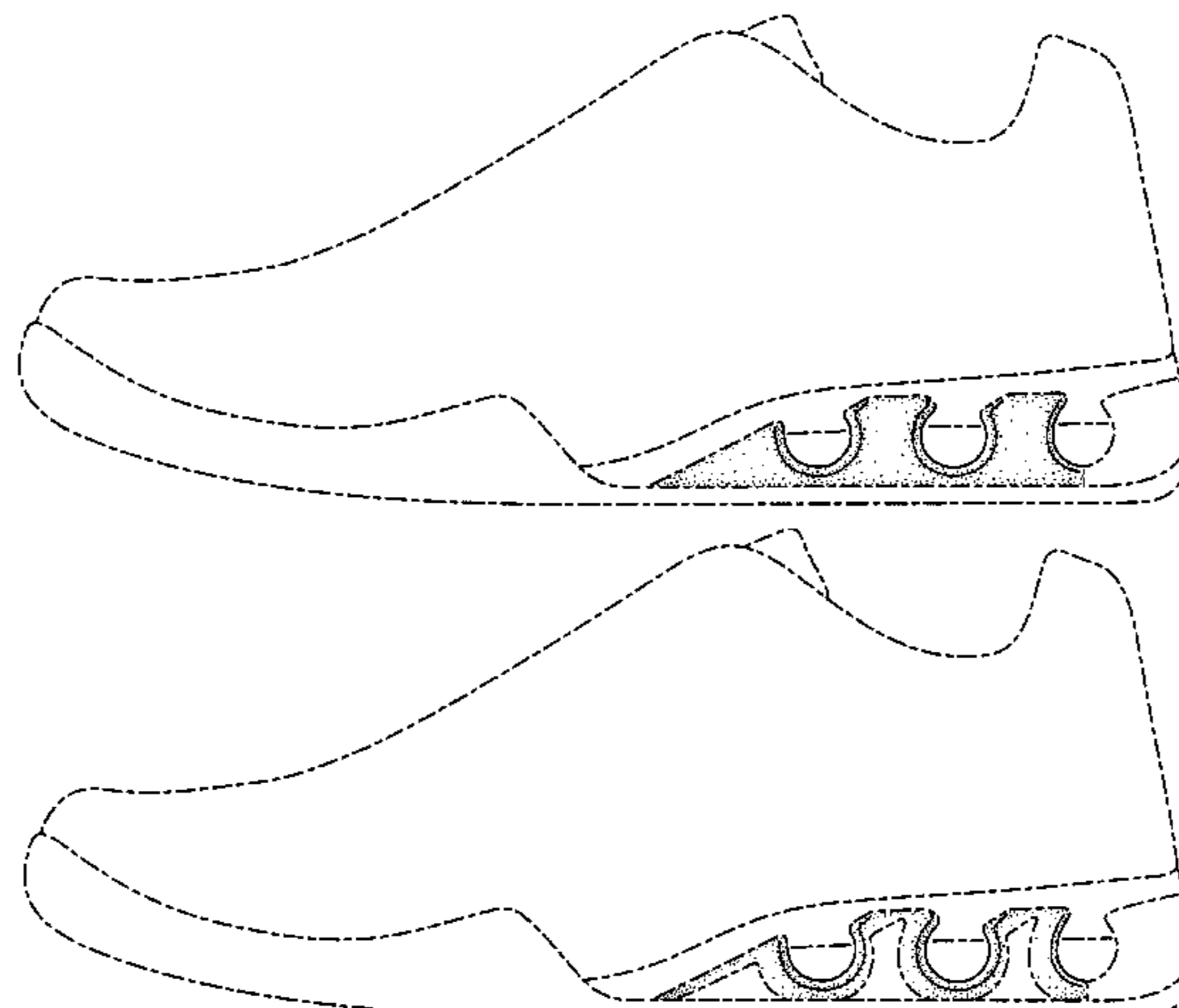
(57) **CLAIM**

The ornamental design for a portion of a shoe midsole, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a portion of a shoe midsole showing my new design.
 FIG. 2 is a rear perspective view thereof.
 FIG. 3 is a side elevational view thereof.
 FIG. 4 is another front perspective view showing a second embodiment of my new design.
 FIG. 5 is another rear perspective view showing the second embodiment of my new design; and,
 FIG. 6 is another side elevational view showing the second embodiment of my new design.
 The broken lines immediately adjacent to the shaded areas represent unclaimed boundaries of the design. The broken lines showing of the remainder of the shoe are for illustrative purposes only and form no part of the claimed design.

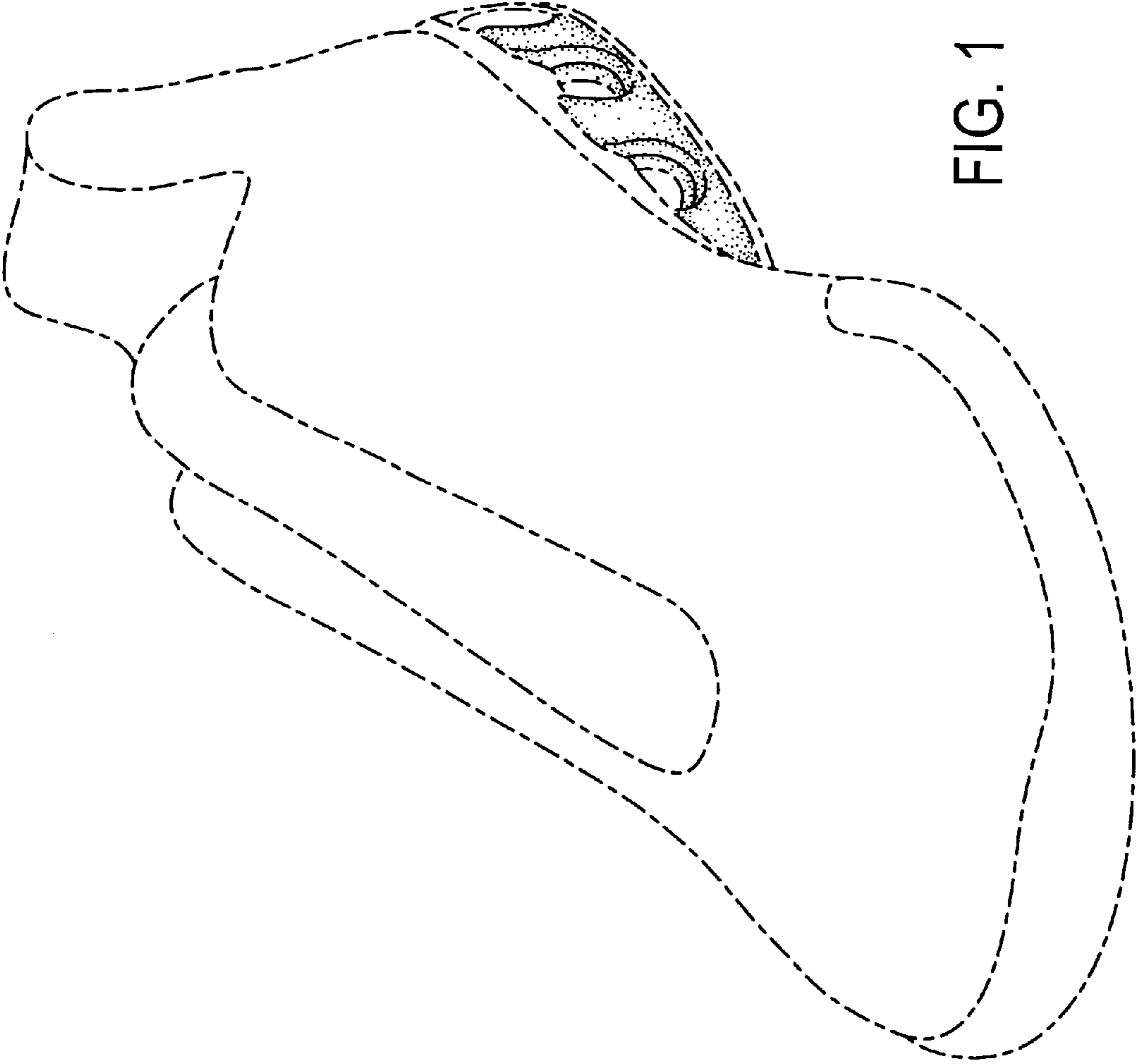

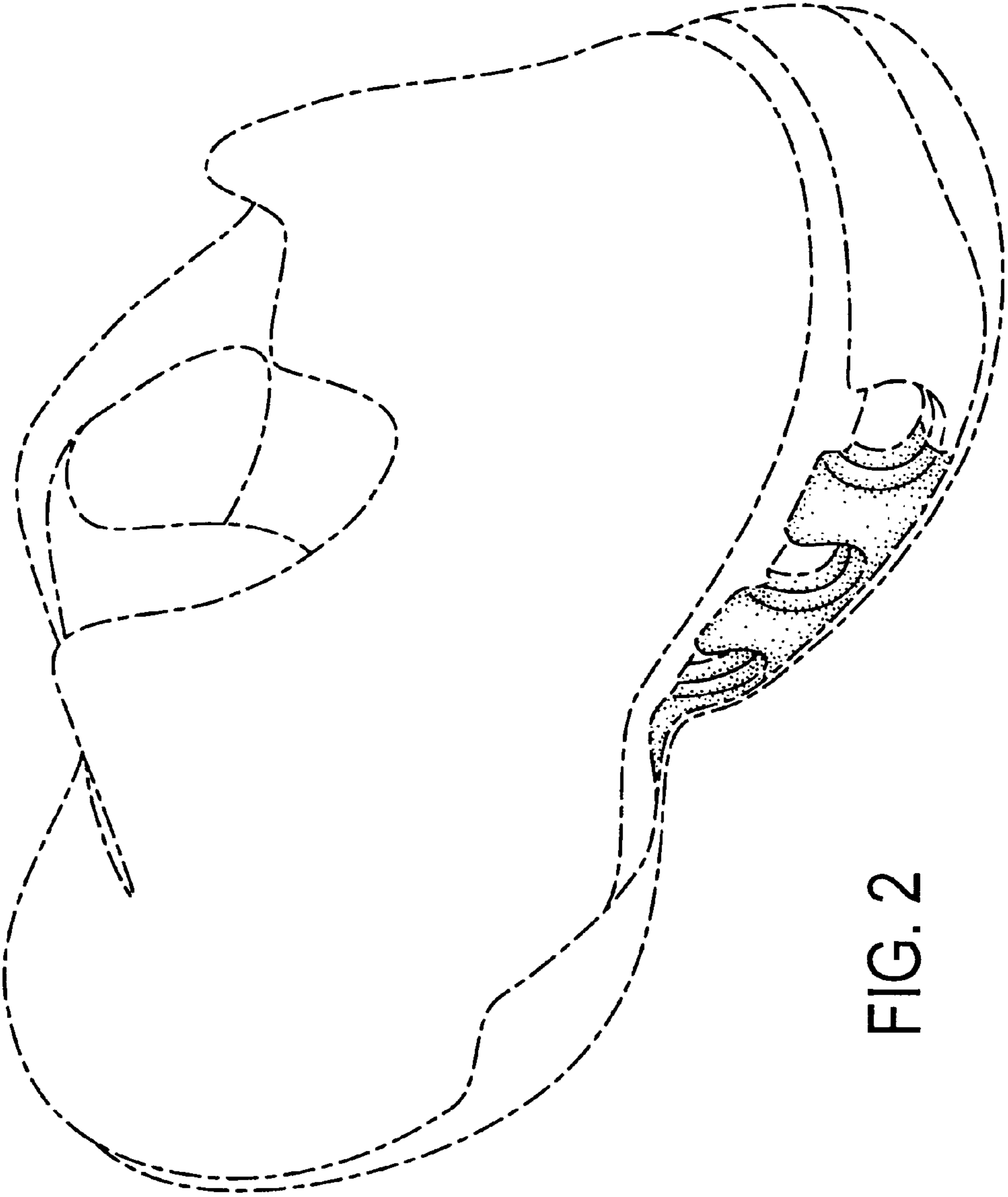

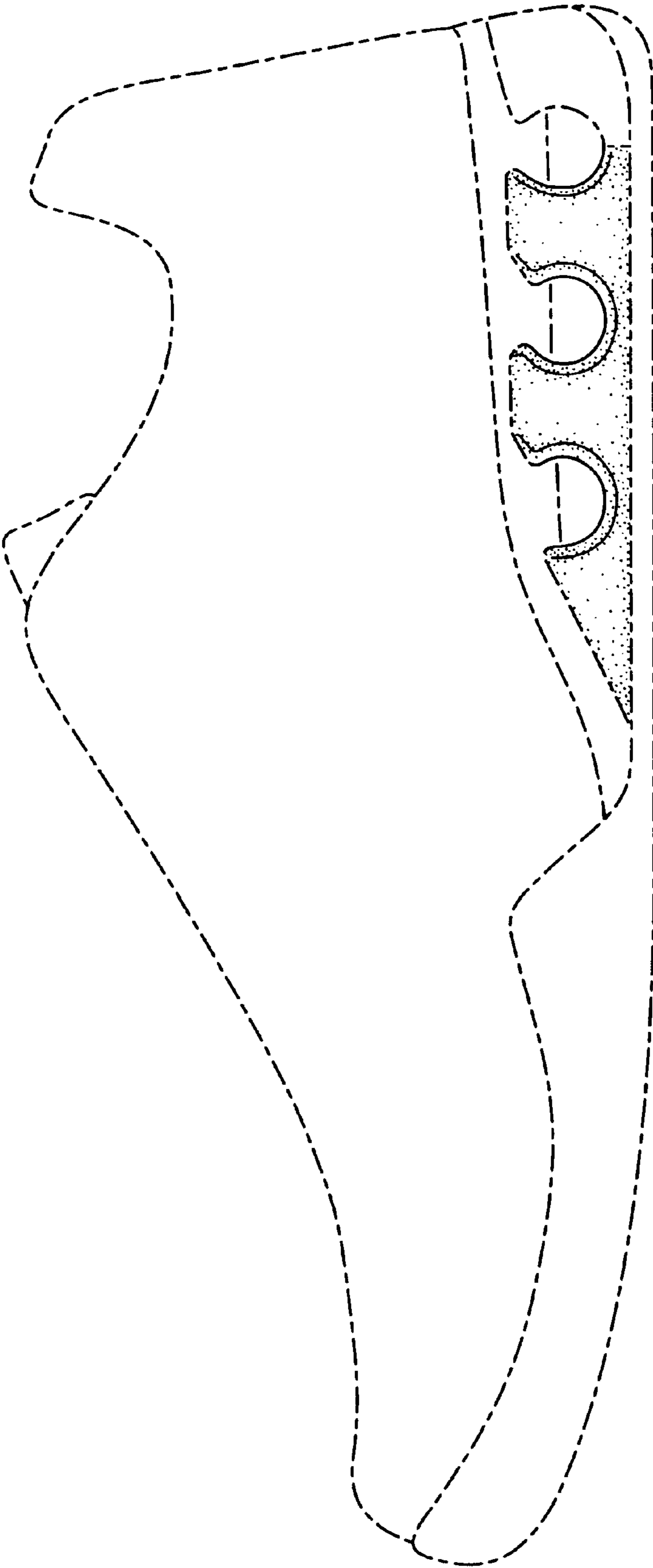

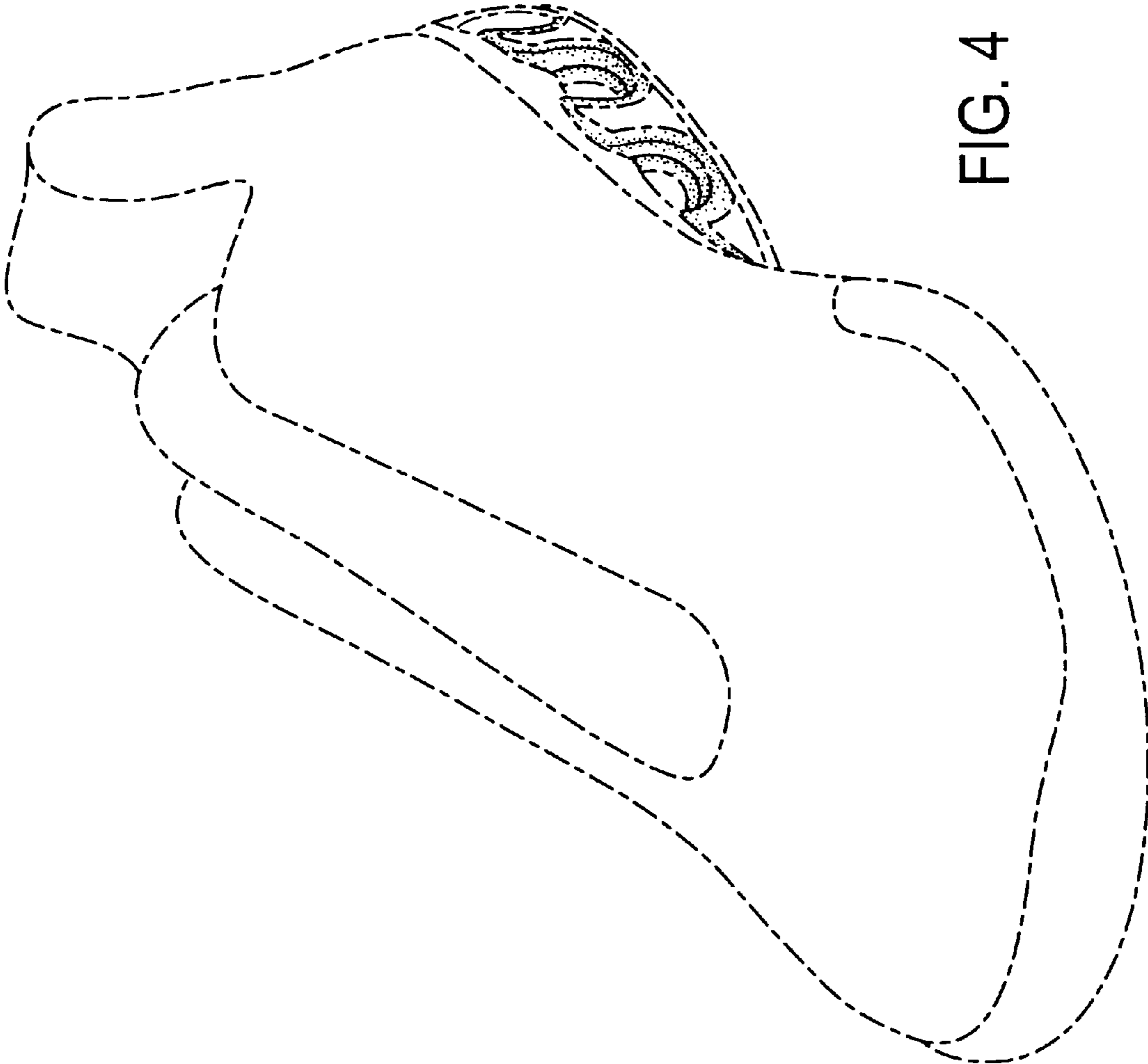

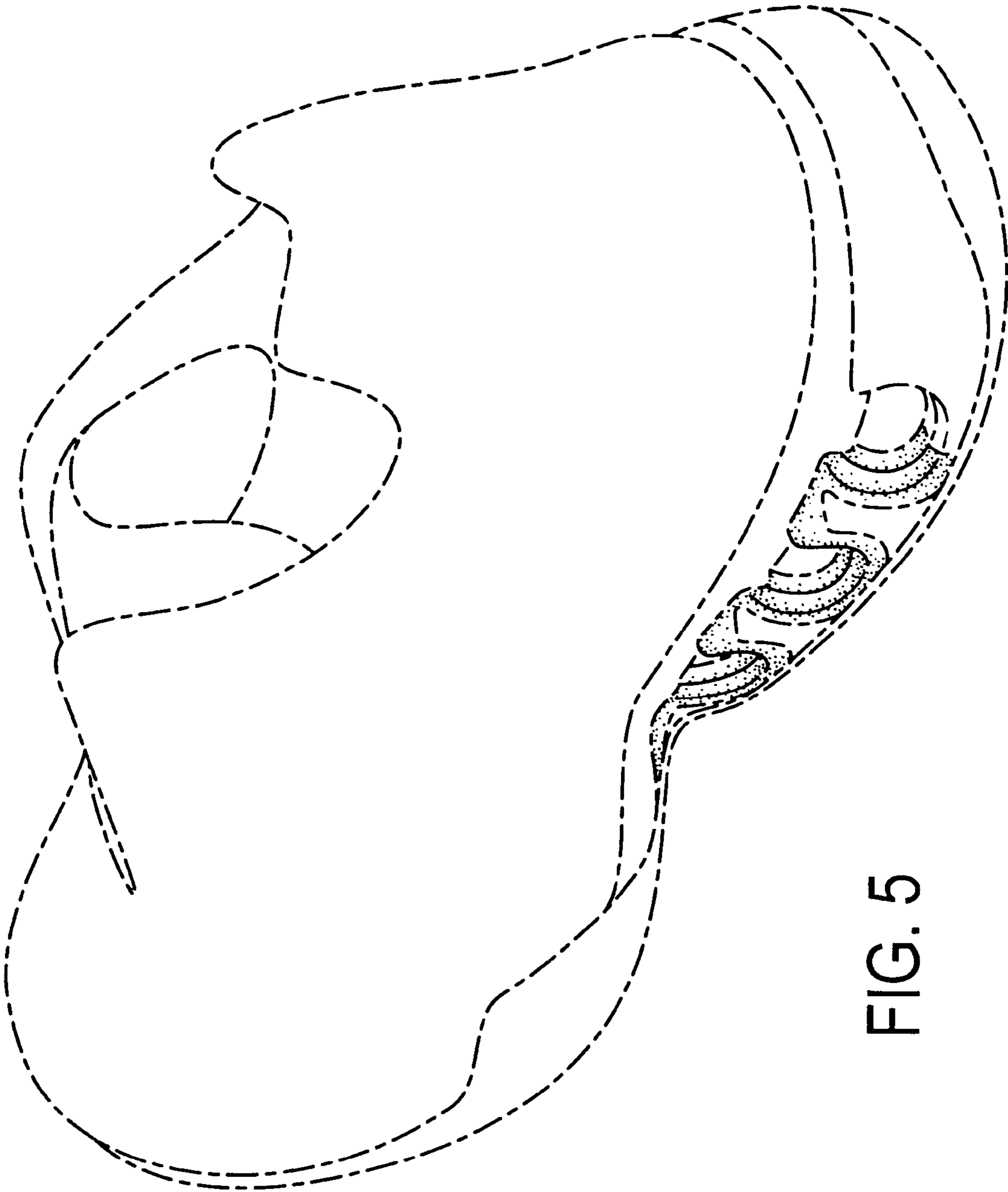

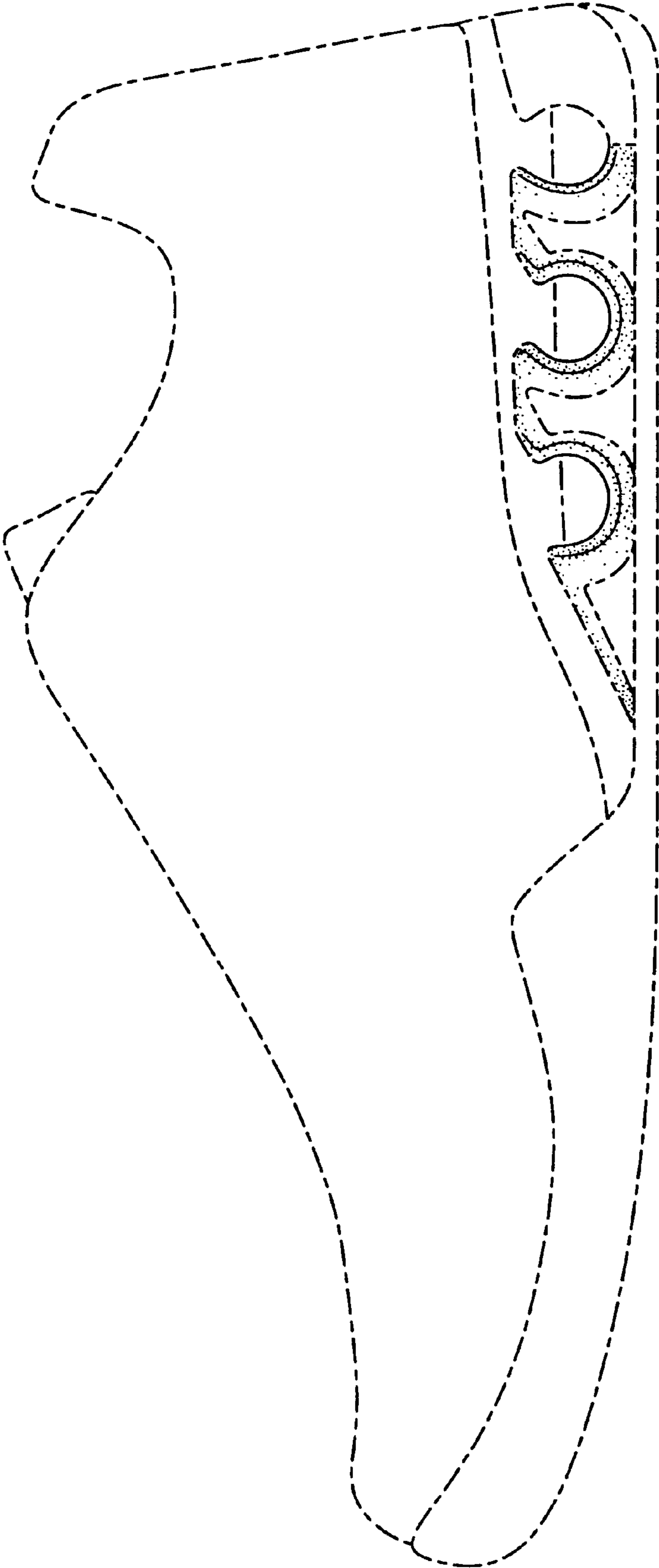
