**DESCRIPTION**

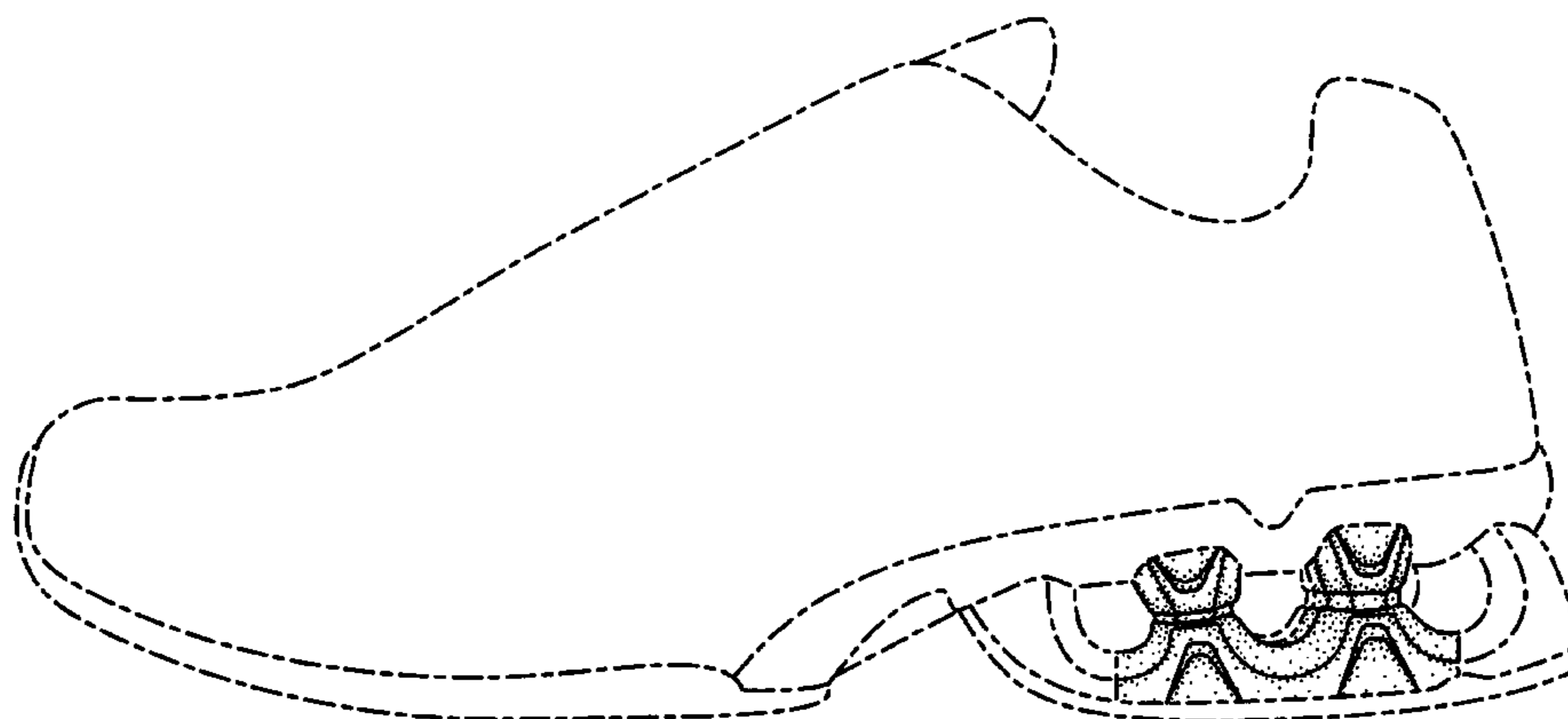
FIG. 1 is a front view of a portion of a shoe midsole showing my new design;

FIG. 2 is a rear perspective thereof; and,

FIG. 3 is a side view thereof.

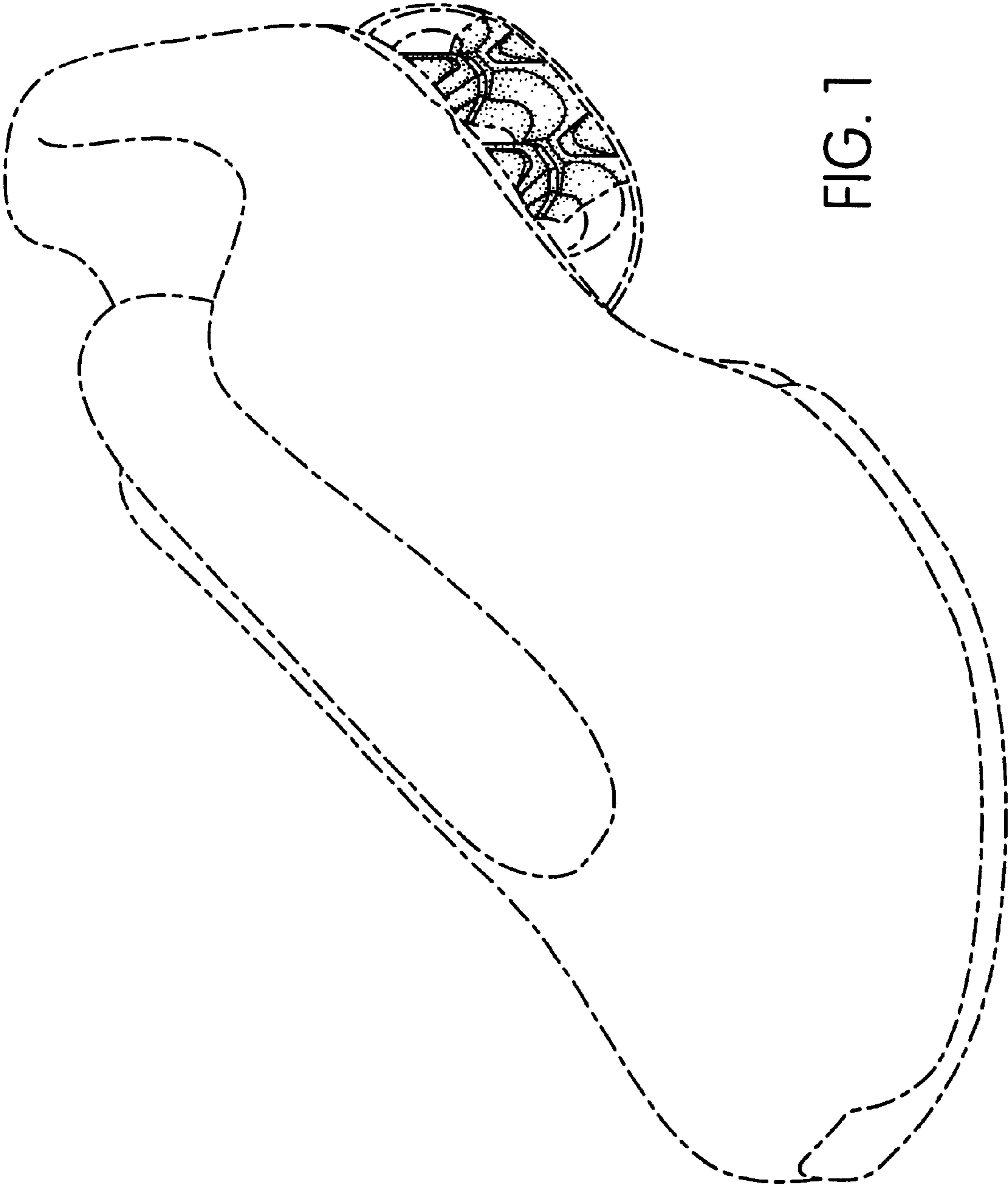

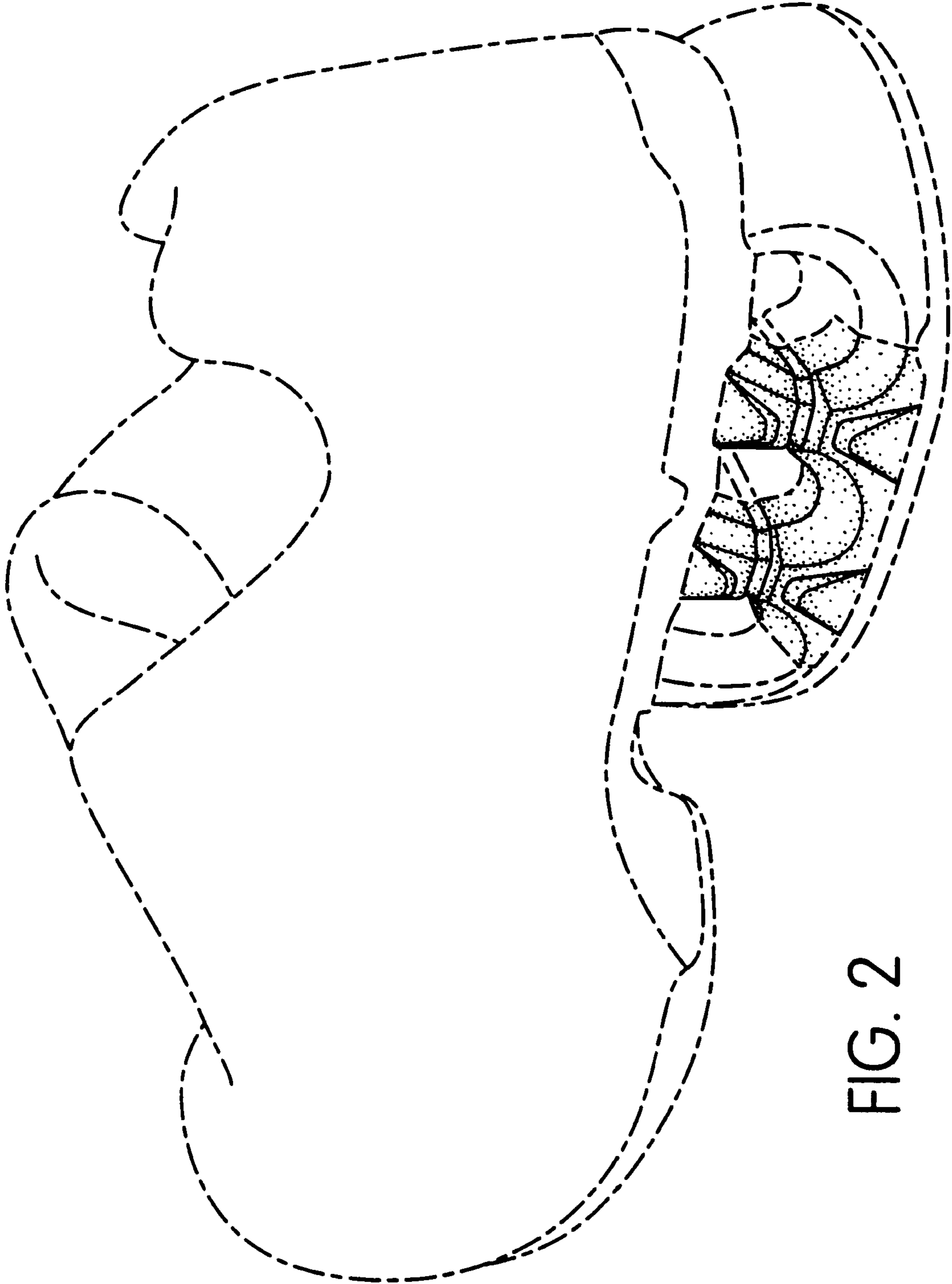

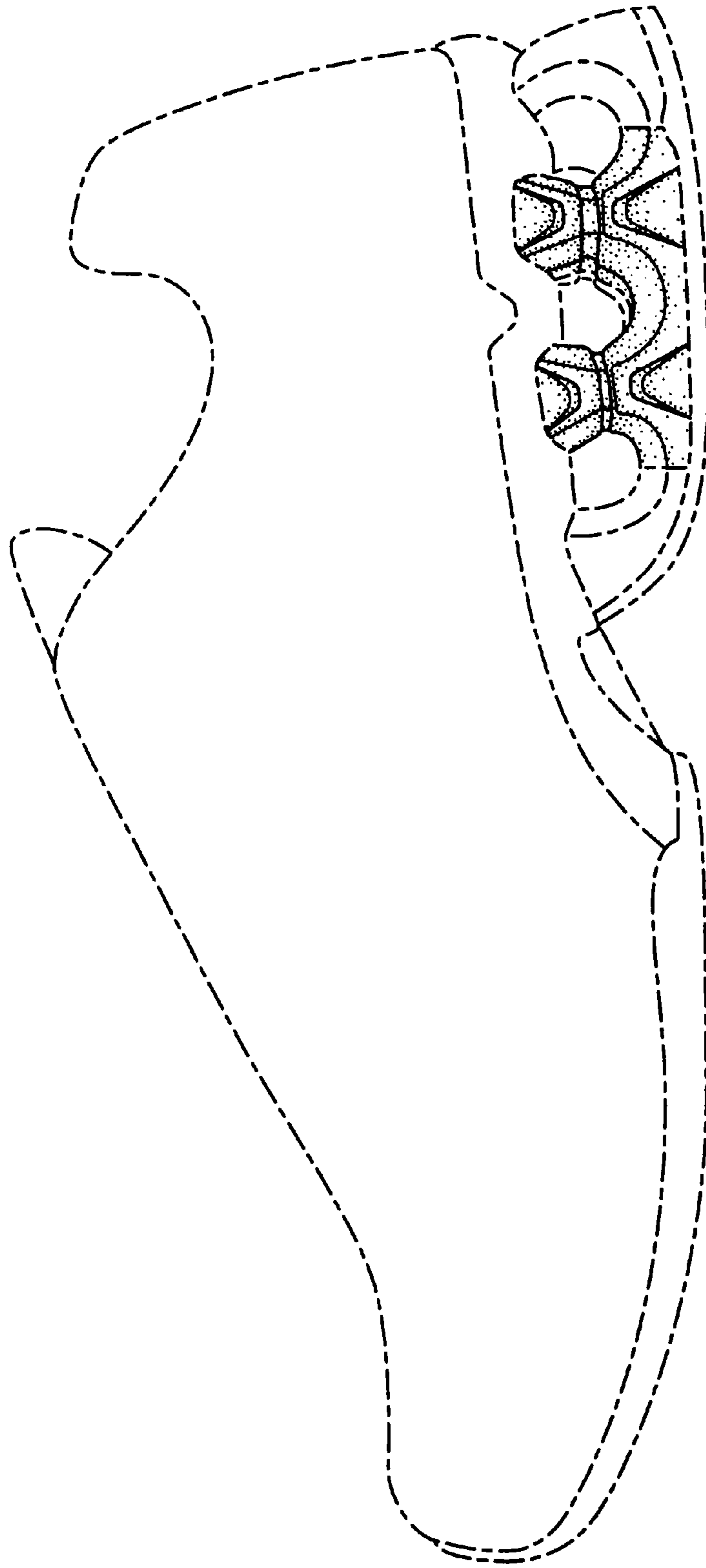
