The ornamental design for a container, as shown and described.

**DESCRIPTION**

FIG. 1 is a top plan view of a container showing our new design;

FIG. 2 is a bottom view thereof;

FIG. 3 is a left side view thereof and right side view is a mirror image of the left;

FIG. 4 is a front elevational view thereof;

FIG. 5 is a rear elevation thereof;

FIG. 6 is a perspective view thereof with a cover partially opened; and,

FIG. 7 is a bottom perspective view thereof; with the cover partially opened.

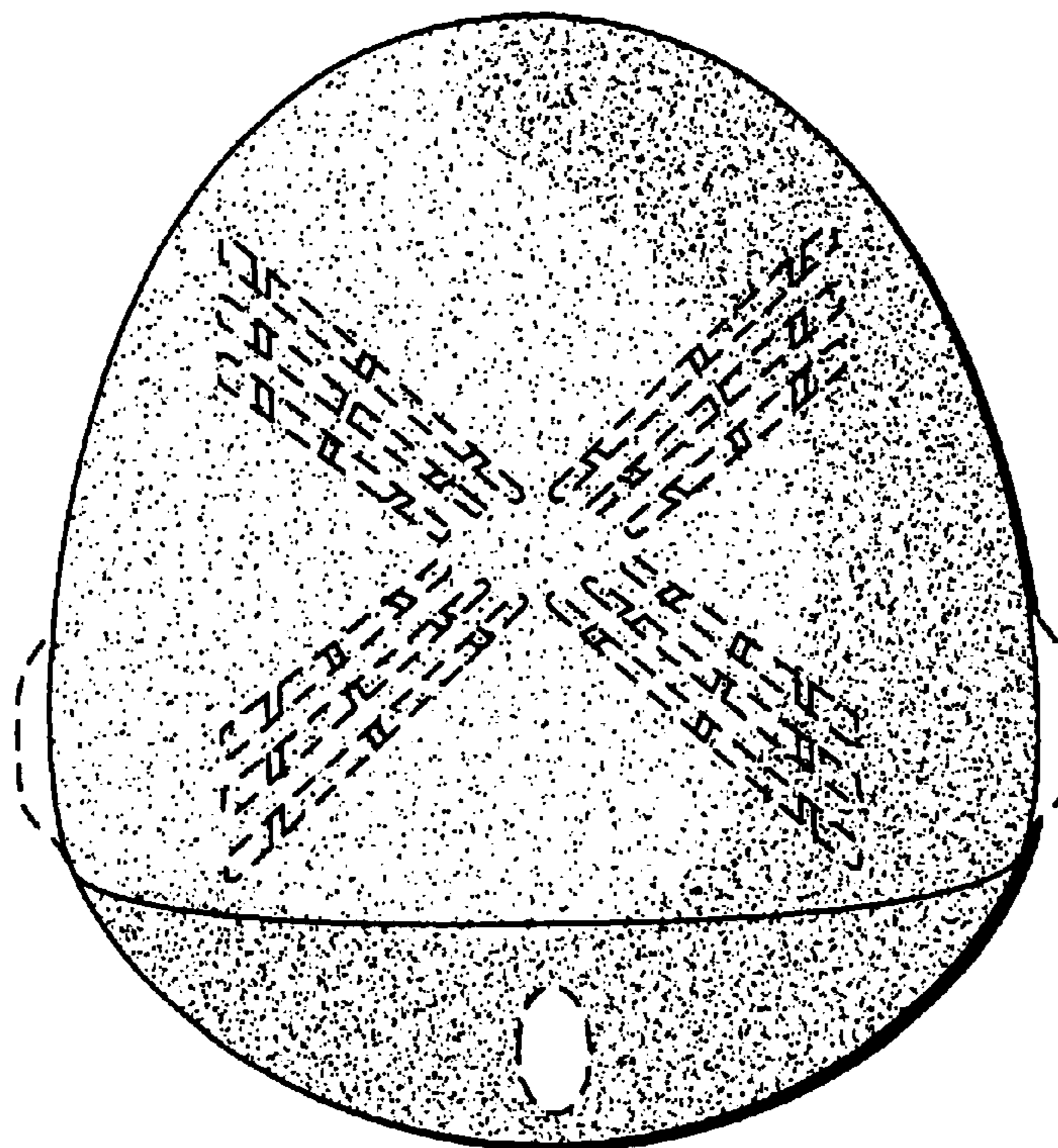

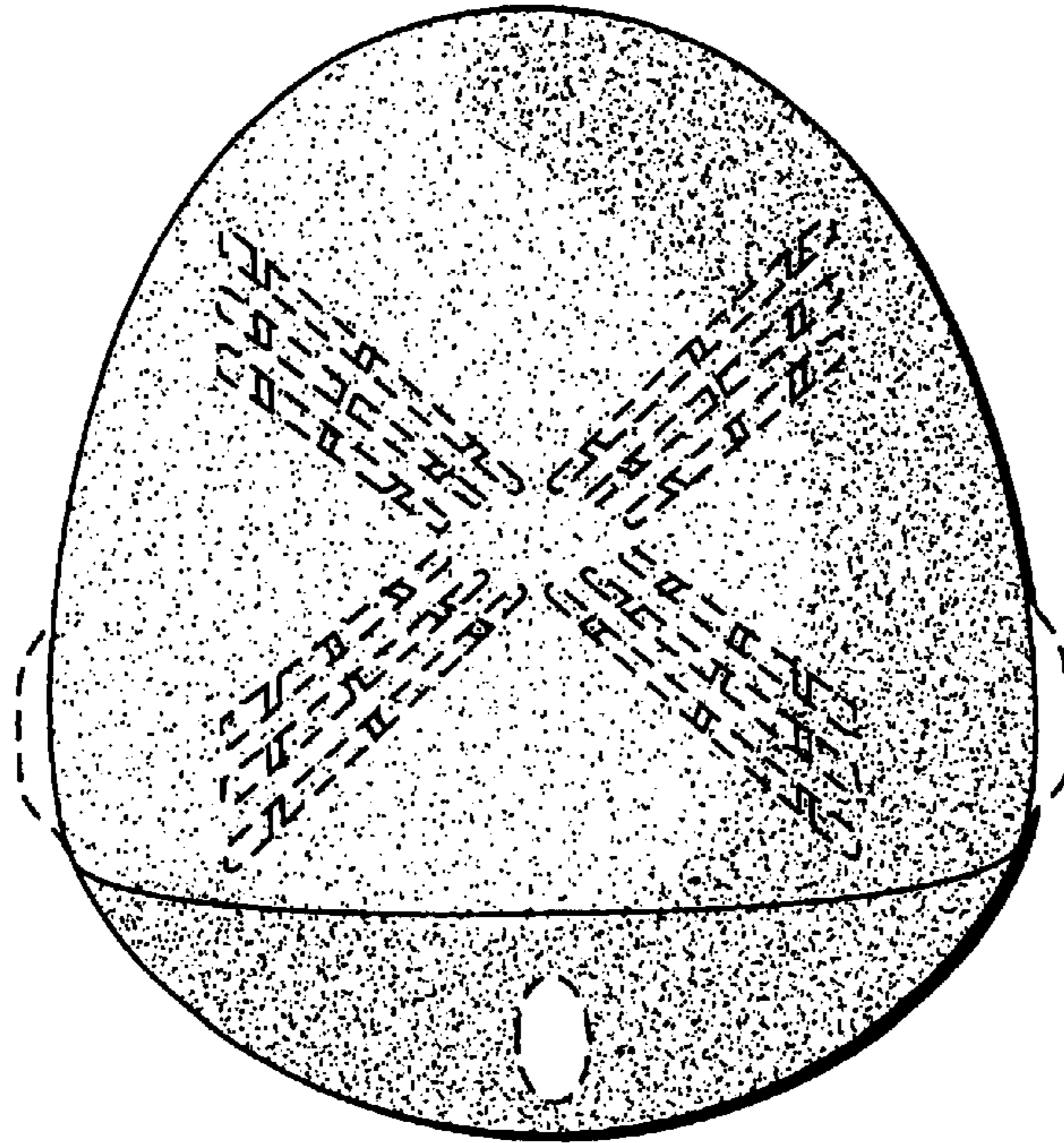
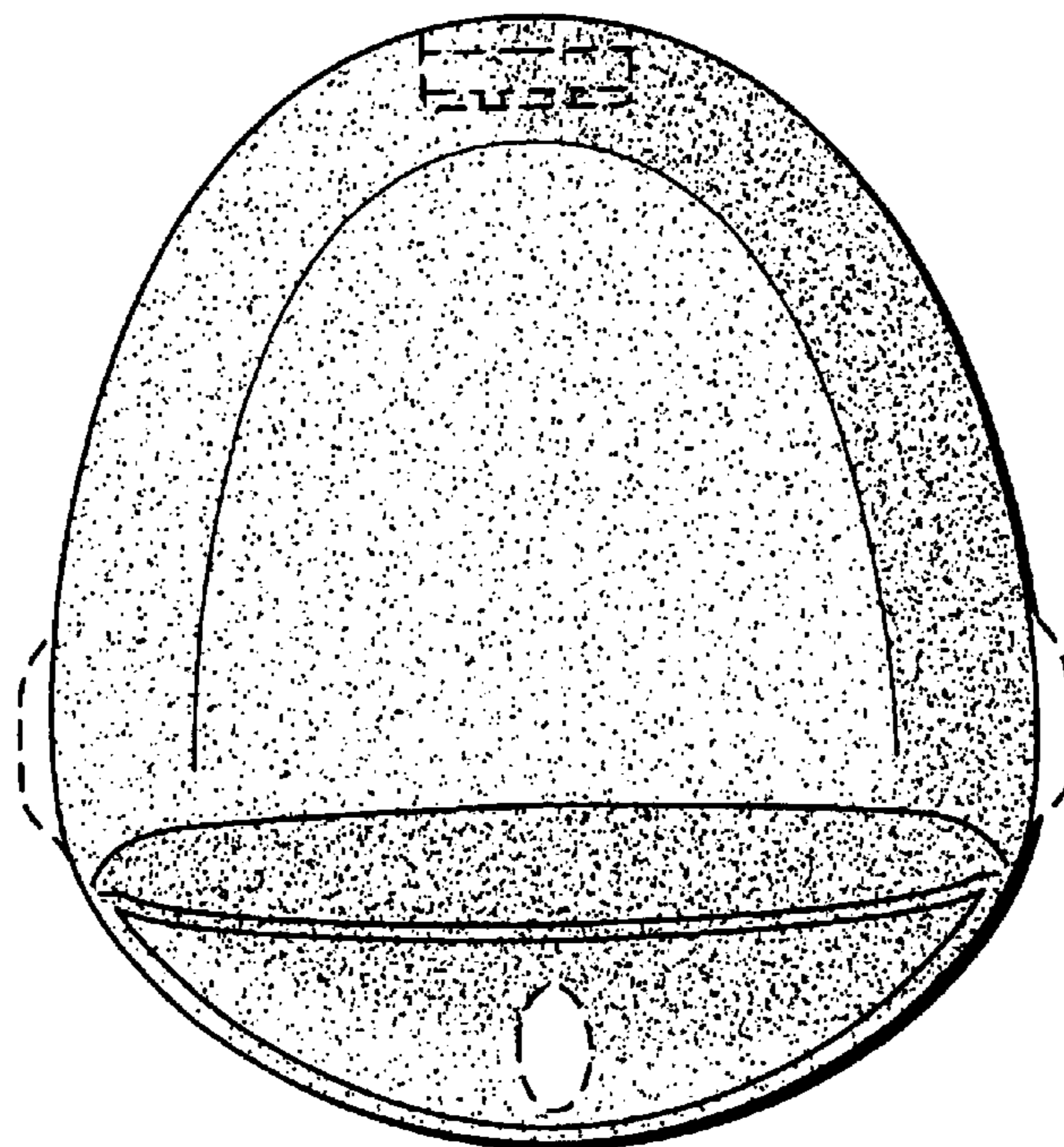
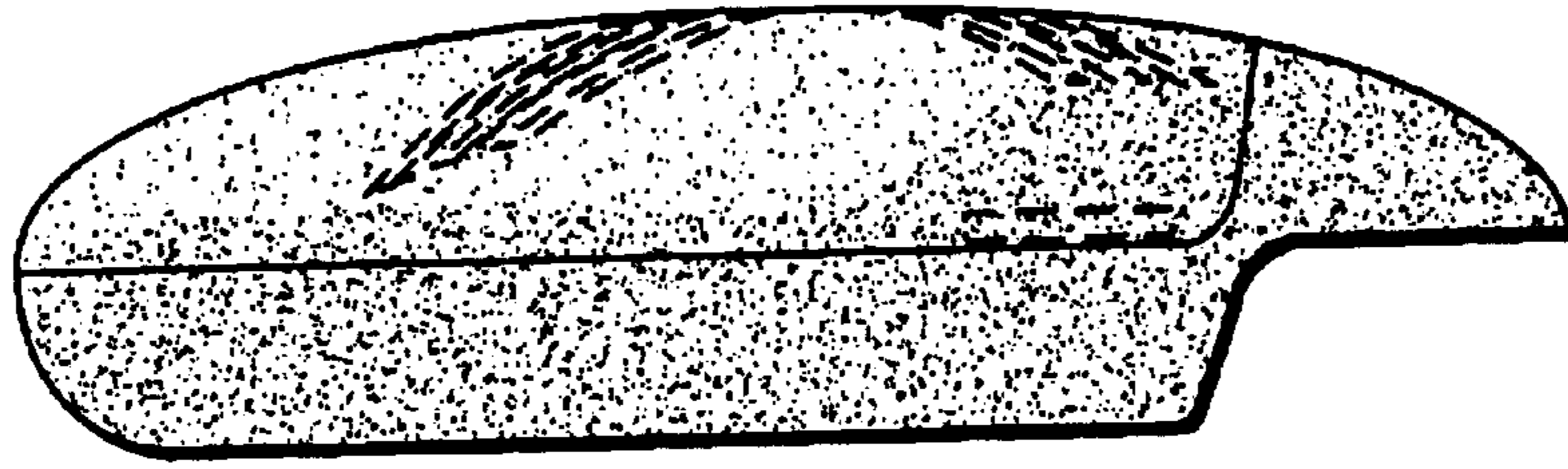

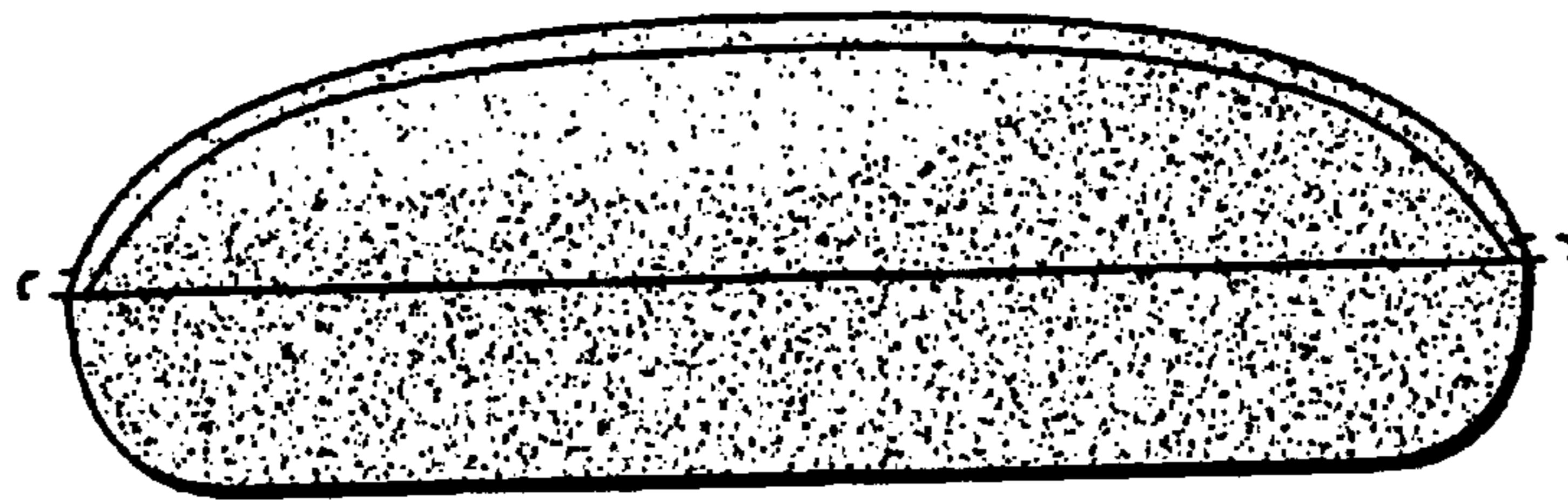

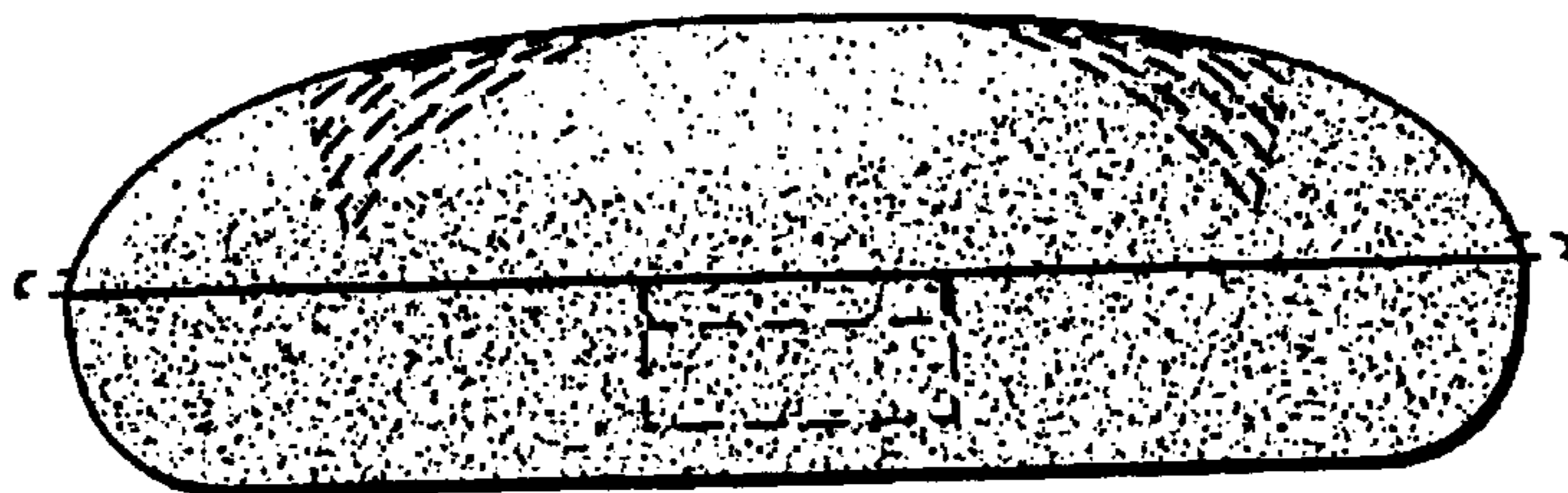

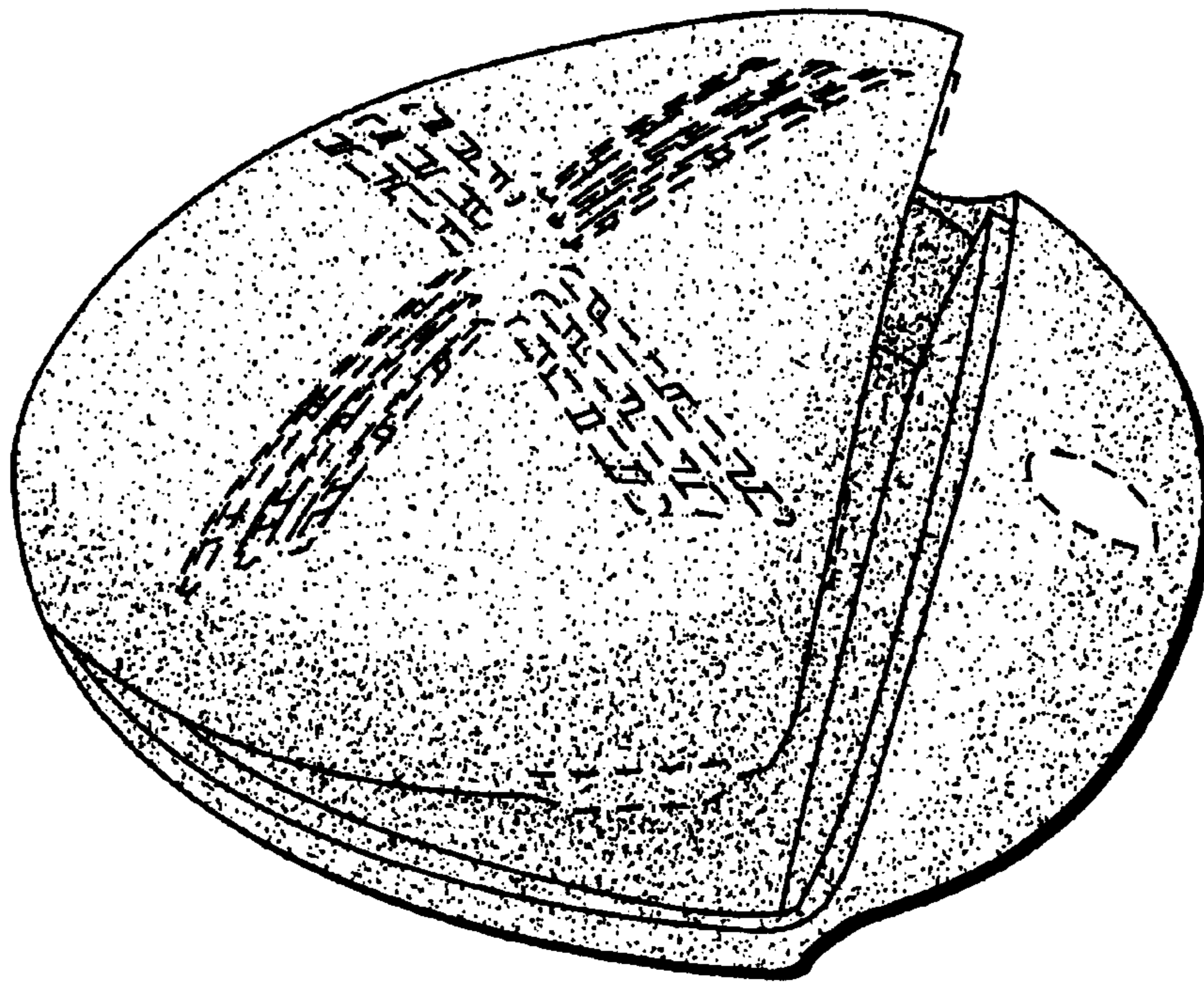
