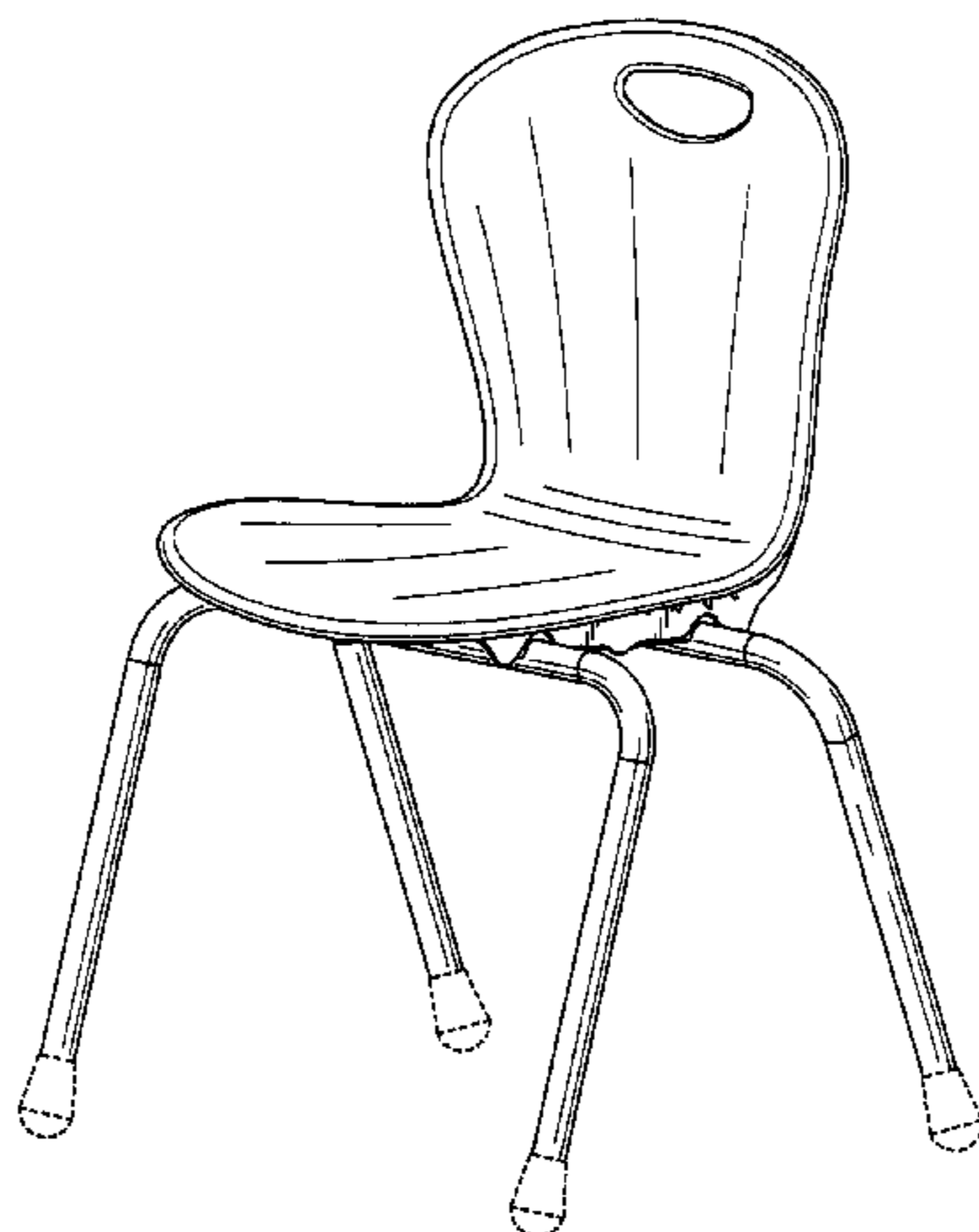
(57) **CLAIM**

The ornamental design for a chair, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the chair of the invention; FIG. 2 is a front view of the chair illustrated in FIG. 1; FIG. 3 is a left side view and the mirror image of the right side view of the chair illustrated in FIG. 1; FIG. 4 is a top view of the chair illustrated in FIG. 1; FIG. 5 is a bottom view of the chair illustrated in FIG. 1; and, FIG. 6 is a rear view of the chair illustrated in FIG. 1. The broken lines shown in the drawing are for illustrative purposes only and form no part of the claimed design.

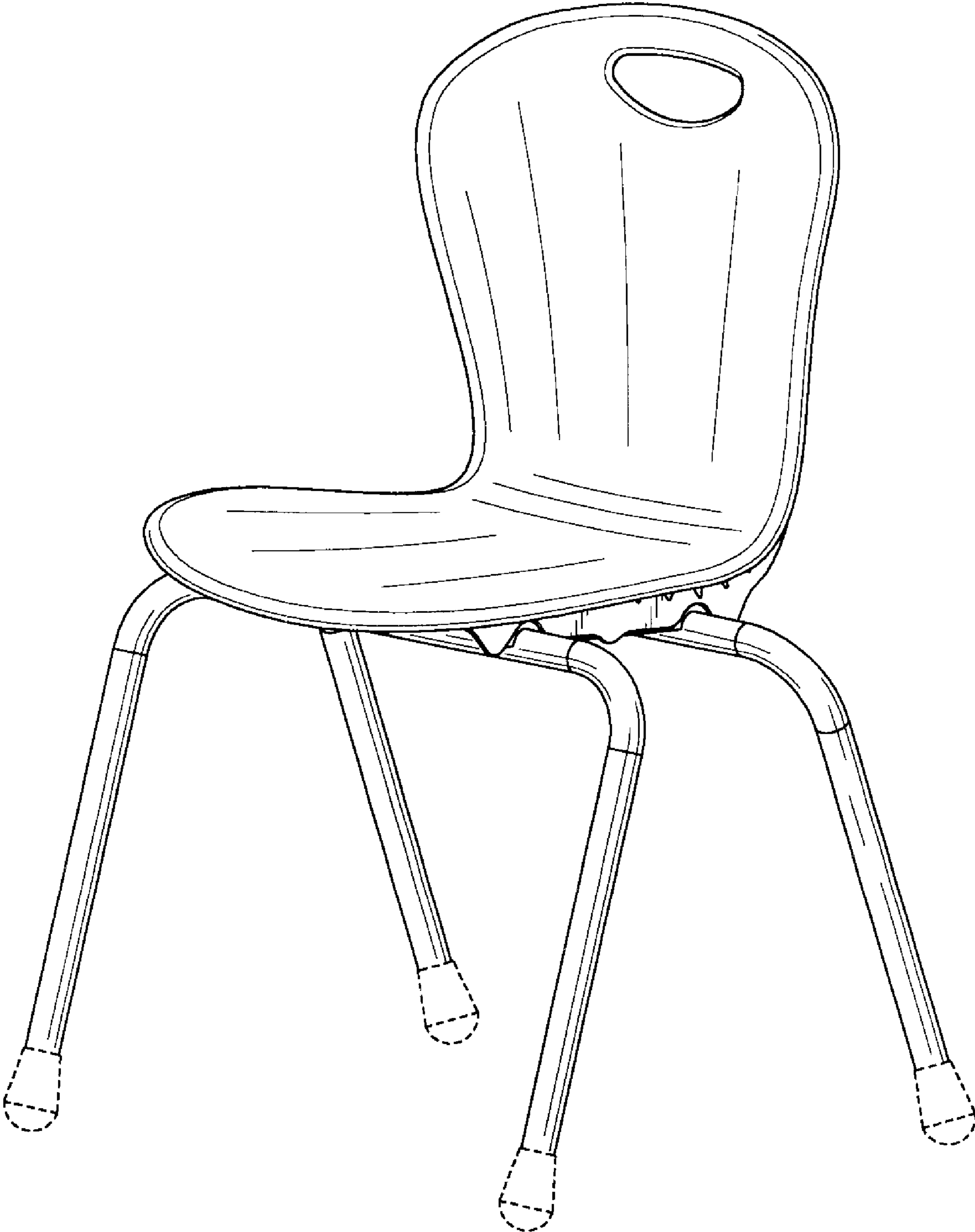

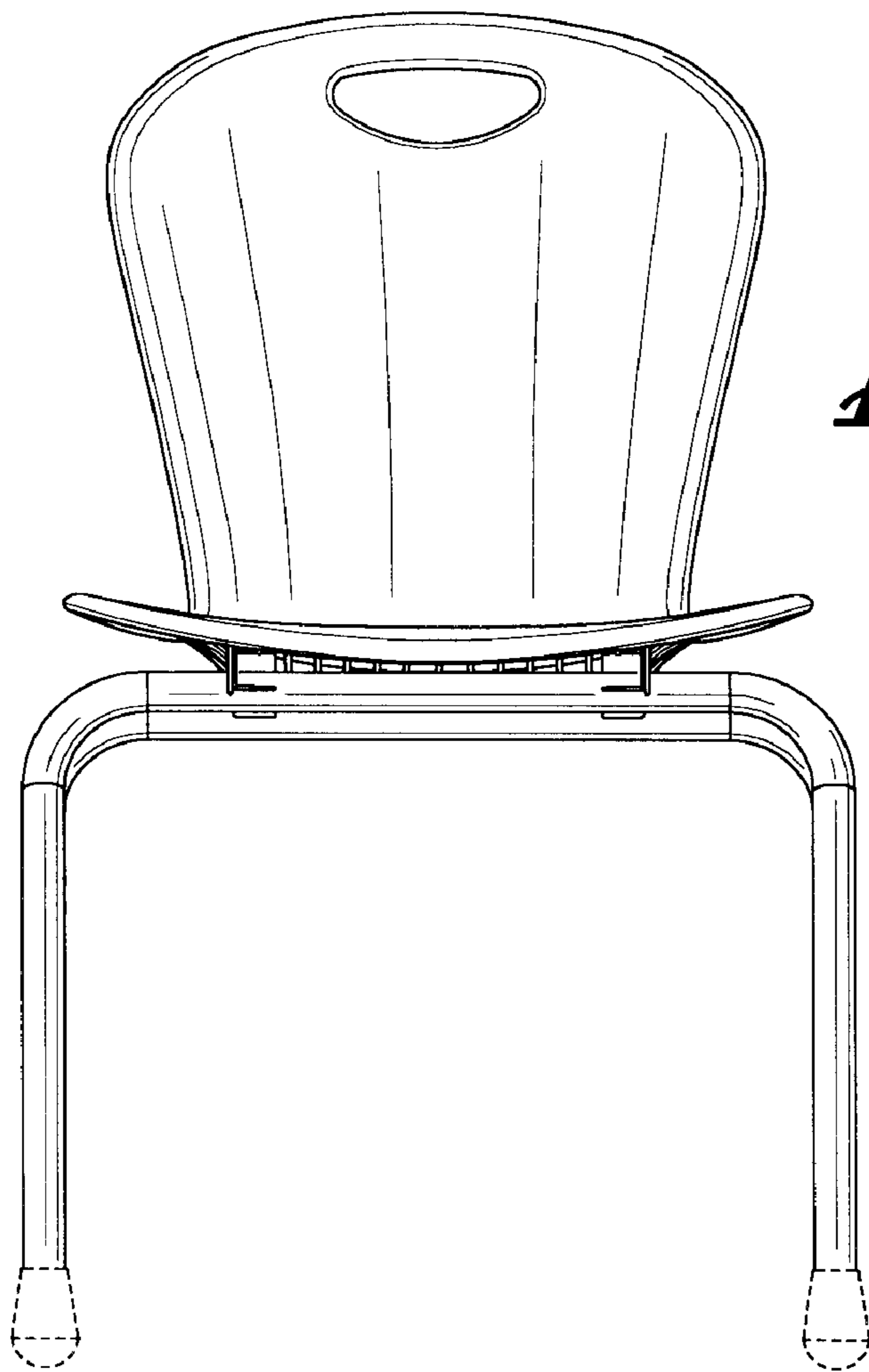

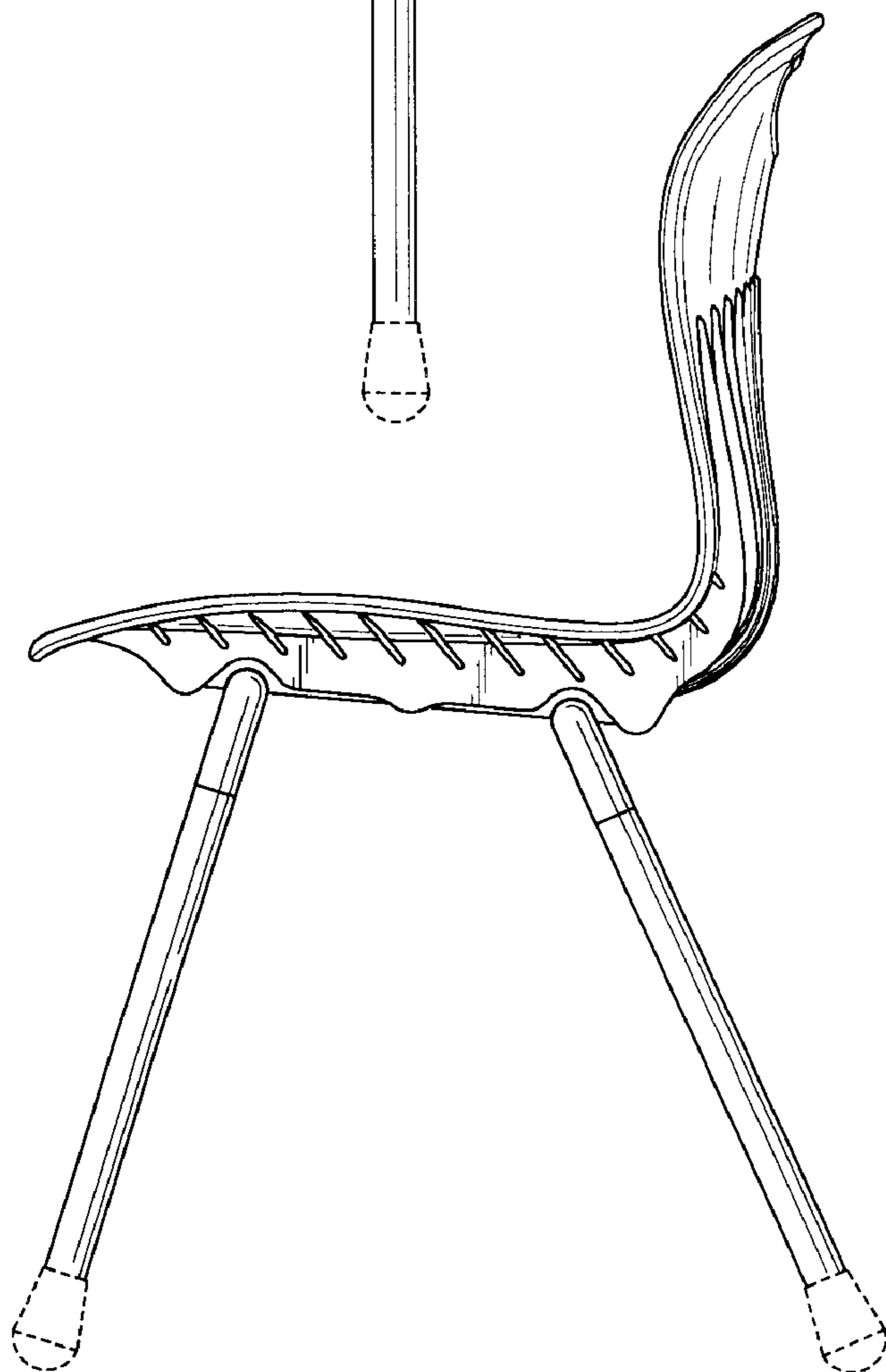

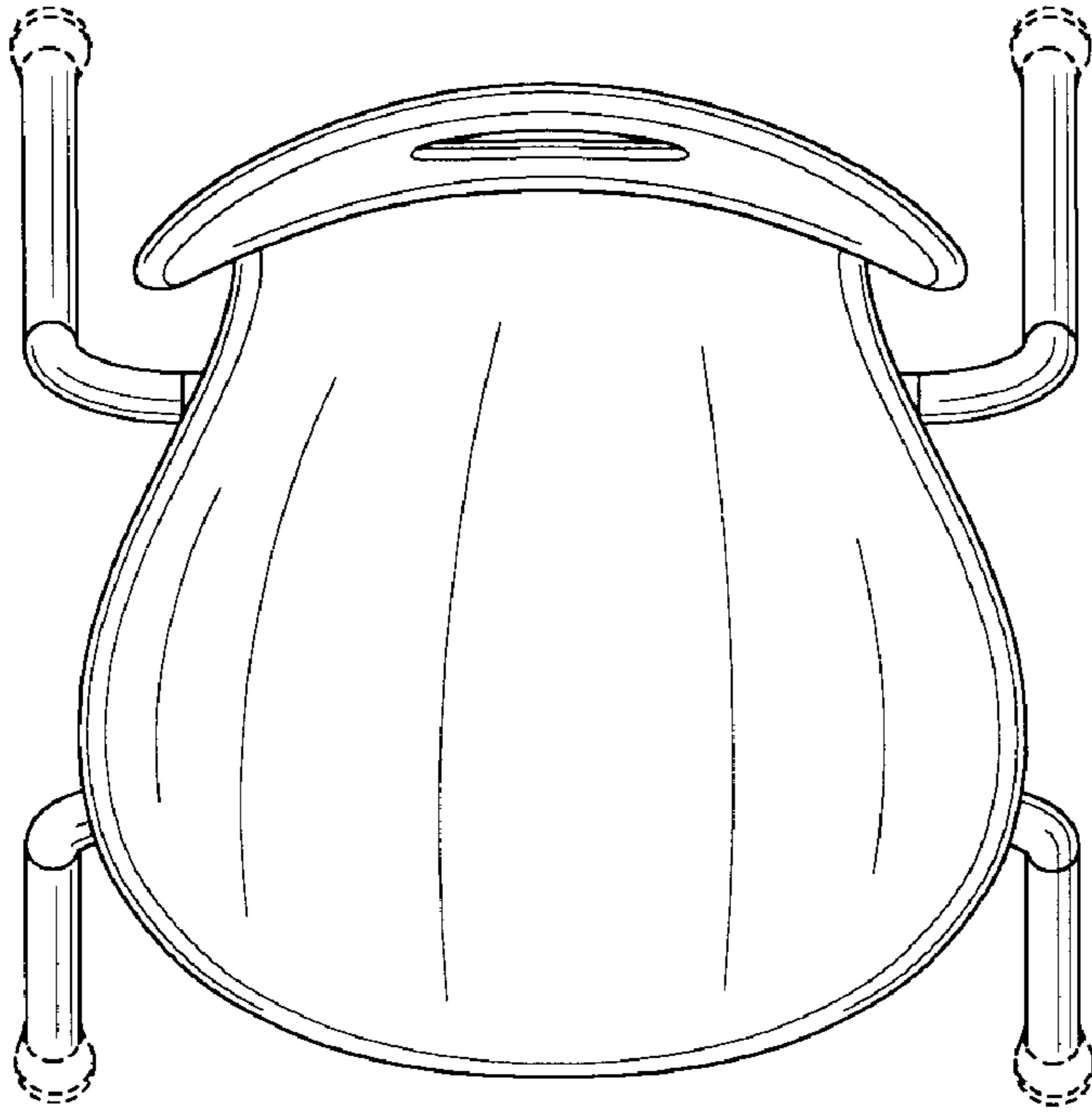

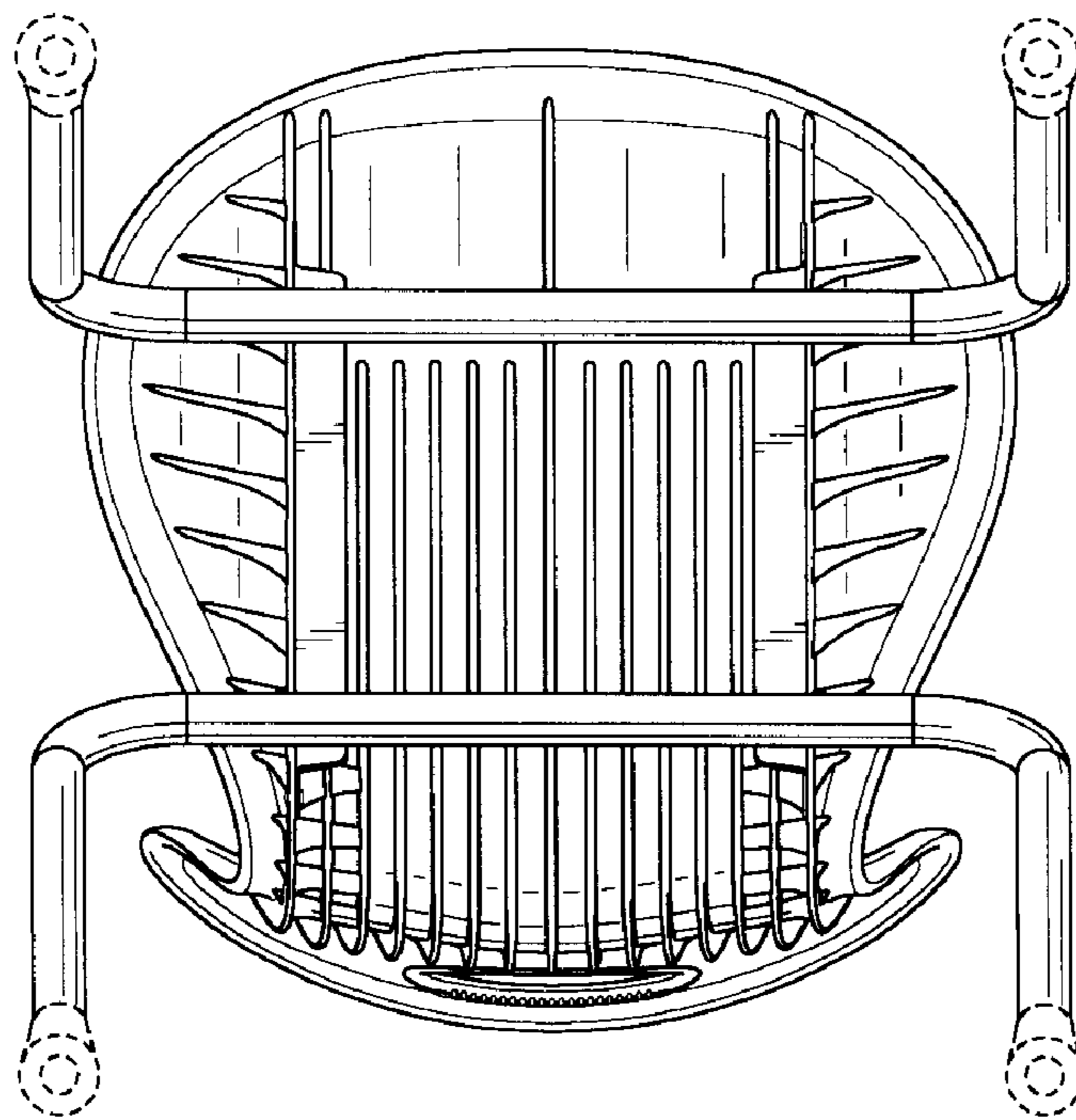

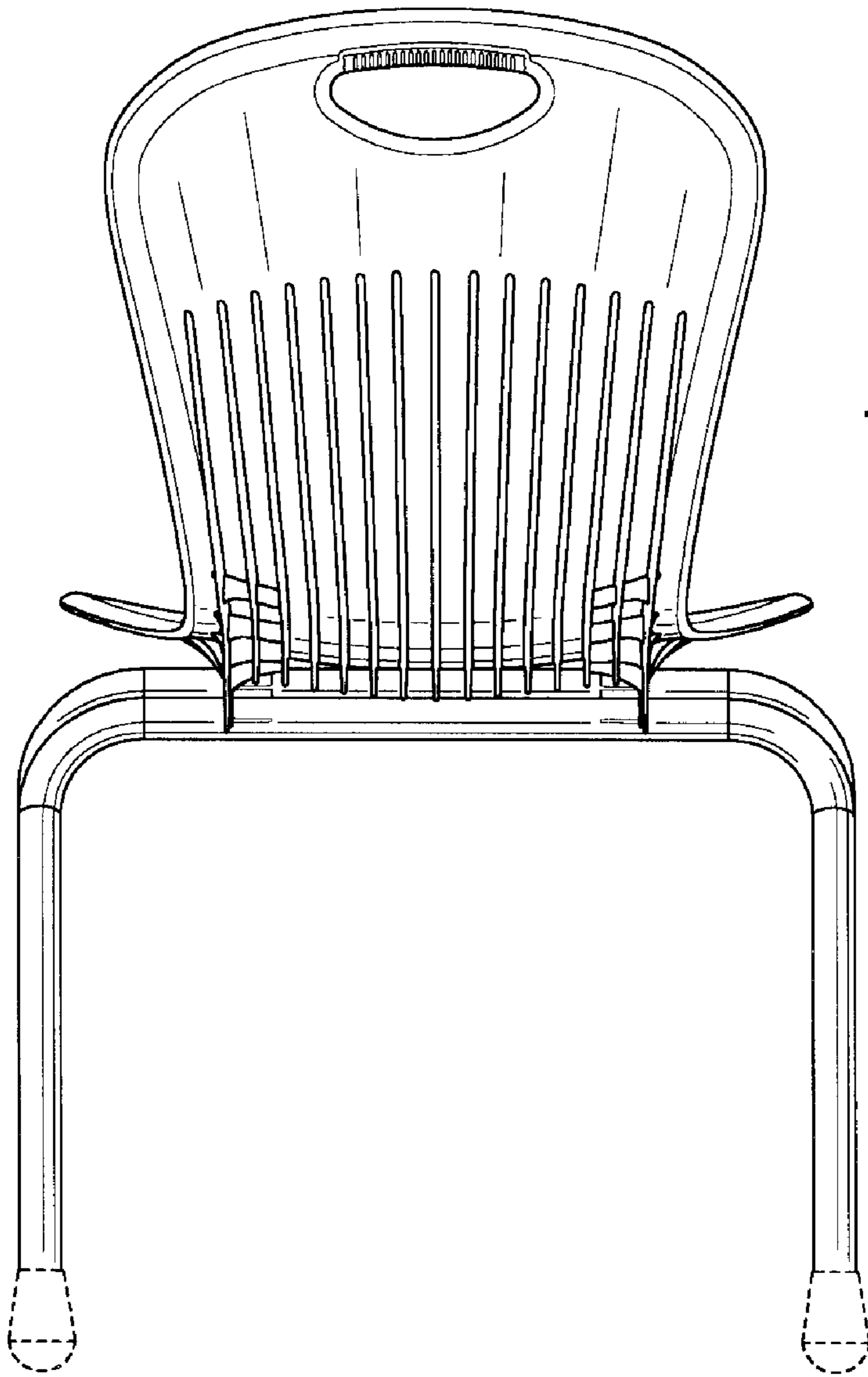
