DESCRIPTION

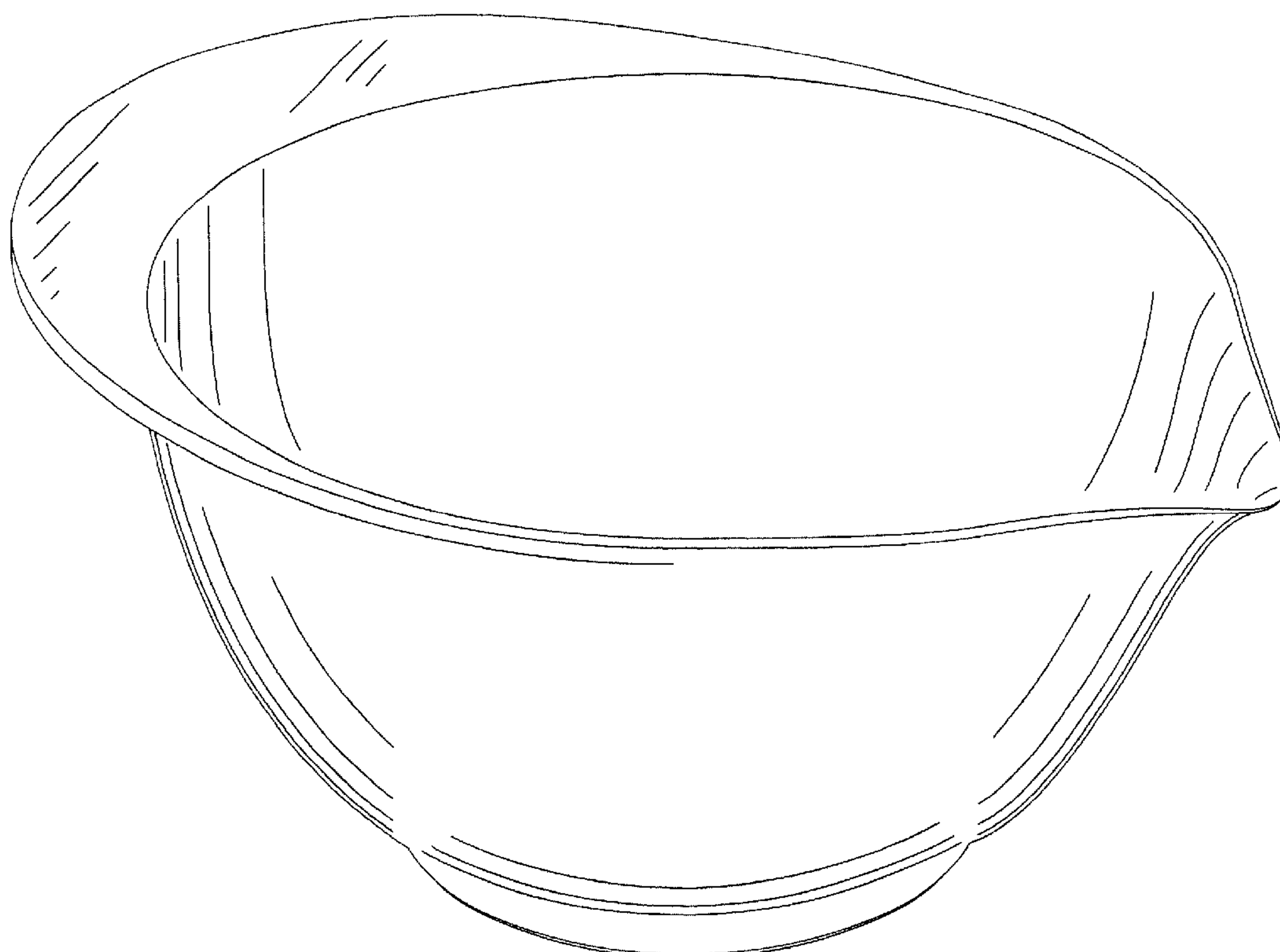
FIG. 1 is a top perspective view of a bowl showing our new design;

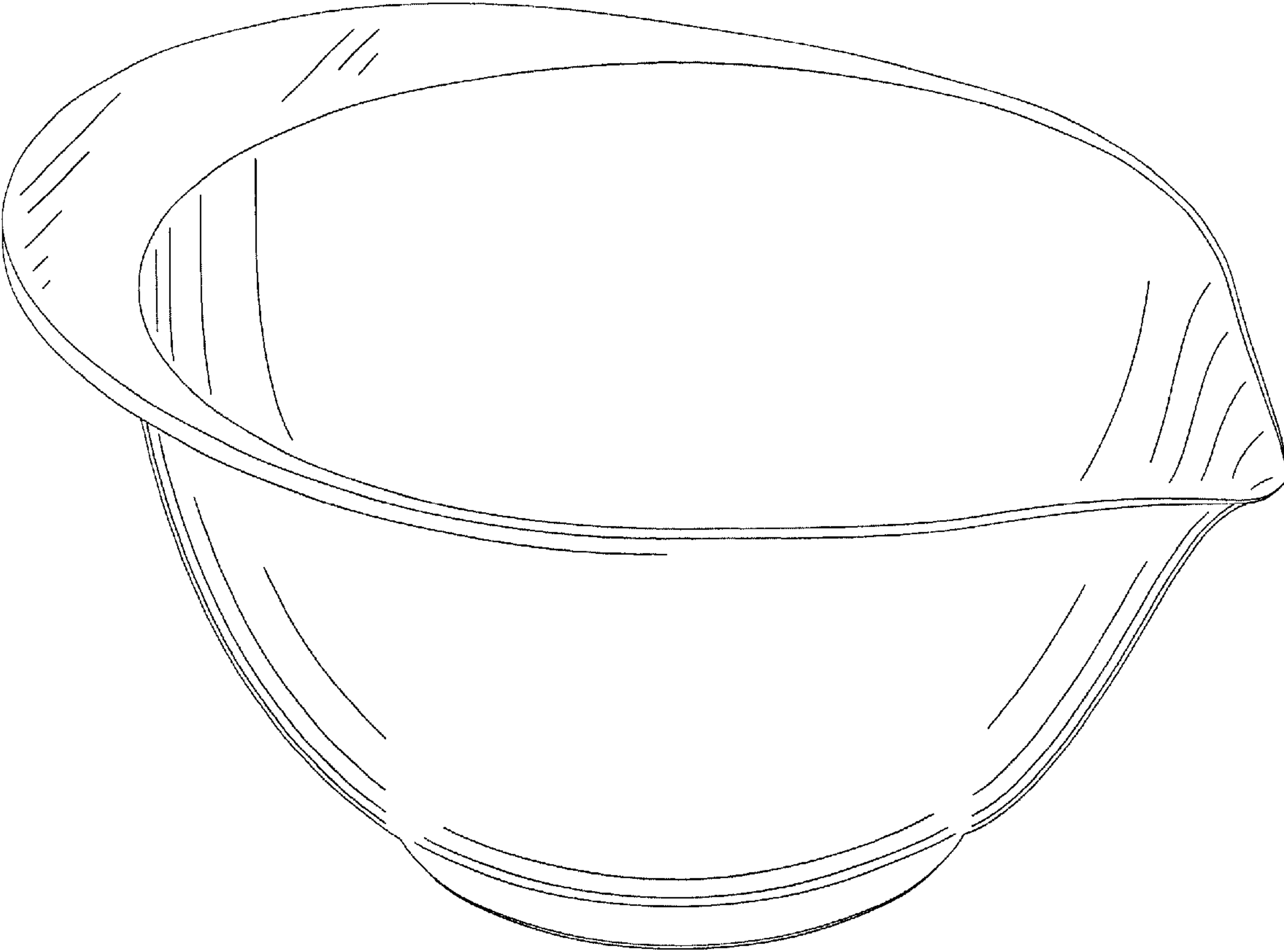

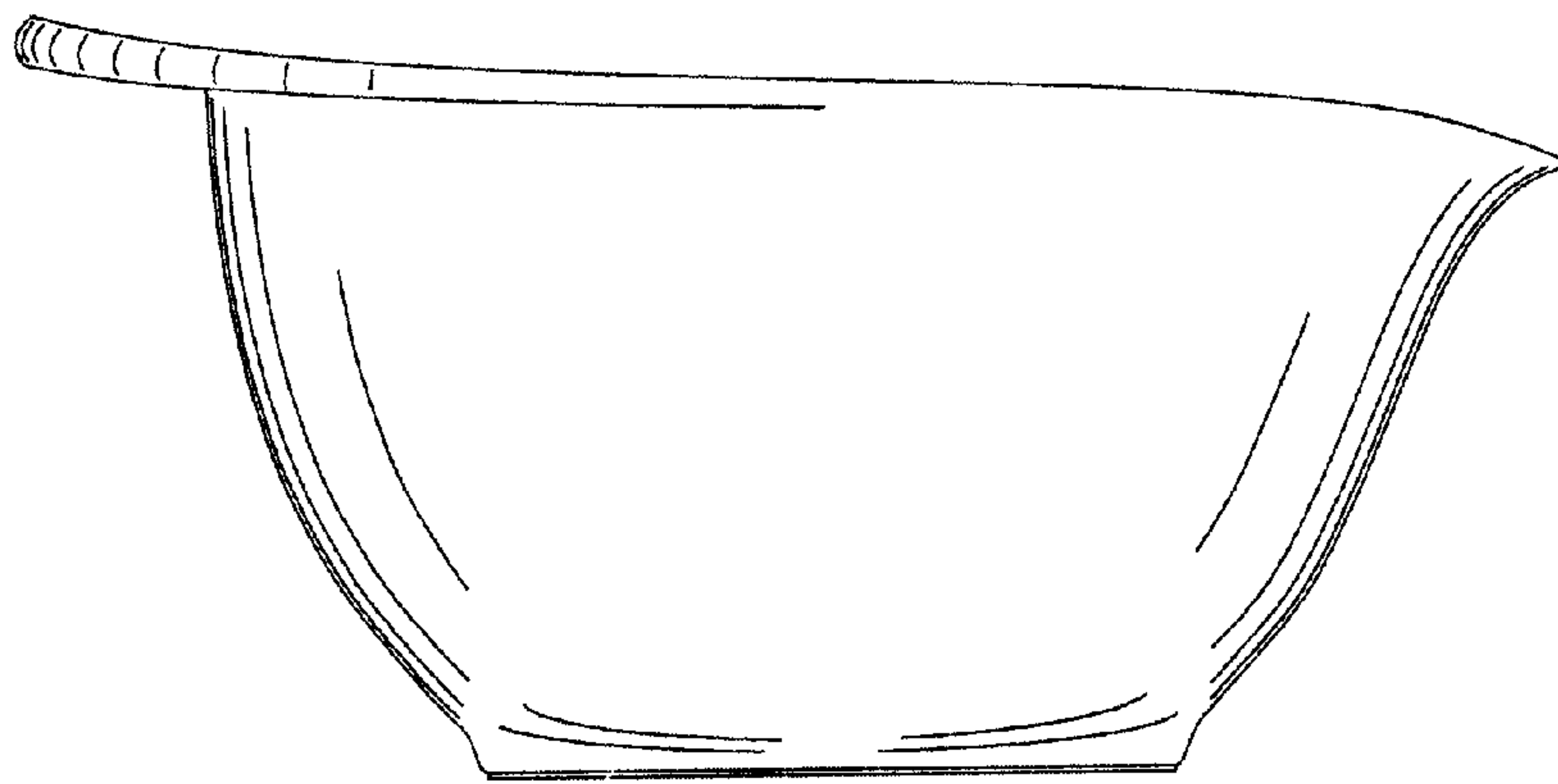

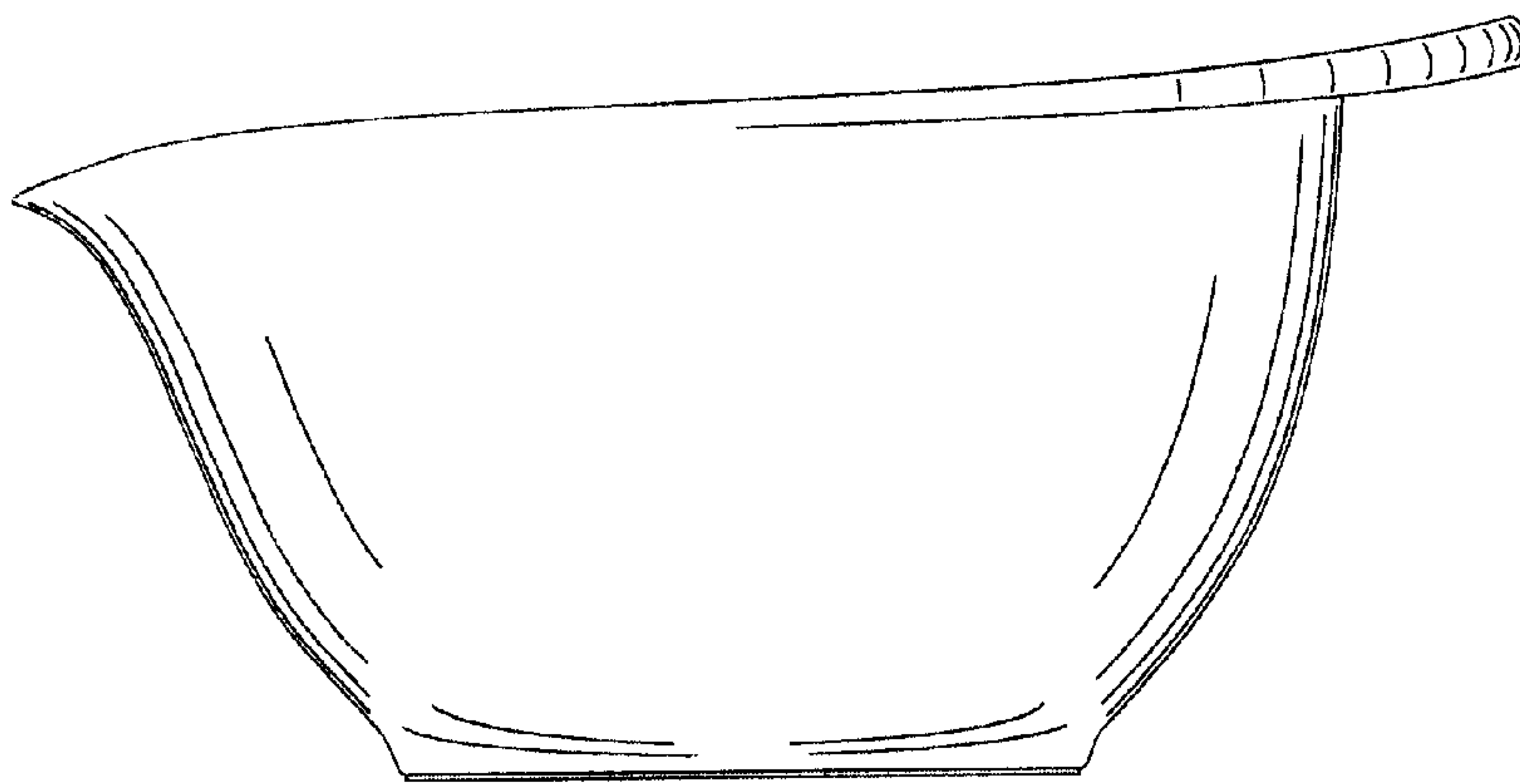

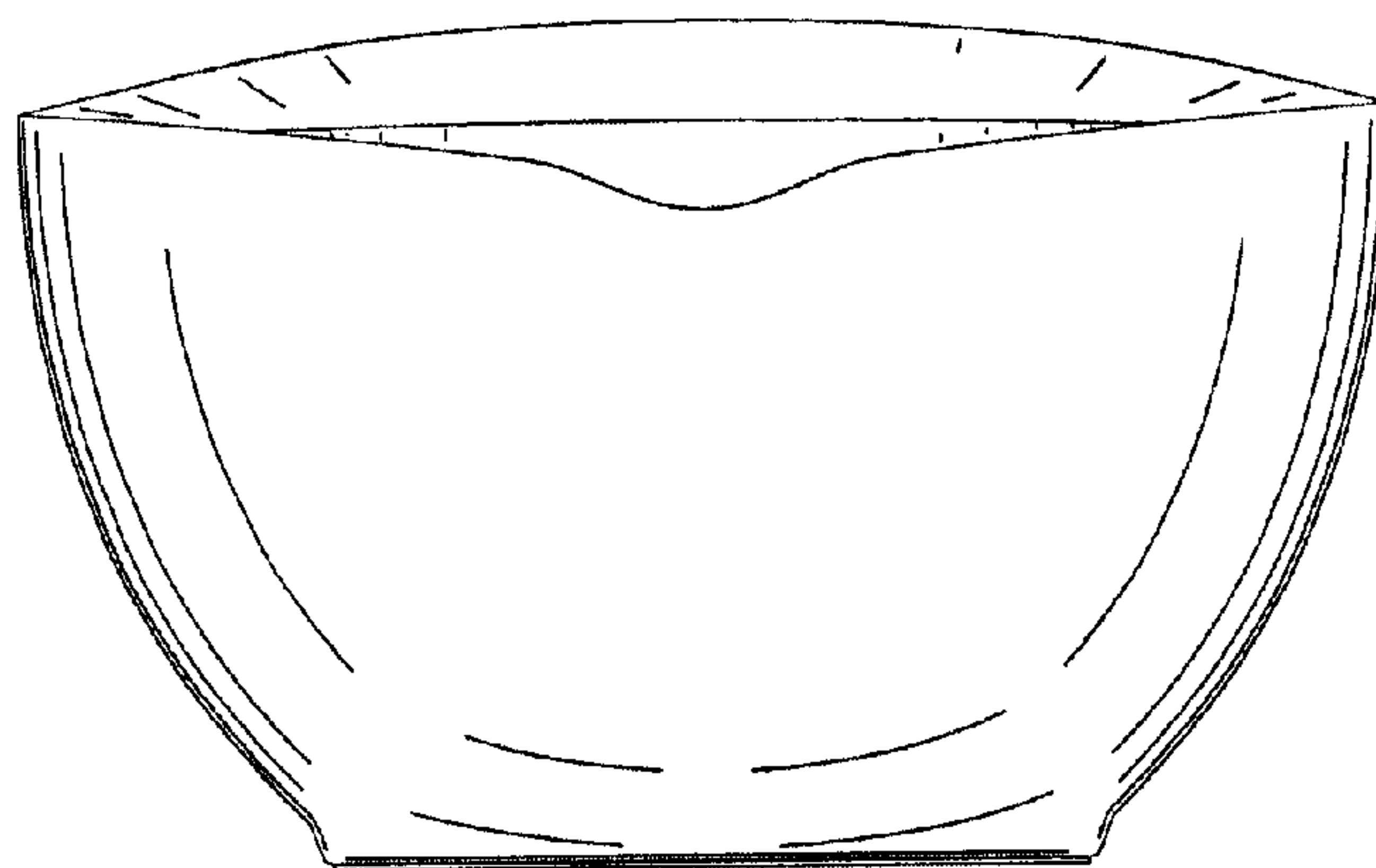

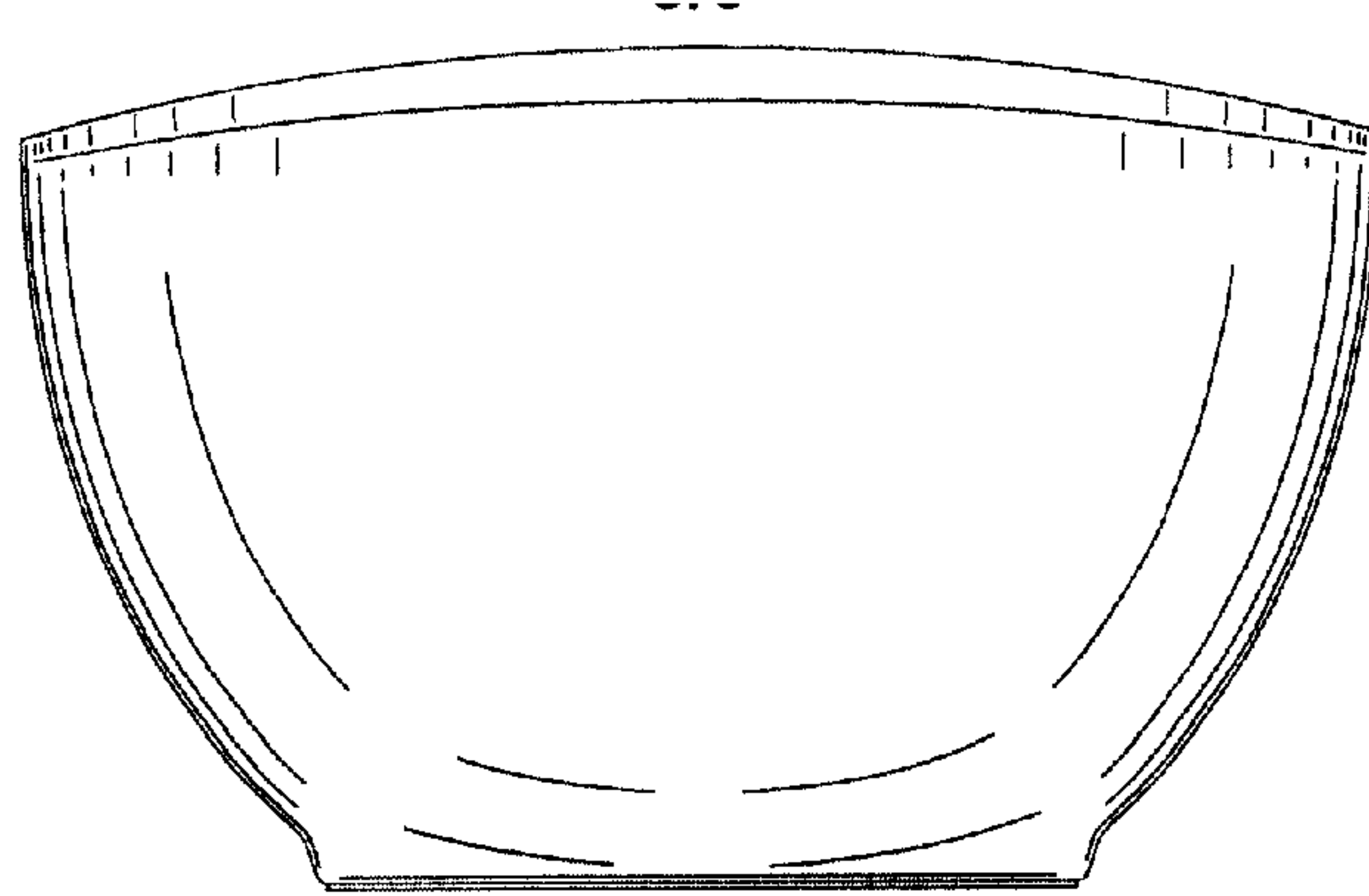

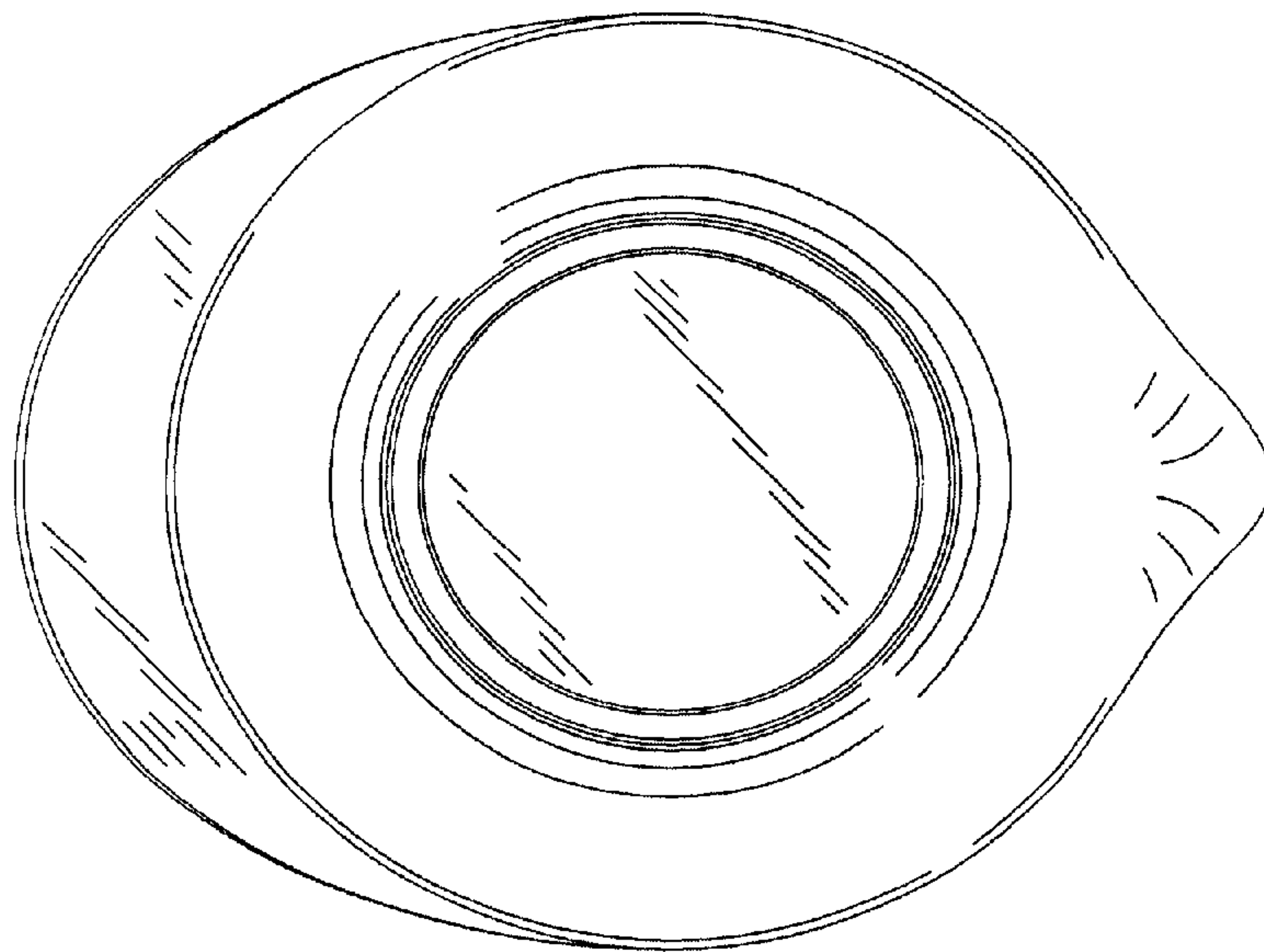

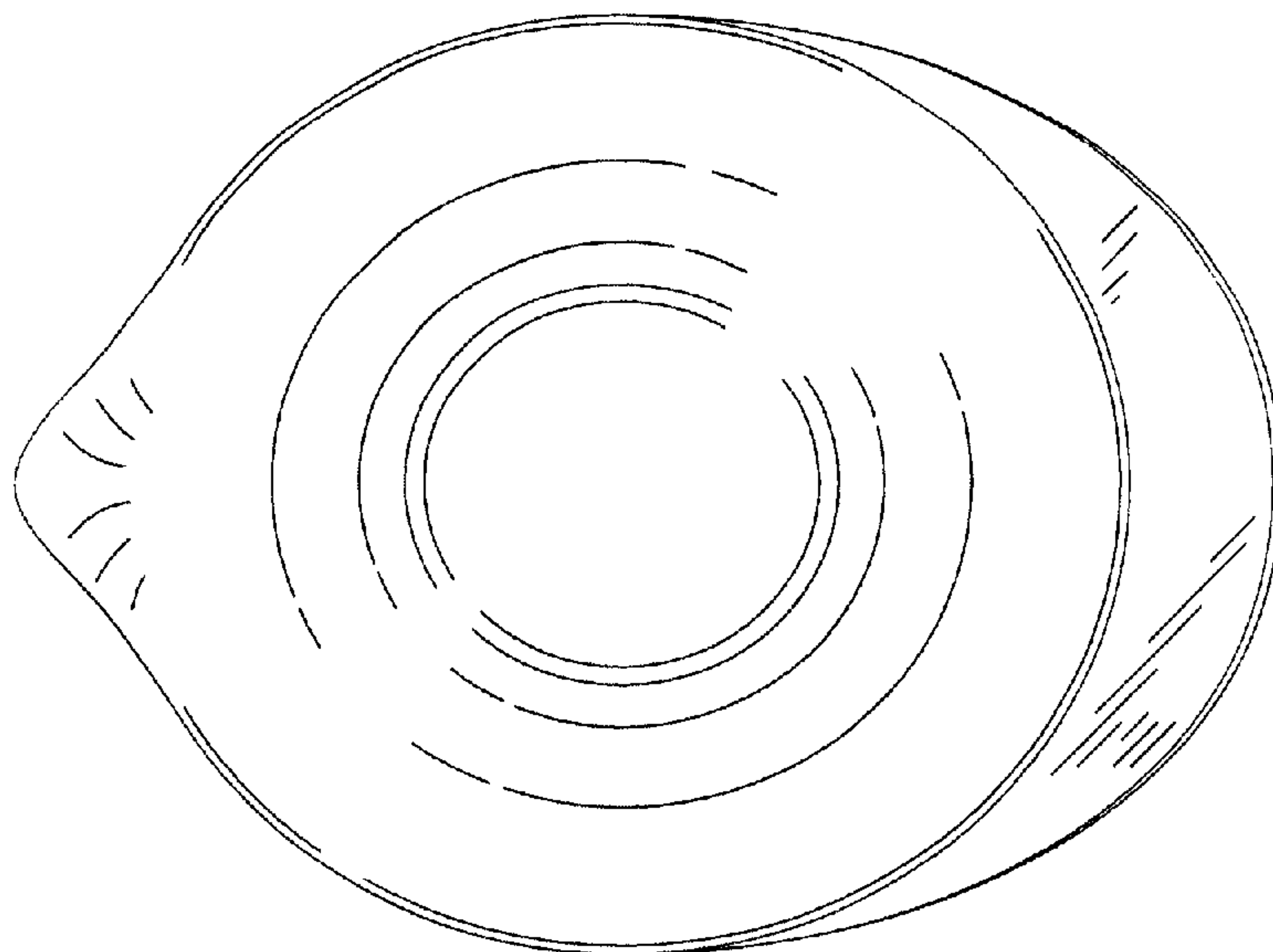
