DESCRIPTION

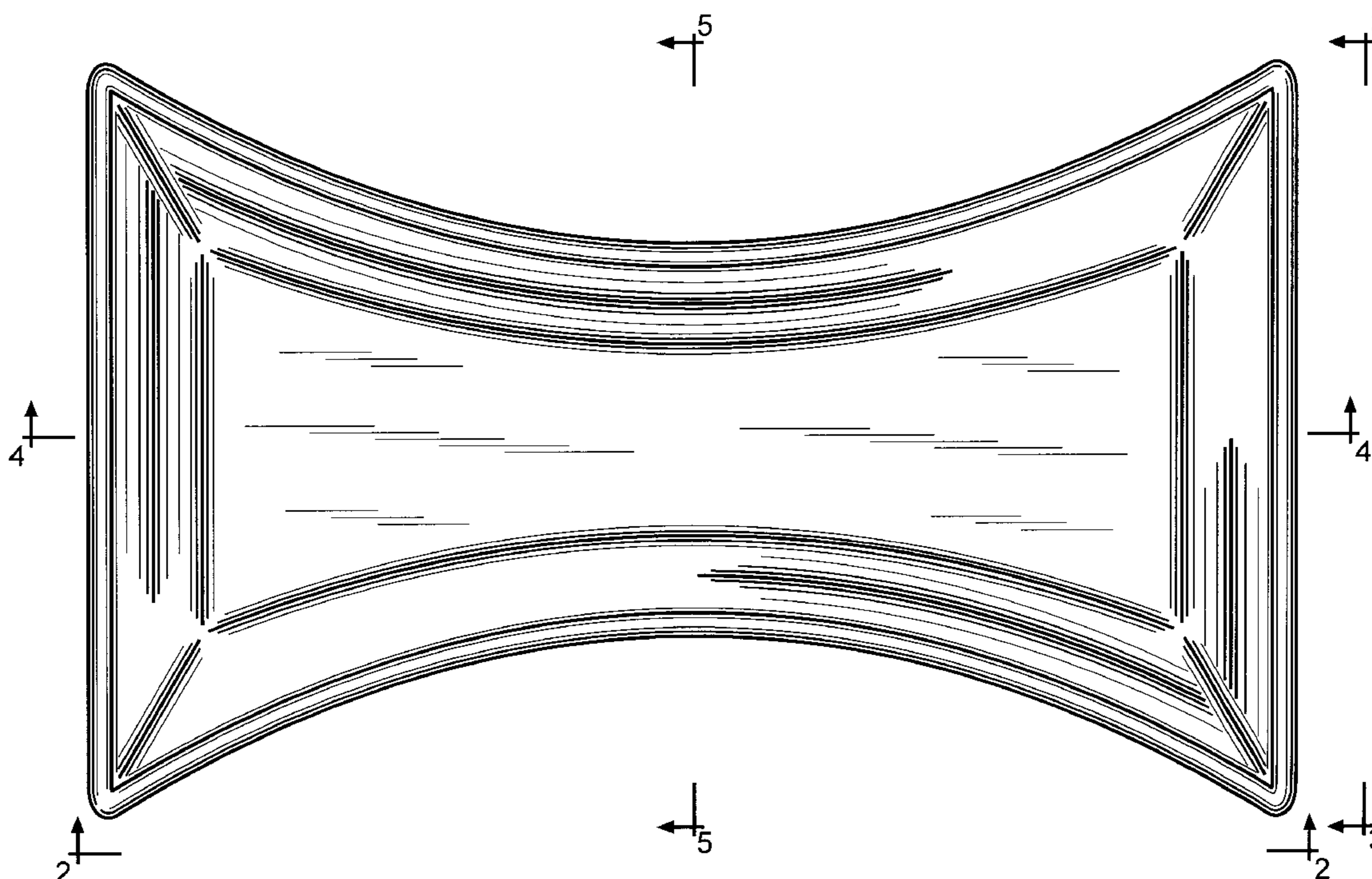
FIG. 1 is a top plan view of a plate according to the present design;
FIG. 2 is a front elevational view thereof taken along line 2—2 of FIG. 1; the rear elevational view being the same;
FIG. 3 is a right side elevational view thereof taken along line 3—3 of FIG. 1; the left side elevational view being the same;
FIG. 4 is a cross-sectional view thereof taken along line 4—4 of FIG. 1;
FIG. 5 is a cross-sectional elevational view thereof taken along line 5—5 of FIG. 1;
FIG. 6 is a bottom plan view thereof; and,
FIG. 7 is a top plan view showing a plate with three additional plates shown in broken line for illustrative purposes only and forming no part of the claimed design.

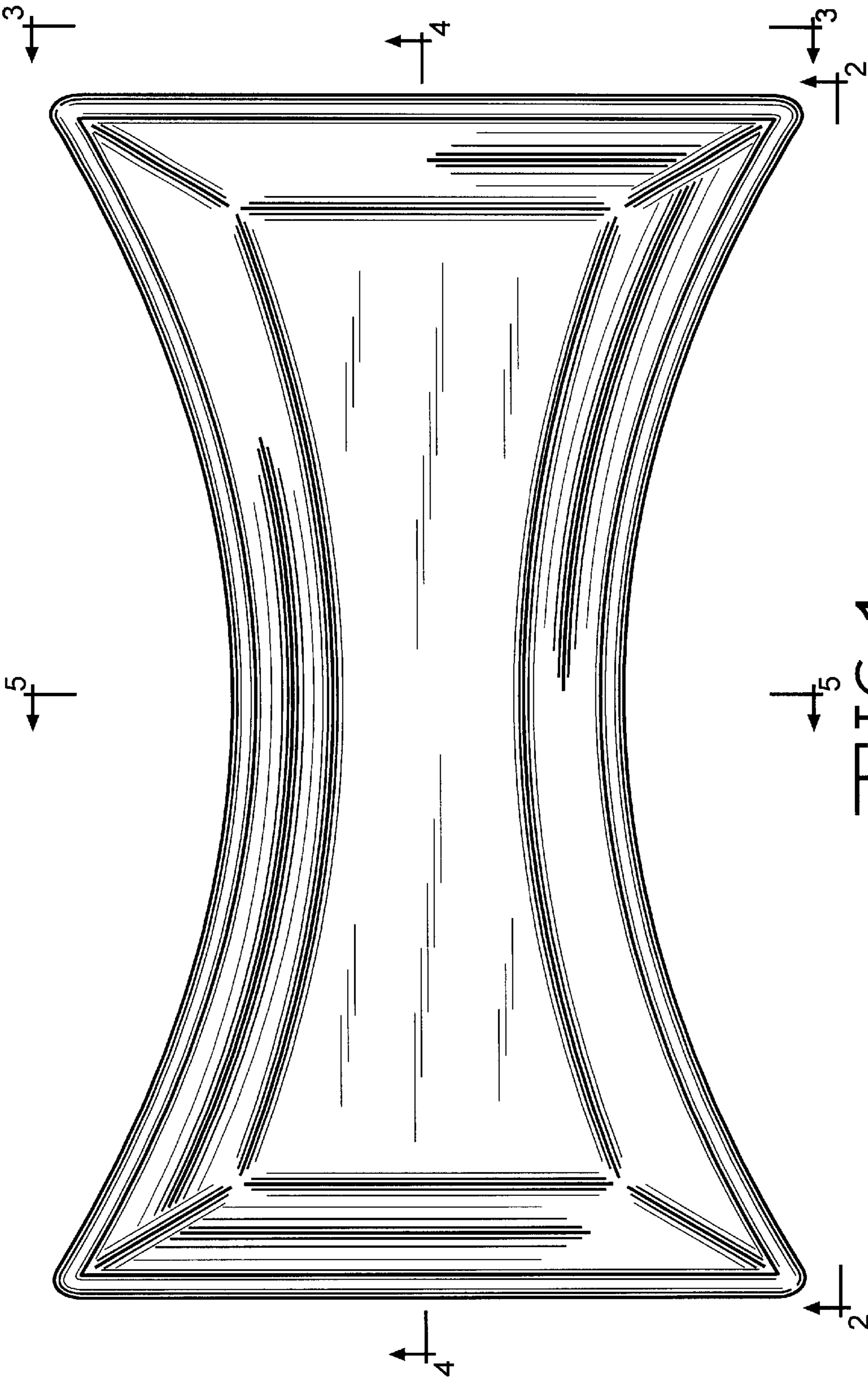

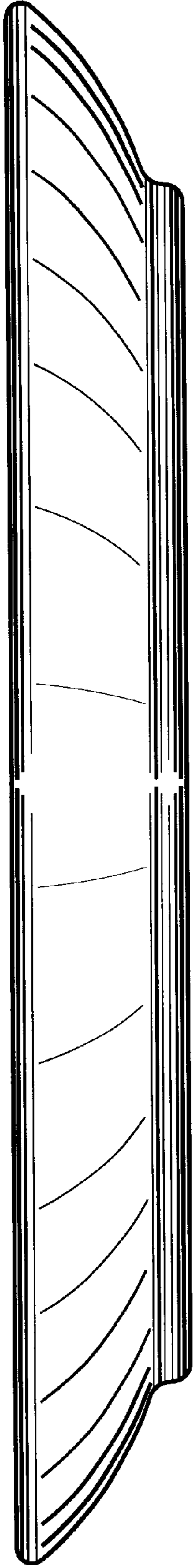

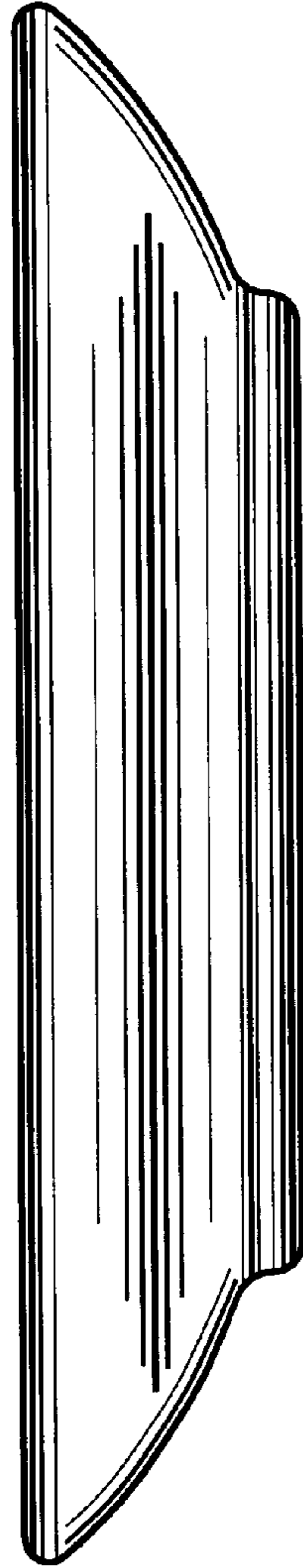

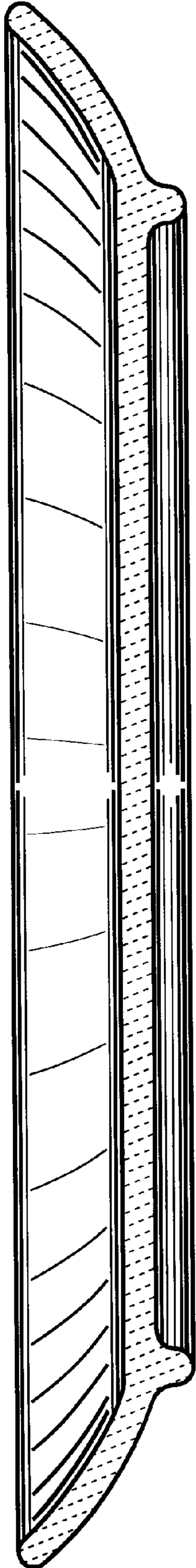

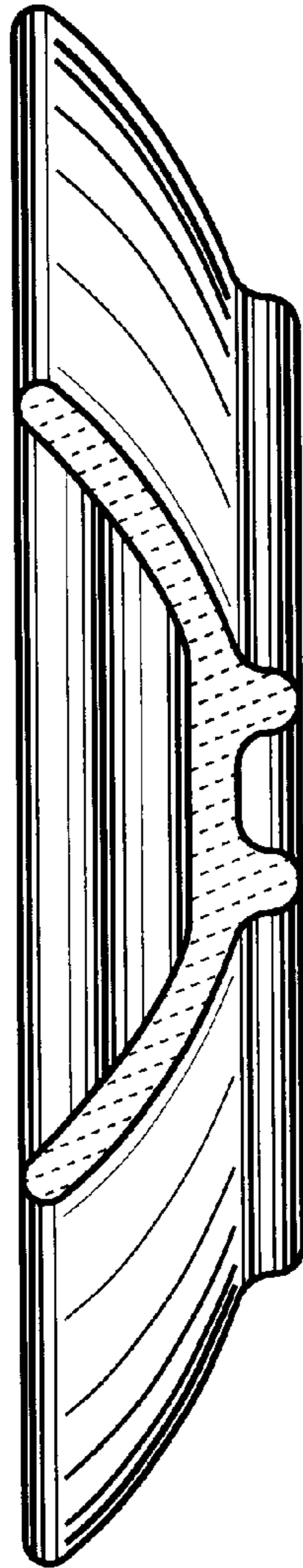

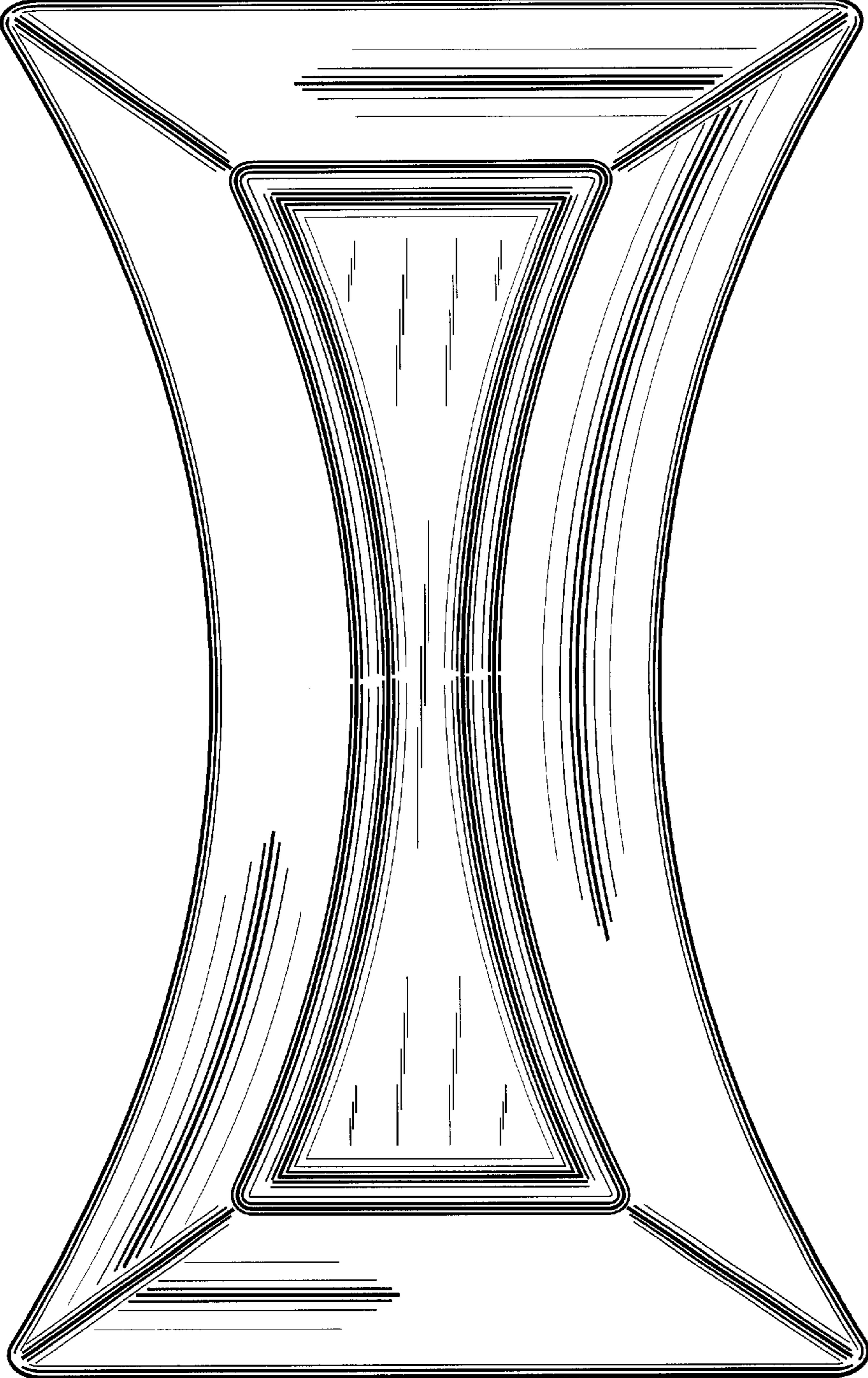

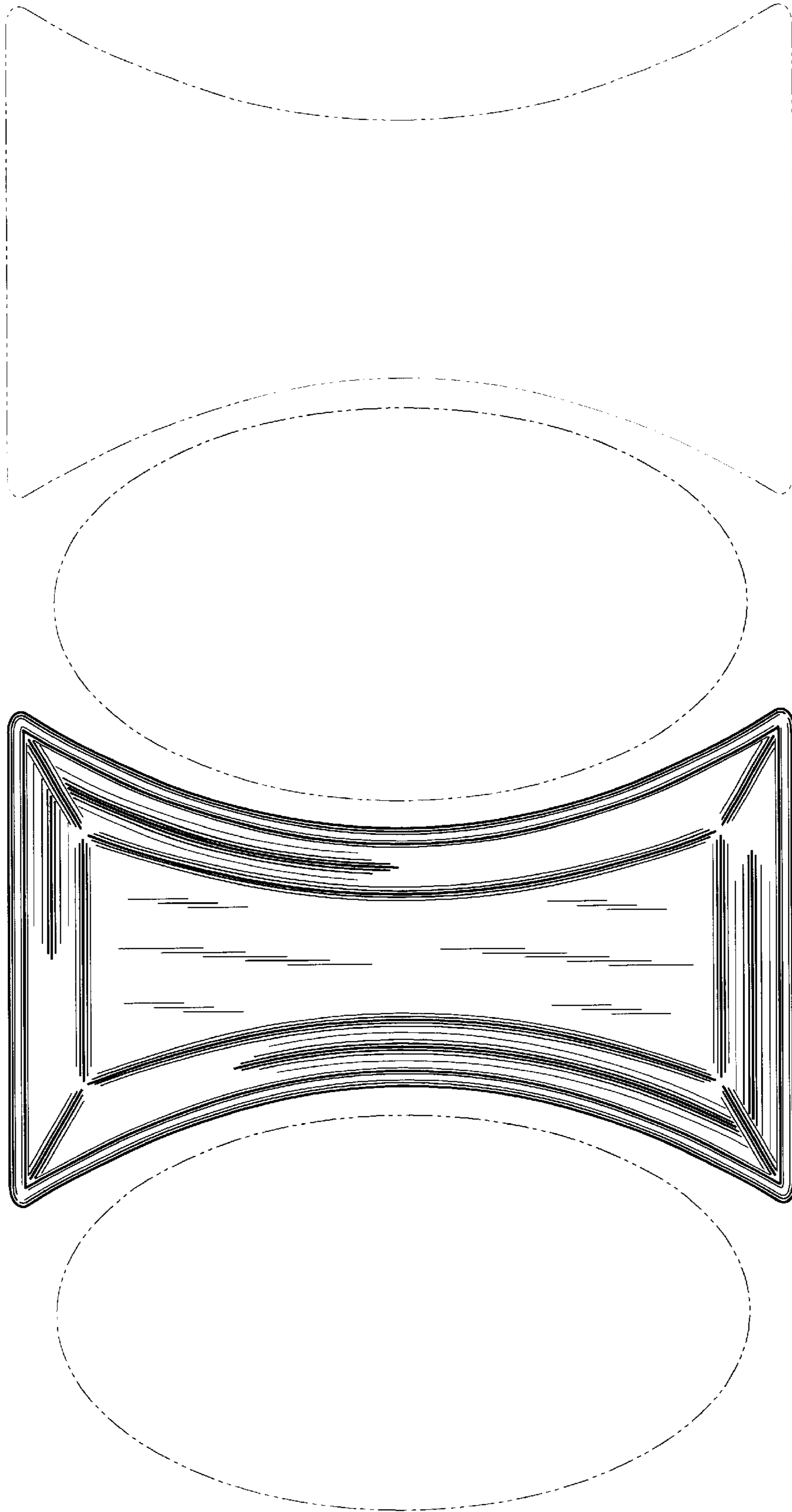
