tainer, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the condiment dispensing  
container showing my new design;  
FIG. 2 is a top plan view of FIG. 1;  
FIG. 3 is a front elevation view of FIG. 1; and,  
FIG. 4 is a perspective view of FIG. 1 with the container  
shown in open position.

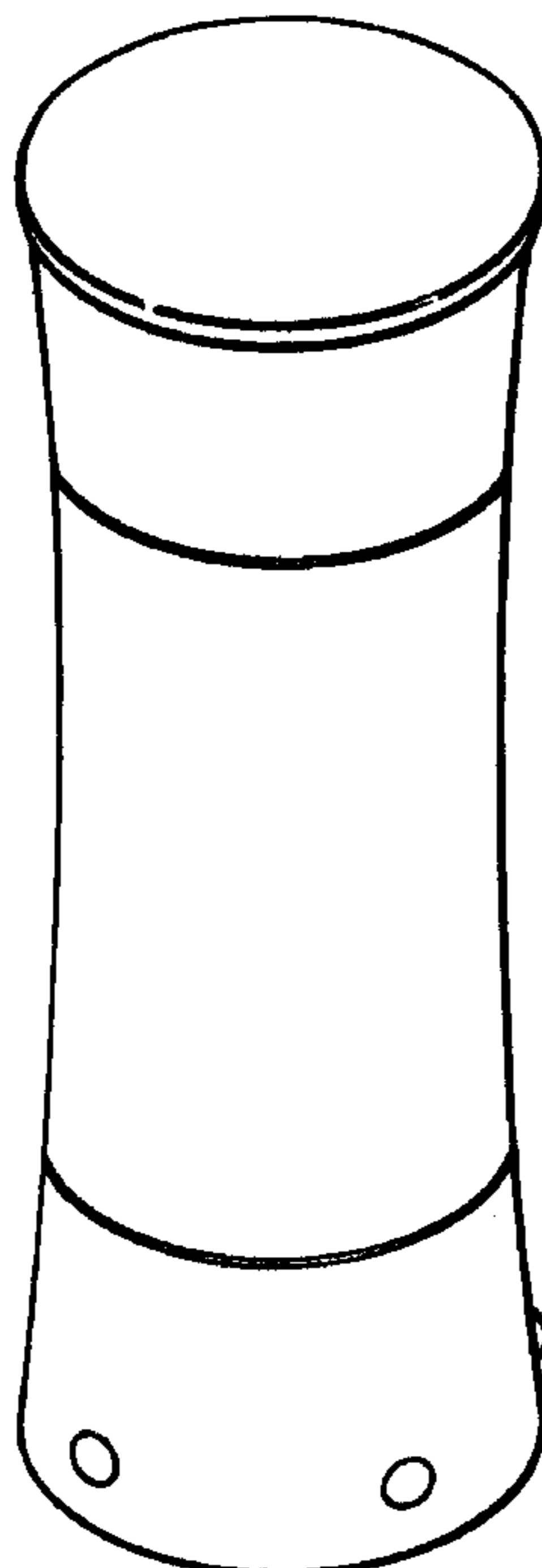

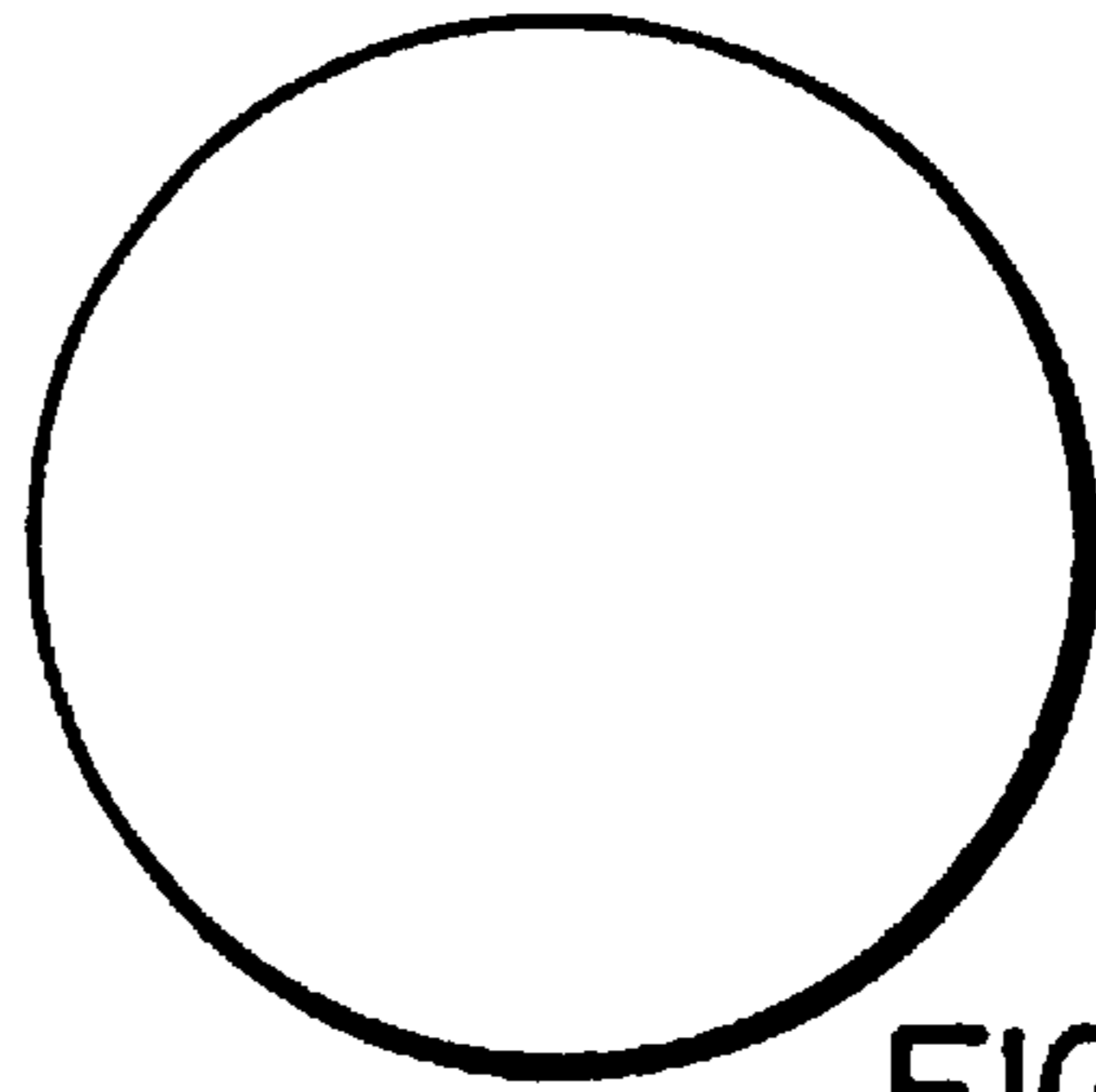
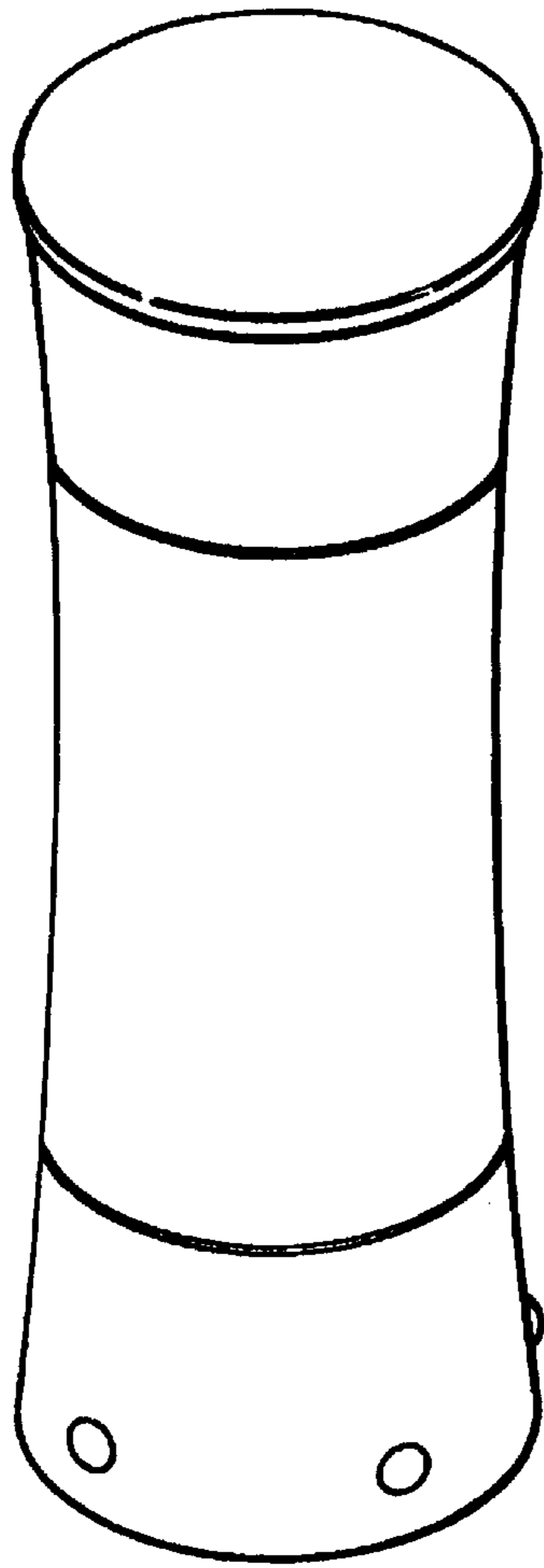
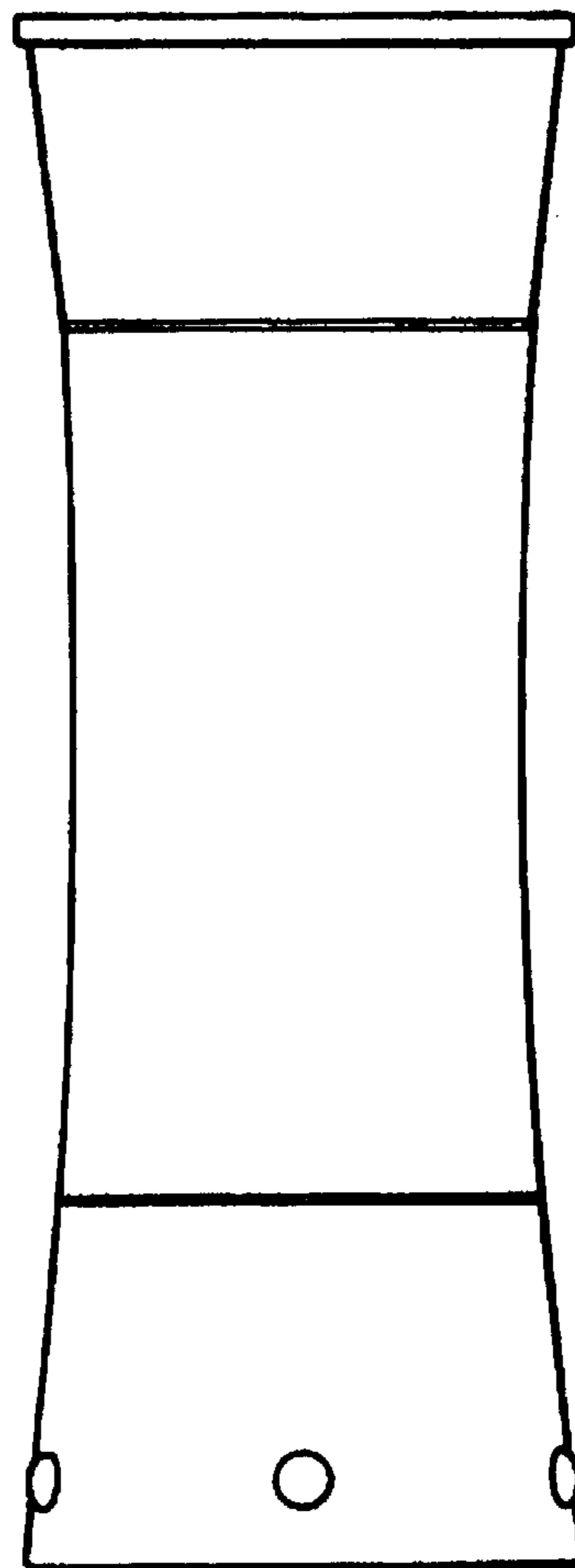

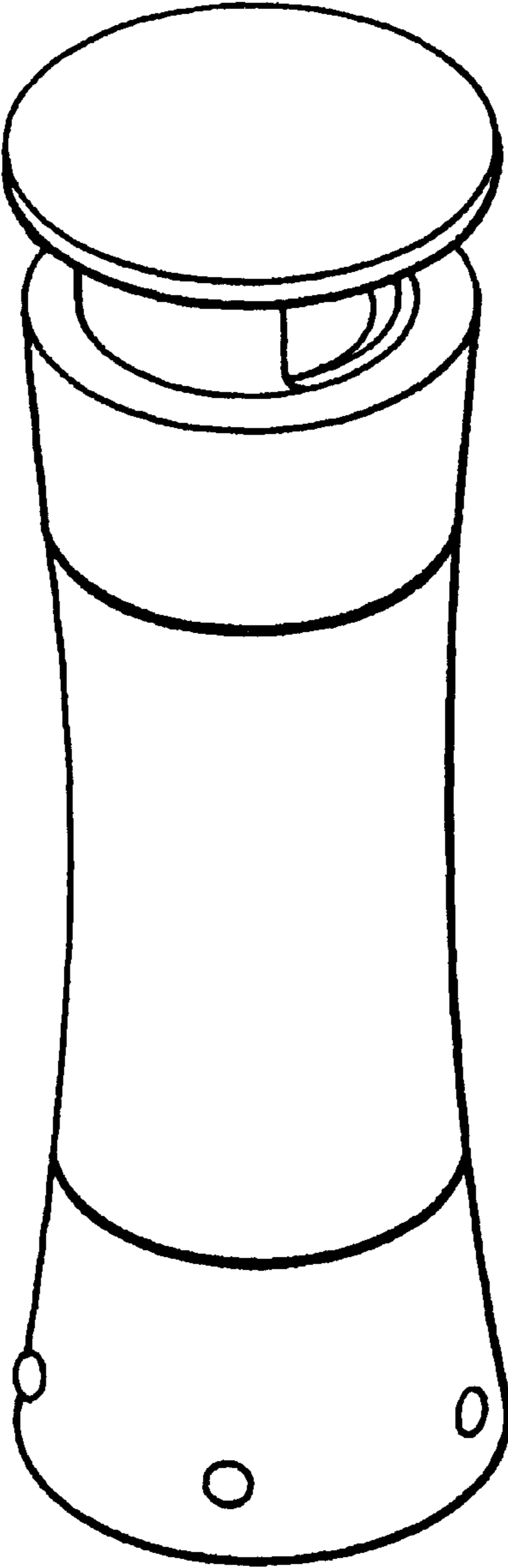
