(57) **CLAIM**

The ornamental design for a cultivator head for hand tool, as
shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a cultivator head for hand
tool showing our new design;

FIG. 2 is a top plan view of the cultivator head for hand tool
of FIG. 1;

FIG. 3 is a bottom plan view of the cultivator head for hand
tool of FIGS. 1 and 2;

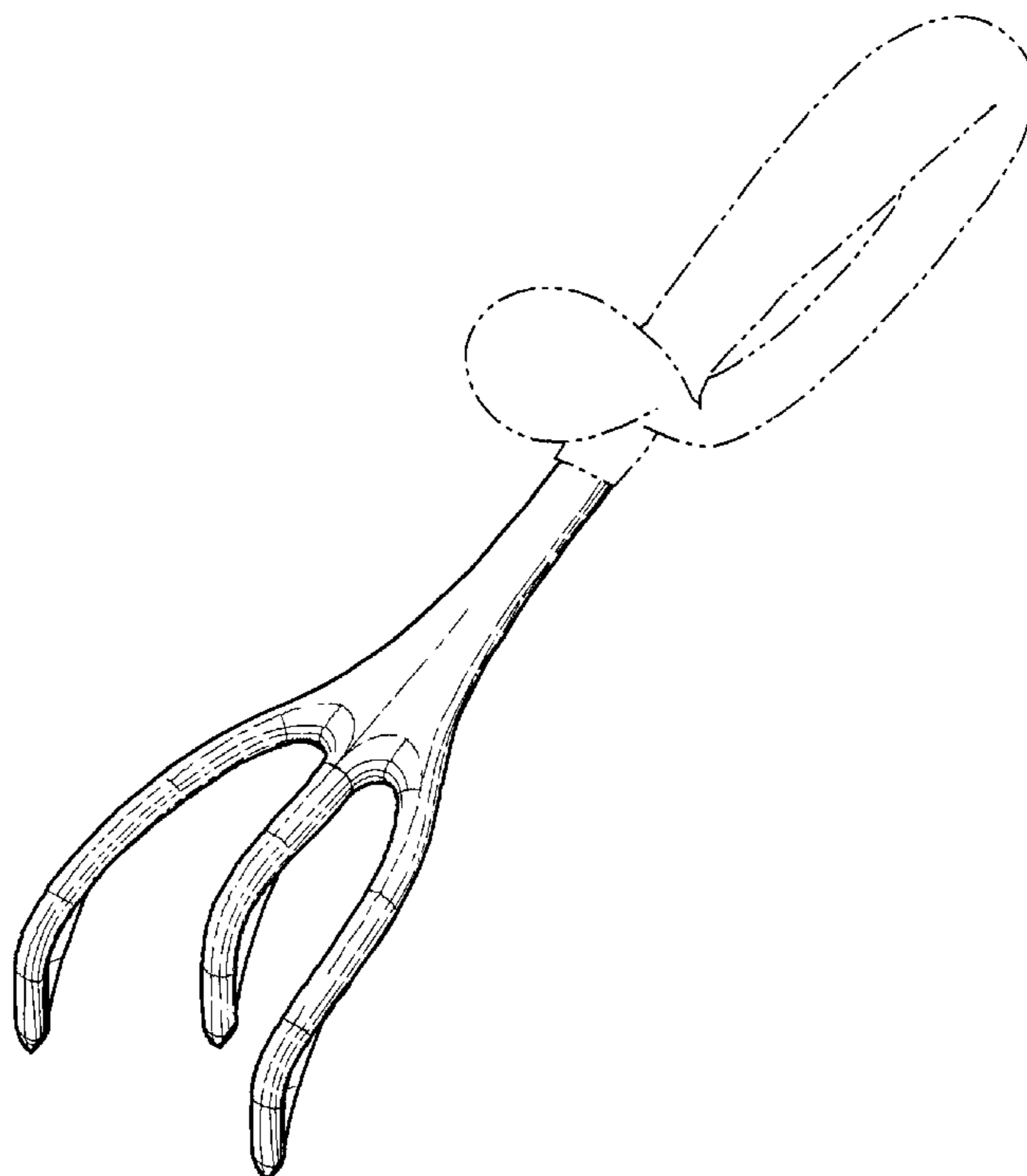
FIG. 4 is a right-side elevational view of the cultivator head
for hand tool of FIGS. 1 to 3, the left side elevational view
being a mirror image thereof;

FIG. 5 is a front elevational view of the cultivator head for
hand tool of FIGS. 1 to 4; and,

FIG. 6 is a rear elevational view of the cultivator head for
hand tool of FIGS. 1 to 5.

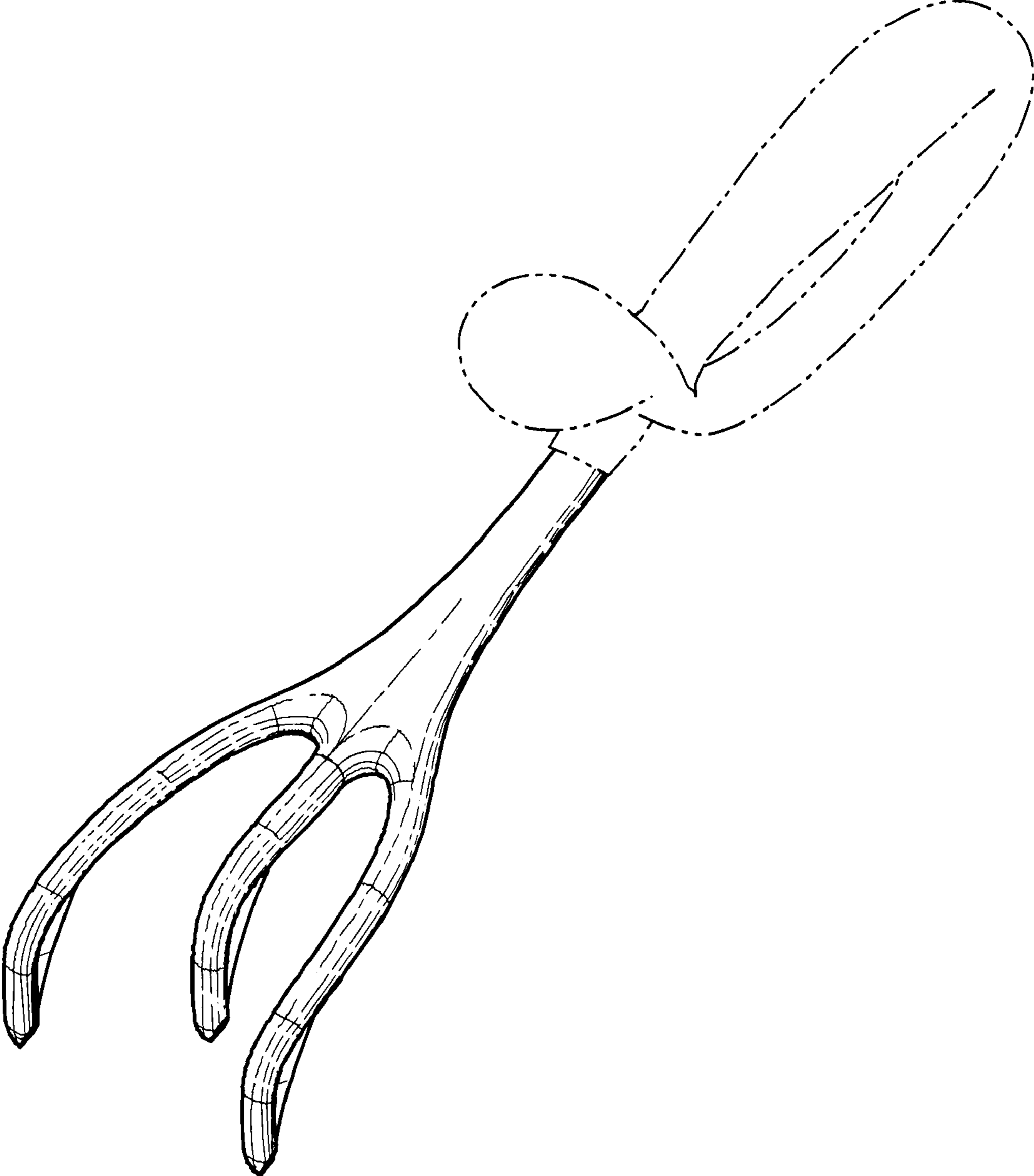

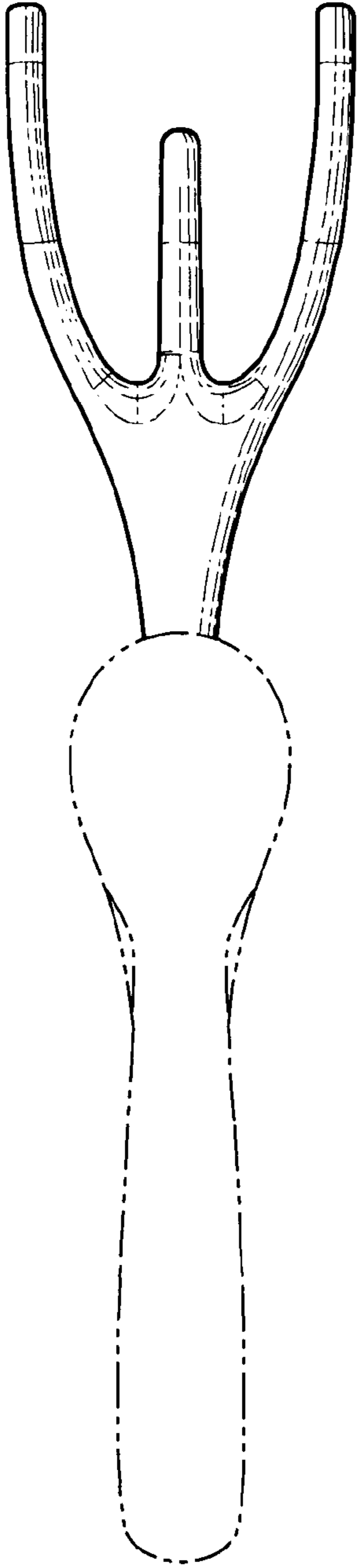

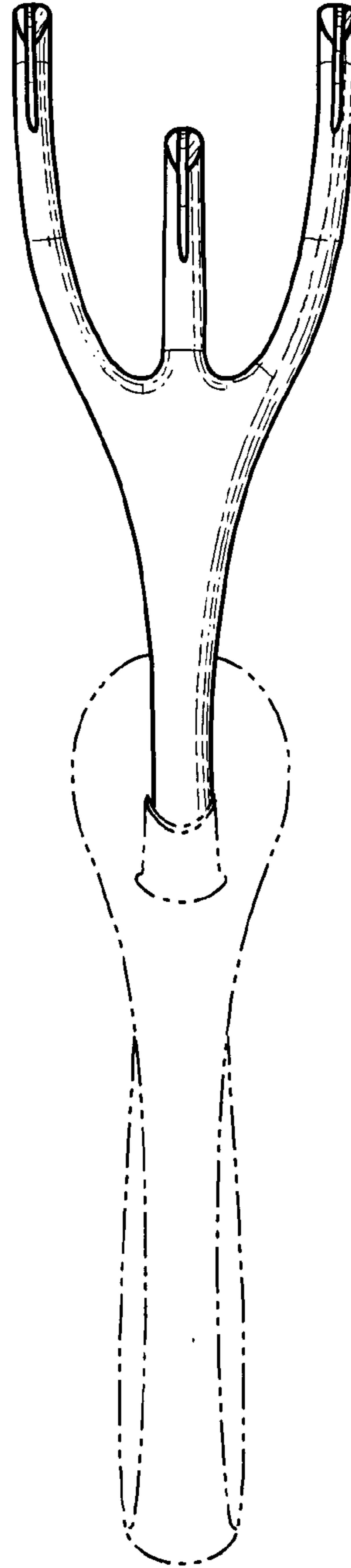

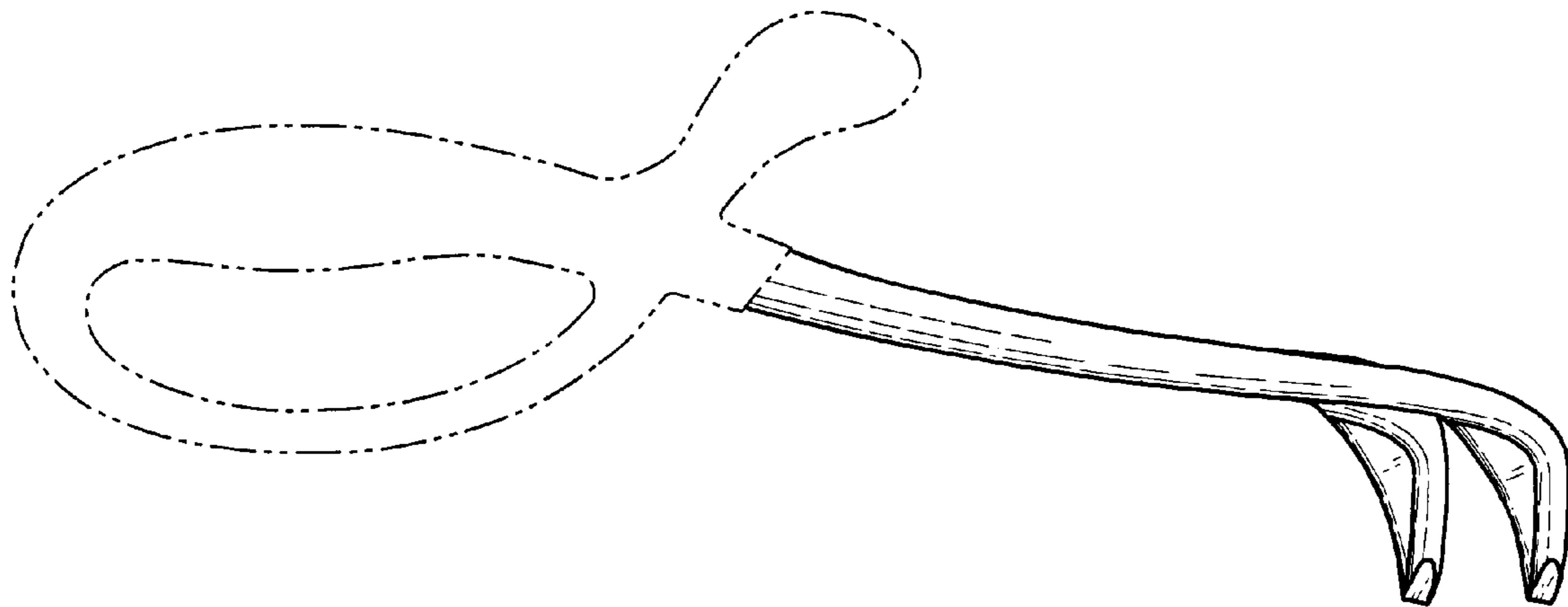

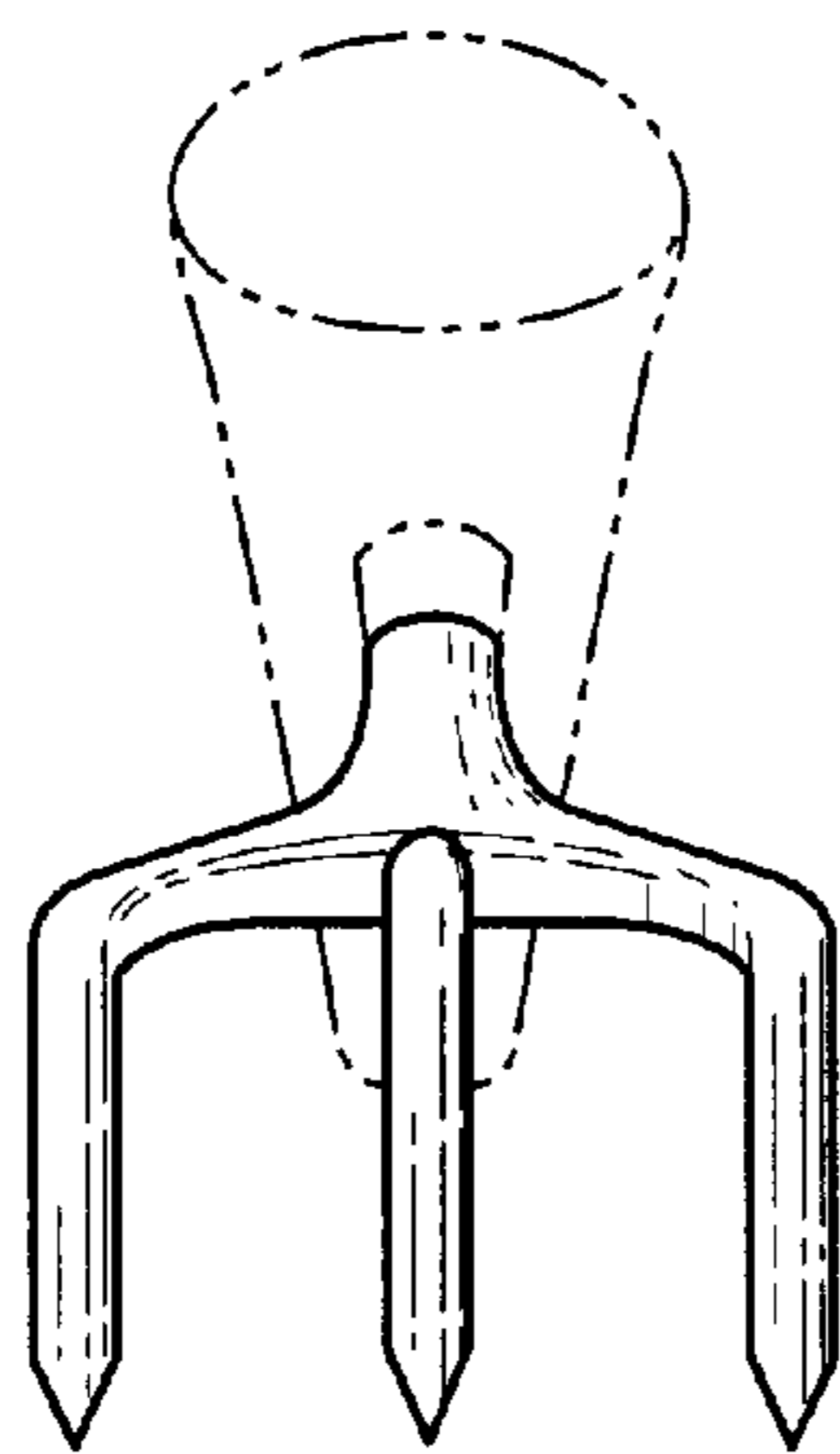

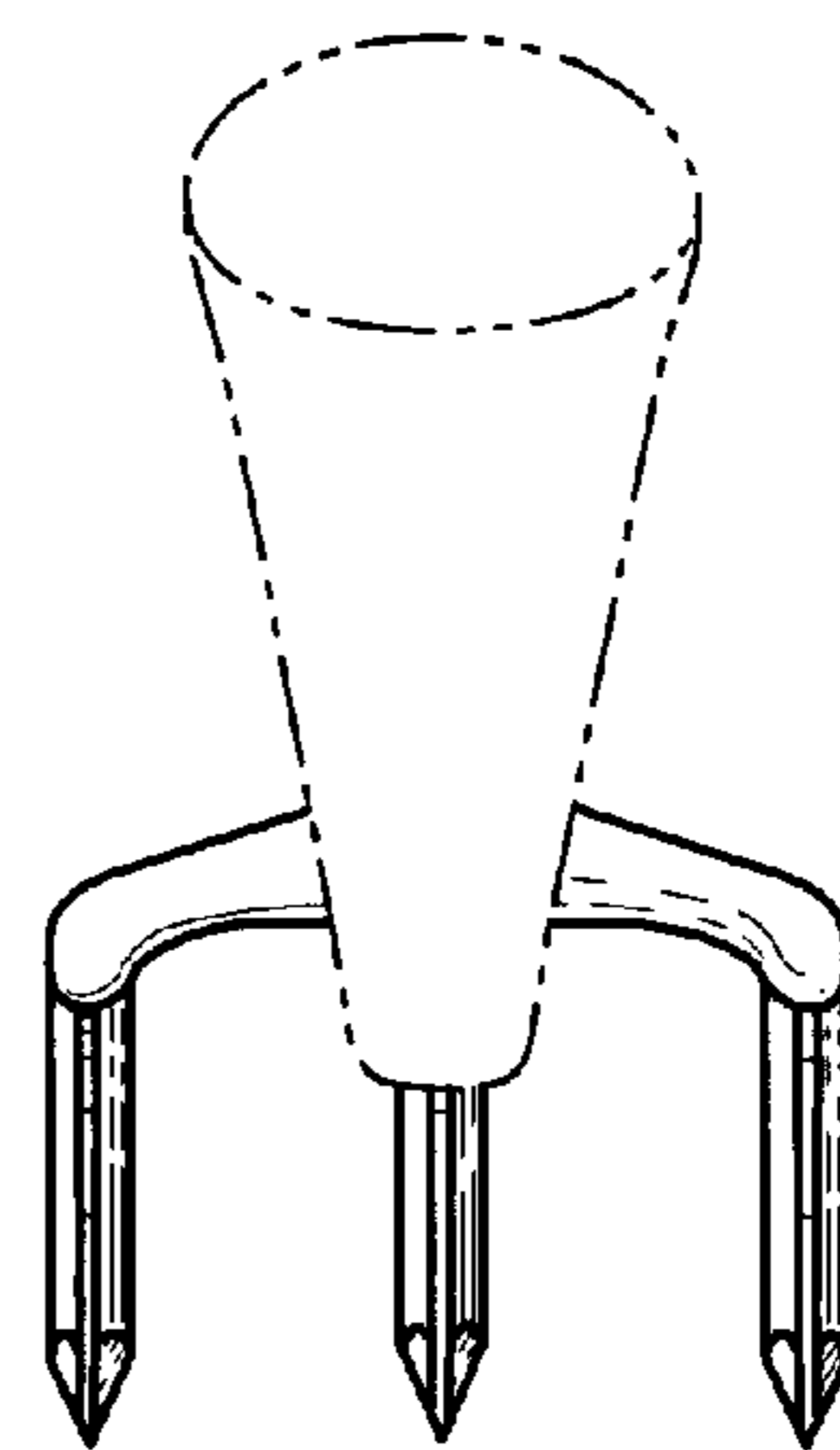
