FIG. 1 is a perspective view of a hand tool showing my new design as seen from one side edge and one side thereof;

FIG. 2 is a perspective view thereof as seen from the one side and the opposite side edge of FIG. 1;

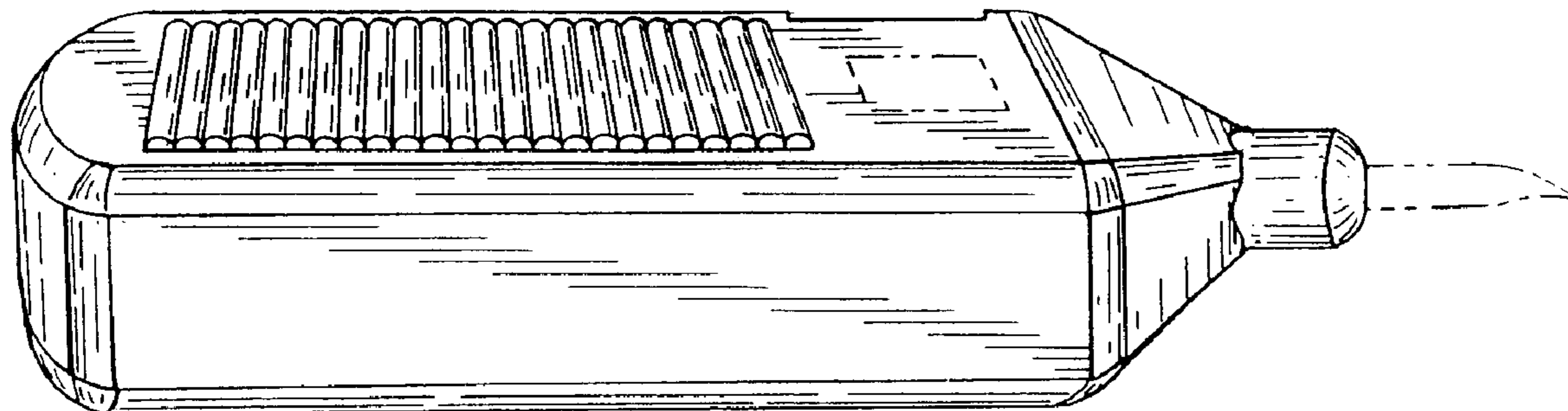
FIG. 3 is a perspective view thereof as seen from the opposite side edge and opposite side of FIG. 1;

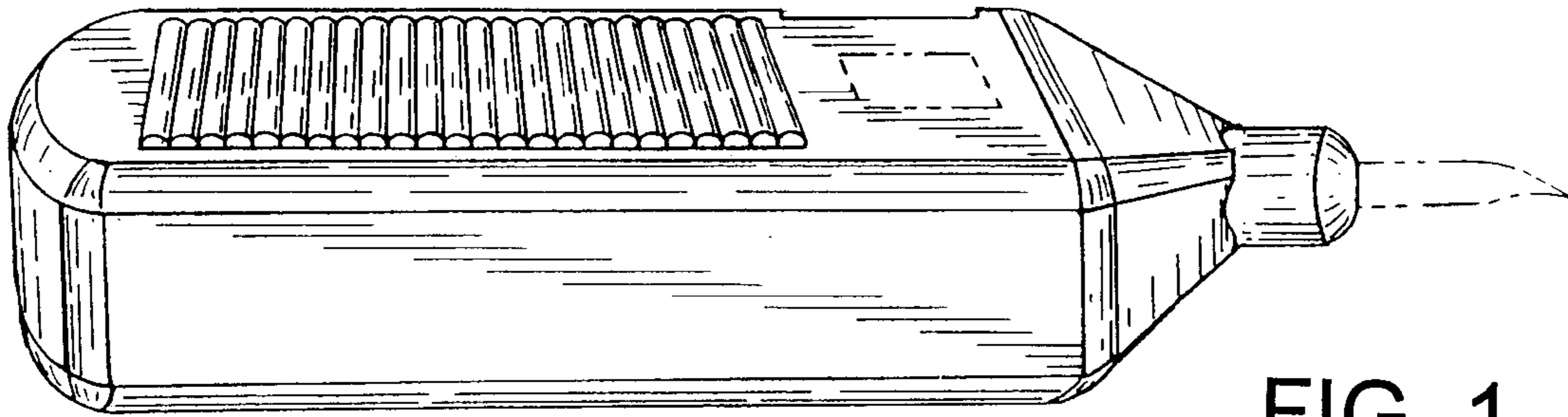

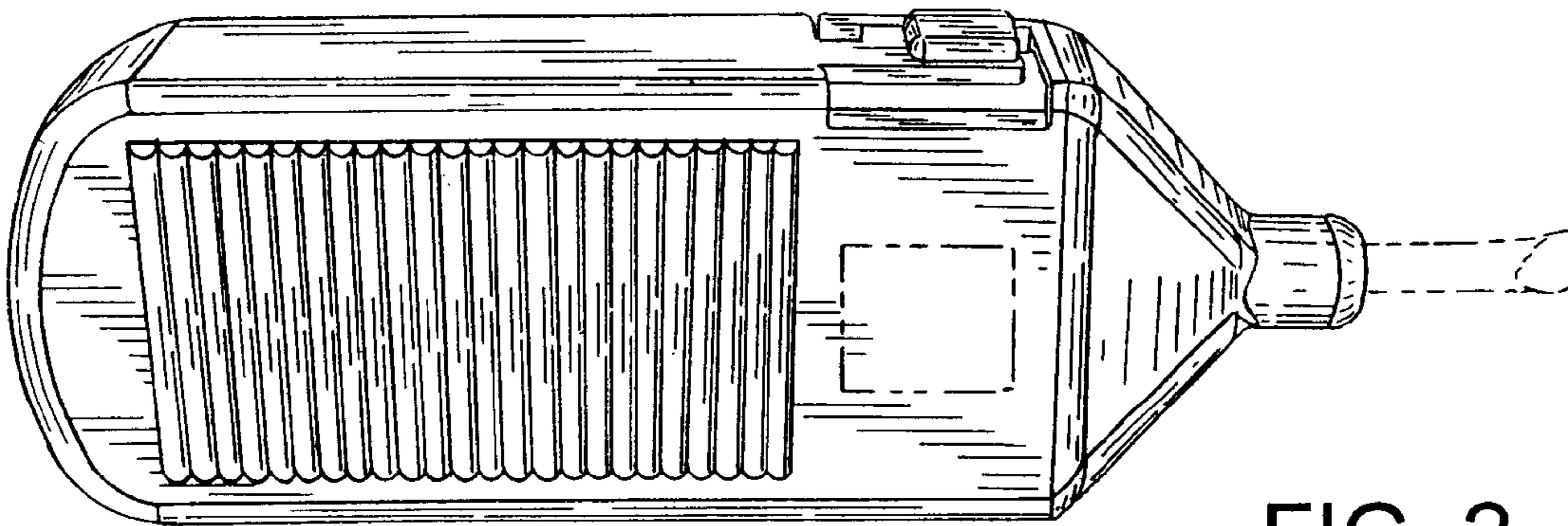

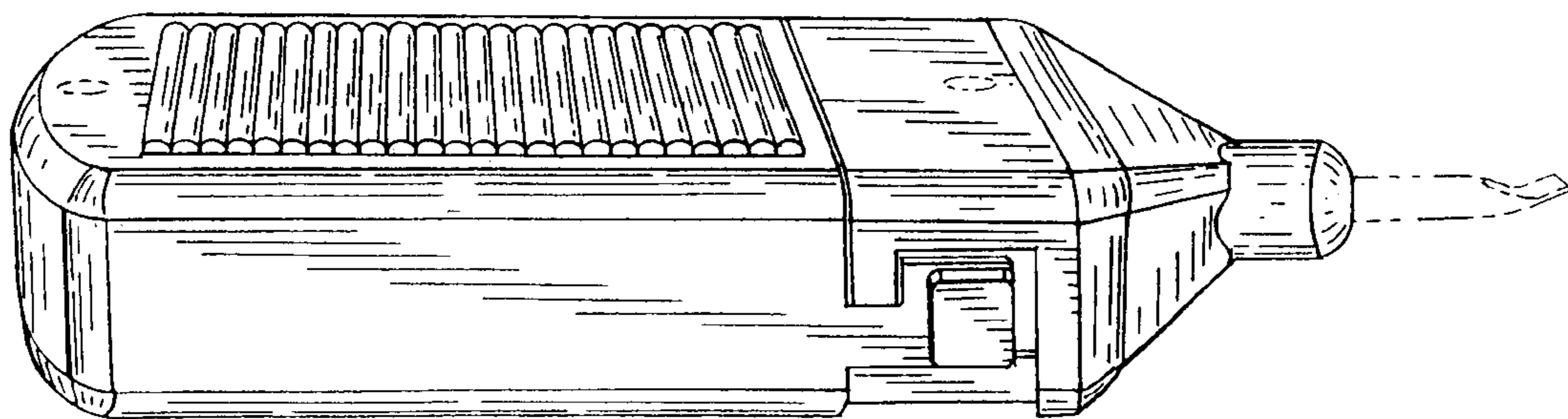

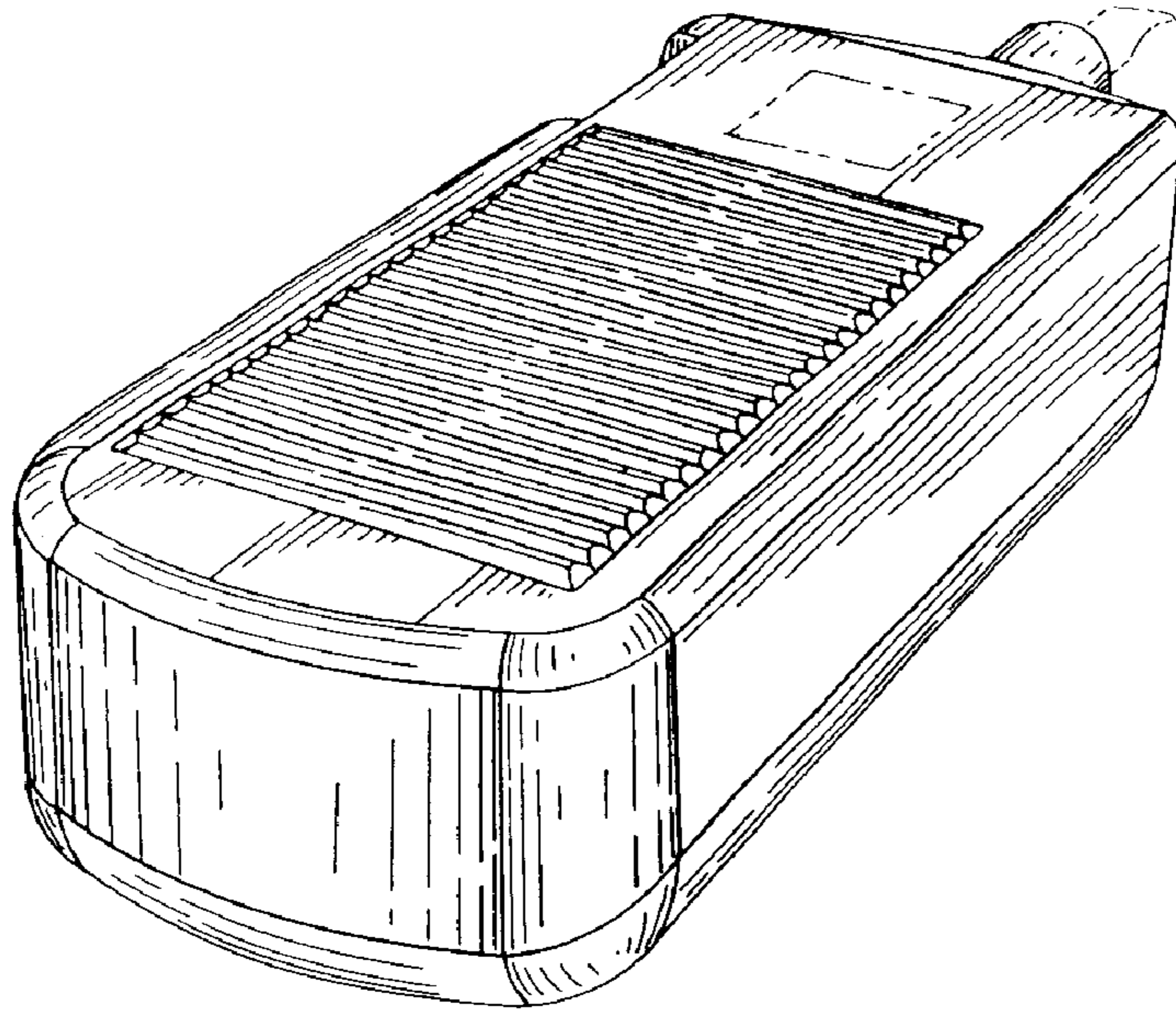

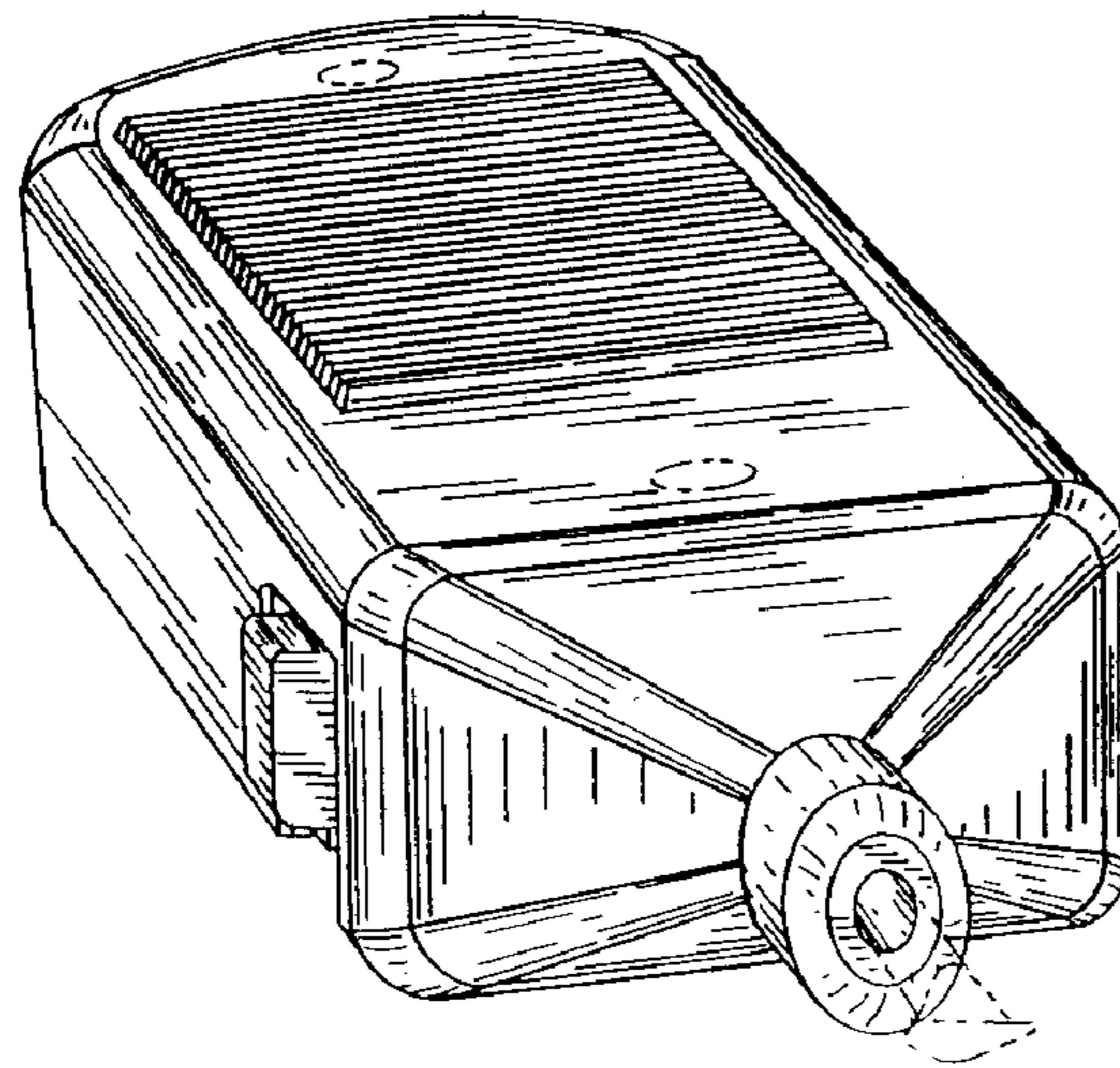
