(57) **CLAIM**

The ornamental design for a hand-held tag attacher, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a hand-held tag attacher in accordance with the invention;

FIG. 2 is a left side elevational view of the attacher shown in FIG. 2;

FIG. 3 is a right side elevational view of the attacher shown in FIGS. 1 and 2; and

FIG. 4 is a top plan view thereof;

FIG. 5 is a bottom plan view thereof;

FIG. 6 is a left end elevational view thereof; and,

FIG. 7 is a right end elevational view thereof.

The stippling evident in FIGS. 1, 2 and 4 through 7 indicates surface texture contrast and color contrast.

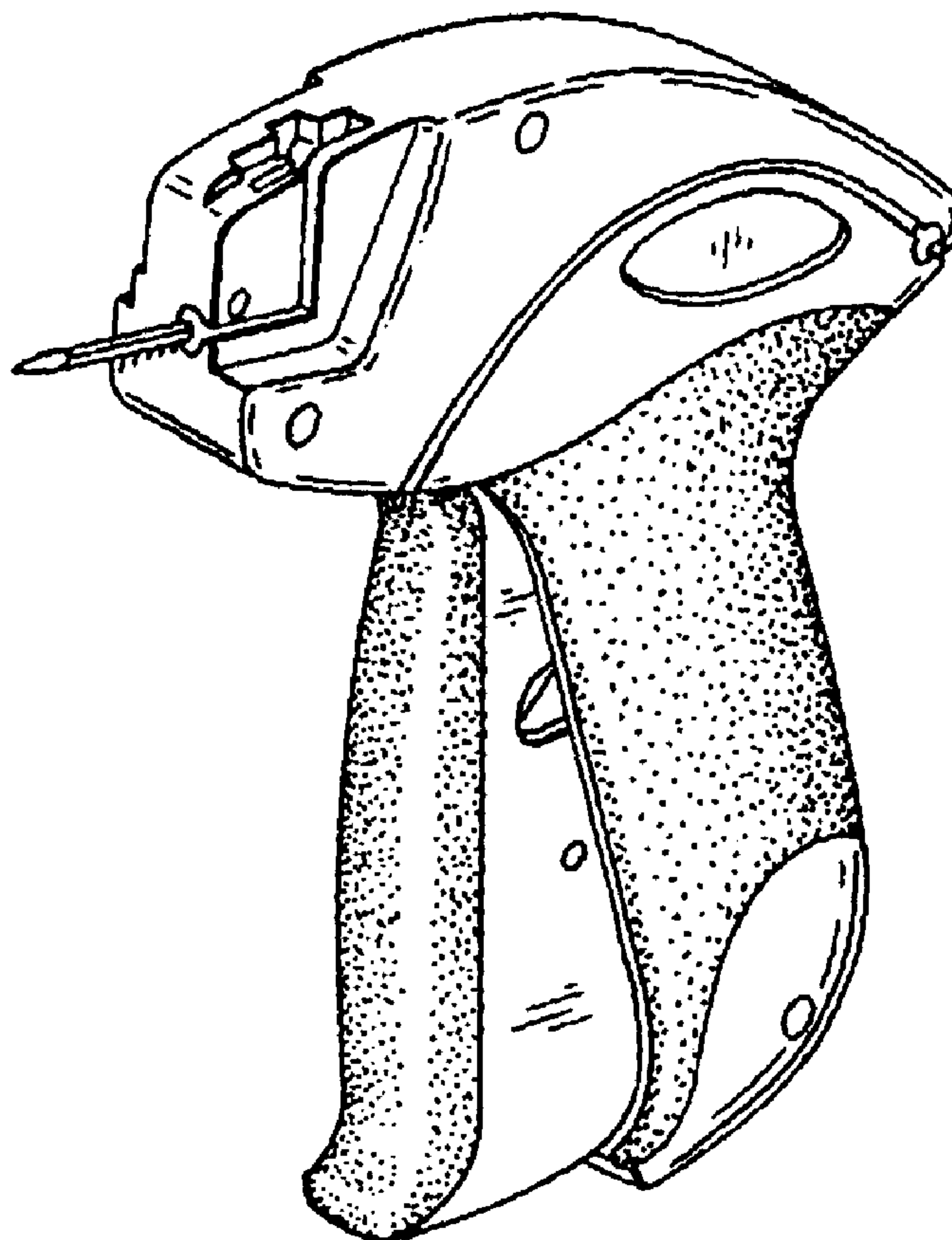

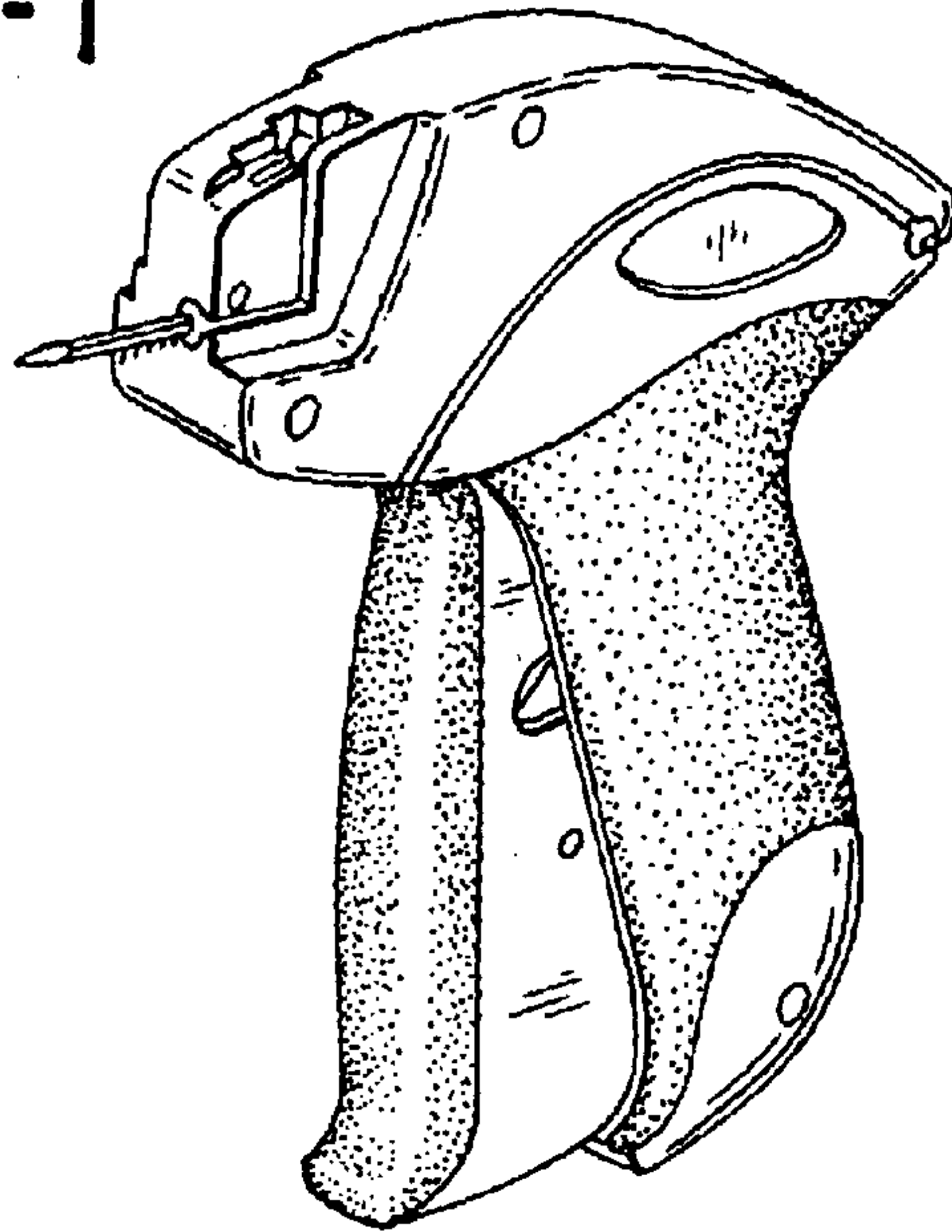

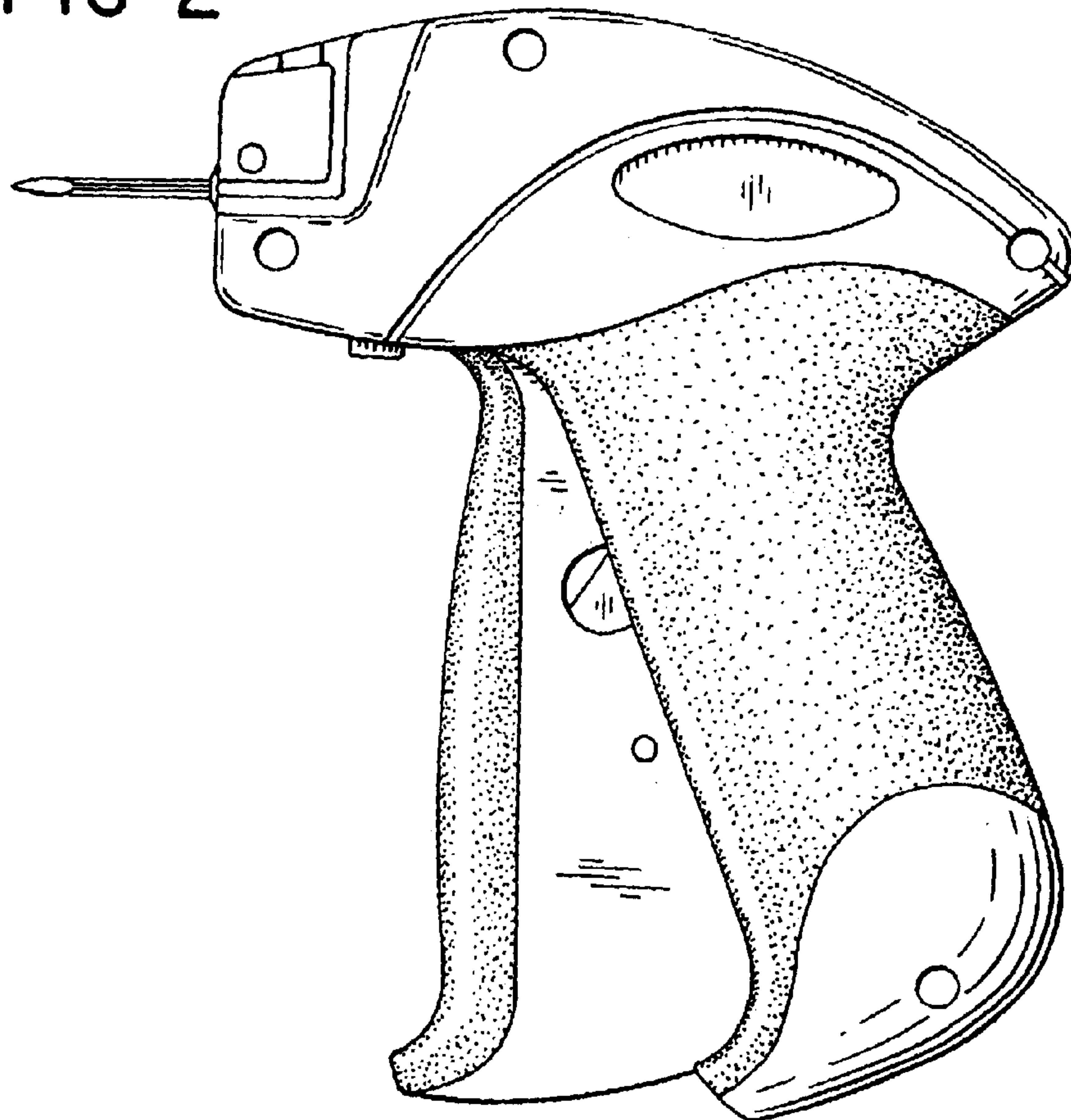

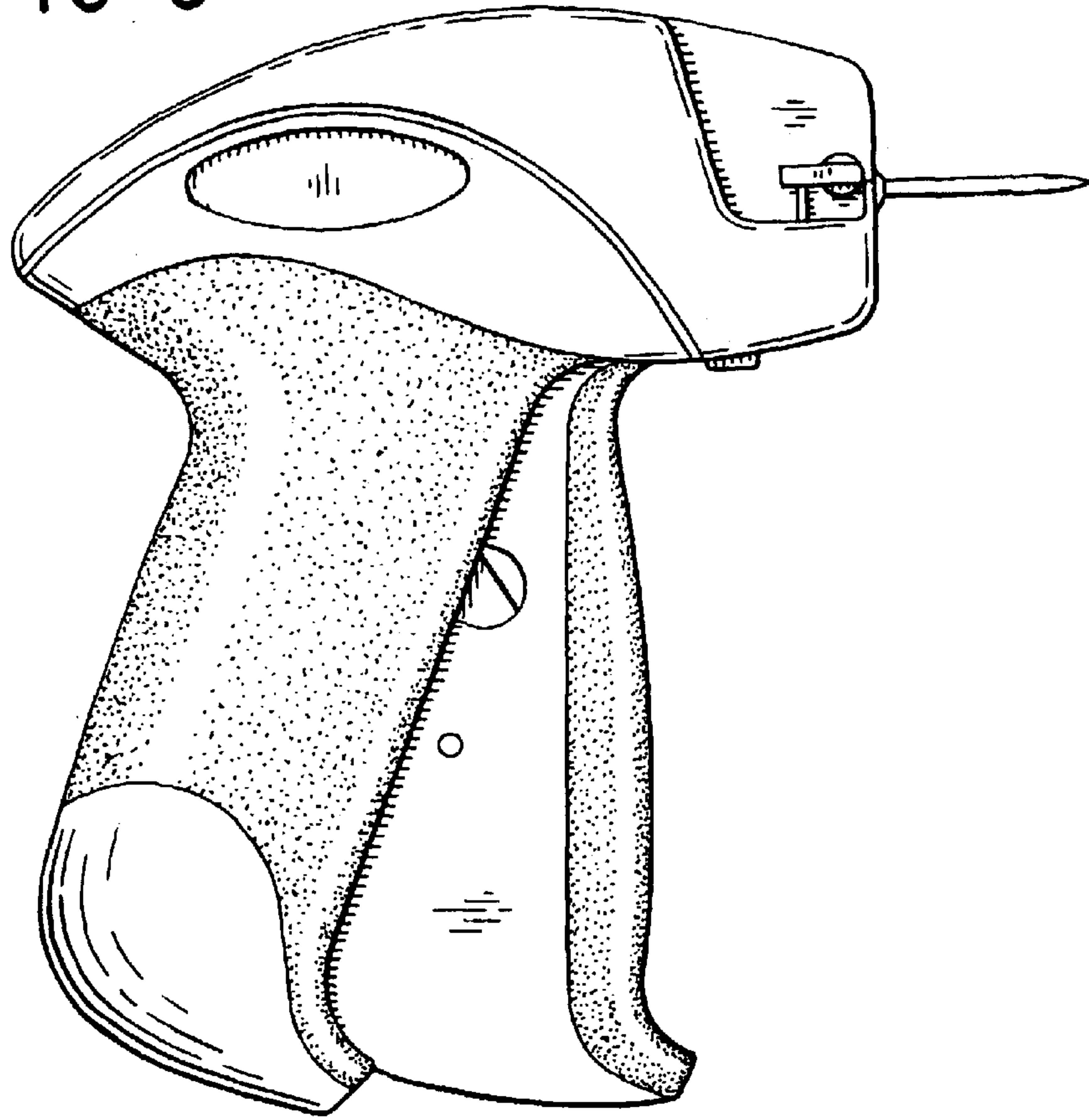

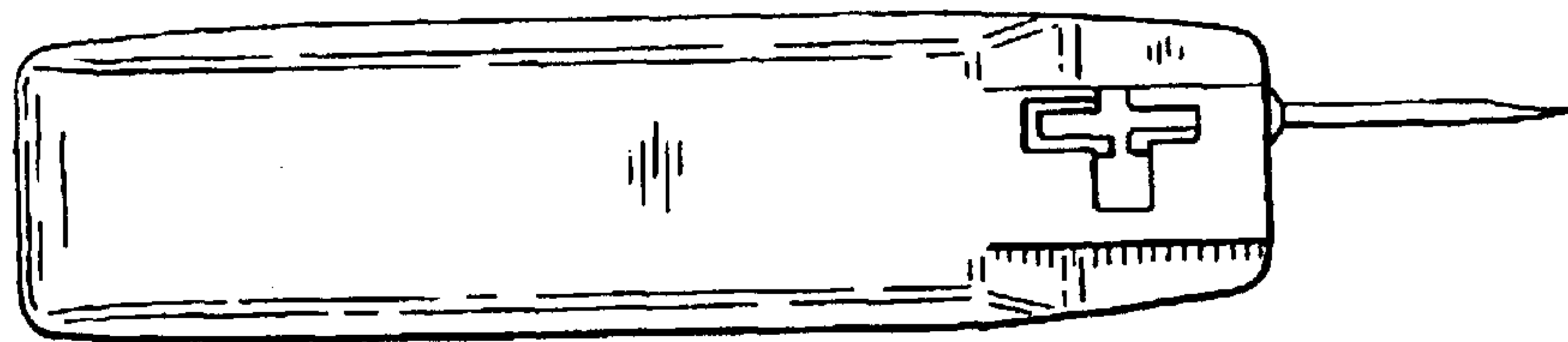

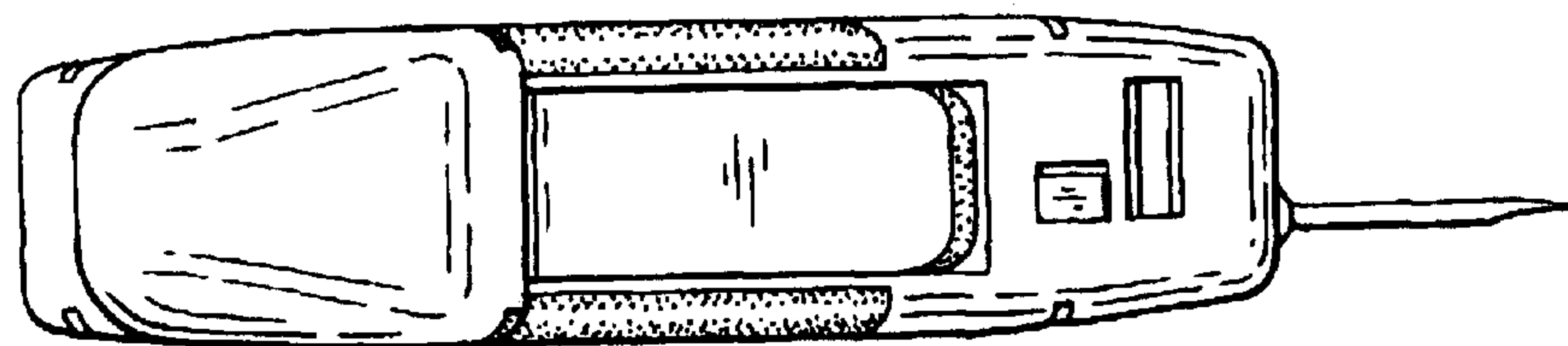

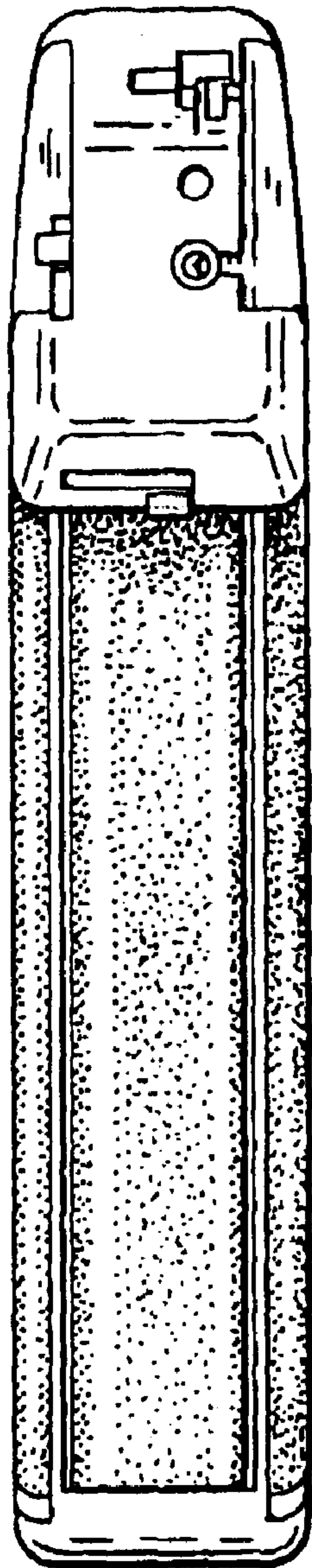
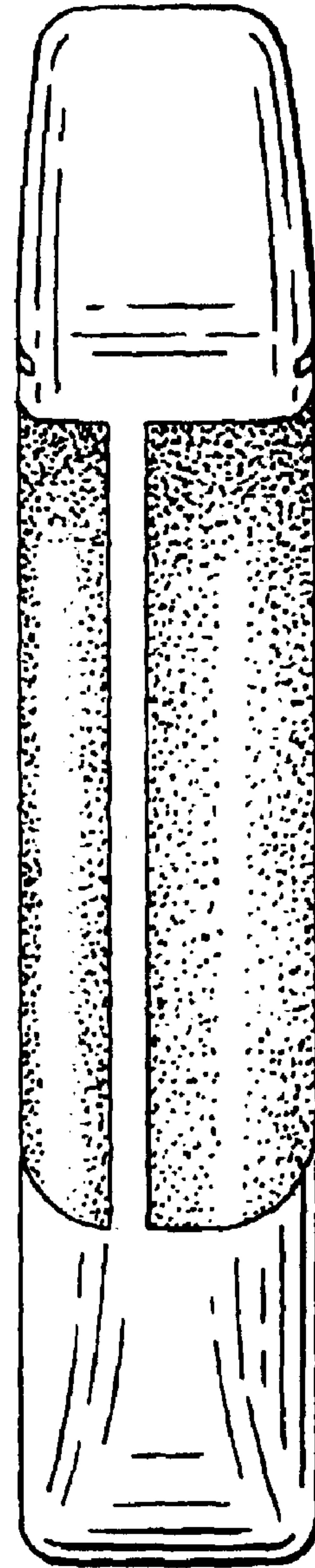
