DESCRIPTION

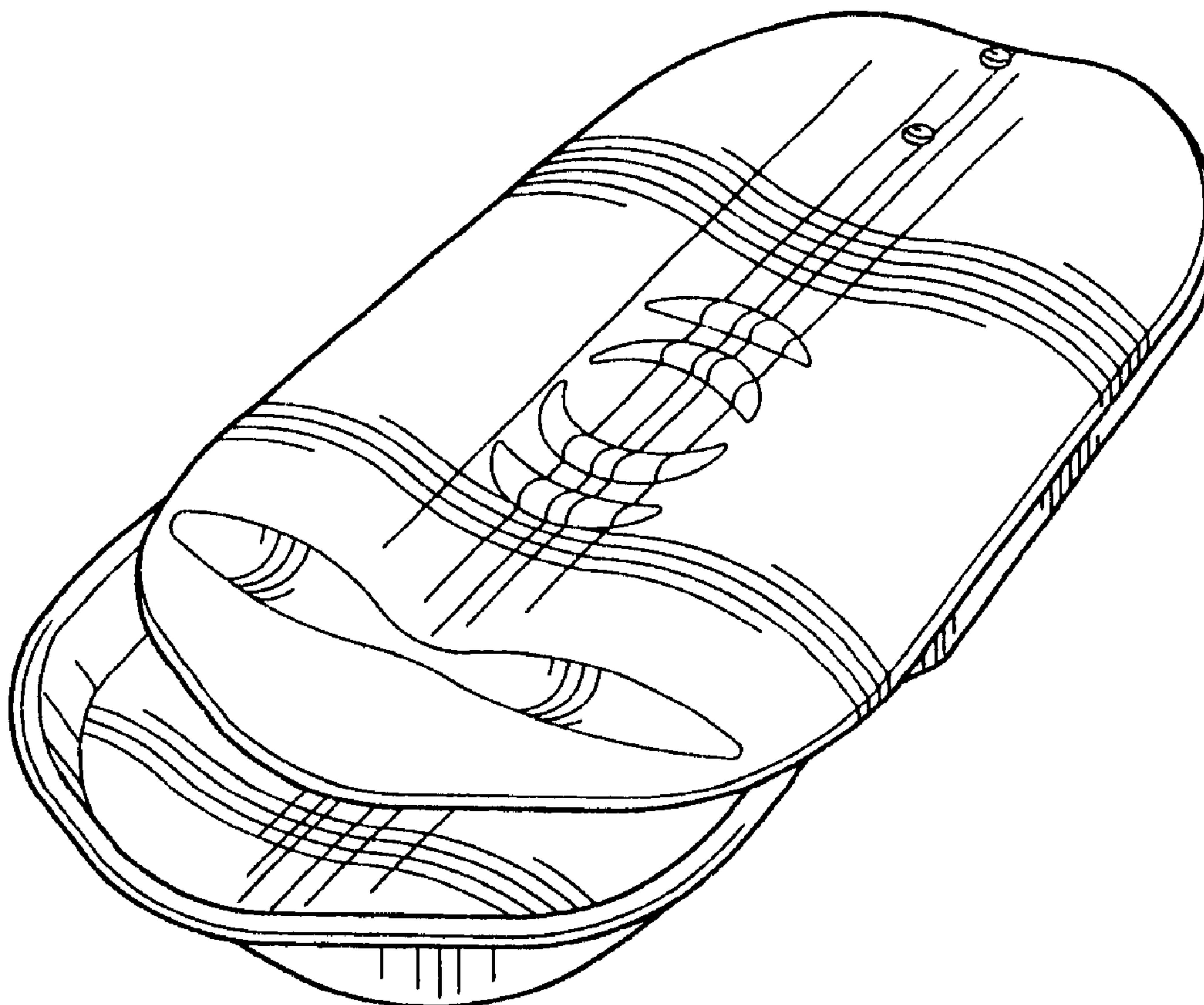
FIG. 1 is a perspective view of a slide lid container, showing my new design;

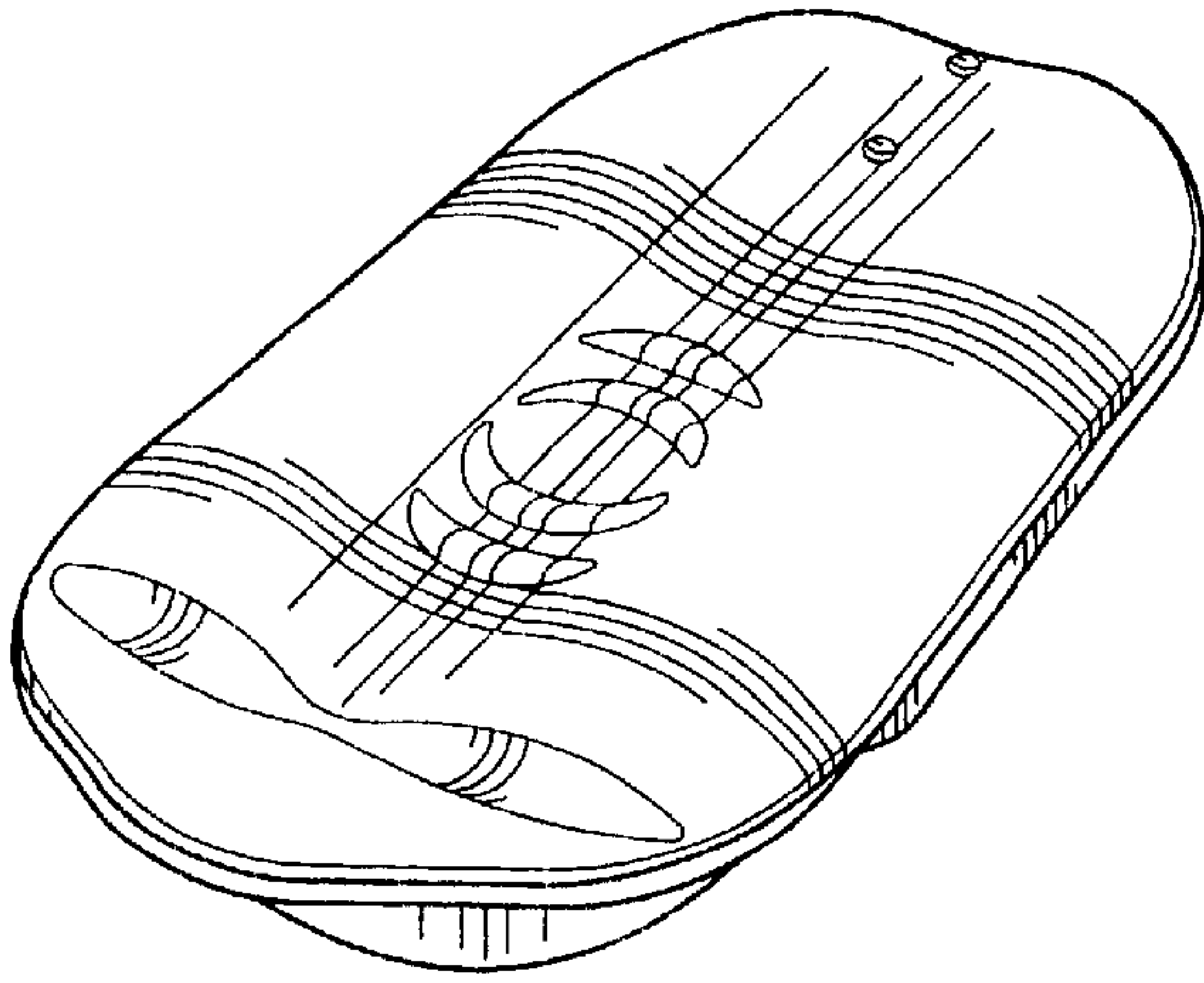

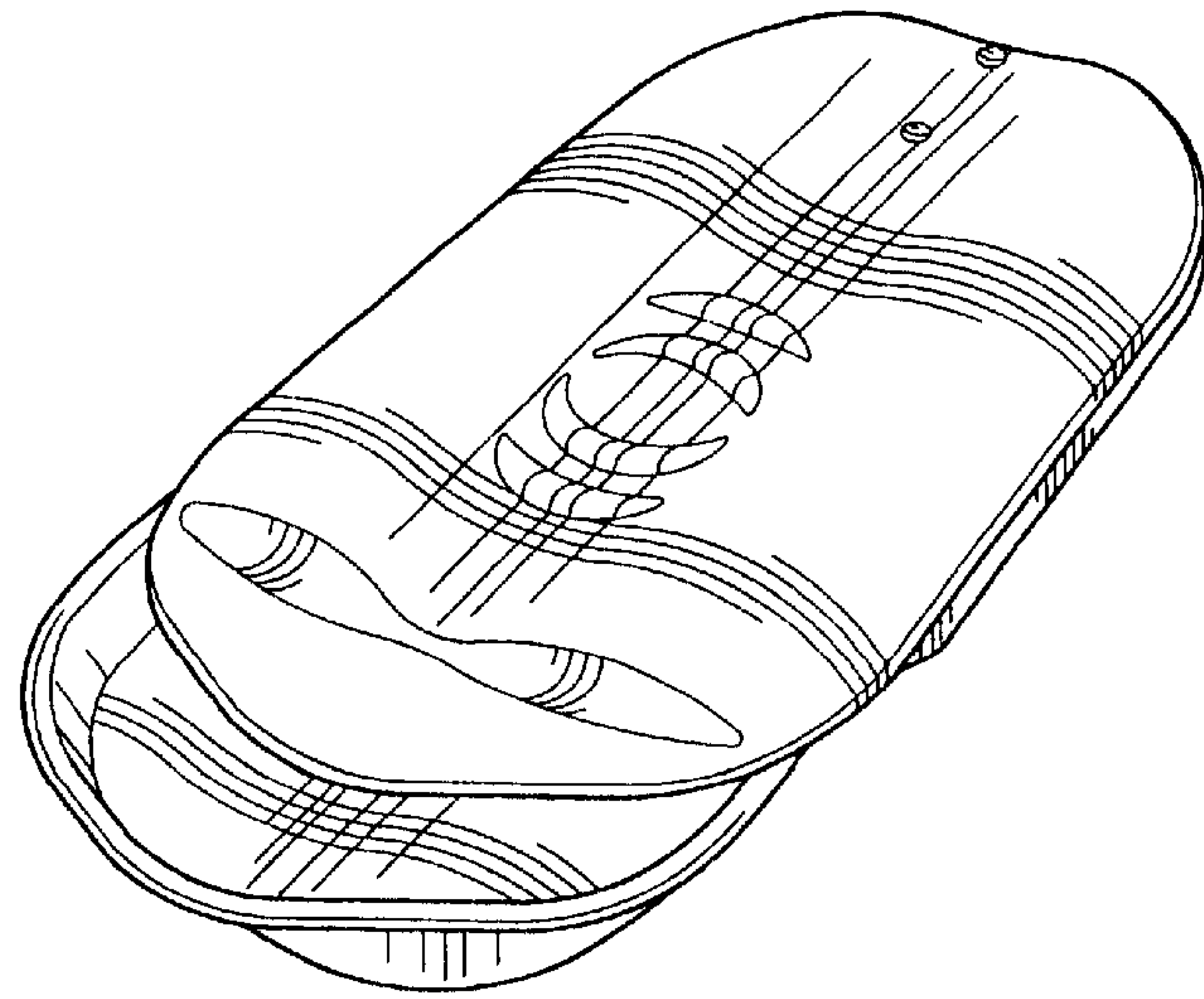

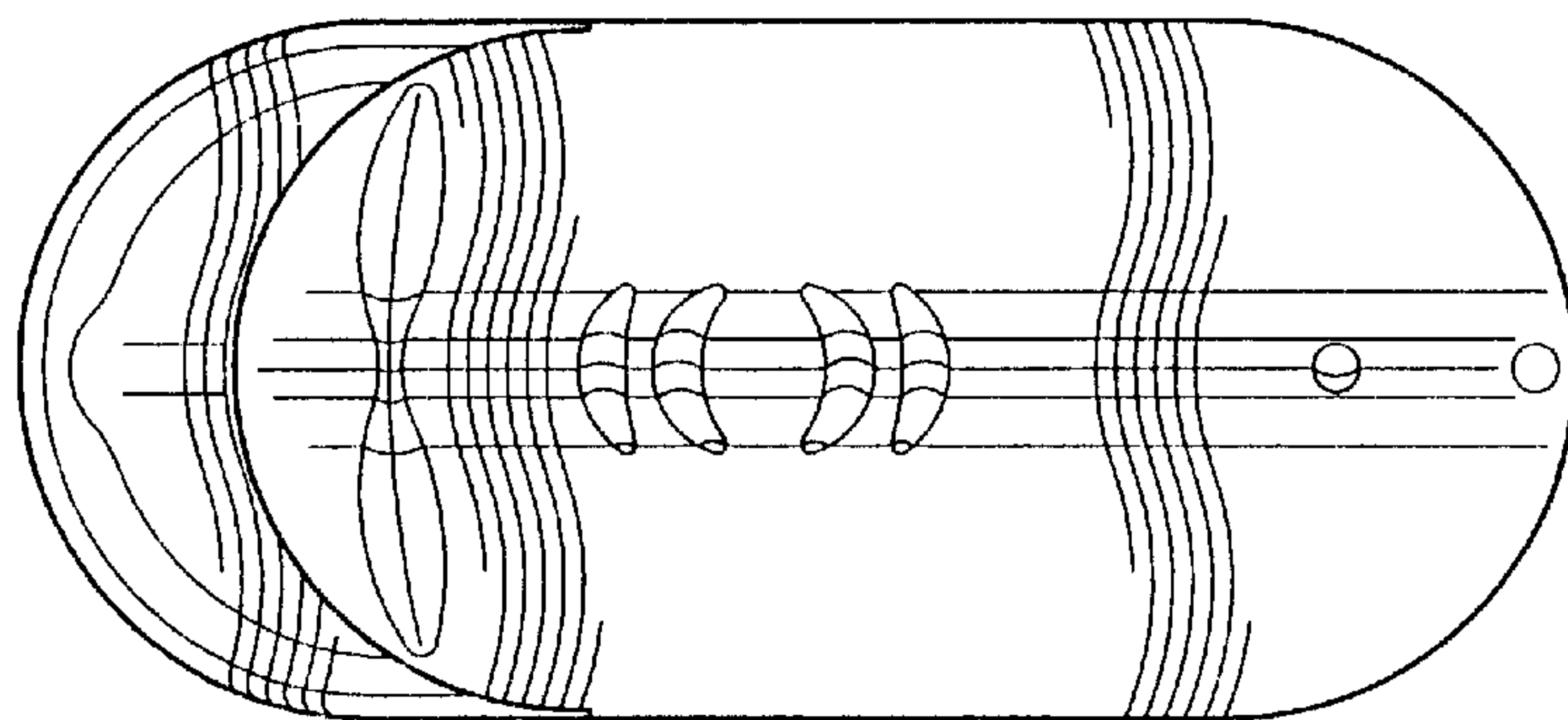

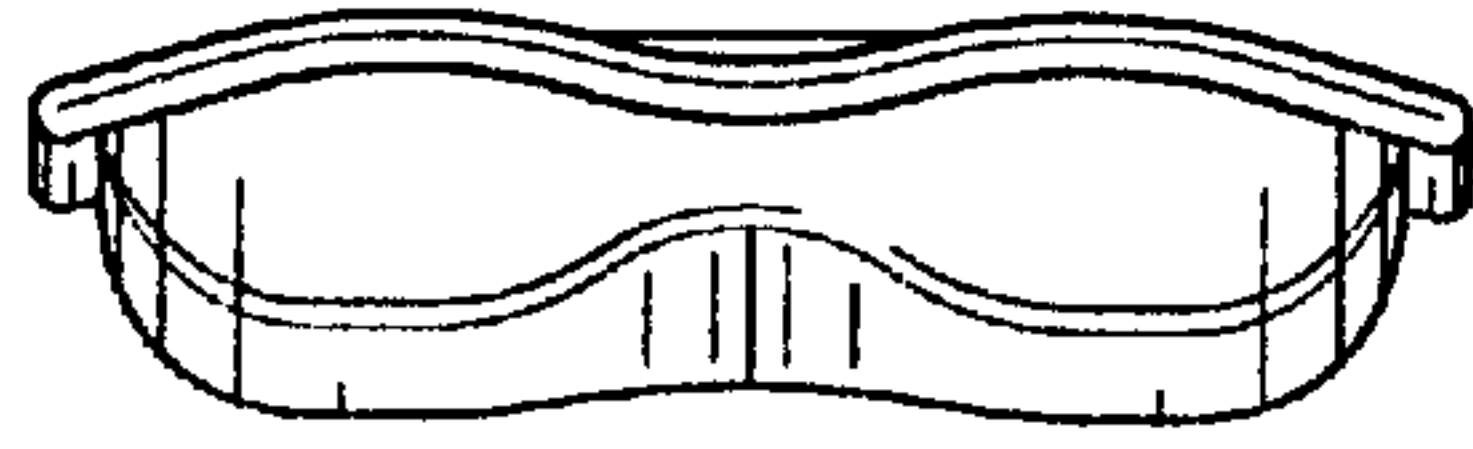

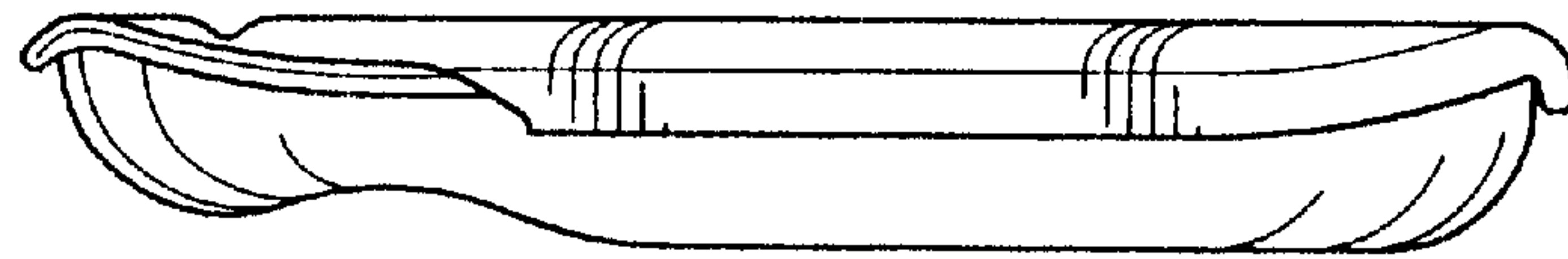

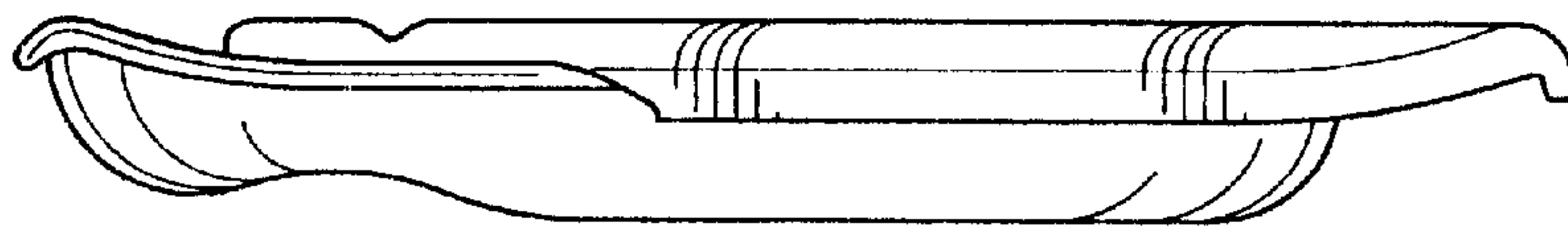

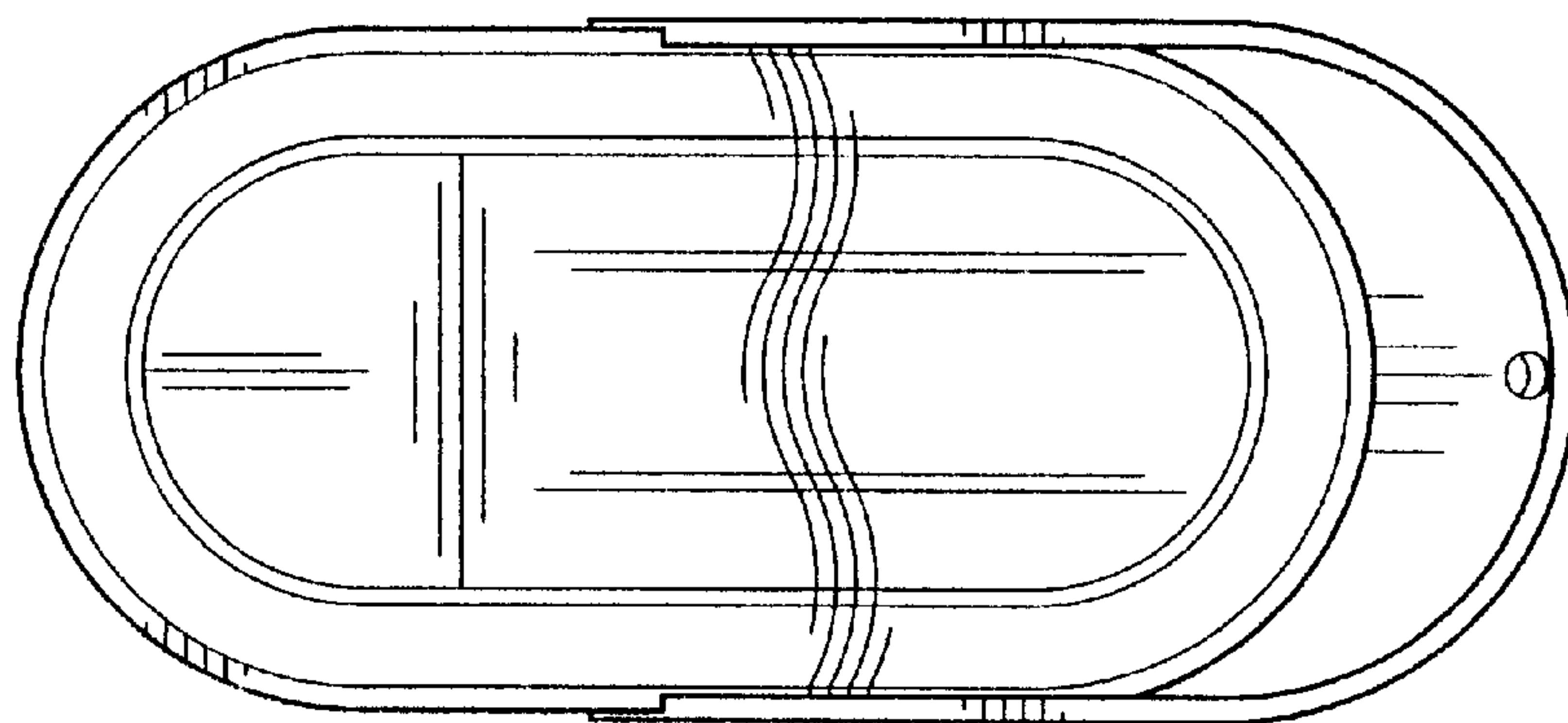
