(57) **CLAIM**

The ornamental design for an actuator cap, as shown and described.

DESCRIPTION

In a preferred embodiment, the nature of this product is an actuator cap for an aerosol can.

FIG. 1 is a top, front, right perspective view of an actuator cap embodying our new design;

FIG. 2 is a right side elevational view thereof, the left side elevational view being a mirror image of the right side elevational view;

FIG. 3 is a front elevational view thereof;

FIG. 4 is a rear elevational view thereof; and,

FIG. 5 is a top plan view thereof.

The broken line representations of a tubular plug in FIGS. 1, 3, 4 and 5 are for the purpose of illustration only and form no part of the claimed design.

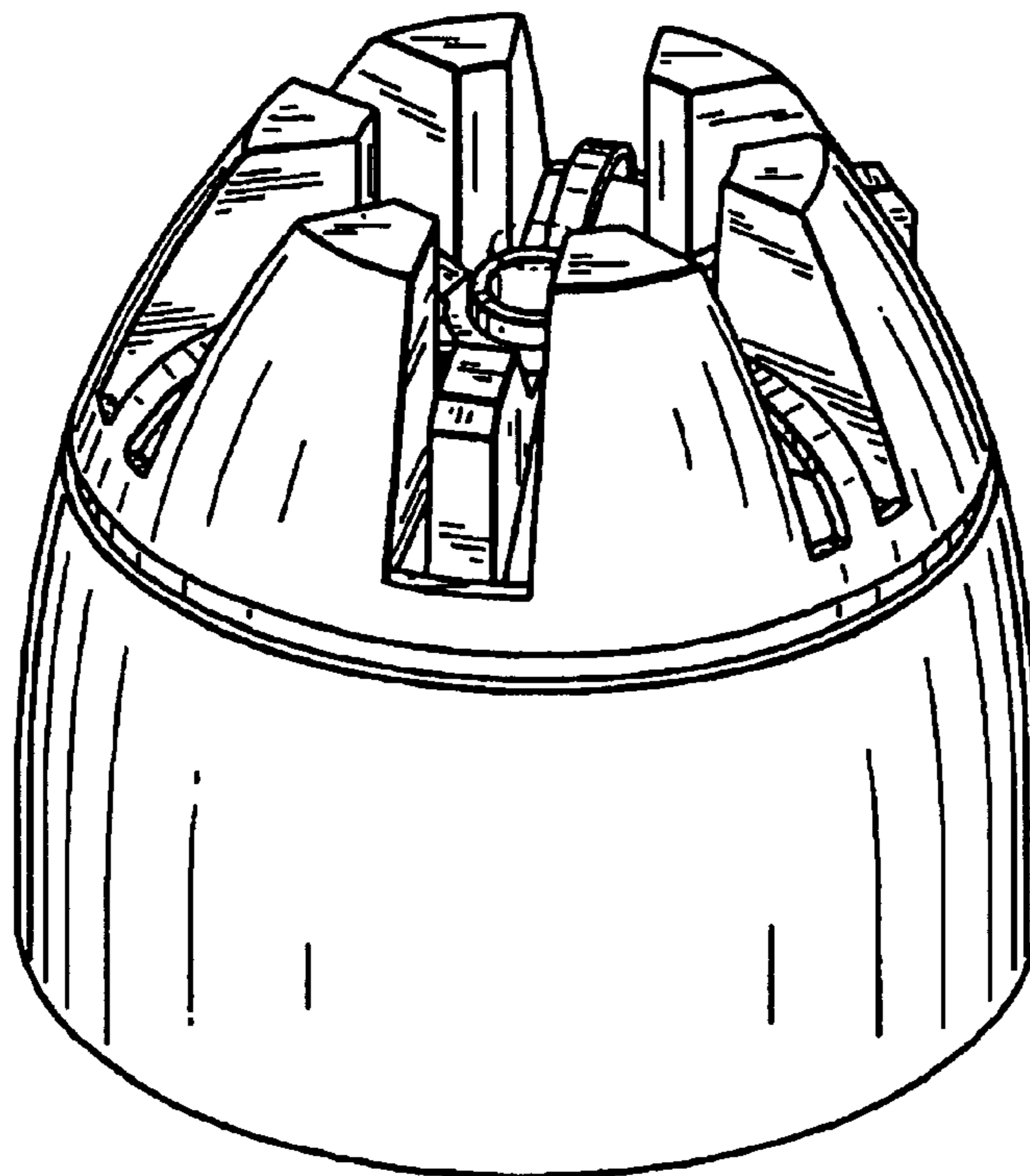

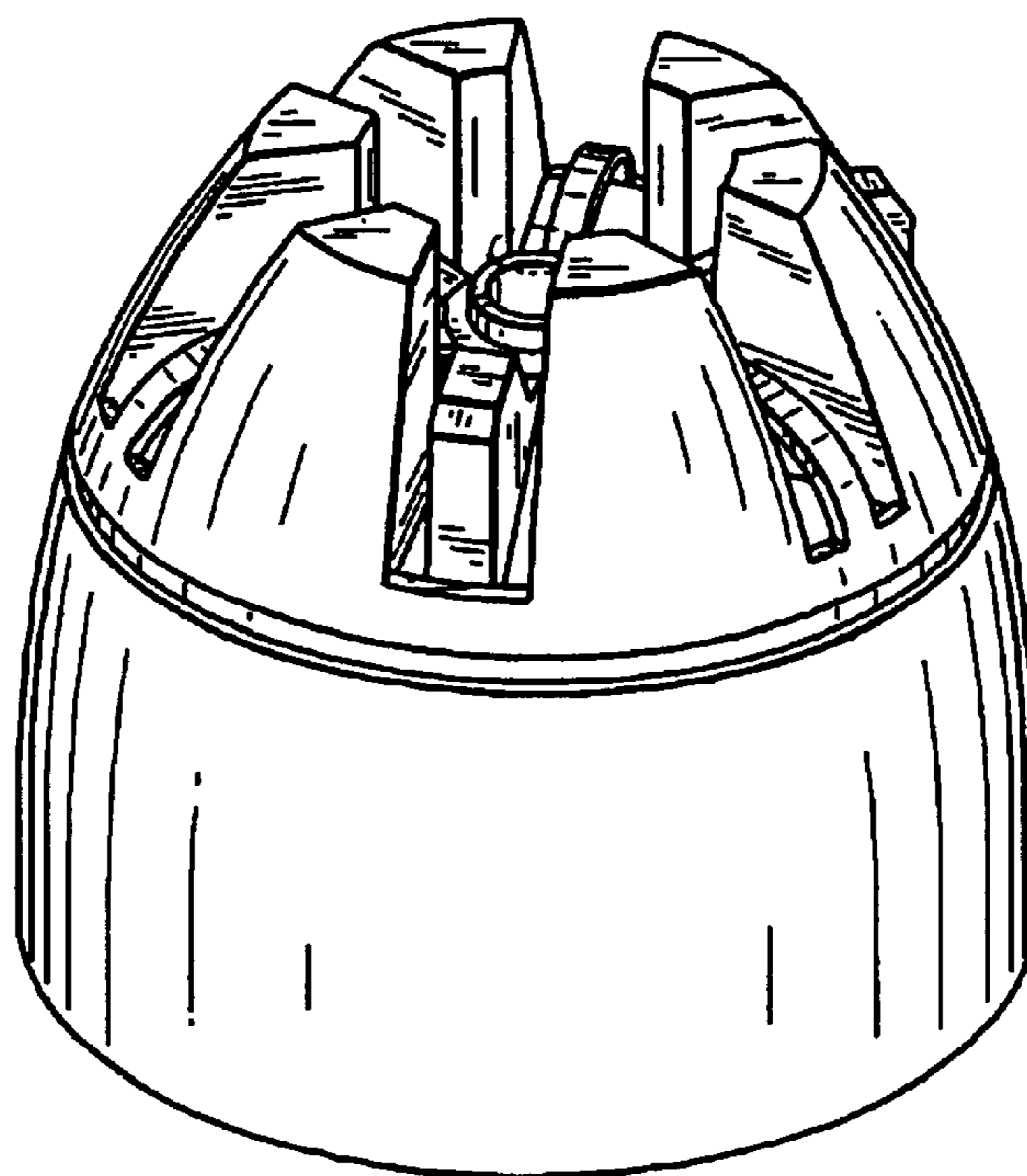

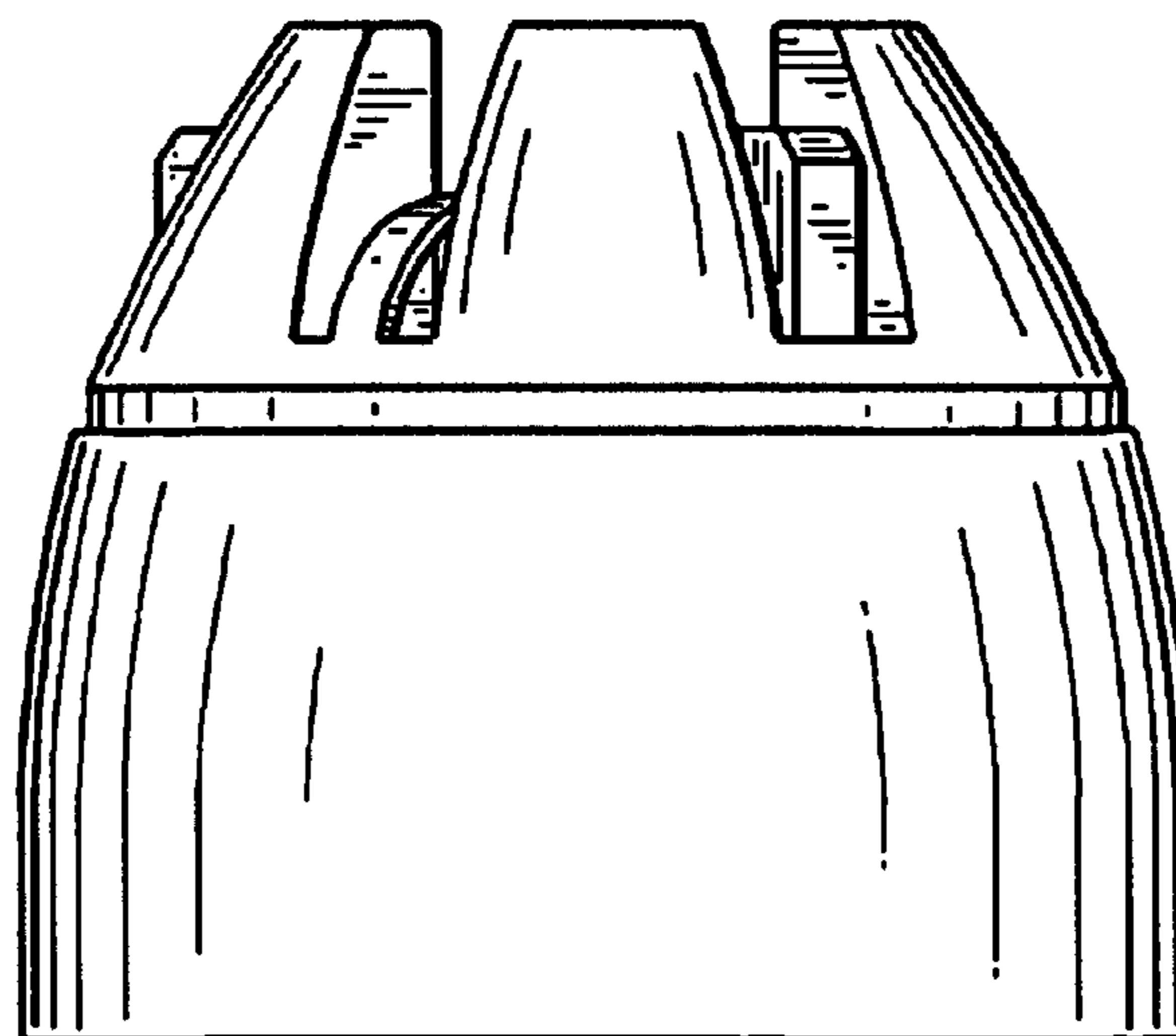

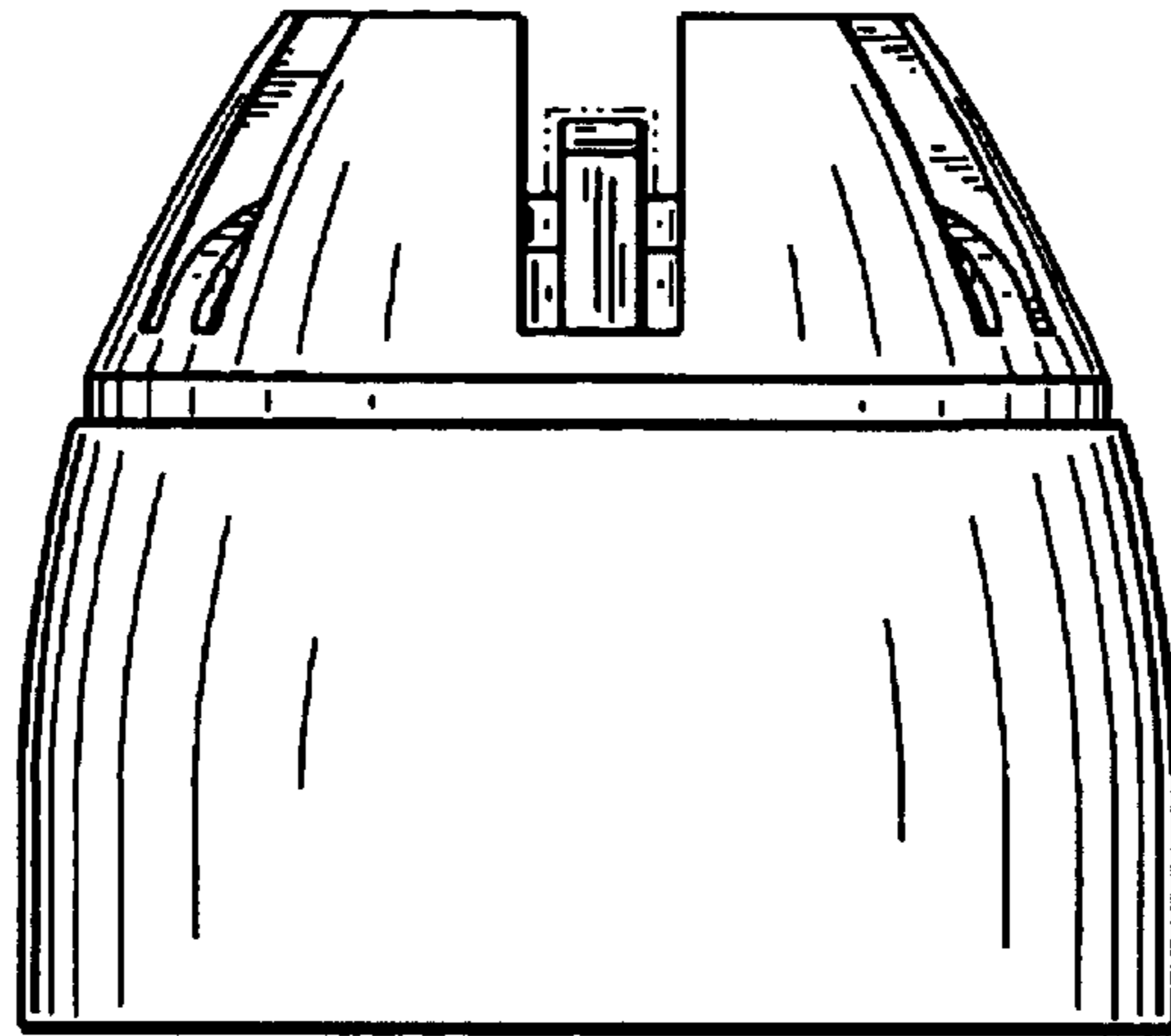

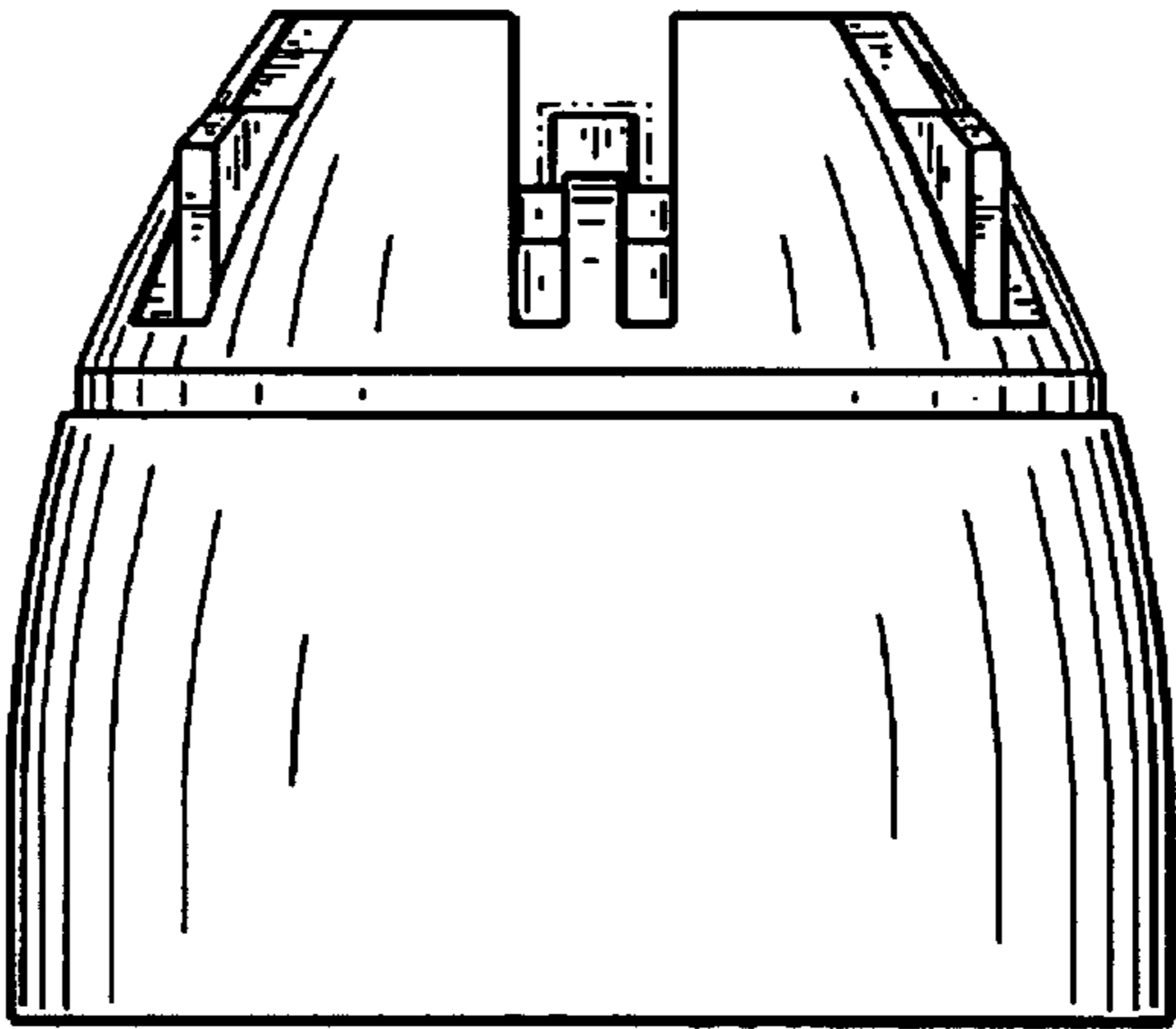
