DESCRIPTION

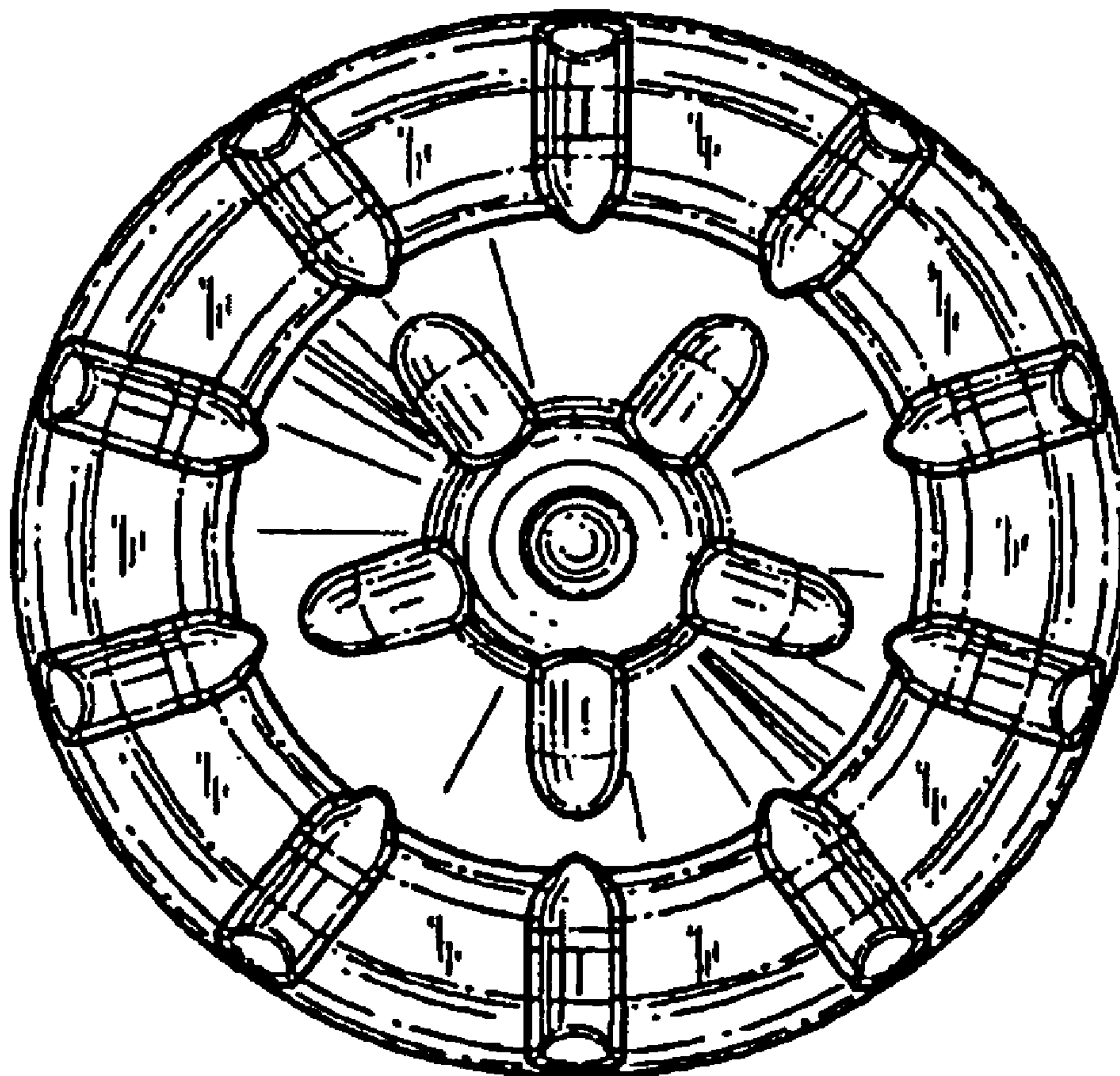
FIG. 1 is a top perspective view of the container base of the present invention;

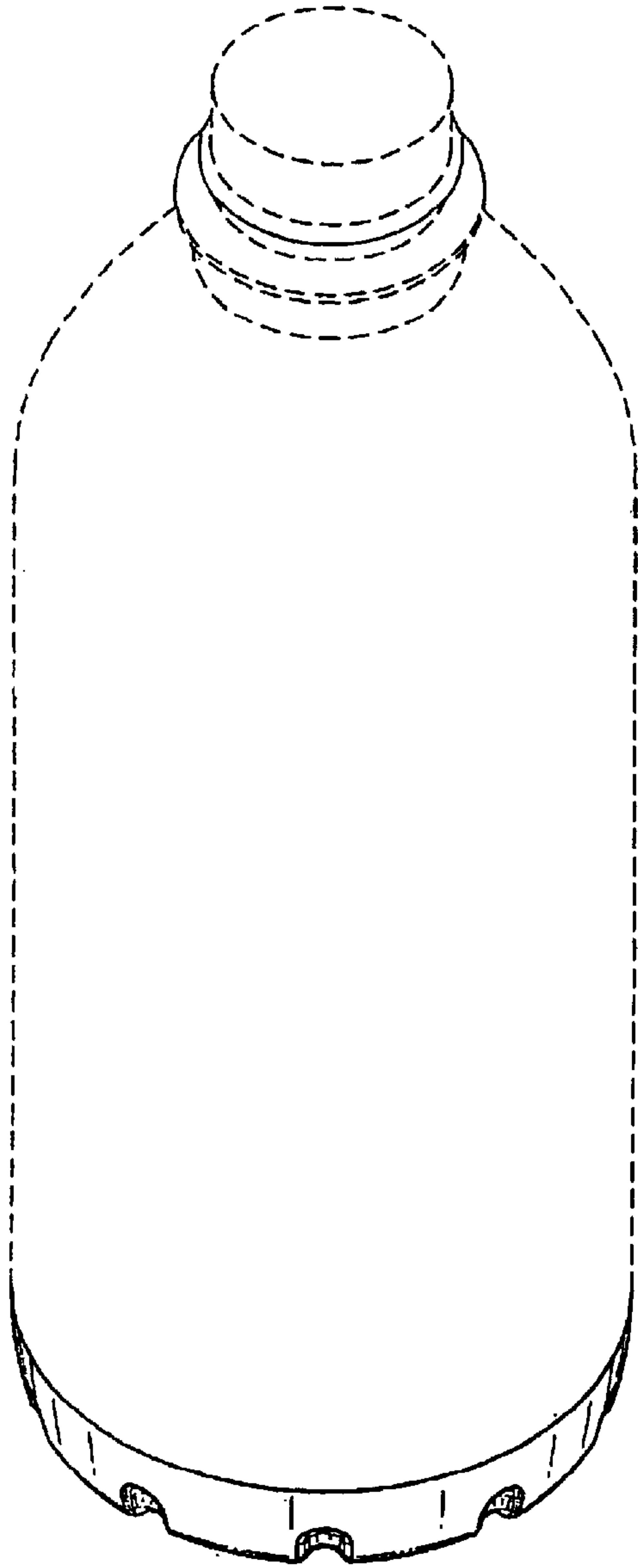

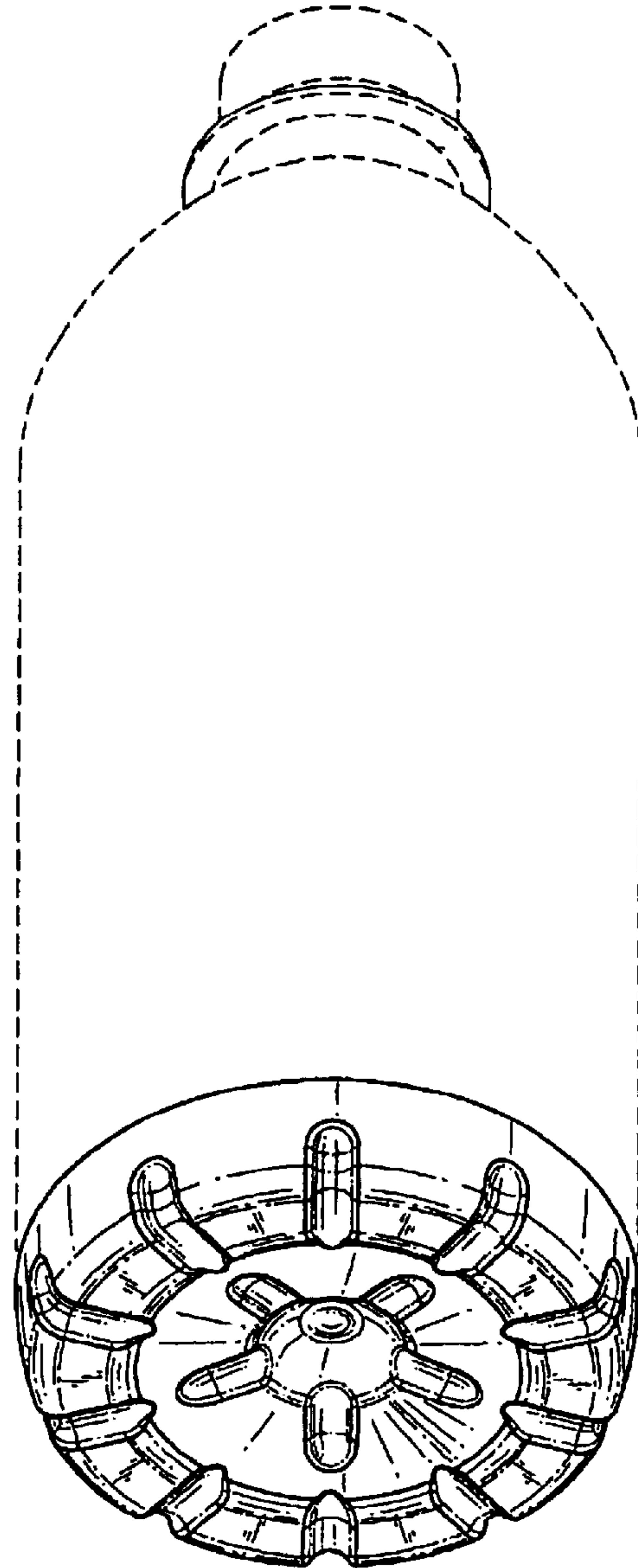

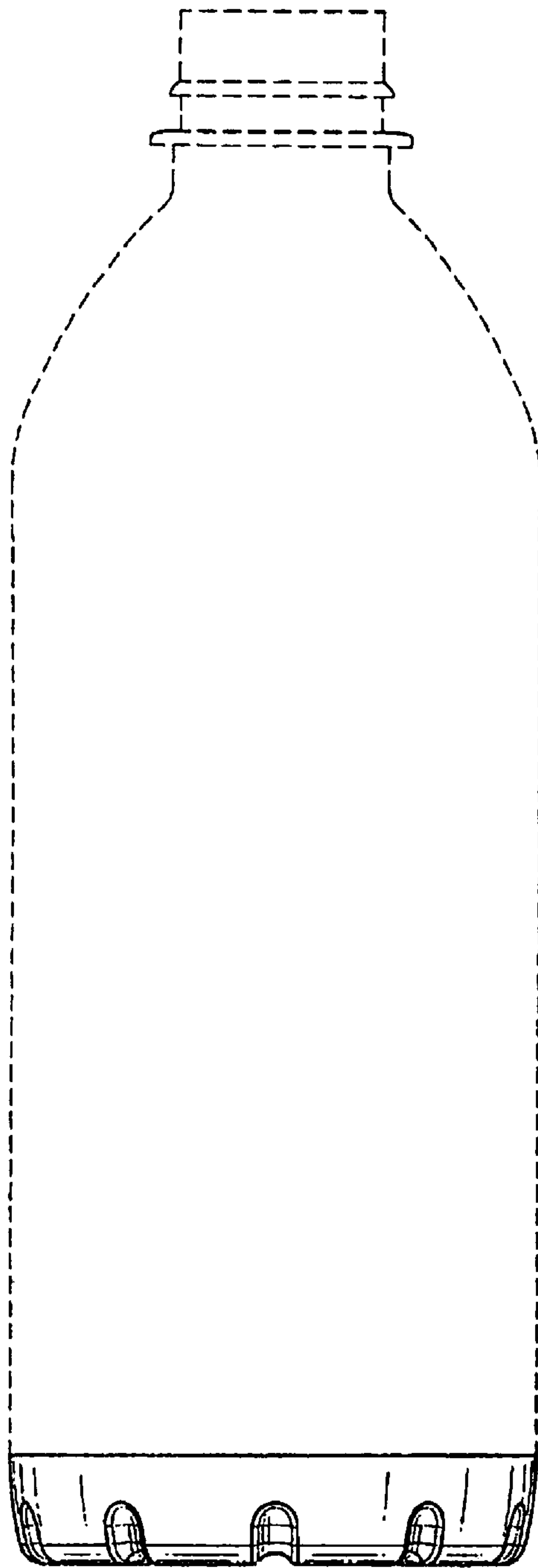

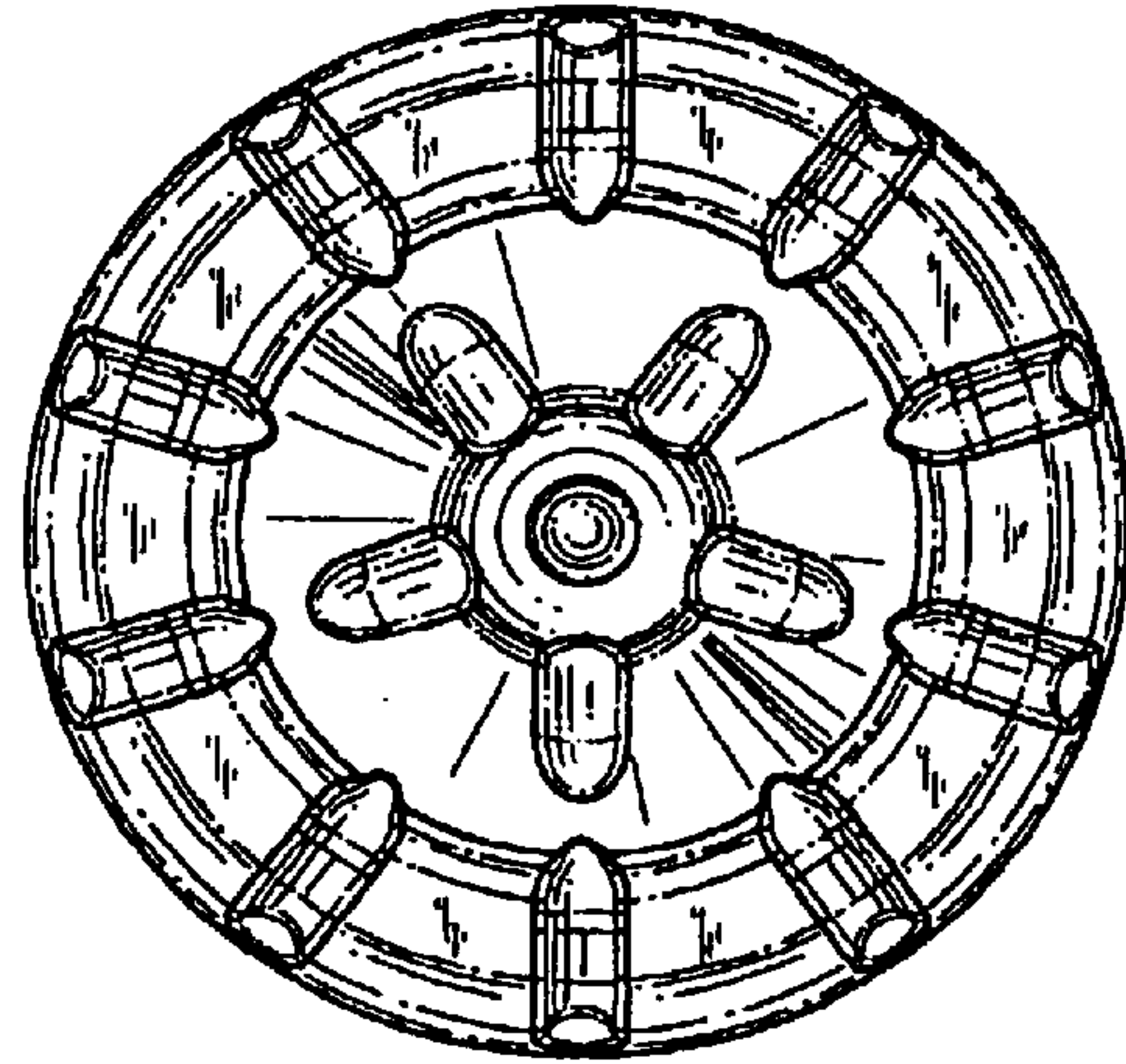
