The ornamental design for a keypad for communication device or similar articles, as shown.

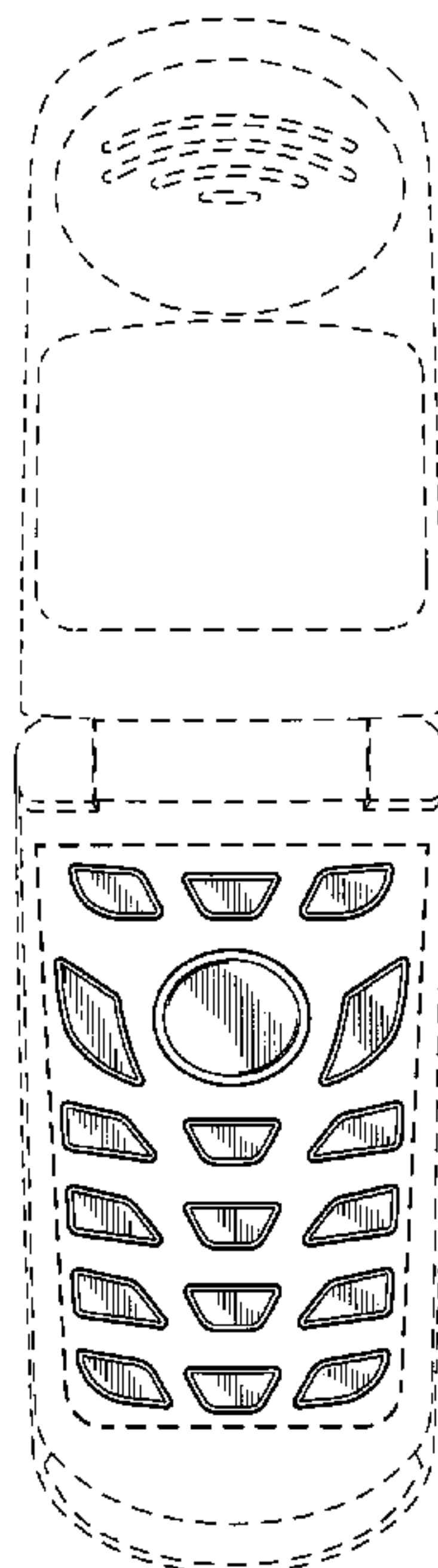
DESCRIPTION

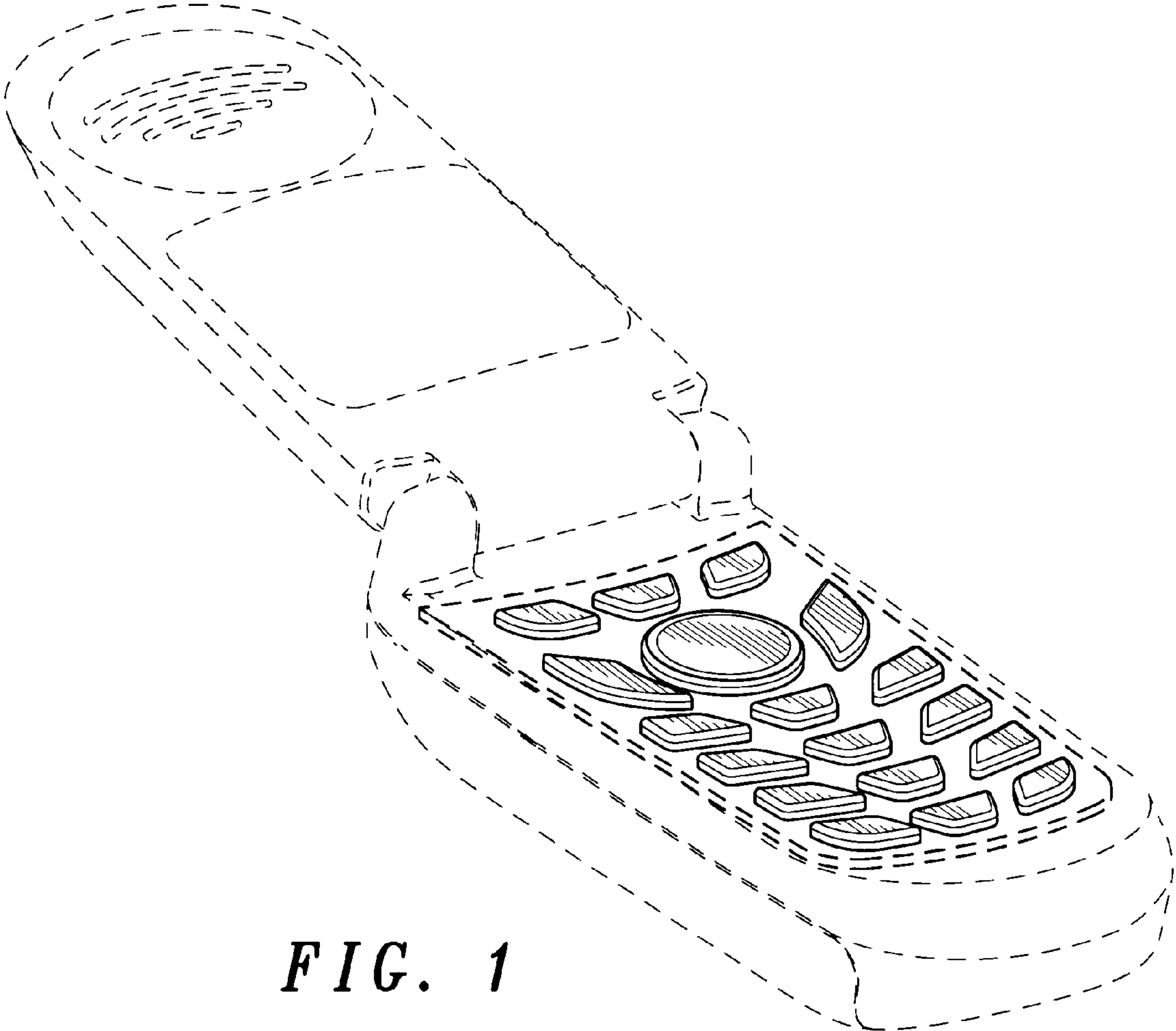

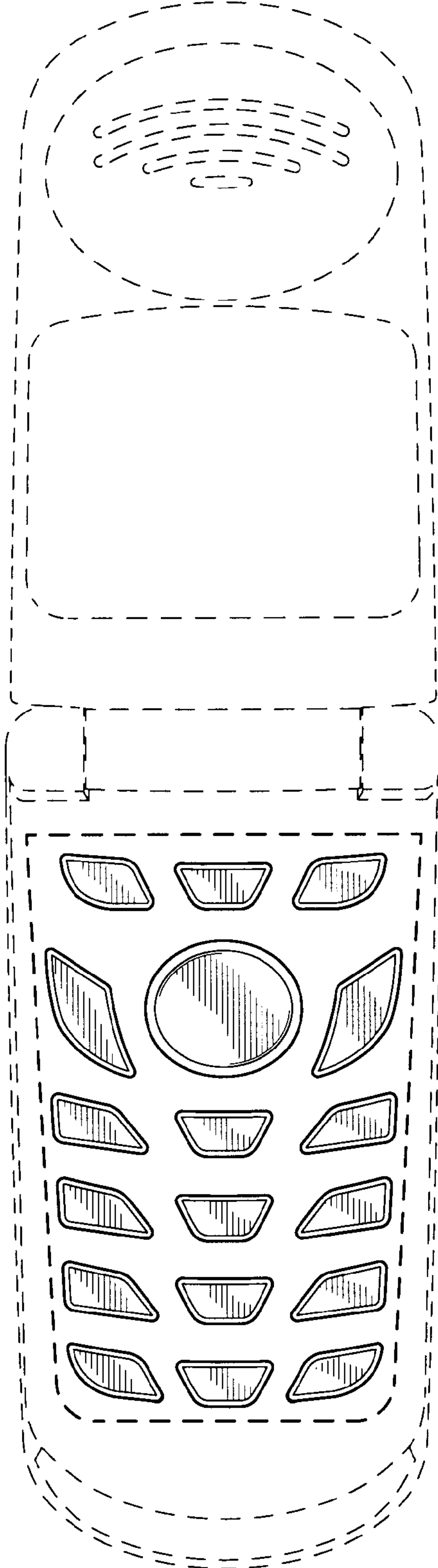
