(57) **CLAIM**

The ornamental design for a plastic holder for a golfer's scorecard and pencil, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a first embodiment of a plastic holder for a golfer's scorecard and pencil showing my new design having a transparent front pocket panel; the long and short broken lines showing the scorecard and pencil are for information purposes only and form no part of the claimed design;

FIG. 2 is a front view thereof;

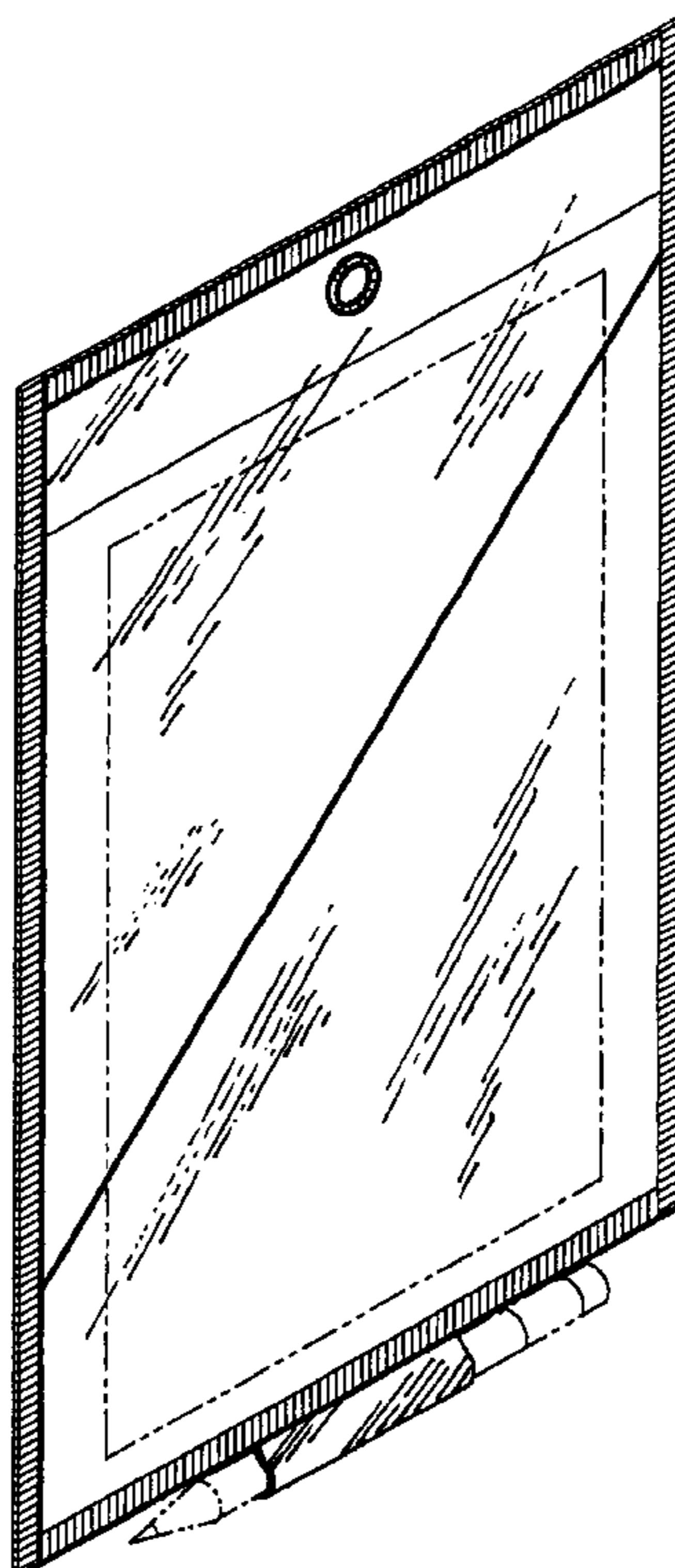
FIG. 3 is a top view thereof;

FIG. 4 is a side view thereof, the unshown opposite side being of identical appearance;

FIG. 5 is a bottom view thereof; and,

FIG. 6 is a front view of a second embodiment of my plastic holder for a golfer's scorecard and pencil, showing my new design having an opaque front pocket panel, and being otherwise identical to said first embodiment.

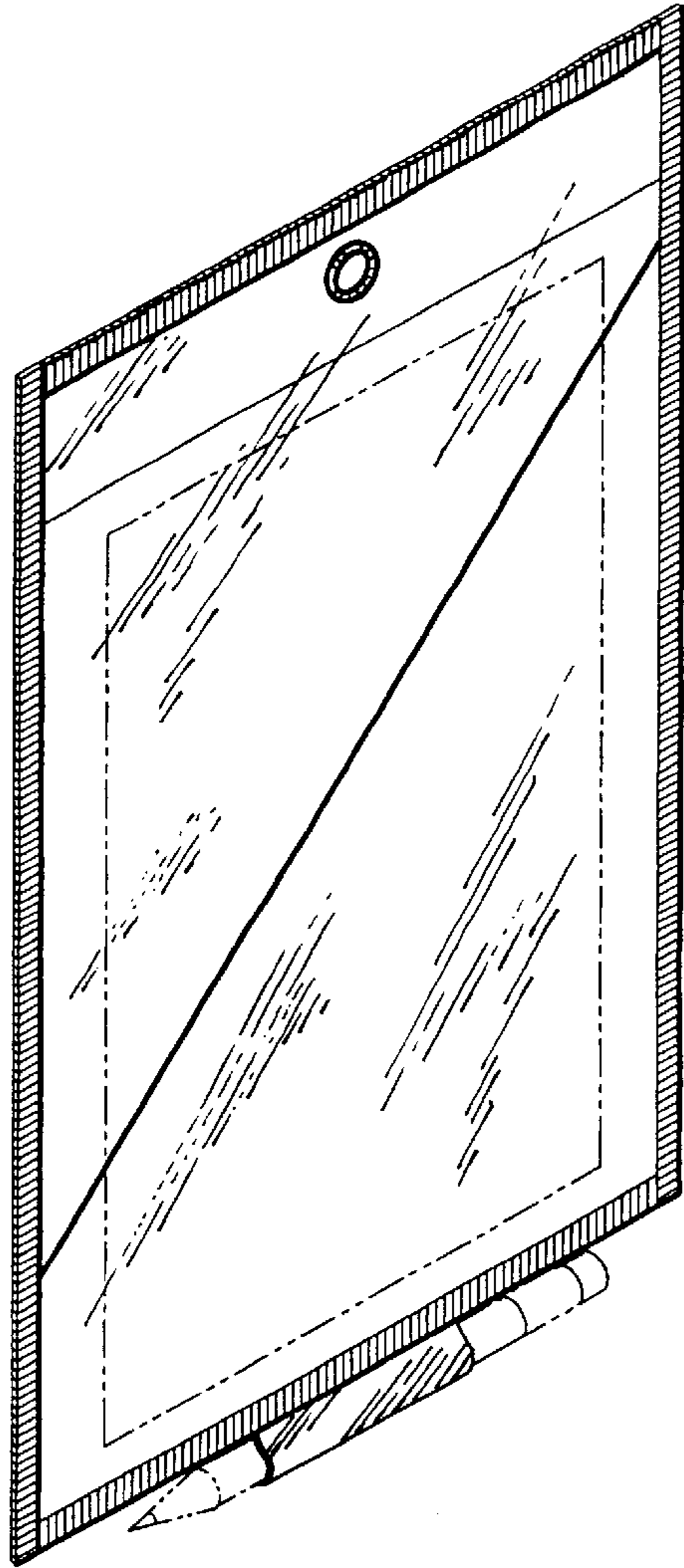

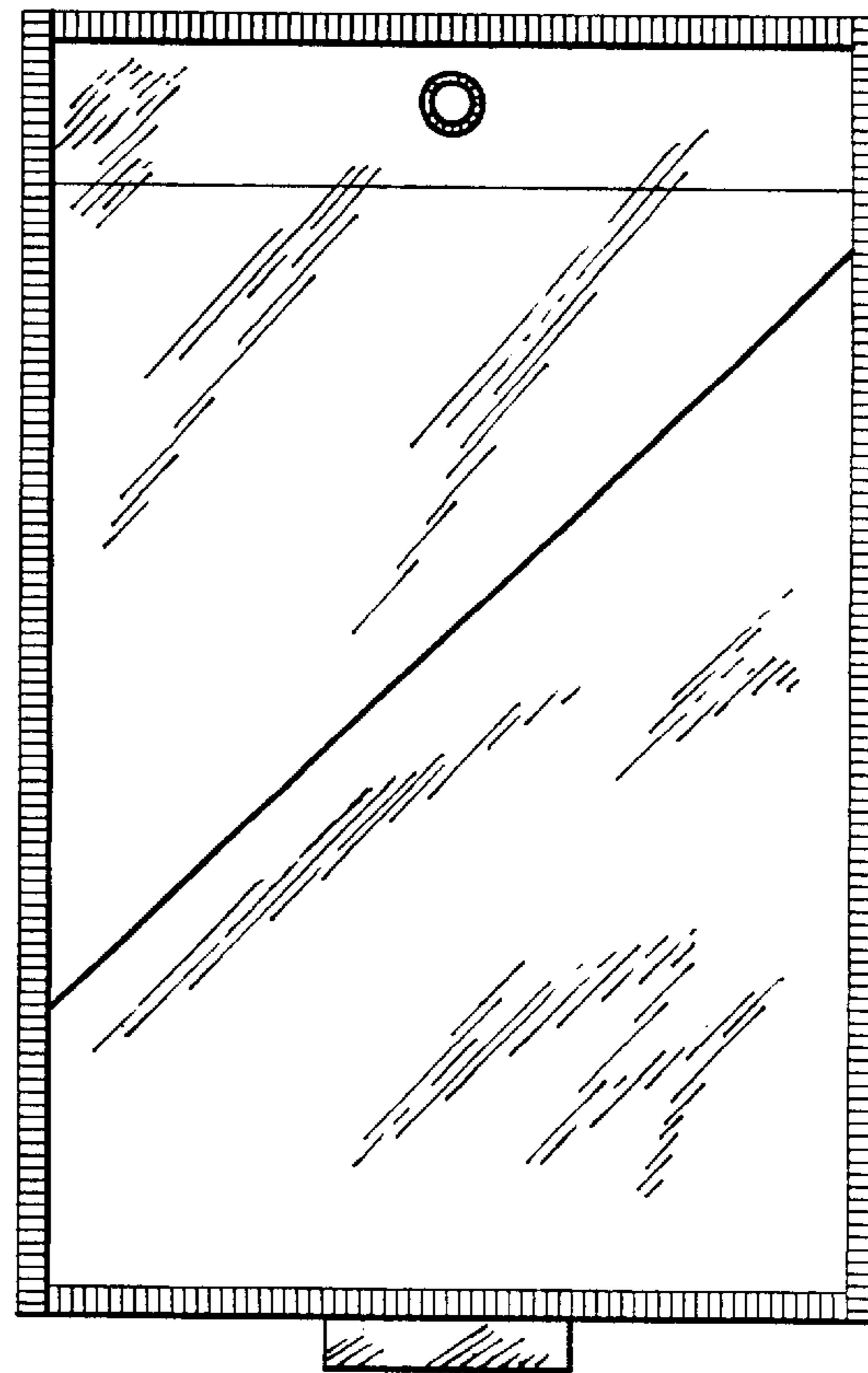

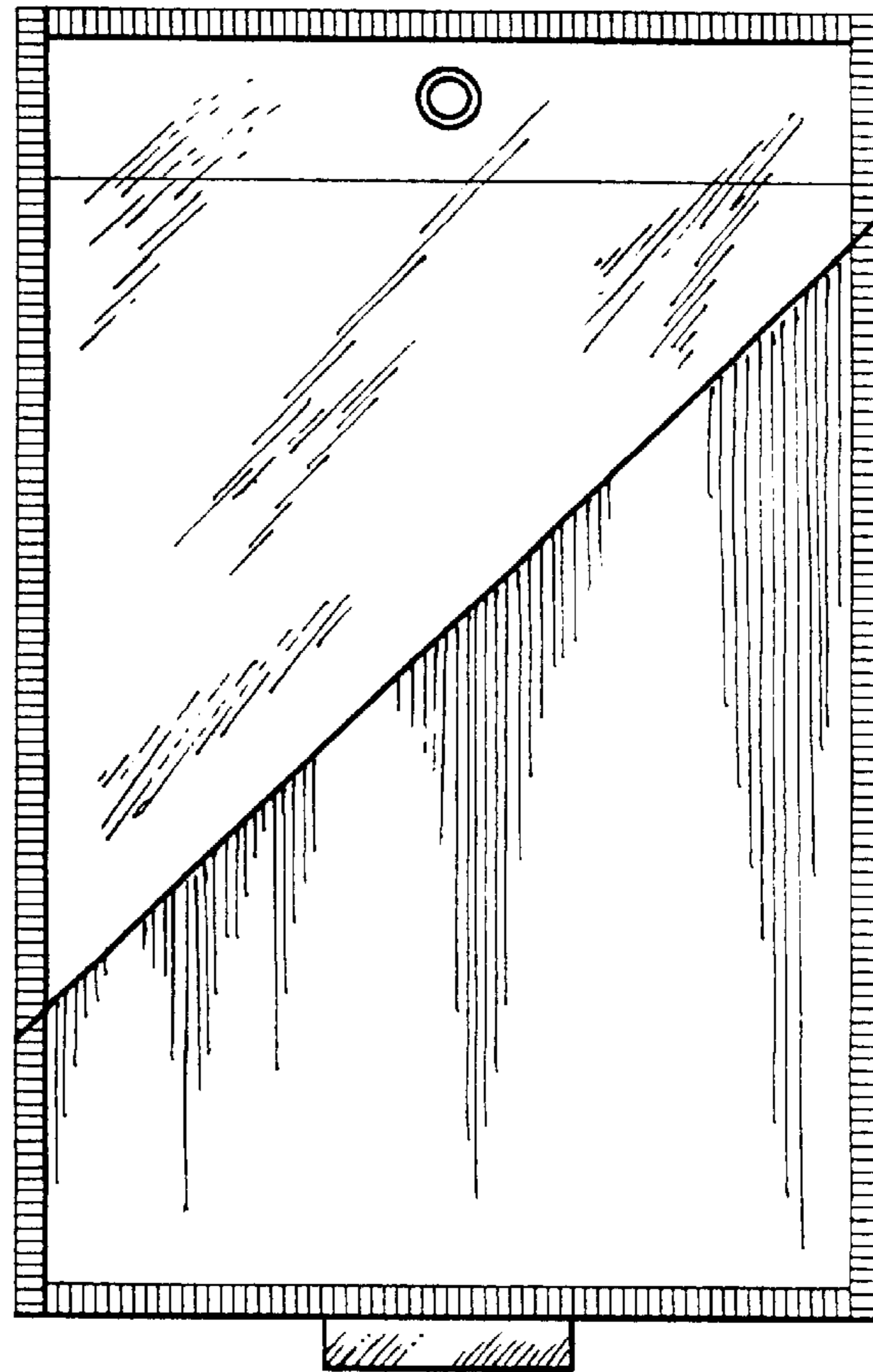
