FIG. 3 is a bottom view of the bunny in accordance with my invention.

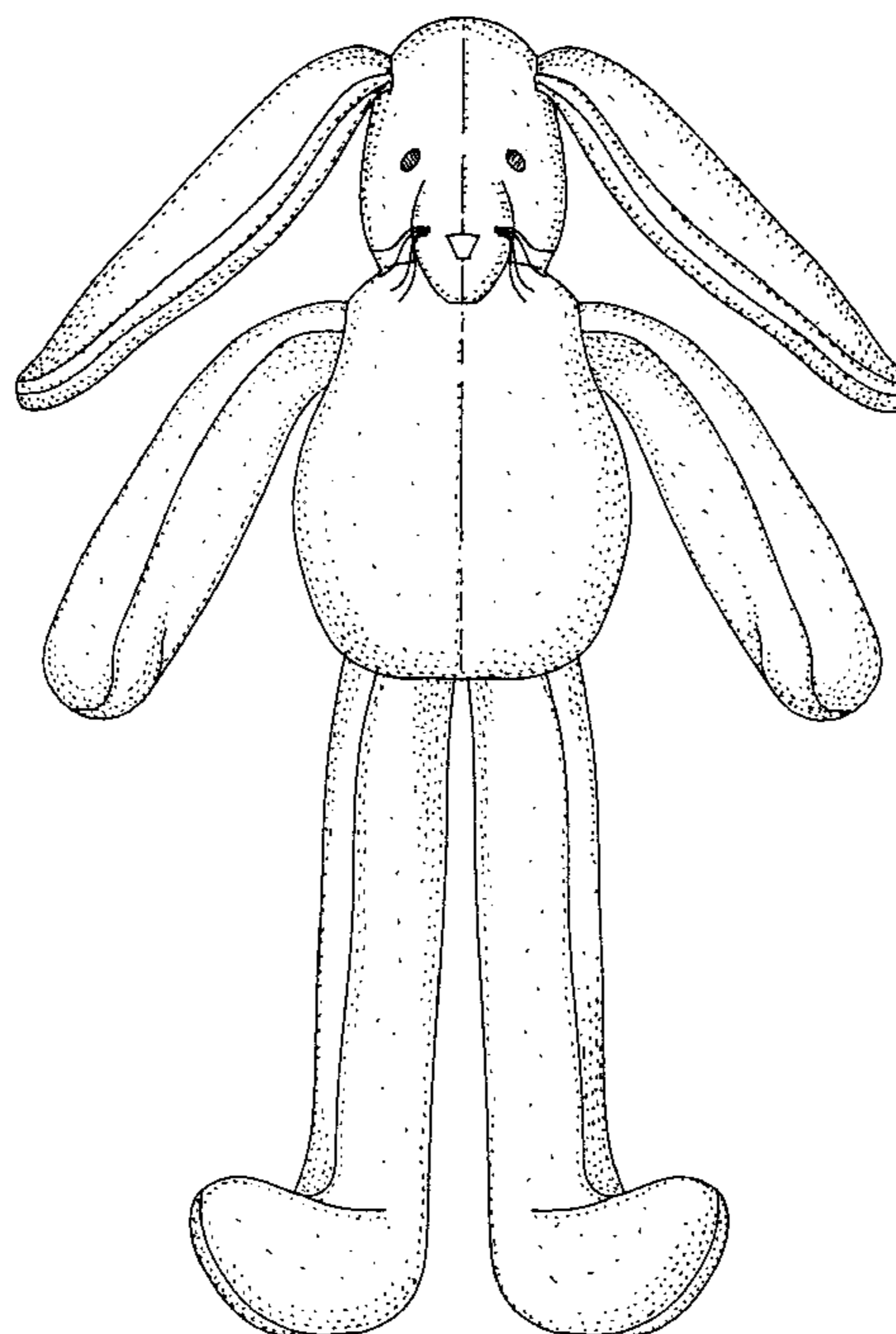
FIG. 4 is a back view of the bunny in accordance with my invention.

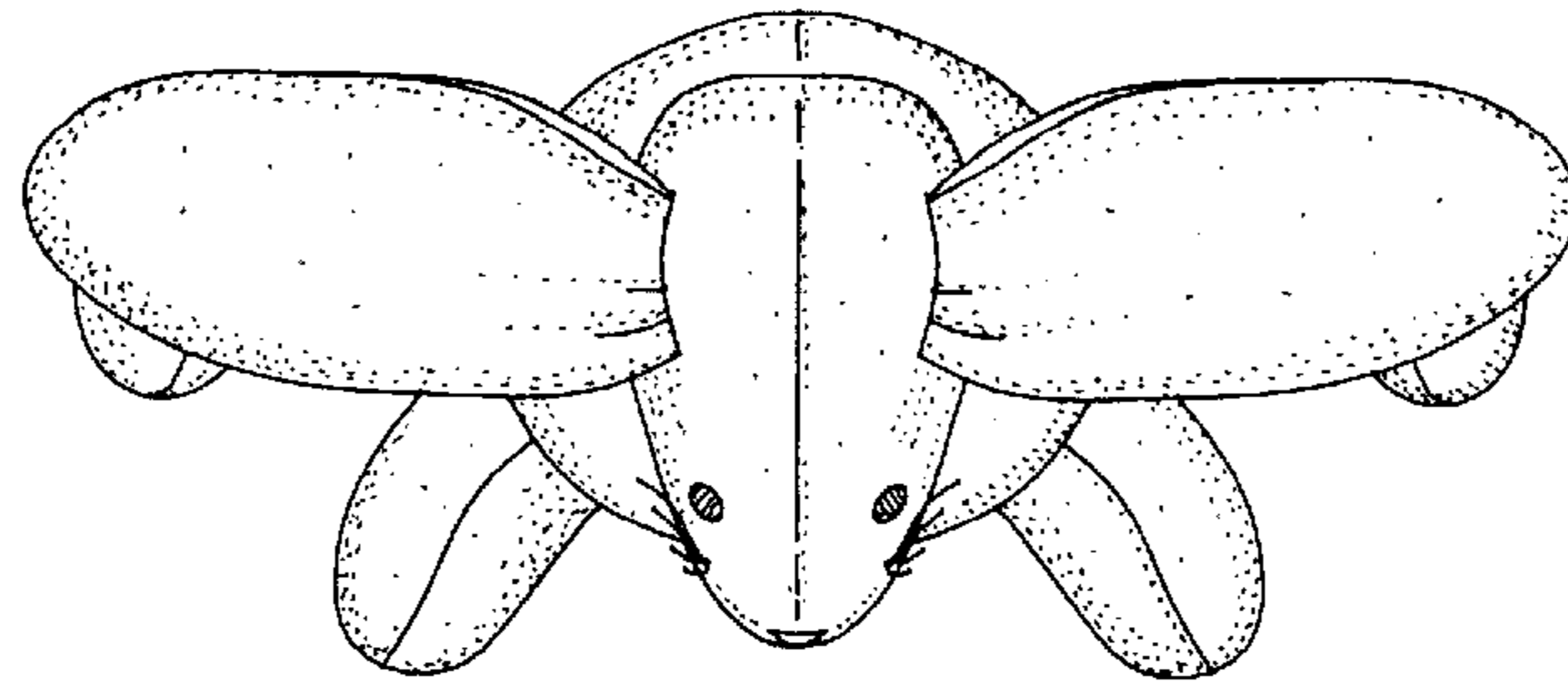
FIG. 5 is a side view of the bunny in accordance with my invention.

FIG. 6 is a prospective view of the bunny in accordance with my invention; and,

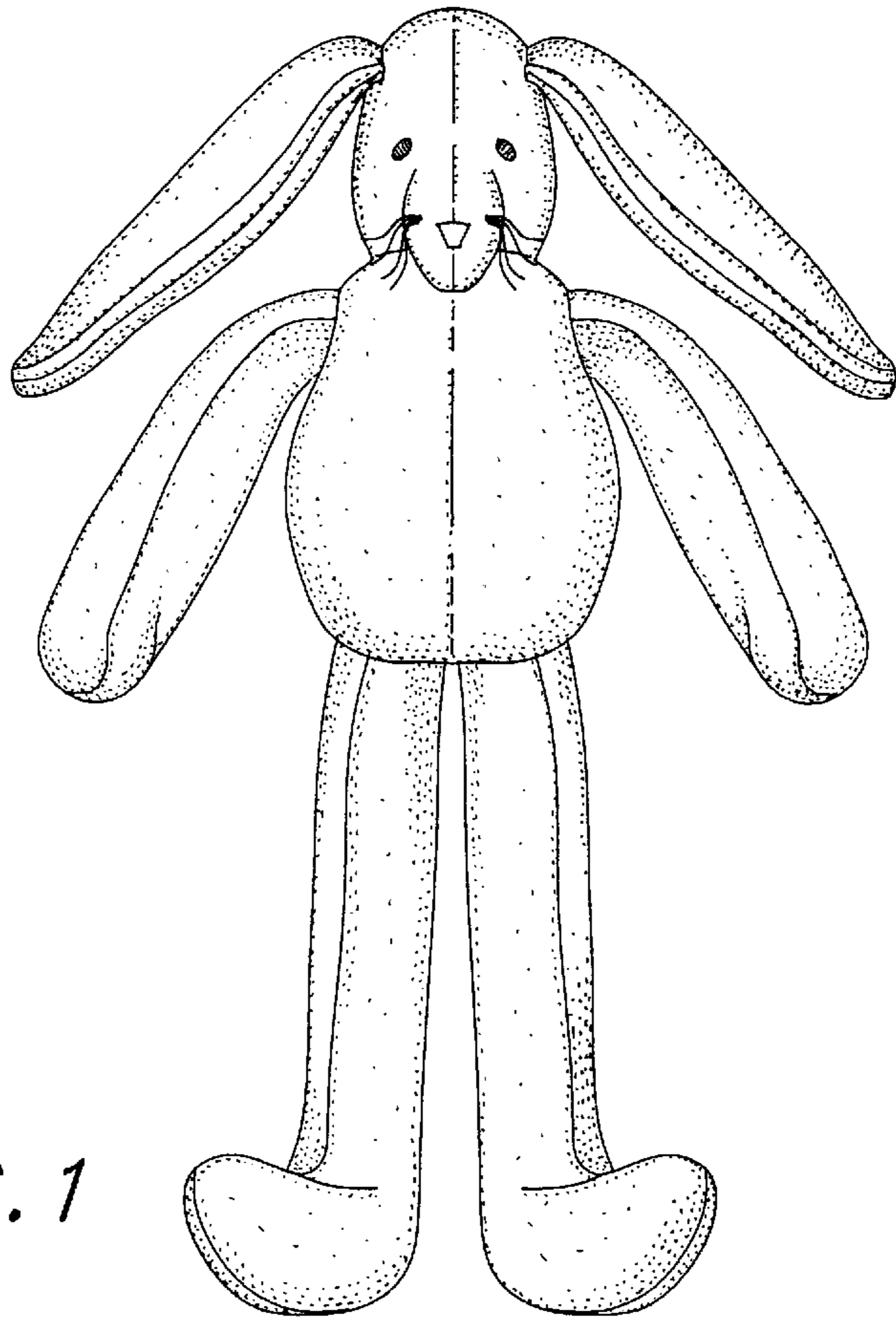

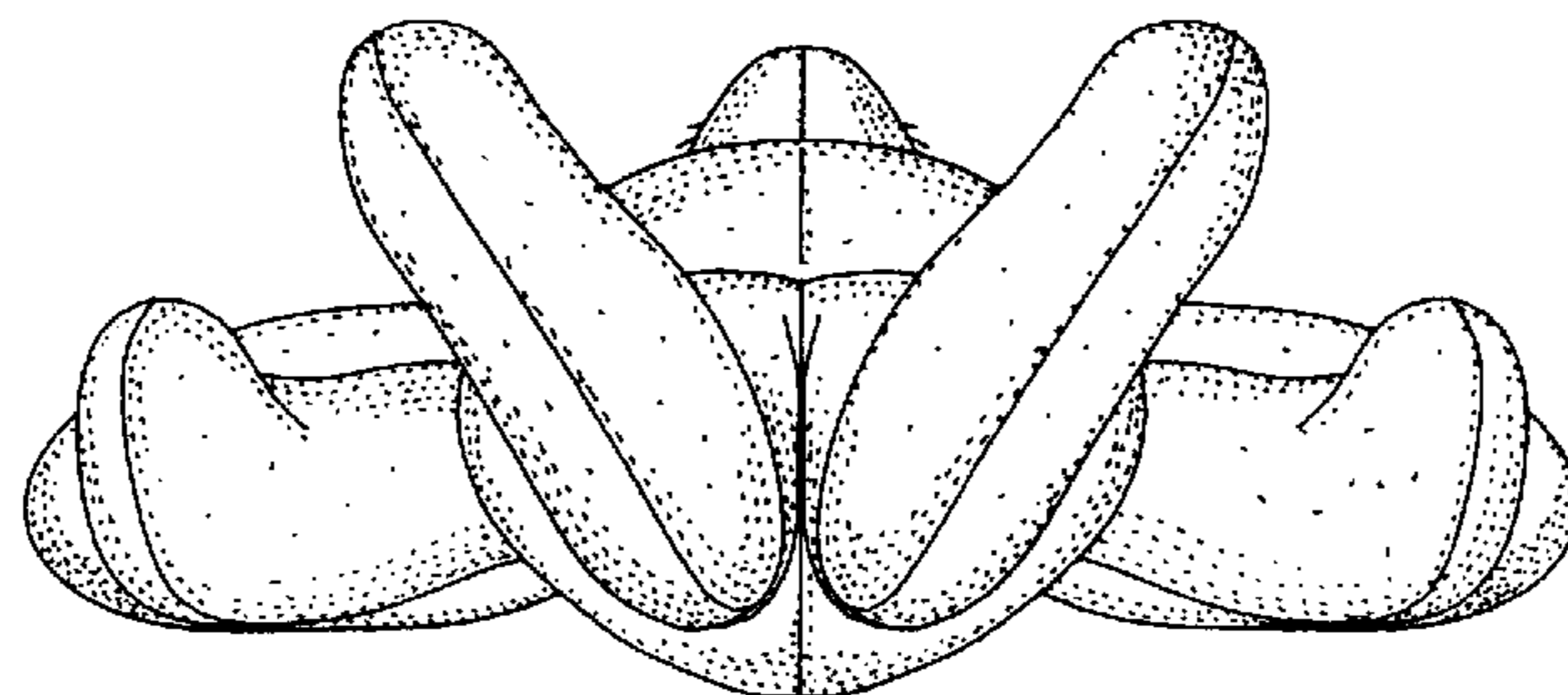




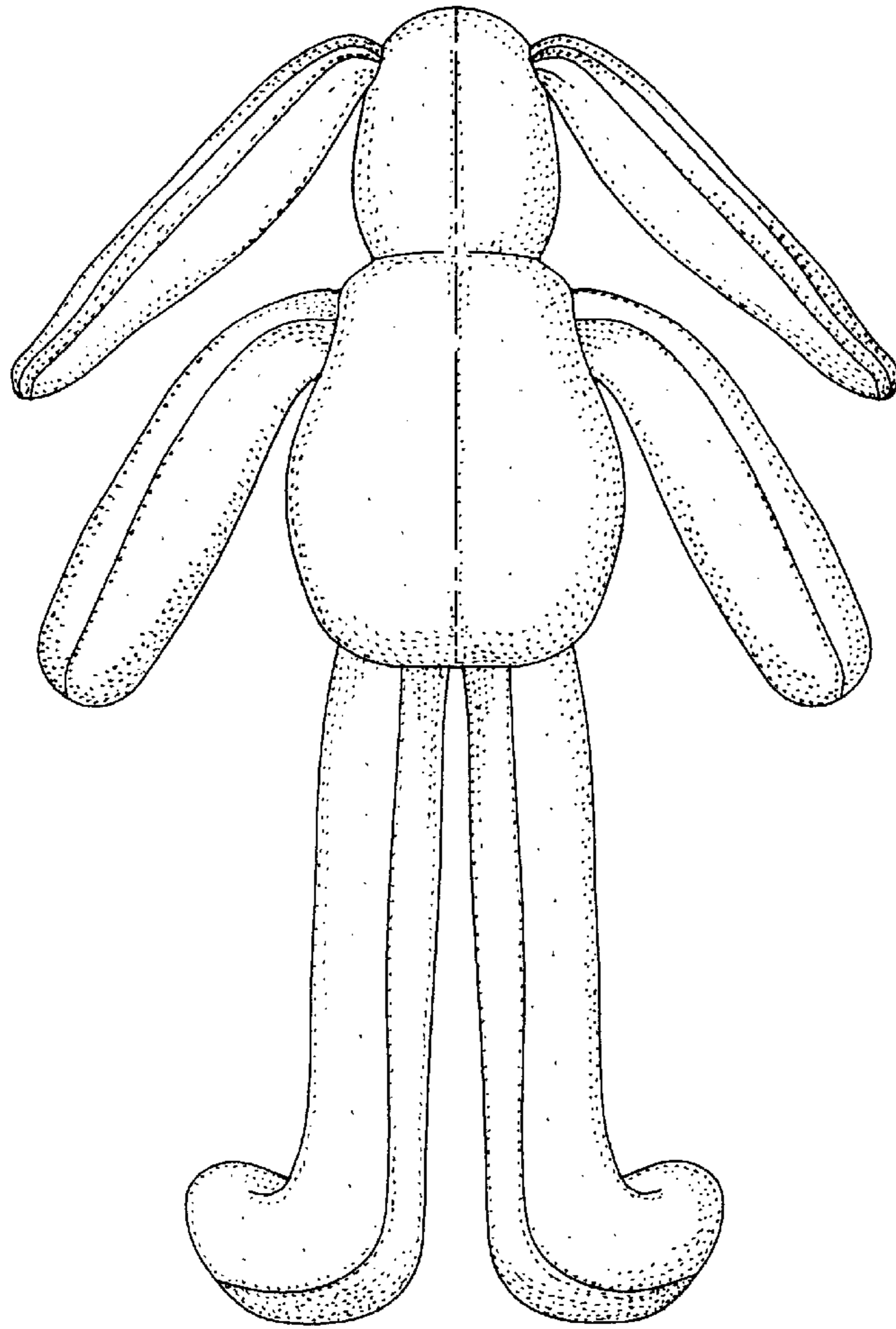

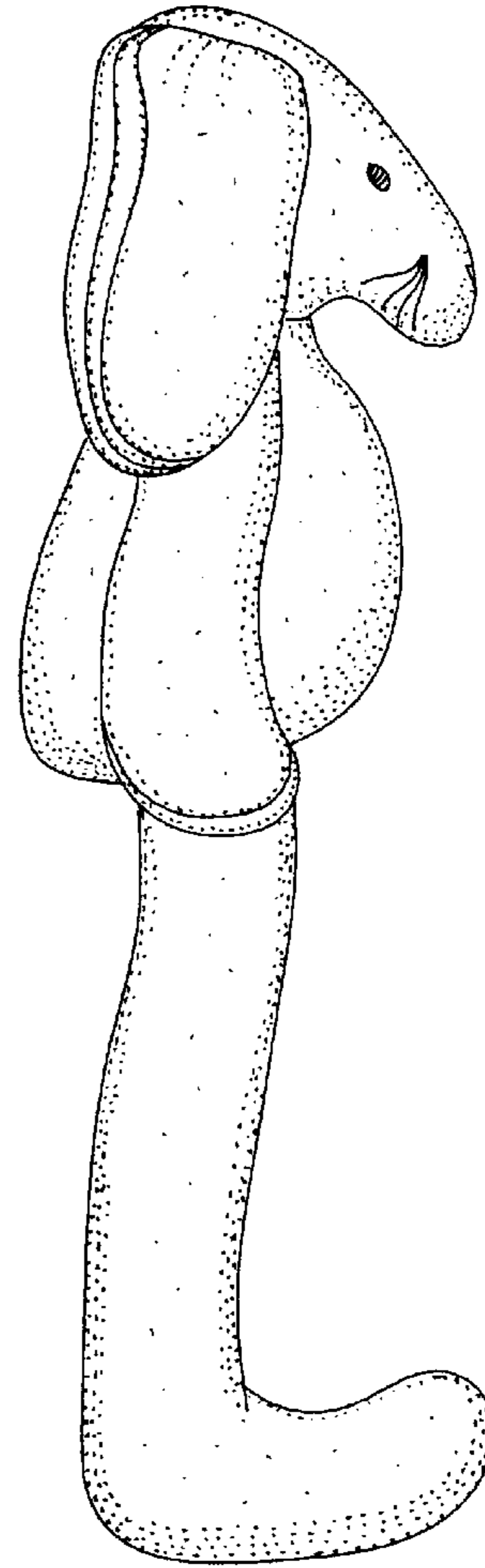

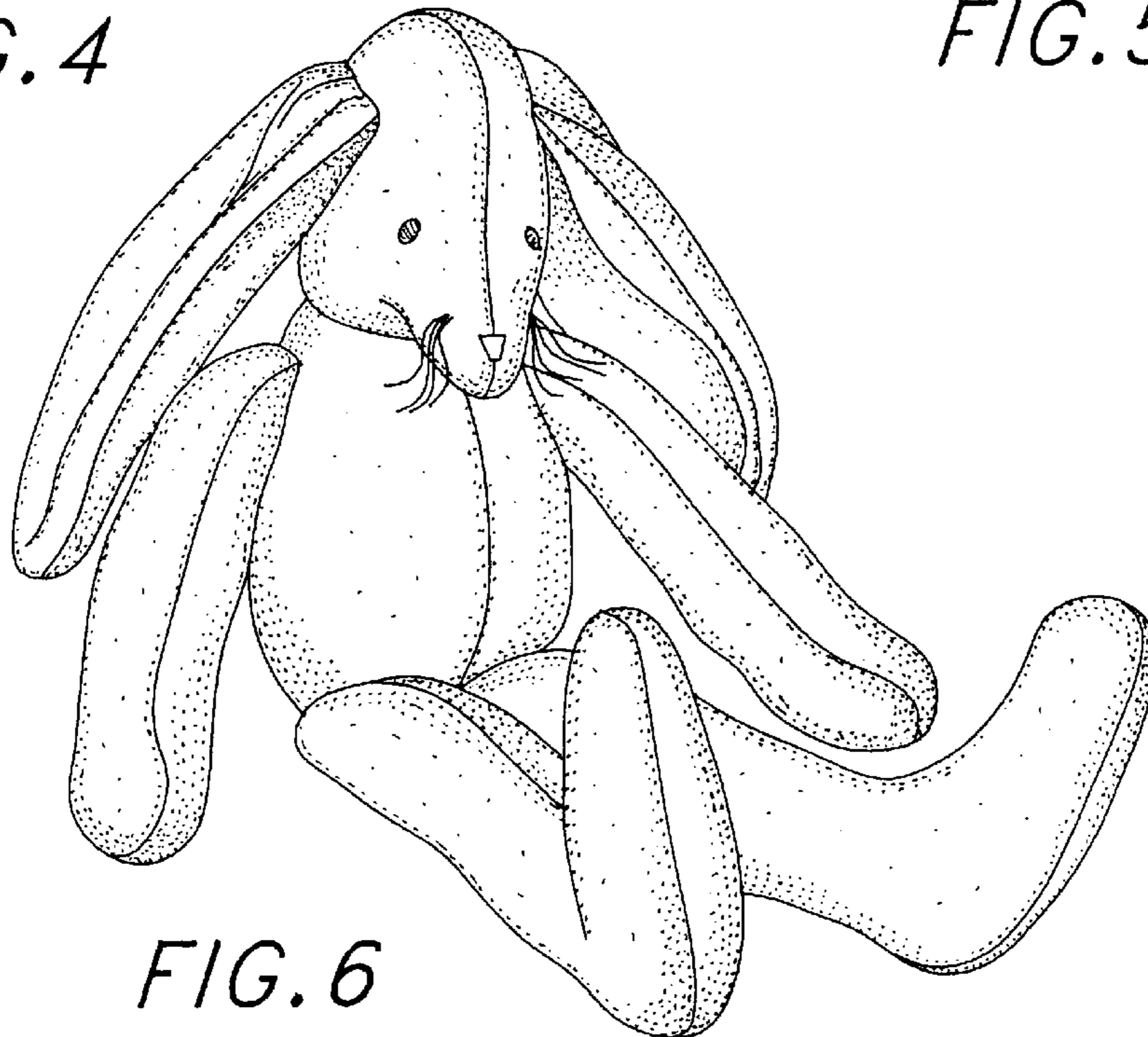

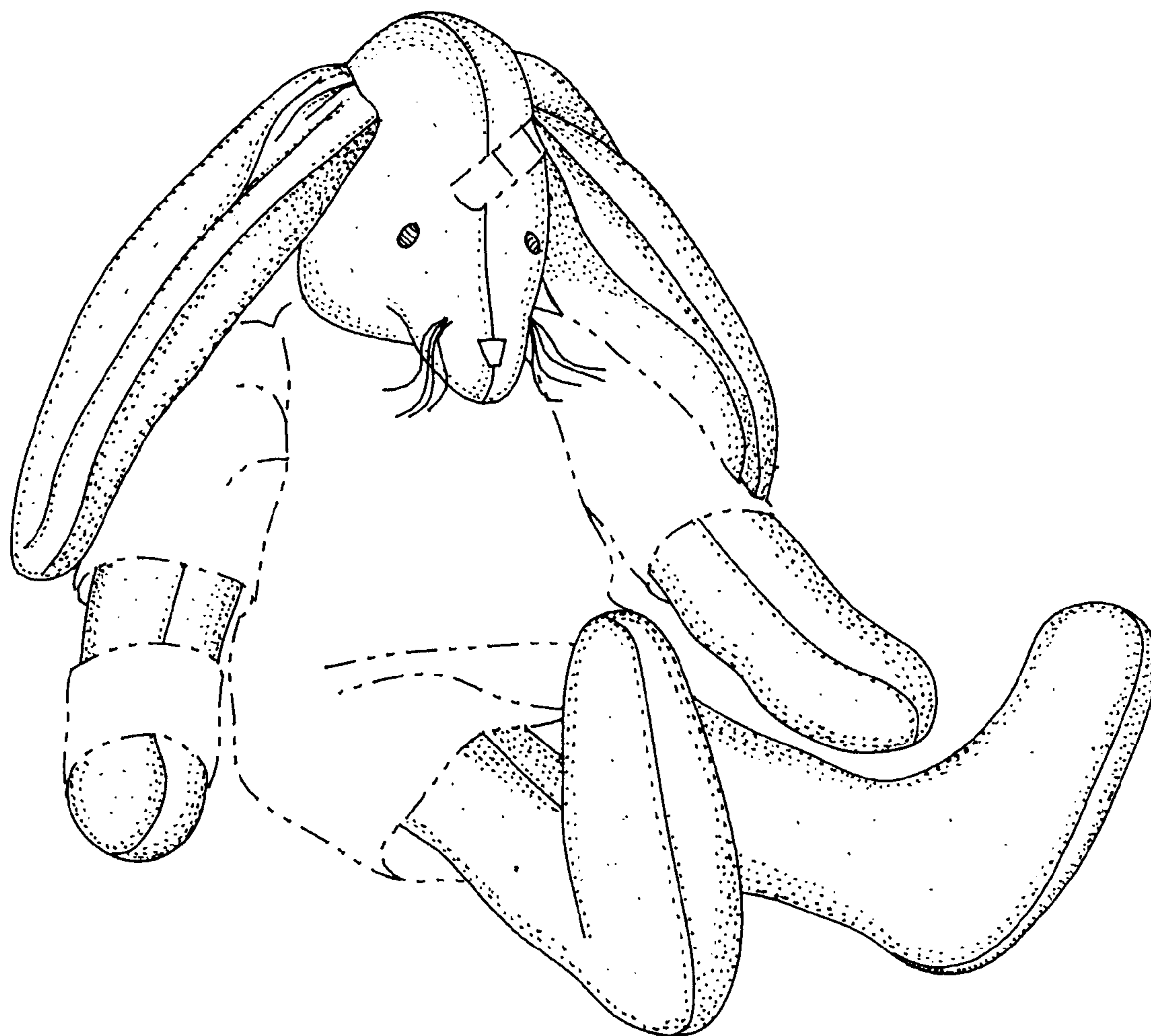
