(57) **CLAIM**

The ornamental design for a combination ceiling fan and light fixture, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view from below of a combination ceiling fan and light fixture in accordance with my design; FIG. 2 is a bottom plan view of the combination ceiling fan and light fixture in accordance with my design;

FIG. 3 is a top plan view of a combination ceiling fan and light fixture in accordance with my design;

FIG. 4 is a side elevation view of the combination ceiling fan and light fixture in accordance with my design; and,

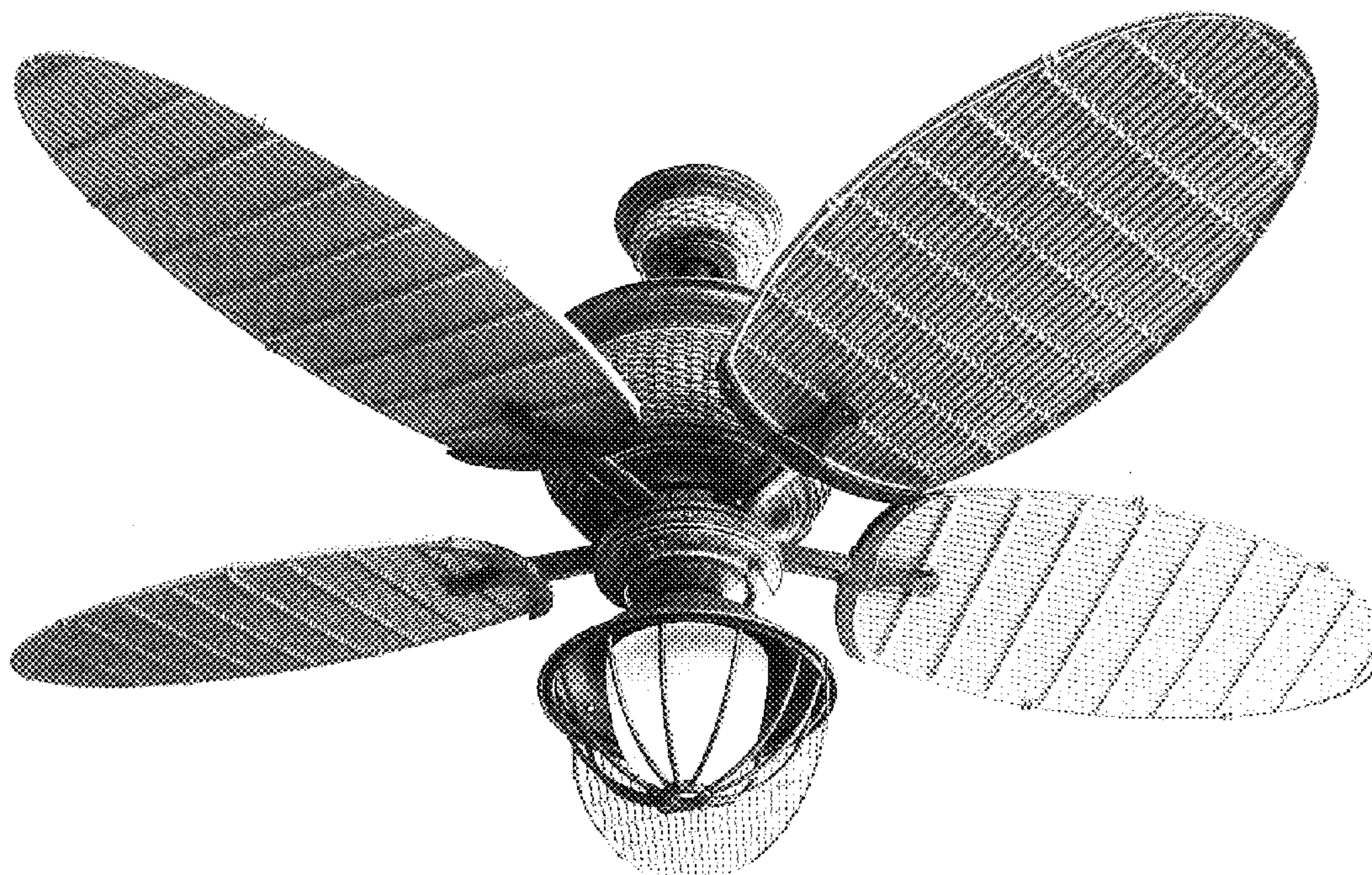
FIG. 5 is a reduced front elevation view of the combination ceiling fan and light fixture in accordance with my design; and,

FIG. 6 is an enlarged partial perspective view from below of combination ceiling fan and light fixture in accordance with my design.

FIGS. 4 and 5 and the opposite side view and the rear view are identical except for the positioning of the fan blades.

The broken lines showing environmental structure are for illustrative purposes and form no part of the claimed design.

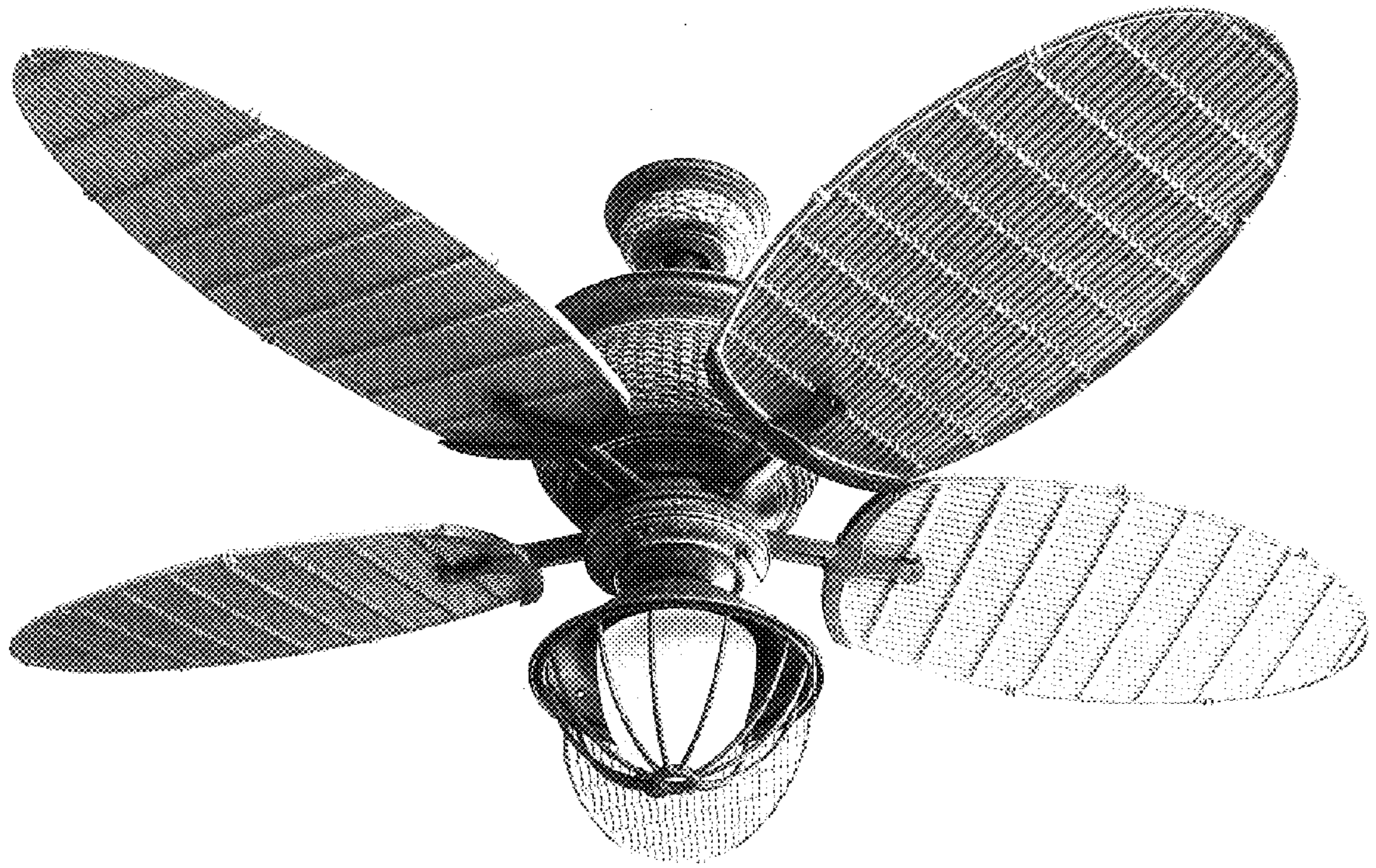

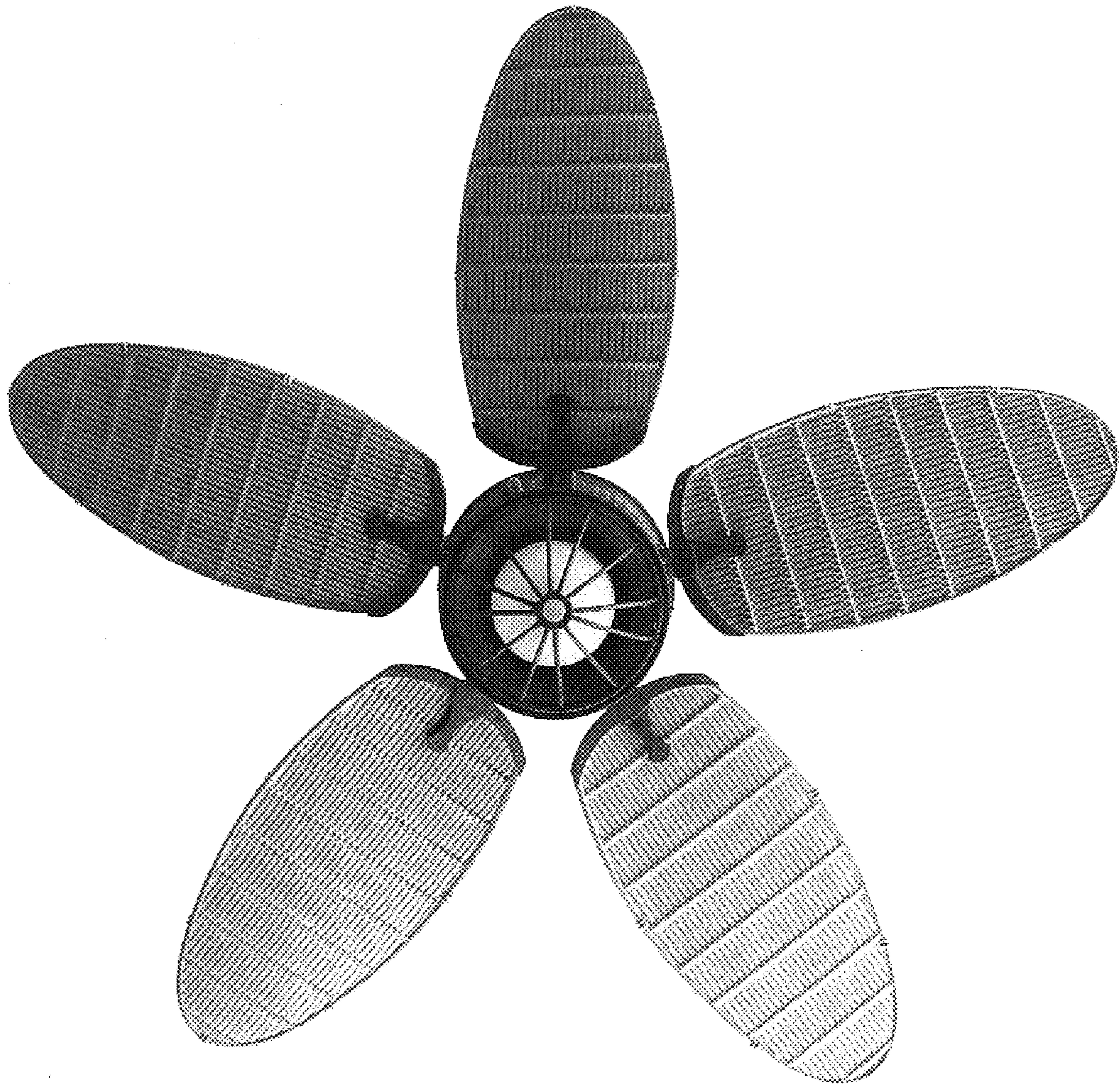

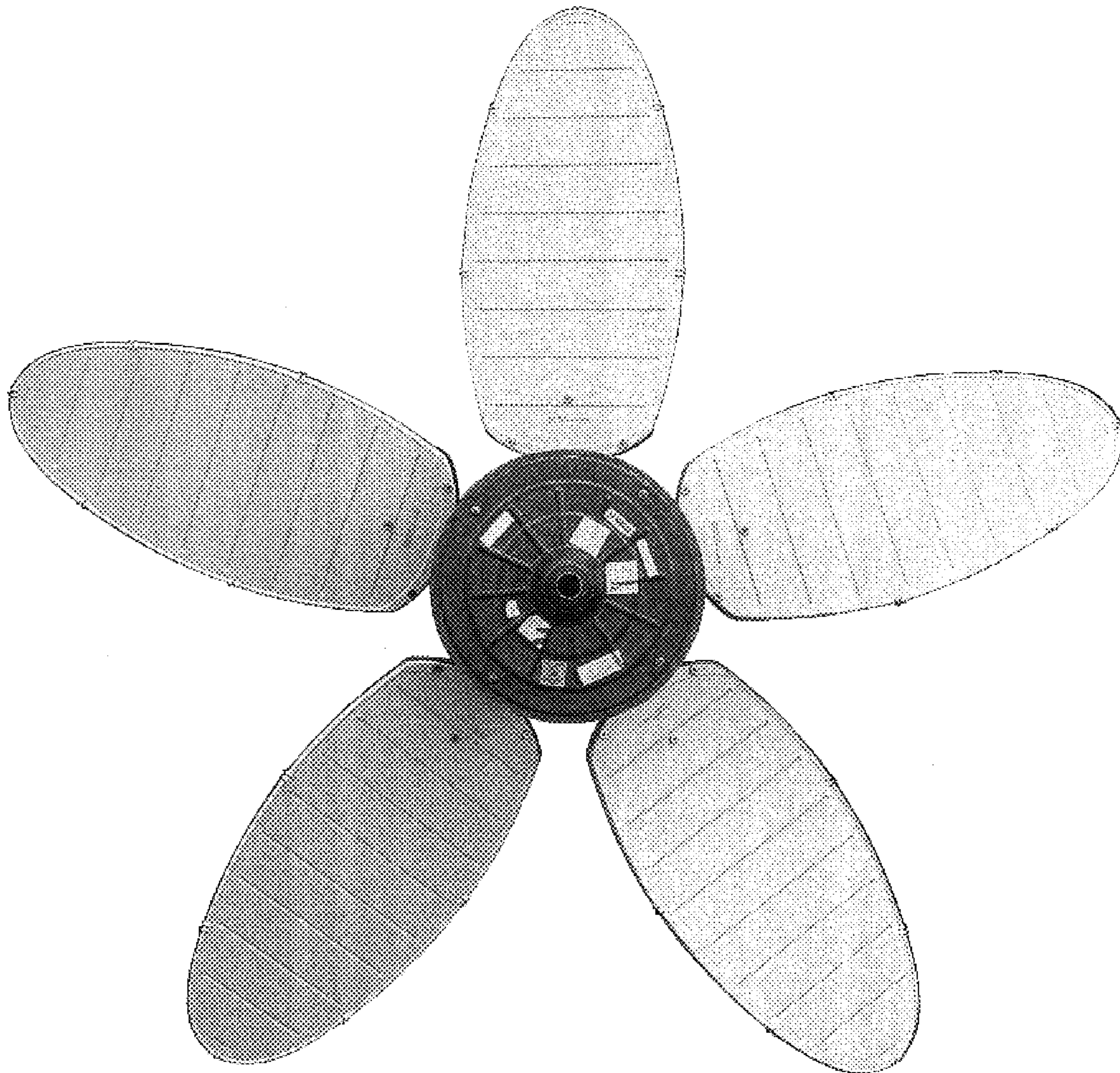

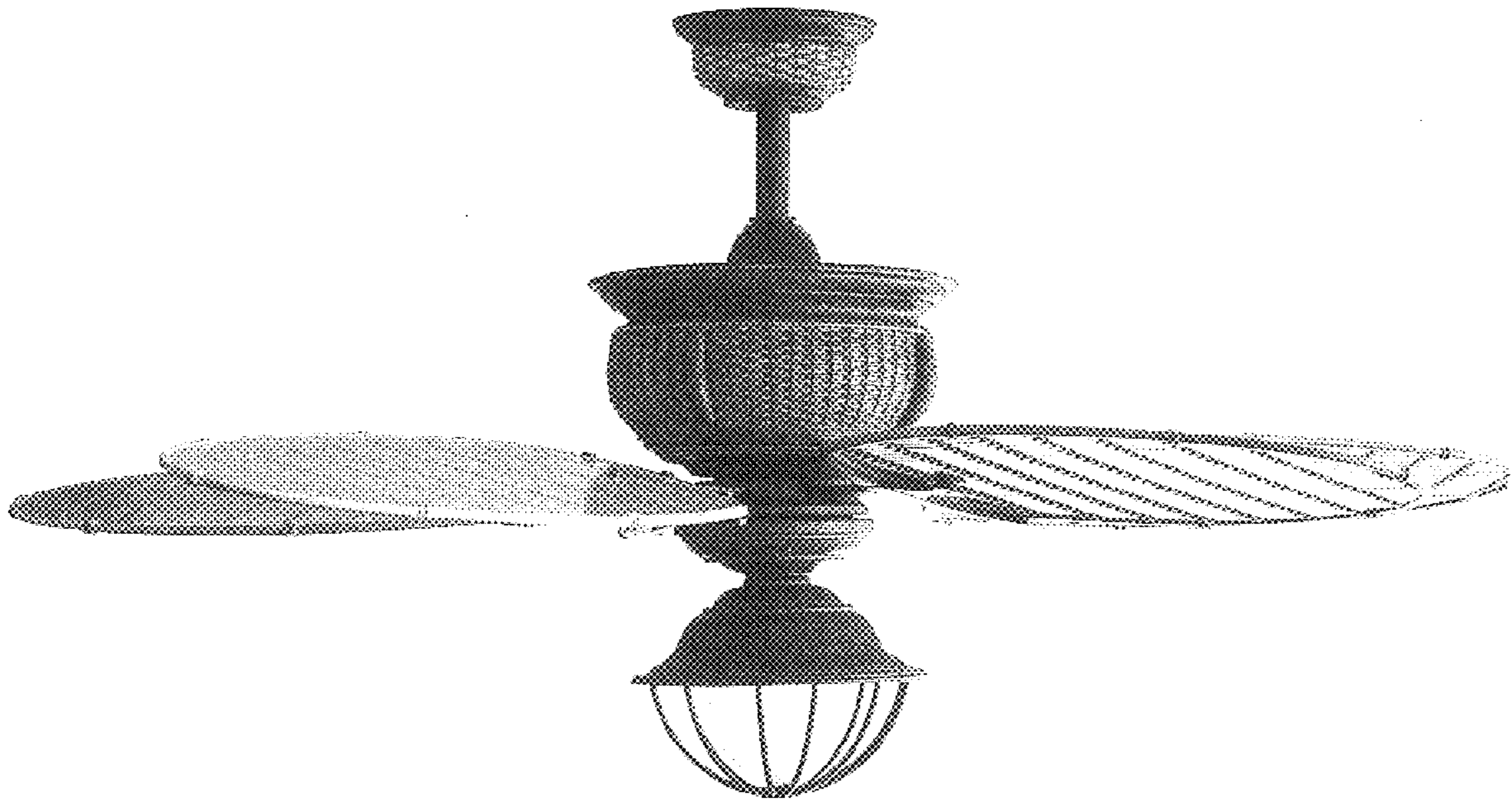

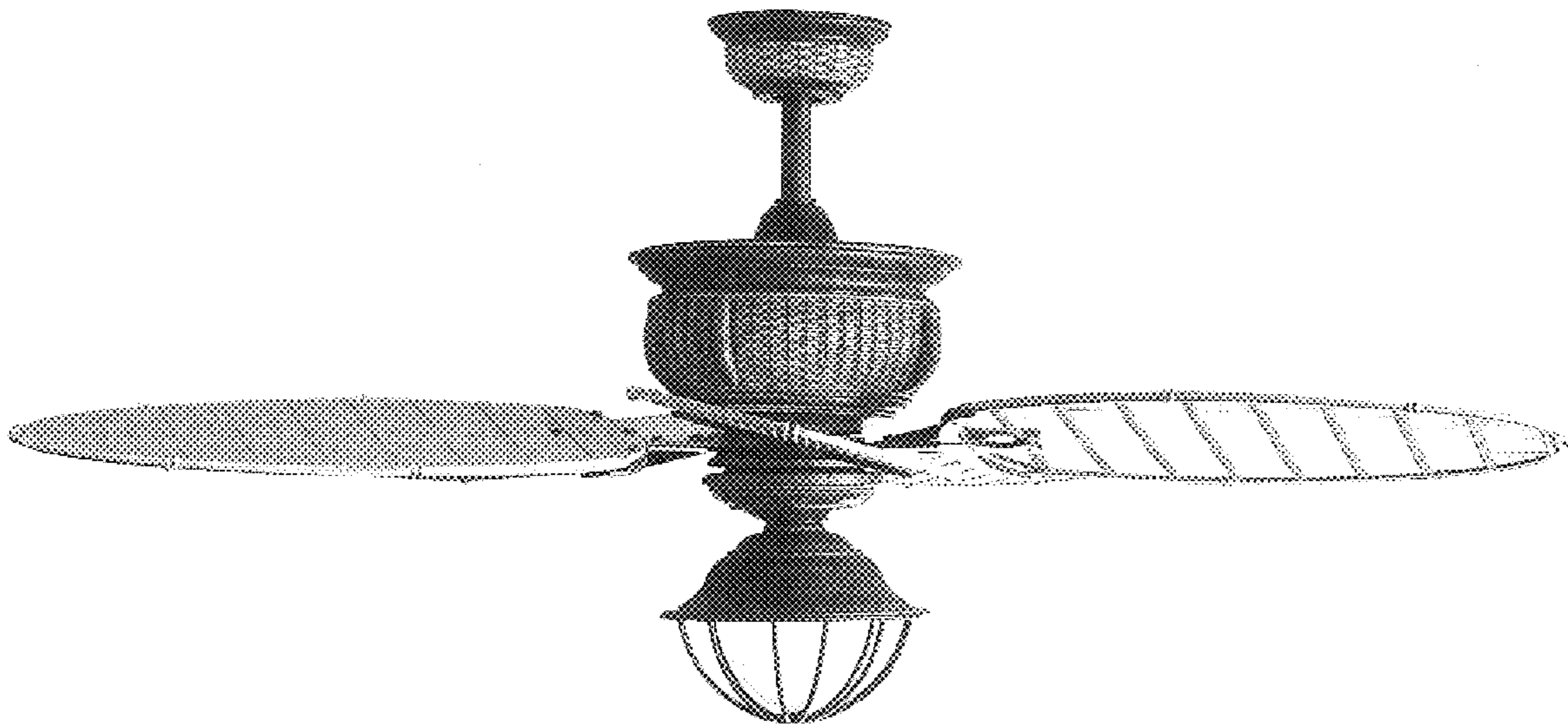
