(57) **CLAIM**

We claim the ornamental design for an analyte test meter, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of the analyte test meter, as seen from the top, front and side;

FIG. 2 is a top perspective view of the analyte test meter, as seen from the top, back and side;

FIG. 3 is a top plan view thereof;

FIG. 4 is a bottom plan view thereof;

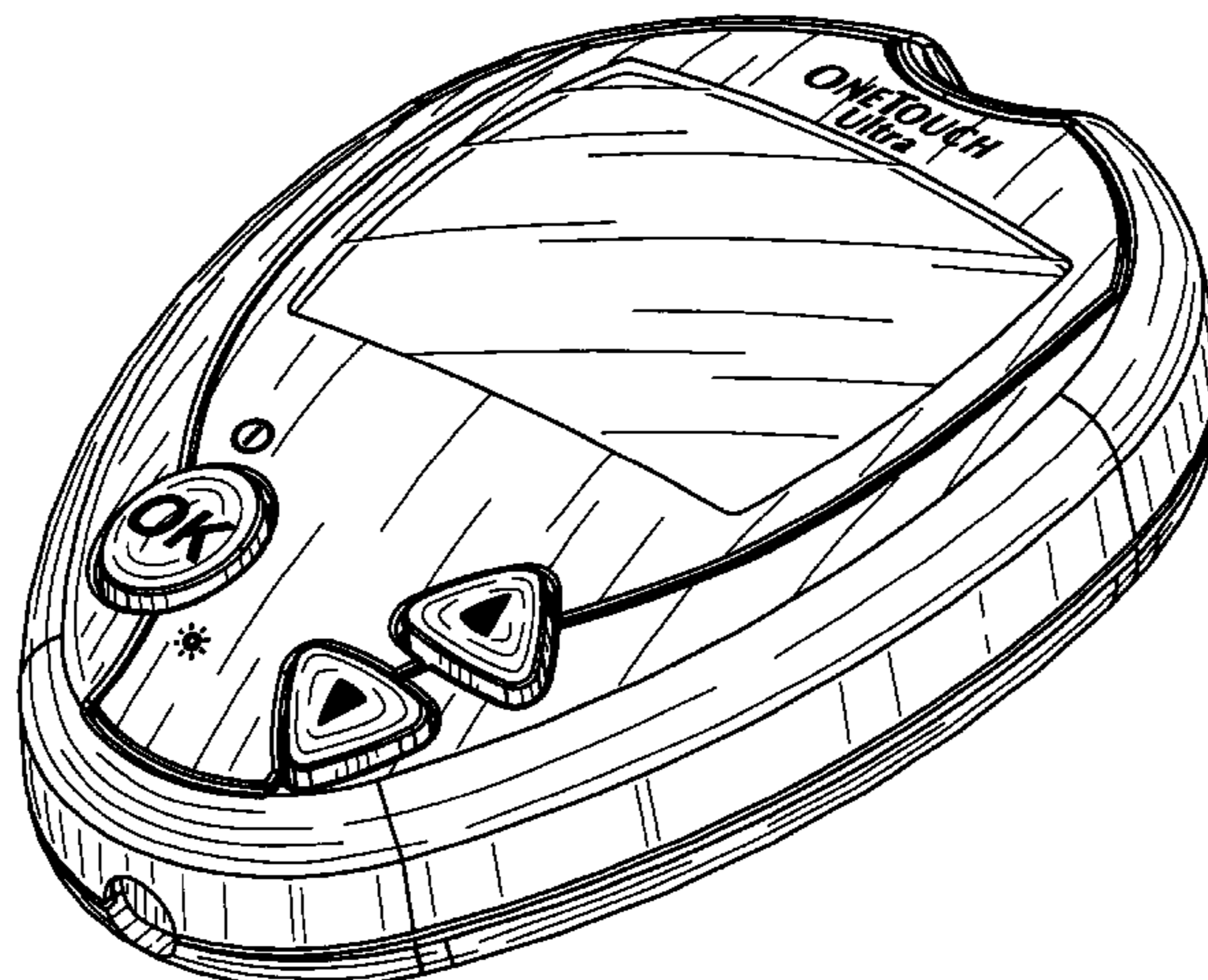
FIG. 5 is a first side elevational view thereof;

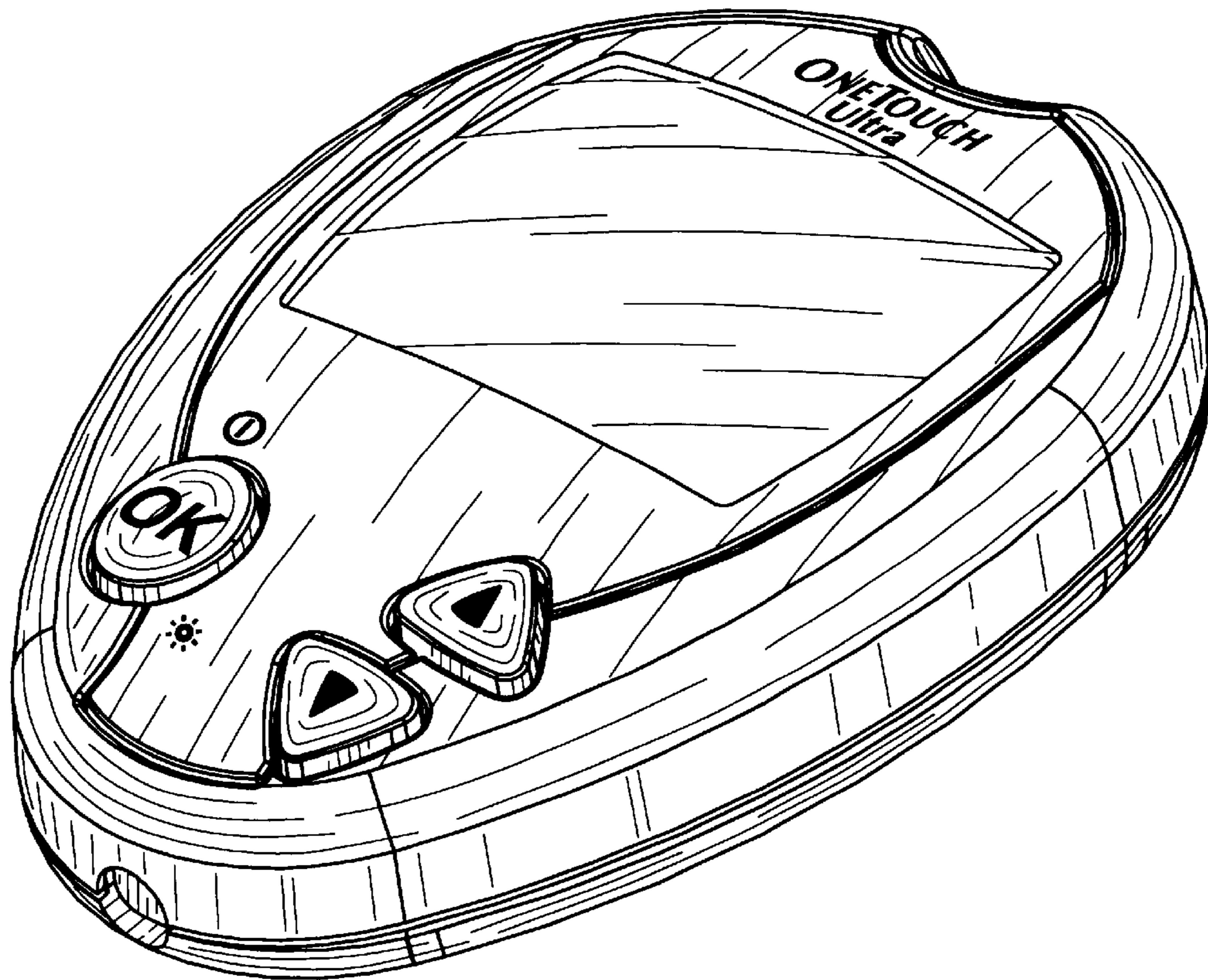

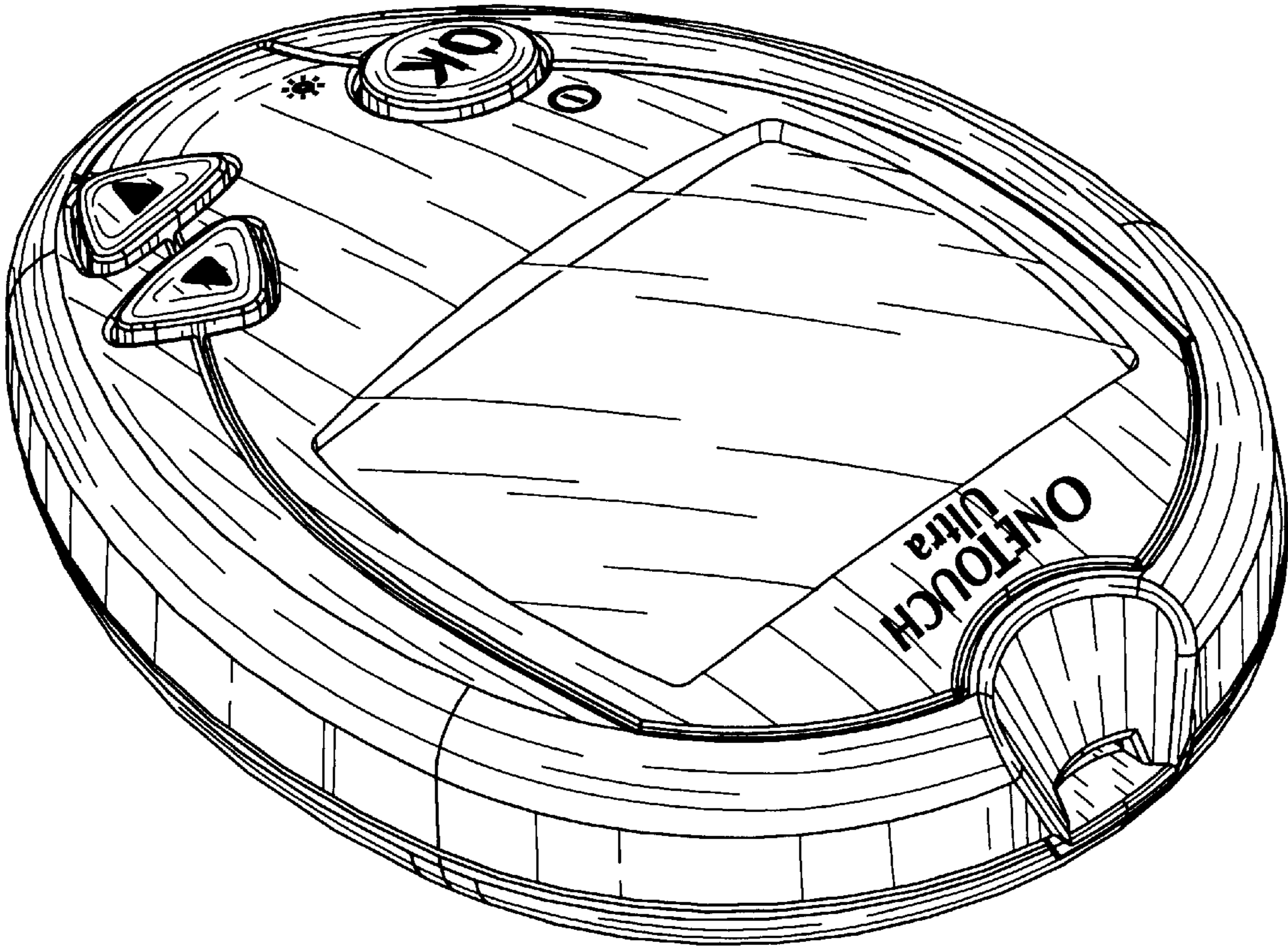

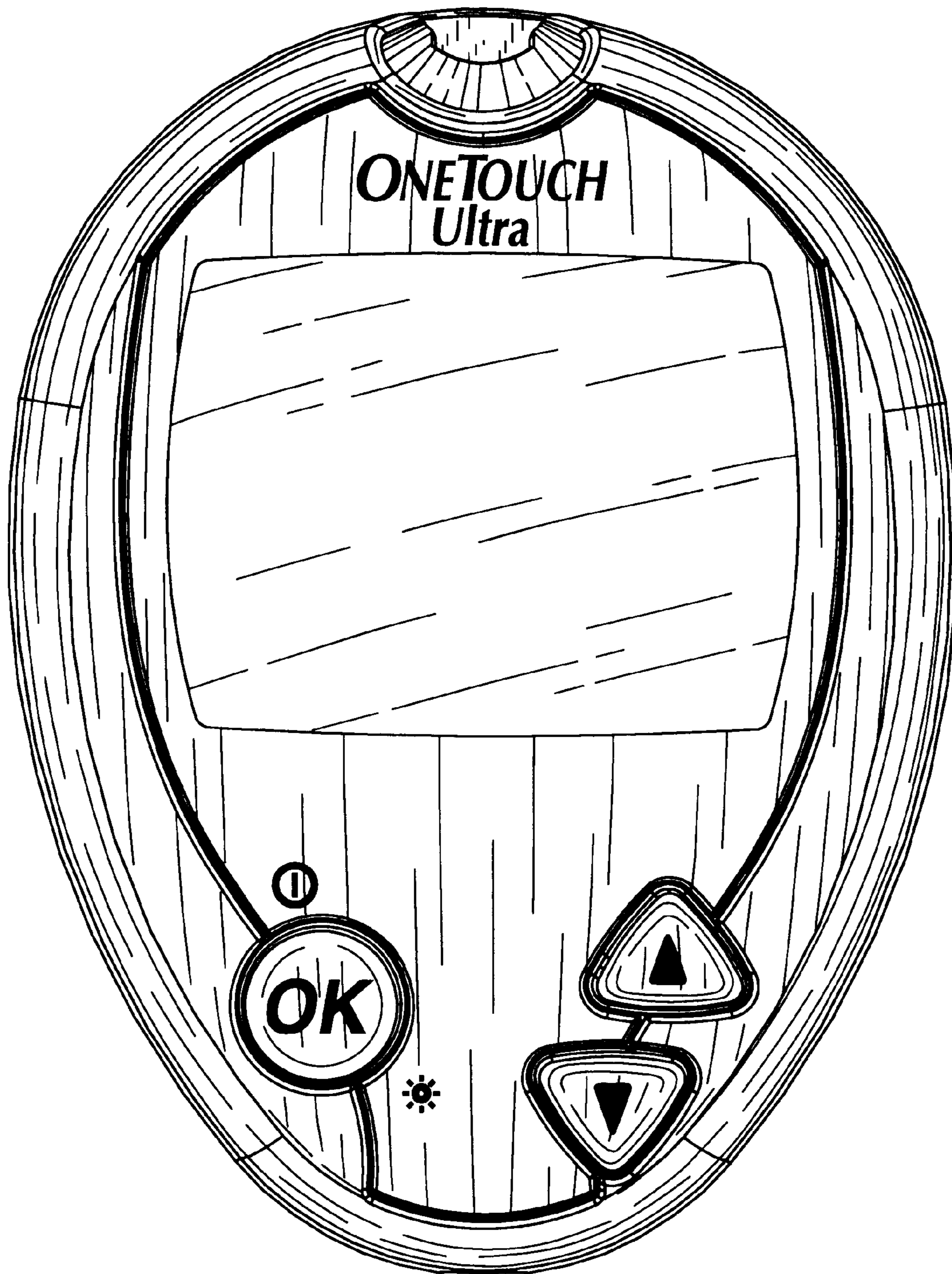

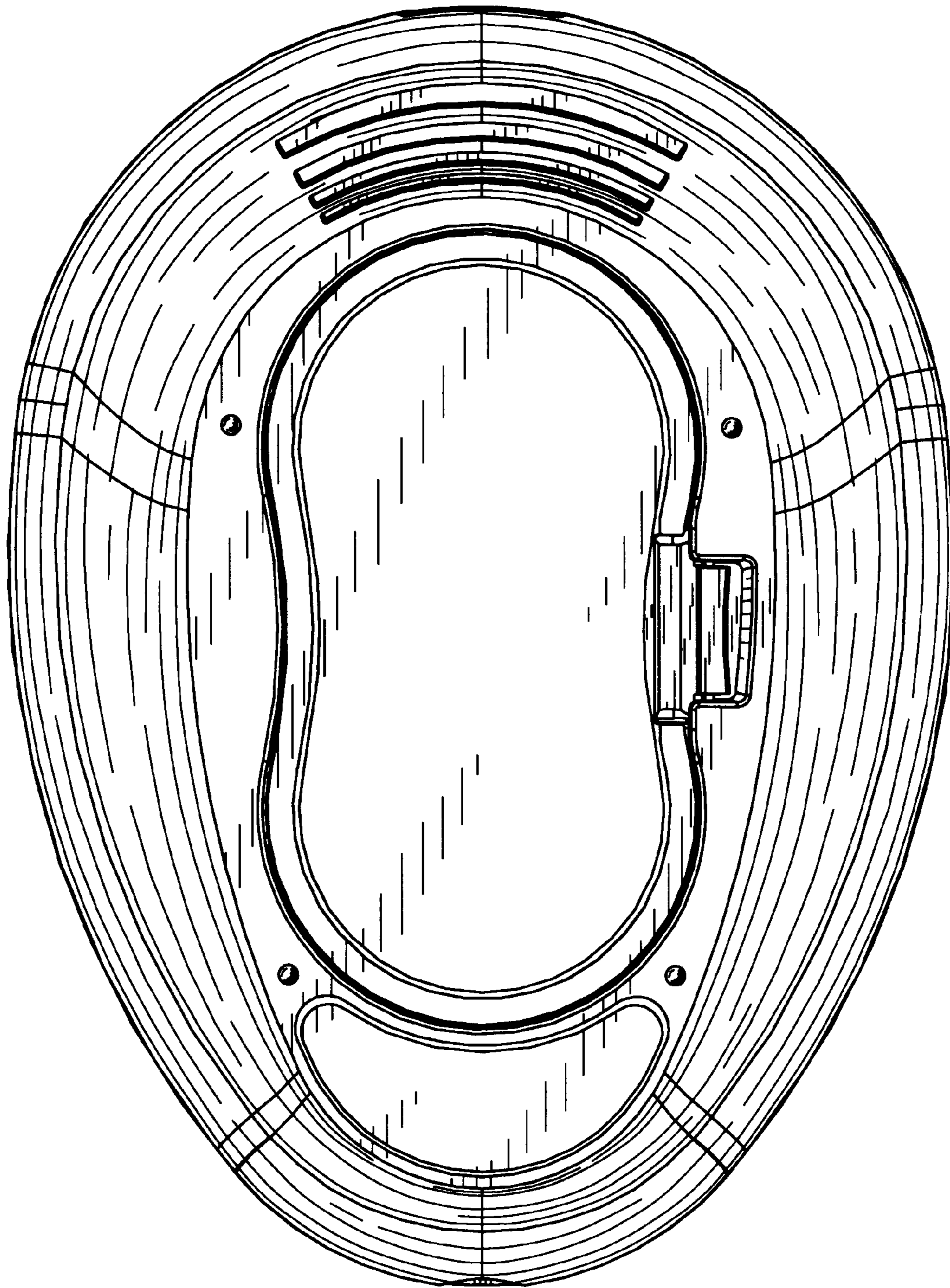

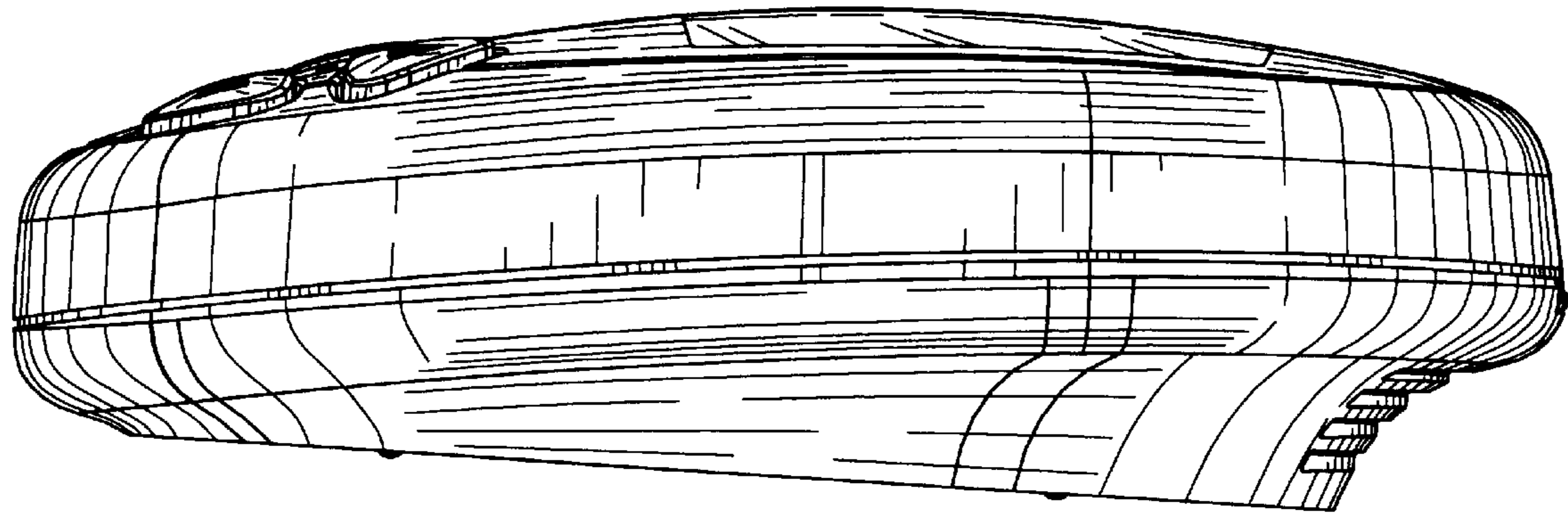

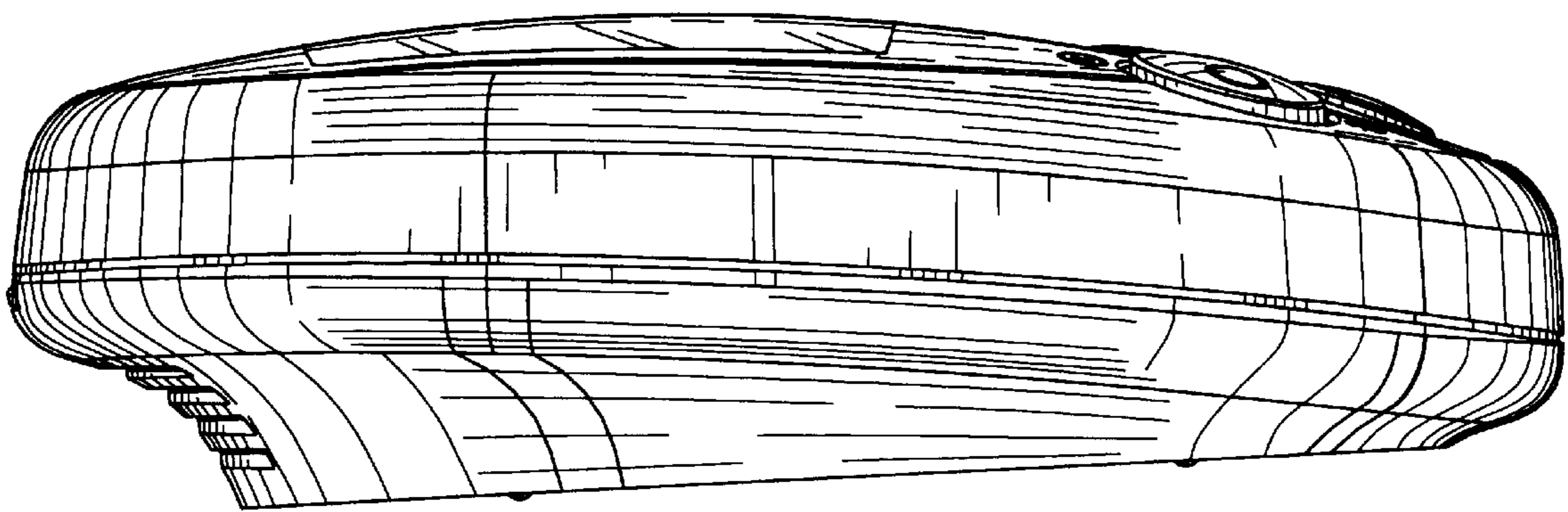

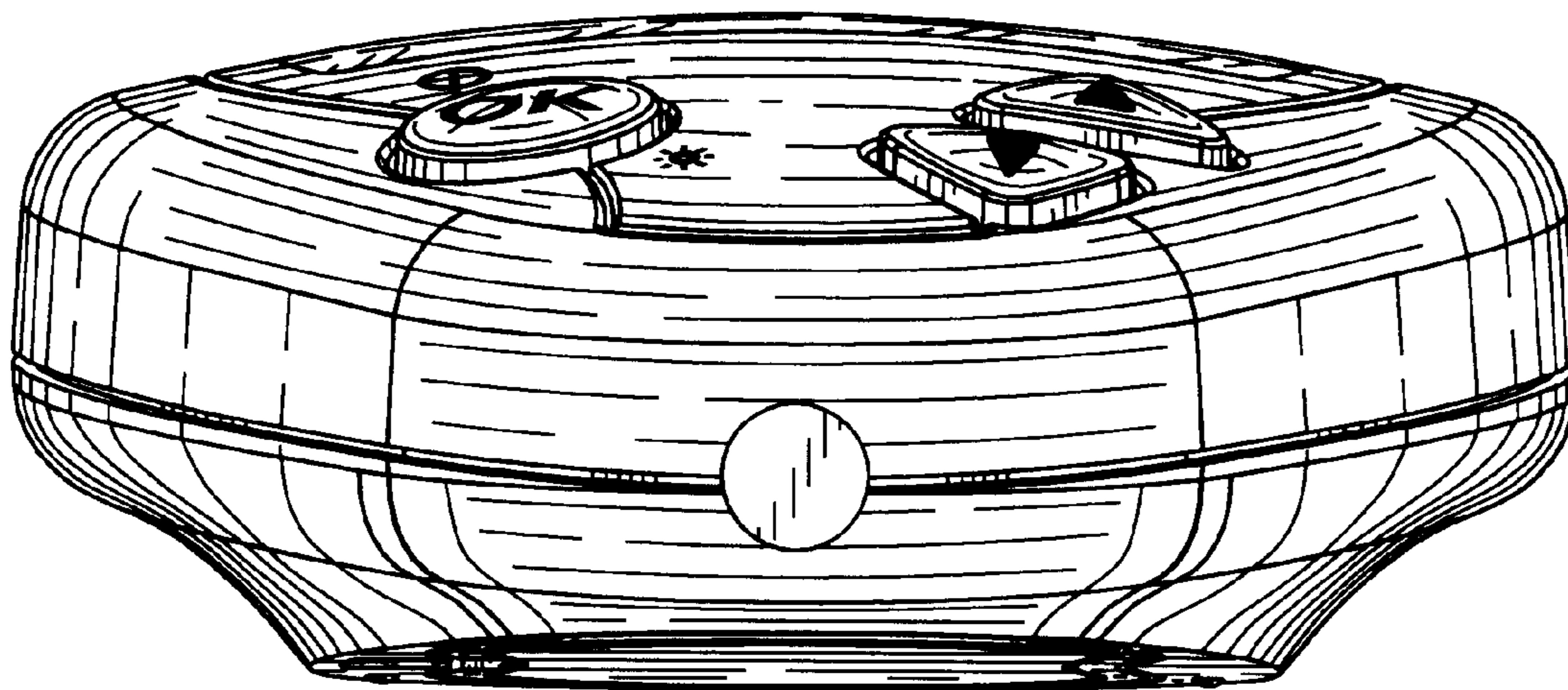

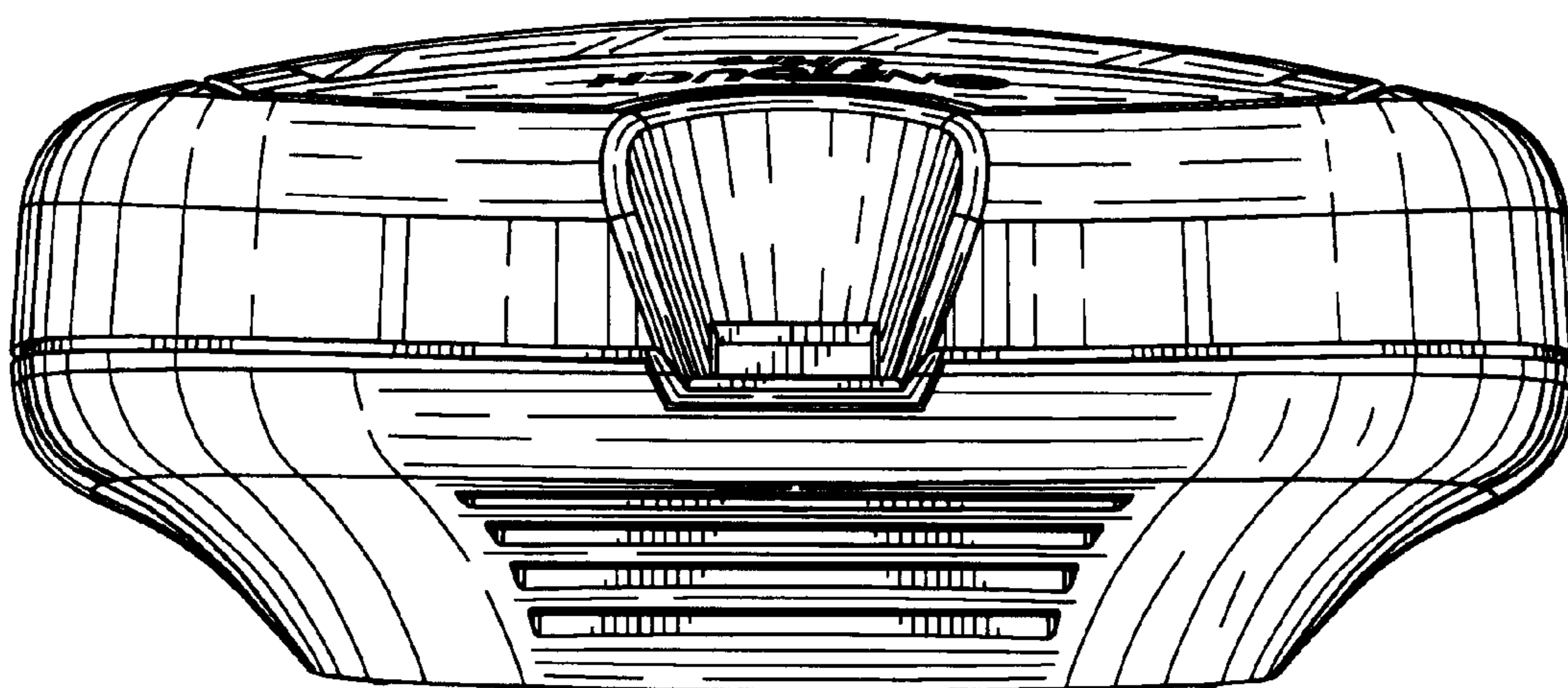
