The ornamental design for a tank for a floor care appliance, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a tank in the installed position in a floor care appliance shown in dashed lines showing our new design;

FIG. 2 is a front perspective view of a tank for a floor care appliance;

FIG. 3 is a front view thereof;

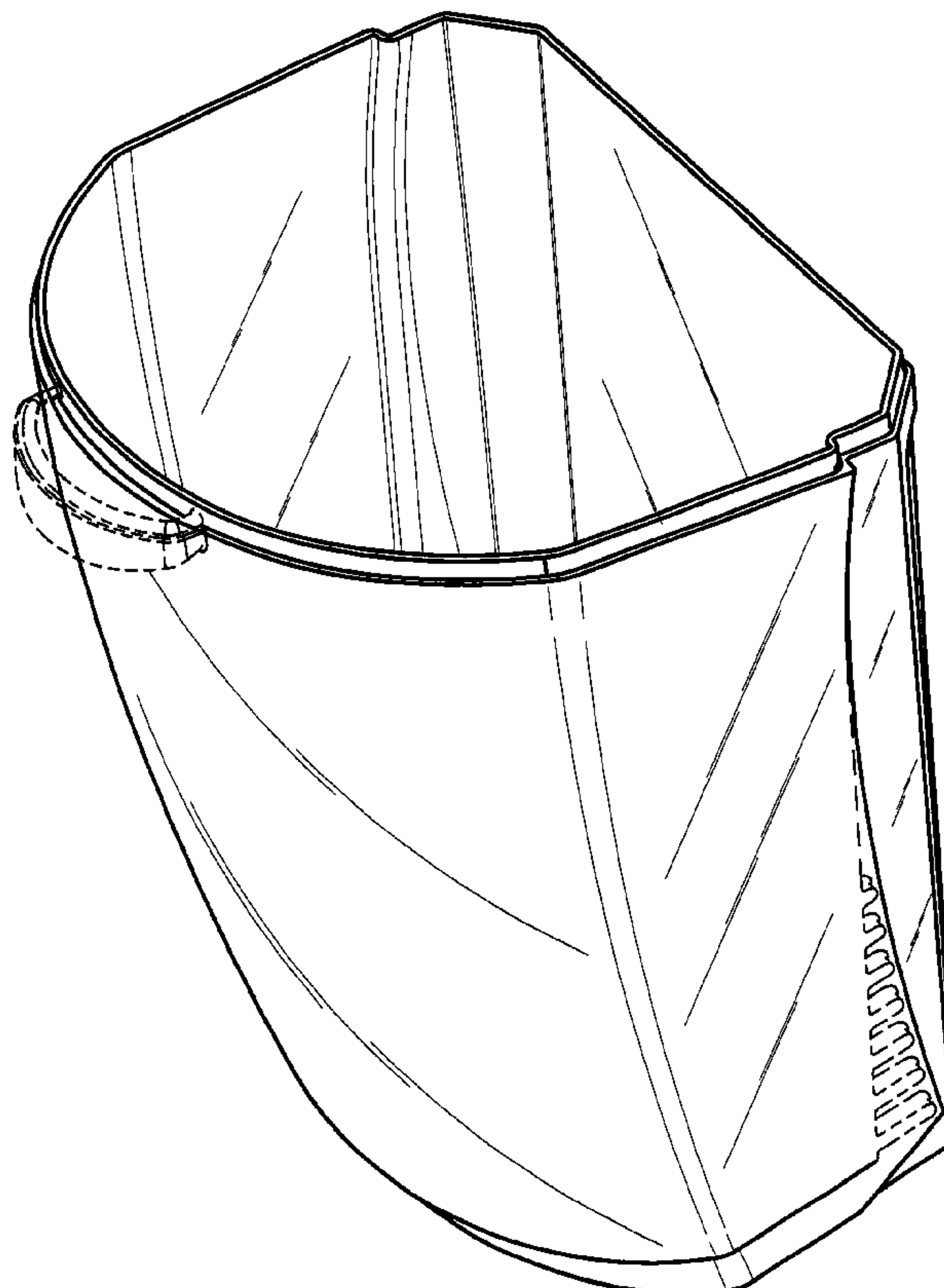
FIG. 4 is a top view thereof;

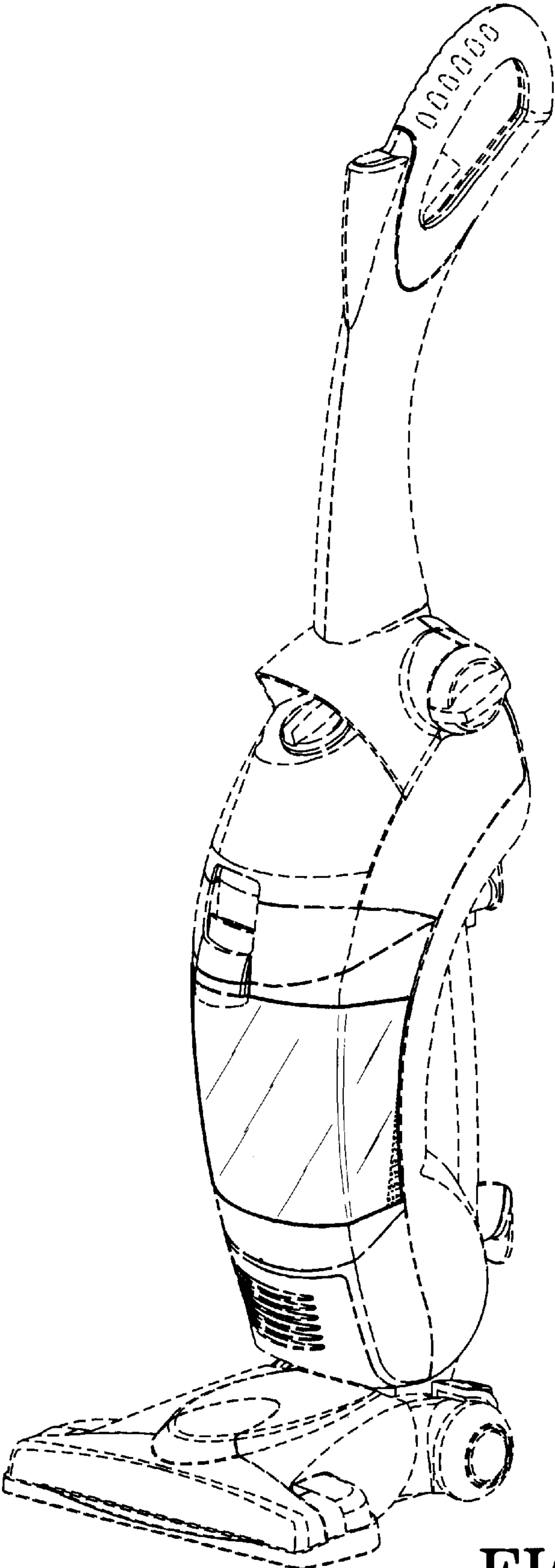

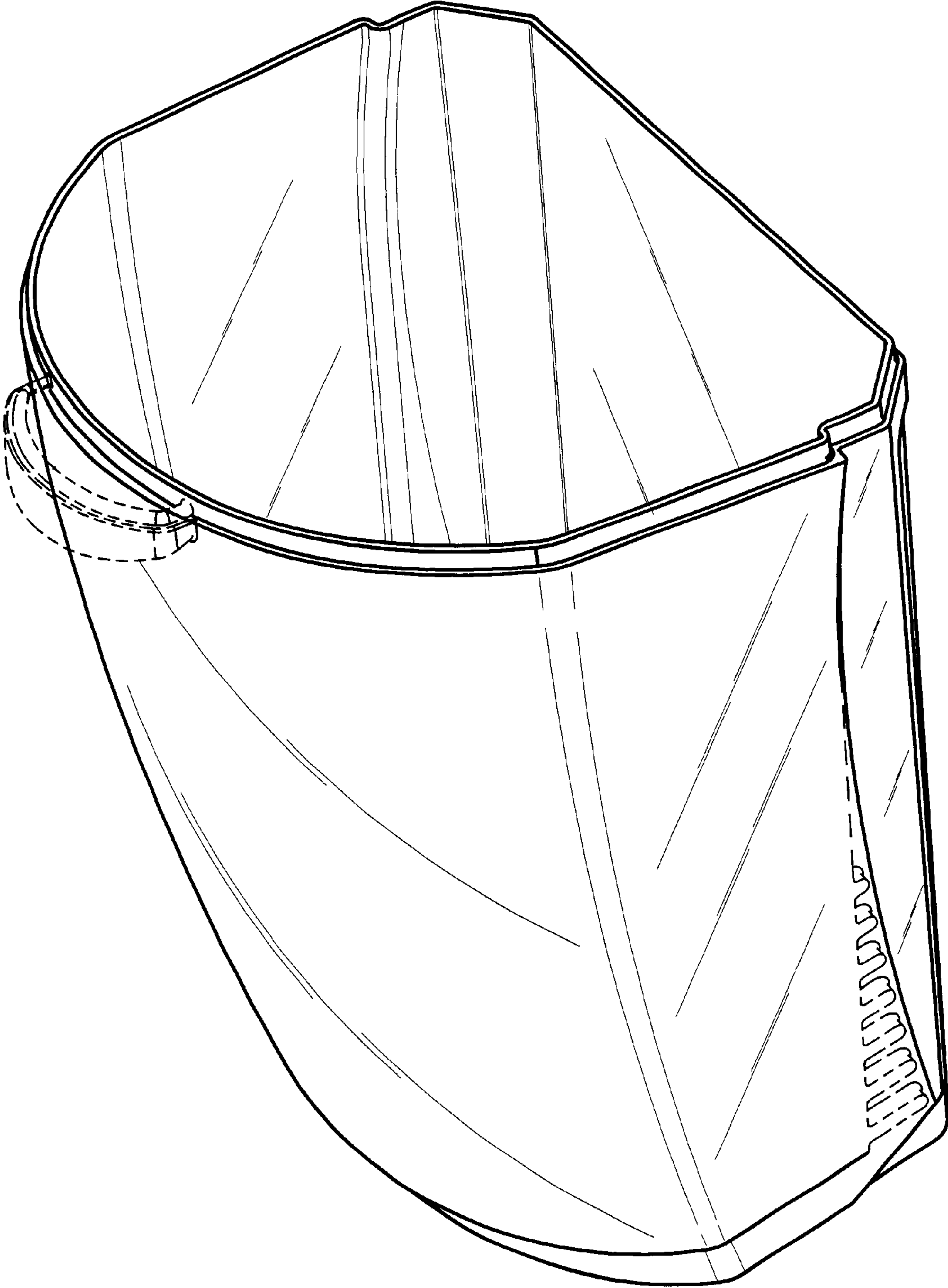

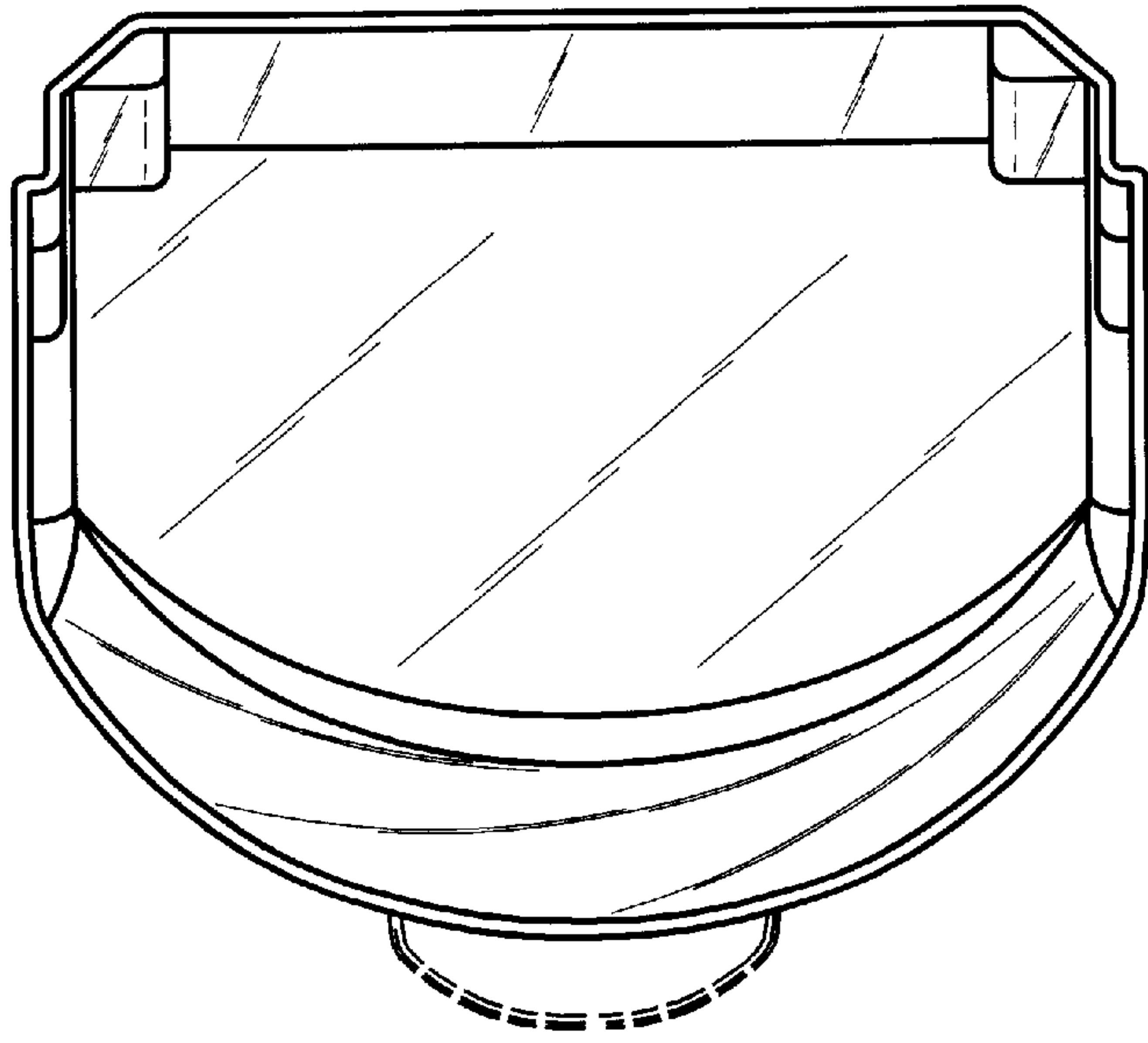

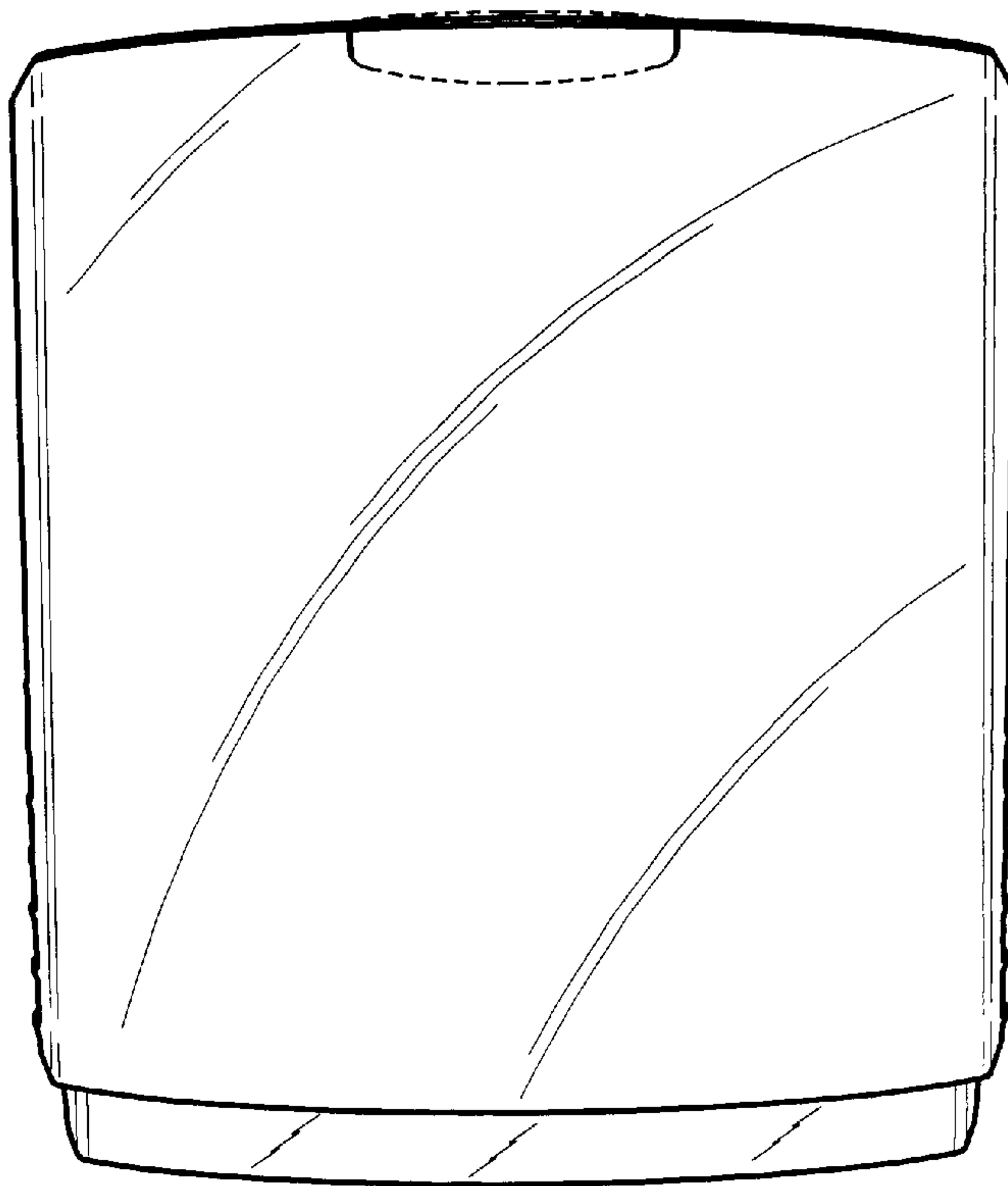

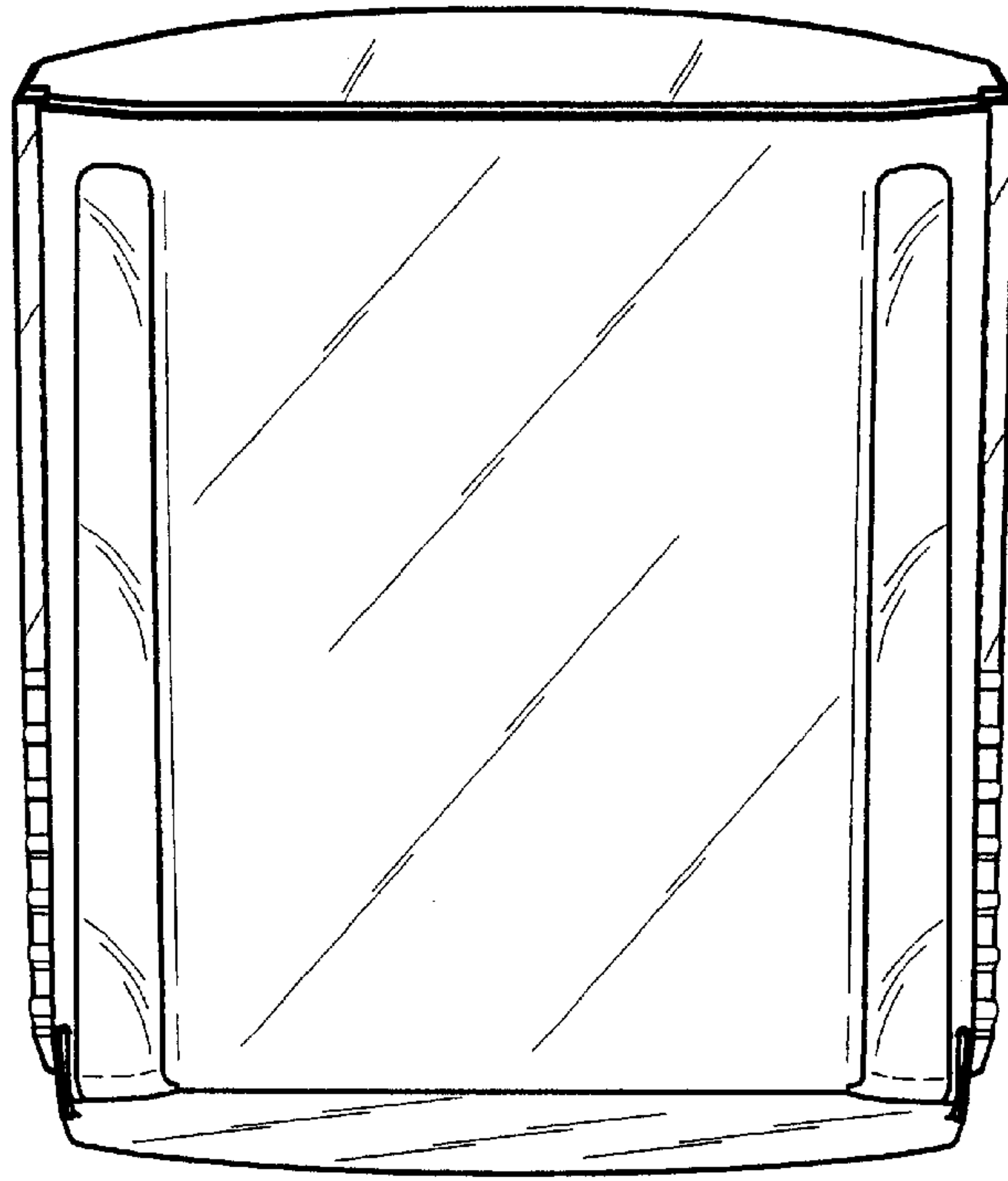

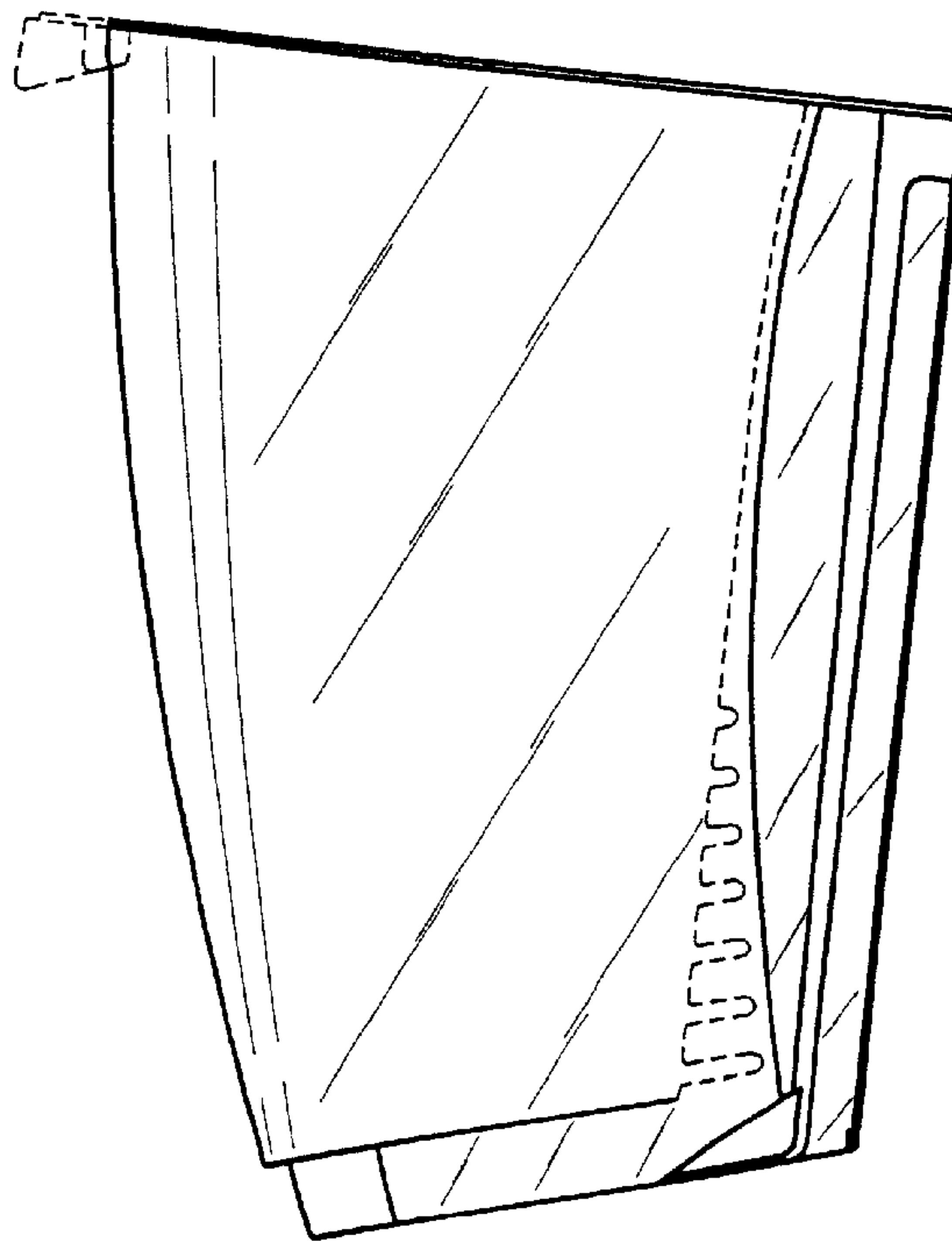
