**DESCRIPTION**

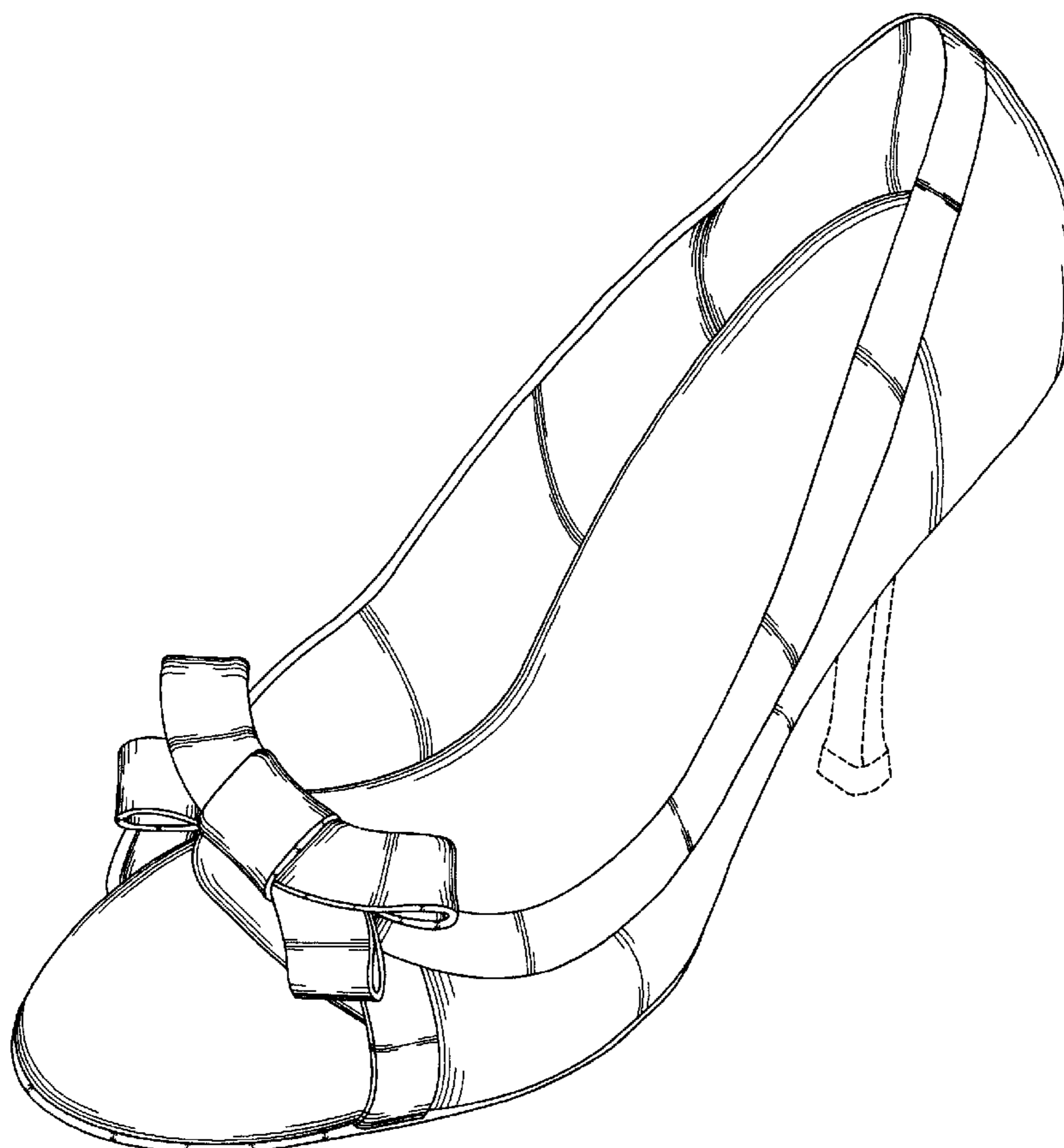
FIG. 1 is a front perspective view of a shoe showing our shoe design;

FIG. 2 is a right side view of the shoe shown in FIG. 1;

FIG. 3 is a left side view of the shoe shown in FIG. 1; and,  
FIG. 4 is a top view of the shoe shown in FIG. 1.

The broken line showing of the heel is for illustrative purposes only and forms no part of the claimed design. The sole of the shoe is plain and unornamented.

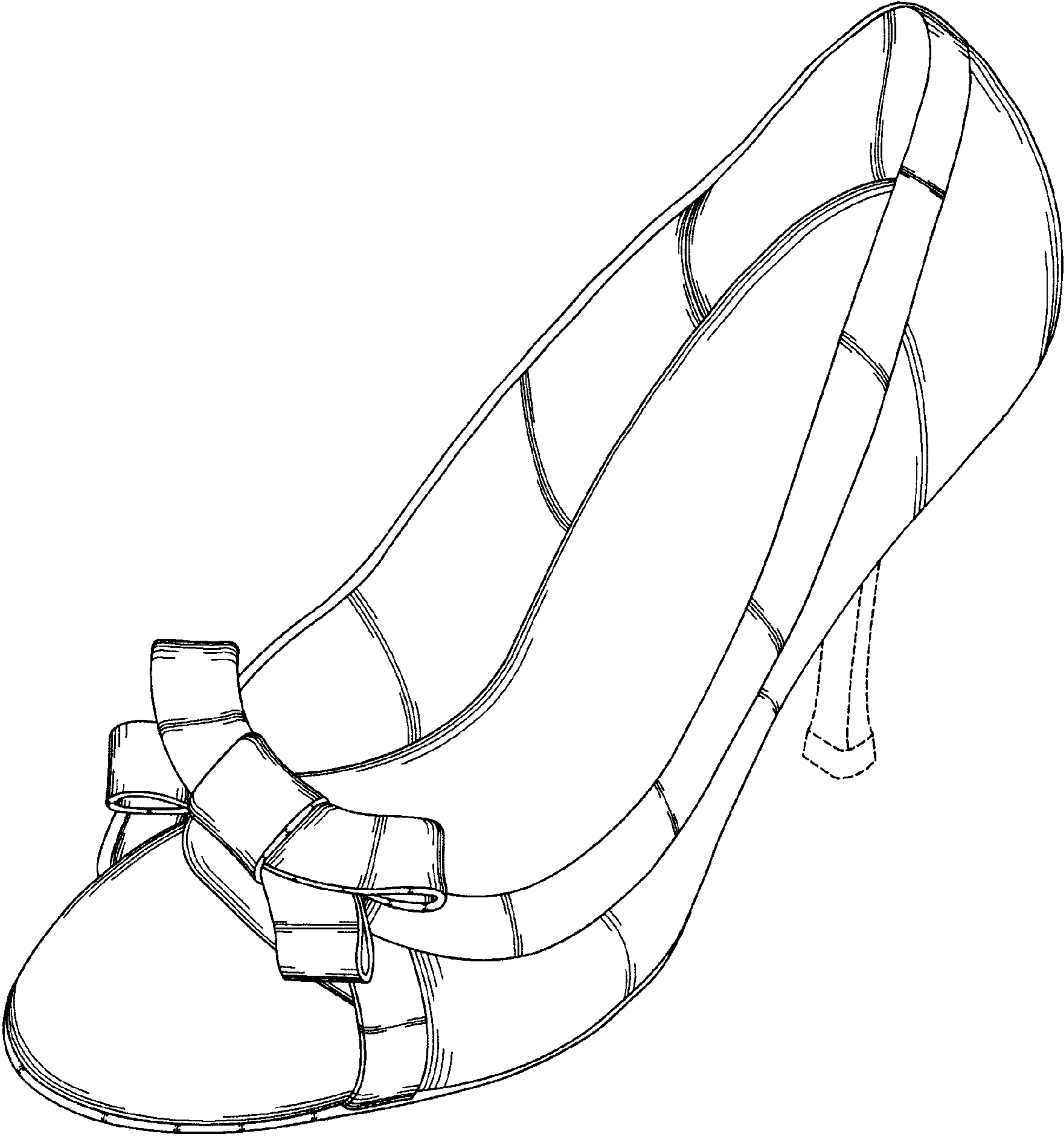

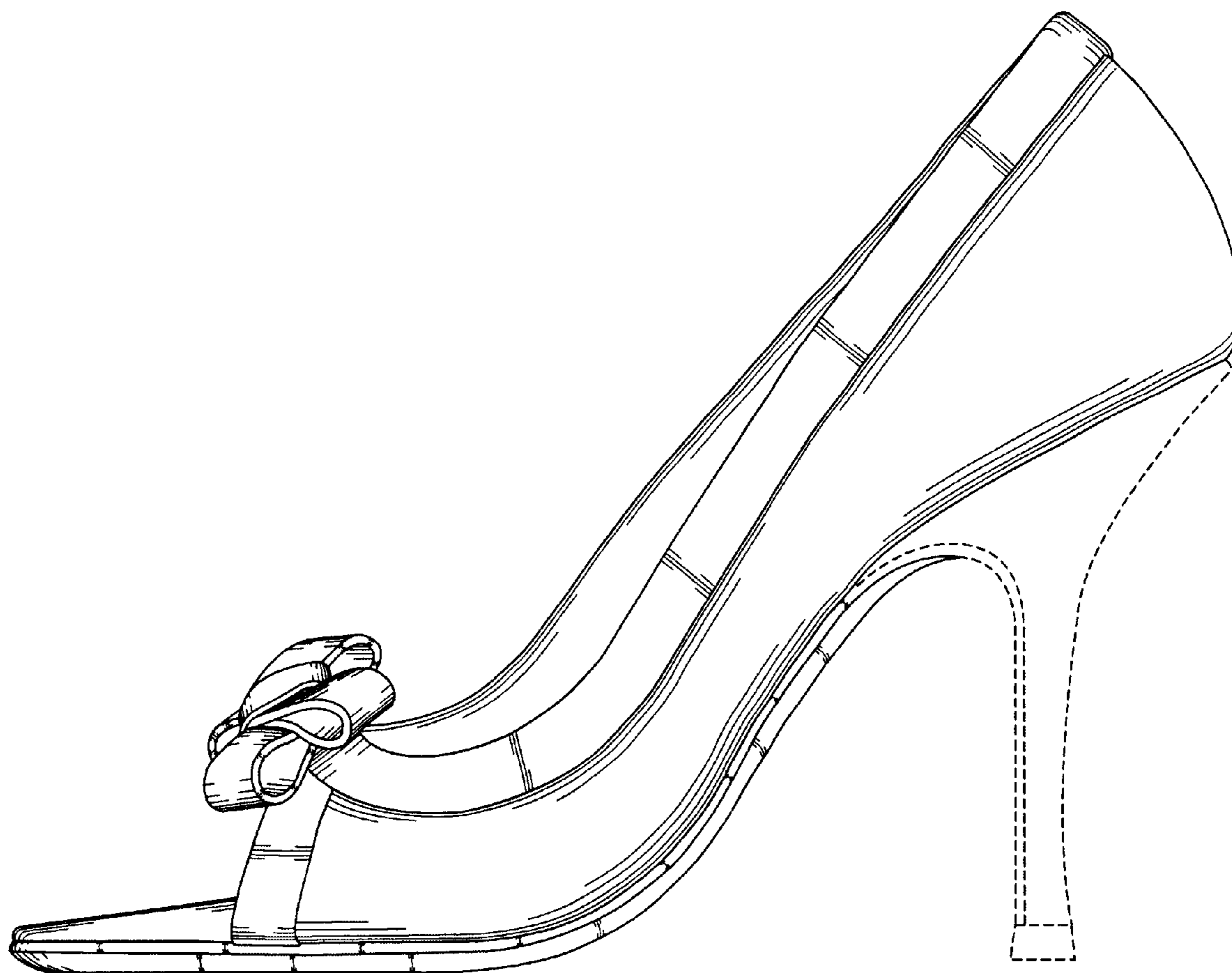

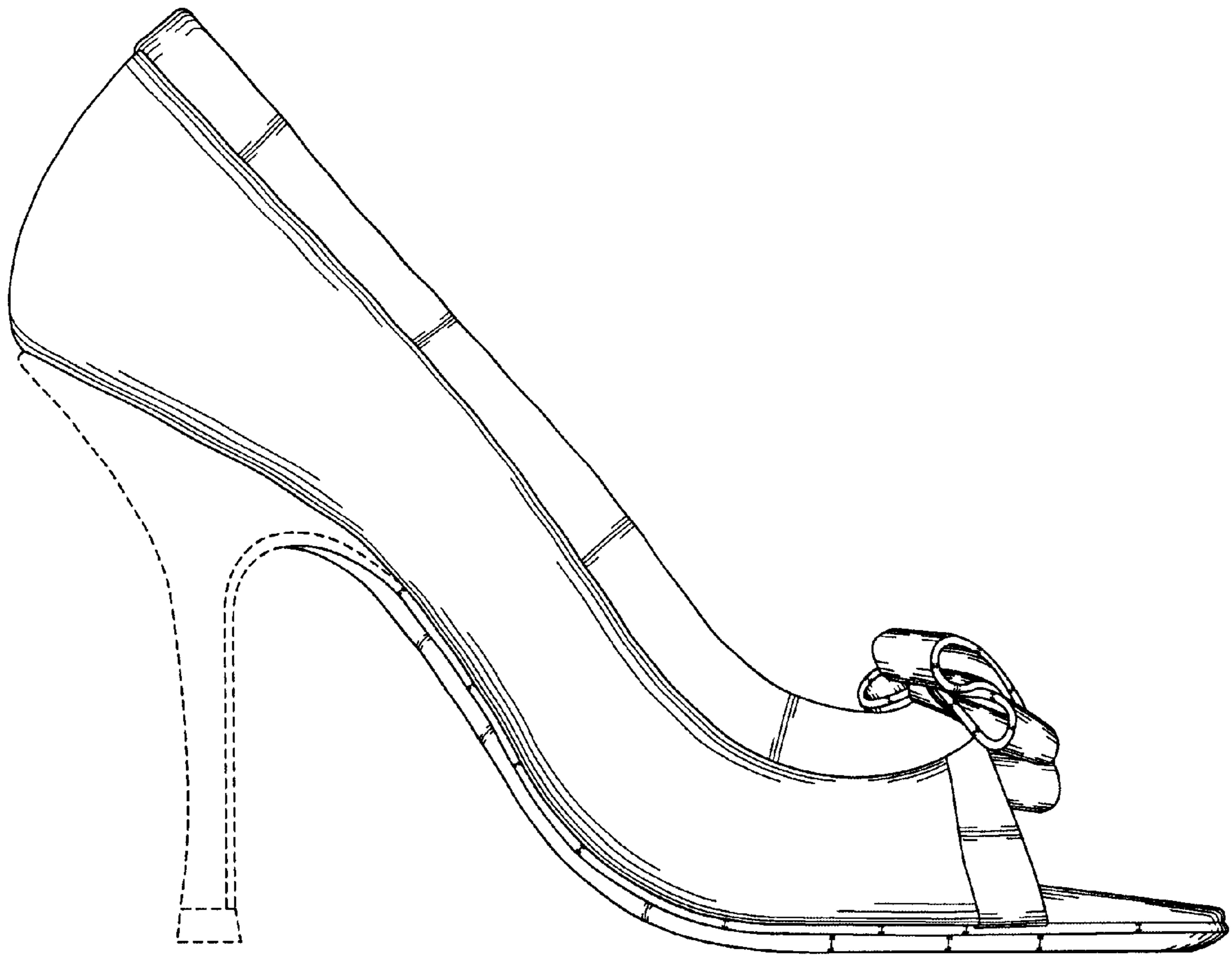

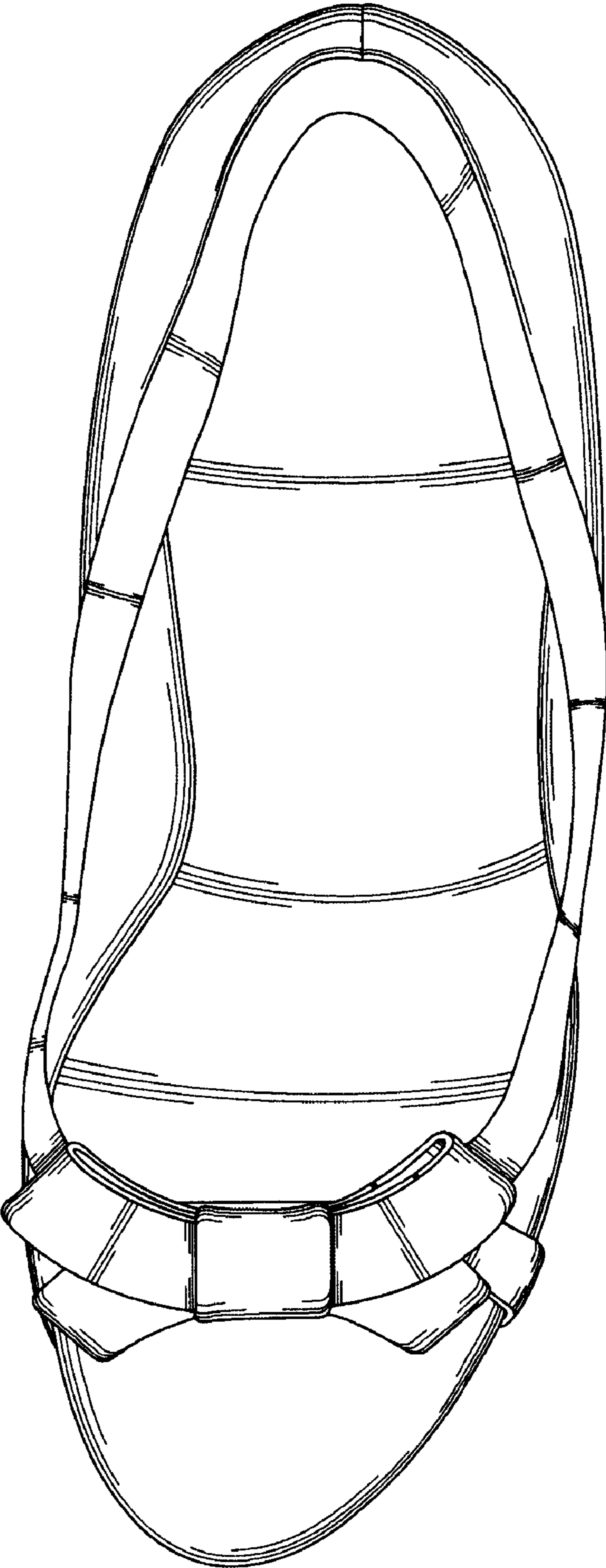
