**DESCRIPTION**

FIG. 1 is a top perspective view of the four week pill reminder showing my new design;

FIG. 2 is a top plan view thereof;

FIG. 5 is a front end view thereof;

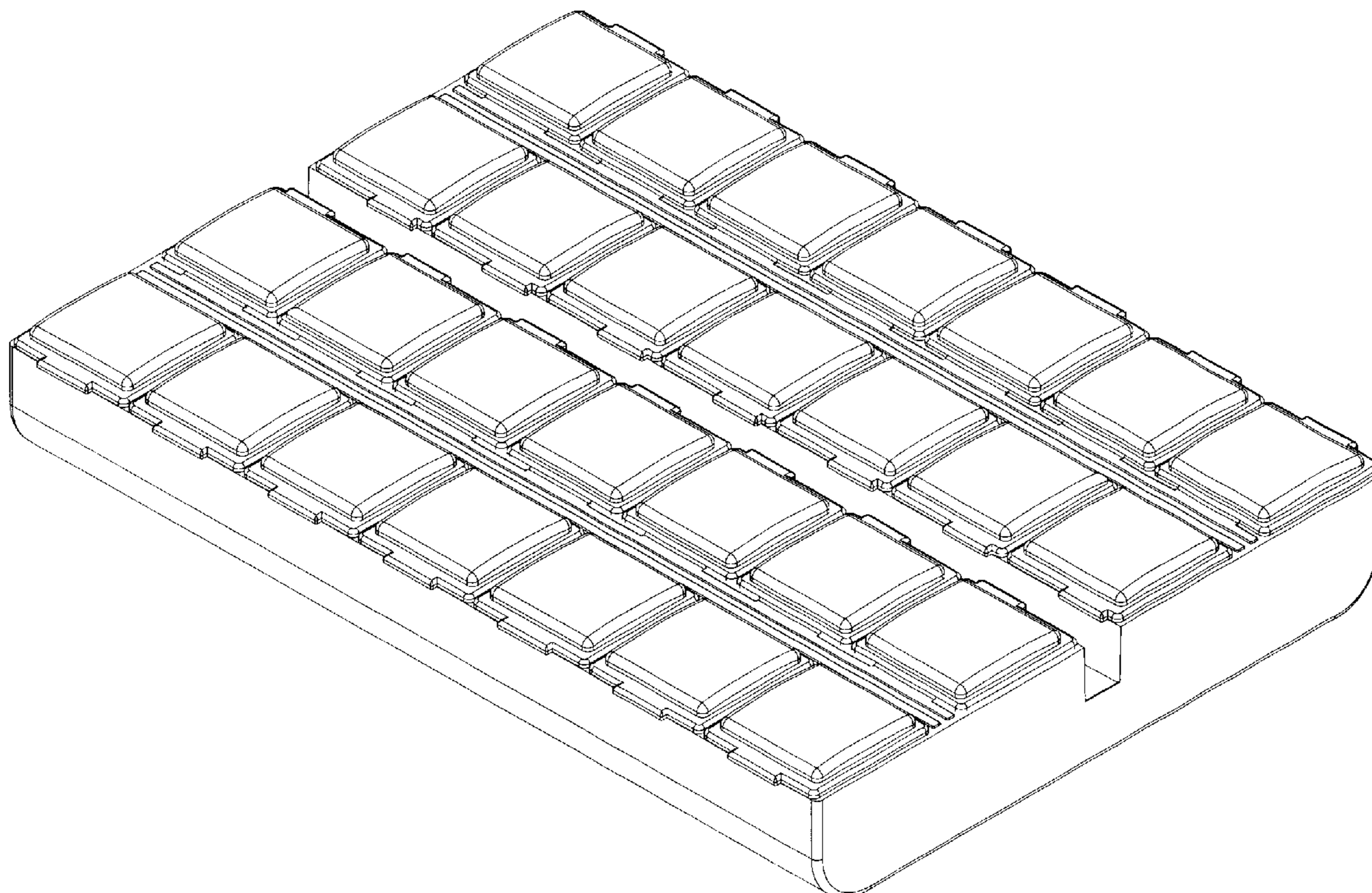
FIG. 6 is a bottom plan view thereof;

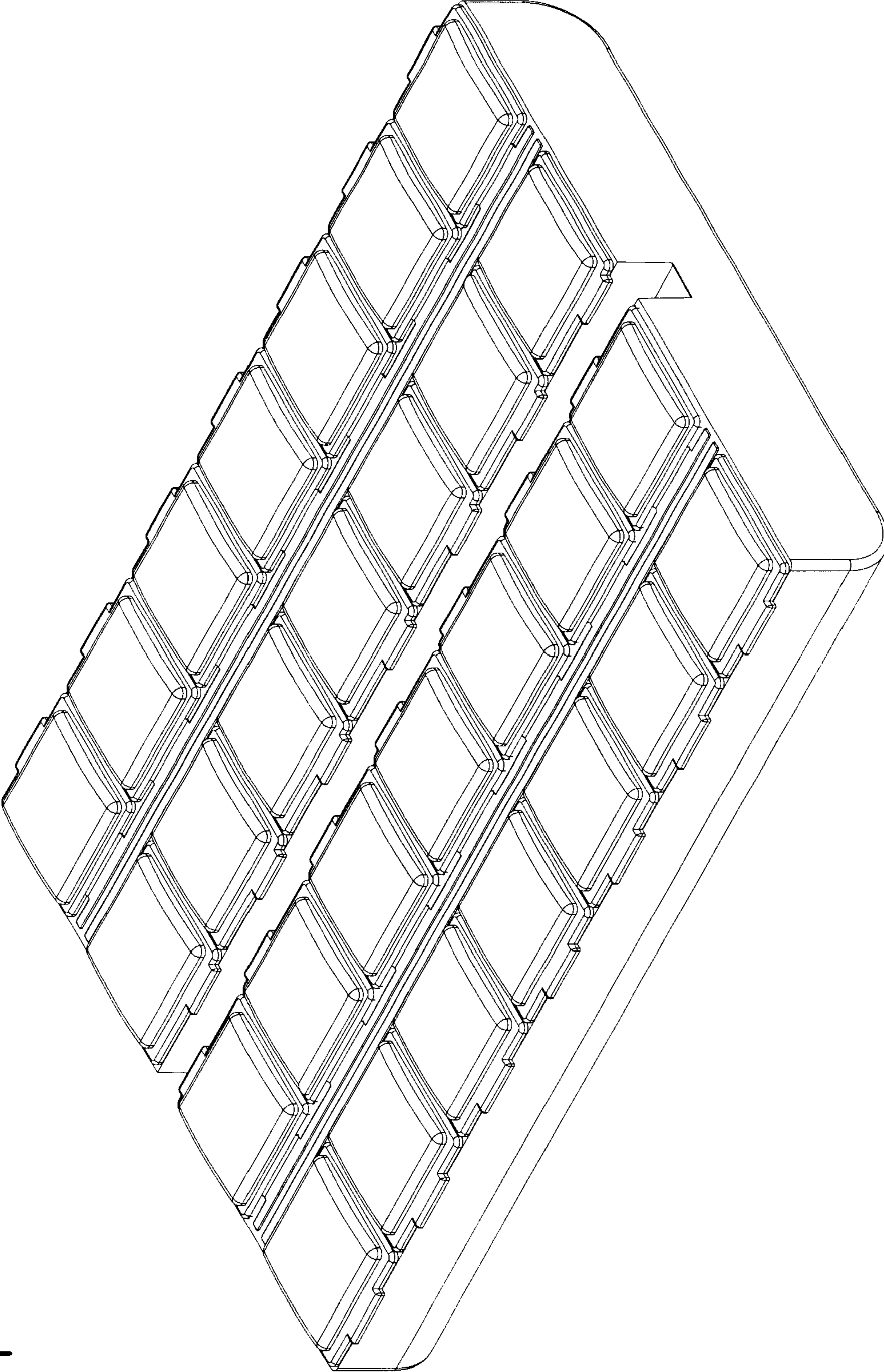

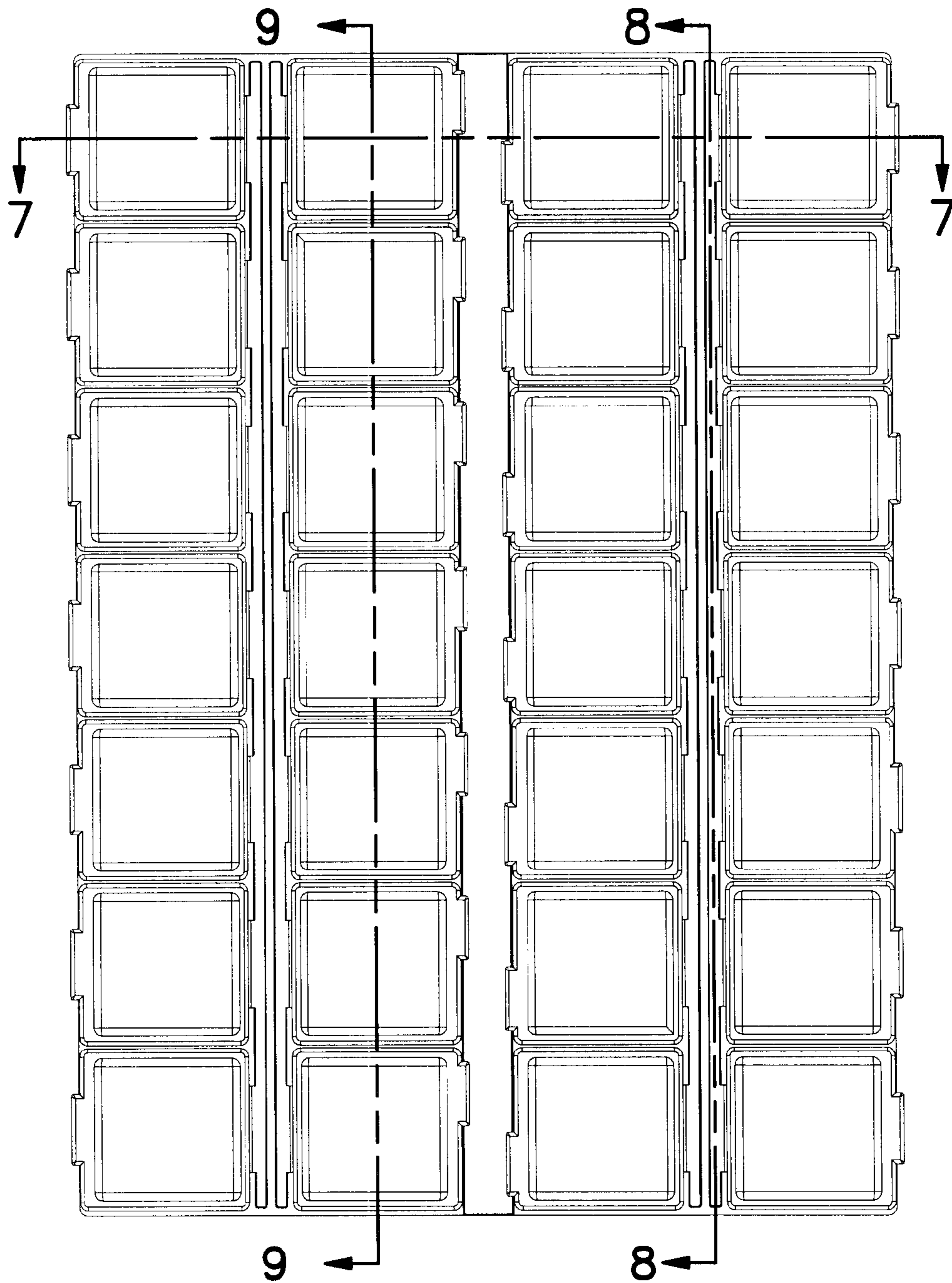

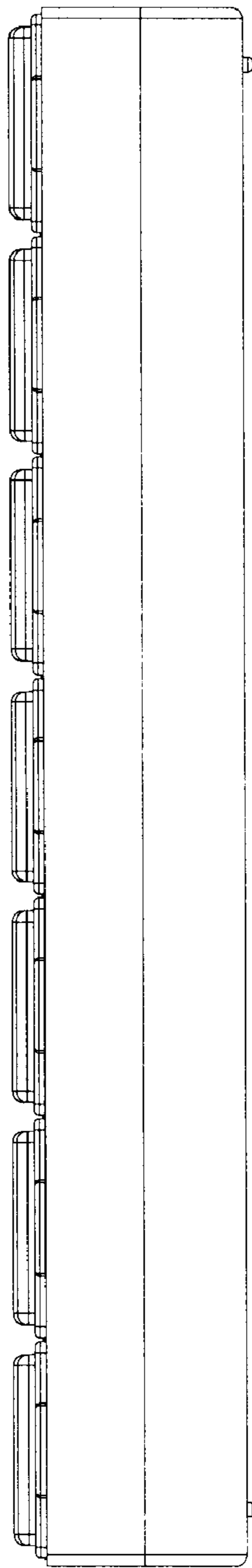

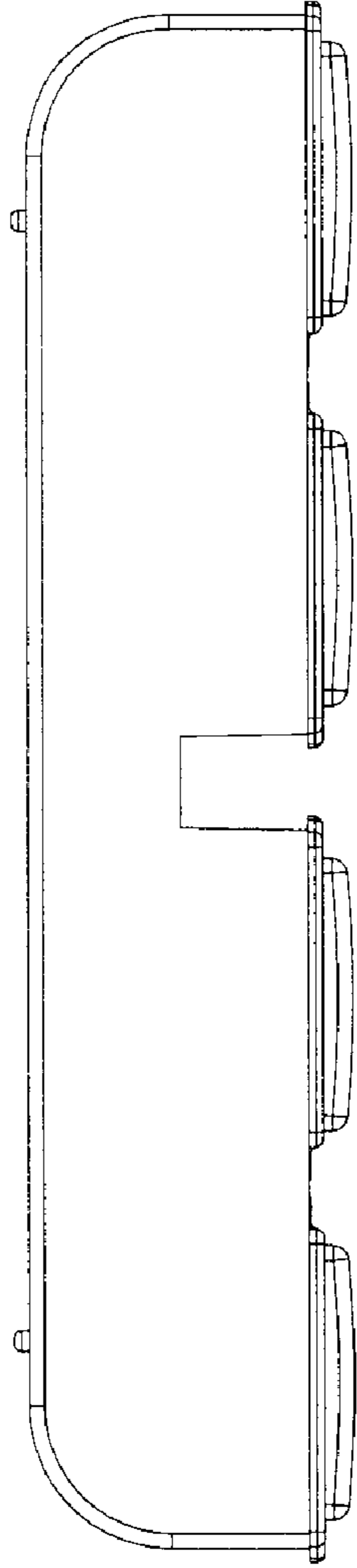

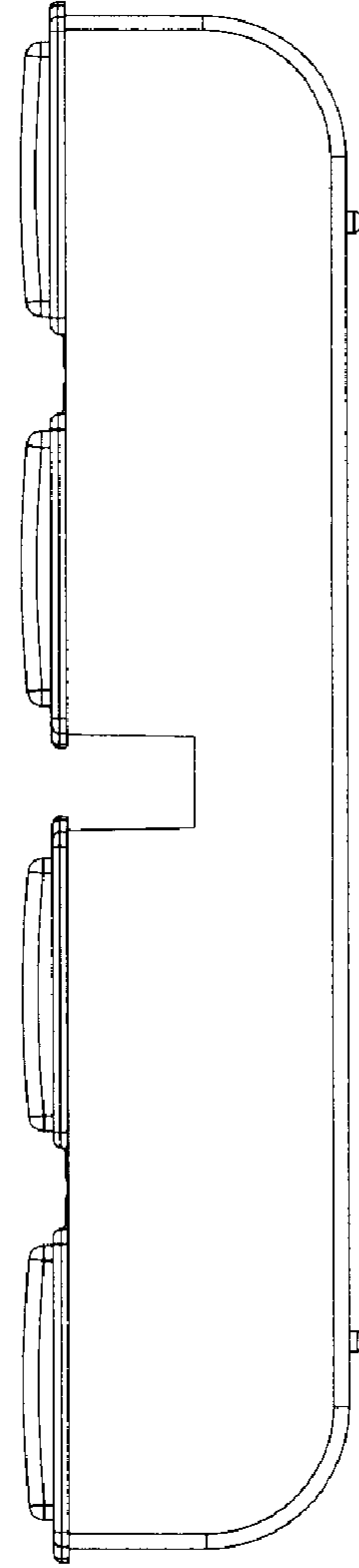

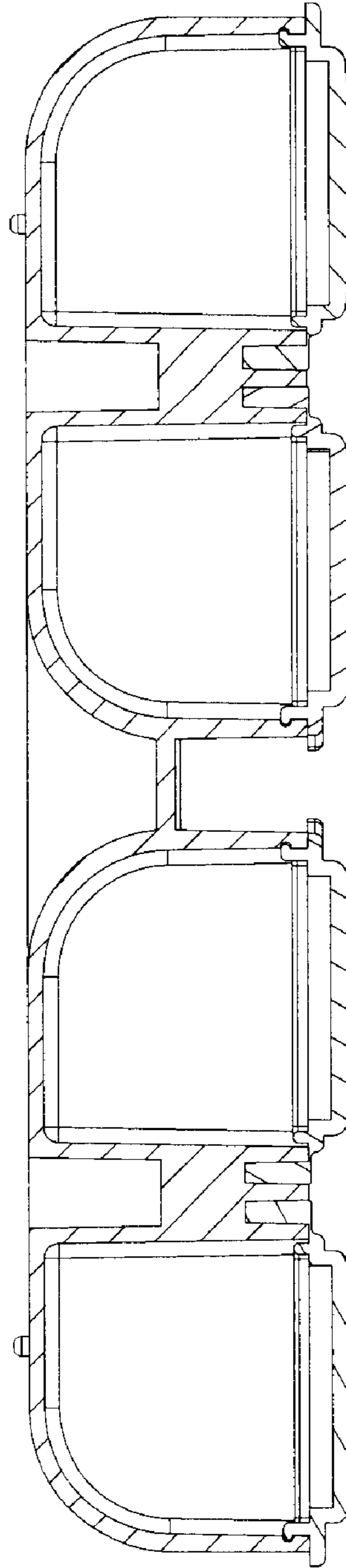

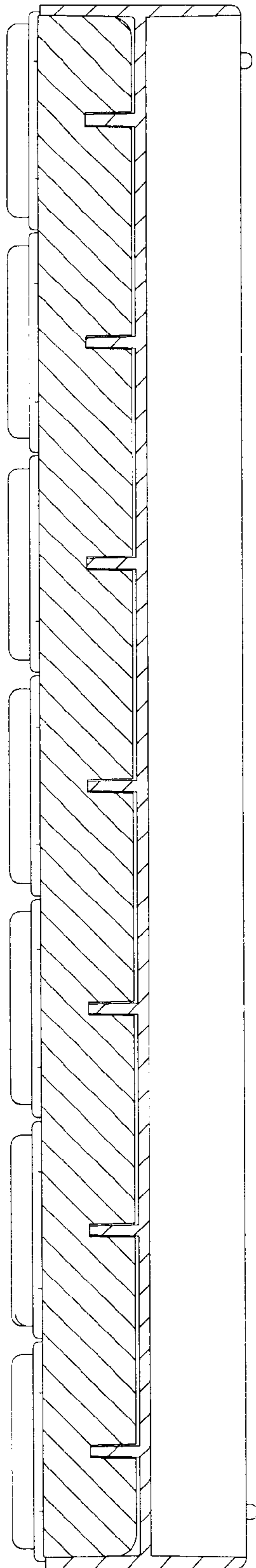
