(57) **CLAIM**

The ornamental design for a fabric covered necktie container, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a fabric covered necktie container shown in a closed position; FIG. 2 is a front view thereof; FIG. 3 is a side view thereof; FIG. 4 is a top view thereof; FIG. 5 is a back view thereof; FIG. 6 is a bottom view thereof; and, FIG. 7 is a perspective view of the fabric covered necktie container of FIG. 1 shown in an open position. The texture shown in all views of the drawing disclosure represents fabric, but no particular color or pattern.

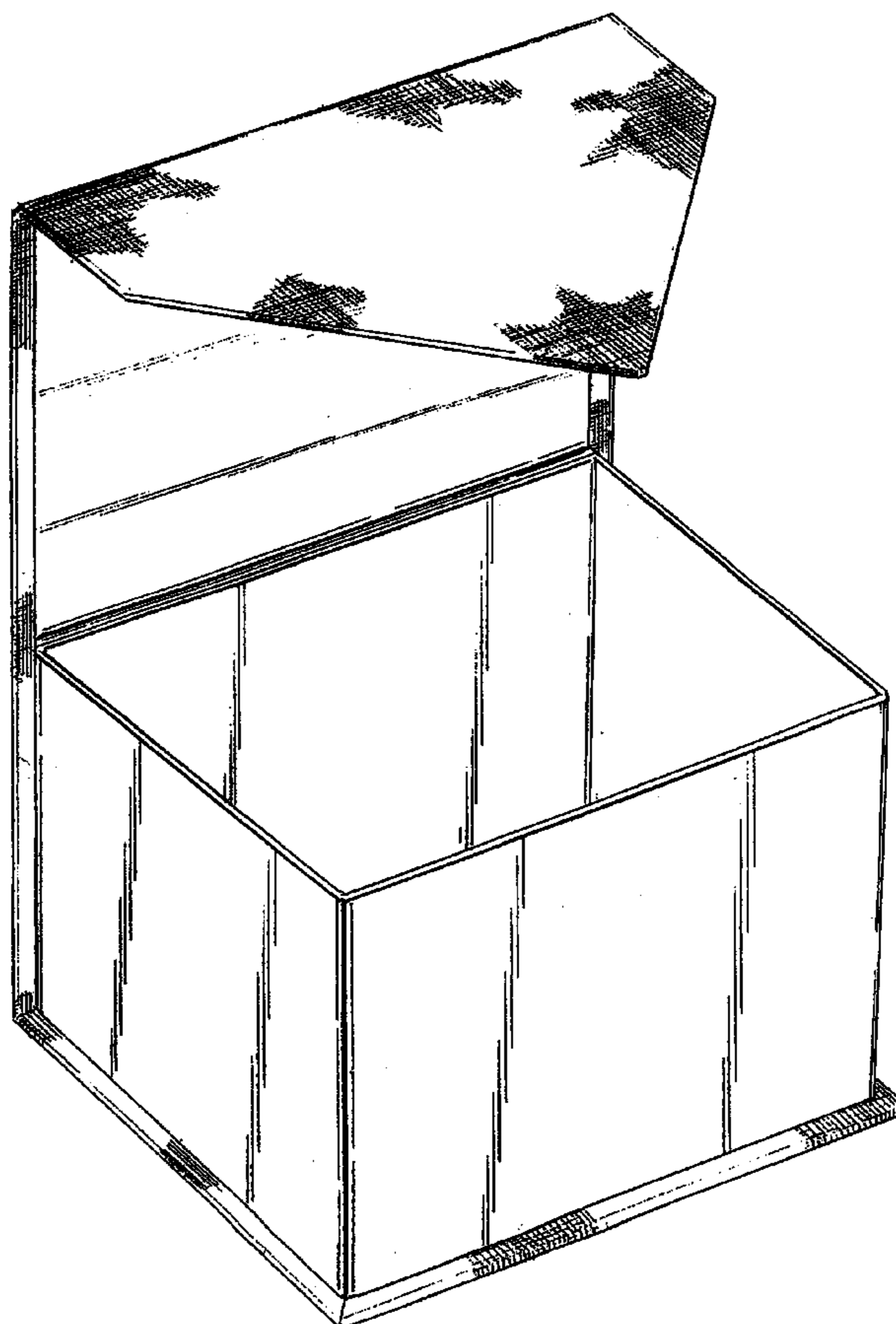

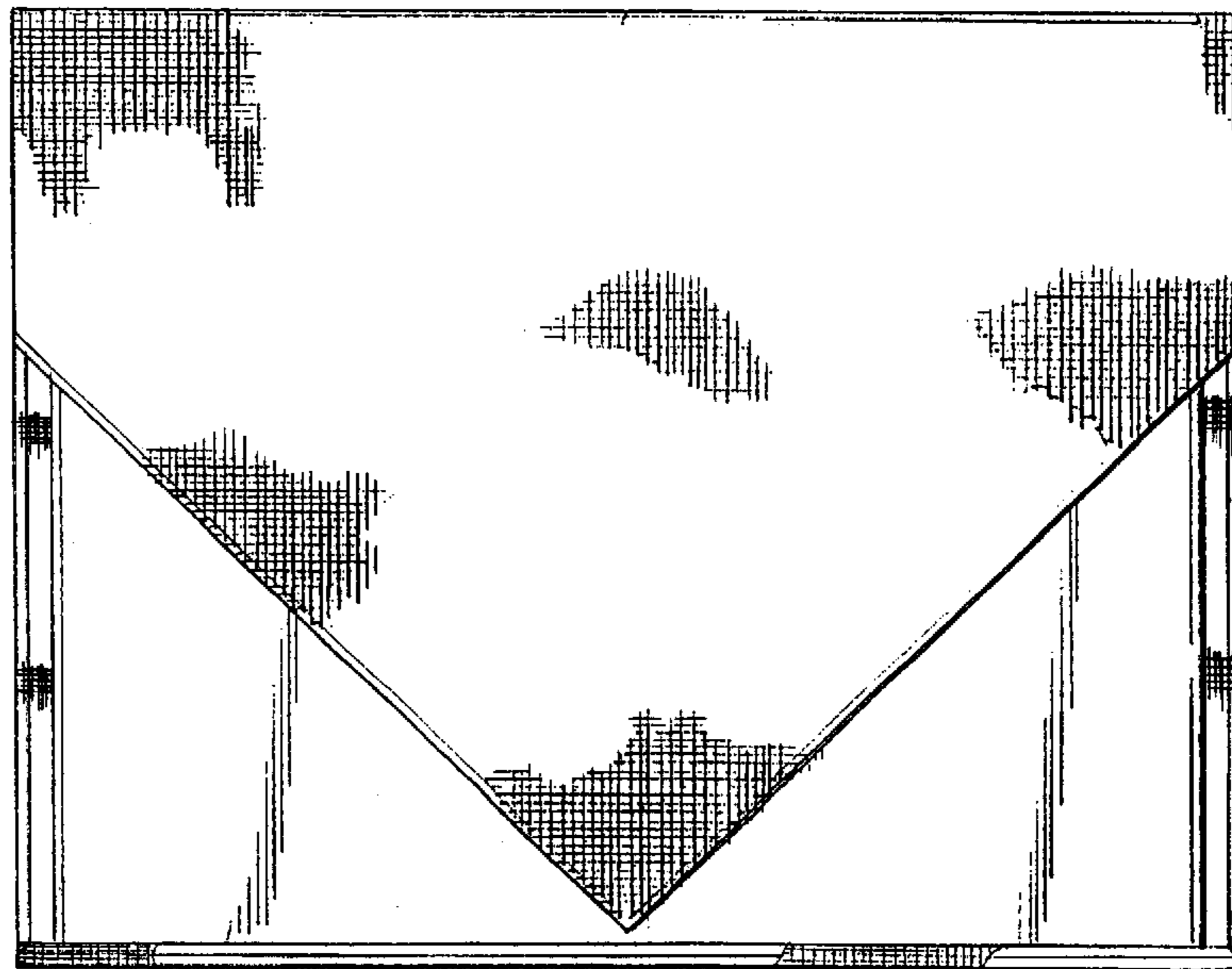
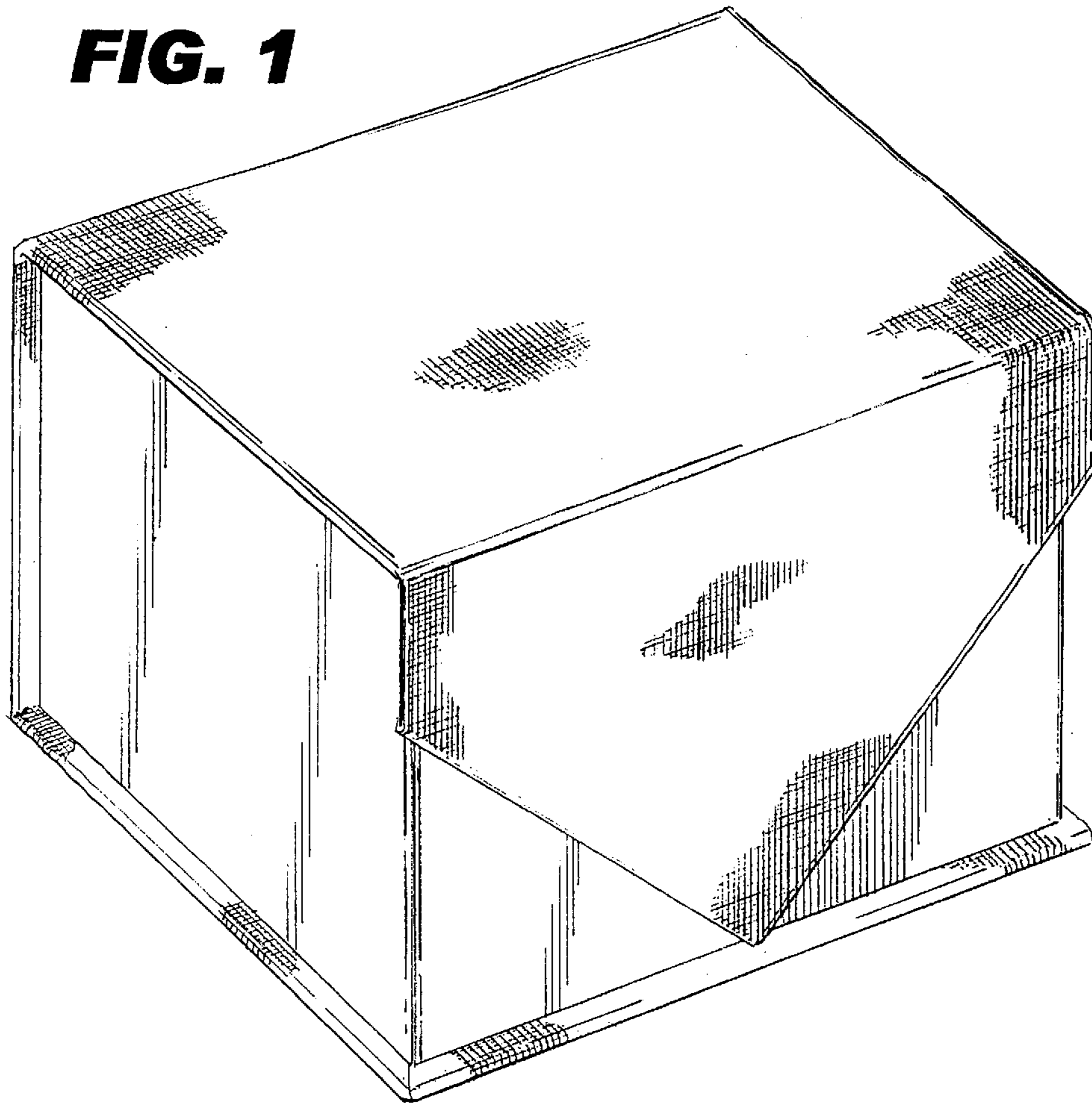

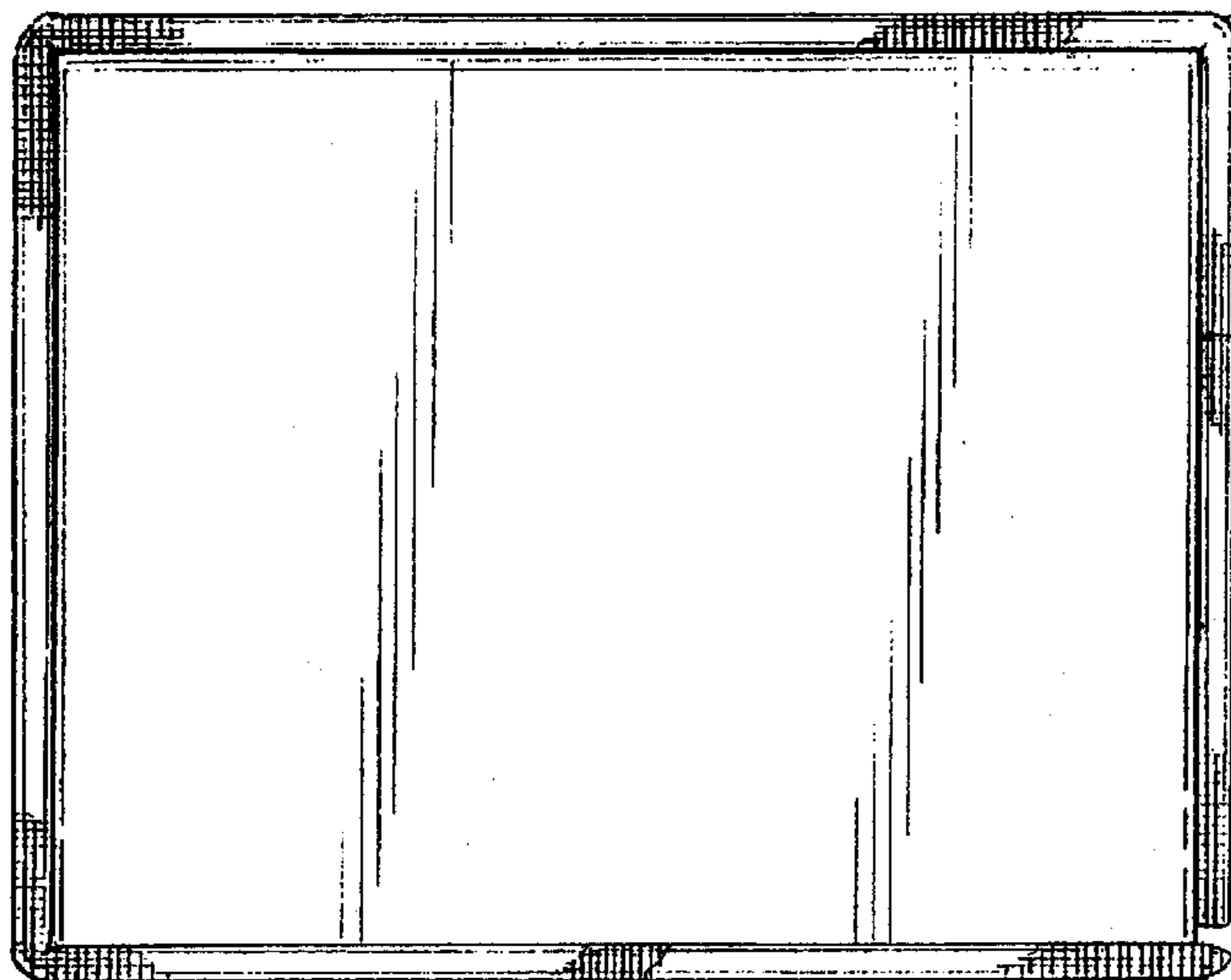

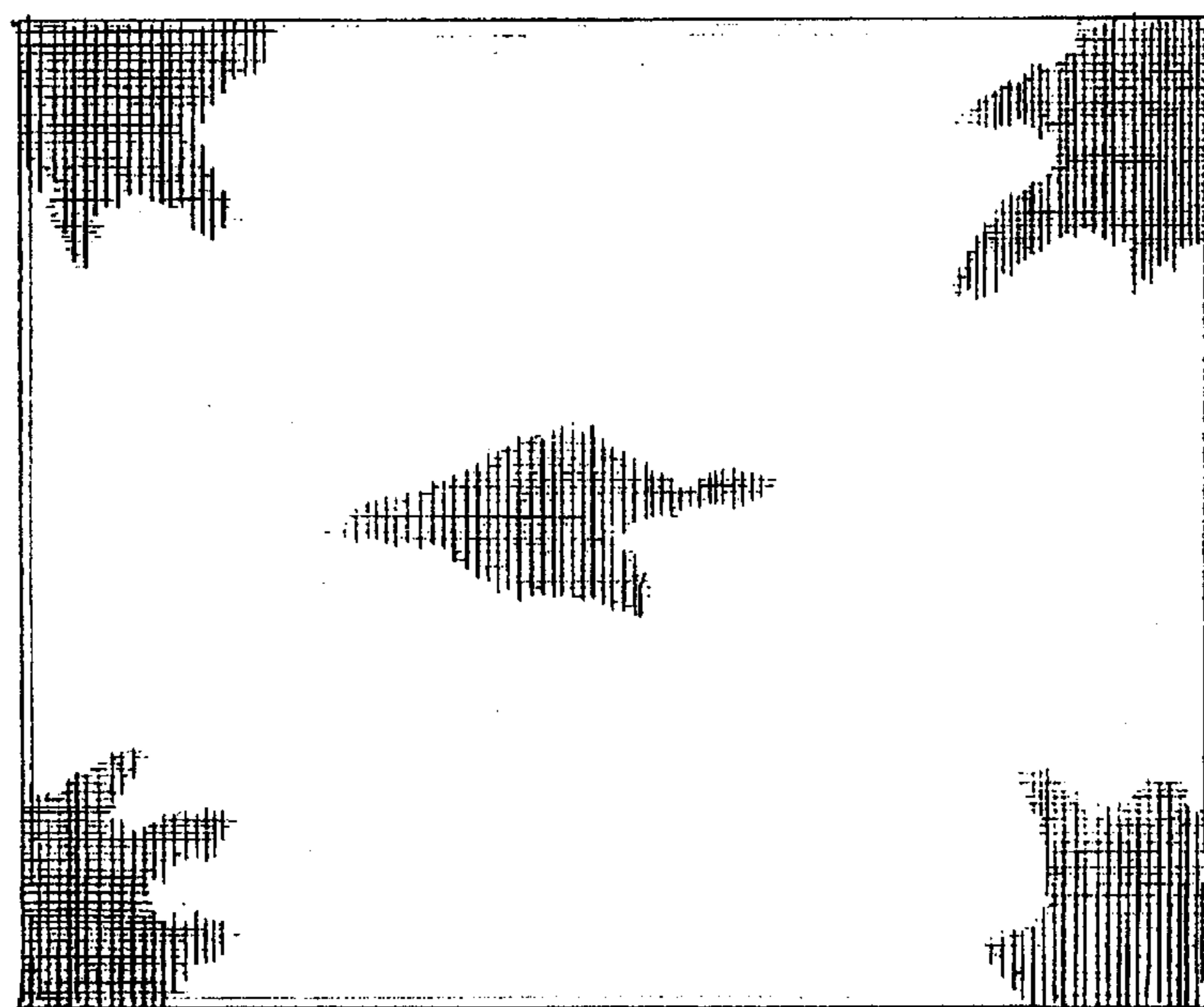

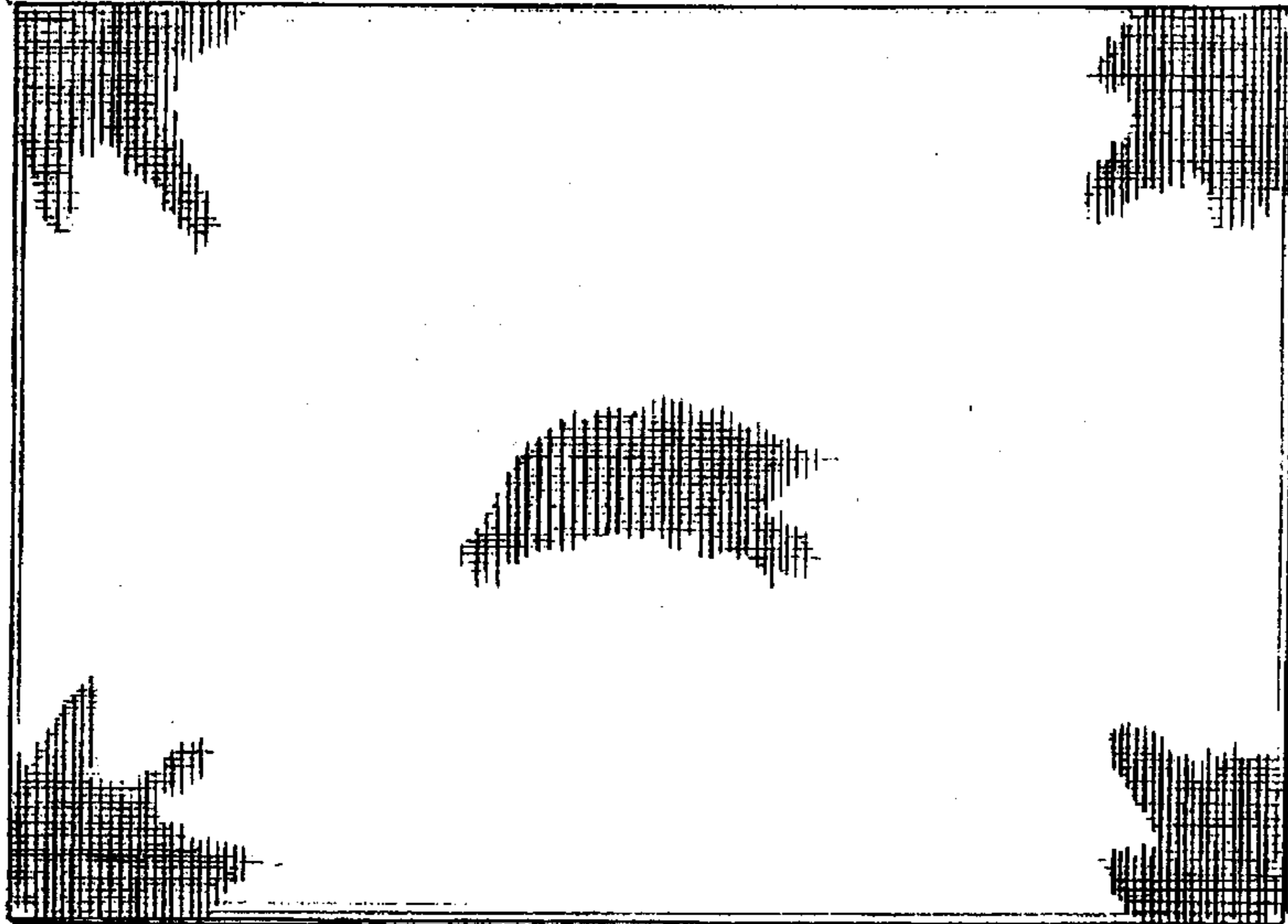

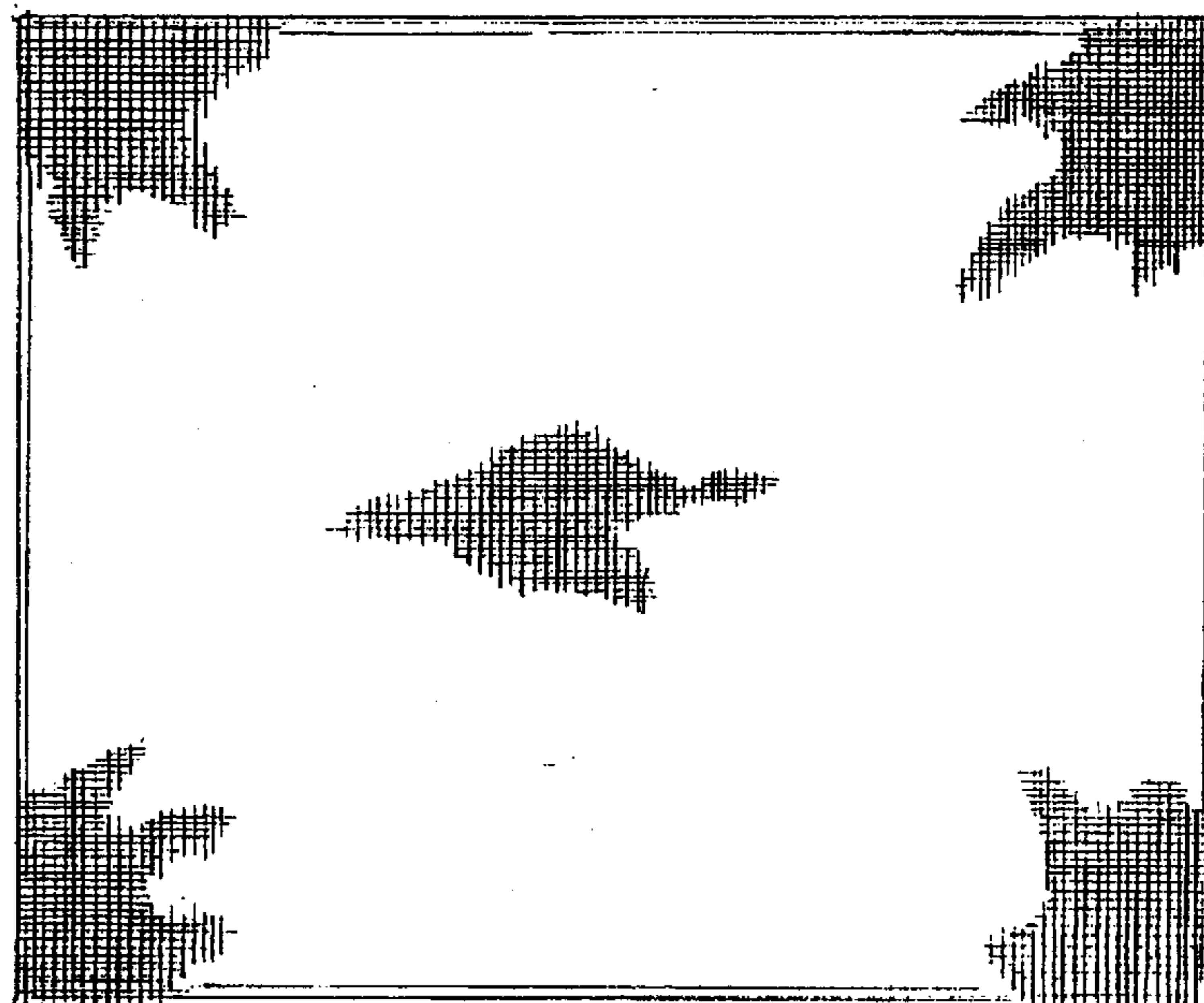
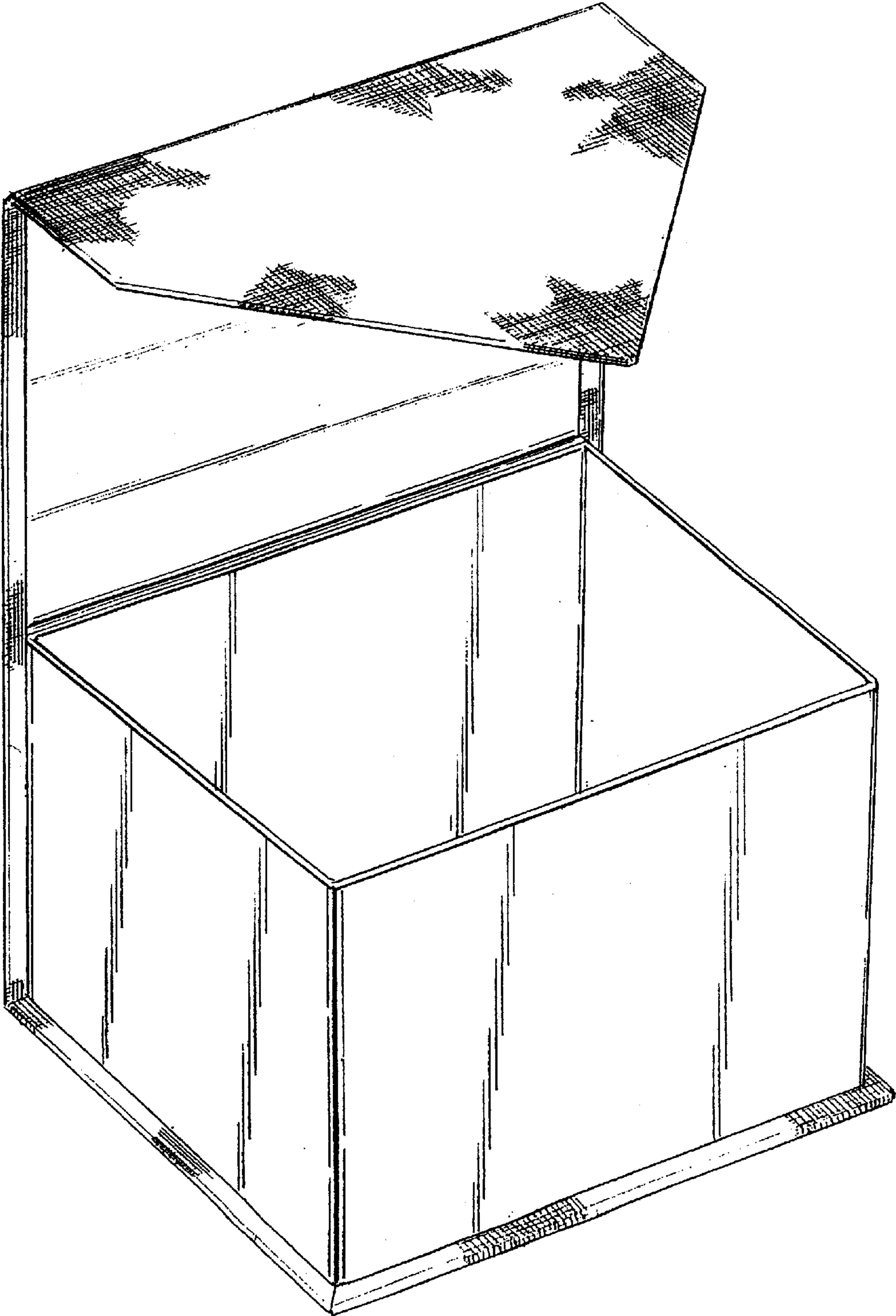
